- 披露有關資料以便就權益索償;及
- 與上述有關的任何其他附帶或相關目的及/ 或使本公司及香港股份過戶登記分處能履行 對證券持有人及/或監管機構承擔的責任

及/或證券持有人不時同意的任何其他目的。

### 3. 轉交個人資料

本公司及其香港股份過戶登記分處所持有關證券持有人的個人資料將會保密,但本公司及其香港股份過戶登記分處可以在為達到上述任何目的之必要情況下,向下列任何人士披露、獲取或轉交(無論在香港境內或境外)有關個人資料:

- 本公司委任的代理,例如財務顧問、收款銀行和海外股份過戶登記總處;
- (如證券申請人要求將證券存於中央結算系統)香港結算或香港結算代理人將會就中央 結算系統的運作使用有關個人資料;
- 向本公司或香港股份過戶登記分處提供與其 各自業務營運有關的行政、電訊、電腦、付 款或其他服務的任何代理、承包商或第三方 服務供應商;
- 聯交所、證監會及任何其他法定監管機構或 政府部門或遵照其他法例、規則或法規;及
- 證券持有人與其進行或擬進行交易的任何人 士或機構,例如彼等的銀行、律師、會計師 或股票經紀等。

#### 4. 個人資料的保留
