POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 29 MAY 2019

The Board is pleased to announce that at the AGM held on 29 May 2019, all resolutions as set out in the AGM Notice dated 22 March 2019 were duly passed as ordinary resolutions of the Company by the Shareholders by way of poll.

Reference is made to the circular (“**Circular**”) of ST International Holdings Company Limited (“**Company**”) dated 22 March 2019 and the notice (“**AGM Notice**”) of the annual general meeting (“**AGM**”) dated 22 March 2019. Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meanings as defined in the Circular.

POLL RESULTS OF THE AGM

The Board is pleased to announce that at the AGM held on 29 May 2019, all the resolutions as set out in the AGM Notice were duly passed by the Shareholders by way of poll.

As at the date of the AGM, there were a total of 480,000,000 Shares in issue. To the best of the Directors’ knowledge, information and belief having made all reasonable enquiries, no Shareholder was required to abstain from voting on the resolutions proposed at the AGM. As such, there were a total of 480,000,000 Shares, representing 100% of the Shares in issue as at the date of the AGM, entitling Shareholders to attend and vote on the resolutions proposed at the AGM. None of the Shareholders was entitled to attend and abstain from voting in favour of the resolutions proposed at the AGM according to Rule 17.47A of the GEM Listing Rules. None of the Shareholders has stated their intention in the Circular to vote against the resolutions proposed or to abstain from voting at the AGM.
