POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 28 JUNE 2019

Reference is made to the circular (“**Circular**”) of First Credit Finance Group Limited (“**Company**”) dated 29 May 2019 and the notice (“**Notice**”) of the annual general meeting of the Company (“**AGM**”) dated 29 May 2019. Unless the context otherwise requires, terms used in this announcement shall have the same meanings as those defined in the Circular.

POLL RESULTS OF THE AGM

The Board is pleased to announce that all the resolutions as set out in the Notice (“**Resolutions**”) were duly passed at the AGM as ordinary resolutions of the Company by way of poll.

The Company’s auditors, Elite Partners CPA Limited, was appointed as the scrutineer for the purpose of vote-taking. The poll results are as follows:

Note 2: The number of votes and percentage of the voting as stated above are based on the total number of Shares held by the Shareholders who attended and voted at the AGM in person, by authorised corporate representative(s) or by proxy(ies) (excluding 421,840,000 Shares registered under the name of Mr. Ng Kam Lung Volais, whose votes were not counted for the purpose of calculating the votes on any of the Resolutions as decided by Chairman of the AGM pursuant to the Bye-Laws), being 2,079,699,791 Shares in total.

As at the date of the AGM, there were a total of 3,628,800,000 Shares in issue. To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, no Shareholder was required under the GEM Listing Rules to abstain from voting on the Resolutions. The Bye-Laws provide that if any objection shall be raised to the qualification of any voter at a meeting, the chairman of the meeting may make a decision on the votes cast. Since there was a dispute in the ownership of the Shares held by a substantial Shareholder, namely Mr. Ng Kam Lung Volais, the chairman of the AGM decided that for the sake of the interest of the Company and the Shareholders, the votes in respect of 421,840,000 Shares registered under the name of Mr. Ng Kam Lung Volais were not to be counted for the purpose of calculating the votes on any of the Resolutions. As such, there were a total of 3,206,960,000 Shares, representing approximately 88.38% of the issued share capital of the Company as at the date of the AGM, entitling the Shareholders to attend and vote on the Resolutions. There were no Shares entitling the Shareholders to attend the AGM and abstain from voting in favour of the Resolutions as set out in Rule 17.47A of the GEM Listing Rules. None of the Shareholders had stated his/her/its intention in the Circular to vote against any of the Resolutions or to abstain from voting at the AGM.

As more than 50% of the votes were cast in favour of each of the Resolutions, all the Resolutions were duly passed by the Shareholders as ordinary resolutions of the Company at the AGM.
