

PROPOSALS FOR RE-ELECTION OF DIRECTORS, GENERAL MANDATES TO REPURCHASE AND ISSUE SHARES AND NOTICE OF ANNUAL GENERAL MEETING

1. INTRODUCTION

The purpose of this circular is to provide you with the information regarding the resolutions to be proposed at the AGM for (i) re-election of Directors retiring at the AGM; (ii) the granting of the Repurchase Mandate to the Directors; (iii) the granting of the Issuance Mandate to the Directors; and (iv) the extension of the Issuance Mandate by the addition of the Shares repurchased by the Company pursuant to the Repurchase Mandate.

LETTER FROM THE BOARD

2. **RE-ELECTION OF DIRECTORS**

Pursuant to Articles 84(1) and 84(2), Ms. Cheng Hang Fan and Mr. Mak King Sau will retire by rotation at the AGM and, being eligible, will offer themselves for re-election. Details of the Directors proposed to be re-elected at the AGM are set out in Appendix I to this circular.

3. REPURCHASE AND ISSUANCE MANDATES

Ordinary resolutions will be proposed at the AGM to approve the granting of general mandates to the Directors:

- (a) to purchase Shares on the Stock Exchange of up to 50,985,900 Shares, being 10% of the aggregate amount of the issued Shares of the Company on the date of passing of such resolution on the basis that 509,859,000 Shares were in issue as at the Latest Practicable Date and no further Shares are issued or repurchased before the AGM (the "Repurchase Mandate");
- (b) to allot, issue and deal with additional Shares of up to 101,971,800 Shares, being 20% of the Shares in issue as at the date of passing of such resolution on the basis that 509,859,000 Shares were in issue as at the Latest Practicable Date and no further Shares are issued or repurchased before the AGM (the "Issuance Mandate"); and
- (c) to extend the Issuance Mandate by the addition of the Shares repurchased by the Company pursuant to the Repurchase Mandate.

The Repurchase Mandate and the Issuance Mandate will continue in force until the earlier of the Relevant Period as defined in Resolution 5 as set out in the AGM Notice.

With reference to the Repurchase Mandate and the Issuance Mandate, the Directors wish to state that they have no immediate plan to repurchase or issue any Shares pursuant thereto.

An explanatory statement required by the Listing Rules to provide Shareholders with requisite information reasonably necessary to enable them to make an informed decision on whether to vote for or against the granting of the Repurchase Mandate is set out in Appendix II to this circular.

4. NOTICE OF AGM

The AGM Notice is set out in Appendix III to this circular.

A form of proxy for use at the AGM is enclosed with this circular. To be valid, the form of proxy must be completed in accordance with the instructions printed thereon and deposited, together with the power of attorney or other authority (if any) under which it is signed or a certified copy of that power of attorney or authority, at the Company's Hong Kong Branch Registrar, Tricor Investor Services Limited at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong as soon as possible and in any event not less than 48 hours before the time appointed for holding the AGM or any adjournment thereof. Completion and return of the form of proxy shall not preclude you from attending and voting at the AGM or any adjourned meeting should you so desire.

5. VOTING BY POLL

Pursuant to Rule 13.39(4) of the Listing Rules, any vote of the Shareholders at an annual general meeting must be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. Accordingly, the chairman of the AGM will demand a poll on each of the resolutions to be proposed at the AGM unless the abovementioned reason arises.

6. **RECOMMENDATION**

The Directors consider that the proposed re-election of Directors, the granting of Repurchase Mandate and Issuance Mandate and the extension of the Issuance Mandate are each in the best interests of the Company and Shareholders. The Directors recommend Shareholders to vote in favour of the Resolutions to be proposed at the AGM.

7. **RESPONSIBILITY STATEMENT**

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

APPENDIX I DIRECTORS PROPOSED TO BE RE-ELECTED

The details of the Directors proposed to be re-elected at the AGM are set out below:

Ms. Cheng Hang Fan, aged 60, is one of the co-founders of the Group and became the Chief Executive Officer and an Executive Director of the Company on 6 September 2011 and 30 September 2010 respectively. Ms. Cheng has over 33 years of experience in the travel industry. She is primarily responsible for the Group's overall management and operation, business development and strategic planning. Ms. Cheng is the spouse of Mr. Ko Wai Ming, Daniel, the Chairman and an Executive Director of the Company.

Ms. Cheng has entered into a Director's Service Agreement with the Company for an initial term of three years commencing on the date of listing of the Company's Shares on the Stock Exchange, i.e. 30 September 2011, and shall continue thereafter until terminated. She is subject to retirement by rotation at least once every three years pursuant to the relevant provisions under the Articles. She is presently entitled to a fixed salary of HK\$1,020,000 per annum and a discretionary bonus, which were determined by the Board with reference to the prevailing market practice and her duties and responsibilities with the Group.

As at the Latest Practicable Date and pursuant to Part XV of SFO, Ms. Cheng has a personal interest in 8,370,000 Shares, a family interest in 4,240,000 Shares and corporate interest in 356,715,000 Shares, representing approximately in aggregate 72.4% of the issued share capital of the Company.

Save as disclosed herein, Ms. Cheng does not have any other relationships with any other Directors, senior management, substantial or controlling shareholders of the Company.

As at the Latest Practicable Date, Ms. Cheng has not held any directorship in any other public companies whose securities are listed on any securities market in Hong Kong or overseas during the past three years and did not have any other major appointments and professional qualifications.

There is no information that is required to be disclosed by Ms. Cheng pursuant to Rules 13.51(2)(h) to (v) of the Listing Rules. Save as disclosed herein, there is no other matter that needs to be brought to the attention of the Shareholders relating to the re-election of Ms. Cheng.

Mr. Mak King Sau, aged 45, was appointed as an Independent Non-executive Director of the Company on 29 June 2011. Mr. Mak is a member of the American Institute of Certified Public Accountants. He graduated from Boston University with a Bachelor of Science in Business Administration and was awarded a Master of Science in Financial Management from University of London. Mr. Mak served various senior management positions in investment institutions. He has more than 17 years of experience in corporate finance and private equity fund investment. From 2010 to 2012, he worked for Sino-Life (Hong Kong) Limited (a wholly-owned subsidiary of Sino-Life Group Limited (stock code: 8296)) as general manager. Mr. Mak was an independent non-executive director of Xinjiang Tianye Water Saving Irrigation System Company Limited (stock code: 840), a company listed on The Stock Exchange of Hong Kong Limited, since October 2007 and resigned on 31 October 2018.

APPENDIX I DIRECTORS PROPOSED TO BE RE-ELECTED

Mr. Mak has entered into an appointment letter with the Company for an initial term of two years commencing on the date of listing of the Company's Shares on the Stock Exchange, i.e. 30 September 2011. In March 2016, Mr. Mak signed a letter to confirm his term of appointment on the date of the annual general meeting at which he was re-elected for a term of two years shall be automatically renewed unless terminated by either the Company or Mr. Mak by giving at least one month's notice in writing to the other. He is presently entitled to a Director's fee of HK\$144,000 per annum, which was determined by the Board with reference to the prevailing market rate for independent non-executive directors of listed companies in Hong Kong. Mr. Mak is subject to retirement by rotation at least once every three years pursuant to the relevant provisions under the Articles.

Mr. Mak does not have any interest or deemed interest in any Shares of the Company pursuant to Part XV of the SFO.

Mr. Mak does not have any relationships with any Directors, senior management, substantial or controlling shareholders of the Company. The Company has received from Mr. Mak his annual confirmation of independence pursuant to Rule 3.13 of the Listing Rules and considers that he is independent.

Save as disclosed above, as at the Latest Practicable Date, Mr. Mak has not held any position with the Company or any of its subsidiaries, has not held any directorships in other public companies whose securities are listed on any securities market in Hong Kong or overseas during the past three years and did not have any other major appointments and professional qualifications.

There is no information that is required to be disclosed by Mr. Mak pursuant to Rules 13.51(2)(h) to (v) of the Listing Rules. Save as disclosed herein, there is no other matter that needs to be brought to the attention of the Shareholders relating to the re-election of Mr. Mak.

APPENDIX II EXPLANATORY STATEMENT ON THE REPURCHASE MANDATE

The following is an explanatory statement required by the Listing Rules to be sent to the Shareholders to enable them to make an informed decision on whether to vote for or against the ordinary resolution to be proposed at the AGM in relation to the granting of the Repurchase Mandate.

1. SHARE CAPITAL

As at the Latest Practicable Date, there were 509,859,000 Shares in issue. Subject to the passing of the Resolution 5 as set out in the AGM Notice in respect of the granting of the Repurchase Mandate and on the basis that no further Shares are issued or repurchased before the AGM, the Directors would be authorized under the Repurchase Mandate to repurchase, during the period in which the Repurchase Mandate remains in force, a maximum of 50,985,900 Shares, representing 10% of the aggregate number of Shares in issue as at the Latest Practicable Date.

2. REASONS FOR REPURCHASES

The Directors believe that it is in the best interests of the Company and the Shareholders to seek a general authority from the Shareholders to enable the Directors to repurchase the Shares on the market.

Repurchases of Shares may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share or may otherwise be in the interest of the Company, and will only be made when the Directors believe that such a repurchase will benefit the Company and the Shareholders.

3. FUNDING OF REPURCHASES

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with the Memorandum and Articles, the laws of the Cayman Islands and other applicable laws, as the case may be, and will be financed by the Group's internal resources.

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 March 2019) in the event that the Repurchase Mandate was to be carried out in full at any time during the proposed repurchase period. However, the Directors do not intend to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

APPENDIX II EXPLANATORY STATEMENT ON THE REPURCHASE MANDATE

4. DIRECTORS' UNDERTAKING

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to make repurchases pursuant to the proposed resolution in accordance with the Listing Rules and all applicable Cayman Islands laws and in accordance with the regulations set out in the Memorandum and Articles.

5. DIRECTORS AND CORE CONNECTED PERSONS

None of the Directors nor, to the best of the knowledge and belief of the Directors having made all reasonable enquiries, any of their close associates have any present intention, in the event that the grant to the Directors of the Repurchase Mandate is approved by the Shareholders, of selling Shares to the Company. No core connected persons of the Company have notified the Company that they have a present intention to sell Shares to the Company, or have undertaken not to do so in the event that the Company is authorised to make repurchases of Shares.

6. TAKEOVERS CODE

If, as a result of a share repurchase, a shareholder's proportionate interest in the voting capital of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeovers Code and, if such increase results in a change of control, may in certain circumstances give rise to an obligation to make a mandatory offer for the securities of the Company under Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, Colvin & Horne Holdings Limited, which is owned as to 60% by Mr. Ko Wai Ming, Daniel ("**Mr. Ko**"), the Chairman and an Executive Director of the Company, and as to 40% by Ms. Cheng Hang Fan ("**Ms. Cheng**"), the spouse of Mr. Ko and the Chief Executive Officer and an Executive Director of the Company, together with Mr. Ko and Ms. Cheng (all together, "**Mr. Ko and Associates**") held approximately 72.4% of the Company's issued Shares. If the power under the Repurchase Mandate is exercised in full, the interest of Mr. Ko and Associates would be increased to 80.5% of the issued Shares. The Directors are not aware of any consequences which will arise under the Takeovers Code as a result of the exercise of the power in full under the Repurchase Mandate. The Directors have no intention to exercise the Repurchase Mandate to an extent that may result in a public shareholding of less than the minimum public float requirement.

A member who is the holder of two or more shares may appoint more than one proxy to represent him and vote on his behalf at the Meeting. A proxy need not be a member of the Company. If more than one proxy is so appointed, the appointment shall specify the number of shares in respect of which each such proxy is so appointed.
- 3. In order to be valid, the form of proxy, together with the power of attorney or other authority, if any, under which it is signed or a certified copy of that power of attorney or authority, must be deposited at the Company's Hong Kong Branch Share Registrar, Tricor Investor Services Limited ("Tricor") at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong, not less than 48 hours before the time appointed for the holding of the Meeting or any adjournment thereof. Delivery of the form of proxy shall not preclude a member of the Company from attending and voting in person at the Meeting and in such event, the instrument appointing a proxy shall be deemed to be revoked.

The Register of Members of the Company will be closed from Tuesday, 13 August 2019 to Friday, 16 August 2019 (both days inclusive), during which period no transfer of shares in the Company will be registered, for the purpose of determining shareholders who are entitled to attend and vote at the Meeting.
