The Company further announces that all the other conditions precedent for the implementation of the Capital Reduction and the Share Sub-division have been fulfilled. The Capital Reduction and the Share Sub-division shall become effective before 9:00 a.m. on Tuesday, 3 March 2020 and the dealing in the New Shares shall commence at 9:00 a.m. on Tuesday, 3 March 2020.

FREE EXCHANGE OF SHARE CERTIFICATES

Shareholders may between 9:00 a.m. and 4:30 p.m. on any Business Day during the period from Tuesday, 3 March 2020 to Wednesday, 8 April 2020 (both days inclusive), submit share certificates for the Consolidated Shares (in yellow color) to the Registrar at Level 54, Hopewell Centre, 183 Queen’s Road East, Hong Kong to exchange for new share certificates for the New Shares (in red color) at the expense of the Company.

All existing certificates of the Consolidated Shares or (as the case may be) the Existing Shares will continue to be evidence of title to such Shares but all existing certificate of Existing Shares will cease to be valid for trading and settlement purpose.
