- 聯交所、證監會及任何其他法定監管機關或政府部 門或遵照其他法例、規則或法規;及
- 證券持有人與其進行或擬進行交易的任何人士或機構,例如彼等的銀行、律師、會計師或股票經紀等。

4. 個人資料的保留

本公司及其香港股份登記分處將按收集個人資料所需的 用途保留證券申請人及持有人的個人資料。無需保留的 個人資料將會根據條例銷毀或處理。

5. 查閱和更正個人資料
