The Board is pleased to announce that the proposed change of the name of the Company from “China Singyes Solar Technologies Holdings Limited” to “China Shuifa Singyes Energy Holdings Limited” and the proposed adoption of “中國水發興業能源集團有限公司” as the secondary name of the Company in Chinese have become effective from 12 February 2020 pursuant to the Certificate of Incorporation on Change of Name and the Certificate of Secondary Name issued by the Registrar of Companies in Bermuda. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 30 March 2020 confirming the registration of the new names of the Company in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the laws of Hong Kong).

#### **CHANGE OF STOCK SHORT NAME**

The stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “SINGYES SOLAR” to “SFSY ENERGY” in English and from “興業太陽能” to “水發興業能源” in Chinese with effect from 9:00 a.m. on 9 April 2020.
