Since the Disposal was conducted through open market at the prevailing market price, the Directors consider that the Disposal is on normal commercial terms and its terms including consideration are fair and reasonable.

REASONS FOR AND BENEFITS OF THE DISPOSAL

The Company is an investment holding company, and the Group is principally engaged in the business of investments in securities, trading of commodities and electronic components, money lending as well as securities brokerage. In light of the recent volatile market conditions, the Directors consider that notwithstanding the Disposal is made at a loss, in light of the interest income earned by the Group in the previous year and up to the date of the Disposal, and the fact that the Disposal can provide immediate liquidity to improve the Group's cash position, thereby allowing it to better structure its asset portfolio, the Directors consider the Disposal is in the interest of the Company and the Shareholders as a whole.

Since the Disposal was conducted through open market, the Directors consider that the Disposal is on normal commercial terms and is fair and reasonable.

FINANCIAL EFFECT OF THE DISPOSAL

It is expected that the Group will record a loss of approximately US\$2,000 (equivalent to approximately HK\$15,600) as a result of the Disposal, subject to auditor's review. The loss represents the difference between the net proceeds from the Disposal and the acquisition cost of the respective Senior Notes.

USE OF PROCEEDS

It is expected that the net proceeds from the Disposal (i.e. proceeds from the Disposal and deducting therefrom transaction costs), which is US\$2,174,000 (equivalent to approximately HK\$16,957,000), will be used as general working capital of the Group.
