INTRODUCTION

The purpose of this circular is to provide you with information relating to the resolutions to be proposed at the Annual General Meeting involving (i) the proposed grant of the Issue Mandate and the Repurchase Mandate; and (ii) the re-election of retiring Directors and continuous appointment of independent non-executive Director who has served more than nine years and to give you the notice of the Annual General Meeting.

GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

Issue Mandate

At the Annual General Meeting, an ordinary resolution will be proposed such that the Directors be given an unconditional general mandate to allot, issue and deal with new Shares or underlying shares of the Company or make or grant offers, agreements or options which might require the exercise of such power, of an aggregate number not exceeding 20% of the total number of Shares in issue as at the date of passing of ordinary resolution in relation to the Issue Mandate.

In addition, a separate ordinary resolution will further be proposed for extending the Issue Mandate authorising the Directors to allot, issue and deal with Shares to the extent of the Shares repurchased pursuant to the Repurchase Mandate (the "Extended Issue Mandate"). Details on the Repurchase Mandate are further elaborated below.

As at the Latest Practicable Date, the Company has an aggregate of 1,503,477,166 Shares in issue. Subject to the passing of the resolution for the approval of the Issue Mandate and on the basis that no further Shares will be issued or repurchased after the Latest Practicable Date and prior to the date of the Annual General Meeting, the Company would be allowed under the Issue Mandate to allot, issue and deal with a maximum of 300,695,433 Shares.

Repurchase Mandate

At the Annual General Meeting, an ordinary resolution will also be proposed such that the Directors be given an unconditional general mandate to repurchase Shares (i.e. the Repurchase Mandate) on the Stock Exchange of an aggregate number of up to 10% of the total number of Shares in issue as at the date of passing of ordinary resolution in relation to the Repurchase Mandate.

Subject to the passing of the resolution for the approval of the Repurchase Mandate and on the basis that no further Shares will be issued or repurchased after the Latest Practicable Date and prior to the date of the Annual General Meeting, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 150,347,716 Shares.

The Issue Mandate (including the Extended Issue Mandate) and the Repurchase Mandate, if granted, shall continue to be in force during the period from the date of passing of the resolutions for the approval of the Issue Mandate (including the Extended Issue Mandate) and the Repurchase Mandate up to (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association or any other applicable laws of the Cayman Islands to be held; or (iii) the revocation or variation of the relevant resolutions of the Shareholders by ordinary resolution in general meeting, whichever occurs first.

An explanatory statement as required by the Listing Rules in connection with the Repurchase Mandate is set out in Appendix I to this circular. The explanatory statement contains information required under the Listing Rules to be given to the Shareholders to enable them to make an informed decision on whether to vote for or against the resolution approving the Repurchase Mandate.

RE-ELECTION OF RETIRING DIRECTORS AND CONTINUOUS APPOINTMENT OF INDEPENDENT NON-EXECUTIVE DIRECTOR WHO HAS SERVED MORE THAN NINE YEARS

According to Article 83(3), the Directors shall have the power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy on the Board or as an addition to the existing Board. Any Director appointed by the Board to fill a casual vacancy shall hold office until the first general meeting of Members after his appointment and be subject to re-election at such meeting and any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting of the Company and shall then by eligible for re-election.

According to Articles 84(1) and 84(2), at each annual general meeting one-third of the Directors for the time being, or, if their number is not a multiple of three, then the number nearest to but not less than one-third, shall retire from office by rotation, provided that every Director shall be subject to retirement at an annual general meeting at least once every three years and a retiring Director shall be eligible for re-election. Any Director appointed by the Board pursuant to Article 83(3) shall not be taken into account in determining which particular Directors or the number of Directors who are to retire by rotation.

In accordance with Article 83(3), Mr. Ho Man, who was appointed as independent non-executive Director on 22 January 2020 shall retire from office at the Annual General Meeting, whereas in accordance with Articles 84(1) and 84(2), Mr. Kwok Chi Shing and Mr. Chang Xuejun shall retire from office by rotation at the Annual General Meeting. Being eligible, Mr. Ho Man, Mr. Kwok Chi Shing and Mr. Chang Xuejun will offer themselves for re-election as independent non-executive Directors at the Annual General Meeting.

The nomination committee of the Company ("Nomination Committee") has reviewed the biographical details of Mr. Kwok Chi Shing, ("Mr. Kwok"), Mr. Chang Xuejun ("Mr. Chang") and Mr. Ho Man ("Mr. Ho") and their meeting of nomination criteria (including but not limited to, character and integrity, professional qualifications, skills, knowledge and experience that are relevant to the Company's business and corporate strategy, time commitment to effectively discharge duties as Board member) set out in the nomination policy of the Company and considered the diversity aspects (including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of services) set out in the diversity policy of the Company, and took the view that with their professional qualifications, skills, knowledge and experience, Mr. Kwok Chi Shing, Mr. Chang Xuejun and Mr. Ho Man have been contributing to the Group including the diversity of the Board effectively and are committed to their role as independent non-executive Directors ("INED"). The Nomination Committee had also assessed the independence of Mr. Kwok Chi Shing, Mr. Chang Xuejun and Mr. Ho Man based on their annual confirmation of independence and was satisfied with their independence with reference to the criteria as set out in Rule 3.13 of the Listing Rules.

The recommendation for recommending the Shareholders to re-elect Mr. Kwok Chi Shing was made by the Nomination Committee, after reviewing his suitability based on the assessment criteria as set out in the Terms of Reference of Nomination Committee adopted by the Company and the independence criteria set out in Rule 3.13 of the Listing Rules. Mr. Kwok has extensive experience in corporate and financial management work especially for international cross border transactions, real estate development and property management industries. In addition, he has extensive experience in public sector work both in Hong Kong and the PRC. Mr. Kwok is currently the managing director of LKKC C.P.A. Limited. Pursuant to code provision A.4.3 of the Corporate Governance Code (Appendix 14 to the Listing Rules), any further appointment of independent non-executive director serving more than nine years should be subject to a separate resolution to be approved by shareholders. Mr. Kwok Chi Shing has served on the Board for more than 9 years but he never held any executive or management position in the Group nor has he throughout such period been under the employment of any member of the Group. It is noted the positive contributions of Mr. Kwok to the development of the Company's strategy and policies through independent, constructive and informed contributions supported by his skills, expertise and qualifications and from his active participations at meetings. Hence, it is considered that long services of Mr. Kwok would not affect his exercises of independent judgements, and Mr. Kwok is considered to be independent and he is recommended to be re-elected.

The recommendation for recommending the Shareholders to re-elect Mr. Chang Xuejun was made by the Nomination Committee, after reviewing his suitability based on the assessment criteria as set out in the Terms of Reference of Nomination Committee adopted by the Company and the independence criteria set out in Rule 3.13 of the Listing Rules. Mr. Chang has more than 20 years of legal experience. Mr. Chang is currently the partner of LI & PARTNERS Attorneys at Law in Shenzhen, the PRC. Mr. Chang demonstrated the ability to provde an independent view on the Company's matters in different perspectives and his presence in the Board contributes to the diversity of the Board.

The recommendation for recommending the Shareholders to re-elect Mr. Ho Man was made by the Nomination Committee, after reviewing his suitability based on assessment criteria as set out in the Terms of Reference of Nomination Committee adopted by the Company and the independence criteria set out in Rule 3.13 of the Listing Rules. Mr. Ho has more than 20 years of experience in private equity investment and finance and has rich experience in directorship of listed companies in Hong Kong. It is considered that his professional background and skills can bring valuable insights and perspectives to the Company. Having regard to the confirmation with Mr. Ho Man the availability to discharge his duties, and the satisfactory attendance record to meetings and the actual contributions that Mr. Ho has made, the Board concluded that Mr. Ho is able to discharge his responsibilities as an INED of the Company and can devote sufficient time to and contribute to the diversity of the Board.

The Board accepted the recommendation by the Nomination Committee for recommending the Shareholders to re-elect Mr. Kwok Chi Shing, Mr. Chang Xuejun and Mr. Ho Man as Independent non-executive Directors at the AGM. Each of them abstained from voting at the Board meeting and the Nomination Committee meeting (if applicable) regarding their nomination.

The Board considered that the re-election of Mr. Kwok Chi Shing, Mr. Chang Xuejun and Mr. Ho Man was in the best interest of the Company and the Shareholders as a whole and recommended the Shareholders to vote for their re-election at the AGM.

Details of the retiring Directors who are proposed to be re-elected at the Annual General Meeting are set out in Appendix II to this circular.

This Appendix serves as an explanatory statement, as required by the Listing Rules, to provide requisite information to you for your consideration of the Repurchase Mandate.

1. EXERCISE OF THE REPURCHASE MANDATE

The Company's authority is restricted to purchases made on the Stock Exchange in accordance with the Listing Rules. As at the Latest Practicable Date, there were in issue 1,503,477,166 Shares. Subject to the passing of the resolution in respect of Repurchase Mandate and on the assumption that no further Shares will be issued or repurchased after the Latest Practicable Date and prior to the date of the AGM, the Board would be authorised under the Repurchase Mandate to repurchase up to 150,347,716 Shares. Furthermore, the Repurchase Mandate covers purchases made only during the period ending on the earliest of (a) the conclusion of the next annual general meeting of the Company; (b) the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association or any other applicable laws of the Cayman Islands to be held; or (c) the revocation or variation of the relevant resolutions of the Shareholders by ordinary resolution in general meeting, whichever occurs first.

2. REASONS FOR REPURCHASES

The Directors have no present intention to repurchase any Shares but consider that the mandate will provide the Company the flexibility to make such purchase when appropriate and beneficial to the Company. Such repurchases may, depending on market conditions and funding arrangement at the time, enhance the net assets and/or earnings per Share.

3. FUNDING OF REPURCHASES

The Company is empowered by the Articles of Association to purchase its Shares. In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with the Articles of Association and the applicable laws and regulations of the Cayman Islands. In the event that the Repurchase Mandate is exercised in full and assuming that there is no change in the number of Shares held by Mr. Liu Chang Deng and there is no other change to the issued share capital of the Company, the aggregate shareholding of Mr. Liu Chang Deng in the Company will be increased to approximately 11.54% of the reduced issued share capital of the Company immediately after the exercise in full of the Repurchase Mandate.
