The Board is pleased to announce that, on 24 April 2020, the Company held the AGM at which the ordinary resolutions proposed in the AGM Notice were duly passed.

The board of directors (the “**Board**”) of Lee & Man Paper Manufacturing Limited (the “**Company**”) is pleased to announce that, at the Annual General Meeting (the “**AGM**”) held on 24 April 2020, the ordinary resolutions proposed in the notice of the AGM dated 24 March 2020 (the “**Notice**”) were duly passed by the shareholders of the Company (the “**Shareholders**”) present thereat by way of poll voting in which Tricor Investor Services Limited acted as scrutineer for the votetaking.

As at the date of the AGM, the total number of issued Shares of the Company was 4,346,642,000 Shares. No Shareholders were required to abstain from voting at the AGM.
