PRECAUTIONARY MEASURES FOR THE ANNUAL GENERAL MEETING TO BE HELD ON 13 MAY 2020

Unless otherwise stated, capitalised terms used herein shall have the same meanings as defined in the Circular.

Having considered the Company's statutory obligation to hold its AGM on or before 30 June 2020 and the uncertain development of the current COVID-19 situation, the Company will hold its AGM as scheduled.
