### POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 5 MAY 2020

At the Annual General Meeting of Great Eagle Holdings Limited (the “**Company**”) held on 5 May 2020 (the “**AGM**”), a poll was demanded by the Chairman for voting on all proposed resolutions (the “**Resolutions**”) as set out in the Notice of AGM dated 27 March 2020.

No Shareholders were subject to any restrictions in exercising their votes on any of the Resolutions at the AGM.
