

2. 目的

- 處理 閣下之申請、退款支票及電子退款指示(如適用)、核實是否符合本申請表格及招股章程載列之條款和申請手續以及公佈公開發售股份之分配結果;
- 遵守香港及其他地區之適用法律法規;
