### **DELAY IN DESPATCH OF CIRCULAR**

Reference is made to the announcement of Ausnutria Dairy Corporation Ltd (the “**Company**”) dated 9 April 2020 in relation to, among others, the HBC Acquisition and the HNC Amendments (the “**Announcement**”).
