POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 5 JUNE 2020

The Board is pleased to announce that all the Resolutions were duly passed by the Shareholders by way of poll at the AGM held on 5 June 2020.

Reference is made to the circular (the “**Circular**”) and notice (the “**AGM Notice**”) in relation to the annual general meeting (the “**AGM**”) both dated 21 April 2020 of Tian Yuan Group Holdings Limited (the “**Company**”). Capitalised terms used in this announcement shall have the same meanings as defined in the Circular, unless otherwise defined.

As at the date of the AGM, the total number of Shares in issue was 600,000,000, which was the total number of Shares entitling the Shareholders to attend and vote for or against all the resolutions proposed at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of the Resolutions at the AGM pursuant to Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and no Shareholders were required under the Listing Rules to abstain from voting at the AGM. No parties have indicated in the Circular that they intend to vote against or to abstain from voting on any of the Resolutions at the AGM.

At the AGM, all of the resolutions as set out in the AGM Notice (the “**Resolutions**”) were approved by the Shareholders by way of the Poll.

As more than 50% of the votes were cast in favour of each of the Resolutions, all the Resolutions were duly passed as ordinary resolutions. The poll results for the respective Resolutions are set out as follows:
