POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 16 JUNE 2020

The Board is pleased to announce that all resolutions proposed at the AGM were duly passed by the Shareholders by way of poll at the AGM held on 16 June 2020.

The board (“**Board**”) of directors (“**Directors**”, each a “**Director**”) of SIM Technology Group Limited (“**Company**”) is pleased to announce that all resolutions as set out in the notice of the annual general meeting of the Company (“**AGM**”) dated 28 April 2020 (“**Notice**”) were duly passed by the shareholders of the Company (“**Shareholders**”) at the AGM held on 16 June 2020 by way of poll.

At the AGM, all proposed resolutions as set out in the Notice were taken by poll. The Company’s Hong Kong branch share registrar, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking. None of the Shareholders was required to abstain from voting on the resolutions proposed at the AGM and none of the Shareholders was entitled to attend and abstain from voting in favour of the resolutions proposed at the AGM according to Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited. None of the Shareholders has stated his/her/its intention in the circular of the Company dated 28 April 2020 to vote against any of the resolutions proposed or to abstain from voting at the AGM.
