**POLL RESULTS OF THE ANNUAL GENERAL MEETING
HELD ON 23 JUNE 2020**

At the annual general meeting (the “AGM”) of Luye Pharma Group Ltd. (the “Company”) held on 23 June 2020, a poll was demanded by the chairman of the AGM for voting on all the proposed resolutions as set out in the notice of the AGM dated 22 May 2020 (the “AGM Notice”).

As at the date of the AGM, the total number of issued shares of the Company was 3,259,965,343 shares of US\$0.02 each, being the total number of shares entitling the shareholders of the Company (the “Shareholders”) to attend and vote for or against the resolutions at the AGM. There were no restrictions on any Shareholders casting vote on any of the proposed resolutions at the AGM. No Shareholder was required to attend and vote only against the proposed resolutions at the AGM.

The Company’s Hong Kong share registrar, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.
