POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 28 SEPTEMBER 2020

All the Applicable Proposed Resolutions as set out in the AGM Notice were duly passed by the Shareholders by way of poll at the 2020 AGM.

POLL RESULTS OF THE AGM

The board of directors (the “Board”) of China Ocean Group Development Limited (the “Company”) is pleased to announce that all the applicable ordinary resolutions as set out in the notice of the annual general meeting of the Company (the “AGM” and the “Applicable Proposed Resolutions”, respectively) dated 26 August 2020 (the “AGM Notice”) were duly passed by the holders of the Company’s ordinary shares of HK\$0.01 each (the “Shares” and the “Shareholders”, respectively) by way of poll at the AGM held on Monday, 28 September 2020 (the “2020 AGM”).

As at the date of the AGM, there were 4,305,960,179 issued Shares entitling the Shareholders to attend and vote on the resolutions at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of the resolutions at the AGM as set out in Rule 17.47A of the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the “GEM Listing Rules”).

None of the Shareholders are required under the GEM Listing Rules to abstain from voting on the resolutions at the AGM. None of the Shareholders have stated in the Company’s circular dated 26 August 2020 in relation to the transactions contemplated under the AGM Notice (the “Circular”) their intention to vote against or to abstain from voting on any of the resolutions at the AGM.

Tricor Tengis Limited, the branch share registrar of the Company in Hong Kong acted as the scrutineer for the vote-taking at the 2020 AGM.
