The Company wishes to emphasise that it takes seriously the Issues raised by Deloitte in its Resignation Letter, and the Company has taken reasonable steps with a view to resolving the Issues, including but not limited to instructing external legal firms to carry out an investigation and seeking advice from senior counsels in Hong Kong, which have concluded that the Issues do not give rise to any legitimate concerns.

The Audit Committee would like to inform the Shareholders that it has substantially finalised its Investigations, and nothing has come to the attention of the Audit Committee that would lead it to conclude that there are legitimate concerns relating to the Issues that need to be brought to the attention of the Shareholders. Further details regarding the Investigations and the Company's internal control and procedures, among others, will be published in due course.

UPDATE ON FINANCIAL RESULTS

The Company has published its unaudited annual financial results for the year ended 31 August 2019 on 29 April 2020, and its unaudited interim financial results for the six months ended 29 February 2020 on 29 April 2020 (supplemented by a supplemental announcement dated 3 May 2020).

An announcement regarding the update of the audited annual results of the Company for the year ended 31 August 2019 and the unaudited interim results for the six months ended 29 February 2020 has been published on 20 August 2020. Both the 2019 Annual Report and the 2020 Interim Report have been published on the websites of the Stock Exchange and the Company on 26 August 2020.

As a result of the delay in publication of the 2019 Annual Results, trading in the shares of the Company on the Stock Exchange has been suspended with effect from 9:00 a.m. on 2 December 2019.

The Board wishes to state that the business operations of the Group have not been affected as a result of the matters set out in this announcement. The Board (including the Audit Committee) has confirmed that as at the date of this announcement, there are no other matters in connection with the foregoing that need to be brought to the attention of the Shareholders.
