The board (the "Board") of directors ("Directors") of the Company wishes to inform the shareholders of the Company and potential investors that, the Company has been notified by Hong Kong Shanshan Resources Company Limited (香港杉杉資源有限公司) ("Shanshan HK"), a controlling shareholder (as defined in the GEM Listing Rules) of the Company, that on 18 November 2020, Shanshan HK has entered into the following agreements to effect the disposal of a total of 79,054,800 unlisted foreign shares of the Company, representing 22% of the total number of issued shares of the Company (the "Disposal"):

- (i) a sale and purchase agreement with Beijing Youke Yu Technology Development Co., Ltd. (北京優科玉科技發展有限公司) ("Youke Yu") pursuant to which Shanshan HK has agreed to dispose of, and Youke Yu has agreed to acquire, 46,714,200 unlisted foreign shares of the Company, representing 13% of the total number of issued shares of the Company as at the date of this announcement; and
- (ii) a sale and purchase agreement with Beijing Hengsheng Rongcheng Trading Co., Ltd. (北京恒盛融誠商貿有限公司) ("Hengsheng Rongcheng") pursuant to which Shanshan HK has agreed to dispose of, and Hengsheng Rongcheng has agreed to acquire, 32,340,600 unlisted foreign shares of the Company, representing 9% of the total number of issued shares of the Company as at the date of this announcement.
