The Company and the Hong Kong Share Registrar will keep the personal data of the applicants and holders of securities for as long as necessary to fulfil the purposes for which the personal data was collected. ### 5. Access to and correction of personal data

The Company and the Hong Kong Share Registrar have the right to charge a reasonable fee for the processing of such requests.
