The Board is pleased to announce that all the Resolutions as set out in the Notice of AGM dated 31 March 2021 were duly passed by the Shareholders by way of a poll at the AGM held on 10 May 2021.

Reference is made to the circular of Great Water Holdings Limited (the “**Company**”) (the “**Circular**”) and the notice of the annual general meeting (the “**AGM**”) of the Company both dated 31 March 2021 (the “**Notice of AGM**”). Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meanings as defined in the Circular.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company is pleased to announce that all the ordinary resolutions (the “**Resolutions**”) as set out in the Notice of AGM were duly passed by the Shareholders (as defined below) by way of poll at the AGM held on 10 May 2021.

As at the date of the AGM, the total number of ordinary shares of the Company in issue (the “**Shares**”) was 300,000,000, being the total number of Shares entitling the holders thereof (the “**Shareholders**”) to attend and vote for or against all the Resolutions proposed at the AGM. To the best of the Directors’ knowledge, information and belief having made all reasonable enquiries, there was no Share entitling the Shareholders to attend and abstain from voting in favour of any of the Resolutions proposed at the AGM pursuant to Rule 17.47A of the GEM Listing Rules and no Shareholder was required under the GEM Listing Rules to abstain from voting on any of the Resolutions proposed at the AGM. In addition, no parties have stated their intention in the Circular to vote

against or to abstain from voting on any of the resolutions at the AGM and no Shareholder had a material interest in any of the resolutions proposed at the AGM.

The full text of the Resolutions was set out in the Notice of AGM. The poll results in respect of the Resolutions were as follows:
