The increase is primarily due to (i) decrease in loss on changes in fair value of investment properties; (ii) decrease in impairment loss on account receivable from margin clients; and (iii) decrease in finance costs resulted from the absence of imputed interests of convertible bonds issued by a listed subsidiary. The ordinary businesses of the Group have no significant change during the year ended 31 March 2021.
