**1. INTRODUCTION**

The purpose of this circular is to provide you with information in respect of the ordinary resolutions to be proposed at the AGM for the approval of (i) the re-election of the retiring Directors; (ii) the appointment of new auditor; and (iii) the grant of New Issue Mandate and New Repurchase Mandate; and to give you notice of AGM.

### 2. RE-ELECTION OF RETIRING DIRECTORS

Pursuant to Bye-law 87 of the Bye-laws, at each annual general meeting of the Company, one-third of the Directors for the time being, or, if their number is not three (3) or a multiple of three (3), the number nearest to but not less than one-third, shall retire from office by rotation such that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years. The Directors to retire by rotation shall include any Director who wishes to retire and not to offer himself for re-election. Any further Directors so to retire shall be those of the other Directors subject to rotation who have been longest in office since their last election or appointment and so that as between persons who became Directors on the same day those to retire shall (unless they otherwise agree among themselves) be determined by lot.

Pursuant to Bye-law 86(2) of the Bye-laws, the Directors shall have power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy or as an addition to the Board. All Directors appointed to fill a casual vacancy shall be subject to election by the Shareholders at the first general meeting after their appointment. Any other Director so appointed by the Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election at that meeting.

Pursuant to Bye-laws 86(2) and/or 87 of the Bye-laws, Mr. Wang Hongfang, Mr. Kwong Kai Sing Benny, Mr. Zheng Yuchun, Mr. Xiao Yiqun and Ms. Liu Yan shall retire at the AGM and, being eligible, will offer themselves for re-election.

The Nomination Committee has reviewed the structure and composition of the Board, the qualifications, skills and experience, commitment and contribution, and the independence of these retiring Directors with reference to the nomination principles and criteria set out in the Company's board diversity policy and nomination policy.

Accordingly, the Nomination Committee has recommended to the Board on re-election of Mr. Wang Hongfang, Mr. Kwong Kai Sing Benny and Mr. Zheng Yuchun as executive Directors; Mr. Xiao Yiqun as non-executive Director; and Ms. Liu Yan as independent non-executive Director at the AGM.

Brief biographical details of these retiring Directors are set out in Appendix I to this circular.

If a valid notice from a Shareholder to propose a person to stand for election as a Director at the AGM is received in accordance with the Bye-laws after the printing of this circular, the Company will issue a supplemental circular to inform Shareholders of the details of such additional candidate(s) proposed.

### 3. APPOINTMENT OF NEW AUDITOR

Reference is made to the announcement of the Company dated 28 May 2021 relating to the proposed change of auditor of the Company (“**Announcement**”).

As set out in the Announcement, the Company received a letter from Deloitte Touche Tohmatsu, Certified Public Accountants (“**Deloitte**”) to not seek re-appointment as the auditor of the Company with effect from the conclusion of the AGM due to reasons of level of audit fees for future audit services and available internal resources in the light of the current work flows. Deloitte will retire as the auditor of the Company with effect from the conclusion of the AGM, and will not be re-appointed.

To fill the casual vacancy of the auditor of the Company, the Board has resolved to propose to appoint Elite Partners CPA Limited (“**Elite Partners**”) as the auditor of the Company following the retirement of Deloitte. As such, an ordinary resolution will be proposed at the AGM to approve, the proposed appointment of Elite Partners as the new auditor of the Company with effect from the conclusion of the AGM and to authorize the Board to fix their remuneration.

Deloitte has confirmed that there are no other matters connected with its resignation that need to be brought to the attention of the holders of securities of the Company. The Board and the Audit Committee further confirm that there is no disagreement or unresolved matters between the Company and Deloitte and there were no other matters in connection with their intention not to seek for re-appointment as the auditor of the Company that need to be brought to the attention of the shareholders of the Company.

The Board would like to express its appreciation for the services of Deloitte provided to the Company in the past years.

### 4. GENERAL MANDATES TO ISSUE SHARES AND REPURCHASE SHARES

At the last annual general meeting of the Company held on 18 June 2020, the Directors were granted (i) a general mandate to allot, issue and deal with Shares or any securities with an aggregate value of not exceeding 20% of the total number of Shares in issue as at 18 June 2020 (equivalent to the aggregate nominal amount of HK\$52,500,198.50 divided into 1,050,003,970 Shares with a nominal value of HK\$0.05 each) (“**Existing General Mandate**”); and (ii) a general mandate to repurchase Shares up to a maximum 10% of the total number of Shares in issue as at 18 June 2020 (equivalent to the aggregate nominal amount of HK\$26,250,099.25 divided into 525,001,985 Shares with a nominal value of HK\$0.05 each) (“**Existing Repurchase Mandate**”).

As at the Latest Practicable Date, the Existing General Mandate and the Existing Repurchase Mandate had yet been utilised and will expire at the conclusion of the AGM.

To facilitate future allotment and issue of Shares by the Directors on behalf of the Company, the Directors will seek the approval of the Shareholders for the grant of:

- (a) New Issue Mandate;
- (b) New Repurchase Mandate; and
- (c) if the New Repurchase Mandate is granted, the extension of New Issue Mandate by the addition of the aggregate number of Shares repurchased by the Company under the New Repurchase Mandate to the New Issue Mandate, subject to a maximum of 10% of the total number of Shares in issue as at the date of passing of the relevant resolution.

As at the Latest Practicable Date, the total number of Shares in issue was 5,250,019,852 Shares. Upon passing of the relevant resolutions at the AGM and assuming no further Shares are issued and/or repurchased by the Company between the Latest Practicable Date and the date of the AGM, the Company would be allowed:

- (i) pursuant to the New Issue Mandate to allot, issue and deal with 1,050,003,970 Shares, representing 20% of the total number of Shares in issue as at the date of passing of the relevant resolution; and
- (ii) pursuant to the New Repurchase Mandate to repurchase 525,001,985 Shares, representing 10% of the total number of Shares in issue as at the date of passing of the relevant resolution.

With reference to the New Issue Mandate and the New Repurchase Mandate, the Directors wish to state that they have no immediate plan to issue or repurchase any Shares pursuant thereto.

An explanatory statement giving certain information in respect of the New Repurchase Mandate as required under the Listing Rules to be included in this circular is set out in Appendix II to this circular.

Both the New Issue Mandate and the New Repurchase Mandate will expire upon the earliest of (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required to be held by the Bye-laws or the laws of Bermuda or any applicable law; and (iii) the revocation or variation of such authority by the passing of an ordinary resolution by the Shareholders in general meeting.

### 5. AGM AND PROXY ARRANGEMENT

The notice of AGM is set out on pages AGM-1 to AGM-6 of this circular. At the AGM, ordinary resolutions will be proposed to approve, among other things, (i) the re-election of the retiring Directors; (ii) the appointment of new auditor; and (iii) the granting of New Issue Mandate and New Repurchase Mandate.

The Directors are not aware of any Shareholder who is required to abstain from voting at the AGM. Pursuant to Rule 13.39(4) of the Listing Rules and/or the Bye-laws, any vote of Shareholders at a general meeting must be taken by poll. Therefore, all the resolutions put to vote at the AGM will be taken by way of poll. The chairman of the AGM will explain the detailed procedures for conducting a poll at the commencement of the AGM. After the conclusion of the AGM, the poll results will be published on the HKExnews website of the Stock Exchange at [www.hkexnews.hk](http://www.hkexnews.hk) and the website of the Company at [www.irasia.com/listco/hk/taiunited/index.htm](http://www.irasia.com/listco/hk/taiunited/index.htm) in the manner prescribed under Rule 13.39(5) of the Listing Rules.

A form of proxy for use by the Shareholders at the AGM is enclosed with this circular and such form of proxy is also published on the HKExnews website of the Stock Exchange at [www.hkexnews.hk](http://www.hkexnews.hk). Whether or not you intend to attend and vote in person at the AGM, you are requested to complete the enclosed form of proxy in accordance with the instructions printed thereon and return the same to the Company's branch share registrar and transfer office in Hong Kong, Tricor Tengis Limited at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong as soon as practicable but in any event by 10:30 a.m. on Sunday, 27 June 2021 or not later than 48 hours before the time appointed for holding the AGM or any adjournment thereof (as the case may be). Completion and return of the form of proxy will not preclude you from attending and voting in person at the AGM or any adjournment thereof (as the case may be) should you so wish, and in such event, the instrument appointing a proxy shall be deemed to be revoked.

### 6. CLOSURE OF REGISTER OF MEMBERS

The AGM is scheduled to be held on Tuesday, 29 June 2021. For the purpose of determining eligibility to attend and vote at the AGM as members of the Company, the register of members of the Company will be closed from Thursday, 24 June 2021 to Tuesday, 29 June 2021, both days inclusive, on which period no transfer of the Shares will be registered. All transfers of Shares accompanied by the relevant share certificates and appropriate transfer forms must be lodged for registration with the Company's Hong Kong branch share registrar and transfer office, Tricor Tengis Limited at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong no later than 4:30 p.m. on Wednesday, 23 June 2021.

### 7. PRECAUTIONARY MEASURES FOR AGM

In view of the ongoing COVID-19 epidemic and recent development for prevention and control of its spread, the Company will implement the following preventive measures at the AGM to prevent attending Shareholders, staff and other stakeholders from the risk of infection:

- i. compulsory body temperature check will be conducted on every attendee at the entrance of the AGM venue;
- ii. every attendee to enter the AGM venue is required to wear surgical face mask at all times until after they have left the venue (please note that no masks will be provided at the AGM venue and attendees should bring their own masks);
- iii. no refreshments, beverage or souvenirs will be provided; and
- iv. appropriate distancing and spacing in line with the guidance from the Hong Kong Government will be maintained and as such, the Company may limited the number of attendees at the AGM as may be necessary to avoid over-crowding.

In order to ensure the safety of the attendees at the AGM, the Company reserves the rights to deny entry into or require any person to leave the AGM venue if such person:

- i. refuses to comply with any of the above precautionary measures;
- ii. is having a body temperature of over 37.2 degree Celsius;
- iii. is subject to any quarantine prescribed by Hong Kong Government or has close contact with any person under quarantine; or
- iv. has any flu-like symptoms.

**Shareholders are strongly recommended to consider appointing the chairman of the AGM as their proxy to vote on the resolutions for them, instead of attending the AGM in person.**

### 8. RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

### 9. RECOMMENDATION

The Directors are of the opinion that the resolutions set out in the Notice of AGM, including (i) the proposed re-election of the retiring Directors; (ii) the appointment of new auditor; and (iii) the grant of New Issue Mandate and New Repurchase Mandate are in the interests of the Company, the Group and the Shareholders as a whole. Accordingly, the Directors recommend the Shareholders to vote in favour of the resolutions to be proposed at the AGM.

*Pursuant to the Listing Rules, the biographical details of the Directors who will retire at the AGM according to the Bye-laws and be proposed to be re-elected at the AGM are set out below:*

## **EXECUTIVE DIRECTORS**

### **Mr. Wang Hongfang (“Mr. Wang”)**

Mr. Wang, aged 61, was appointed as the executive Director on 7 January 2021 and the Chairman of the Board on 20 May 2021.

Mr. Wang has over twenty six years of management experience. Since 2018, he has been the chairman of Baby First Education Group Limited and the chairman of Shenzhen Qizhi Education Technology Limited, both being his privately owned companies.

From 2003 to 2018, Mr. Wang served in China Dili Group (formerly known as Renhe Commercial Holdings Company Limited (人和商業控股有限公司\*), Stock Code: 1387, a company listed on the main board of the Stock Exchange). In 2003, he was appointed as the vice president of China Dili Group and became the executive president in 2006. He was then appointed as an executive director on 14 December 2007, the executive president (Investments and Financing) on 26 February 2008 and the chief executive officer on 30 June 2014, and resigned from all the positions on 4 September 2018. Prior to joining China Dili Group, Mr. Wang held management positions in a number of companies in the PRC during the period from 1994 to 2000. From 2001 to 2003, Mr. Wang was the president of Harbin Jurong New Power Co., Ltd. in which he was responsible for the overall planning and management of its business.

Mr. Wang obtained a bachelor’s degree in automatic control mechanics (自動控制專業) in 1982 and graduated with a master’s degree in politics and economics in 1991 from the Harbin Institute of Technology (哈爾濱工業大學).

Mr. Wang has entered into an appointment letter with the Company for an initial term of one year commencing from 7 January 2021. His appointment shall be subject to retirement by rotation and re-election as stipulated in the Bye-laws and Listing Rules. Mr. Wang is entitled to a remuneration of HK\$1,200,000 per annum which has been determined by reference to his qualification, duties and responsibilities with the Company, the Company’s performance and the prevailing market conditions.

Mr. Wang does not have any relationship with any other Directors, senior management or substantial Shareholders, or controlling Shareholders.

As at the Latest Practicable Date, Mr. Wang does not have any interests in the securities of the Company within the meaning of Part XV of the SFO.

There is no information which is discloseable nor is/was Mr. Wang involved in any of the matters required to be disclosed pursuant to any of the requirements of the provisions under paragraphs 13.51(2)(h) to 13.51(2)(v) of the Listing Rules, and there are no other matters concerning Mr. Wang that need to be brought to the attention of the Shareholders.

**Mr. Kwong Kai Sing Benny (“Mr. Kwong”)**

Mr. Kwong, aged 62, was appointed as the executive Director and authorised representative of the Company on 19 April 2018 and 7 September 2018 respectively. He was further appointed as the chief executive officer of the Company on 30 October 2019. He also serves as the director of certain subsidiaries of the Group currently.

Mr. Kwong holds a Bachelor Degree in Arts from Simon Fraser University in British Columbia, Canada and was awarded the Honor Degree of Doctor of Commerce by The University of West Alabama in 2007. Mr. Kwong held senior positions with major international banks in Hong Kong in respective lending departments and China department for many years. For the past years, he has served as executive director of over ten publicly listed companies both in Hong Kong, Canada and the United Kingdom. Mr. Kwong has extensive knowledge in corporate finance and banking.

Mr. Kwong was a director of the Tung Wah Group of Hospitals from 2008 to 2010 and was a member of the Campaign Committee of The Community Chest from 2006 to 2010. Mr. Kwong was an appointed member of the China People’s Political Consultative Conference of the Hubei Province and Zhaoqing City of the Guangdong Province. He is the Hospital Governing Committee member of Tai Po Hospital since 2012 and the audit committee member of Tung Wah College since 2013. Mr. Kwong has been appointed as non-executive director of PYI Corporation Limited (Stock Code: 498) since 9 February 2021. He was appointed as an independent non-executive director on 30 April 2019 of Planetree International Development Limited (“**Planetree International**”) (Stock Code: 613), and re-designated to non-executive director on 1 April 2020, and then resigned on 17 February 2021. He was also the acting chairman of Planetree International from 1 April 2020 to 1 June 2020. Mr. Kwong was an independent non-executive director of Imagi International Holdings Limited (Stock Code: 585) from January 2016 to May 2017 and an executive director of GT Group Holdings Limited (Stock code: 263) from September 2017 to April 2018, all of which are listed on the main board of the Stock Exchange.

Mr. Kwong has entered into an appointment letter with the Company for an initial term of one year commencing from 19 April 2018. His appointment shall be subject to retirement by rotation and re-election as stipulated in the Bye-laws and Listing Rules. Mr. Kwong is entitled to a remuneration of HK\$2,400,000 per annum which has been determined by reference to his qualification, duties and responsibilities with the Company, the Company's performance and the prevailing market conditions.

Mr. Kwong does not have any relationship with any other Directors, senior management or substantial Shareholders, or controlling Shareholders.

As at the Latest Practicable Date, Mr. Kwong does not have any interests in the securities of the Company within the meaning of Part XV of the SFO.

### **1. SHARE CAPITAL**

As at the Latest Practicable Date, the issued share capital of the Company comprised 5,250,019,852 Shares of HK\$0.05 each.

Subject to the passing of the ordinary resolution no. 4 set out in the notice of the AGM in respect of the granting of the New Repurchase Mandate and assuming that no further Shares are issued or repurchased between the Latest Practicable Date and the date of the AGM, the Directors would be authorised under the New Repurchase Mandate to repurchase a maximum of 525,001,985 Shares (representing 10% of the total number of Shares in issue as at the Latest Practicable Date) during the period in which the New Repurchase Mandate remains in force.

### **2. REASONS FOR REPURCHASES**

The Directors believe that it is in the best interests of the Company and the Shareholders to seek a general authority from the Shareholders to enable the Directors to repurchase the Shares in the market. Such repurchases may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and its assets and/or its earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders as a whole.

### **3. FUNDING OF REPURCHASES**

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its memorandum of association, the Bye-laws, the laws of Bermuda and/or any other applicable laws.

The laws of Bermuda provide that the amount of capital paid in connection with a share repurchase by a company may only be paid out of either the capital paid up on the relevant shares, or the funds of the company which would otherwise be available for dividend or distribution or out of the proceeds of a fresh issue of shares made for such purpose. The amount of premium payable on repurchase may only be paid out of funds of the company which would otherwise be available for dividend or distribution or out of the share premium account of the company before the shares are repurchased.

**4. IMPACT OF REPURCHASES**

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 December 2020) in the event that the New Repurchase Mandate was to be carried out in full at any time during the proposed repurchase period.

However, the Directors do not intend to exercise the New Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

**5. TAKEOVERS CODE**

If, as a result of share repurchase by the Company, a Shareholder’s proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeovers Code. Accordingly, a Shareholder, or group of Shareholders acting in concert (within the meaning under the Takeovers Code), could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 and 32 of the Takeovers Code.

In the event that the Directors exercise in full the New Repurchase Mandate which is to be approved by the Shareholders, the aforesaid interests of the abovementioned substantial Shareholders in the issued share capital of the Company would be proportionally increased as set out above. Songbird SG and Satinu (together the “**Concert Group**”), who are presumed to be acting in concert under the Takeovers Code, were interested in an aggregate of 3,937,234,889 Shares, representing approximately 74.99% of the issued Shares carrying voting rights. The percentage of shareholding of the Concert Group will increase to approximately 83.33% of the issued Shares immediately following the full exercise of the New Repurchase Mandate. Save as disclosed, the Directors are not aware of any consequence which would arise under the Takeovers Code as a result of any repurchase pursuant to the New Repurchase Mandate.

Nevertheless, the Directors do not intend to exercise the New Repurchase Mandate to such extent as would, in the circumstances, trigger any potential consequences under Rule 26 of the Takeovers Code. In any event, the New Repurchase Mandate will be exercised only if the number of Shares held by the public would not fall below 25% following such exercise.

Any person who does not comply with the precautionary measures may be denied the entry into the meeting venue. The Company also encourages Shareholders NOT to attend the AGM in person and advise Shareholders to appoint the chairman of the meeting as their proxy to vote on relevant resolution(s) according to their indicated voting instructions as an alternative. When assessing whether or not it is necessary to adjourn the AGM or change the meeting venue, the Board will consider the impact of the latest outbreak of COVID-19 in the local community, the measures announced by the Government of the Hong Kong Special Administrative Region and/or any applicable regulatory body in connection with COVID-19 and the availability of suitable meeting venue(s).
