POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 4 JUNE 2021

POLL RESULTS OF THE AGM

The total number of issued shares of the Company entitling the holders to attend and vote at the AGM was 523,330,908 Shares, which was the total number of Shares entitling Shareholders to attend and vote for or against all the proposed resolutions at the AGM. No Shareholder was required under the Listing Rules to abstain from voting and no Shareholder was entitled to attend and vote only against the resolutions at the AGM. None of the Shareholders was required to abstain from voting in favour of the resolutions at the AGM.
