POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 7 JUNE 2021 AND FINAL DIVIDEND PAYMENT

The Board is pleased to announce that at the AGM, all the resolutions set out in the AGM Notice were approved by the Shareholders by way of poll.

POLL RESULTS OF THE AGM

References are made to the circular (the “**Circular**”) of Perfect Group International Holdings Limited (the “**Company**”) dated 5 May 2021, and the notice of annual general meeting of the Company (the “**AGM**”) dated 5 May 2021 (the “**AGM Notice**”). Unless the context requires otherwise, terms used herein shall have the same meanings as those defined in the Circular.

The Board is pleased to announce that at the AGM held on 7 June 2021, all the resolutions set out in the AGM Notice were duly passed by the Shareholders by way of poll.

As at the date of the AGM, the number of issued shares of the Company was 1,350,000,000 Shares, which was the total number of Shares entitling the holders to attend and vote on the resolutions set out in the AGM Notice at the AGM. There were no Shares entitling the holder to attend and abstain from voting in favour of the resolutions set out in the AGM Notice at the AGM as set out in Rule 13.40 of the Listing Rules. There were no holders of Shares that are required under the Listing Rules to abstain from voting on the resolutions set out in the AGM Notice at the AGM.

None of the Shareholders has stated their intention in the Circular to vote against or to abstain from voting on any of the resolutions of the AGM.

The Company's Hong Kong branch share registrar, Union Registrars Limited, was appointed as the scrutineer for the vote-taking at the AGM.

Final Dividend Payment

The proposal for the payment of a final dividend of HK\$0.02 per share for the year ended 31 December 2020 to the Shareholders whose names appear on the register of members of the Company on Wednesday, 16 June 2021 was duly passed and approved at the AGM.

In order to establish the identity of the Shareholders who are entitled to the final dividend, all duly completed transfer forms accompanied by the relevant share certificates must be lodged with the Company's Hong Kong branch share registrar and transfer office, Union Registrars Limited, at Suites 3301–04, 33/F., Two Chinachem Exchange Square, 338 King's Road, North Point, Hong Kong, no later than 4:00 p.m. on Thursday, 10 June 2021. The register of members of the Company will be closed from Friday, 11 June 2021 to Wednesday, 16 June 2021 (both dates inclusive), during which period no share transfers will be registered. The final dividend is expected to be paid on or around Tuesday, 22 June 2021 to those shareholders of the Company whose names appear on the register of members of the Company on Wednesday, 16 June 2021.
