The Board is pleased to announce that all of the resolutions set out in the AGM Notice were duly passed at the AGM held on 8 June 2021 by way of poll.

Reference is made to the notice of annual general meeting (the “**AGM**”) dated 5 May 2021 (the “**AGM Notice**”) and the circular dated 5 May 2021 (the “**Circular**”) of Glory Flame Holdings Limited (the “**Company**”). Unless otherwise defined, capitalized terms used herein shall have the same meanings as defined in the Circular.

RESULTS OF THE AGM

The Board is pleased to announce that, at the AGM held at Suite 821, 8th Floor, Ocean Centre, Harbour City, 5 Canton Road, Tsim Sha Tsui, Kowloon, Hong Kong on 8 June 2021 at 11:00 a.m., all of the resolutions set out in the AGM Notice (the “**Resolutions**”) were duly passed by the shareholders of the Company (the “**Shareholders**”) by way of poll. - (1) The total number of shares of the Company in issue as at the date of the AGM was 1,010,605,000 shares of HK\$0.01 each. No Shareholder was required under the GEM Listing Rules to abstain from voting on the Resolutions at the AGM.
- (2) There was no shares of the Company entitling the holders to attend and vote only against the Resolutions at the AGM as set out in Rule 17.47A of the GEM Listing Rules.
- (3) The total number of shares of the Company entitling the holders to attend and to vote for or against the Resolutions at the AGM was 1,010,605,000 shares of the Company.
