

Failure to supply the requested data may result in your application for securities being rejected, or in delay or the inability of the Company or the Hong Kong Share Registrar to effect transfers or otherwise render their services. It may also prevent or delay registration or transfers of the Hong Kong Offer Shares which you have successfully applied for and/ or the despatch of share certificate(s) and/or refund cheque(s) to which you are entitled.

2. **Purposes**

The personal data of the securities holders may be used, held, processed, and/or stored (by whatever

means) for the following purposes:

processing your application and/or refund cheque(s), where applicable, verification of compliance with the terms and application procedures set out in the Prospectus and this Application Form and announcing results of allocation of the Hong Kong Offer Shares; complying with applicable laws and regulations

telecommunications, computer, payment or other services to the Company or the Hong Kong Share Registrar in connection with their respective business operations; the Stock Exchange, the SFC and any other

statutory regulatory or governmental bodies or otherwise as required by laws, rules or

regulations; and

any persons or institutions with which the securities holders have or propose to have dealings, such as their bankers, solicitors, accountants or stockbrokers, etc.

Retention of personal data

The Company and the Hong Kong Share Registrar will keep the personal data of the applicants and holders of securities for as long as necessary to fulfil the purposes for which the personal data was collected. compliance officer.
