As at the date of the AGM, the total number of issued Shares was 5,201,250,000 Shares, which was the total number of Shares entitling the Shareholders to attend and vote on the ordinary resolutions at the AGM. A total of 2,907,464,620 Shares were held by the Shareholders who have attended and voted for or against the resolutions at the AGM. To the best of the Director’s knowledge, information and belief having made all reasonable enquiries, there were no Shares entitling the holders thereof to attend and abstain from voting in favour of the resolutions proposed at the AGM as set out in Rule 13.40 of the Listing Rules and no Shareholders were required under the Listing Rules to abstain from voting on the resolutions proposed at the AGM.
