Dear Shareholders,

On behalf of the board of directors (the "**Board**" or the "**Director(s)**") of China Agri-Products Exchange Limited (the "**Company**", together with its subsidiaries, collectively the "**Group**"), I am pleased to present to our shareholders the annual report for the twelve months ended 31 March 2021 (the "**Year**" or the "**year under review**"). During the Year, the Group recorded a turnover of approximately HK\$651 million, representing a decrease of approximately HK\$440 million as compared to that of the last financial period for the fifteen months ended 31 March 2020 (the "**Period**").

各位股東:

本人謹代表中國農產品交易有限公司(「本公司」, 連同其附屬公司統稱「本集團」)董事會(「董事會」或 「董事」)向各股東提呈截至二零二一年三月三十一 日止十二個月(「本年度」或「回顧年度」)之年度報 告。本年度,本集團錄得營業額約651,000,000港 元,較上一財政期間截至二零二零年三月三十一日 止十五個月(「該期間」)減少約440,000,000港元。

The Group has successfully built a nationwide chain of wholesale markets and a network of modern agricultural produce logistics center, linking the southern and northern regions and across the eastern and south-western parts of the PRC. During the year under review, the Group managed a total of 11 agricultural produce exchange markets in mainland China, covering Wuhan, Huangshi, Suizhou, Luoyang, Puyang, Kaifeng, Yulin, Qinzhou, Xuzhou, Huai'an and Panjin, with business spreading across various provinces, including Hubei Province, Henan Province, Guangxi Zhuang Autonomous Region, Jiangsu Province and Liaoning Province.

During the year under review, under the outbreak of Coronavirus Disease 2019 pandemic ("**COVID-19 pandemic**"), the business development of the Group remained stable due to its commitment to communal engineering project and the effective implementation of cost control measures. Given that Wai Yuen Tong Medicine Holdings Limited ("**WYT**" or "**controlling shareholder**"; stock code: 897) and parties acting in concert with it completed the partial share offer in respect of shares of the Group. The Group has changed its financial year end date for the financial years of 2019 and 2020 (the "**Previous Year**") to be aligned with that of its controlling shareholder. Accordingly, there are total fifteen months recorded in the accounts for the Previous Year and only twelve months recorded in the accounts as of 31 March 2021.

BUSINESS ENVIRONMENT

Since the reform and opening up, the People's Republic of China ("**China**" or the "**PRC**") has basically formed a supply chain of agricultural byproducts on the basis of the agricultural produce wholesale markets, which has played an important role in ensuring the supply of agricultural products and promoting the development of "Three Rural Issues". In the first quarter of 2020, the agricultural wholesale market has aroused social concern along with the outbreak of COVID-19 pandemic. The State Council of China has focused on "Three Rural Issues" since the No.1 Central Document was released in 2003 with continuous focus on the development of "Three Rural Issues" in No. 1 Central Document of 2021, in which one of the key contents of "accelerating agricultural modernization" is mentioned, further reflecting China's strong support and promotion of the development of agricultural produce wholesale markets and agricultural produce logistics industry. 本集團已成功建立縱貫華南華北、橫跨華東大西南 的全國性連鎖批發市場體系和現代化的農副產品物 流中心網絡。於回顧年度,本集團在中國內地管理 合共十一個農產品交易市場,分佈在武漢、黃石、 隨州、洛陽、濮陽、開封、玉林、欽州、徐州、淮 安及盤錦,業務遍及湖北省、河南省、廣西壯族自 治區、江蘇省及遼寧省等多個省份。

回顧年度內,新型冠狀病毒肺炎疫情(「新冠疫情」) 爆發下,由於本集團為民生工程項目,以及有效執 行成本控制措施,令本集團業務發展持續平穩。鑑 於位元堂藥業控股有限公司(「位元堂」或「控股股 東」:股份代號:897)及其一致行動人士,已於二 零二零年二月完成本公司股份的部分股份收購要 約,成為本集團之控股股東。本集團二零一九年至 二零二零年財政年度(「上年度」)結算日更改為與控 股股東一致,故此計入上年度的賬目共有十五個 月;計入本年度截至二零二一年三月三十一日止的 賬目只有十二個月。

業務環境

改革開放以來,中華人民共和國(「中國」或「國家」) 已經基本形成以農產品批發市場為體系的農副產品 供應鏈,在保障農產品供應、促進「三農」發展等方 面發揮了重要作用。二零二零年首季,新冠疫情爆 發,農貿批發市場一度成為社會關注熱點。國務 院自二零零三年開始的中央一號文件關注「三農」工 作,而二零二一年的中央一號文件持續聚焦「三農」 發展,其中提及重點內容之一的「加快推進農業現 代化」,再度反映國家大力支持及推進農產品批發 市場及農產品物流行業發展。

According to the data shown from the Ministry of Commerce of the PRC, there are currently 44,000 agricultural produce markets, including over 4,100 wholesale markets, of which 1,300 wholesale markets reach an annual transaction volume of more than RMB100 million, and nearly 40,000 agricultural trade markets, wet markets and bazaars. Approximately 70% of agricultural products are distributed nationwide through wholesale markets¹.

Currently, agricultural wholesale markets are the key market and main channel for popularizing agricultural products in China, connecting both ends of production and sales. In March 2021, the "Regulations of the State Council on Strengthening the Supervision and Administration of Agricultural Wholesale Markets (Exposure Draft)《國務院關於加強農產 品批發市場監督管理的規定(徵求意見稿)》" (the "Opinion") drafted by relevant departments of the State Council of China was issued to provide a legal basis for normalized epidemic prevention and control, among which the policy clarifies the regulatory responsibilities of local governments and relevant departments. On one hand, the Opinion requires market operators to possess appropriate qualifications and assume greater management responsibilities. On the other hand, it is proposed that people's governments at all levels should take effective measures and provide supporting policies. Such policies will facilitate the operation of agricultural wholesale markets in a more advanced manner while standardizing the laws to further raise the industry's entry barriers, which is conducive to achieving positive integration of the agricultural wholesale industry, separating the wheat from the chaff.

As a leading agricultural produce logistics and warehouse operator in mainland China, the Group, supported by national policies, is actively seizing the opportunity to standardize the development of agricultural wholesale markets, seeking suitable opportunities to expand the market and diversifying the market share of the existing agricultural wholesale markets. The Group believes that there is still a room for expansion. Meanwhile, it is expected to write a new chapter in the business development of the Group along further upgrade and transform of smart agricultural wholesale through digitalization.

根據中國商務部數據顯示,中國目前現有農產品市 場4.4萬家,其中批發市場4,100多家,年交易額在 人民幣億元以上的批發市場有1,300多家,農貿市 場、菜市場和集貿市場近4萬家。約70%農產品經 由批發市場分銷全國1。

農產品批發市場連接產銷兩端,是中國農產品流通 的關鍵場所和主要渠道。二零二一年三月,國務院 有關部門起草的《國務院關於加強農產品批發市場 監督管理的規定(徵求意見稿)》(「《意見》」)出台, 為常態化疫情防控提供法律依據,而當中政策明確 地方政府和有關部門監管職責,《意見》一方面要求 市場開辦及經營者應具備適當資質條件及承擔更大 管理責任,另一方面提出各級人民政府應採取有效 措施及給予支持政策,有關政策將使農產品批發市 場的經營更趨規模,並規範法令行業進入門檻進一 步提升,有利於農批行業實現良性的整頓,去蕪存 菁。

本集團作為中國內地領先的農產品物流聯合基地營 運商,受惠於國家政策支持,正積極把握農產品批 發市場建設規範化的機遇,積極尋求合適的機會拓 展市場,及現有農產品批發市場的分散市場份額, 本集團相信仍有很大的拓展空間,同時,為了進一 步以電子化為手段進行智慧農批升級改造,期望為 本集團業務發展寫上另一新篇章。

BUSINESS DEVELOPMENT

Under e-commerce, seizing new development opportunities in new era

As a leading agricultural produce logistics and warehouse operation in mainland China, the Group has fully introduced a new business model of electronic transaction settlement and a modern lease management system in all agricultural produce exchange markets under the increasing demand for digitalization in the "post-epidemic era". Accordingly, the Group took a big step forward in promoting the digitalization of agricultural wholesale business during the Year. According to the big data from the Group's electronic settlement, electronic payments are increasingly used between buyers and sellers instead of cash payments which result in higher risk of being infected since the outbreak of COVID-19 pandemic. In addition, the Group has switched all paper lease contracts to electronic ones. The operators are not required to make the payment in person. Alternatively, they can pay rent and property management fees online, and even enter into contracts online with electronic seals, which not only reduces costs, but also helps to grasp the situation of business transactions and promote the informatization of the Group's agricultural produce exchange markets.

Scientific management under the pandemic, equipped with sufficient risk prevention and control as well as cost control

Under the pandemic, the Group's advanced systematic management provides a good check on the risk prevention and control of the market. During the year under review, the Group implemented various nationwide measures to control the pandemic, in which the monitoring of imported cold chain food was exercised in stringent manner that the food was not allowed to be stored in the warehouse if officially recognized certification documents were not provided. Meanwhile, the Group has also strengthened the education on employees' antiepidemic awareness and adopted various strict anti-epidemic hygiene requirements for employees, tenants, customers and visitors when entering and exiting the agricultural produce exchange markets, requiring them to wear masks, measure body temperature, disinfect the hands, and present health codes. Notwithstanding the Group's business operation was slightly affected by COVID-19 pandemic, it is committed to integrating internal and external resources as well as strengthening the cost control to enhance operating efficiency.

業務發展

電子化營運模式抓緊新時代發展機遇

本集團作為中國內地領先的農產品物流營運商,在 「後疫情時代」的電子化需求更為殷切下,已在所有 農產品交易市場全面引進電子化交易結算新型商業 模式及現代化租賃管理系統,本年度本集團在推進 農批業務電子化更跨進一大步。根據本集團電子化 結算大數據顯示,自新冠疫情爆發以來,買賣雙方 因避免接觸現金增添染疫風險,轉而採用電子貨幣 交易的情況有增加趨勢。此外,本集團已將全部紙 質租賃合同轉為電子租賃合同,經營戶不需要親身 前往收費中心,可於線上繳交租金及物業管理費, 甚至線上電子蓋章簽約。此舉不但有效減低成本, 更有助掌握經營戶交易經營狀況,推進本集團農產 品交易市場信息化的建設。

疫下科學化管理 做足風險防控及成本控制

新冠肺炎疫情下,本集團先進系統化管理為市場的 風險防控做好把關。回顧年度內,本集團貫徹執行 國家對疫情控制的各項措施,其中對進口冷鏈食品 的監控極其嚴謹,沒有官方認可的證明文件一律不 得入庫。同時,本集團亦加強了職工的防疫意識教 育,並對進出農產品交易市場之員工、租戶、顧客 及訪客都採取要求配戴口罩、量度體溫、消毒雙 手、出示健康碼等各項嚴格的衛生防疫措施。儘管 新冠肺炎疫情對業務營運造成輕微影響,本集團堅 定整合內部及外部資源,加強成本控制,以提升營 運效益。

CORPORATE STRATEGY

"Opinions of the State Council on Comprehensively Pushing forward Rural Revitalization and Accelerating Modernization of Agriculture and Rural Areas (《關於全面推進鄉村振興加快農業農村現代化的意見》)", also known as the No.1 Central Document for 2021, published by the central government stated that "Three Rural Issues" should be well solved during the "14th Five-Year Plan" period, focusing on accelerating agricultural modernization, optimizing the distribution of agricultural products trading, supporting enterprises to integrate into the global agricultural product supply chain, as well as strengthening the port quarantine and prevention and control of invasive alien species².

Under the nationwide support of "Three Rural Issues" policy, the Group will integrate offline physical agricultural produce exchange markets and build an online agricultural produce exchange big data cloud platform. By fully displaying the advantages of the physical network in China and applying modern technology to manage five aspects: traffic, mobility, logistics, information flow and capital flow, a new generation of agricultural product supply chain logistics center will be upgraded and transformed with offline physical operation plus online smart agricultural wholesale combined.

In the era of electronic settlement transactions and big data, the informatization construction of agricultural produce exchange markets has been implemented. The Group has gradually improved the market rate mechanism by accurately grasping the actual transaction and business conditions of operators. In the long term, the Group will transform the traditional agricultural wholesale markets from a profit model that only charges fixed rent to one that mainly charges transaction commissions, which is able to drive market scale more flexibly and effectively as well as maintain profit growth.

Looking forward, the Group adheres to a business philosophy of "dedicated to developing agriculture with sincere in serving agriculture" and continues to invest in corporate resources, fully supporting the nationwide construction of "the vegetable basket (菜籃子)" and "the rice bag (米袋子)" for the communal engineering project. Through digitalization as the core means to ensure food safety as the primary responsibility, along with smart agricultural wholesale as the orientation of upgrade and transformation, high-quality and stable business performance as well as the broad prospects of sustainable growth, it will bring reasonable returns to shareholders.

企業策略

中央政府發佈《關於全面推進鄉村振興加快農業農 村現代化的意見》,即二零二一年中央一號文件, 指出「十四五」時期要堅持解決好「三農」問題,重點 提出要加快推進農業現代化,優化農產品貿易佈 局,支持企業融入全球農產品供應鏈,並加強口岸 檢疫和外來入侵物種防控²。

在國家「三農」政策的支持下,本集團將整合線下實 體農產品交易市場及建設線上農產品交易大數據雲 平台,充分發揮全國實體網絡優勢,應用現代化科 技管理「五流」:車流、人流、物流、信息流與資金 流,升級改造實體經營線下+智慧農批線上的新一 代農產品供應鏈物流中心。

在電子結算交易與大數據的時代背景下,農產品交 易市場的信息化建設落地,本集團通過對經營戶實 際交易經營狀況的準確掌握,逐步提升市場收費模 式。長遠而言,本集團將由傳統農產品批發市場只 收取固定場地租金的盈利模式,轉化為收取交易佣 金為主的盈利模式,能夠更靈活、更有效地驅動市 場規模化,保持利潤增長。

展望未來,本集團將秉持「以誠強農,以信惠農」的 經營理念,持續投入企業資源,全力支援國家「菜 籃子」及「米袋子」民生工程建設,以電子化為核心 手段、以保障食品安全為首要責任、以智慧農批為 升級改造導向、以優質穩定的業務表現、以可持續 增長的廣闊前景,為股東帶來合理回報。

The Group recorded a turnover of approximately HK\$651 million for the Year, representing a decrease of approximately 40% as compared to approximately HK\$1,091 million of the Period, which was mainly due to the decrease in property sales recognition and the extra three months of reporting data for the Period. The Group recorded a gross profit and a segment result of approximately HK\$352 million and approximately HK\$230 million, respectively, for the Year (Period ended 31 March 2020: approximately HK\$539 million and approximately HK\$337 million, respectively), representing a decrease of approximately 35% and a decrease of approximately 32%, respectively, as compared to that of the Period. The decrease in gross profit and segment result was mainly due to the decrease in property sales recognition and the extra three months of reporting data for the Period.

Other revenue and other net income

The Group recorded other revenue and other net income of approximately HK\$41 million for the Year (Period ended 31 March 2020: approximately HK\$20 million). The increase was mainly due to the government grant and subsidies.

本集團於本年度錄得營業額約651,000,000港元, 較該期間約1,091,000,000港元減少約40%,主要由 於確認的物業銷售減少及該期間多出三個月報告數 據所致。本集團於本年度錄得毛利及分部業績分別 約352,000,000港元及約230,000,000港元(截至二零 二零年三月三十一日止期間:分別約539,000,000 港元及約337,000,000港元),較該期間分別減少約 35%及減少約32%。毛利及分部業績減少主要由於 已確認的物業銷售減少以及該期間多出三個月報告 數據所致。

其他收益及其他淨收入

本集團於本年度錄得其他收益及其他淨收入約 41,000,000港元(截至二零二零年三月三十一日止 期間:約20,000,000港元),此增加主要由於政府補 助及補貼所致。

Gain on litigation judgment

The Group recorded gain on litigation judgment of approximately HK\$661 million for the Year (Period ended 31 March 2020: nil). This is resulting from the verdict of Wuhan market legal cases as disclosed in the announcement of the Company dated 18 January 2021, details of which have been disclosed in the section headed "Litigation" in this annual report and note 36 to the consolidated financial statements.

General and administrative expenses, selling expenses and finance costs

General and administrative expenses were approximately HK\$157 million for the Year (Period ended 31 March 2020: approximately HK\$200 million). The decrease was mainly due to the extra three months of reporting data for the Period. Selling expenses were approximately HK\$31 million for the Year (Period ended 31 March 2020: approximately HK\$97 million). The decrease in selling expenses was mainly due to the decrease in sales and promotion activities during the Year. Finance costs were approximately HK\$157 million for the Year (Period ended 31 March 2020: approximately HK\$227 million), and such decrease was mainly due to the early repayments of the convertible notes during the Year and decrease in interest-bearing debt as compared to the Period.

Loss on Early Redemption of Convertible Notes

The Group recorded loss on early redemption of convertible notes (the "**Convertible Notes**") of approximately HK\$5 million for the Year (Period ended 31 March 2020: nil). The increase in loss was mainly due to the Company partially redeemed the Convertible Notes in the principal amount of HK\$130 million on 9 December 2020.

Allowance for expected credit losses on trade and other receivables and loan receivables

The Group recorded allowance for expected credit losses on trade and other receivables and loan receivables of approximately HK\$43 million for the Year (Period ended 31 March 2020: approximately HK\$7 million). The increase was mainly due to the recognition of the long aged trade and other receivables and loan receivables.

Net loss in fair value of investment properties and written down of stock of properties

During the Year, net loss in fair value of investment properties was approximately HK\$14 million (Period ended 31 March 2020: net gain in fair value of investment properties of approximately HK\$149 million). The net loss was mainly due to decrease in fair value of Kaifeng Hongjin Agricultural and By-Product Exchange Market ("**Kaifeng Market**") and Xuzhou Hongjin Agricultural and By-Product Exchange Market ("**Xuzhou Market**"). Stock of properties value was written down for approximately HK\$2 million for the Year (Period ended 31 March 2020: approximately HK\$3 million) mainly due to written down of stock of properties of Huai'an Hongjin Agricultural and By-Product Exchange Market ("**Huai'an Market**").

訴訟判決之收益

本集團於本年度錄得訴訟判決收益約661,000,000 港元(截至二零二零年三月三十一日止期間:無)。 此乃由於本公司日期為二零二一年一月十八日之公 佈中所披露有關武漢市場法律訴訟之裁決所致,有 關詳情已於本年報「訴訟」一節及綜合財務報表附註 36披露。

一般及行政開支、銷售開支及融資成本

本年度一般及行政開支約157,000,000港元(截至 二零二零年三月三十一日止期間:約200,000,000 港元)。減少乃主要由於該期間多出三個月報告數 據所致。本年度銷售開支約31,000,000港元(截至 二零二零年三月三十一日止期間:約97,000,000 港元)。銷售開支減少主要由於本年度銷售及推 廣活動減少所致。本年度融資成本約157,000,000 港元(截至二零二零年三月三十一日止期間:約 227,000,000港元),該減少主要由於本年度提早償 還可換股票據以及計息債務較該期間減少所致。

提早贖回可換股票據虧損

本集團於本年度錄得提早贖回可換股票據(「**可換** 股票據」)虧損約5,000,000港元(截至二零二零年 三月三十一日止期間:無)。該虧損增加由於本 公司於二零二零年十二月九日部分贖回本金額為 130,000,000港元的可換股票據所致。

貿易及其他應收款項以及應收貸款之預期信 貸虧損撥備

本集團於本年度錄得貿易及其他應收款項以及應收 貸款之預期信貸虧損撥備約43,000,000港元(截至 二零二零年三月三十一日止期間:約7,000,000港 元)。此增加主要由於確認賬齡長的貿易及其他應 收款項以及應收貸款所致。

投資物業公平值淨虧損及物業存貨撇減

於本年度,投資物業公平值之淨虧損約14,000,000 港元(截至二零二零年三月三十一日止期間:投資 物業公平值之淨收益約149,000,000港元)。淨虧損 主要由於開封宏進農副產品交易市場(「開封市場」) 及徐州宏進農副產品交易市場(「徐州市場」)之公 平值減少所致。本年度物業存貨價值約2,000,000 港元已作撇減(截至二零二零年三月三十一日止期 間:約3,000,000港元),主要由於撇減淮安宏進農 副產品交易市場(「淮安市場」)之物業存貨所致。

Loss on fair value change of derivative financial instruments

During the Year, net loss in fair value of derivative financial instruments was approximately HK\$0.3 million (Period ended 31 March 2020: approximately HK\$2 million). The decrease of the net loss was due to the approaching of the due date of the Convertible Notes.

Profit attributable to owners of the Company

The profit attributable to owners of the Company for the Year was approximately HK\$490 million as compared to the profit of approximately HK\$6 million in the Period. Profit from operations before fair value changes and impairment, interest and tax was approximately HK\$866 million and the profit from operations was approximately HK\$802 million for the Year (Period ended 31 March 2020: approximately HK\$261 million and approximately HK\$399 million, respectively). The increase in profit attributable to owners of the Company was mainly due to gain on litigation judgment resulting from the verdict of Wuhan market legal case and a decrease in finance costs by early repayment of Convertible Notes during the Year and decrease in interest-bearing debt as compared to the Period.

DIVIDENDS

The Directors do not recommend any payment of final dividend for the Year (Period ended 31 March 2020: Nil). No interim dividend was paid to the shareholders of the Company (the "**Shareholders**") during the years 2020 and 2019.

REVIEW OF OPERATIONS

During the Year, the Group was principally engaged in management and sales of properties in agricultural produce exchange markets in the PRC. Since May 2020, the Coronavirus Disease 2019 (the "**COVID-19**") was gradually brought under control and our market operation restored to pre-pandemic level.

於本年度,本公司擁有人應佔溢利約490,000,000 港元,而該期間溢利則為約6,000,000港元。於 本年度,扣除公平值變動及減值、利息及税項 前的經營溢利約866,000,000港元及經營溢利約 802,000,000港元(截至二零二零年三月三十一日止 期間:分別約261,000,000港元及約399,000,000港 元)。本公司擁有人應佔溢利增加主要由於與該期 間相比,武漢市場法律訴訟裁決導致錄得訴訟判決 收益,以及由於本年度提早償還可換股票據而使融 資成本減少及計息債務減少所致。

股息

董事不建議派付本年度之任何末期股息(截至二零 二零年三月三十一日止期間:無)。本公司並無於 二零二零年及二零一九年向本公司股東(「**股東**」)派 付中期股息。

業務回顧

於本年度,本集團主要在中國從事農產品交易市場 之物業管理及銷售。自二零二零年五月起,2019 冠狀病毒(「新冠肺炎」)已經逐漸受控,我們的市場 營運亦恢復至疫前水平。

WUHAN BAISAZHOU Market 武漢白沙洲市場

Agricultural Produce Exchange Markets

Hubei Province

Wuhan Baisazhou Market

Wuhan Baisazhou Agricultural and By-Product Exchange Market ("**Wuhan Baisazhou Market**") is one of the largest agricultural produce exchange operators in the PRC. Wuhan Baisazhou Market is situated in the Hongshan District of Wuhan City, the PRC with a site area of approximately 310,000 square metres and a total gross floor area of approximately 190,000 square metres. In 2020, Wuhan Baisazhou Market was awarded top 10 of agricultural produce exchange market by China Agricultural Wholesale Market Association. The award was a sign to the market contribution being made by the Group's effort and expertise as an agricultural produce exchange market operator in the PRC.

During the Year, the market related legal disputes have come to a positive outcome. For details, please refer to the section headed "Litigation" in this report and note 36 to the consolidated financial statements of this annual report.

The outbreak of the COVID-19 significantly affected the market performance of Wuhan Baisazhou Market in early 2020. When the epidemic began, the Wuhan local government limited the market operation scale as a control measure which lasted until late April 2020, and resumed normal operation afterwards. Wuhan Baisazhou Market was titled "An Outstanding Enterprise in Contributing to the Epidemic Prevention and Control and Supply Guarantee in Wuhan" by the Supplies Security Section under the Wuhan's Epidemic Prevention and Control Division for its remarkable contributions towards "supply guarantee".



湖北省 *武漢白沙洲市場*

武漢白沙洲農副產品交易市場(「武漢白沙洲市場」) 乃全中國最大之農產品交易市場營運商之一。武漢 白沙洲市場位於中國武漢市洪山區,佔地面積約 310,000平方米及總建築面積約190,000平方米。於 二零二零年,武漢白沙洲市場榮獲全國城市農貿中 心聯合會評為「中國農產品十佳市場」。該獎項表彰 本集團作為中國農產品交易市場營運商以其努力及 專業知識對市場所作出的貢獻。

於本年度,市場相關的法律糾紛經已取得正面成 果。有關詳情,請參閱本報告中「訴訟」一節及本年 報之綜合財務報表附註36。

爆發新冠肺炎疫情嚴重影響武漢白沙洲市場於二零 二零年初之市場表現。疫情爆發後,武漢當地政府 限制市場營運規模,該控制措施持續至二零二零年 四月底,其後市場已全面恢復正常營運。武漢白沙 洲市場對「保供應」之卓越貢獻榮獲武漢市新冠肺炎 疫情防控指揮部物資保障組評為「武漢市疫情防控 保供突出貢獻企業」。





HUANGSHI Market 黄石市場

Huangshi Market

Huangshi Hongjin Agricultural and By-Product Exchange Market ("**Huangshi Market**") is a joint venture project of the Group founded in January 2015 with an operating area of approximately 23,000 square metres. Huangshi city is a county level city in Hubei and around 100 kilometres away from Wuhan Baisazhou Market. Huangshi Market, as a second-tier agricultural produce exchange market, created synergy effect with Wuhan Baisazhou Market, facilitating vegetables and by-products trading. During the Year, the operation turnover of Huangshi Market was approximately HK\$6 million.

黃石市場

黃石宏進農副產品交易市場(「黃石市場」)為本集團 於二零一五年一月成立的合營項目,經營面積約 23,000平方米。黃石市是湖北省的縣級市,距離武 漢白沙洲市場約100公里。作為次級農產品交易市 場,黃石市場能夠與武漢白沙洲市場產生協同作 用,促進蔬菜及副產品交易。於本年度,黃石市場 的經營營業額約為6,000,000港元。



SUIZHOU Market 随州市場

Suizhou Baisazhou Agricultural and By-Product Exchange Market ("**Suizhou Market**") is another joint venture project of the Group founded in March 2018. It occupied approximately 240,000 square metres. The Group pursued asset-light operation business model by taking up the contract management rights to operate this market. During the Year, the operation performance of Suizhou Market improved and grew gradually.

隨州市場

隨州白沙洲農副產品交易市場(「**隨州市場**」)為本集 團於二零一八年三月成立的另一個合營項目,佔地 約240,000平方米。本集團採用輕資產營運業務模 式,透過取得合約管理權以經營該市場。於本年 度,隨州市場的經營表現有所改善並逐步增長。

During the Year, Puyang Market faced a keen competition from a new market. The market turnover for the Year decreased approximately 22% due to the decrease of properties sale recognition during the Year as compared to that of the Period.

濮陽市場

濮陽宏進農副產品交易市場(「**濮陽市場**」)是我們與 中國河南省當地夥伴合作的合營項目之一。於本年 度,濮陽市場面臨新興市場的激烈競爭。由於本年 度物業銷售的確認減少,市場營業額較該期間減少 約22%。



KAIFENG Market 開封市場

Kaifeng Market

Kaifeng Market, with a gross floor construction area of approximately 120,000 square metres, is the Group's third market operation point for the facilitation of the building of an agricultural produce market network in Henan Province, the PRC. During the Year, the turnover of Kaifeng Market improved approximately 499% due to the closure of competitive wholesale market in Kaifeng as compared to that of the Period.

開封市場

開封市場之總建築面積約120,000平方米,為本集 團位於河南省的第三個市場營運據點,其有助本集 團於中國河南省建立農產品市場網絡。於本年度, 由於位於開封的競爭對手批發市場關閉,開封市場 的營業額較該期間增加約499%。



YULIN Market 玉林市場

Guangxi Zhuang Autonomous Region Yulin Market

Yulin Hongjin Agricultural and By-Product Exchange Market ("**Yulin Market**") is one of the largest agricultural produce exchange markets in Guangxi Zhuang Autonomous Region, the PRC ("**Guangxi Region**") with a site area of approximately 415,000 square metres and a total gross floor area of approximately 196,000 square metres. The turnover of Yulin Market was decreased approximately 54% due to the decrease of properties sale recognition during the Year as compared to that of the Period.

廣西壯族自治區

玉林市場

玉林宏進農副產品交易市場(「**玉林市場**」)是中國廣 西壯族自治區(「**廣西地區**」)最大的農產品交易市場 之一,佔地面積約415,000平方米及總建築面積約 196,000平方米。於本年度,玉林市場的營業額較 該期間下跌約54%,乃由於物業銷售確認下跌。



QINZHOU Market 欽州市場

Qinzhou Hongjin Agricultural and By-Product Exchange Market ("**Qinzhou Market**"), with a gross floor construction area of approximately 180,000 square metres, is the Group's second market operation point for the facilitation of the building of an agricultural produce market network in the Guangxi Region. During the Year, the Group focused on enhancing the operation performance of Qinzhou Market and it resulted in a decrease of approximately 5% in operation turnover as compared to that of the Period.

欽州市場

欽州宏進農副產品交易市場(「**欽州市場**」)之總建築 面積約180,000平方米,為本集團第二個市場營運 據點,其有助本集團於廣西地區建立農產品市場網 絡。於本年度,本集團專注提升欽州市場之經營表 現,經營營業額較該期間減少約5%。

Xuzhou Market occupies approximately 200,000 square metres and is located in the northern part of Jiangsu Province, the PRC. The operation performance of Xuzhou Market was steady.

HUAI'AN Market 淮安市場

Huai'an Market

Huai'an Market, with contracted operating area of approximately 100,000 square metres, is located at Huai'an City of Jiangsu Province, the PRC. Phase one of Huai'an Market had been in operation since October 2015 and it is expected that the performance of Huai'an Market will gradually improve after the market becomes more mature. During the Year, the Company is under a legal dispute with the joint venture partner, details of which were disclosed in note 36 to the consolidated financial statements of this annual report.

PANJIN Market 盤錦市場

Panjin Market

Phase one of Panjin Market, with a construction area of around 50,000 square metres, is the Group's first attempt in investment in Liaoning Province, the PRC. Panjin Market focused on the trading of river crabs and held regular market fairs. During the Year, the performance of Panjin Market was steady.

盤錦市場一期之建築面積約50,000平方米,為本集 團首個嘗試在中國遼寧省投資之項目。盤錦市場集 中於河蟹買賣並定期舉行交易會。於本年度,盤錦 市場表現穩健。



E-commerce development

With the robust mobile network and widespread use of intelligent mobile devices in the PRC, the Group allocated cost effective resources to e-commerce development. The Group would also explore opportunities to cooperate with other business partners or study to set up new e-commerce development team in this area.

Cyber risk and security

With information technology system and internet network playing a vital role in our operation, the Group has designated professionals to monitor and assess potential cyber risks. Both hardware and software are kept track with appropriate Company's policies. Potential cyber risks and network security are the key concerns of management, thus the Group has formulated policies and procedures to regulate the use of internet, physically safeguard system power supply and regularly update internet protection system and firewall to separate the Company's intranet from the outside network. Designated professionals are responsible for the day-to-day monitoring on any abnormal network activities.

Data fraud or theft risk

The Group continuously reviews and updates its internal control system on data and information access. Appropriate policies have been adopted to protect data, and access permissions are only granted to the authorised personnel. Management believes effective policies and procedures are in place to avoid data fraud or theft risk.

Environmental and social risk

Due to the nature of business, the Company will face a moderate environmental risk if serious and permanent climate change happens in the PRC. Such risk may cause an adverse impact on agricultural production and affect the Company's turnover from market operation and property sales.

COVID-19 outbreak

During the COVID-19 epidemic, the PRC government have imposed various measures to constraint the spread of the virus. These included limiting the locomotion of people and vehicles and strengthening the markets hygiene controls. These measures lowered the market trading activities and related commission income. Since agri-products exchange market is a critical link on daily necessaries supply chain, the local governments closely monitored markets' operation and assisted the operation back to normal via different measures. These included reducing governmental fees and taxes, and compensating business loss during the epidemic. As the epidemic began to be under control since early 2020, the trading volume and income of our markets have been gradually restored to normal level.

電子商務發展

隨著強大的移動通訊網絡及智能手機在中國廣泛使 用,本集團已將具成本效益的資源投入發展電子商 務,本集團亦將尋求其他業務夥伴在該領域的合作 機會,並研究建立新電子商務開發團隊。

網絡風險及安全

隨著資訊科技系統及互聯網網絡在我們的營運中扮 演重要角色,本集團已指派專業人士監控及評估潛 在的網絡風險。硬件及軟件均緊貼本公司適當的政 策。潛在的網絡風險及網絡安全是管理層的主要關 注,因此本集團已制定政策及程序來規範互聯網的 使用、系統供電的實質維護以及定期更新互聯網保 護系統及防火牆,將本公司內聯網與外界網絡隔 離。獲指派的專業人士負責對任何異常網絡活動進 行日常監控。

數據欺詐或盜竊風險

本集團不斷審視並更新其數據及資料取用的內部監 控系統。本集團已採納適當政策以保護數據,只允 許獲授權人士登入訪問。管理層認為,有效的政策 及程序已落實,以避免數據欺詐或盜竊風險。

環境及社會風險

基於業務性質,如中國發生嚴重且永久的氣候變 化,本公司將面臨中度的環境風險。該風險可能對 農業生產造成不利影響,並影響本公司市場營運及 物業銷售的營業額。

爆發新冠肺炎疫情

於爆發新冠肺炎疫情期間,中國政府已採取各種措施以控制病毒傳播,包括限制人員及車輛活動,以 及加強市場的衛生管制。該等措施降低了市場買賣 活動及相關佣金收入。農產品交易市場是日常必需 品供應鏈關鍵的一環,地方政府密切監控市場營 運,並透過各種措施幫助營運恢復正常。該等措施 包括下調政府收費及税項,並補貼疫情期間的業務 虧損。由於疫情自二零二零年初開始受控,我們市 場的交易量及收入已逐步恢復正常水平。

RECLASSIFICATION OF INVESTMENT PROPERTIES TO STOCK OF PROPERTIES

During the Year, the Group has reclassified the investment properties of Luoyang Market to stock of properties in the amount of approximately HK\$0.6 million due to the change of sale plan and business strategy to increase sale of properties.

LIQUIDITY AND FINANCIAL RESOURCES

As at 31 March 2021, the Group had total cash and cash equivalents amounting to approximately HK\$425 million (31 March 2020: approximately HK\$340 million) whilst total assets and net assets were approximately HK\$5,584 million (31 March 2020: approximately HK\$5,139 million) and approximately HK\$2,206 million (31 March 2020: approximately HK\$1,485 million), respectively. The Group's gearing ratio as at 31 March 2021 was approximately 0.4 (31 March 2020: approximately 1.0), being a ratio of total bank and other borrowings, bond and promissory notes of approximately HK\$1,371 million (31 March 2020: approximately HK\$1,811 million), net of cash and cash equivalents of approximately HK\$425 million (31 March 2020: approximately HK\$4340 million) to shareholders' funds of approximately HK\$2,206 million (31 March 2020: approximately HK\$1,485 million).

As at 31 March 2021, the ratio of total interest-bearing debts of approximately HK\$1,371 million (31 March 2020: approximately HK\$1,811 million) to total assets of approximately HK\$5,584 million (31 March 2020: approximately HK\$5,139 million) was approximately 25% (31 March 2020: approximately 35%).

CONVERTIBLE NOTES

On 19 October 2016, the Company issued the Convertible Notes with the aggregate principal amount of HK\$500 million which will mature on 18 October 2021, which entitle the holders to convert into the shares of the Company (the "**Share(s**)") at a conversion price of HK\$0.4 per Share. During the Year, no Convertible Notes were converted into Shares by the Convertible Notes' holders. On 9 December 2020, the Company partially redeemed the Convertible Notes in the principal amount of HK\$130 million. As at 31 March 2021, there were outstanding Convertible Notes in the principal amount of HK\$134.8 million.

投資物業重新分類至物業存貨

於本年度,由於變更了銷售計劃及業務策略以增加 物業銷售,本集團已將洛陽市場的投資物業重新分 類至物業存貨,金額約600,000港元。

流動資金及財務資源

LISTED NOTES DUE IN 2024 (THE "LISTED NOTES")

In May 2014, the Company established a HK\$1,000 million medium term note program. The Listed Notes issued under the program are listed on the Stock Exchange by way of debt issue to professional investors only (stock code: 5755). As at 31 March 2021, the Listed Notes in the principal amount of HK\$290 million remained outstanding.

CAPITAL COMMITMENTS, PLEDGES AND CONTINGENT LIABILITIES

As at 31 March 2021, outstanding capital commitments, contracted but not provided for, amounted to approximately HK\$241 million (31 March 2020: approximately HK\$398 million) in relation to the purchase of property, plant and equipment, construction contracts and operating lease agreements. As at 31 March 2021, the Group had significant contingent liabilities in the amount of approximately HK\$27,000 in relation to the guarantees provided by a wholly-owned subsidiary of the Company to our customers in favor of a bank for the loans provided by the bank to the customers of our project (31 March 2020: approximately HK\$0.6 million).

As at 31 March 2021, certain investment properties and stock of properties with carrying amount of approximately HK\$1,405 million (31 March 2020: approximately HK\$1,633 million for land use right and properties) were pledged to secure certain bank borrowings.

The Group did not have any outstanding foreign exchange contracts, interest or currency swaps or other financial derivatives as at 31 March 2021. The revenue, operating costs and bank deposits of the Group were mainly denominated in Renminbi ("**RMB**") and Hong Kong dollars. The activities of the Group are exposed to foreign currency risks mainly arising from its operations in mainland China and certain bank deposits denominated in RMB. Currently, the Group does not have a foreign currency hedging policy. During the Year, due to the currency fluctuation of RMB against Hong Kong dollars, the Group had been considering, from time to time, alternative risk hedging tools to mitigate RMB currency exchange risk.

TREASURY POLICY

The Group's treasury policy includes diversifying the funding sources. Internally generated cash flow and interest-bearing bank/non-financial institution loans were the general sources of funds to finance the operation of the Group during the Year. The Group regularly reviews its major funding positions to ensure that it has adequate financial resources in meeting its financial obligations. In order to meet interestbearing debts and business capital expenditure, the Group from time to time considers various alternatives including equity and debt financing including but not limited to new share placing, rights issues of new shares, financial institution borrowings, non-financial institution borrowings, bonds issuance, convertible notes, other debt financial instruments, disposal of investment properties and sales of stock of properties.

CONTRACTUAL ARRANGEMENT OF E-COMMERCE BUSINESS

Shenzhen Gudeng Technology Limited ("**Shenzhen Gudeng**"), established in 2015, was an indirectly-owned subsidiary of the Group carrying out the business of e-commerce and electronic trading platform of the Group. For the compliance of the PRC regulatory requirements, on 11 July 2016, the Group entered into an agreement to transfer its entire interest in Shenzhen Gudeng to a nominee shareholder and further entered into a series of contractual arrangements after obtaining the Internet Content Provider license issued by the Communication Authority of Guangdong Province to enable the Group to manage and operate the Internet Content Provider services of Shenzhen Gudeng. During the Year, the above said contractual arrangements were still valid and effective between the nominee shareholder and the Group.

財務政策

本集團的財務政策包括多元化資金來源。於本年 度,本集團營運的一般資金來源為內部產生現金流 量及計息銀行/非金融機構貸款。本集團定期檢討 其主要資金狀況,以確保其有足夠財政資源履行其 財務責任。為滿足計息債務及業務資本支出,本集 團不時考慮各種股本及債務融資方案,包括但不限 於配售新股份、以供股方式發行新股份、金融機構 借貸、非金融機構借貸、發行債券、可換股票據、 其他債務金融工具、出售投資物業及銷售物業存 貨。

電子商務業務的合約安排

深圳谷登科技有限公司(「**深圳谷登**」)於二零一五年 成立,為本集團的間接附屬公司,經營本集團的電 子商務及電子交易平台業務。為符合中國監管要 求,於二零一六年七月十一日,本集團訂立一份協 議,將其於深圳谷登的全部股權轉讓予一名代名人 股東,並在取得廣東省通信管理局發放的電信與信 息服務業務經營許可證後訂立一系列合約安排,令 本集團可管理及經營深圳谷登的電信與信息服務。 於本年度,上述合約安排仍然對該代名人股東及本 集團有效。

MATERIAL VALUATION METHOD OF INVESTMENT PROPERTIES AND REVIEW OF AUDIT COMMITTEE

The investment properties of the Group were stated at fair value as at 31 March 2021. The fair value was arrived at based on the valuations carried out by an independent firm of qualified professional valuers. The professional valuers are professional members of The Hong Kong Institute of Surveyors with experience in the location of the properties being valued. The valuations are confirmed to be in accordance with HKIS Valuation Standards 2017, which incorporates the International Valuation Standards (IVS). The professional valuers valued the investment properties on the basis of capitalisation of the net income derived from properties rental and made reference to the asking or transaction price of market comparable. For inventory portions of the properties, Direct Comparison Method is adopted based on the principle of substitution, where comparison is made based on prices realised on actual sales and/or asking prices of comparable properties. Comparable properties of similar size, scale, maturity, character and location are analysed and carefully weighed against all the respective advantages and disadvantages of each property in order to arrive at a fair comparison of market value.

The material valuation methods of investment properties valuation have been reviewed by the audit committee of the Company (the "Audit Committee") and the Board.

本公司審核委員會(「**審核委員會**」)及董事會已審閲 投資物業估值的重大估值方法。

RISK FACTORS RELATING TO OUR INDUSTRY AND BUSINESS OPERATIONS

As at 31 March 2021, the Group operated 11 agricultural produce exchange markets across 5 provinces in the PRC. In view of the everchanging business environment in the PRC, the following risks are the principal risks, challenges and uncertainties faced by the Group, including: (1) fluctuation in the exchange rate of RMB against Hong Kong dollars, which affects the translation of the PRC assets and liabilities from RMB to Hong Kong dollars in the Group's financial reporting, in view of which the Group periodically monitor the exchange rate fluctuation, and prepare effective hedging mechanism to tackle when adverse condition happens; (2) difficulty in obtaining adequate financing, including equity and debt financing, to support our agri-products exchange markets that are capital intensive, in view of which the Group regularly reviews the short-term and long-term liquidity level to prepare for the future needs, as and when appropriate; (3) preserving or enhancing our competitive position in the agri-products exchange markets industry, in view of which the Group has designated personnel to monitor our competitors' activities and formulate effective strategies to preserve our competitive position; (4) maintaining or enhancing the level of occupancy at our agriproducts exchange markets, in view of which the Group launches, from time to time, various marketing campaigns to retain existing tenants and to attract new tenants; (5) obtaining all necessary licenses and permits for the development, construction, operations and acquisition of agriproducts exchange markets, in view of which the Group hires sufficient local staff with professional qualifications to ensure all processes comply with local laws and regulations; (6) the effect of changes and amendments in the national and local laws and regulations, especially the laws and regulations relating to agri-products exchange markets, on the Group's operations and development, in view of which the Group maintains a relatively flat organizational structure with high autonomy to enable fast reaction to changes; and (7) the effect of close down agricultural produce exchange market when COVID-19 may probably break out in our markets.

有關我們行業及業務營運的風險因 素

於二零二一年三月三十一日,本集團於中國五個省 份經營十一個農產品交易市場。由於中國營商環境 瞬息萬變,本集團面對以下主要風險、挑戰及不確 定因素,包括:(1)人民幣兑港元匯率波動,其影 響本集團財務報告中由人民幣匯兑至港元的中國資 產及負債,為此本集團定期監察匯率波動,並在發 生不利狀況時制定有效的對沖解決機制:(2)難以 取得足夠融資(包括股權及債務融資)以支持我們資 本密集的農產品交易市場,為此本集團定期審閱短 期及長期流動資金水平,適時為未來需求做好準 備;(3)保持或提升我們於農產品交易市場行業的 競爭地位,為此本集團已指派人員監察競爭對手 的活動,並制定有效的策略維持我們的競爭地位; (4)保持或提高我們的農產品交易市場出租率,為 此本集團不時推出各種營銷活動,以挽留現有租戶 並吸引新租戶;(5)取得開發、建設、營運及收購 農產品交易市場的所有必要牌照及許可,為此本集 團聘用足夠且具專業資格的當地員工,以確保所有 過程符合當地法律及法規;(6)國家及地方的法律 及法規(尤其是有關農產品交易市場的法律及法規) 變動及修訂對本集團的營運及發展的影響,為此本 集團維持相對扁平化的組織架構及高度自治性,以 確保迅速應對各種轉變;及(7)於我們的農產品交 易市場可能爆發新冠肺炎時關閉市場。

DEPENDENCE OF EMPLOYEES, CUSTOMERS AND 對僱員、客戶及供應商之依賴 SUPPLIERS

As the Group is adopting market remuneration practices by reference to market terms, company performance, and individual qualifications and performance and well-organized structure management, no key and specific employee would materially and significantly affect the Group's success. Meanwhile, there were no major customers and suppliers which accounted for over 5% of the Group's income and no major suppliers which cannot be replaced by other appropriate suppliers. In this connection, no customers and suppliers would have material impact on the success of the Group's business performance.

ENVIRONMENTAL POLICIES AND PERFORMANCE

The operations and development of agri-products exchange markets are subject to a variety of environmental laws and regulations during their construction and operations. Major environmental impacts are caused by waste and wastewater generated during the construction and operations of the markets. The Group has, in compliance with the PRC environmental law, engaged independent environmental consultants to conduct environmental impact assessments on all of our construction projects in all material aspects. The environmental investigations conducted to date have not revealed any environmental liability that would be expected to have a material adverse effect on our business condition. Upon completion of construction of each market, the environmental authorities inspect the site to ensure compliance with all applicable environmental standards. All our construction projects comply with the "three simultaneities" principles stipulated in the Environmental Protection Law of the PRC. For further details of the impact of environmental laws and regulations on our operations and our environmental policies, please refer to our Environmental, Social and Governance Report to be published in compliance with the requirements under the Listing Rules.

環境政策及表現

在農產品交易市場的建設及營運過程中,其發展及 營運受各種與環境有關的法律及法規所規限。在建 設及營運市場時所產生的廢物及污水構成對環境的 主要影響。本集團已在所有重大方面遵守中國環保 法,並委聘獨立環境顧問對我們所有建設項目進行 環境影響評估。迄今已開展的環境調查並無顯示預 期對我們的經營狀況造成重大不利影響的任何環境 責任。各市場建設完成後,環境部門巡查市場,以 確保遵守所有適用的環境標準。我們所有的建設項 目均遵從中國環境保護法訂明的「三同時」原則。有 關環境法律及法規對我們的營運及環境政策所帶來 的影響的更多詳情,請參閱根據上市規則規定將予 刊發之環境、社會及管治報告。

COMPLIANCE WITH LAWS AND REGULATIONS

During the Year, the Group complied in material aspects with the relevant laws and regulations that have a significant impact on the business and operation of the Group. The Company also complied with the requirements under the Listing Rules, the Securities and Futures Ordinance and the laws of Bermuda during the Year. The Group continuously reviews newly enacted laws and regulations affecting the operations of the Group, if any, and provides relevant trainings and guidance to the staff.

SIGNIFICANT INVESTMENT HELD, MATERIAL ACQUISITIONS AND DISPOSALS OF SUBSIDIARIES, AND FUTURE PLANS FOR MATERIAL INVESTMENTS OR CAPITAL ASSETS

Save for the subsidiaries of the Company, there was no significant investment held, nor was there any material acquisition or disposal of subsidiaries during the Year. As at 31 March 2021, the Group did not have a concrete plan for material investments or capital assets nor acquisition or disposal of subsidiaries.

LITIGATION

References were made to the announcements of the Company dated 11 January 2011, 22 May 2012, 19 June 2014, 4 July 2014, 13 January 2015, 14 January 2015, 28 May 2015, 8 January 2016, 11 January 2016, 24 May 2016, 31 August 2016, 19 April 2017, 11 May 2017, 27 December 2018, 11 March 2020 and 30 March 2021 in relation to the civil proceedings (the "**Legal Proceedings**") in the PRC initiated by Ms. Wang Xiu Qun ("**Ms. Wang**") and Wuhan Tian Jiu Industrial and Commercial Development Co., Ltd ("**Tian Jiu**") as plaintiffs against the Company as defendant and joined Wuhan Baisazhou Agricultural By-Product Grand Market Company Limited ("**Baisazhou Agricultural**") as third party and other related legal proceedings.

遵守法律及法規

於本年度,本集團於各重大方面遵守對本集團業務 及營運有重大影響的相關法律及法規。本公司於本 年度內亦已遵守上市規則、證券及期貨條例以及百 慕達法律的規定。本集團持續審閲影響本集團營運 的新頒佈法律及法規(如有),並向員工提供相關培 訓及指引。

所持重大投資、重大收購及出售附 屬公司以及重大投資或資本資產的 未來計劃

於本年度,除本公司的附屬公司外,概無持有重大 投資,亦無任何附屬公司的重大收購或出售。於二 零二一年三月三十一日,本集團並無重大投資、資 本資產或收購或出售附屬公司的具體計劃。

訴訟

 兹提述本公司日期為二零一一年一月十一日、二零 一二年五月二十二日、二零一四年六月十九日、二 零一四年七月四日、二零一五年一月十三日、二零 一五年一月十四日、二零一五年五月二十八日、二 零一六年一月八日、二零一六年一月十一日、二零 一六年五月二十四日、二零一六年八月三十一日、 二零一七年四月十九日、二零一七年五月十一日、 二零一八年十二月二十七日、二零二零年三月十一日 日及二零二一年三月三十日之公佈,內容有關王秀 群女士(「王女士」)及武漢天九工貿發展有限公司 (「天九」)(作為原告)於中國針對本公司(作為被告) 及牽涉武漢白沙洲農副產品大市場有限公司(「白沙 洲農副產品」,作為第三方)提出的民事訴訟(「法律 訴訟])及其他相關法律訴訟。

Ms. Wang and Tian Jiu alleged that the share transfer agreements in relation to the acquisition of an aggregate of 90% interest in Baisazhou Agricultural by the Company from Ms. Wang as to 70% thereof and Tian Jiu as to 20% thereof (the "**Contended Agreements**") were forged. They sought an order from the Higher People's Court of Hubei Province, the PRC (the "**Hubei Court**") that the Contended Agreements were void and invalid from the beginning and should be terminated and claimed against the Company and Baisazhou Agricultural all relevant profits of Baisazhou Agricultural which were attributable to Ms. Wang and Tian Jiu, together with costs of the Legal Proceedings.

The Company received the judgment from the Hubei Court in relation to the Legal Proceedings (the "**Hubei Court Judgment**") in June 2014. By the Hubei Court Judgment, the Hubei Court dismissed the claims of Ms. Wang and Tian Jiu, and ordered Ms. Wang and Tian Jiu to bear the legal costs of the Legal Proceedings. Ms. Wang and Tian Jiu filed an appeal notice to the Supreme People's Court of the PRC (the "**Supreme Court**"). On 13 January 2015, the Company received the judgment (the "**Beijing Judgment**") handed down from the Supreme Court in relation to Ms. Wang and Tian Jiu's appeal against the Hubei Court Judgment. The Supreme Court ordered that (i) the Hubei Court Judgment be revoked; (ii) the Contended Agreements were void; and (iii) acknowledged that the HK\$1,156 million sale and purchase agreement (the "**SPA**") shall be the actual agreement being performed by the Company, Ms. Wang and Tian Jiu.

In May 2015, Ms. Wang and Tian Jiu jointly commenced legal proceedings against the Ministry of Commerce ("**MOFCOM**") of the PRC alleging that MOFCOM failed to discharge its statutory duties for handling their application submitted in January 2015 for revoking the certificate of approval and letter of approval in relation to the Contended Agreements (the "**Application**"). The cases were accepted by the Beijing Second Intermediate People's Court (the "**Beijing Court**") in May 2015. The Company and Baisazhou Agricultural then made an application to join the cases as third party. On 8 January 2016, the Company received a judgment dated 31 December 2015 issued by the Beijing Court, by which the Beijing Court demanded MOFCOM to handle the Application again within 30 days.

On 23 May 2016, the Company received a decision (the "**Decision**") issued by MOFCOM dated 19 May 2016 to the effect, among other things, that its approval issued in November 2007 (the "**Approval**") in relation to the Contended Agreements shall not be revoked and shall remain to be in force. In making the Decision, MOFCOM considered that the revocation of the Approval as requested by Ms. Wang and Tian Jiu may cause serious damage to the public interest.

王女士及天九聲稱有關本公司收購白沙洲農副產 品合共90%權益(向王女士收購70%及向天九收購 20%)的股份轉讓協議(「爭議協議」)乃偽造。彼等 尋求中國湖北省高級人民法院(「湖北法院」)頒令爭 議協議自始無效及應當終止,及向本公司及白沙洲 農副產品申索應當屬於王女士及天九的白沙洲農副 產品所有相關溢利連同法律訴訟之訟費。

本公司於二零一四年六月收到湖北法院有關法律訴 訟的判決(「湖北法院判決」)。依據湖北法院判決, 湖北法院駁回王女士及天九的申索,並判令王女士 及天九承擔法律訴訟之訟費。王女士及天九向中國 最高人民法院(「最高法院」)提交行政上訴狀。於二 零一五年一月十三日,本公司收到最高法院作出有 關王女士及天九對湖北法院判決上訴的判決(「北京 判決」)。最高法院頒令:(i)撤銷湖北法院判決;(ii) 爭議協議無效:及(iii)承認1,156,000,000港元之買 賣協議(「買賣協議」)須為本公司、王女士及天九履 行之實際協議。

於二零一五年五月,王女士及天九共同對中國商務 部(「商務部」)提出法律訴訟,指稱商務部未能履行 其法定職責,處理王女士及天九於二零一五年一月 就撤銷有關爭議協議之批准證書及批復提交之申請 (「申請」)。案件已於二零一五年五月獲北京第二中 級人民法院(「北京法院」)受理。本公司及白沙洲農 副產品其後申請作為第三方加入該等案件。於二零 一六年一月八日,本公司收到北京法院發出日期為 二零一五年十二月三十一日的判決,據此北京法院 要求商務部於30天內再次處理申請。

於二零一六年五月二十三日,本公司收到商務部 發出之日期為二零一六年五月十九日之決定(「決 定」),確認(其中包括)其於二零零七年十一月就爭 議協議發出之批准(「批准」)將不予撤銷並繼續有 效。於作出決定時,商務部已考慮到按王女士及天 九之要求撤銷批准可能會對公眾利益造成重大損 害。

Upon the making of the Decision by MOFCOM that the Approval shall not be revoked and shall remain in force in August 2016, the Company noted that Ms. Wang and Tian Jiu had brought another administrative proceedings (the "Administrative Proceedings") to the Beijing Court. According to a writ dated 3 August 2016, Ms. Wang and Tian Jiu requested the Beijing Court to revoke the Decision and to order MOFCOM to make a decision to revoke the Approval. According to a notice issued by the Beijing Court dated 26 August 2016 together with the writ which was served to the Company on 30 August 2016, each of the Company and Baisazhou Agricultural has been added as third party by the Beijing Court to the Administrative Proceedings.

On 18 April 2017, the Company received the judgment of the Beijing Court dated 31 March 2017 (the "**31 March Judgment**") stating that the request made by Ms. Wang and Tian Jiu to revoke the Decision lacked both legal and factual basis and was not supported by the Beijing Court. Accordingly, the Beijing Court dismissed the application of Ms. Wang and Tian Jiu.

On 10 May 2017, the Company received a notice of appeal dated 8 May 2017 (the "**Notice of Appeal**"). By the Notice of Appeal, Ms. Wang and Tian Jiu appealed against the 31 March Judgment and requested for an order that (a) the 31 March Judgment be set aside and (b) MOFCOM to make a decision to revoke the Approval.

On 30 August 2017, the hearing for the appeal against the 31 March Judgment took place. On 24 December 2018, the Company received the judgment of the Beijing High People's Court dated 20 December 2018 (the "**20 December Judgment**"). By the 20 December Judgment, the Beijing High People's Court dismissed the appeal of Ms. Wang and Tian Jiu and upheld the ruling of the Beijing Court as set out in the 31 March Judgment.

On 4 March 2020, the Company noted the judgment of the Supreme Court dated 31 December 2019 (the "**31 December Judgment**"). By the 31 December Judgment, the Supreme Court dismissed the application of Ms. Wang and Tian Jiu for retrial and for dismissal of the 31 March Judgment and the 20 December Judgment.

In other words, the approval issued by MOFCOM in November 2007 in relation to the Contended Agreements shall not be revoked and remain to be in force, and the Company continues to be the legal and beneficial owner of Baisazhou Agricultural under the PRC Laws.

Separately, in May 2015, in view of the Beijing Judgment, the Company issued a writ against Ms. Wang and Tian Jiu which was accepted by the Hubei Court. The Company sought an order from the Hubei Court that Ms. Wang and Tian Jiu shall assist Baisazhou Agricultural to discharge its contractual duties under the SPA to make the necessary filing with MOFCOM.

商務部於二零一六年八月作出決定指批准不得撤銷 並應繼續生效後,本公司得悉王女士及天九於北京 法院提出另一宗行政訴訟(「行政訴訟」)。根據日期 為二零一六年八月三日的令狀,王女士及天九要求 北京法院撤銷決定,及頒令商務部作出決定以撤銷 批准。根據北京法院發出日期為二零一六年八月 二十六日的通知,連同本公司於二零一六年八月 三十日接獲的令狀,本公司與白沙洲農副產品各自 已被北京法院加入作為行政訴訟的第三方。

於二零一七年四月十八日,本公司收到北京法院日 期為二零一七年三月三十一日的判決(「**三月三十一 日判決**」),當中指出王女士及天九請求撤銷決定缺 乏法律及事實依據,不獲北京法院支持。因此,北 京法院駁回王女士及天九之申請。

於二零一七年五月十日,本公司收到一份日期為二 零一七年五月八日的行政上訴狀(「行政上訴狀」)。 依據行政上訴狀,王女士及天九就三月三十一日判 決提出上訴,請求頒令(a)撤銷三月三十一日判決 及(b)商務部作出決定以撤回批准。

於二零一七年八月三十日,針對三月三十一日判決 的上訴進行聆訊。於二零一八年十二月二十四日, 本公司收到北京市高級人民法院日期為二零一八年 十二月二十日的判決(「**十二月二十日判決**」)。依據 十二月二十日判決,北京市高級人民法院駁回王女 士及天九的上訴,並維持北京法院原判(載於三月 三十一日判決)。

於二零二零年三月四日,本公司注意到最高法院日 期為二零一九年十二月三十一日的判決(「十二月 三十一日判決」)。依據十二月三十一日判決,最高 法院駁回王女士及天九關於重審及駁回三月三十一 日判決及十二月二十日判決的申請。

換言之,商務部於二零零七年十一月就爭議協議發 出之批准將不予撤銷並繼續有效,及根據中國法律 本公司繼續為白沙洲農副產品的法定及實益擁有 人。

另外,於二零一五年五月,鑒於北京判決,本公司 向王女士及天九發出令狀,並獲湖北法院受理。本 公司向湖北法院尋求頒令王女士及天九須協助白沙 洲農副產品履行買賣協議下其須向商務部報送的合 約義務。

On 10 May 2017, Ms. Wang and Tian Jiu applied to the Hubei Court for a freezing order in respect of the Company's 70% interest in Baisazhou Agricultural. According to the order of the Hubei Court dated 26 May 2017 (the "**26 May Order**"), the Hubei Court granted a freezing order as against the Company's 70% interest in Baisazhou Agricultural. The Company then applied for review of the 26 May Order which was dismissed by the Hubei Court on 12 June 2017.

On 26 May 2017, Ms. Wang and Tian Jiu applied to add a counterclaim for return of the Company's 90% interest in Baisazhou Agricultural (70% for Ms. Wang and 20% for Tian Jiu). On 10 April 2019, in light of the outcome of the legal proceedings against MOFCOM by Ms. Wang and Tian Jiu, the Company applied to the Hubei Court for withdrawal of the Company's claim. On 11 April 2019, the application of the Company was granted by the Hubei Court.

According to the judgment of the Hubei Court dated 23 December 2019 (the "**23 December Judgment**"), the counterclaim made by Ms. Wang and Tian Jiu was dismissed by the Hubei Court.

According to the notice of appeal dated 19 January 2020, Ms. Wang and Tian Jiu appealed against the 23 December Judgment to the Supreme Court and requested for an order from the Supreme Court that (a) the 23 December Judgment be set aside and (b) return of the Company's 90% interest in Baisazhou Agricultural (70% for Ms. Wang and 20% for Tian Jiu).

On 29 March 2021, the Company received the judgment of the Supreme Court dated 29 December 2020 (the "**29 December Judgment**") stating that the appeal basis of Ms. Wang and Tian Jiu could not be established and was not supported by the Supreme Court. Accordingly, the Supreme Court dismissed the appeal of Ms. Wang and Tian Jiu and upheld the 23 December Judgment. The 29 December Judgment is final.

As advised by the PRC legal advisors of the Company, according to the 23 December Judgment and the 29 December Judgment, the Company continues to be the legal owner of Baisazhou Agricultural.

For other detailed information of the litigation cases, please refer to note 36 to the consolidated financial statements in this annual report.

On or about 24 October 2011, the Company issued a Writ of Summons in the Hong Kong Court of First Instance (the "**HK Court**") against Ms. Wang and Tian Jiu. The Company (as purchaser) sought damages from Ms. Wang and Tian Jiu (as vendors) for their breach of various provisions of the SPA regarding the acquisition of the interest in Baisazhou Agricultural. 於二零一七年五月十日,王女士及天九就本公司於 白沙洲農副產品之70%權益向湖北法院申請凍結 令。根據湖北法院日期為二零一七年五月二十六日 的命令(「五月二十六日命令」),湖北法院批准凍結 令,凍結本公司於白沙洲農副產品之70%權益。 本公司其後申請覆核五月二十六日命令,申請於二 零一七年六月十二日被湖北法院駁回。

於二零一七年五月二十六日,王女士及天九申請 增加反申訴,要求取回本公司於白沙洲農副產品 之90%權益(王女士佔70%及天九佔20%)。於二零 一九年四月十日,鑑於王女士及天九針對商務部的 法律訴訟結果,本公司向湖北法院申請撤回本公司 的申訴。於二零一九年四月十一日,本公司的申請 獲得湖北法院批准。

根據湖北法院日期為二零一九年十二月二十三日的 判決(「十二月二十三日判決」),王女士及天九申請 的反申訴被湖北法院駁回。

根據日期為二零二零年一月十九日的行政上訴狀, 王女士及天九就十二月二十三日判決向最高法院提 出上訴,請求最高法院頒令(a)撤銷十二月二十三 日判決,及(b)收回本公司於白沙洲農副產品之 90%權益(王女士佔70%及天九佔20%)。

於二零二一年三月二十九日,本公司接獲最高法院 日期為二零二零年十二月二十九日之判決(「**十二月 二十九日判決**」),當中指出王女士及天九的上訴理 據可能不成立,不獲最高法院支持。因此,最高法 院駁回王女士及天九上訴,並維持十二月二十三日 判決原判。十二月二十九日判決則為最終裁決。

據本公司中國法律顧問所告知,根據十二月二十三 日判決及十二月二十九日判決,本公司繼續為白沙 洲農副產品的合法擁有人。

有關訴訟案件的其他詳細資料,請參閱本年報內之 綜合財務報表附註36。

於二零一一年十月二十四日或前後,本公司於香港 原訟法院(「**香港法院**」)向王女士及天九發出傳票令 狀。由於王女士及天九(作為賣方)對有關收購白沙 洲農副產品權益違反買賣協議多項條文,本公司 (作為買方)正向彼等尋求損害賠償。

On 18 January 2021, the Court handed down a judgment ("**HK** Judgment"). Pursuant to the HK Judgment, the Court ruled, inter alia, that (i) Ms. Wang and Tian Jiu shall pay to the Company damages in the total sum of RMB510,000,001; (ii) the Company is entitled to setoff an amount of HK\$54,211,000 from the sum due by the Company to Ms. Wang under one of the Instruments (as defined hereinafter); (iii) as the quantum of the award of damages to the Company is greater than the amounts due under the two instruments (the "Instruments") purportedly described as promissory notes issued by the Company to Ms. Wang and Tian Jiu as part of consideration for the SPA, Ms. Wang and Tian Jiu are not allowed to enforce the Instruments against the Company. In the circumstances, the Company is not required to make any payment under the Instruments to Ms. Wang or Tian Jiu.

EVENT AFTER REPORTING PERIOD

Disposal of equity interest in a non-wholly owned subsidiary

Subsequent to the year ended 31 March 2021, on 18 June 2021, Century Choice Limited ("Century Choice"), a wholly-owned subsidiary of the Company and a substantial shareholder (the "PRC Shareholder") of 玉林宏進農副產品批發市場有限公司 (Yulin Hongjin Agricultural Byproducts Wholesale Marketplace Limited ("Yulin Hongjin")) entered into an agreement in relation to the reduction of registered capital contribution of Century Choice in Yulin Hongjin. Pursuant to the agreement, the PRC Shareholder waived its entitlement to the dividend declared by Yulin Hongjin for the financial year ended 31 December 2020 in the amount of approximately RMB117 million and directed the same to be paid to Century Choice, and the amount of registered capital contribution by Century Choice in Yulin Hongjin was reduced by an amount equal to approximately RMB41.9 million. As a result of such reduction of registered capital contribution, the CAP Group's equity interest in Yulin Hongjin was decreased from 65% to 51%. Details of the capital reduction were disclosed in the joint announcement of, inter alia, the Company dated 18 June 2021.

NUMBER OF EMPLOYEES AND REMUNERATION POLICY

As at 31 March 2021, the Group had 1,151 employees (31 March 2020: 1,171), approximately 98% of whom were located in the PRC. The Group's remuneration policy was reviewed periodically by the remuneration committee of the Company and the Board's remuneration is determined by reference to market terms, company performance, and individual qualifications and performance. The Group aimed to recruit, retain and develop competent individuals who were committed to the Group's long-term success and growth. Remunerations and other benefits of employees were reviewed annually in response to both market conditions and trends, and were based on qualifications, experience, responsibilities and performance. The Company has adopted a share option scheme on 3 May 2012 for the primary purpose of providing incentive to selected eligible persons to take up options for their contribution to the Group. During the Year, no share option was granted.

於二零二一年一月十八日,法院已作出一項判決 (「**香港判決**」)。根據香港判決,法院裁定(其中包 括)(i)王女士及天九須向本公司支付損害賠償總額 人民幣510,000,001元:(ii)本公司有權自本公司根 據其中一份文據(定義見下文)結欠王女士的款項中 扣除54,211,000港元:(iii)由於須向本公司支付的 損害賠償金額大於兩份文據(據稱是本公司向王女 士及天九發行作為買賣協議部分代價之承兑票據) (「文據」)項下的應付款項,故王女士及天九不得針 對本公司強制執行文據。於此情況下,本公司無需 根據文據向王女士或天九支付任何款項。

報告期後事件

出售於非全資附屬公司的股權

於截至二零二一年三月三十一日止年度後,於二零 二一年六月十八日,龍群有限公司(「龍群」,本公 司的全資附屬公司)與玉林宏進農副產品批發市場 有限公司(「**玉林宏進**])的一名主要股東(「**中國股 東**」)訂立有關龍群減持其於玉林宏進之註冊資本注 資的協議。根據該協議,中國股東放棄其享有玉林 宏進於截至二零二零年十二月三十一日止財政年度 宣派股息約人民幣117,000,000元的權利,並指示 將金額支付予龍群,而龍群於玉林宏進的註冊資本 注資將減少金額相等於約人民幣41,900,000元。由 於以上註冊資本注資的減少,中國農產品集團於玉 林宏進的股權已由65%減少至51%。有關資本減少 的詳情已在(其中包括)本公司日期為二零二一年六 月十八日的聯合公佈披露。

僱員人數及薪酬政策

於二零二一年三月三十一日,本集團共聘用1,151 名僱員(二零二零年三月三十一日:1,171名),其 中約98%位於中國。本集團的薪酬政策由本公司薪 酬委員會定期檢討,而董事會之薪酬乃依據市場條 款、公司表現、個別資歷以及表現釐定。本集團旨 在聘用、挽留及發展致力於本集團長遠成功及增長 的人才。員工薪酬及其他福利根據每年市場狀況及 趨勢,及資歷、經驗、職責及表現進行檢討。本公 司已於二零一二年五月三日採納一項購股權計劃, 主要目的是讓經甄選合資格人士取得購股權,以獎 勵彼等對本集團之貢獻。於本年度,概無授出購股 權。

PROSPECTS

During the Year, the tension between the PRC and the United States has slowed down the economic growth. However, such friction has little impact on the Group's operation which is mainly focused on domestic market. Looking ahead, the Group will continue to build a nationwide agricultural produce exchange network by leveraging on its leading position in the industry, readily replicable business model, well-advanced management system, information technology infrastructure and quality customer services.

Since the outbreak of the COVID-19, all of our agricultural produce exchange markets have upgraded the facilities and fixtures to keep up with the stringent health and hygiene measures imposed by the local governments. On one side, this increased our operation cost; on the other side, this raised our competitive edges against many local and lesssophisticated competitors. In conclusion, the industry steps towards a more regulated business environment where only well-organized enterprises can survive and grow.

Once again, agricultural development is the PRC central government's first priority policy for the next consecutive years. In 2021, the Central Committee of Communist Party of China and the State Council of China released the "No. 1 Central Document of 2021". The document promises to promote investments in agricultural produce markets, expand agricultural produce network, build logistic infrastructure and storage facilities of agricultural products and improve regional cold storage infrastructure. On the other hand, it is expected that the "Belt and Road Initiative" policy will drive the overall growth of the PRC economy and provide a sustainable way for the PRC's continuing development.

In order to capture new business opportunities, the Group has taken further steps to expand its operations in the PRC by cooperating with different partners with "asset-light" strategy. Taking the advantage of its leading position in the industry, the Group is confident that this strategy and business model will deliver long-term benefits to the Company and the Shareholders as a whole.

前景

於本年度,中國與美國之間的緊張局勢令經濟增長 放緩。然而,有關貿易磨擦對本集團主要集中於國 內市場的營運影響輕微。展望將來,本集團將繼續 憑藉其於行業的領先地位、可複製的業務模式、完 善的管理體系、先進資訊科技基礎設施及優質客戶 服務,打造一個覆蓋全國的農產品交易市場網絡。

自新冠肺炎疫情爆發以來,我們所有農產品交易市 場均已升級設施及裝置,以跟上地方政府所實施的 嚴格健康衛生措施要求。一方面,此舉令經營成本 增加;另一方面,亦提升了我們與大部分較為缺乏 經驗的本地競爭對手之競爭優勢。總括而言,行業 的經營環境步向更受規管的方向,只有組織完善的 企業才可繼續生存及保持增長。

農業發展仍然是中國中央政府未來數年的首要政 策。於二零二一年,中國共產黨中央委員會及中國 國務院發佈「二零二一年中央一號文件」。文件承諾 推動農產品市場投資,擴展農產品網絡,建設物流 基礎設施及農產品儲存設施,並完善區域性冷藏基 礎設施。另一方面,預期「一帶一路倡議」政策將推 動中國經濟整體增長,為中國持續發展提供一種可 持續方式。

為把握新商機,本集團已採取進一步措施,透過以 「輕資產」策略與不同的夥伴合作,以擴充其於中國 的營運。憑藉在行業的領先地位優勢,本集團有信 心此策略及業務模式將為本公司及股東整體帶來長 遠裨益。





BOARD OF DIRECTORS

Executive Directors

Mr. LEUNG Sui Wah, Raymond, aged 53, joined the Group as an executive director of the Group in June 2010. Mr. Leung is also the chief executive officer, an authorised representative, the company secretary of the Company, the chairman of the executive committee and a member of the nomination committee of the Company, and the chief executive officer of Hongjin Agri-Products Group Limited, a wholly-owned subsidiary of the Company, responsible for managing the agricultural produce exchange market operation of the Group in the PRC. Mr. Leung had over 28 years of experience in business operation, business development, corporate governance, mergers and acquisitions in Hong Kong and the PRC. He is a council member of the Chinese Agri-products Marketing Association, which is the national leading association of the agricultural wholesale markets in the PRC. He holds a Master Degree in Business Administration and Master of Arts from The University of Hong Kong and City University of Hong Kong, respectively. He is a fellow member of The Hong Kong Institute of Certified Public Accountants, The Association of Chartered Certified Accountants, The Hong Kong Institute of Chartered Secretaries and The Chartered Governance Institute. He is also a full member of Chartered Institute of Procurement and Supply and Certified Information Security Manager of Information Systems Audit and Control Association.

Mr. YAU Yuk Shing, aged 57, joined the Group in April 2012 and was appointed as an executive director of the Group in December 2012. Mr. Yau is a member of the executive committee of the Company. He has more than 26-year management experience in property development, engineering and construction businesses. Prior to joining the Group, Mr. Yau worked for certain companies with a wide spread of experience in real estate industry and project management. Mr. Yau is a brother-inlaw of Mr. Tang Ching Ho, the non-executive Director and the controlling shareholder of the Company.

執行董事

梁瑞華先生,現年53歲,於二零一零年六月加入 本集團擔任本集團執行董事。梁先生亦為本公司行 政總裁、法定代表、公司秘書、本公司執行委員會 主席及提名委員會成員,以及本公司全資附屬公司 宏進農副產品集團有限公司之總裁,負責管理本集 團於中國的農產品交易市場之營運。梁先生於香港 及中國之業務營運、業務發展、企業管治及併購方 面擁有逾28年經驗。彼為國內領先全國的農產品 批發市場組織中國農產品市場協會之常務理事。彼 分別持有香港大學及香港城市大學之工商管理碩士 及文學碩士學位。彼為香港會計師公會、英國特許 公認會計師公會、香港特許秘書公會及英國特許企 業管治公會之資深會員。彼亦為英國特許採購及供 應公會之會員及國際信息系統審計協會之信息安全 經理。

游育城先生,現年57歲,於二零一二年四月加入 本集團並於二零一二年十二月獲委任為本集團執行 董事。游先生為本公司執行委員會成員。彼於物業 發展、工程及建築業務累積超過26年管理經驗。 於加入本集團前,游先生曾任職若干公司並於房地 產業務及項目管理方面具有廣泛經驗。游先生為本 公司非執行董事兼控股股東鄧清河先生之內弟。

Non-executive Director

Mr. TANG Ching Ho, GBS, JP, aged 59, joined the Group as a nonexecutive director of the Group and the chairman of the board of directors of the Company in February 2021. He is also an authorised representative of the Company. Mr. Tang is a co-founder of Wang On Group Limited ("WOG"), which was established in 1987, and has been the chairman of WOG since November 1993. He has extensive experience in corporate management. He is also the chairman and managing director of Wai Yuen Tong Medicine Holdings Limited ("WYT", the Company is an indirect non-wholly owned subsidiary of WYT which in turn is an indirect non-wholly owned subsidiary of WOG). Mr. Tang is the committee member of the 12th and 13th National Committee of the Chinese People's Political Consultative Conference ("CPPCC") and is also appointed as a standing committee member and convener of the 10th to 12th plenary sessions of the CPPCC Guangxi Zhuang Autonomous Region Committee. Mr. Tang is also appointed as the first executive chairman of the Federation of Hong Kong Guangdong Community Organisations and the chairman of Federation of Hong Kong Shenzhen Association. He is a controlling shareholder of the Company and the brother-in-law of Mr. Yau Yuk Shing, an executive Director.

Independent Non-executive Directors

Mr. NG Yat Cheung, *JP*, aged 65, joined the Company as an independent non-executive Director in February 2009. He is a member of each of the audit committee, the remuneration committee and the nomination committee of the Company. On 16 March 2012, Mr. Ng was also appointed as the chairman of the remuneration committee of the Company. He holds an associate degree in arts in business data processing from Chabot College in the United States. He holds offices as a director with a number of private companies which are principally engaged in technology, property development, insurance, finance and property holding. Mr. Ng is an independent non-executive director of Tao Heung Holdings Limited, a company listed on the main board of the Stock Exchange.

Mr. LAU King Lung, aged 74, joined the Company as an independent non-executive Director in May 2013. He is the chairman of the nomination committee and a member of each of the audit committee and the remuneration committee of the Company. Mr. Lau has over 40 years' experience in planning, design and contracting of civil engineering and building works in Hong Kong or the PRC. Mr. Lau is a chartered engineer with his profession registration both in the United Kingdom and Hong Kong. He remains a retirement member of The Hong Kong Institution of Engineers after his retirement. He participated in the design of the initial systems of the Mass Transit Railway in Hong Kong after his graduation from civil engineering department of Imperial College, University of London for 6 years with Freeman Fox and Partners, London.

The Company is committed to maintaining a high standard of corporate governance within a sensible framework with a strong emphasis on transparency, accountability, integrity and independence and enhancing the Company's competitiveness and operating efficiency, to ensure its sustainable development and to generate greater returns for the Shareholders.

CORPORATE GOVERNANCE PRACTICES

Compliance with Listing Rules and CG Code

The Board has reviewed the corporate governance practices of the Company and is satisfied that the Company had applied the principles and complied with the code provisions set out in the Corporate Governance Code (the "**CG Code**") as contained in Appendix 14 to the Listing Rules throughout the financial year ended 31 March 2021, except for the following deviation:

Code provision A.2.1

During the period from 1 April 2020 to 8 February 2021 (the date of resignation of Mr. Chan Chun Hong, Thomas ("Mr. Chan") as an executive Director), Mr. Chan took up the roles of both the chairman of the Board and the chief executive officer, which deviated from code provision A.2.1 of the CG Code. Mr. Chan had extensive executive and financial management experience and was responsible for overall corporate planning, strategic policy making and management of operations of the Group which was of great value in enhancing the efficiency to cope with the dynamic business environment. The daily business operation of the Group was delegated to various experienced individuals under the supervision of Mr. Chan. Furthermore, the Board believed that a balance of power and authority was adequately ensured by the operations of the Board which comprised three then executive Directors and three independent non-executive Directors with balance of skills and experience appropriate for the Group's further development during the period. Subsequent to the resignation of Mr. Chan, Mr. Tang Ching Ho ("Mr. Tang", a non-executive Director) has been appointed the chairman of the Board and Mr. Leung Sui Wah, Raymond ("Mr. Leung") has been redesignated from the chief financial officer to the chief executive officer of the Company on 8 February 2021. As a result, the Company has complied with requirement under code provision A.2.1 of the CG Code since the appointment of Mr. Tang and the redesignation of Mr. Leung. The Company periodically reviewed its corporate governance practices to ensure it continued to meet the requirements of the CG Code during the financial year ended 31 March 2021. The key corporate governance principles and practices of the Company are summarised in this report.

Responsibilities

The Board's primary functions are to set corporate policy and overall strategy for the Group and to provide effective oversight of the management of the Group's business and affairs. It delegates day-to-day operations of the Group to executive Directors and senior management. Apart from its statutory responsibilities, the Board also approves, among others, strategic plans, key operational issues, investments and loans, reviews the financial performance of the Group and evaluates the performance and compensation of senior management. These functions are either carried out directly by the Board or indirectly through committees established by the Board. Besides, the Board has delegated general powers to management to deal with day-to-day management, administration and operations of the Group.

The Board possesses a balance of skills and experience which are appropriate for the requirements of the businesses of the Company. Save as Mr. Tang, a non- executive Director, is the brother-in-law of Mr. Yau Yuk Shing, an executive Director, none of the Directors have any financial, business, family or other material/relevant relationships with each other. The opinions raised by the independent non-executive Directors at the meetings of the Board facilitate the maintenance of good corporate governance practices. The Board has three independent non-executive Directors, representing more than one-third of the Board, and at least one of the independent non-executive Directors has the appropriate professional qualification and accounting and related financial management expertise as required by Rules 3.10(1) and (2) of the Listing Rules. A balanced composition of executive and nonexecutive Directors also ensures a strong independent element on the Board, which allows for an independent and objective decision making process for the best interests of the Company. The Company will review the composition of the Board regularly to ensure the Board possesses the appropriate and necessary expertise, skills and experience to meet the needs of the Group's business with due regard for the benefits of diversity, as set out in the diversity policy adopted by the Board.

All independent non-executive Directors are appointed for a term of three years under respective service agreements and all Directors (including both executive and non-executive) are subject to retirement by rotation at the Company's annual general meetings in accordance with the bye-laws of the Company.

All independent non-executive Directors are free from any business or other relationship with the Company. Each independent non-executive Director is required to inform the Company as soon as practicable if there is any change in his own personal particulars that may affect his independence. No such notification was received during the financial year under review. The Company has also received from each of the existing independent non-executive Director an annual confirmation of his independence pursuant to Rule 3.13 of the Listing Rules and the Company continues to consider the three independent non-executive Directors to be independent.

The Board meets at least four times a year with additional meetings arranged, as and when necessary, and has a schedule of matters reserved for its review and approval. The specific responsibility reserved for the Board includes matters in relation to, among others, determining strategies and objectives of the Group, monitoring the overall management and operation of the Group, reviewing capital, corporate and control structures, ensuring financial reporting, risk management and internal control measures, determining major capital projects and contracts, including material acquisitions, disposals and other significant potential investments, communication with the Shareholders, determining the Board composition, the appointment of company secretary and auditors, evaluating the effectiveness of internal controls, reviewing adequacy of resources, qualification and experience of staff, delegation of authority to committees and reviewing the Group's overall corporate governance arrangements.

Save as those matters mentioned above, the Board has delegated general powers to management to deal with day-to-day management, administration and operations of the Group. At the same time, management will provide with the Board and its committees with adequate information, in a timely manner, to enable it to make informed decisions.

At least 14 days' notice for each regular meeting is given to all Directors. Agendas accompanying Board papers are sent to all Directors 3 days before the date of a regular meeting of the Board to ensure that the Directors are given sufficient time to review the same. All minutes of the meetings of the Board and its committee are kept by the company secretary of the Company and are open for inspection at any reasonable time on reasonable notice by any Director.

ROLES OF CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Code provision A.2.1 of the CG Code stipulates that the roles of chairman and chief executive should be separate and should not be performed by the same individual.

As at the date of this report, the positions of the chairman and the chief executive officer are held by Mr. Tang Ching Ho and Mr. Leung Sui Wah, Raymond respectively. There is clear division of responsibilities between the chairman and the chief executive officer which provides a balance of power and authority.

TRAINING, INDUCTION AND CONTINUING DEVELOPMENT FOR DIRECTORS

All Directors are encouraged to participate in continuous professional development to develop and refresh their knowledge and skills. The Company provides a comprehensive induction package covering the summary of the responsibilities of a director of a Hong Kong listed company and the Guides on Directors' Duties issued by the Companies Registry. The Company would also arrange seminars on professional knowledge of regulatory requirements related to director's duties and responsibilities for each newly appointed Director to ensure that he/she is sufficiently aware of his/her responsibilities and obligations under the Listing Rules and other regulatory requirements.

During the financial year ended 31 March 2021, all Directors received regular update on corporate governance matters or news or changes to laws and regulations. Mr. Tang Ching Ho, Mr. Leung Sui Wah, Raymond and Mr. Wong Ping Yuen attended briefings or seminars on relevant topics. All Directors are requested to provide the Company with a record of the training they received.

BOARD COMMITTEES

The Board has established various committees, including the remuneration committee (the "**Remuneration Committee**"), the nomination committee (the "**Nomination Committee**") and the audit committee (the "**Audit Committee**"), each of which has the specific written terms of reference that will be renewed and updated, if necessary. Each committee is required to report to the Board on its decision and recommendations, where appropriate.

董事委員會

Remuneration Committee

The terms of reference of the Remuneration Committee are available on the websites of the Stock Exchange and the Company. The duties, roles and functions of the Remuneration Committee are as follows:

- to make recommendations to the Board on the Company's policy and structure of remuneration for all Directors and senior management of the Company and on the establishment of a formal and transparent procedure for developing such policy;
- to review and approve the management's remuneration proposals by reference to the Board's corporate goals and objectives;
- to make recommendations to the Board on the remuneration packages of individual executive Directors, non-executive Director and senior management of the Company, including but not limited to benefits in kind, pension rights and compensation payments for loss or termination of their office or appointment;
- to consider salaries paid by comparable companies, time commitment and responsibilities and employment conditions elsewhere in the Group;
- to review and approve the compensation payable to executive Directors and senior management of the Company for any loss or termination of office or appointment to ensure that it is consistent with contractual terms and is otherwise fair and not excessive;
- to review and approve compensation arrangements relating to dismissal or removal of Directors for misconduct to ensure that they are consistent with contractual terms and are otherwise reasonable and appropriate; and
- 7. to ensure that no Director or any of his/her associates is involved in deciding his/her own remuneration.

During the financial year under review, the Remuneration Committee reviewed the existing remuneration policy, assessed performance of executive Directors, reviewed the existing remuneration packages and structure of executive Directors and senior management of the Company and the existing remuneration packages of independent non-executive Directors, and approved the terms of the engagement letter of the nonexecutive Director appointed during the financial year under review.

The Remuneration Committee has discharged or will continue to discharge its major roles to, among other things, make recommendations, if any, to the Board on the remuneration packages of individual executive Directors and senior management of the Company (i.e. the model described in the code provision B.1.2(c)(ii) of the CG Code is adopted) and approve the terms of executive Director's service contracts.

Nomination Committee

The Nomination Committee consists of three independent non-executive Directors, namely Mr. Lau King Lung (chairman), Mr. Ng Yat Cheung and Mr. Wong Ping Yuen and one executive Director, namely Mr. Leung Sui Wah, Raymond.

The terms of reference of the Nomination Committee are available on the websites of the Stock Exchange and the Company. The duties, roles and functions of the Nomination Committee are as follows:

- 1. to review the structure, size, composition and diversity (including without limitation, gender, age, cultural and educational background, ethnicity, experience, skills, knowledge, independence and length of service) of the Board at least annually and make recommendations to the Board on any proposed changes to complement the Company's corporate strategy;
- 2. to identify and nominate individuals suitably qualified to become Board members and select or make recommendations to the Board on the selection of individuals nominated for directorships. In identifying suitable individuals, the Nomination Committee shall consider individuals on merit against the objective criteria, with due regard for the benefits of diversity on the Board;
- 3. to assess the independence of independent non-executive Directors and review the independent non-executive Directors' annual confirmations on their independence and make disclosure of its review results in the corporate governance report of the Company;
- 4. to regularly review the time required for a Director to perform his/ her responsibilities;
- 5. to review the balance between executive and non-executive Directors and the blend of skills, knowledge, experience and diversity on the Board;
- 6. to keep under review the leadership and succession needs of the Group with a view to ensuring the long term success of the Group;
- 7. to review the Board diversity policy, as appropriate, and review the measurable objectives that the Board has set for implementing the Board diversity policy, and the progress on achieving the objectives; and make disclosure of its review results in the corporate governance report annually;

During the financial year under review and up to the date of this report the Nomination Committee (i) reviewed, inter alia, the policy for the nomination of Directors, the nomination procedures and the process and criteria to select and recommend candidates for directorship and the Board diversity policy; (ii) nominated the appointment of a non-executive Director; (iii) recommended the re-elections of Mr. Yau Yuk Shing and Mr. Ng Yat Cheung in the annual general meeting of the Company held on 24 August 2020 and (iv) recommended the re-elections of Mr. Leung Sui Wah, Raymond, Mr. Lau King Lung and Mr. Tang Ching Ho in the annual general meeting to be held on 25 August 2021. The nominations of reelection were made in accordance with the objective criteria (including without limitation, gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge, independence and length of service), with due regard for the benefits of diversity, as set out in the Board diversity policy adopted by the Company. As a good governance practice, Mr. Leung Sui Wah, Raymond, Mr. Lau King Lung and Mr. Tang Ching Ho had abstained from voting at the Nomination Committee and/or Board meeting on their nominations for election by the Shareholders and Mr. Yau Yuk Shing had abstained from voting at the Board meeting on Mr. Tang's appointment and re-election.

Board Diversity Policy

The Company has adopted a Board diversity policy which sets out the approach to diversify the Board and for which the Nomination Committee has reviewed annually. The Nomination Committee reviewed and assessed the Board composition and made recommendations (if any) to the Board pursuant to the Board diversity policy and the nomination policy.

The Nomination Committee will consider, when designing and reviewing the Board's composition, from a number of aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge, independence and length of service. The Nomination Committee will also consider candidates on merit against the objective criteria, with due regard for the benefits of diversity on the Board.

As at 31 March 2021, the Board comprises six Directors, including two executive Directors, one non-executive Director and three independent non-executive Directors, thereby promoting critical review and control of the management process. The Board is also characterised by significant diversity, whether in terms of professional experience, skills and knowledge.

董事會多元化政策

本公司已採納董事會多元化政策,訂明董事會多元 化之方針,並每年由提名委員會審閱。提名委員會 已根據董事會多元化政策及提名政策審閱及評估董 事會之組成,並向董事會提出建議(如有)。

在設計及審閱董事會之組成時,提名委員會將會從 多方面考慮,包括但不限於性別、年齡、文化及教 育背景、種族、專業經驗、技能、知識、獨立性及 服務任期。提名委員會亦將會按客觀標準考慮人 選,並充分顧及董事會多元化之裨益。

於二零二一年三月三十一日,董事會由六名董事 (包括兩名執行董事、一名非執行董事及三名獨立 非執行董事)組成,從而促進管理過程的重要審核 及監控。無論於專業經驗、技能或知識層面,董事 會亦體現顯著的多元化特色。

Having reviewed the Board diversity policy and the Board's composition, the Nomination Committee is satisfied that the requirements set out in the Board diversity policy had been met. The Nomination Committee considered that the current Board composition has provided the Company with a good balance and diversity of skills and experience appropriate for the business of the Company. The Nomination Committee will review the implementation of the Board diversity policy from time to time to ensure its effectiveness on determining the optimum composition of the Board.

Nomination Policy

The Company has adopted a nomination policy which sets out the guidelines for the Nomination Committee to nominate suitable candidate(s) to the Board for it to consider and make recommendations to the Shareholders for election or re-election as Director(s) at a general meeting of the Company or recommendations to the Board for appointment or re-election as Director(s).

1. Selection Criteria

- 1.1 In assessing the suitability of a proposed candidate, the Nomination Committee will consider the factors (as reference), including but not limited to reputation, integrity, accomplishment and relevant experience in relation to the principal businesses of the Company from time to time, commitment in respect of available time and relevant interest, diversity in all its aspects, including but not limited to gender, age (18 years or above), cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. These factors are for reference only, and are not meant to be exhaustive and decisive. The Nomination Committee has the discretion to nominate any person, as it considers appropriate.
- 1.2 Retiring Directors are eligible for nomination by the Board to stand for re-election at a general meeting. For those serving as independent non-executive Directors for a period of 9 years (or above), the Nomination Committee will consider the independence of such Director for nomination by the Board to stand for election at a general meeting and state the reason in a circular to the Shareholders for the re-election. For those serving as independent non-executive directors for 7 (or more) listed companies, the Nomination Committee will consider why they would still be able to devote sufficient time to the Board for nomination by the Board to stand for appointment or re-election at a general meeting and state the reason in a circular to the Shareholders for election.

提名政策

- 1.1 於評估擬議候選人是否適當時,提名委員 會將考慮的因素(作為參考)包括但不限於 聲譽、誠信、成就及與本公司不時之主要 業務有關的經驗、可利用時間及相關利益 之承諾、各方面的多樣性,包括但不限於 性別、年齡(18歲或以上)、文化和教育背 景、種族、專業經驗、技能、知識和服務 任期。該等因素僅供參考,並非詳盡無遺 及具決定性。提名委員會於認為適當時有 權酌情提名任何人士。
- 1.2 退任董事有資格獲董事會提名於股東大會 上膺選連任。就已擔任獨立非執行董事9 年(或以上)的人士而言,提名委員會將考 慮該董事的獨立性,以供董事會提名於股 東大會參選,並於致股東之通函中就重選 陳述理由。就擔任7間(或以上)上市公司 獨立非執行董事的人士而言,提名委員會 將考慮彼等仍有能力投入足夠時間予董事 會之理由,以供董事會提名委任或於股東 大會上重選,並於致股東之通函中就選舉 或重選陳述理由。

- 1.3 Candidate(s) is required to submit the necessary personal information pursuant to the applicable laws, rules and regulations, together with their written consent to be appointed as Director(s) and to the public disclosure of their personal data on any documents or the relevant websites for the purpose of or in relation to their standing for election as Director(s).
- 1.4 The Nomination Committee may request the candidate(s) to provide additional information and documents, if necessary.

2. Nomination Procedures

- 2.1 The secretary of the Nomination Committee shall call a meeting of the Nomination Committee and invite nominations of candidate(s) from members of the Board, if any, for consideration by the Nomination Committee. The Nomination Committee may nominate candidate(s) without nomination by a member of the Board.
- 2.2 For filling a casual vacancy, the Nomination Committee shall make recommendations for the Board's consideration and approval. For proposing candidate(s) to stand for election at a general meeting, the Nomination Committee shall make nominations to the Board for its consideration and recommendation.
- 2.3 Information (including names, brief biographies (including qualifications and relevant experience), independence, proposed remuneration and any other information, as required pursuant to the applicable laws, rules and regulations) of the candidate(s) nominated by the Board to stand for election at a general meeting will be stated in a circular to be sent to the Shareholders.
- 2.4 The Shareholder can serve a notice to the Company's company secretary to propose a resolution to elect a person as Director, without the Board's recommendation or the Nomination Committee's nomination pursuant to the applicable laws, rules and regulations. The particulars of the candidate(s) so proposed as required pursuant to the applicable laws, rules and regulations will be stated in a circular to be sent to the Shareholders.
- 2.5 A candidate is allowed to withdraw his candidature at any time before the general meeting by serving a notice in writing to the Company's company secretary.
- 2.6 The Board shall have the final decision on all matters relating to its recommendation of candidate(s) to stand for election at any general meeting.

The Audit Committee consists of all of the independent non-executive Directors, namely Mr. Wong Ping Yuen (chairman), Mr. Ng Yat Cheung and Mr. Lau King Lung.

The Audit Committee is mainly responsible for, inter alia, reviewing the interim and annual financial statements and making recommendation to the Board, reviewing the terms of engagement and making recommendation to the Board regarding the appointment of external auditors of the Company, monitoring and assessing the independence of external auditors and effectiveness of the internal control and risk management systems and oversight of the Company's financial reporting, controlling, accounting policies and practices (with external auditors and management of the Company) and risk management and internal control issues.

During the financial year under review, the Audit Committee held three meetings and the attendance of each member of the Audit Committee is set out below:

RISK MANAGEMENT AND INTERNAL CONTROL

Risk management process



The staffs in all levels within the Group are also required to take the relevant responsibility on the risk management process. The structure and procedures for the risk management are as follows:

Internal audit function

For the financial year ended 31 March 2021, the Company appointed external advisers to perform the ongoing monitoring of the systems of internal control of the Group and report their findings and recommendations to the Audit Committee and follow up the status of implementation of the recommendations to ensure all significant control activities are properly in place within the Group.

The Group has adopted a risk-based approach in developing the annual audit plan to cover business activities with material risks across the Group. The rotation basis would be applied to operations with similar risk associated so as to enhance the efficiency and effectiveness of the internal audit.

All findings and recommendations on internal control deficiencies for the financial year under review have been communicated to management, who are required to establish remedial plans to correct those internal control deficiencies within a reasonable time period. Post-audit review is performed to monitor those agreed recommendations having been implemented as intended and on a timely basis.

Based on the audit result and post-audit review, the advisers reported that no significant deficiency on the internal control system of the Group for the financial year under review had been noted.

The senior management of the Group will take all reasonable measures from time to time to ensure that the disclosure of inside information is in compliance with the requirements of all applicable laws and regulations.

Whistleblowing policy

The Company has adopted a whistleblowing policy to facilitate the achieving of highest possible standards of openness, probity and accountability. Procedures are formulated to assist individual employee to disclose internally and at a high level, information which the individual believes that it shows malpractice or impropriety within the Group. Such policy is made available on the website of the Company.

All draft and finalised minutes of the Board meetings and meetings of the Board committees are sent to the Directors or Board committee members as appropriate for comments, approval and records. All records are available for inspection by any Director upon request.

Mr. Leung Sui Wah, Raymond reports directly to the Board and is responsible for, inter alia, providing updated information to all Directors from time to time.

During the financial year ended 31 March 2021, Mr. Leung complied with Rule 3.29 of the Listing Rules and took no less than 15 hours of relevant professional training.

ENVIRONMENTAL AND SOCIAL RESPONSIBILITY

The Group is conscious of its role as an environmentally and socially responsible group of companies. It has made donations for community wellbeing from time to time and has environmental friendly policies in place. We support the communities and encourage our employees to participate in charitable events and environmental protection activities. Details of the environmental and social responsibility matters of the Group were disclosed in the section headed "Management Discussion and Analysis" of this annual report. More details will be disclosed in the Environmental, Social and Governance Report of the Company to be published in accordance with the requirements under the Listing Rules.

SHAREHOLDERS' RIGHTS

Convening of Special General Meeting

Any one or more Shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the secretary of the Company, to require a special general meeting (the "**SGM**") to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two months after the deposit of such requisition.

Pursuant to bye-law 62 of the bye-laws of the Company, a SGM shall be convened on requisition, as provided by the Companies Act 1981 of Bermuda (the "**Companies Act**"), and, in default, may be convened by the requisitionist(s).

Pursuant to bye-law 63 of the bye-laws of the Company, a SGM may be called by notice in writing of not less than fourteen clear days and not less than ten clear business days.

The Company would take appropriate actions and make necessary arrangements, and the Shareholders concerned would be responsible for the expenses incurred in giving effect thereto in accordance with the requirements under Section 74 of the Companies Act once a valid requisition is received.

Putting Forward Proposals at General Meetings

Shareholder(s) representing not less than one-twentieth of the total voting rights at the date of the requisition or not less than 100 Shareholders may put forward a proposal at a Shareholders' meeting, pursuant to the Companies Act, by sending a written requisition to the Board or the company secretary of the Company at the Company's principal place of business in Hong Kong. The proposal should be stated in the written requisition and such written requisition should be submitted as early as practicable to enable the Company to make necessary arrangement (in case of a requisition requiring notice of a resolution, not less than six weeks before the meeting; and in case of any other requisition, not less than one week before the meeting).

For the avoidance of doubt, Shareholder(s) must provide their full name, contact details and identification, in the originally signed written requisition, notice or statement (as the case may be), in order to give effect thereto. Information of Shareholder(s) may be disclosed as required by law.

PRINCIPAL ACTIVITIES AND BUSINESS REVIEW

The principal activity of the Company is investment holding. Its subsidiaries are principally engaged in the business of management and sales of properties in agricultural produce exchange markets in the PRC. Details of the Company's principal subsidiaries as at 31 March 2021 are set out in note 19 to the consolidated financial statements.

Structured Contracts

Pursuant to the Catalogue of Industries for Guiding Foreign Investment (2015 version), value-added telecommunications services are subject to foreign investment restriction in which a foreign investor shall hold no more than 50% equity interest in a value-added telecommunications services provider (excluding e-commerce) in the PRC.

The Internet Content Provider ("**ICP**") services belong to a sub-category of value-added telecommunications services. According to the Administrative Rules for Foreign Investment in Telecommunications Enterprises, foreign investors shall contribute to no more than 50% of the registered capital of a value-added telecommunications services provider (excluding e-commerce) and any such foreign investor shall maintain a good track record and possess relevant operational experience in the value-added telecommunications services industry (the "**Foreign Shareholding Restrictions**").

因應第622章公司條例附表5之要求就此等業務的 進一步討論及分析,包括對業務的中肯審視,以及 本集團所面臨的主要風險和不明朗因素的討論;於 回顧年度結束後對本集團有影響的重大事件詳情、 採用財務關鍵績效指標對本集團表現的分析、本集 團業務可能的未來發展,以及討論本集團的環境政 策及表現和遵守對本集團有重大影響的相關法律及 法規,載於本年報「主席報告」及「管理層討論及分 析」章節。此外,就與主要持份者之關係之討論載 於本年報「管理層討論及分析」及「企業管治報告」章 節。該等討論構成本董事會報告之一部分。

結構性合約

根據《外商投資產業指導目錄》(二零一五年修訂), 增值電信服務受到外商投資限制,外國投資者不得 持有中國增值電信服務提供商(不包括電子商務)超 過50%股權。

互聯網數據提供商服務屬於增值電信服務的子類 別。根據《外商投資電信企業管理規定》,外國投資 者佔增值電信服務提供商(不包括電子商務)的註冊 資本不得超過50%,且任何相關外國投資者須維持 良好的往績記錄,並具備增值電信服務業的相關營 運經驗(「**外資持股限制**」)。

Shenzhen Gudeng, the then direct wholly-owned PRC subsidiary of Shenzhen Zhibo Tianyu Trading Development Limited (**"Shenzhen Zhibo**"), an indirect wholly-owned PRC subsidiary of the Company, was incorporated in September 2015 and received the ICP license on 7 September 2016. It holds one website and two mobile applications for the Group and is principally engaged in online provision of agricultural products in the PRC.

On 19 June 2015, the Circular on Removing the Restrictions on Shareholding Ratio Held by Foreign Investors in Online Data Processing and Transaction Processing (Operating E-commerce) Business (the "**E-commerce Circular**") was issued, which allows the foreign ownership in online data processing and transaction processing (operating e-commerce) business up to 100%. However, since the E-commerce Circular does not provide any clear legal definition of "e-commerce", it is unclear as to whether the business to be conducted by Shenzhen Gudeng would fall within the scope of the E-commerce Circular to benefit from the loosened restrictions on the Foreign Shareholding Restrictions.

As such, Shenzhen Zhibo (i) entered into a disposal agreement on 11 July 2016 with Yu Hui Jun (the "**Nominee Shareholder**") and (ii) further entered into the exclusive business cooperation agreement, the exclusive call option agreement, the equity pledge agreement, the power of attorney and the ancillary documents (collectively the "**Structured Contracts**") with the Nominee Shareholder and Shenzhen Gudeng on 9 October 2016 (other than the exclusive business cooperation agreement which was entered into by and between Shenzhen Zhibo and Shenzhen Gudeng only and the power of attorney which was executed by the Nominee Shareholder in favour of Shenzhen Zhibo) such that the Group is entitled to acquire the rights and ability to control the business of Shenzhen Gudeng and to obtain the economic benefit (the "**Contractual Arrangements**"). 深圳谷登(為深圳智博天宇商貿發展有限公司(「深 圳智博」)當時的直接全資中國附屬公司及本公司的 間接全資中國附屬公司)於二零一五年九月註冊成 立,並於二零一六年九月七日取得互聯網數據提供 商牌照。該公司為本集團持有一個網站及兩個流動 應用程式,主要於中國從事網上提供農產品。

二零一五年六月十九日頒佈了《關於放開在線數據 處理與交易處理業務(經營類電子商務)外資股比限 制的通告》(「電子商務通告」),容許在線數據處理 與交易處理業務(經營類電子商務)的外資擁有權達 到100%。然而,由於電子商務通告並未就「電子商 務」作出任何明確的法律定義,故深圳谷登將經營 之業務是否屬於電子商務通告範圍內而受惠於外資 持股限制之放寬限制,並不清晰。

因此,深圳智博(i)於二零一六年七月十一日與于 惠軍(「代名人股東」)訂立出售協議;及(ii)於二零 一六年十月九日與代名人股東及深圳谷登進一步訂 立獨家業務合作協議、獨家認購權協議、股權質押 協議、授權書及配套文件(統稱「結構性合約」)(惟 獨家業務合作協議僅由深圳智博與深圳谷登訂立及 授權書由代名人股東以深圳智博為受益人簽署), 以讓本集團獲得控制深圳谷登業務的權利及能力及 取得經濟利益(「合約安排」)。

The exclusive business cooperation agreement and the exclusive call option agreement had an initial term of 3 years commencing from the date of the relevant agreements which were renewed for another 3 years on 8 October 2019. As security for the payment of service fees under the exclusive business cooperation agreement and the performance of the exclusive call option agreement and the power of attorney, the equity pledge agreement executed in favour of Shenzhen Zhibo will only be terminated when all the said obligations of the Nominee Shareholder contemplated under the Contractual Arrangements are fulfilled. Similarly, for protection of the Group, the power of attorney executed in favour of Shenzhen Zhibo will be valid so long as the Contractual Arrangements are in place. The Company will keep exploring various opportunities in building up its ICP services operations for the purposes of being qualified as early as possible, to acquire the entire equity interest of Shenzhen Gudeng if and when the Foreign Shareholding Restrictions are lifted. For details of the Structured Contracts, please refer to the announcements of the Company dated 11 July 2016 and 11 October 2016, respectively.

Save for the exclusive business cooperation agreement which involves the payment of a service fee by Shenzhen Gudeng to Shenzhen Zhibo on a monthly basis, and the nominal consideration paid by Shenzhen Zhibo to the Nominee Shareholder under the exclusive call option agreement, each of the Structured Contracts does not involve payment of any consideration.

The Structured Contracts, taken as a whole, permit the results and financial operations of Shenzhen Gudeng to be consolidated in the Company, as if it was the Company's subsidiary resulting in all economic benefits of its business flowing to the Company. Through the appointment by Shenzhen Zhibo of all directors and senior management of Shenzhen Gudeng, the Directors believe that Shenzhen Zhibo is able to effectively supervise, manage and operate the business operations, expansion plans, financial policies and assets of Shenzhen Gudeng, and at the same time, ensure due implementation of the Structured Contracts. According to Hong Kong Financial Reporting Standards, a subsidiary is an entity that is controlled by another entity (known as the parent). An investor controls an investee when it is exposed, or has rights to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee. 獨家業務合作協議及獨家認購權協議之初始年期自 相關合約日期起計為期三年,並已於二零一九年十 月八日再續期三年。作為根據獨家業務合作協議支 付服務費及履行獨家認購權協議與授權書的擔保, 以深圳智博為受益人簽立的股權質押協議將僅會於 前述合約安排項下代名人股東所有責任達成後終 止。同樣地,為保障本集團,以深圳智博為受益人 簽立之授權書僅會於合約安排實行期間有效。本公 司將繼續探索不同機會拓展互聯網數據提供商服務 營運,力求盡快取得資格,於外資持股限制解除後 收購深圳谷登全部股權。有關結構性合約之詳情, 請參閱本公司日期分別為二零一六年七月十一日及 二零一六年十月十一日之公佈。

除獨家業務合作協議涉及深圳谷登每月向深圳智博 支付服務費,以及深圳智博根據獨家認購權協議支 付予代名人股東的名義代價外,各結構性合約不涉 及支付任何代價。

整體而言,結構性合約讓深圳谷登之業績及財務營 運綜合計入本公司,猶如其為本公司之附屬公司, 以致其業務所得所有經濟利益流入本公司。董事認 為,透過深圳智博指派深圳谷登之所有董事及高級 管理層,深圳智博有能力有效監控、管理及經營深 圳谷登之業務營運、擴充計劃、財務政策及資產, 此舉同時亦確保結構性合約獲得妥善落實。根據香 港財務報告準則,附屬公司指由另一間實體(稱為 母公司)控制的實體。當投資者因參與被投資者業 務而承擔風險或有權享有可變回報,並有能力透過 其對被投資者施加權力去影響該等回報時,則擁有 對該被投資者的控制權。

Although the Company does not directly or indirectly own Shenzhen Gudeng, the Structured Contracts enable the Company to exercise control over and receive economic benefits generated from the business operation of Shenzhen Gudeng and the validity and legality of the Structured Contracts have been confirmed by the Company's PRC legal adviser. The Group derives economic benefits from the ICP services provided by Shenzhen Gudeng. Under such circumstances, the Directors are of the view that it is fair and reasonable for Shenzhen Zhibo to be entitled to all the economic benefits generated from Shenzhen Gudeng. The Structured Contracts also permit Shenzhen Zhibo to exclusively acquire all or part of the equity interest in Shenzhen Gudeng, if and when permitted by PRC laws and regulations. Notwithstanding the Group's lack of equity ownership in Shenzhen Gudeng, the Group is able to control the business and financial position of Shenzhen Gudeng in substance through the Structured Contracts. As a result of the Structured Contracts, Shenzhen Gudeng is accounted for as the Company's subsidiary, and its financial position and operating results are consolidated in the Company's consolidated financial statements.

The revenue, net loss and total asset value subject to the Contractual Arrangements amounted to nil and approximately HK\$0.8 million for the financial year ended 31 March 2021 and approximately HK\$0.3 million as of 31 March 2021, respectively.

Manner of settlement of disputes which may arise from the Contractual Arrangements

Pursuant to the Structured Contracts, any dispute arising from the interpretation and performance of the Structured Contracts between the parties thereto should first be resolved through negotiation, failing which any party may submit the said dispute to the South China International Economic and Trade Arbitration Commission (or Shenzhen Court of International Arbitration) with a view to resolving the dispute through arbitration in accordance with the arbitration rules thereof.

Arrangements in the event of death, bankruptcy or divorce of the Nominee Shareholder

The Nominee Shareholder has undertaken in the exclusive call option agreement and the equity pledge agreement that she shall make all appropriate arrangements and execute all necessary documents to ensure that, in the event of death, loss of capacity, bankruptcy, divorce (or other circumstances) of herself, there would be no adverse effect or obstacle in enforcing the exclusive call option agreement and the equity pledge agreement by her successors. 雖然本公司並非直接或間接擁有深圳谷登,惟結構 性合約讓本公司可對深圳谷登行使控制權並收取其 業務營運所得經濟利益,而結構性合約亦已經本公 司中國法律顧問確認為有效及合法。本集團自深圳 谷登提供的互聯網數據提供商服務獲取經濟利益。 在此等情況下,董事認為,讓深圳智博享有深圳谷 登產生的所有經濟利益實屬公平合理。在中國法律 及法規允許的情況下,結構性合約亦讓深圳智博可 獨家收購深圳谷登全部或部分股權。雖然本集團未 持有深圳谷登之股本權益,惟本集團可透過結構性 合約享有對深圳谷登業務及財務狀況的實際控制 權。由於結構性合約,深圳谷登作為本公司附屬公 司列賬,其財務狀況及經營業績綜合計入本公司綜 合財務報表。

根據合約安排,截至二零二一年三月三十一日止 財政年度的收益、虧損淨額及於二零二一年三月 三十一日的資產總值分別為零、約800,000港元及 約300,000港元。

解決由合約安排可能產生爭議的方法

根據結構性合約,相關各方之間因結構性合約的解 釋及實施而產生的任何爭議,應首先協商解決,倘 未能協商解決,則任何一方可將有關爭議提交予華 南貿易仲裁委員會(或深圳國際仲裁院),以按照當 中的仲裁規定透過仲裁解決爭議。

代名人股東身亡、破產或離婚的安排

代名人股東已於獨家認購權協議及股權質押協議承 諾,彼將作出一切適當安排並簽署一切所須文件, 以確保倘其身亡、失去行為能力、破產、離婚(或 遇到其他情況)時,對於由其繼承人執行獨家認購 權協議及股權質押協議而言概無不利影響或阻礙。

Undertaking to mitigate any potential conflict of interests between Shenzhen Zhibo and the Nominee Shareholder

The Nominee Shareholder may have potential conflicts with Shenzhen Zhibo and the Company. To mitigate any potential conflict of interests, the Nominee Shareholder and Shenzhen Gudeng have undertaken in the exclusive call option agreement that, during the period the exclusive call option agreement remains effective, unless otherwise agreed by Shenzhen Zhibo, the Nominee Shareholder and Shenzhen Gudeng (i) would not participate in any business which may be in competition with the business of Shenzhen Zhibo or its related companies; and (ii) would appoint nominees nominated by Shenzhen Zhibo as Shenzhen Gudeng's director(s) or executive director(s).

Risk factors

The following are the major risks relating to the Contractual Arrangements: (1) the PRC Government may determine that the documents for the Contractual Arrangements do not comply with applicable regulations; (2) the Contractual Arrangements may not provide control as effective as direct ownership; and (3) the Contractual Arrangements may be subject to scrutiny of the PRC tax authorities and additional tax may be imposed.

Furthermore, the Group conducts its business operation in the PRC through Shenzhen Gudeng by way of the Contractual Arrangements, but certain of the terms of the Contractual Arrangements may not be enforceable under the PRC laws. As advised by the Company's PRC legal advisers, the Contractual Arrangements were narrowly tailored to minimize the potential conflict with relevant PRC laws and regulations.

Internal control measures

In order to effectively control and safeguard the assets of Shenzhen Gudeng, the Contractual Arrangements have provided, without having obtained the consent of Shenzhen Zhibo, the Nominee Shareholder and Shenzhen Gudeng (i) shall not sell, transfer, mortgage or dispose of in any manner any material assets, legitimate interest or revenue of Shenzhen Gudeng, or allow any encumbrance thereon of any security interest; and (ii) shall always operate Shenzhen Gudeng's business in the ordinary and usual course of business and shall maintain the asset value of Shenzhen Gudeng and refrain from any action/omission that may adversely affect Shenzhen Gudeng's operating status and asset value.

No material change in the Contractual Arrangements

The Board confirmed that there is no material change in the Contractual Arrangements and/or the circumstances under which they were adopted, and its impact on the Group, and the terms of the Contractual Arrangements and the financial assistance are on normal commercial terms.

減輕深圳智博與代名人股東之間任何潛在利 益衝突的承諾

代名人股東可能與深圳智博及本公司有潛在衝突。 為減輕任何潛在利益衝突,代名人股東及深圳谷登 在獨家認購權協議中承諾,於獨家認購權協議仍然 有效期間,除經深圳智博另行同意者外,代名人股 東及深圳谷登(i)不會參與可能與深圳智博或其關聯 公司的業務競爭的任何業務,及(ii)將委任深圳智 博提名的代名人作為深圳谷登的董事或執行董事。

風險因素

以下為有關合約安排之主要風險:(1)中國政府可 決定合約安排下的文件未能遵守適用法規:(2)合 約安排或未能給予直接擁有權般有效之控制權;及 (3)合約安排或會受到中國税務機關的審查並可能 被徵收額外税項。

此外,本集團藉合約安排透過深圳谷登在中國經營 業務,但合約安排若干條款不一定可根據中國法律 強制執行。據本公司中國法律顧問告知,合約安排 的制訂較為嚴密,藉此降低與相關中國法律及法規 出現潛在衝突的風險。

內部監控措施

為有效監控及保障深圳谷登的資產,合約安排規 定,代名人股東及深圳谷登未獲深圳智博的同意(i) 不得以任何方式出售、轉讓、抵押或處置深圳谷登 的任何重大資產、合法權益或收益,或准許就此設 立任何抵押權益之產權負擔;及(ii)須在日常及一 般業務過程中一直經營深圳谷登的業務,並須保留 深圳谷登的資產價值及避免任何可能對深圳谷登的 營運狀況及資產價值造成不利影響的行動/疏忽。

合約安排概無重大變動

董事會確認,合約安排及/或採納合約安排的情況 及其對本集團之影響並無重大變動,且合約安排及 財務資助之條款符合一般商業條款。

No unwinding of the Contractual Arrangements

The Board also confirmed that there is no unwinding of the Structured Contracts or failure to unwind when the restrictions that led to the adopted Structured Contracts are removed.

RESULTS AND APPROPRIATIONS

The results of the Group for the financial year ended 31 March 2021 and the state of affairs of the Company and the Group at that date are set out in the consolidated financial statements on pages 99 to 244 of this annual report.

The Board adopted a dividend policy in order to promote greater dividend policy transparency. In deciding whether to recommend the payment of dividend to the Shareholders, the Board will take into account of a number of factors, including but not limited to the Company's operation and financial performance, liquidity condition, capital requirements, future funding needs, contractual restrictions, availability of reserves and prevailing economic climate, subject to the applicable rules of Bermuda and the bye-laws of the Company. Based on these factors, the determination of dividend distribution, the amount and frequency, will be made at the discretion of the Board.

The Directors did not recommend the payment of any final dividend for the financial year ended 31 March 2021 (2020: Nil). No interim dividend was paid to the Shareholders during the year under review (2020: Nil).

SHARE CAPITAL AND SHARE OPTIONS

The Scheme became effective on 3 May 2012 and will remain in force for a period of 10 years. The remaining life of the Scheme is approximately one year. Under the Scheme, the Board may grant share options to the Participants to subscribe for the Shares. The offer of a grant of share options must be accepted by the relevant Participants within 30 days after the date of grant upon payment of a consideration of HK\$1 for each lot of share options granted. The exercise price is to be determined by the Board and shall not be less than the highest of (i) the official closing price of the Shares as stated in the daily guotation sheet of the Stock Exchange on the date of grant, which must be a business day; (ii) the average of the official closing prices of the Shares as stated in the daily quotation sheet of the Stock Exchange for the five business days immediately preceding the date of grant; and (iii) the nominal value of a Share.

The number of Shares in respect of which options may be granted to any Participants in any 12-month period up to and including the date of grant shall not exceed 1% of the Shares in issue at any point in time, without prior approval from the Shareholders. Options granted to substantial Shareholders or independent non-executive Directors, or any of their respective associates, in excess of 0.1% of the Shares in issue and with an aggregate value in excess of HK\$5,000,000 must be approved in advance by the Shareholders. There is no specific requirement that an option must be held for any minimum period before it can be exercised but the Board is empowered to impose at its discretion any such minimum period at the time of grant of any particular option. The period during which an option may be exercised will be determined by the Board at its absolute discretion, save that no option may be exercised for a period of more than 10 years from the date of grant.

Upon signing of the Structured Contracts, the details of which are set out in the section headed "Principal Activities and Business Review – Structured Contracts" above, Shenzhen Gudeng was treated as a wholly-owned subsidiary of Shenzhen Zhibo and the accounts of which are consolidated with those of the Company. Notwithstanding that Shenzhen Gudeng will be treated as the Company's wholly-owned subsidiary, it is, at the same time, treated as the Company's connected person as it is wholly-owned by the Nominee Shareholder, a director of certain wholly-owned subsidiaries of the Company, for the purposes of Chapter 14A of the Listing Rules. Accordingly, the transactions contemplated under the Structured Contracts constitute continuing connected transactions of the Company under Chapter 14A of the Listing Rules. The amount of financial assistance made by the Group to Shenzhen Gudeng was approximately RMB500,000 for the year ended 31 March 2021.

The transactions relating to the remuneration of the Directors took place during the year under review as set out in note 38(a) to the consolidated financial statements under the heading of "Material Related Party Transactions" were the service contracts entered into between the Directors which were exempt from any disclosure and shareholders' approval requirements under the Listing Rules. The remaining transactions which took place during the year under review as set out under the heading of "Material Related Party Transactions" did not constitute connected transactions under the Listing Rules.

SUFFICIENCY OF PUBLIC FLOAT

Based on the information that is publicly available to the Company and within the knowledge of the Directors, the Company has maintained a sufficient public float of not less than 25% of the total issued Shares as required under the Listing Rules throughout the year ended 31 March 2021 and up to the date of this annual report.

EVENT AFTER REPORTING PERIOD

Details of significant events of the Group after the reporting period are set out in note 40 to the consolidated financial statements.

Management has estimated the fair value of the Group's investment properties to be approximately HK\$3,069,723,000 as at 31 March 2021, with net loss in fair value for the year ended 31 March 2021 recorded in the consolidated statement of profit or loss and other comprehensive income of approximately HK\$14,202,000. Independent external valuations were obtained in order to support management's estimates. The valuations are dependent on certain key assumptions that require significant management judgement, including market selling price, market rental and plot ratio of land use right.

1. GENERAL INFORMATION

China Agri-Products Exchange Limited (the "**Company**", together with its subsidiaries the "**Group**") is incorporated in Bermuda as an exempted company with limited liability and its shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**"). The addresses of the registered office is Clarendon House, 2 Church Street, Hamilton HM11, Bermuda and the principal place of business is Suite 3202, 32/F, Skyline Tower, 39 Wang Kwong Road, Kowloon Bay, Kowloon, Hong Kong. The immediate holding company of the Company is Goal Success Investments Limited and the intermediate holding company is Wai Yuen Tong Medicine Holdings Limited ("**WYT**") (Stock code: 897). In the opinion of the directors of the Company, the ultimate holding company of the Company is Wang On Group Limited (Stock code: 1222).

The Group is principally engaged in the management and sales of properties in agricultural produce exchange markets in the People's Republic of China (the "**PRC**"). The consolidated financial statements are presented in Hong Kong dollars ("**HK\$**") which is also the functional currency of the Company. All values are rounded to the nearest thousand ("**HK\$'000**") except otherwise indicated.

2. SIGNIFICANT ACCOUNTING POLICIES

(a) Statement of compliance

These consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("**HKFRSs**") issued by the Hong Kong Institute of Certified Public Accountants ("**HKICPA**"). For the purpose of preparation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decisions made by primary users. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited ("**Listing Rules**") and by the Hong Kong Companies Ordinance ("**CO**").

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to the periods presented, unless otherwise stated.

本集團主要在中華人民共和國(「**中國**」)從事農 產品交易市場之物業管理及銷售。綜合財務報 表以港元(「**港元**」)呈列,港元亦為本公司功能 貨幣。除另有指明外,所有價值均四捨五入至 最接近之千位數(「**千港元**」)。

(b) Change of financial year end date

On 29 January 2020, the Group announced to change its financial year end date from 31 December to 31 March. The Company changed its financial year end date in order to align the Company's financial year end date with its ultimate holding company. According, the current year cover the twelve-month period from 1 April 2020 to 31 March 2021 (the "**Current Year**"). The corresponding comparative amounts shown for the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity, the consolidated statement of cash flows and related notes cover a fifteen-month period from 1 January 2019 to 31 March 2020 and therefore may not be comparable with the amounts shown for the Current Year.

(c) Basis of preparation of financial statements

(i) Basis of measurement

The consolidated financial statements have been prepared on the historical cost basis except for investment properties and financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

(i) Basis of measurement (Continued)

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 Share-based Payment, leasing transactions that are accounted for in accordance with HKFRS 16 Lease, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 Inventories or value in use in HKAS 36 Impairment of Assets.

For financial instruments and investment properties which are transacted at fair value and a valuation technique that unobservable inputs is to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that at initial recognition the results of the valuation technique equals the transaction price.

 - Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
 - Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
 - Level 3 inputs are unobservable inputs for the asset or liability.
 - (ii) Functional and presentation currency

Items included in the financial statements of each of the Group's subsidiaries are measured using the currency of the primary economic environment in which the entity operates (the "**functional currency**"). The functional currency of the Company is HK\$. For the purposes of presenting the consolidated financial statements, the Group adopted HK\$ as its presentation currency for the convenience of the readers. The directors consider HK\$, being an internationally well-recognised currency, can provide more meaningful information to the Company's investors.

All values are rounded to the nearest thousand unless otherwise stated.

(iii) Use of estimates and judgements

The preparation of consolidated financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying value of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of HKFRSs that have significant effect on the consolidated financial statements and estimates with a significant risk of material adjustment in the next year are discussed in note 4.

(d) Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved where the Company

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with investees; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year/period are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the noncontrolling interests having a deficit balance.

Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with those used by other members of the Group.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

(i) Business combinations

Acquisitions of businesses, other than business combination under common control are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisitiondate fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisitionrelated costs are generally recognised in profit or loss as incurred.

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any noncontrolling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the net amount of the identifiable assets acquired and the liabilities assumed as at acquisition date. If, after re-assessment, the net amount of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the relevant subsidiary's net assets in the event of liquidation are initially measured at the non-controlling interests' proportionate share of the recognised amounts of the acquiree's identifiable net assets or at fair value.

When the consideration transferred by the Group in a business combination includes a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and included as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively. Measurement period adjustments are adjustments that arise from additional information obtained during the "measurement period" (which cannot exceed one year from the acquisition date) about facts and circumstances that existed at the acquisition date.

The subsequent accounting for the contingent consideration that do not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not remeasured at subsequent reporting dates and its subsequent settlement is accounted for within equity. Contingent consideration that is classified as an asset or a liability is remeasured to fair value at subsequent reporting dates, with the corresponding gain or loss being recognised in profit or loss.

When a business combination is achieved in stages, the Group's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date (i.e. the date when the Group obtains control), and the resulting gain or loss, if any, is recognised in profit or loss or other comprehensive income, as appropriate. Amounts arising from interests in the acquiree prior to the acquisition date that have previously been recognised in other comprehensive income and measured under HKFRS 9 would be accounted for on the same basis as would be required if the Group had disposed directly of the previously held equity interest.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. Those provisional amounts are adjusted retrospectively during the measurement period (see above), and additional assets or liabilities are recognised, to reflect new information obtained about facts and circumstances that existed at the acquisition date that, if known, would have affected the amounts recognised at that date.

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business (see the accounting policy above) less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units ("**CGUs**") (or groups of CGUs) that is expected to benefit from the synergies of the combination, which represent the lowest level at which the goodwill is monitored for internal management purposes and not larger than an operating segment.

A CGU (or group of CGUs) to which goodwill has been allocated is tested for impairment annually or more frequently when there is indication that the unit may be impaired. For goodwill arising on an acquisition in a reporting period, the CGU (or group of CGUs) to which goodwill has been allocated is tested for impairment before the end of that reporting period. If the recoverable amount is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit (or group of CGUs).

On disposal of the relevant CGU or any of the CGU within the group of CGUs, the attributable amount of goodwill is included in the determination of the amount of profit or loss on disposal. When the Group disposes of an operation within the CGU (or a CGU within a group of CGUs), the amount of goodwill disposed of is measured on the basis of the relative values of the operation (or the CGU) disposed of and the portion of the CGU (or the group of CGUs) retained.

(e) Investment properties

Investment properties are properties held to earn rentals and/or for capital appreciation (including properties under construction for such purposes).

Investment properties also include leased properties which are being recognised as right-of-use assets upon application of HKFRS 16 and subleased by the Group under operating leases.

Investment properties are initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are measured at fair value, adjusted to exclude any prepaid or accrued operating lease income.

Gains or losses arising from changes in the fair value of investment properties are included in profit or loss for the period in which they arise.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposals. Any gain or loss arising on derecognition of the property (calculated as the difference between the net disposal proceeds and the carrying amount of the property) is included in profit or loss in the period which the property is derecognised.

(f) Property, plant and equipment

Property, plant and equipment are tangible assets that are held for use in the production or supply of goods or services, or for administrative purposes. Property, plant and equipment are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any (see note 2(h)).

Gains or losses arising from the retirement or disposal of an item of property, plant and equipment are determined as the difference between the net disposal proceed and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

投資物業指持作賺取租金及/或待資產 增值之物業(包括為此目的之在建物業)。

投資物業亦包括於應用香港財務報告準 則第16號時確認為使用權資產並由本集 團根據經營租賃分租之租賃物業。

投資物業初步按成本計值,包括任何直 接應佔支出。初次確認以後,投資物業 按公平值計量,並予以調整以撇除任何 預付或應計經營租金收入。

投資物業公平值變動所產生之收益或虧 損計入其產生期間內之損益中。

投資物業於出售或當投資物業被永久棄 置及預期出售該投資物業不會帶來未來 經濟利益時被取消確認。取消確認物業 所產生之任何盈虧(按出售所得款項淨額 與物業賬面值之差額計算)於取消確認期 間內計入損益。

(f) 物業、廠房及設備

物業、廠房及設備為持作用於生產或供 應貨品或服務或作行政用途之有形資 產。物業、廠房及設備在綜合財務狀況 表中按成本減其後累計折舊及其後累計 減值虧損(如有)列賬(請參見附註2(h))。

報廢或出售物業、廠房及設備項目所產 生之損益是以資產之出售所得款項淨額 與賬面值之間之差額釐定,並在報廢或 出售當日在損益內確認。

Depreciation is calculated to write off the cost of items of property, plant and equipment, less their estimated residual value, if any, using the straight-line method over their estimated useful lives are as follows:

- Buildings situated on leasehold land are depreciated over the shorter of the unexpired term of lease and their estimated useful lives, being no more than 30 years after the date of completion.
- Leasehold improvements are depreciated over the shorter of the unexpired term of lease and their estimated useful lives, being no more than 5 years after the date of completion.
- Furniture, equipment and motor vehicles are depreciated over 5–10 years.

Where parts of an item of property, plant and equipment have different useful lives, the cost of the items is allocated on a reasonable basis between the parts and each part is depreciated separately. Both the useful life of an asset and its residual value, if any, are reviewed annually.

(g) Leasing

Definition of a lease

A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

For contracts entered into or modified on or after the date of initial application or arising from business combinations, the Group assesses whether a contract is or contains a lease based on the definition under HKFRS 16 at inception, modification date or acquisition date, as appropriate. Such contract will not be reassessed unless the terms and conditions of the contract are subsequently changed.

倘物業、廠房及設備項目各部分之可使 用年期不同,該項目之成本按合理基準 於各部分之間分配,每部分分開折舊。 資產之可使用年期及其殘值(如有)每年 審閱。

(g) 租賃

租賃之定義 倘合約獲給予控制權於某一段時間內使 用可識別資產以換取代價,則該合約屬 租賃或包含租賃。

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Financial assets and financial liabilities are initially measured at fair value, except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15. The effective interest rate is the rate that exactly discounts estimated future cash payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial liability, or (where appropriate) a shorter period, to the amortised cost of a financial liability.

Compound instruments

The component parts of convertible notes issued by the Group are classified separately as financial liabilities and equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument. A conversion option that will be settled by the exchange of a fixed amount of cash or another financial asset for a fixed number of the Company's own equity instruments is an equity instrument.

Foreign exchange gains and losses

For financial liabilities that are denominated in a foreign currency and are measured at amortised cost at the end of each reporting period, the foreign exchange gains and losses are determined based on the amortised cost of the instruments. These foreign exchange gains and losses are recognised in profit or loss for financial liabilities that are not part of a designated hedging relationship.

Interest-bearing borrowings are recognised initially at fair value less attributable transaction costs. Subsequent to initial recognition, interest-bearing borrowings are stated at amortised cost with any difference between the amount initially recognised and redemption value being recognised in profit or loss over the period of the borrowings, together with any interest and fees payable, using the effective interest method.

(I) Deposits and other payables

Deposits and other payables are initially recognised and subsequently stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at cost.

(m) Bank and cash balances

Bank and cash balances comprise cash at banks and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated statement of cash flows.

Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.
- (ii) Share-based payments

The fair value of share options granted to employees is recognised as an employee cost with a corresponding increase in share options reserve within equity. The fair value is measured at grant date using the binomial option pricing model, taking into account the terms and conditions upon which the options were granted. Where the employees have to meet vesting conditions before becoming unconditionally entitled to the options, the total estimated fair value of the options is spread over the vesting period, taking into account the probability that the options will vest.

During the vesting period, the number of share options that is expected to vest is reviewed. Any adjustment to the cumulative fair value recognised in prior years is charged/credited to the profit or loss for the period of the review, unless the original employee expenses qualify for recognition as an asset, with a corresponding adjustment to the share options reserve. On vesting date, the amount recognised as an expense is adjusted to reflect the actual number of options that vest (with a corresponding adjustment to the share options reserve) except where forfeiture is only due to not achieving vesting conditions that relate to the market price of the Company's shares. The equity amount is recognised in the share options reserve until either the option is exercised (when it is transferred to the share premium account) or the option expires (when it is released directly to accumulated losses).

- (o) Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit before taxation because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered entirely through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale, except for freehold land, which is always presumed to be recovered entirely through sale.

For the purposes of measuring deferred tax for leasing transactions in which the Group recognises the right-of-use assets and the related lease liabilities, the Group first determines whether the tax deductions are attributable to the right-of-use assets or the lease liabilities.

For lease transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 *Income Taxes* requirements to right-of-use assets and lease liabilities separately. Temporary differences relating to rightof-use assets and lease liabilities are not recognised at initial recognition and over the lease terms due to application of the initial recognition exemption. Temporary differences arising from subsequent revision to the carrying amounts of right-ofuse assets and lease liabilities, resulting from remeasurement of lease liabilities and lease modifications, that are not subject to initial recognition exemption are recognised on the date of remeasurement or modification.

Current and deferred tax are recognised in profit or loss.

(p) Provisions and contingent liabilities

(i) Other provisions and contingent liabilities Provisions are recognised for other liabilities of uncertain timing or amount when the Group or the Company has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

> Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliable, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic is remote. Possible obligations, whose existence will only be confirmed by the occurrence or no-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

(q) Revenue from contracts with customers

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- the Group's performance creates and enhances an asset that the customer controls as the Group performs; or
- the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct goods or service.

A contract asset represents the Group's right to consideration in exchange for goods or services that the Group has transferred to a customer that is not yet unconditional. It is assessed for impairment in accordance with HKFRS 9. In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer. A contract asset and a contract liability relating to a contract are accounted for and presented on a net basis.

For contracts that contain more than one performance obligations, the Group allocates the transaction price to each performance obligation on a relative stand-alone selling price basis.

(r) Translation of foreign currencies

Foreign currency transactions during the year/period are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the balance sheet date. Exchange gains and losses are recognised in consolidated statement of profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost on a foreign currency are translated using the foreign exchange rates ruling at the transactions dates. Non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated using the foreign exchange rates ruling at the date the fair value was determined.

For the purpose of presenting the consolidated financial statements, the results of the Group's operations not denominated in Hong Kong dollars are translated into Hong Kong dollars, i.e., the presentation currency of the Group, at the average rates for the year/period. The items of statement of financial position, including goodwill arising on consolidation of foreign operations acquired, are translated into Hong Kong dollars at the foreign exchange rates ruling at the end of the reporting period. The resulting exchange differences are recognised directly in a separate component of equity. Goodwill arising on consolidation of a foreign operation acquired is translated at the foreign exchange rate that applied at the date of acquisition of the foreign operation.

On disposal of a foreign operation, the cumulative amount of the exchange differences recognised in equity which relate to that foreign operation is included in the calculation of the profit or loss on disposal.

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

(t) Related parties

A party is considered to be related to the Group if:

- A person or a close member of that person's family is related to the Group if that person:
 - (i) has control or joint control over the Group;
 - (ii) has significant influence over the Group; or
 - (iii) is a member of the key management personnel of the Group or of a parent of the Group.

Segment revenue, expenses, results, assets and liabilities include items directly attributable to a segment as well as those that can be allocated on a reasonable basis to that segment. For example, segment assets may include stock of properties, trade receivables and other receivables and right-of-use assets and property, plant and equipment. Segment revenue, expenses, assets, and liabilities are determined before intra-group balances and intra-group transactions are eliminated as part of the consolidation process, except to the extent that such intragroup balances and transactions are between group entities within a single segment. Inter-segment pricing is based on similar terms as those available to other external parties.

Segment capital expenditure is the total cost incurred during the period to acquire segment assets (both tangible and intangible) that are expected to be used for more than one period.

Unallocated items mainly comprise financial and corporate assets, interest-bearing loans, borrowings, tax balances, corporate and financing expenses.

(v) Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants related to income that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable. Such grants are presented under "other revenue and other net income".

(w) Intangible assets

Intangible assets acquired separately

Intangible assets with finite useful lives that are acquired separately are carried at cost less accumulated amortisation and accumulated impairment losses. Amortisation is recognised on a straight-line basis over their estimated useful lives. The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis. Intangible assets with indefinite useful lives that are acquired separately are carried at cost less accumulated impairment losses.

Derecognition of intangible assets

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains and losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, are recognised in profit or loss when the asset is derecognised.

(x) Financial guarantee contracts

A financial guarantee contract is a contract that requires the issuer to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payments when due in accordance with the terms of a debt instrument.

The Group regards its financial guarantee contracts in respect of mortgage facilities provided to certain property purchasers as insurance contracts.

Financial guarantee contracts issued by the Group are initially measured at their fair values and, if not designated as at FVTPL, are subsequently measured at the higher of:

- the amount of the obligation under the contract, as determined in accordance with HKAS 37 Provisions, Contingent Liabilities and Contingent Assets; and
- the amount initially recognised less, where appropriate, cumulative amortisation recognised in accordance with the revenue recognition policies.

(y) Convertible bonds

Convertible bonds that can be converted into equity share capital at the option of the holder, where the number of shares that would be issued on conversion and the value of the consideration that would be received at that time do not vary, are accounted for as compound financial instruments which contain both a liability component and an equity component.

At initial recognition the liability component of the convertible bonds is measured as the present value of the future interest and principal payments, discounted at the market rate of interest applicable at the time of initial recognition to similar liabilities that do not have a conversion option. Any excess of proceeds over the amount initially recognised as the liability component is recognised as the equity component. Transaction costs that relate to the issue of a compound financial instrument are allocated to the liability and equity components in proportion to the allocation of proceeds.

The liability component is subsequently carried at amortised cost. The interest expense recognised in profit or loss on the liability component is calculated using the effective interest method. The equity component is recognised in the convertible bonds reserve until either the bond is converted or redeemed.

If the convertible bond is converted, the convertible bonds reserve, together with the carrying amount of the liability component at the time of conversion, is transferred to share capital and share premium as consideration for the shares issued. If the convertible bond is redeemed, the convertible bonds reserve is released directly to retained profits.

When the convertible bond is extinguished before maturity through an early redemption or repurchase where the original conversion privileges are unchanged, the consideration paid and any transaction costs for the redemption or repurchase are allocated to the liability component and equity component using the same allocation basis as when the convertible bond was originally issued. Once the allocation of consideration and transaction costs is made, any resulting gain or loss relating to the liability component is recognised in profit or loss and the amount of consideration relating to equity component is recognised in equity.

4. CRITICAL ACCOUNTING JUDGEMENTS AND KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, the directors of the Company are required to make judgements, estimates and assumption about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Key sources of estimation uncertainty

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

(i) Impairment of property, plant and equipment and right-ofuse assets

The recoverable amount of an asset is the greater of its fair value less costs to sell and value-in-use. In assessing value-in-use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset, which requires significant judgement relating to level of revenue and amount of operating costs. The Group uses all readily available information in determining an amount that is a reasonable approximation of the recoverable amount, including estimates based on reasonable and supportable assumptions and projections of revenue and operating costs. Changes in these estimates could have a significant impact on the carrying amount of the assets and could result in additional impairment charge or reversal of impairment in future periods.

- (ii) Valuation of investment properties Investment properties are included in the consolidated statement of financial position at their fair value, which is assessed at the end of each reporting period by independent qualified valuers, after taking into consideration all readily available information and current market environment.
- (iii) Net realisable value of stock of properties Valuations of stock of properties are stated at the lower of cost and net realisable value at the end of the reporting period. Net realisable value is determined on the basis of the estimated selling price less the estimated costs necessary to make the sale. The directors of the Company estimate the net realisable value for stock of properties based primarily on the latest invoice prices and current market conditions. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. The Group recognises liabilities for anticipated tax issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made.

Deferred tax assets relating to certain temporary differences and certain tax losses are recognised as management considers it is probable that future taxable profit will be available against which the temporary differences or tax losses can be utilised. Where the expectation is different from the original estimate, such differences will impact the recognition of deferred tax assets and tax in the period in which such estimate is changed.

The Group participates in defined contribution retirement schemes (the "**Schemes**") organised by the relevant local government authorities whereby the Group is required to make contributions to the Schemes at certain percentage of the eligible employees' salaries, pursuant to the relevant labour rules and regulations in the PRC. The local government authorities are responsible for the entire pension obligations payable to retired employees.

The Group also operates a Mandatory Provident Fund Scheme (the "**MPF Scheme**") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed under the jurisdiction of the Hong Kong Employment Ordinance. The MPF Scheme is a defined contribution retirement plan administered by independent trustees. Under the MPF Scheme, the employer and its employees are each required to make contributions to the plan at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000. Contributions to the plan vest immediately.

The Group has no other obligation for the payment of postretirement benefits beyond the contributions described above.

(a) Valuation of investment properties

The investment properties amounted of approximately HK\$3,069,723,000 of the Group were stated at fair value as at 31 March 2021 (2020: HK\$2,839,091,000). The fair value were arrived at based on the valuations carried out by an independent firm of qualified professional valuer, RHL Appraisal Limited ("**RHL**"), who has among their staff members of the Hong Kong Institute of Surveyors with recent experience in the location and category of the properties being valued. The valuations conform to the Valuation Standards 2017 Edition published by the Hong Kong Institute of Surveyors.

RHL has valued the properties on the basis of capitalisation of the net income derived from properties rental. In the course of their valuation, RHL has also made reference to the comparable market transactions as available. Discussions of valuation processes and results are held between the Group and valuers at least once every six months, in line with the Group's interim and annual reporting dates. As at 31 March 2021 and 31 March 2020, the fair values of the properties have been determined by RHL. At each financial year end, the Group (i) verifies all major inputs to the independent valuation report; (ii) assesses property valuations movements when compared to the prior years valuation input; and (iii) holds discussions with the independent valuer.

- (d) the properties are connected to main services and sewers which are available on normal terms.

There has been no change from the valuation technique used in the prior years. In estimating the fair value of the properties, the highest and best use of the properties is their current use.

The valuation of investment properties is determined by various major inputs:

The major key inputs applied in valuing the investment properties were market unit rental per each square meter per month (the "**s.q.m. per month**"). The ranges of s.q.m. per month of various locations were from RMB10.1 to RMB68.3 (31 March 2020: RMB3.7 to RMB63.1). A significant increase in the s.q.m. per month used would result in a significant increase in fair value, and vice versa.

The term yield and reversionary yield were one of the key inputs used in valuing the investment properties. The ranges of term yield was from 7.0% to 8.0% (31 March 2020: 7.0% to 8.0%) while the ranges of reversionary yield were from 7.5% to 8.5% (31 March 2020: 7.5% to 8.5%). All of the Group's property interests held under operating leases to earn rentals are measured using the fair value model and classified accounted for investment properties.

The Group leases out its investment properties which is agricultural exchange markets to various tenants. The leases typically run for an initial period of 1 year to 5 years, at the end of which period all terms are renegotiated. None of the leases includes contingent rentals. For the year ended 31 March 2021, the rental income from investment properties less direct outgoings of approximately HK\$17,591,000 (fifteen months from 1 January 2019 to 31 March 2020: approximately HK\$20,731,000) amounted to approximately HK\$176,130,000 (fifteen months from 1 January 2019 to 31 March 2020: approximately HK\$216,184,000).

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern, so that it can continue to provide returns for shareholders and benefits for other stakeholders, by pricing products and services commensurately with the level of risk and by securing access to finance at a reasonable cost.

The Group actively and regularly reviews and manages its capital structure to strictly control the debt level. The Group maintains a strategy on acquiring land only if the project development can commence within a short period of time so as to minimise the time period between acquisition and development of the acquired land, thus the Group's capital can be efficiently deployed.

The Group monitors its capital structure on the basis of gearing ratio. For this purpose, the Group defines net debt as total debt (which includes bank and other borrowings, bonds, convertible bonds and promissory notes) less cash and cash equivalents. Capital comprises total equity attributable to equity shareholders of the Company. The Group's overall strategy remains unchanged from prior year.

34. EQUITY SETTLED SHARE-BASED TRANSACTIONS

The Company adopted a share option scheme (the "**Scheme**") on 3 May 2012 whereby the directors the Company are authorised, at their discretion, to invite selected eligible persons (the "**Participants**") to take up options for their contribution to the Group. The Scheme will remain in force for 10 years. (c) the nominal value of a share.

Subject to the issue of a circular and the approval of the shareholders of the Company in general meeting and/or such other requirements prescribed under the Listing Rules from time to time, the Board may refresh the limit at any time to 10% of the total number of shares in issue as at the date of approval by the shareholders of the Company in general meeting. Notwithstanding the foregoing, the shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under the Scheme and any other share option schemes of the Company at any time shall not exceed 30% of the shares in issue from time to time.

The number of shares in respect of which options may be granted to the Participants in any 12-month period up to and including the date of grant shall not exceed 1% of the total number of shares in issue as at the date of grant. Any further grant of options in excess of this 1% limit shall be subject to the approval of the shareholders in general meeting. The participant and his associates (as defined in the Listing Rules) are abstained from voting and/or other requirements prescribed under the Listing Rules from time to time. Options granted to substantial shareholders or independent non-executive directors in excess of 0.1% of the Company's share capital or with a value in excess of HK\$5,000,000 must be approved in advance by the Company's shareholders.

There is no specific requirement that an option must be held for any minimum period before it can be exercised but the Board is empowered to impose at its discretion any such minimum period at the time of grant of any particular option. Exposure to credit, liquidity and market risks (including interest rate, currency risk and equity price risk) arises in the normal course of the Group's business.

These risks are limited by the Group's financial management policies and practices described below.

Credit risk (a)

> The Group is exposed to credit risk in relation to its trade and other receivables, loan receivables and cash deposits with banks.

> The carrying amounts of trade and other receivables, loan receivables and cash and cash equivalents represent the Group's maximum exposure to credit risk in relation to financial assets.

> In relation to the Group's deposits with bank, the Group limits its exposure to credit risk by placing deposits with financial institutions with high credit rating and no recent history of default. The directors of the Company consider that the Group's credit risk on the bank deposits is low. Management continues to monitor the position and will take appropriate action if their ratings should change. As at 31 March 2021 and 2020, the Group has no significant concentration of credit risk in relation to deposits with bank.

> The Group has a concentration of credit risk in certain individual customers. At the end of each reporting period, the five largest receivable balances accounted for approximately 37.7% (2020: approximately 78%) of the trade receivables and the largest trade receivable was approximately 31.6% (2020: approximately 61%) of the Group's total trade receivables. The Group seeks to minimise its risk by dealing with counterparties which have good credit history. Majority of the trade receivables that are neither past due nor impaired have no default payment history.

> The Group's concentration of credit risk by geographical location is mainly in the PRC.

(a) 信貸風險

本集團面臨著與其貿易及其他應收款 項、應收貸款及銀行現金存款有關的信 貸風險。

貿易及其他應收款項、應收貸款及現金 及現金等額的賬面值指本集團有關金融 資產的最大信貸風險。

就本集團存放於銀行之存款而言,本集 團透過將存款存放於具高信貸評級及近 期並無違約紀錄之金融機構,藉以減低 所承擔之信貸風險。本公司董事認為, 本集團銀行存款之信貸風險偏低。管理 層繼續監察有關狀況,並會於彼等之評 級有變時採取適當行動。於二零二一年 及二零二零年三月三十一日,本集團並 無有關銀行存款之高度集中信貸風險。

(a) Credit risk (Continued)

For loan and other receivables, management makes periodic collective assessments as well as individual assessment on the recoverability of loan and other receivables based on historical settlement records and past experience. The directors of the Company believe that there is no material credit risk inherent in the Group's outstanding balance of loan and other receivables.

The Group considers the probability of default upon initial recognition of, a financial asset and whether there has been a significant increase in credit risk on an ongoing basis throughout each reporting period. To assess whether there is a significant increase in credit risk the Group compares the risk of a default occurring on the asset as at the reporting date with the risk of default as at the date of initial recognition. It considers available reasonable and supportive forward-looking information. Especially the following indicators are incorporated:

- internal credit rating;
- external credit rating;
- actual or expected significant adverse changes in business, financial or economic conditions that are expected to cause a significant change to the borrower's ability to meet its obligations;
- actual or expected significant changes in the operating results of the borrower;
- significant increases in credit risk on other financial instruments of the same borrower; and
- significant changes in the expected performance and behaviour of the borrower, including changes in the payment status of borrowers in the Group and changes in the operating results of the borrower.

The Group applies the simplified approach to providing for expected credit losses prescribed by HKFRS 9, which permits the use of the lifetime expected loss provision for all trade receivables.

In general, the credit record and credit period for each customer or debtor are regularly assessed, based on the customer's or debtor's financial condition, their capacity to obtain guarantee from third parties, their credit records and other factors such as current market condition. Management overall considers the shared credit risk characteristic and the days past due of the trade receivables to measure the expected credit. The Group will monitor debtors with long outstanding balances and will engage in enforcement activities to recover the receivables due. Where recoveries are made, these are recognised in consolidated statements of profit or loss and other comprehensive income. The Group closely monitors trade receivables balance more than 30 days. Those trade receivables, due more than 90 days, with financial difficulties, declining credit standing and poor historical payment pattern will be considered as default. The Group will write off these unrecovered receivables after all possible means of debt recovery activities.

For loan and other receivables, the Group applies either a 12-month expected credit losses or lifetime expected credit losses, depending on whether there has been a significant increase in credit risk since initial recognition. If a significant increase in credit risk of a receivables has occurred since initial recognition then impairment is measured as lifetime expected credit losses.

In determining the 12-month or lifetime expected credit loss for these receivables, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical payment experience and the corresponding historical credit loss rates, and adjusted for forward-looking macroeconomic data. In assessing whether the credit risk on these receivables have increased significantly since initial recognition, the Group compares the risk of a default occurring on these receivables as at the reporting date with the risk of default occurring on these receivables as at the date of initial recognition. Management would re-assess these factors periodically for any deterioration or improvement indications to determine if credit risk from these receivables has increased or decreased.

(b) Liquidity risk

Liquidity risk is the risk that the Group will not be able to meet its financial obligations as they fall due. Individual operating entities within the Group are responsible for their own cash management, including the short-term investment of cash surpluses and the raising of loans to cover expected cash demands, subject to approval by the parent company's board when the borrowings exceed certain predetermined levels of authority. The Group's policy is to regularly monitor its current and expected liquidity requirements and its compliance with lending covenants to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term. (c) Interest rate risk

The Group's interest rate risk arises primarily from bank and other borrowings, bonds, convertible bonds, promissory notes, and cash and cash equivalents.

Cash and cash equivalents comprise mainly cash at banks and in hand, with the annual interest rates ranging from approximately 0.001% to 3.05% as at 31 March 2021 (2020: approximately 0.001% to 1.95%).

The interest rates of the Group's bank and other borrowings, bonds, promissory notes and convertible bonds are disclosed in notes 27, 28, 29 and 30 respectively.

The Group is exposed to fair value interest rate risk in relation to fixed-rate bank and other borrowings, bonds, promissory notes and convertible bonds (see notes 27, 28, 29 and 30 for details).

The Group is exposed to cash flow interest rate risk in respect of its variable-rate bank and other borrowings (see note 27) and bank balances (see note 24) due to changes of interest rates. It is the Group's present policy to keep its borrowings at floating rate of interests so as to minimise the fair value interest rate risk. The Group currently does not have any interest rate hedging policy. However, the management monitors interest rate exposure and will consider hedging significant fixed-rate bank and other borrowings should the need arise.

Sensitivity analysis

At 31 March 2021, it is estimated that a general increase/ decrease of 100 basis points in interest rates, with all other variables held constant, would decrease/increase the Group's profit after tax and increase/decrease accumulated losses by approximately HK\$940,000 (fifteen months from 1 January 2019 to 31 March 2020: HK\$1,496,000). Other components of equity would not be affected (fifteen months from 1 January 2019 to 31 March 2020: Nil) in response to the general increase/ decrease in interest rates.

The sensitivity analysis above has been determined assuming that the change in interest rates had occurred at the end of reporting period and had been applied to the exposure to interest rate risk for non-derivative financial instruments in existence at that date. The 100 basis point increase or decrease represents management's assessment of a reasonably possible change in the respective interest rates over the period until the next annual reporting period. (d) Currency risk

Currency risk to the Group is minimal as most of the Group's transactions denominated and settled in the functional currency of the operations to which the transactions relate. Most of the Group's monetary assets and liabilities are also denominated in the Group's functional currencies. Therefore, the Group has no significant currency risk exposure as they are denominated in a currency same as the functional currencies of the group entities to which these transactions relate.

(e) Equity price risk

The Group is exposed to equity price risk mainly through its investment in listed equity securities. The management manages this exposure by maintaining a portfolio of investments with difference risk and return profiles. The Group exposed to equity price risk arising from changes in the Group's financial assets at fair value through profit or loss.

Sensitivity analysis

The sensitivity analysis below have been determined based on the exposure to equity price risk at the reporting date. If equity price had been 5% higher/lower, the Group's net profit for the year would increase/decrease by approximately HK\$3,300 (fifteen months from 1 January 2019 to 31 March 2020: approximately HK\$3,600). This is mainly due to the changes in financial assets at fair value through profit or loss.

(f) Fair value of financial instrument

The fair values of financial assets and financial liabilities are determined as follows:

- the fair values of financial assets and financial liabilities with standard terms and conditions and traded on active liquid markets are determined with reference to quoted market prices; and
- the fair values of other financial assets and financial liabilities are determined in accordance with generally accepted pricing models based on discounted cash flow analysis.

The carrying amount of other financial assets and liabilities carried at amortised cost, approximate their respective fair values due to the relatively short-term nature of these financial instruments.

- (A) Writ issued in the PRC by Ms. Wang Xiu Qun and Wuhan Tian Jiu Industrial and Commercial Development Co., Ltd. against the Company ("PRC Action No.1")
 - On 7 January 2011, the Company received a writ (the "Writ") issued by Ms. Wang Xiu Qun ("Ms. Wang") and Wuhan Tian Jiu Industrial and Commercial Development Co., Ltd. ("Tian Jiu") (as plaintiffs) against the Company (as defendant) and filed with the Higher People's Court of Hubei Province (the "Hubei Court") of the PRC, together with the related court summons dated 4 January 2011 (the "Summons"). The Writ also joined Wuhan Baisazhou Agricultural By-Product Grand Market Company Limited ("Baisazhou Agricultural") as third party to such civil proceeding.

Major allegations of Ms. Wang and Tian Jiu as set out in the Writ are as follows:

- (a) it is alleged that Baisazhou Agricultural forged a share transfer agreement (the "Contended Agreement") in relation to the acquisition of Baisazhou Agricultural (the "Acquisition") wherein consideration for the Acquisition was understated and the manner of settlement of the consideration was inaccurately described;
- (b) it is alleged that Baisazhou Agricultural forged the related documentation for filing with the PRC Ministry of Commerce ("MOFCOM") and the Hubei Administration For Industry and Commerce (the "Hubei AIC"), and that such documentation and the Contended Agreement involved forged signatures; and

 - (c) it is alleged that MOFCOM and the Hubei AIC approved the Acquisition and processed the related filings on the basis of the above documents that are allegedly forged.

At the relevant time of the Acquisition, none of the current Directors or senior management of the Company as at the date of this report were involved in the Acquisition.

According to the Writ, Ms. Wang and Tian Jiu were seeking an order from the court that the Contended Agreement, to which the Company is a party, is void and invalid from the beginning and should therefore be terminated, and claimed against the Company and Baisazhou Agricultural all relevant profits of Baisazhou Agricultural which were attributable to Ms. Wang and Tian Jiu, together with costs of the legal proceedings.

Pursuant to the Undertakings, the Instruments will no longer fall due for payment by the Company on 5 December 2012.

On 9 June 2017, upon the parties' joint application to the Court, the Court varied the Undertakings to the effect that the Undertakings shall stand save that Ms. Wang and Tian Jiu can make a counterclaim under the present action as per the draft attached to the Consent Summons filed by the parties on 2 June 2017.
 - The trial took place in February, March and June 2019 for 23 days.

 - (b) Ms. Wang shall pay to the Company nominal damages of HK\$1 for the failure on the part of Ms. Wang to assist the Company or Baishazhou Agricultural to obtain the Land Use Certificates in question;

As at 18 January 2021, the aggregate amount of the principal amount and interest payable of the promissory notes was approximately HK\$660,833,000 and the award of damages was approximately HK\$663,253,000. Based on the assessment by the management of the Company, the exceeding amount of approximately HK\$2,420,000 from the award of damages was not recognised as probability of the recoverability is remote. As a result, the management of the Company only recognised approximately HK\$660,833,000 in the consolidated statement of profit or loss and other comprehensive income.

- (C) Legal proceedings against MOFCOM by Ms. Wang and Tian Jiu
 - On 4 May 2015 and 5 May 2015, Ms. Wang and Tian Jiu had jointly commenced two separate legal proceedings against MOFCOM alleging that MOFCOM failed to discharge its statutory duties for handling their application submitted in January 2015 for revoking the certificate of approval and letter of approval in relation to the Contended Agreement (the "Application"). - (C) Legal proceedings against MOFCOM by Ms. Wang and Tian Jiu (*Continued*)
 - 7. According to a writ dated 3 August 2016, Ms. Wang and Tian Jiu requested the Beijing Court to revoke the MOFCOM Decision and to order MOFCOM to make a decision to revoke the approval. According to a notice issued by the Beijing Court together with the writ which was served to the Company, each of the Company and Baisazhou Agricultural has been added as a third party to the proceedings by the Beijing Court. Three hearings have taken place in the Beijing Court so far.

 - 12. In other words, the approval issued by MOFCOM in November 2007 in relation to the Contended Agreement shall not be revoked and shall remain to be in force.

Subsequent to the year ended 31 March 2021, on 18 June 2021, Century Choice Limited ("Century Choice"), a wholly-owned subsidiary of CAP and a substantial shareholder (the "PRC Shareholder") of 玉林宏進農副產品批發市場有限公司 (Yulin Hongjin Agricultural By-products Wholesale Marketplace Limited ("Yulin Hongjin")) entered into an agreement in relation to the reduction of registered capital contribution of Century Choice in Yulin Hongjin. Pursuant to the agreement, the PRC Shareholder waived its entitlement to the dividend declared by Yulin Hongjin for the financial year ended 31 December 2020 in the amount of approximately RMB117 million and directed the same to be paid to Century Choice, and the amount of registered capital contribution by Century Choice in Yulin Hongjin was reduced by an amount equal to approximately RMB41.9 million. As a result of such reduction of registered capital contribution, the CAP Group's equity interest in Yulin Hongjin was decreased from 65% to 51%. Details of the capital reduction were disclosed in the joint announcement of, inter alia, the Company dated 18 June 2021.
