INSIDE INFORMATION UPDATES ON WINDING UP PETITION

This announcement is made by CT Environmental Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules (the “**Listing Rules**”) Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

Reference is made to the announcements of the Company dated 13 April 2021 and 7 July 2021 respectively (collectively the “**Announcements**”) in relation to, among other things, a winding up petition presented against the Company (the “**Petition**”). Unless otherwise stated, capitalized terms used in this announcement shall have the same meaning as those defined in the Announcements.

UPDATES ON WINDING UP PETITION

On 27 August 2021, the High Court heard the summons taken out by the Petitioner for applying for the appointment of provisional liquidators of the Company and ordered, among other things, that the application was dismissed with costs of the summons be paid by the Petitioner to the Company.

As disclosed in the announcement of the Company dated 7 July 2021, the hearing of the Petition was adjourned to 1 September 2021. The Company will keep its shareholders and investors informed of any significant development in respect of the Petition and will make further announcement(s) as and when appropriate in accordance with the Listing Rules.

CONTINUED SUSPENSION OF TRADING

At the request of the Company, trading in the Shares on the Stock Exchange has been suspended with effect from 9:00 a.m. on 1 April 2019. Trading in the Shares will remain suspended until further notice.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the Shares and other securities of the Company.
