THE PROVISIONAL AGREEMENT

On 9 September 2021, the Vendor (a non wholly-owned subsidiary of the Company) entered into the Provisional Agreement with the Purchaser for the sale and purchase of the Property at a Consideration of HK\$32,218,920 which shall be paid by the Purchaser to the Vendor in the manner as follows:

- (i) HK\$1,500,000, being the initial deposit, has been paid upon the signing of the Provisional Agreement;
- (ii) HK\$1,721,892, being further deposit, will be paid on or before 23 September 2021; and
- (iii) the balance of the Consideration of HK\$28,997,028 will be paid upon completion on or before 1 December 2021.

Pursuant to the Provisional Agreement, the Vendor and the Purchaser will enter into a formal agreement for the sale and purchase of the Property on or before 23 September 2021.
