

POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 23 SEPTEMBER 2021

At the annual general meeting (the “AGM”) of Man Sang International Limited (the “Company”) held on 23 September 2021, all the proposed resolutions as set out in the notice of the AGM of the Company dated 30 July 2021 (the “Notice”) were duly passed by the shareholders of the Company by way of poll. Unless otherwise indicated, capitalised terms used herein have the same meanings as those defined in the Notice and the circular of the Company dated 30 July 2021 (the “Circular”). The Company’s branch share registrar in Hong Kong, Tricor Secretaries Limited, was appointed as the scrutineer for vote-taking at the AGM. The poll results are as follows:

There were no Shares entitling the holders to attend and abstain from voting in favour of the resolutions at the AGM as set out in the Listing Rules.

No Shareholder was required under the Listing Rules to abstain from voting on the resolutions at the AGM. None of the Shareholders has stated their intention in the Circular to vote against or to abstain from voting on any of the resolutions at the AGM.
