

## **VOLUNTARY ANNOUNCEMENT SHARE REPURCHASE**

This is a voluntary announcement made by Sihuan Pharmaceutical Holdings Group Ltd. (the “**Company**”).

Reference is made to the announcement of the Company dated 28 March 2021 (the “**March Announcement**”) in relation to the proposed on-market repurchase of shares of the Company (the “**Shares**”) pursuant to the general repurchase mandate granted by the shareholders of the Company. The board of directors of the Company (the “**Board**”) hereby announces that it intends to exercise its powers under the general mandate to repurchase (the “**Repurchase Mandate**”) Shares of the Company granted by the shareholders of the Company at the annual general meeting held on 30 June 2021 to repurchase Shares in the open market at appropriate timing.

The Board further announces that, on 28 September 2021, the Company repurchased, pursuant to the Repurchase Mandate, a total of 5,000,000 Shares of the Company on market at an average price of HK\$1.5145 per Share (the “**Share Repurchase**”).

The aggregate purchase price paid (excluding commission and other expenses) for the Share Repurchase was approximately HK\$7,572,500. The repurchased Shares represent approximately 0.05% of the total number of issued Shares as at the date of this announcement. The Company will subsequently cancel the repurchased Shares as a result of the Share Repurchase.

The financial position of the Company is solid and healthy currently. The Board believes the Share Repurchase and subsequent cancellation of the repurchased Shares could enhance the value of the Shares thereby improving the return to shareholders of the Company. In addition, the Board believes that the Share Repurchase reflects the Company’s confidence in its long term business prospects and would ultimately benefit the Company and is in the interests of the Company and the shareholders of the Company as a whole. The Company may make further share repurchase depending on market conditions.

Shareholders and potential investors should note that any repurchase may be done subject to market conditions and at the Board's absolute discretion. There is no assurance of the timing, quantity or price of any repurchase. Shareholders and potential investors should therefore exercise caution when dealing in the securities of the Company.
