## INSIDE INFORMATION

This announcement is made by Chuang's Consortium International Limited (the "Company") pursuant to Rule 13.09 of The Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The principal activities of the Company and its subsidiaries (collectively as the "Group") are property development, investment and trading, hotel operation and management, development and operation of cemetery, manufacturing, sales of goods and merchandises, securities investment and trading and money lending business. As disclosed in the annual report of the Company for the year ended 31 March 2021 (the "2021 Annual Report"), as part of the principal activities, the Group has investments in high yield bonds recorded in "Financial assets at fair value through profit or loss" (the "Bond Investment") with the amount of about HK\$3,334.8 million, in which about HK\$2,114.8 million were held by the wholly-owned subsidiaries of the Group, and about HK\$1,220.0 million were held by the wholly-owned subsidiaries of Chuang's China Investments Limited, a 60.7% listed subsidiary of the Group.

For the six months ended 30 September 2021, the performance of the Bond Investment was adversely affected by unfavourable and high volatility of the high yield bond market. During this period, in respect of the Bond Investment, the Group expects to record interest income of about HK\$128.2 million, realized loss on disposal and redemption of Bond Investment of about HK\$12.3 million, and unrealized fair value loss on Bond Investment of about HK\$563.7 million as a result of mark to market prices of the Bond Investment as at 30 September 2021. The net effect of the above is a loss of about HK\$364.2 million (after deducting non-controlling interests of about HK\$83.6 million). Shareholders of the Company and potential investors should, however, note that the unrealized fair values loss on Bond Investment are accounting loss with no immediate cash flow impact to the Group.

As disclosed in the 2021 Annual Report, the Group completed the disposals of the property projects in Panyu, the People's Republic of China at a consideration of about RMB1.57 billion (equivalent to approximately HK\$1.88 billion) and Vietnam at a consideration of about US\$25.6 million (equivalent to approximately HK\$199.4 million) in May 2021. The disposals in cash have greatly strengthened the Group's financial position and are expected to generate substantial net gain to the Group for the six months ended 30 September 2021.

The Company is in the process of preparing the interim results of the Group for the six months ended 30 September 2021. The information contained in this announcement is only based on the preliminary assessment by the board of directors of the Company (the "Board") on the Bond Investment according to the information currently available which have not been finalized as at the date of this announcement and have not been reviewed by the Company's auditor.
