SUPPLEMENTAL INFORMATION ON CONNECTED TRANSACTIONS

We refer to the announcement issued by the XPeng Inc. (the “**Company**”) on 19 October 2021 in relation to the connected transactions of the Company (the “**Announcement**”). Capitalised terms used herein shall have the same meanings as those defined in the Announcement unless the context requires otherwise.

The Company wishes to provide the following additional information about the beneficial owners of Huitian and Dogotix.

As of the date of the Announcement, save for (i) Mr. Xiaopeng He’s 34.3% equity interests and XPeng Huitian Investment Company’s 19.9% equity interests in Huitian and (ii) 15% equity interests in Huitian reserved for Huitian’s employee share option plan, Zrocket Holdings Limited held 15.0% equity interests in Huitian. Zrocket Holdings Limited is a company incorporated in the British Virgin Islands with limited liability and its sole shareholder is Mr. Zhao Deli, a founder and senior management of Huitian and an independent third party of the Company. Other than mentioned above, each of the remaining five shareholders of Huitian, who was an independent third party of the Company, held less than 10% equity interests in Huitian.

As of the date of the Announcement, save for Mr. Xiaopeng He’s 50.1% equity interests and XPeng Dogotix Investment Company’s 19.9% equity interests in Dogotix, of the remaining 30% equity interests in Dogotix, 22.5% was reserved for Dogotix’s employee share option plan and 7.5% equity interest was held by Zdogo Holdings Limited, which was in turn wholly-owned by Mr. Zhao Tongyang, a founder of Dogotix and an independent third party of the Company.
