# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層討論及分析

### BUSINESS REVIEW

Wecon Holdings Limited (the "Company", together with its subsidiaries, the "Group") is a long-established main contractor in Hong Kong and principally engaged in the provision of (i) building construction services; and (ii) repair, maintenance, alteration and addition ("RMAA") works services. The Group provides building construction services to customers in both the private and public sectors. The building construction services provided by the Group primarily consist of building works for new buildings, including residential, commercial and industrial buildings, while the Group's RMAA works services include the general upkeep, maintenance, improvement, refurbishment, alteration and addition of existing facilities and components of buildings and their surroundings.

As at 30 September 2021, the Group had 12 major projects on hand with an awarded contract sum of HK\$10.0 million or above, which include four new projects awarded during the six months ended 30 September 2021.

During the six months ended 30 September 2021, the Group had completed one major project with an awarded contract sum of HK\$10.0 million or above.

### PROSPECTS

The outbreak of COVID-19 pandemic (the "Pandemic") at the beginning of 2020 has made the operating environment difficult and has created challenges to various industries in Hong Kong. The negative impact brought by the Pandemic had caused an adverse effect on the Group's business, which led to a delay in the delivery of raw materials to the construction sites and progress of certain construction projects. However, the Group had taken the necessary measures to maintain its construction works during the outbreak of the Pandemic to be performed within the planned schedule. As the Pandemic may persist in the foreseeable future, the management of the Group will continuously monitor the development of the Pandemic as well as assess the overall impact on the Group's business from time to time, and accordingly evaluate the impact on the financial position and performance of the Group. Also, the management of the Group monitors any changes to the law and regulations in compliance with industrial safety and public health policies; and deploys appropriate preventive measures to enhance protection of the Group's employees by providing healthy and hygienic environment both in the office and at the construction sites.

### 業務回顧

偉工控股有限公司(「本公司」，連同其附屬公司統稱「本集團」)作為香港一間歷史悠久之總承建商，主要從事提供(i)屋宇建造服務；及(ii)維修、保養、改建及加建(「裝修及維修工程」)工程服務。本集團提供屋宇建造服務予私營及公營界別客戶。本集團提供的屋宇建造服務主要包括住宅、商用和工業樓宇等新樓宇的建築工程，而本集團的裝修及維修工程服務包括對現有設施、樓宇各部分及周圍環境的一般維修、保養、改善、翻新、改建及加建。

於2021年9月30日，本集團手頭上有12宗主要項目，其獲授合約金額為10.0百萬港元或以上，其中包括截至2021年9月30日止六個月期間獲授的四宗新項目。

截至2021年9月30日止六個月期間，本集團已完成一宗主要項目，其獲授合約金額為10.0百萬港元或以上。

### 展望

2020年年初爆發的新型冠狀病毒病疫情(「疫情」)令經營環境變得艱難，亦對香港各行業構成挑戰。疫情所帶來的負面影響對本集團的業務造成不利影響，導致向建築工地交付原材料及若干建設項目進度均有所延遲。然而，本集團已採取必要措施使疫情爆發期間的建築工程按計劃如期進行。由於疫情可能於可預見將來存續，本集團管理層將繼續不時觀察疫情發展，並評估疫情對本集團的業務的整體影響，並就此評估其對本集團財務狀況及表現的影響。此外，本集團管理層亦監察法律及法規的任何變動，以遵守工業安全及公共衛生政策；並採取適當的預防措施，提供健康衛生的辦公室及建築工地環境，以加強保護本集團的僱員。

During the six months ended 30 September 2021, the Group was successfully awarded four sizeable contracts with an aggregate contract sum of approximately HK\$1,229.3 million, one of which was awarded from a new customer. Subsequent to 30 September 2021, the Group was awarded one additional contract with a contract sum of approximately HK\$202.8 million, which was also awarded from a new customer. The Group will continue to diversify its customer base by placing more effort to maintain the Group's reputation, ensuring projects are completed on time with the highest quality and implementing various cost-effective measures to improve its competitiveness. The management of the Group still remains prudently optimistic about the prospects of the construction industry in Hong Kong.

As the world economy enters into a period of profound transformation, the Group would seek evolution through every avenue. The Group believes that the building information modeling services could differentiate the Group from the Group's competitors, through providing creative technical solutions to the Group's customers. Going forward, the Group plans to invest in building construction related services that will enhance the Group's capabilities and provide synergies to the existing business of the Group, while the Group strives to maintain its high quality and workmanship which the Group has been delivering to its customers.

## PRINCIPAL RISKS AND UNCERTAINTIES

There are certain risks relating to the Group's operations which could harm the Group's business, financial condition and operating results. Some of the relatively material risks relating to the Group are summarised as follows:

- (i) the Group's business and operation may be affected by the Pandemic or other public health incident, which may cause lockdown, travel restrictions and suspension of work in Hong Kong or elsewhere;
- (ii) the Group's revenue relies on the Group's contracts being awarded through tendering or quotation processes which are not recurrent in nature. There is no guarantee on the Group's continual success in project tenders or quotation and the Group's sustainability and financial performance may be materially and adversely affected;

截至2021年9月30日止六個月期間，本集團成功獲授四項合約金額合共約1,229.3百萬港元的大型合約，其中一項由新客戶授予。於2021年9月30日後，本集團獲授一項合約金額約202.8百萬港元的額外合約，亦為由新客戶授予。本集團將繼續格外注重保持本集團的聲譽，確保項目以最高質素按時完成，並實施各項具有成本效益的措施提升競爭力，使客戶群得以多元化。本集團管理層仍對香港建造業的前景保持審慎樂觀。

隨著世界經濟步入重大變革時期，本集團將通過各種途徑尋求發展。本集團認為建築信息模擬服務讓本集團從本集團的競爭對手中脫穎而出，皆因本集團為客戶提供創新的技術解決方案。展望未來，本集團致力維持其一貫水準，繼續向客戶交付優質工藝，並計劃投資於屋宇建造相關服務，以提升本集團的能力並為本集團現有的業務提供協同效應。

## 主要風險及不確定因素

與本集團營運相關的若干風險可能會損害本集團的業務、財務狀況及營運業績。若干有關本集團相對重大的風險概述如下：

- (i) 本集團業務及營運可能因疫情或其他公眾健康事故而受到影響，可能導致香港或其他地方出現封鎖、旅遊限制及停工；
- (ii) 本集團收益倚賴於本集團通過非經常性投標或報價流程獲得的合約。概不保證本集團持續成功進行項目投標或報價，本集團的可持續性及財務表現或受重大不利影響；

- (iii) the Group is exposed to concentration risk of heavy reliance on the Group's largest and major customers;
  - (iv) the Group relies on the Group's subcontractors to perform generally most of the works of the Group's projects; any fluctuations in subcontracting costs, unsatisfactory performance or unavailability of the Group's subcontractors may materially and adversely affect the Group's operations and profitability;
  - (v) the Group may suffer from cash flow shortcomings due to mismatch in time between receipt of progress payments from our customers, and payments to our suppliers and subcontractors;
  - (vi) changes in the prices and availability of raw materials may materially and adversely affect the Group's operating results; and
  - (vii) the Group provides performance bonds in the course of the Group's business operations which could affect the Group's liquidity position.

## SEGMENT INFORMATION

The Group's reportable and operating segments are (i) building construction services; and (ii) RMAA works services. Details of the segmental information of the Group is disclosed in note 3 to the interim condensed consolidated financial information of this interim report.

## 分部資料

本集團可呈報及經營分部為(i)屋宇建造服務；及(ii)裝修及維修工程服務。本集團分部資料詳情於本中期報告內中期簡明綜合財務資料附註3內披露。

## FINANCIAL REVIEW

### Revenue

The revenue of the Group decreased by approximately HK\$105.4 million or approximately 16.4% from approximately HK\$643.8 million during the six months ended 30 September 2020 to approximately HK\$538.4 million during the six months ended 30 September 2021.

#### (i) Building Construction Services

The revenue generated from the building construction services decreased by approximately HK\$78.9 million or approximately 13.9% from approximately HK\$567.7 million during the six months ended 30 September 2020 to approximately HK\$488.8 million during the six months ended 30 September 2021. Such decrease was mainly due to the decrease in revenue as a result of the practical completion of one sizable project during the six months ended 30 September 2021. Such decrease, however, was partially offset by the increase in revenue generated from several sizable projects, which achieved significant progress during the six months ended 30 September 2021.

#### (ii) RMAA Works Services

The revenue generated from the RMAA works services decreased by approximately HK\$26.5 million or approximately 34.8% from approximately HK\$76.1 million during the six months ended 30 September 2020 to approximately HK\$49.6 million during the six months ended 30 September 2021. Such decrease was mainly due to the decrease in revenue generated from one sizable project reaching the completion stage during the six months ended 30 September 2021. Such decrease, however, was partially offset by the increase in revenue generated from two newly awarded sizable projects during the six months ended 30 September 2021.

### 財務回顧

#### 收益

本集團收益由截至2020年9月30日止六個月期間約643.8百萬港元減少至截至2021年9月30日止六個月期間約538.4百萬港元，減幅約105.4百萬港元或約16.4%。

#### (i) 屋宇建造服務

屋宇建造服務所產生的收益由截至2020年9月30日止六個月期間約567.7百萬港元減少至截至2021年9月30日止六個月期間約488.8百萬港元，減幅約78.9百萬港元或約13.9%。該減幅主要由於截至2021年9月30日止六個月期間一項大型項目實際竣工導致收益減少。然而，該減幅部分被截至2021年9月30日止六個月期間多項取得重大進展的大型項目所產生的收益增加所抵銷。

#### (ii) 裝修及維修工程服務

裝修及維修工程服務所產生的收益由截至2020年9月30日止六個月期間約76.1百萬港元減少至截至2021年9月30日止六個月期間約49.6百萬港元，減幅約26.5百萬港元或約34.8%。該減幅主要由於截至2021年9月30日止六個月期間一項已進入竣工階段的大型項目所產生的收益減少。然而，該減幅部分被截至2021年9月30日止六個月期間兩項新獲授的大型項目所產生的收益增加所抵銷。

### Cost of Sales

The cost of sales of the Group decreased by approximately HK\$105.3 million or approximately 17.3% from approximately HK\$609.5 million during the six months ended 30 September 2020 to approximately HK\$504.2 million during the six months ended 30 September 2021. Such decrease was mainly driven by the corresponding decrease in revenue. The Group's cost of sales primarily consisted of subcontracting costs, material costs, direct staff costs and site overhead costs.

### Gross Profit and Gross Profit Margin

The gross profit of the Group slightly decreased by approximately HK\$0.2 million or approximately 0.6% from approximately HK\$34.3 million during the six months ended 30 September 2020 to approximately HK\$34.1 million during the six months ended 30 September 2021. The Group's gross profit margin was approximately 5.3% and 6.3% during the six months ended 30 September 2020 and 2021, respectively. The gross profit margin of the Group for the six months ended 30 September 2021 increased by approximately 1.0% comparing with that for the six months ended 30 September 2020.

#### (i) Building Construction Services

The gross profit of building construction services was approximately HK\$37.2 million during the six months ended 30 September 2021, representing an increase of approximately HK\$10.0 million or approximately 36.8% from approximately HK\$27.2 million during the six months ended 30 September 2020. The gross profit margin of building construction services increased from approximately 4.8% during the six months ended 30 September 2020 to approximately 7.6% during the six months ended 30 September 2021. Such increase was primarily attributable to the increase in gross profit of several sizable projects as a result of negotiation of final accounts with subcontractors.

### 銷售成本

本集團的銷售成本由截至2020年9月30日止六個月期間約609.5百萬港元減少至截至2021年9月30日止六個月期間約504.2百萬港元，減幅約105.3百萬港元或約17.3%。該減幅乃主要由相應的收益減少所帶動。本集團的銷售成本主要包括分包成本、材料成本、直接員工成本及地盤間接開支。

### 毛利及毛利率

本集團毛利由截至2020年9月30日止六個月期間約34.3百萬港元輕微減少至截至2021年9月30日止六個月期間約34.1百萬港元，減幅約0.2百萬港元或約0.6%。截至2020年及2021年9月30日止六個月期間，本集團毛利率分別約5.3%及6.3%。與截至2020年9月30日止六個月相比，本集團截至2021年9月30日止六個月的毛利率上升約1.0%。

#### (i) 屋宇建造服務

屋宇建造服務所得毛利截至2021年9月30日止六個月期間約37.2百萬港元，較截至2020年9月30日止六個月期間約27.2百萬港元增加約10.0百萬港元或約36.8%。屋宇建造服務的毛利率由截至2020年9月30日止六個月期間約4.8%上升至截至2021年9月30日止六個月期間約7.6%。該升幅主要歸因於與分包商磋商最終賬目後數項大型項目的毛利增加。

(ii) RMAA Works Services

The gross loss of RMAA works services was approximately HK\$3.1 million during the six months ended 30 September 2021, as compared to the gross profit of approximately HK\$7.1 million during the six months ended 30 September 2020. The gross profit/(loss) margin of RMAA works services decreased from approximately 9.3% during the six months ended 30 September 2020 to approximately (6.3)% during the six months ended 30 September 2021. Such decrease was mainly attributable to the decrease in gross profit generated from one sizable project reaching the completion stage during the six months ended 30 September 2021, and the gross loss generated from the two newly awarded sizable projects due to the significant site overhead costs incurred at the initial stage during the six months ended 30 September 2021.

**Other Income and Gains**

The other income and gains of the Group decreased by approximately HK\$4.2 million or approximately 47.2% from approximately HK\$8.9 million during the six months ended 30 September 2020 to approximately HK\$4.7 million during the six months ended 30 September 2021. Such decrease was primarily due to the recognition of a non-recurring government subsidy under the Employment Support Scheme established by the Government of Hong Kong during the six months ended 30 September 2020 but no such government subsidy was recognised during the six months ended 30 September 2021, which was partially offset by the dividend income from equity investments during the six months ended 30 September 2021.

**Administrative and Other Operating Expenses, Net**

The administrative and other operating expenses, net slightly increased by approximately HK\$0.3 million or approximately 1.3% from approximately HK\$22.5 million during the six months ended 30 September 2020 to approximately HK\$22.8 million during the six months ended 30 September 2021. Such increase was mainly due to the fair value loss on financial assets at fair value through profit or loss, net, which was partially offset by the decrease in staff cost and professional fees during the six months ended 30 September 2021.

(ii) 裝修及維修工程服務

裝修及維修工程服務所得毛損截至2021年9月30日止六個月期間約3.1百萬港元，而截至2020年9月30日止六個月期間的毛利約7.1百萬港元。裝修及維修工程服務的毛利／(毛損)率由截至2020年9月30日止六個月期間約9.3%下跌至截至2021年9月30日止六個月期間約(6.3)%。該跌幅主要歸因於截至2021年9月30日止六個月期間一項已進入竣工階段的大型項目所得毛利減少；及截至2021年9月30日止六個月期間兩項新獲授的大型項目於初始階段產生重大地盤間接開支而產生毛損。

**其他收入及收益**

本集團的其他收入及收益由截至2020年9月30日止六個月期間約8.9百萬港元減少至截至2021年9月30日止六個月期間約4.7百萬港元，減幅約4.2百萬港元或約47.2%。該減幅主要由於截至2020年9月30日止六個月期間確認香港政府設立的保就業計劃項下的非經常性政府補貼所致，惟截至2021年9月30日止六個月期間並無確認有關政府補貼，部分被截至2021年9月30日止六個月期間來自股權投資的股息收入所抵銷。

**行政及其他經營開支，淨額**

行政及其他經營開支，淨額由截至2020年9月30日止六個月期間約22.5百萬港元輕微增加至截至2021年9月30日止六個月期間約22.8百萬港元，增幅約0.3百萬港元或約1.3%。該增幅主要由於按公允值計入損益的金融資產之公允值虧損，淨額，部分被截至2021年9月30日止六個月期間員工成本及專業費用減少所抵銷。

### Finance Costs

The finance costs of the Group decreased by approximately HK\$54,000 or approximately 42.2% from approximately HK\$128,000 during the six months ended 30 September 2020 to approximately HK\$74,000 during the six months ended 30 September 2021. Such decrease was mainly due to the decrease in interest expense on lease liabilities.

### Income Tax

The income tax of the Group increased by approximately HK\$0.3 million or approximately 14.3% from approximately HK\$2.1 million during the six months ended 30 September 2020 to approximately HK\$2.4 million during the six months ended 30 September 2021. The effective tax rate (defined as the income tax divided by profit before tax) was approximately 10.0% and 14.9% during the six months ended 30 September 2020 and 2021, respectively. The increase of the effective tax rate of approximately 4.9% was mainly due to the non-taxable non-recurring government subsidy recognised during the six months ended 30 September 2020 but no such government subsidy was recognised during the six months ended 30 September 2021.

### Net Profit

As a result of the foregoing, the net profit during the six months ended 30 September 2021 decreased by approximately HK\$4.9 million or approximately 26.5% from approximately HK\$18.5 million during the six months ended 30 September 2020 to approximately HK\$13.6 million during the six months ended 30 September 2021. The net profit margin during the six months ended 30 September 2020 and 2021 were approximately 2.9% and 2.5%, respectively, representing a decrease of approximately 0.4%. Such decrease was primarily attributable to the non-recurring government subsidy recognised during the six months ended 30 September 2020 but no such government subsidy was recognised during the six months ended 30 September 2021.

### 財務成本

本集團的財務成本由截至2020年9月30日止六個月期間約128,000港元減少至截至2021年9月30日止六個月期間約74,000港元，減幅約54,000港元或約42.2%。該減幅主要由於租賃負債的利息開支減少所致。

### 所得稅

本集團的所得稅由截至2020年9月30日止六個月期間約2.1百萬港元增加至截至2021年9月30日止六個月期間約2.4百萬港元，增幅約0.3百萬港元或約14.3%。截至2020年及2021年9月30日止六個月期間，實際稅率(定義為所得稅除以除稅前溢利)分別約10.0%及14.9%。實際稅率上升約4.9%主要由於截至2020年9月30日止六個月期間確認非課稅非經常性政府補貼，惟截至2021年9月30日止六個月期間並無確認有關政府補貼。

### 純利

由於上文所述原因，截至2021年9月30日止六個月期間之純利由截至2020年9月30日止六個月期間約18.5百萬港元減少至截至2021年9月30日止六個月期間約13.6百萬港元，減幅約4.9百萬港元或約26.5%。截至2020年及2021年9月30日止六個月期間，純利率分別約2.9%及2.5%，減幅約0.4%。該減幅主要歸因於截至2020年9月30日止六個月期間確認非經常性政府補貼，惟截至2021年9月30日止六個月期間並無確認有關政府補貼所致。

## EMPLOYEES AND REMUNERATION POLICIES

As at 30 September 2021, the Group has a total of 223 full-time and one part-time employees (as at 30 September 2020: 204 full-time and one part-time employees). The Group has developed its human resources policies and procedures to determine the individual remuneration with reference to factors such as performance, qualification, merits, responsibilities of each individual and market conditions. Remuneration packages are normally reviewed on a regular basis. Apart from salary payments, other staff benefits include provident fund contributions, medical insurance coverage, annual leave and share options and share awards which may be granted to eligible employees. The total staff costs (excluding Directors' remuneration) incurred by the Group during the six months ended 30 September 2021 and 2020 was approximately HK\$42.8 million and HK\$42.2 million, respectively.

## SIGNIFICANT INVESTMENTS, MATERIAL ACQUISITIONS AND DISPOSAL OF SUBSIDIARIES AND ASSOCIATED COMPANIES

During the six months ended 30 September 2021, other than the shareholding in the subsidiaries of the Company, there were no significant investments held by the Company. There were no material acquisitions or disposals of subsidiaries and associated companies by the Group during the six months ended 30 September 2021.

## CAPITAL COMMITMENTS

As at 30 September 2021, the Group did not have any significant capital commitments (as at 31 March 2021: nil).

## CONTINGENT LIABILITIES

Save as disclosed in note 13 to the interim condensed consolidated financial information, the Group had no other material contingent liabilities as at 30 September 2021.

## 僱員及薪酬政策

於2021年9月30日，本集團共有223名全職及1名兼職僱員(於2020年9月30日：204名全職及1名兼職僱員)。本集團已制定人力資源政策及程序，以參考各人的表現、資歷、優點、責任及市況等因素釐定個別薪酬。薪酬待遇通常會定期檢討。除薪金外，其他員工福利包括公積金供款、醫療保險、年假及可能授予合資格僱員的購股權及股份獎勵。截至2021年及2020年9月30日止六個月期間，本集團產生的總員工成本(不包括董事酬金)分別約42.8百萬港元及42.2百萬港元。

## MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論及分析

### FOREIGN EXCHANGE EXPOSURE

The Group has a minimal exposure to foreign currency risk as most of its business transactions and assets and liabilities are principally denominated in Hong Kong dollar. As such, the Directors believe that the Group's risk in foreign exchange is insignificant, such that the Group is not necessary to arrange any foreign currency hedging policy and the Group has not entered into any instrument for hedging purpose during the six months ended 30 September 2021.

### GEARING RATIO

As at 30 September 2021, the gearing ratio of the Group (defined as the lease liabilities divided by total equity) was approximately 1.0% (as at 31 March 2021: approximately 1.7%).

### LIQUIDITY AND FINANCIAL RESOURCES AND CAPITAL STRUCTURE

The Group has principally funded the liquidity and capital requirements through capital contributions from the shareholders, bank borrowings and net cash generated from operating activities.

As at 30 September 2021, the Group had pledged deposits, time deposits and cash and bank balances of approximately HK\$93.1 million (as at 31 March 2021: approximately HK\$167.9 million). The gearing ratio of the Group as at 30 September 2021 (defined as the lease liabilities divided by total equity) was approximately 1.0% (as at 31 March 2021: approximately 1.7%). As at 30 September 2021, the current ratio of the Group was approximately 2.0 times (as at 31 March 2021: approximately 2.2 times).

### 外匯風險

由於大部分業務交易及資產及負債主要以港元計值，故本集團面對的外匯風險極低。因此，董事認為本集團的外匯風險微不足道，所以本集團無須安排任何外幣對沖政策，而本集團截至2021年9月30日止六個月期間並未為對沖訂立任何文書。

### 資本負債比率

於2021年9月30日，本集團資本負債比率(定義為租賃負債除以總權益)約1.0% (於2021年3月31日：約1.7%)。

### 流動資金及財政資源及資本結構

本集團主要通過股東出資、銀行借款及經營活動所得現金淨額為流動資金及資本要求提供資金。

於2021年9月30日，本集團抵押存款、定期存款以及現金及銀行結餘約93.1百萬港元(於2021年3月31日：約167.9百萬港元)。於2021年9月30日，本集團資本負債比率(定義為租賃負債除以總權益)約1.0% (於2021年3月31日：約1.7%)。於2021年9月30日，本集團流動比率約2.0倍(於2021年3月31日：約2.2倍)。

The Group generally finances its operation by internally generated resources and banking facilities provided by certain banks in Hong Kong. The Directors believe that the Group has sufficient working capital for the Group's current commitments and future requirements.

During the six months ended 30 September 2021, there has been no change in the capital structure of the Company.

### DEBTS AND CHARGE ON ASSETS

As at 30 September 2021, the Group has no outstanding bank borrowings (as at 31 March 2021: nil). The lease liabilities of the Group amounted to approximately HK\$2.9 million as at 30 September 2021 (as at 31 March 2021: approximately HK\$4.7 million).

As at 30 September 2021, the banking facilities of the Group were secured by (i) the Group's pledged deposits of approximately HK\$45.6 million (as at 31 March 2021: approximately HK\$42.2 million); and (ii) corporate guarantee executed by the Group.

The Group's borrowings were denominated in Hong Kong dollar and interests on borrowings were mainly charged at floating rate. The Group currently does not have any interest rate hedging policy. Although the Group had no outstanding bank borrowings as at 30 September 2021, the Group pays vigilant attention to and monitors interest rate risks continuously and cautiously.

本集團一般以內部產生之資源及若干香港銀行提供之銀行融資為其營運提供資金。董事認為本集團有足夠營運資金以應付本集團現時承擔及未來需求。

截至2021年9月30日止六個月期間，本公司資本結構並無變動。

### 債務及資產抵押

於2021年9月30日，本集團並無未償還之銀行借款(於2021年3月31日：無)。於2021年9月30日，本集團租賃負債約2.9百萬港元(於2021年3月31日：約4.7百萬港元)。

於2021年9月30日，本集團銀行融資由(i)本集團抵押存款約45.6百萬港元(於2021年3月31日：約42.2百萬港元)；及(ii)本集團履行的公司擔保抵押。

本集團的借款以港元計值，借款利息主要按浮動利率計息。本集團目前並無任何利率對沖政策。儘管本集團於2021年9月30日並無未償還之銀行借款，惟本集團持續及謹慎地警惕關注及監察利率風險。

#### USE OF PROCEEDS

The shares of the Company (the "Share(s)") were successfully listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 27 February 2019 (the "Listing Date"). The net proceeds from the share offer (the "Net Proceeds"), after deducting related underwriting commission and listing expenses, of approximately HK\$93.5 million were and will be utilised in accordance with the section headed "Future Plans and Use of Proceeds" in the Prospectus.

The particulars of the Net Proceeds utilised during the six months ended 30 September 2021 are as follows:

As at 30 September 2021, the Group has not yet fully utilised the Net Proceeds allocated for strengthening manpower, upgrading and renovating office and developing engineering and technological innovation. The delay in utilisation of the Net Proceeds in the abovementioned areas were due to (i) the difficulty in recruiting suitable candidates for the positions which were created as planned; and (ii) the delay in development of the Group's technological innovation. The Group plans to utilise the remaining balance of the Net Proceeds allocated to the abovementioned areas during the coming six months ending 31 March 2022.

The Group will continue to apply the Net Proceeds in accordance with the disclosure in the section headed "Future Plans and Use of Proceeds" in the Prospectus.

### CORPORATE GOVERNANCE PRACTICES

The Company is committed to achieving and maintaining the highest standard of corporate governance as the Board recognises the importance of sound corporate governance to the long term and continuing success of the Group. The corporate governance principles of the Group emphasise transparency, accountability and independence. The Board commits to continuously reviewing and enhancing the Group's corporate governance practices and procedures for the best interest of the Company's shareholders.

During the six months ended 30 September 2021 and up to the date of this interim report, the Company has complied with the applicable code provisions as set out in the Corporate Governance Code ("CG Code") in Appendix 14 to the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules") except the deviation mentioned in the paragraph below headed "Chairman and Chief Executive".

### CHAIRMAN AND CHIEF EXECUTIVE

Code Provision A.2.1 of the CG Code stipulates that the roles of chairman (the "Chairman") and chief executive officer (the "CEO") should be separated and should not be performed by the same individual. Since the Listing Date and up to the date of this interim report, Mr. Tsang Ka Yip ("Mr. KY Tsang") has been the Chairman of the Board and the CEO of the Company. Given the nature and extent of the Group's operations and Mr. KY Tsang's in-depth knowledge and experience in the industry in which the Group operates and his familiarity with the operations of the Group, the Board believes that it is the most beneficial to the Group and the shareholders as a whole to have Mr. KY Tsang acting as the Chairman of the Board and CEO of the Company at the same time.

### 企業管治常規

本公司致力實現並維持最高標準的企業管治，因董事會深明穩健的企業管治對本集團取得長遠及持續的成功至關重要。本集團的企業管治以強調透明度、問責性及獨立性為原則。董事會承諾持續檢討並加強本集團的企業管治常規及程序，以符合本公司股東的最佳利益。

截至2021年9月30日止六個月及直至本中期報告日期，本公司已遵守聯交所證券上市規則(「上市規則」)附錄14企業管治守則(「企業管治守則」)所載之適用守則條文，惟下文「主席及行政總裁」一段所述偏離者除外。

### 主席及行政總裁

企業管治守則守則條文第A.2.1條規定主席(「主席」)與行政總裁(「行政總裁」)的角色應有區分，並不應由一人同時兼任。自上市日期起及直至本中期報告日期，曾家葉先生(「曾家葉先生」)為董事會主席兼本公司行政總裁。鑑於本集團的營運性質及規模以及曾家葉先生對本集團營運所在的行業有深入認識及經驗，加上彼熟悉本集團營運，董事會認為，曾家葉先生同時擔任董事會主席兼本公司行政總裁對本集團及股東整體而言乃最為有利。

The Board has resolved not to declare any interim dividend to the shareholders of the Company for the six months ended 30 September 2021 (six months ended 30 September 2020: nil).

## SHARE OPTIONS SCHEME

The Company has adopted a share option scheme (the "Share Option Scheme") on 21 January 2019. No share option has been granted, exercised, expired, cancelled or lapsed under the Share Option Scheme since its adoption date and up to the date of this interim report.

The Board adopted a share award plan (the "Share Award Plan") on 31 July 2020 (the "Adoption Date"), under which any employee of the Group and its invested entities who contributes to the Group or its invested entities (the "Eligible Participants") will be entitled to participate. The purposes of the Share Award Plan are:

- i. to recognise and reward the contribution of the Eligible Participants to the growth and development of the Group;
- ii. to give incentives to the Eligible Participants in order to retain them for the continual operation and development of the Group; and
- iii. to attract suitable personnel for further development of the Group.

The Group has set up a trust (the "Share Award Plan Trust") for the purpose of administrating the Share Award Plan. The Share Award Plan Trust will acquire the Shares from the Stock Exchange, with a maximum amount of funds allocated by the Board, and will hold such Shares until they are vested. Unless early terminated by the Board, the Share Award Plan shall be valid and effective for a period of 10 years commencing from the Adoption Date.

The Board may from time to time, at its discretion, determine the vesting date(s), any condition(s) or performance target(s) when granting the share award to the Eligible Participants.

On 23 December 2020, the Company allocated HK\$1,000,000 to the Share Award Plan Trust, and approximately HK\$996,000 was utilised to purchase 5,304,000 Shares. Up to the date of this interim report, these 5,304,000 Shares are held by the trustee for the benefit of the Eligible Participants under the Share Awards Plan Trust. No share award has been granted or vested under the Share Award Plan since its Adoption Date and up to 30 September 2021.

### 1. CORPORATE AND GROUP INFORMATION

The Company is an exempted company incorporated in the Cayman Islands with limited liability on 23 March 2018. The registered address of the Company is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands. The principal place of business of the Company in Hong Kong is located at Room 1801-1802, 18/F., Tung Hip Commercial Building, 244-252 Des Voeux Road Central, Hong Kong.

The Company is an investment holding company. During the period, the Group's subsidiaries were principally engaged in the provision of building construction and repair, maintenance, alteration and addition ("RMAA") services.

In the opinion of the directors, the immediate holding company and the ultimate holding company of the Company is Triple Arch Limited, which is incorporated in the British Virgin Islands (the "BVI").

#### 2.1. BASIS OF PREPARATION

The interim condensed consolidated financial information for the six months ended 30 September 2021 has been prepared in accordance with Hong Kong Accounting Standards ("HKAS") 34 *Interim Financial Reporting* issued by the Hong Kong Institute of Certified Public Accountants and the applicable disclosure requirements of Appendix 16 to the Rules Governing the Listing of Securities (the "Listing Rules") on the Stock Exchange. The interim condensed consolidated financial information does not include all the information and disclosures required in the annual financial statements, and should be read in conjunction with the Group's annual consolidated financial statements for the year ended 31 March 2021.

#### 1. 公司及本集團資料

於2018年3月23日，本公司於開曼群島註冊成立為獲豁免有限公司。本公司的註冊地址為Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands。本公司於香港的主要營業地點位於香港德輔道中244-252號東協商業大廈18樓1801-1802室。

本公司為投資控股公司。期內，本集團附屬公司主要從事提供屋宇建造及維修、保養、改建及加建(「裝修及維修工程」)服務。

董事認為，本公司的直接控股公司及最終控股公司為Triple Arch Limited，該公司於英屬處女群島(「英屬處女群島」)註冊成立。

#### 2.1. 編製基準

### Basis of consolidation

The interim condensed consolidated financial information includes the financial statements of the Group for the six months ended 30 September 2021. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases. Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

## 7. INCOME TAX

Pursuant to the rules and regulations of the Cayman Islands and the BVI, the Group is not subject to any income tax in the Cayman Islands and the BVI. Hong Kong profits tax has been provided at the rate of 16.5% (2020: 16.5%) on the estimated assessable profits arising in Hong Kong during the period, except for one subsidiary of the Group which is a qualifying entity under the two-tiered profits tax rates regime effective from the year of assessment 2018/2019. The first HK\$2,000,000 (2020: HK\$2,000,000) of estimated assessable profits of this subsidiary is taxed at 8.25% and the remaining estimated assessable profits are taxed at 16.5%.

- (b) Retention receivables are part of the consideration that the customers retain which are payable on successful completion of the contracts in order to provide the customers with assurance that the Group will complete its obligation satisfactorily under the contracts, rather than to provide financing to the customers. As at 1 April 2020, 31 March 2021 and 30 September 2021, the Group's retention receivables were HK\$69,834,000, HK\$90,462,000 and HK\$101,640,000, respectively. At 30 September 2021, retention receivables are repayable within terms ranging from one to two years. Included in retention receivables, HK\$11,953,000 (31 March 2021: HK\$41,165,000) were expected to be recovered after more than one year. Retention receivables, amounting to HK\$89,687,000 (31 March 2021: HK\$49,297,000), are expected to be recovered within twelve months. Retention receivables increased as at 30 September 2021 and 31 March 2021 due to more contracts achieved significant progress during the reporting period but not yet completed at the end of reporting periods.
- (c) Trade receivables represented receivables for contract work. Management generally submits interim payment applications to customers on a monthly basis containing a statement setting out the management's estimation of the valuation of the works completed in the preceding month. Upon receiving the interim payment application, the architect or the consultant of the customer will verify such valuation of works completed and issue an interim payment certificate within 30 days. Within 30 days after the issuance of the interim payment certificate, the customer will make payment to the Group based on the certified amount stipulated in such certificate, deducting any retention money in accordance with the contract.


