### **FURTHER EXTENSION OF LONG STOP DATE FOR THE COMPLETION OF THE VERY SUBSTANTIAL ACQUISITION AND CONNECTED TRANSACTION IN RELATION TO THE ACQUISITION OF THE TARGET COMPANY**

Reference is made to (1) the announcement (the “**Announcement**”) of China Tangshang Holdings Limited (the “**Company**”) dated 30 July 2021, (2) the circular (the “**Circular**”) of the Company dated 30 September 2021, (3) the poll results announcement of the Company dated 20 October 2021, (4) the announcement on the extension of long stop date of the Company dated 29 October 2021 and (5) the announcement on the further extension of long stop date of the Company dated 31 December 2021, each in relation to the Acquisition. Capitalised terms used in this announcement shall have the same meanings as defined in the Circular and the Announcement unless the context requires otherwise.

As disclosed on 31 December 2021, the Company and Shenzhen Yaoling agreed in writing to extend the Long Stop Date from 31 December 2021 to 31 January 2022 (or such other date as the parties may agree in writing).

As additional time is required for the fulfillment of the conditions precedent to the Equity Sale and Purchase Agreement, on 31 January 2022, the Company and Shenzhen Yaoling agreed in writing to further extend the Long Stop Date from 31 January 2022 to 31 March 2022 (or such other date as the parties may agree in writing).

Save for the aforesaid extension of the Long Stop Date, the other terms and conditions of the Equity Sale and Purchase Agreement remain unchanged and continue in full force and effect. Further announcement will be made by the Company upon Completion.
