## UNLISTED PERPETUAL CONVERTIBLE SECURITIES PAYMENT OF ELEVENTH DISTRIBUTION

Reference is made to the prospectus issued by the Company dated 29 September 2016 (the “**Prospectus**”) in relation to the Open Offer of Offered Shares with an alternative of unlisted Perpetual Convertible Securities on the basis of one Offered Share for every five Ordinary Shares held on 28 September 2016. Capitalised terms herein shall have the same meanings as those defined in the Prospectus unless otherwise stated.

The Company announces that, in accordance with the terms and conditions of the Perpetual Convertible Securities (the “**Terms and Conditions**”), the eleventh distribution (the “**Eleventh Distribution**”) at the distribution rate of 6% per annum on the Perpetual Convertible Securities will be made to the Convertible Securities Holders on 24 April 2022 (the “**Distribution Payment Date**”).
