

#### CHAIRMAN'S 主席報告 **STATEMENT**

On behalf of the board (the "Board") of directors (the "Directors") of Glory Flame Holdings (the "Company"), I am honoured to present this annual report of the consolidated results of the Company and its subsidiaries (collectively, the "Group") for the financial year ended 31 December 2021 ("FY2021" or the "Reporting Period").

#### **PERFORMANCE**

The Group posted a revenue of approximately HK\$99.0 million for FY2021, representing an increase by 22.4% as compared to approximately HK\$80.9 million for the year ended 31 December 2020 ("**FY2020**").

The Group's revenue attributable to concrete demolition services decreased by 3.1% from approximately HK\$57.9 million for FY2020 to approximately HK\$56.1 million for FY2021. The Group's revenue attributable to prefabricated construction increased by 86.9% from approximately HK\$22.9 million for FY2020 to approximately HK\$42.8 million for FY2021.

The Group recorded a net loss of approximately HK\$37.2 million for FY2021, representing an increase by 129.6% as compared to a net loss of approximately HK\$16.2 million for FY2020. Basic loss per share for FY2021 was HK3.65 cents, as compared to HK1.51 cents for FY2020.

#### **BUSINESS REVIEW AND PROSPECT**

Given that the Covid-19 epidemic in various countries over the world is still fluctuating, Hong Kong had succeeded in keep Covid-19 virus under control for much of 2021. It showed the Hong Kong economy was on the path to recovery. Entering the third year of Covid-19 pandemic, the Company has come to terms with the disruption of the supply chain and manpower resources. The Group's concrete demolition services business in Hong Kong was relatively stable, in line with the Company's expectation when considering the lingering impact of the pandemic. However, after a few months when Hong Kong's pandemic situation seemed like relatively stable, a spike in infections driven by a combination of the Omicron and Delta variants of Covid-19 has led to reinstate the draconian quarantine and social-distancing measures. The Company anticipates it will face a lot of challenge from the threats and uncertainty of the outbreak of the Omicron variant or more mutations in forthcoming years.

#### 業績

本集團於財政年度二一年錄得收入約 99,000,000港元,較截至二零二零年十二月 三十一日止年度(「財政年度二零年」)之約 80.900.000港元增加22.4%。

本集團之混凝土拆卸服務所佔之收益由財政 年度二零年約57.900.000港元減少3.1%至 財政年度二一年約56,100,000港元。本集團 之裝配式建築所佔之收益由財政年度二零年 約22,900,000港元增加86.9%至財政年度 二一年約42,800,000港元。

本集團於財政年度二一年錄得淨虧損約 37,200,000港元,較財政年度二零年之淨虧 損約16,200,000港元增加129.6%。於財政 年度二一年之每股基本虧損為3.65港仙, 而財政年度二零年則為1.51港仙。

#### 業務回顧及前景

考慮到全球多個國家的新冠病毒疫情持續反 覆,香港於二零二一年的大部分時間裡已相 對地成功控制了新冠病毒。這顯示香港經濟 步入復甦階段。進入新冠病毒疫情的第三個 年度,本公司已適應供應鏈及人力資源方面 出現的干擾。在考慮到疫情持續的影響之 下,本集團於香港的混凝土拆卸服務業務相 對穩定,這與本公司的預期相符。然而,在 香港疫情似乎相對穩定的幾個月之後,由 Omicron 及 Delta 變種新冠病毒合併所引致的 感染數字激增,導致政府恢復嚴厲的隔離及 社交距離措施。本公司預料其於未來數年將 面對許多來自爆發Omicron變種病毒或更多 病毒突變的威脅及不確定性的挑戰。

The Group's prefabricated construction business in China continued to make a stride to grow on the back of increasing urbanization and growing focus on developing green buildings in China. Revenue attributable to the Group's prefabricated construction grew by 86.9% for FY2021. However, such increase was in large part due to the very low comparison base resulting from adopting lockdown measures to control the spread of Covid-19 in China in the year 2020. China is facing downward pressures on the economy and the complexity and uncertainty of the external environment. Property developers in China have obviously shown less motivation in land purchases in the wake of the debt crisis at a few large property developers. China has initiated a deleverage campaign to avoid excessive domestic credit expansion for the property developers. The expectation of a downward trend in property market seems to be formed. The Company has to maintain a high alert on any unpredictable development and event that could adversely affect the Group's business.

The Group devotes to promote the green building. Prefabricated construction is not only green but also be more efficient and even higher quality. The Company has plans to develop and tap the prefabricated construction business into overseas market, particularly for the countries along the Belt and Road and the Group has paired up with a reputable construction company as a long term cooperative partner. The cooperative partner has an extensive experience and business connection to those targeted overseas market. The Group believes that the market diversification may usher in a strong growth potential of the Group. Unfortunately, most of these countries are still in the grip of Covid-19 pandemic. The vaccination rate of some Africa countries remains low due to the inequity in supply of vaccines. This has been the third year of the Covid-19 pandemic with no end in sight. Prolonged pandemic has fueled concerns of making investment in these countries. In addition, the Company also felt more difficult to source the fund for the project than previous years due to the liquidity tight for many corporations. The Company intends to postpone the expansion plan at this moment and keep the close watch on the development of the situation.

本集團致力推廣綠色建築。裝配式建築不但 環保,而且更具效率及質量更高。本公司計 劃發展裝配式建築業務及將該業務擴展至海 外市場,尤其是至一帶一路沿線國家,且本 集團已與一家知名建築公司結為長期合作夥 伴。該合作夥伴具備豐富經驗,且與該等目 標海外市場有業務聯繫。本集團相信,市場 多元化可帶動本集團的強大增長潛力。不幸 的是,該等國家中的大多數仍在遭受新冠病 毒疫情的困擾。由於疫苗供應出現不公平現 象,部分非洲國家的疫苗接種率仍然較低。 這已是新冠病毒疫情的第三個年度,惟仍無 了期。延長的疫情加深了對該等國家作出投 資的憂慮。此外,由於許多公司的流動資金 緊張,本公司亦發現在為項目尋找資金方面 較過往年度困難。因此,本公司在現階段計 劃延遲擴展計劃並且密切留意情況的發展。

#### MANAGEMENT DISCUSSION AND ANALYSIS

#### **BUSINESS REVIEW**

The principal activity of the Company is investment holding. For the year ended 31 December 2021 (the "Reporting Period"), the Group mainly engages in provision of concrete demolition services and manufacturing and trading of prefabricated construction components.

#### **Concrete Demolition Services**

Concrete demolition is one aspect of the construction industry in Hong Kong. The Group's concrete demolition services were mainly concerned with the removal of pieces or section of concrete from concrete structures by applying a variety of methods, such as core drilling, sawing, bursting and crushing. Concrete demolition services are usually performed by subcontractors in (i) general building works, especially for alteration and redevelopment projects; and (ii) civil engineering works. Concrete demolition work can be applied in various situations, such as the construction of underground utilities, creation of openings for elevator, door, and window installation, redevelopment of buildings, roads, tunnels and underground facilities, removal of concrete during building construction and the preparation of road surfaces.

The customers of the Group's concrete demolition services mainly include main contractors and subcontractors of different types of construction and civil engineering projects in Hong Kong. Such customers can generally be categorized into public sector projects' customers and private sector projects' customers. Public sector projects refer to projects of which the main contractors are employed by Government departments or statutory bodies in Hong Kong, while private sector projects refer to projects that are not public sector projects.

#### 業務回顧

本公司的主要活動為投資控股。截至二零二一年十二月三十一日止年度(「**報告期**」),本集團主要從事提供混凝土拆卸服務以及裝配式預製建築組件製造及貿易。

#### 混凝土拆卸服務

混凝土拆卸行業為香港建築行業特定領域之一。本集團的混凝土拆卸服務主要涉及透過採用各種方法,例如鑽取土芯、鋸切、逼裂及鉗碎等,移除混凝土結構的混凝土塊或組件。混凝土拆卸服務通常為分包商於(i)一般建築工程,特別是改建及重建工程;及(ii)土木工程所進行運作。混凝土拆卸工程可用於地下公共設施建設、電梯開口、門窗安裝、地下公共設施建設、電梯開口、門窗安裝施工過程中混凝土拆除及路面製備。

本集團的混凝土拆卸服務的客戶主要為香港 各類建築及土木工程項目的總承建商及分包 商。相關客戶一般可分類為公營及私營界別 項目客戶。公營界別項目指由香港政府部門 或法定機構聘請總承建商的項目,而私營界 別項目指非公營界別項目。

#### **Prefabricated Construction**

Prefabricated construction is a new kind of architecture with the construction process that is splitting the traditional building products into precast reinforced concrete member produced in the factory and transported to the construction site for assembling into a whole building. Precast concrete contributes to green building practices as it can be very durable and energy efficient. Prefabricated Construction also reduces construction waste and debris on construction site as the precast concrete components are factory-made and employed by exact-batching technologies.

Prefabricated Constructions are becoming more popular in many developing countries, due to compressed project timelines, more affordable pricing, greener construction technology and the ability to service remote locations. Growth in urbanization and industrialization drive the demand in affordable urban housing that was built in a shorter construction time. The Group established its own production facilities and construction project team in Huizhou, the PRC for production, research and development of precast concrete components and glass fiber reinforced cement components, product installation guidance and sales which mainly serviced the construction projects in Greater Bay area of China. The Group was also looking at this opportunity to develop the overseas market, particularly the countries along the Belt and Road for prefabricated construction business. The Group has currently paired up with a reputable construction company as a long term cooperative partner in an attempt to penetrate the oversea market.

#### 裝配式建築

裝配式建築是將傳統建築產品分拆成於工廠 生產的預製鋼筋混凝土部件並運輸至施工現 場組裝成完整建築的一種新型建築形式。預 製混凝土非常耐用及節能,有助於綠色建築 實踐。由於預製混凝土部件乃於工廠生產並 採用精確的配料技術,裝配式建築亦減少施 工現場的建築垃圾及瓦礫。

#### **FINANCIAL REVIEW**

#### Revenue

Revenue increased by approximately HK\$18.1 million or 22.4% from approximately HK\$80.9 million for the year ended 31 December 2020 ("**FY2020**") to approximately HK\$99.0 million for the Reporting Period.

The analysis of revenue was shown as follows:

#### 財務回顧

#### Concrete demolition services

For the Reporting Period, revenue attributable to concrete demolition services was approximately HK\$56.1 million, representing a decrease of approximately HK\$1.8 million or 3.1% as compared with approximately HK\$57.9 million for FY2020. The decrease was primarily due to the delays and disruption to the regular progress of the works on construction projects in Hong Kong, affected by Covid-19 pandemic.

#### Prefabricated construction

For the Reporting Period, revenue attributable to prefabricated construction was approximately HK\$42.8 million, representing an increase of approximately HK\$19.9 million or 86.9% as compared with approximately HK\$22.9 million for FY2020. The increase was in large part due to the low comparison base resulting from imposing a lockdown measures to control the spread of Covid-19 in China during the first quarter in last year and certain traveling restriction measures that led to the general disruption of production, supply chain and logistics.

#### 混凝土拆卸服務

於報告期內,混凝土拆卸服務所佔之收益 為約56,100,000港元,較財政年度二零年 約57,900,000港元減少約1,800,000港元或 3.1%。該減少主要是由於香港建築項目工程 之常規進度因新冠病毒疫情影響而延遲及受 到干擾所致。

#### 裝配式建築

於報告期內,裝配式建築所佔之收益為約42,800,000港元,較財政年度二零年約22,900,000港元增加約19,900,000港元或86.9%。該增加主要是由於中國於去年第一季度施行封城措施以控制新冠病毒傳播,導致比較基數極低,以及若干旅遊限制措施導致生產、供應鏈及物流全面中斷所致。



MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論及分析

#### **Gross Profit and Gross Profit Margin**

Gross profit increased by approximately HK\$1.3 million or 5.6% from approximately HK\$23.3 million for FY2020 to approximately HK\$24.6 million for the Reporting Period.

Gross profit margin decreased from 28.9% for FY2020 to 24.9% for the Reporting Period. The decrease was primarily due to a decrease by 3.7 percentage points in gross profit margin attributable to concrete demolition services from 29.8% for FY2020 to 26.1% for the Reporting Period.

#### **Impairment Loss on Various Assets**

Impairment loss on various assets increased by HK\$21.2 million from approximately HK\$0.7 million for FY2020 to approximately HK\$21.9 million for the Reporting Period. Such increase was primarily due to an impairment loss of HK\$21.3 million on other receivables provided for the Reporting Period.

The provision for impairment was made primarily due to concerns over the recoverability of a payment of HK\$29.5 million made in connection with prefabricated construction projects led by a supplier who was one of the Group's cooperative partners in the prefabricated construction business. During the Reporting Period, while the Group was able to recover HK\$8.2 million from the cooperative partner, the Group made assessment on the market conditions of the markets in which the cooperative partner operates including the PRC, certain belt and road countries and Australia, and noted that, due to the downturn in these markets caused by the Covid-19 pandemic and other unforeseen natural disasters and events, the recoverability of the remaining HK\$21.3 million was low.

#### 毛利及毛利率

毛利由財政年度二零年的23,300,000港元增加約1,300,000港元或5.6%至報告期的約24,600,000港元。

毛利率由財政年度二零年的28.9%減至報告期內的24.9%。減少主要由於混凝土拆卸服務所佔之毛利率由財政年度二零年的29.8%下降3.7百分點至報告期的26.1%所致。

#### 各項資產之減值虧損

各項資產之減值虧損由財政年度二零年的約700,000港元增加21,200,000港元至報告期的約21,900,000港元。該增加主要由於報告期內已就其他應收款項計提減值虧損21,300,000港元所致。

計提減值撥備主要乃由於擔心是否可收回供應商(為本集團裝配式建築業務的合作夥伴之一)所牽頭裝配式建築項目而作出的29,500,000港元付款。於報告期內,儘管本集團能夠向合作夥伴收回8,200,000港元,但本集團評估了合作夥伴經營所在市場的海場狀況,包括中國、部分一帶一路國家及澳洲,並注意到,由於新冠病毒疫情及其他不可預見的自然災害事件導致該等市場低迷,因此,餘下21,300,000港元的可收回程度較低。

#### **Administrative and Other Operating Expenses**

Administrative and other operating expenses decreased by approximately HK\$2.6 million from approximately HK\$38.9 million for FY2020 to approximately HK\$36.3 million for the Reporting Period. Such decrease was primarily due to a combined effect of (i) a decrease of approximately HK\$3.4 million in deprecation on property, plant and equipment and amortization to right-ofuse assets; (ii) an increase of approximately HK\$1.7 million in transportation cost and (iii) a decrease of approximately HK\$0.7 million in consultancy fee.

#### Loss Attributable to Owners of the Company

After a result of the foregoing, the Group's loss attributable to owners of the Company was approximately HK\$36.8 million for the Reporting Period, representing an increase of approximately HK\$21.5 million as compared to a loss of HK\$15.3 million attributable to owners of the Company for FY2020.

#### **Liquidity, Financial Resources and Capital Structure**

As at 31 December 2021, the Group had cash and bank deposits of approximately HK\$37.1 million (2020: approximately HK\$37.3 million).

The gearing ratio of the Group as at 31 December 2021 (defined as total borrowings including interest bearing and non-interest bearing, divided by the Group's total equity) was approximately 18.9 (2020: approximately 1.61).

#### 行政及其他營運開支

行政及其他營運開支由財政年度二零年的約 38,900,000港元減少約2,600,000港元至報 告期的約36,300,000港元。該減少主要因 為物業、廠房及設備折舊及使用權資產攤銷 減少約3.400.000港元;(ii)運輸成本增加約 1.700.000港元;及(iii)諮詢費減少約700.000 港元的合併效應。



MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論及分析

#### **Treasury Policy**

The Group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy liquidity position throughout the Reporting Period. The Group strives to reduce exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and other commitments can meet its funding requirements from time to time.

#### Foreign Exchange Risk

The Group principally operates its businesses in Hong Kong and the PRC. The Group is exposed to foreign exchange fluctuations from various currencies, such as United States dollars and Chinese Renminbi. Since Hong Kong dollars remains pegged to the United States dollars within a defined range, the Group is not exposed to any significant foreign exchange risk against the United States dollars. The Group has certain subsidiaries operating in mainland China, in which most of their transactions, including revenue, expenses and other financing activities, are denominated in Chinese Renminbi. The Group is not exposed to any significant foreign exchange transaction risk in relation to these currencies and had not entered into any foreign exchange contract as hedging measures against these currencies.

#### Significant Investment Held

As at 31 December 2021 and 2020, there were no material investment held by the Group.

#### **Debts and Charge on Assets**

As at 31 December 2021, the total borrowings of the Group, including unsecured fixed bonds and other loan, amounted to approximately HK\$64.3 million (2020: approximately HK\$64.3 million). The annual interest rates of the borrowings during the Reporting Period ranged from 6.75% to 12.0% per annum (2020: 6.75% to 12.0% per annum). All of the borrowings are unsecured and denominated in Hong Kong dollars. The borrowings of HK\$45.8 million were repayable within one year which was accounted for as current liabilities of the Group and the borrowings of HK\$18.5 million were repayable over one year which was accounted for as non-current liabilities.

#### 庫務政策

#### **Employee and Remuneration Policies**

As at 31 December 2021, the Group employed 124 staff (2020: 116 staff). Total employee costs for the Reporting Period including directors' emoluments, amounted to approximately HK\$41.2 million (2020: approximately HK\$37.0 million).

The salary and benefit levels of the employees of the Group are competitive. This is very important as the construction industry has been experiencing labour shortage in general. Individual performance of our employees is rewarded through the Group's salary and bonus system. In addition, the Group provides adequate job training to employees in order to equip them with practical knowledge and skills to tackle situations and challenges encountered in diverse work sites.

#### **Final Dividend**

The Board does not recommend payment of final dividend to Shareholders for the Reporting Period (2020: Nil).

Dividends may be paid only out of distributable profits as permitted under the relevant laws. There can be no assurance that the Company will be able to declare or distribute any dividend in the amount set out in any of the plans or at all. The Company's dividend distribution record in the past may not be used as a reference or basis to determine the level of dividends that may be declared or paid by the Company in the future.

The risk management framework, coupled with our internal controls, ensures that the risk associated with our different business units are effectively controlled in line with the Group's appetite.

The Company does not have an internal audit department and engaged an independent internal control consultant, Premier Advisory Services Limited, to conduct review on the internal control system of the Group during the Reporting Period. The review covering certain procedures and implementation of risk management policies of the Group and make recommendations for improvement and strengthening of internal control system. No significant areas of concern that may affect the financial, operational, compliance, controls and risk management of the Group have been identified.

The Group's risk management and internal control system are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. The Board has the overall responsibility to maintain the adequacy of resources, staff qualifications and experience training programs and budget of accounting and financial reporting function as well as those relating to our ESG performance and reporting the Board has reached the conclusion that the Group's risk management and internal control system was in place and effective.


#### 股東大會

# Convening Extraordinary General Meeting on Requisition by Shareholders

Pursuant to article 64 of the Articles, the Board may, whenever it thinks fit, convene an extraordinary general meeting ("EGM"). EGMs shall also be convened on the requisition of one or more Shareholders holding, at the date of deposit of the requisition, not less than one tenth of the paid up capital of the Company having the right of voting at general meetings. Such requisition shall be made in writing to the Board or the company secretary of the Company for the purpose of requiring an EGM to be called by the Board for the transaction of any business specified in such requisition. Such meeting shall be held within 2 months after the deposit of such requisition. If, within 21 days of such deposit, the Board fails to proceed to convene such meeting, all reasonable expenses incurred by the acquisition(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

# **Procedures for Shareholders' Nomination of Directors**

Pursuant to article 113 of the Articles, no person, other than a retiring Director, shall, unless recommended by the Board for election, be eligible for election to the office of Director at any general meeting, unless notice in writing of the intention to propose that person for election as a Director and notice in writing by that person of his willingness to be elected shall have been lodged at the head office or at the registration office of the Company. The period for lodgement of the notices required under the Articles will commence no earlier than the day after the dispatch of the notice of the general meeting appointed for such election and end no later than 7 days prior to the date of such general meeting and the minimum length of the period during which such notices to the Company may be given will be at least 7 days.

## ENVIRONMENTAL, SOCIAL 環境、社會及管治報告 AND GOVERNANCE REPORT

### ABOUT GLORY FLAME HOLDINGS LIMITED

Glory Flame Holdings Limited (the "Company"), together with its subsidiaries (collectively referred to as the "Group"), believe operating sustainably and quality growth is the key to our success and the economic basis for us to practice social responsibility. The Group strives to integrate environmentally friendly practices into all aspects of our daily operations to grow its business and create a positive impact on the market.

For the Reporting Period, the Group and its subsidiaries are mainly engaged in provision of construction services and building materials supply, including provision of concrete demolition and manufacturing and trading of prefabricated precast construction components.

### REPORTING SCOPE AND STANDARDS

This Environmental, Social and Governance report (the "ESG report") is prepared in accordance with the "Environmental, Social and Governance Reporting Guide" ("ESG Guide") as set out in Appendix 20 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("SEHK"). The information in this ESG Report is derived from the Group's official documents and statistical data, as well as the integration and summary of monitoring, management and operational information provided by subsidiaries of the Group. Information on the environmental and social aspects of the report is set out below whilst information on the governance aspect is set out in the Corporate Governance Report on pages 17 to 35.

The reporting period of this ESG report is from 1 January 2021 to 31 December 2021 ("Reporting Period"). This report highlights significant environmental and social impacts of our business activities in the provision of concrete demolition and construction engineering services, and the manufacturing and trading of prefabricated precast construction components.

While this report only covers the construction services and building materials supply business of the Group, and the Group aims to upgrade its internal data collection procedures and gradually expand the scope of the disclosure in future reports when appropriate.

### 關於朝威控股有限公司

朝威控股有限公司(「本公司」,連同其附屬公 司統稱「本集團」) 視可持續的優質增長為取 得成功的關鍵和履行社會責任的經濟基礎。 本集團努力將環保做法貫徹融入日常營運的 所有方面,藉此促進業務增長和為市場帶來 下面影響。

於報告期間,本集團及其附屬公司主要從事 提供建築服務及樓宇材料供應,包括提供混 凝土拆卸以及製造及買賣裝配式建築組件。

### 報告範圍及準則

本環境、社會及管治報告(「環境、社會及管 治報告」) 乃根據香港聯合交易所有限公司 (「聯交所」)證券上市規則附錄20《環境、社 會及管治報告指引》(「環境、社會及管治報告 指引」)編製。本環境、社會及管治報告的資 料來自本集團官方文件及統計數據以及本集 團附屬公司所提供的監察、管理及營運資料 的匯總概括。有關本報告環境及社會層面的 資料載於下文,而有關管治方面的資料載於 企業管治報告第17至35頁。

本環境、社會及管治報告的報告期間為二零 二一年一月一日至二零二一年十二月三十一 日(「報告期間」)。本報告著重説明我們於提 供混凝土拆卸及建築工程服務以及製造及買 賣裝配式建築組件時進行的業務活動所造成 的重大環境及社會影響。

本報告涵蓋了本集團的建築服務及樓宇材料 供應業務,本集團將目標定為改善內部數據 收集程序, 並於合適情況下在日後的報告中 逐步擴大披露範圍。

### **MATERIALITY ASSESSMENT**

In order to gain a better understanding of the expectations, perceptions and concerns of our stakeholders, we have engaged our management team and employees in identifying the Group's material ESG issues. With the identified material ESG aspects, we strive to ensure proper measures on significant issues are addressed adequately throughout our business activities.

### PROTECTING THE ENVIRONMENT

With greater concerns from the general public on the impacts of global warming and climate change, we acknowledge our responsibility to protect the environment as an integral part of our business operations. The Group is committed to upholding high environmental standards, not only fulfilling relevant requirements under applicable laws and ordinances but also to becoming a sustainable leader and corporate citizen in our community and industry.

### **EMISSIONS**

Engaging in construction activities as a contractor for years, it is inevitable that our operation activities have an impact on our environment. Emissions from our daily business activities mainly represent greenhouse gases ("GHG") emissions, noise, waste and effluents while carrying out construction works. In order to minimise these emissions and combat climate change, our subsidiaries under the construction segment comply with industry-standard environmental protection measures and continue to seek practical means to mitigate the emission of GHGs in its operations. Across our operations, we have carried out a number of green initiatives to reduce emissions and waste, enhance resources efficiency and minimise environmental footprint.

Given the issue of climate change and our Group's responsibilities to mitigate the climate impact of our operations, the Group has set an emissions reduction target of 10% of the Group's emissions over five years compared with the FY2021. To achieve this target, we plan to gradually switch to compact fluorescent lamps or LED lights, reducing emissions from electricity uses in our daily operations.

### 重要性評估

為更好地瞭解持份者的期望、看法及關注, 我們已讓管理團隊及僱員參與識別本集團的 主要環境、社會及管治議題。憑藉這些經識 別的重大環境、社會及管治層面,我們致力 於確保採取適當措施於整個業務活動期間充 分處理該等重要議題。

### 保護環境

由於公眾對全球變暖及氣候變化的關注程度 越來越高,我們認識到保護環境的責任為業 務營運不可分割的一部分。本集團致力於秉 承高水平的環保標準,不僅履行適用法例及 條例下的相關規定,亦要成為我們所在社區 及行業的可持續領導者及企業公民。

### 排放

我們作為承包商從事建築活動多年,所進行的營運活動不可避免地對環境構成影響。我們日常業務活動產生的排放主要是從事建築工作時的溫室氣體(「溫室氣體」)排放、電音、廢物及污水。為盡量降低排放及應對環境變化,我們建築分部下的附屬公司實施行業標準環保措施,並繼續尋求實際方式減少營運中溫室氣體的排放。在我們的業務範圍內,我們實施了多項環保措施,以減少排放及廢物,提高資源效率,並儘量減少環境足跡。

鑑於氣候變化問題以及本集團有關減輕經營活動對氣候影響的責任,本集團已設定一個較二零二一年度減排10%的五年減排目標。 為實現該目標,我們計劃逐步改用一體式螢光燈或LED燈,以減少日常營運中的用電排放。

### **Environmentally-Friendly Demolition Methods**

Construction materials such as sands and cement stored outdoor as well as the dust of the exposed construction area are easily scattered. In order to prevent the generation of dust during our works, environmentally friendly construction methods such as scarifying and shot blasting are adopted. These methods significantly reduce the amount of dust emitted to the surrounding areas of construction sites. It also produces excellent bonding characteristics that reduce the risk of coating failure to improve road safety and maximise floor life.

For projects that involve indoor demolition works, demolition methods that would not emit exhaust gas and would cause only minimal vibration during works were used. To ensure the safety of workers, our machinery can be remotely controlled so that our workers do not have to work close to the areas under demolition.

We also adopt splitting/bursting as a demolition method. Under this method, splitter is inserted into a hole of the concrete structure drilled beforehand for bursting the structure from within, resulting in minimum noise emission and vibration.

### **Prefabricated construction components**

Unlike traditional construction methods, prefabricated construction components are constructed in a factory environment to facilitate materials to be recycled or reused. A considerable amount of dust and noise emissions can be further reduced thanks to the controlled environment of the production factory. In our production factory, we have introduced a water spraying device for daily maintenance of sub-assemblies and for the prevention of dust scattering.

The largest source of the Group's GHG emissions relates to the below "Scope 1 – direct emissions or removals from sources" and accounts for the electricity use for lighting, air-conditioning, electrical appliances, machinery and equipment in operations. Due to COVID-19 pandemic, there has been no business air travel by our employees during the Reporting Period.

### 環保拆卸方法

室外存放的砂石及水泥等建築材料以及暴露的建築區域產生的灰塵容易造成塵土飛揚。為防止進行工程時產生灰塵,我們已採取打沙及石矢打花等環保建築方法。此等方法可大幅減少在建築工地周圍產生的灰塵。該技術亦具有超強粘結性能,可降低塗層失效的風險,從而改善道路安全並延長地面壽命。

對於涉及室內拆卸工程的項目,以我們所採用的拆卸方法,工作過程中不會產生廢氣, 造成的振動也能降至最低。為確保工人的安全,我們的機械由工人遠程操作,工人毋須 靠近拆卸區域工作。

我們亦採用逼裂/鉗碎的拆卸方法。該方法 是將劈裂機插入混凝土構築物的事先鑽好的 孔隙中,將構築物劈裂,使產生的噪音及振 動降至最低。

### 裝配式建築部件

與傳統建築方法不同,裝配式建築部件是在 工廠完成,使材料可以循環再利用。得益於 生產廠房的這種受控制的環境,灰塵及噪音 排放可進一步減少。在我們的生產廠房,我 們引進了噴水裝置,用於次組裝的日常維護 及防止揚塵。

本集團的溫室氣體排放最大源頭與下文「範圍1 — 直接排放及從源頭減除」有關,歸因於營運期間的照明、空調、電器及機械及設備的用電。由於新冠病毒疫情,報告期內我們的並無僱員乘坐飛機出外公幹。

### **WASTE MANAGEMENT**

Construction waste from daily operations includes general inert waste and non-inert waste. The major approach to managing construction waste in Hong Kong is the use of public filling areas for reusable inert construction waste and landfills for non-inert construction waste. The fill banks temporarily stockpile the inert construction waste for subsequent reuse in reclamation and site formation works. In general, the Group categorises the waste from construction works before removal from the site. General inert waste from work, such as rocks, shall be reused as filling materials at the site if applicable or disposed to public fill for reclamation in the future. Other waste that is not applicable for recycling or reuse shall be discarded to the public filling areas to conserve landfills. We are committed to only disposing waste at legitimate waste disposal facilities or through licensed collectors to collect and dispose on behalf of the Group.

In respect of office waste, we shall continue to encourage our employees to fully utilise all materials to avoid producing unnecessary waste and to reduce paper usage electronic means.

For the Reporting Period, the amount of non-hazardous waste produced by the Group was as follows:

### 廢物管理

During the Reporting Period, the Group established a waste reduction target of reducing non-hazardous waste by 10% of the Group's non-hazardous waste over five years compared with the FY2021 levels. To achieve our waste reduction target, the Group separates waste before disposal and take waste to the allocated sorting area. We have adopted a trip-ticket system to avoid fly-tipping and to ensure waste is disposed of properly when our client did not provide the disposal area. The Group also implement the following measures to reduce:

- Maximise the utilisation of materials and avoid unnecessary use and cutting;
- Order the appropriate amount of raw material at the appropriate time;
- Store materials in an allocated area with suitable protective measures:
- Periodically review operating procedures to minimise waste generation; and
- Collect the exact number of materials and return the surplus to stock as needed.

Due to our business nature (provision of construction services and building materials supply), no hazardous waste was generated from our operations for the Reporting Period.

### **USE OF RESOURCES**

The Group's major use of resources includes energy and water consumption. For energy use, both office operation and the carrying out of construction works consume electricity and fuel. Fuel consumption mostly came from equipment operation and ground transportation of equipment during delivery, while electricity consumption was from office operation. We place great emphasis on resource conservation and strives to enhance the energy efficiency by strengthening the maintenance of construction equipment, optimising operation procedures, and adopting energy-saving measures.

於報告期內,本集團制定了減廢目標,即於五年內將本集團的無害廢棄物較財政年度二零二一年的水平減少10%。為實現我們的減廢目標,本集團在處置廢物前會先將廢物分類,並將廢物帶到指定分類區。我們已採用運載紀錄制度,以避免在客戶未提供垃圾處理區域的情況下,隨意傾倒垃圾並確保垃圾得到妥善處理。本集團亦採取以下措施以減廢:

- 最大限度利用材料,避免不必要的使用及切割;
- 在適當時候訂購適當數量的原材料;
- 將材料存放在指定區域並採取適當的保護措施;
- 定期審查操作程序以盡量減少廢物的產生;及
- 收集確切數量的材料並根據需要將剩餘 部分退回庫存。

由於我們的業務性質(提供建築服務及建築 材料供應)使然,我們於報告期間的營運並 無產生任何有害廢物。

### 資源使用

本集團的主要資源使用包括能源及水消耗。 對於能源使用而言,、我們的辦公室運營及 建築工作須消耗電力及燃料。燃料消耗大部 分產生於設備操作及付運期間的設備地面運 輸,而電力消耗則來自辦公室運營。我們高 度重視資源節用,努力透過維護建築設備、 優化操作流程及採納節能措施提高能源效率。 Several initiatives have been implemented in offices and construction sites to control energy consumption as follows:

Apart from office operation, the major source of the Group's water consumption is from our construction segment. To promote water conservation, the Group incorporated various water conservation measures in both offices and project sites. Control measures like protection of drainage system and discharge point to avoid blockage, and conduction of regular self-monitoring checks to ensure the quality of the effluent discharged meeting the prescribed standards, are being practised in our daily operations. At our construction sites, wastewater is collected and properly treated by on-site wastewater treatment facilities and then reused for dust suppression and vehicle wheel washing or ground mud to reduce freshwater consumption. Our sub-contractors were also encouraged to work closely with our staff to implement appropriate measures to prevent the waste of fresh water on site.

During the Reporting Period, the Group established an energy-use efficiency target of reducing energy use by 10% for electricity, paper and water over five years compared with the FY2021 levels. To achieve our energy-use efficiency target, the Group has adopted the Reduce, Replace and Reuse approach, in line with national initiatives. Our management will perform periodic reviews to monitor the progress.

辦公室營運外,本集團用水消耗的主要源頭 為建築分部。為提倡節水,本集團在辦公室 及建築工地納入了各種節水措施。我們於 常營運中實施了多項控制措施,如保護排水 系統以避免阻塞及定期進行自主監測檢查 確保排放廢水治理符合規定標準。於建築 地,我們收集並以現場污水處理設施妥為處 理廢水,之後將其用於抑制揚塵和清洗汽車 輪胎或地面淤泥,以減少食水消耗。我們亦 鼓勵我們的分包商與我們員工緊密合作,執 行適當措施減少工地的食水浪費。

於報告期內,本集團已制定能源使用效率目標,即在五年內將電力、紙張及水的能源使用量較財政年度二零二一年的水平降低10%。為實現我們的能源使用效率目標,本集團根據國家倡議採取減少、替換及再利用的方法。我們的管理層將進行定期檢討以監察進度。

### **ENVIRONMENT AND NATURAL RESOURCES**

### 環境及天然資源

In compliance with applicable environmental legislation, our operating activities have no significant impact on the environment and natural resources. For the sake of compliance with relevant laws and regulations, we regularly assess the environmental risks of our operations and adopt preventive measures as necessary to reduce the risks.

我們的經營活動遵守適用的環保法例,並無 對環境及天然資源造成重大影響。為符合相 關法律及法規,我們定期評估業務經營的環 境風險,並在必需時採取預防措施以降低風 險。

In managing our emissions, the Group has complied with the Air Pollution Control Ordinance (Cap. 311), Waste Disposal Ordinance (Cap. 354), Water Pollution Control Ordinance (Cap. 358), Noise Control Ordinance (Cap. 400), Dumping at Sea Ordinance (Cap. 466), Environment Impact Assessment Ordinance (Cap. 499) and other regulations promulgated by governments and currently applicable to the Group, as well as environmental requirements from customers.

為管理我們的排放,本集團已遵守《空氣污染管制條例》(第311章)、《廢物處置條例》第354章)、《水污染管制條例》(第358章)、《噪音管制條例》(第400章)、《海上傾倒物料條例》(第466章)、《環境影響評估條例》(第499章)及政府頒佈且目前適用於本集團之其他法規,以及客戶提出的環保要求。

For the Reporting Period, the Group was not aware of any cases of non-compliance with laws and regulations that have a significant impact on the Group in relation to air and GHG emissions, noise control, discharges into water and land, and generation of hazardous and non-hazardous waste.

Strategy 策略 **Policies and guidelines:** The Management meets monthly and discusses any potential climate change risk to our business. Management will then brainstorm ideas to mitigate these risks. The corresponding actions will be implemented and reviewed from time to time to assess their effectiveness.

**政策及指引**:管理層每月召開會議,討論我們業務面臨的任何潛在氣候變化風險。然後,管理層將集思廣益得出措施以減輕相關風險。本公司將時實施及檢討相應行動,以評估其有效性。

**Physical risks:** We assess our sites for impacts related to flood risks. We work closely with the sub-contractor at the site and assist with implementing fast-response measures, regular inspections and hoarding to ensure sites will not be flooded.

**Transition risks:** Impacts related to market risk are assessed in our construction materials. We keep abreast of the latest energy-saving technology and equipment and recommend it to the main contractor and the sub-contractor. In line with the national initiative for smart technology, we work with suppliers to bring in LED lighting, which uses sensors to help reduce energy usage.

Risk Management 風險管理 Climate-related risks are incorporated into the Group's risk management framework and ESG materiality assessment by different stakeholders. The Group will monitor and follow up on both transition and physical climate-related risks and set up the policy to respond with our management.

### **EMPLOYMENT AND LABOUR PRACTICES**

The Group values people and considers a respectful and fair working environment to be vital to its operations. We make sure compensation packages offered to staff can be commensurate with their performance and experience. Specifically, compensatory leave, overtime allowance, discretionary bonus, mandatory provident fund or pension security, social insurance, rewards for long-term services, and an annually reviewed salary level in our employment contracts allow the Group to retain quality talent.

The Group has established a series of internal policies related to employment with reference to anti-discrimination ordinances and the guidance under Employment Ordinance (Cap. 57), Laws of Hong Kong, the Labour Law and Labour Contract Law of the PRC, as well as industry features and practices to ensure that our employees are treated fairly, and their employment, remuneration and promotion are not affected by their social identities such as age, gender, marital status, family status, sexual orientation, race, nationality or religion.

A comprehensive human resources management policy was formulated to support human resources function, which covers guidelines on recruitment and promotion, compensation and dismissal, working hours, rest periods, appraisal, training and other benefits. We motivate employees by promotion, salary increment, and discretionary bonus based on an annual performance appraisal. In our demolition works subsidiary, a long service award is given to those employees that have been employed for over 10 years as a reward to their loyalty.

We take staff opinion seriously. All employees are welcome to make comments and suggestions through various communication channels such as letters, emails, or by communicating with their direct supervisors, department heads, or our human resources function. We make sure to keep the detail of such communications and the identity of the employee confidential, and to address any grievances of the employee as appropriate as we can.

### 僱傭及勞工常規

本集團重視人才,並認為互相尊重及公平的工作環境對其營運至關重要。我們確保員工的薪酬待遇與其表現及經驗相匹配。具體而言,我們的僱傭合同中列明有薪假期、加班津貼、酌情花紅、強制性公積金或退休金保障、社會保險、長期服務獎勵以及按年檢討薪資水平,使本集團得以保留優質人才。

本集團已參照香港法例第57章《僱傭條例》、《中國勞動法》及《中國勞動合同法》下的反歧視條例及指引以及行業特點及常規制定一系列內部僱傭政策,確保僱員享有公平待遇,不會因年齡、性別、婚姻狀況、家庭狀況、性取向、種族、國籍或宗教信仰等社會身份而影響彼等之就職、薪酬及晉升。

本集團已制定全面的人力資源管理政策以支持人力資源職能,當中包含有關招聘及晉升、薪酬及解僱、工作時間、休假、評估、培訓及其他福利等方面的指引。我們激勵僱員的方式包括根據年度績效考核結果對其晉升、加薪及給予酌情花紅。在我們的拆卸工程附屬公司工作超過10年的僱員可獲得長期服務獎,以表揚其忠誠。

我們尊重僱員的意見。我們歡迎全體僱員透 過信件、電子郵件等各種通訊渠道,或直接 與上司、部門負責人或人力資源部進行溝 通,提出意見及建議。我們為有關通訊資料 及僱員身份保密,並盡我們所能解決僱員的 任何不滿(如合適)。

### **Staff Composition**

The Group's principal businesses are prefabricated construction and demolition works which requires plenty of physical labour. Traditionally male employees comprise a majority of our workforce. This does not mean we prefer hiring male employees to female employees. We welcome any candidate who can demonstrate they can excel at work and is committed to developing his/her career within the construction industry.

As at 31 December 2021, we employed a total of 124 full-time staff, including back-office and site staff. All of our staff members are located in Hong Kong and the PRC.

### 員工組成

### Employees by Gender 按性別劃分的僱員




# Employees by Employment Category 按職務類別劃分的僱員

### **Staff Turnover**

For the Reporting Period, the Group has a turnover rate of approximately 8%. The turnover rate by gender is 9% for male staff and 4% for female staff leaving the Group. Geographically, 10% of staff who are based in Hong Kong left the Group, whereas in the PRC 3% of staff left.

For the Reporting Period, the percentages of employee turnover categorised by age group were as follows: for the "18 - 30 years old", the "31 - 40 years old", the "41 - 50 years old", the "51 - 60 years old", and the "over 60 years old" groups, the turnover rates were 50%, 0%, 20%, 0%, and 0%, respectively.

For the Reporting Period, the Group was not aware of any cases of non-compliance with laws and regulations concerning compensation and dismissal, recruitment and promotion, working hours, rest periods, equal opportunities, diversity, anti-discrimination, and other benefits and welfare.

### **HEALTH AND SAFETY**

Recognising that the construction industry is one of those industries with a higher risk in terms of occupational health and safety ("**OHS**"), we put safety first and are committed to maintaining a workplace that is safe for our people. To ensure that all employees are equipped with adequate knowledge in protecting themselves from occupational hazards, the Group has provided training for all levels of employees.

For the Reporting Period, the Group's operations do not possess high-risk areas related to OHS to its employees except for construction-related operations. We are determined to ensure that all construction works are carried out in accordance with the best OHS practices. Specifically, protective equipment such as safety helmets, safety shoes and high visibility clothing are provided to all personnel who needs to work at construction sites. Relevant OHS training such as safety induction training, toolbox talks, specific training for high-risk activities, periodic emergency contingency drills to heighten employee awareness of workplace hazards are provided to staff to ensure they are competent to discharge their OHS responsibilities and obligations and respond to emergencies.

### 員工流失

於報告期內,本集團之員工流失率約8%。男性及女性離職員工比例分別為9%及4%。按地區劃分,香港離職人員佔10%,而中國離職人員佔3%。

於報告期內,本集團概不知悉任何關於薪酬 及解僱、招聘及晉升、工作時間、休假、平 等機會、多樣化、反歧視以及其他利益及福 利不符合法律及法規的事件。

### 健康與安全

我們深知,建築業是職業健康與安全(「**職業健康及安全**」)風險較高的行業之一,故我們將安全置於首位,並致力於為僱員維持安全的工作場所。為確保全體僱員均具備保護自己免受職業危害的充足知識,本集團為各級僱員提供培訓。

於報告期內,除建築相關業務外,本集團之營運並無涉足對僱員之職業健康與安全而言屬高風險的領域。我們堅決確保根據職東與安全最佳慣例開展所有建築工作。具有實施,我們為所有須於施工現場工作的的是供頭盔、安全鞋及反光衣等防護設場工提供相關的職業健康與安全時間,如為與安全時間,如專項培訓以及定期的應急演習,以提高僱員的工作場所危機意識,確保彼等有應對緊急情況。

We hire professionally qualified persons in OHS to oversee the management of safety risks and issues in our operations. Safety measures are tailored to respond to different site conditions and activity risks to ensure a safe working environment for all employees and those who work on our projects. Our safety officers would regularly review and check for updates in applicable safety laws and regulations. Site inspections are also regularly performed to conduct risk assessment, note for material safety issues, suggest remediation measures, and follow up implementation of safety recommendations. Our on-site foremen and site supervisors are required to co-operate with our safety officers to ensure all health hazards would be rectified promptly.

To keep the Group abreast of the latest OHS best practices and/ or updated in-laws and regulations relevant to OHS, one of our subsidiaries had registered as a Green Cross Group member under the Occupation Safety and Health Council ("OSHC") in Hong Kong. This allows the Group to access the OSHC's library to obtain the latest information and participate in workshops to facilitate experience sharing and gain deeper insights into the implementation of OHS best practices. The Group has continued to optimise its work practices and daily management for the sake of its staff's health and safety with the aim to create a safe, healthy and comfortable working environment. To this end, our operations fully comply with applicable laws and regulations such as the Occupational Safety and Health Ordinance (Cap. 509), Employees' Compensation Ordinance (Cap. 282), Factories and Industrial Undertakings Ordinance (Cap. 59), Laws of Hong Kong, and Work Safety Law of the PRC.

我們僱用專業合資格的職業健康與安全人員,監督我們於運營期間對安全風險及問題的管理。安全措施針對不同的現場條件及及動風險而制定,以確保為所有員工及我們的實施人員提供安全的工作環境。我們的安主任會定期檢討並檢查適用的現場一個險評估,關注材料安全問題,就被有人風險評估,關注材料安全問題,就被過過一個大學的現場,並跟進安全建議的實施。我們的現場工長及現場監督員須與安全主任合作,確保任何所有健康危害得到及時糾正。

Noted that there were increased cases of work accidents during the Reporting Period, the Group will put more efforts to reduce the risks of work injuries of employees in the coming year. In addition to providing adequate protective equipment and implementing aforementioned site safety measures, the Group introduced new plant and equipment to further enhance site safety and productivity, such as Camera drone which enhance the effectiveness of site safety supervision. For the Reporting Period, the Group was not aware of any cases of non-compliance with laws and regulations that have a significant impact on the Group in relation to providing a safe working environment and protecting employees from occupational hazards.

本集團留意到於報告期內工傷意外有所增加,未來一年本集團將加大力度降低員工工傷風險。除了提供足夠的防護設備及實施上述工地安全措施外,本集團亦引進了新的廠房及設備以進一步提高工地安全及生產力,例如提高工地安全監管有效性的帶攝像頭無人機。於報告期內,本集團概不知悉任何違反關於提供安全工作環境及保護僱員免受職業危害的法律及法規而對本集團構成重大影響的事件。

The Group has introduced a number of measures in response to the COVID-19 outbreak to safeguard the health of our employees and to enable them to carry on with their daily work with a healthy and positive state of mind. COVID-19 prevention facilities and equipment, for example, non-contact forehead thermometers were set up in offices and construction sites, while individual health packs were distributed to show our care for the welfare of our employees.

本集團已採取多項措施應對新冠病毒疫情, 以保障我們員工的健康,讓其可以健康積極 的心態繼續日常工作。我們在辦公室及建築 工地設有非接觸式額溫計等新冠病毒預防設 施及設備,同時分發個人健康包,以表達我 們對員工福祉的關心。

### **DEVELOPMENT AND TRAINING**

We recognised that our construction workers are exposed to higher injury risks than office staff. In order to reasonably mitigate the risk of work-related injuries, our site foremen, site supervisors and safety officers would conduct work safety briefings to all site workers from time to time and when needed. Causes of accidents in the construction industry are identified and corresponding recommendations or training sessions will be provided to workers to avoid the reoccurrence of similar accidents.

The Group recognises the importance of skilled and professionally trained employees to its business growth and future success. We are committed to providing a career development platform for our employees where everyone can achieve their career goals. We have invested resources on the career development of employees and encouraged employees from each level to participate in order to enhance the competitiveness of the Group and the relevant individuals. The Group also acknowledges the importance of conducting performance appraisal with employees. On an annual basis, performance appraisal is conducted between management and employees for continuous improvement. Employees are able to communicate and seek professional advice from their supervisors on their career development progress.

### LABOUR STANDARDS

The Group highly respects human rights and freedom. We strictly prohibit the uses of child and forced labour in our workplace by adhering with the Employment of Children Regulations and Employment of Young Persons (Industry) Regulations under the Employment Ordinance (Cap. 57), Laws of Hong Kong, Provisions on the Prohibition of Using Child Labour, and the Law of the People's Republic of China on Protection of the Minors. Comprehensive recruitment procedures are required to be performed to check and verify the age of a job applicant before the Group can hire him/her. The procedures require a job applicant to present their valid proof of identity to ensure that they have reached the legal working age. Important details such as job duties, locations and working hours of the staff are also set out clearly in the employment contract to protect their rights and interests and forced labour is strictly prohibited.

### 發展及培訓

我們深知建築工人比辦公室工作人員面臨更高的受傷風險。為合理減低工傷風險,我們的現場工長、現場監督員及安全主任會於必要時不時向全體工地工人提供工作安全簡報。我們確定建築行業事故原因並向工人提供相應的建議或培訓課程,以避免類似事故再次發生。

本集團深知技能熟練及經專業培訓的僱員對 其取得業務增長及未來成功至關重要。我 致力為僱員提供可讓他們實現職業目標的 業發展平台。我們已為僱員的職業發展 資源,並鼓勵各級別僱員參與,以提高對 團及有關人員的競爭力。本集團亦明對管 員進行績效考核的重要性。我們每年對管理 層及僱員開展績效考核,以實現持續改建 僱員可就其職業發展路徑與上司進行溝通並 尋求其專業意見。

### 勞工準則

本集團高度尊重人權與自由。我們遵循香港 法例第57章《僱傭條例》下的《僱用兒童規 例》及《僱用青年(工業)規例》、《禁止使用 童工規定》及《中華人民共和國未成年人保 護法》規定,嚴禁於我們的工作場所招使用 正及強制勞工。我們要求執行全面的位也 序,在本集團僱用之前檢查及核實崗位出示 序的年齡。該等程序要求崗位申請人出定工作 年齡。僱傭合約內亦會清楚列明員工的 年齡。僱傭合約內亦會清楚列明員工權 為,杜絕強制勞工。

### SUPPLY CHAIN MANAGEMENT

We place great emphasis on product quality to protect the interests of our clients. Vendor management is a crucial part of our quality control procedures. The Group stringently manage suppliers and sub-contractors to avoid any inferior materials acquired and adopt strict quality control over the production and construction process. We collaborate with suppliers, service providers, material manufacturers and sub-contractors who share our goals in responsible management of business ethics, quality, safety, labour, environmental management in order to provide the best solutions to our clients.

Through the implementation of a robust procurement and tendering mechanism, we select reliable and competent business partners from potential organisations in adherence to the principle of equal opportunity and fair competition. In respect of suppliers or sub-contractors selection, a list of approved suppliers is in place and we will only select suppliers and appoint sub-contractors from this approved list unless individually reviewed and approved by management or specifically requested by the client.

Looking forward, the Group aims to promote local economic development and reduce carbon footprint, by prioritising local suppliers by shortening the distance of transportation. In addition to geographical factors, we expect our suppliers to meet the requirements including but not limited to areas such as child or forced labour, health and safety, working hours, discrimination and disciplinary processes.

Specifically, we maintain approved lists of suppliers and subcontractors while regular reviews are conducted to ensure our suppliers, sub-contractors and service providers continue to have the capability and capacity to provide stable and reliable services and products. The Group's suppliers are selected based on the following factors: environmental compliance of products supplied; quality of materials; and any background issues concerning potential conflict of interest in supplying goods to the Group.

### 供應鏈管理

展望未來,本集團計劃優先選用本地供應商以縮短運輸距離,從而促進本地經濟發展及減少碳足跡。除地區因素外,我們期望供應商符合以下方面的要求,包括但不限於童工或強制勞工、健康與安全、工時、歧視和紀律程序。

### PRODUCT RESPONSIBILITY

To meet the demand of our clients, the Group has developed its internal management system and closely monitored its project execution process, with an aim to render premium and reliable service to our clients.

In our prefabricated construction business, we have established and implemented a quality management system ("QMS") in our operations, which conforms with internationally recognised ISO 9001:2015 standard in Hong Kong. This system helps us to comply with relevant laws, regulations and contract obligations that are applicable to our products and services; control quality issues systematically to enhance our customers' satisfaction; as well as continuously improve quality performance in our operations. The Group also provides adequate training to all levels of employees to raise their awareness of QMS in their responsible tasks. For instance, the design, production and supply of our product, Ready Mixed Concrete, has obtained the Quality Scheme for the Production and Supply of Concrete ("QSPSC") under the Hong Kong Quality Assurance Agency.

### 產品責任

In compliance with the Personal Data (Privacy) Ordinance (Cap. 486), Laws of Hong Kong, we ensure that all the collected business data from our clients will be treated as strictly confidential and properly dealt with by our staff. Our clients' data can only be accessed by designated personnel to prevent information leakage to unauthorised persons or parties.

We also request our suppliers to comply with such laws and regulations.

do not tolerate corruption, bribery, money laundering and other fraudulent activities in connection with any of our business operations. The Group strictly adhere to relevant regulations and laws, such as the Prevention of Bribery Ordinance (Cap. 201), the Anti-Money Laundering and Counter-Terrorist Financing Ordinance (Cap. 615), Laws of Hong Kong, and the Criminal Law of the PRC.

To facilitate the identification of suspected cases of corruption, money laundering and other misconducts, the Group has developed a whistle-blowing policy as stated in our staff handbook. Employees are prohibited from accepting or offering any advantages, including but not limited to rewards, gifts, fees, loans, services, from or to any clients, suppliers or person having a business relationship with the Group. In the event that they identify any irregularities, staff can report to senior management or the audit committee of the Group as they see fit, and we will protect the identity of the whistleblower. Detailed investigation on the reported event shall be conducted and would be followed by appropriate actions according to the result.

The tendering process is vital to our business and all tendering documents are kept confidential and restricted to concerned parties only. It must be done in a fair manner in order to protect the interest of the Group and our clients. Employees responsible for tendering must comply with the Competition Ordinance (Cap. 619), Laws of Hong Kong, refraining themselves exchanging or communicating any sensitive information with competitors, participating in price-fixing, imposing restrictions on clients, and abusing the dominant market position.

### GIVING BACK TO THE COMMUNITY

We are committed to supporting the community by incorporating social participation and contribution into our strategic development. We believe that this will nurture a sound corporate culture and good practices in the Group.

In April 2008, the Environmental Protection Department of the Government of the Hong Kong Special Administrative Region, launched the Cleaner Production Partnership Programme in collaboration with the Economic and Information Commission of Guangdong Province to encourage and facilitate Hong Kongowned factories in Hong Kong and Guangdong to adopt cleaner production technologies and practices, thereby contributing to improving the environment. One of our subsidiaries, Huizhou Precast Building Materials Co. Ltd., was awarded in the programme in 2021. The Group will continue efforts to make a positive contribution to a cleaner environment by reducing emissions.

With a focus to contribute towards the occupational safety, the Group made donations to the Hong Kong General Building Conference that aim to enhance safety awareness through experience sharing and encourage management and frontline staff to implement a safe system of work.

The Group shall keep abreast latest trends and best practices related to environmental protection at construction sites, and workers' health and safety. We also encourage employees to actively participate in community and voluntary work to further the benefits of local communities and render assistance to the needy. Meanwhile, the Group has strengthened its ties and ensured continuous communication with members of the community where it operates, in an effort to advocate a caring and serving spirit.

The purpose of the Scheme is to attract and retain the best available personnel, to provide additional incentive to employees (full-time and part-time), Directors, consultants, advisers, distributors, contractors, suppliers, agents, customers, business partners and services providers of the Group and to promote the success of the business of the Group.

The Board may, at its absolute discretion and on such terms as it may think fit, grant any employee (full-time or part-time), Director, consultant or adviser of the Group, or any substantial shareholder of the Group, or any distributor, contractor, supplier, agent, customer, business partner or services provider of the Group, options to subscribe for such number of shares of the Company as it may determine in accordance with the terms of the Scheme. The basis of eligibility of any participant to the grant of any option shall be determined by the Board (or as the case may be, the independent non-executive Directors) from time to time on the basis of his contribution or potential contribution to the development and growth of the Group.

As at 31 December 2021 and 2020, the number of outstanding share options under the Scheme is 6,200,000 options, representing 0.61% of the total issued Shares. During the Reporting Period, none of share options was granted, exercised, cancelled and lapsed.

The maximum number of entitlement to Shares of each grantee under the Scheme (including exercised, cancelled and outstanding options) in any 12-month period shall not exceed 1% of the total number of the issued Shares. Any further grant of options in excess of this 1% limit shall be subject to the approval of the Shareholders in accordance with the GEM Listing Rules.

#### **QUALIFIED OPINION**

We have audited the consolidated financial statements of Glory Flame Holdings Limited (the "Company") and its subsidiaries (collectively referred to as the "Group") set out on pages 93 to 163, which comprise the consolidated statement of financial position as at 31 December 2021, and the consolidated statement of profit or loss and other comprehensive income, consolidated statement of changes in equity and consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion section of our report, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2021, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

#### **BASIS FOR QUALIFIED OPINION**

#### **Prepayment**

As at 31 December 2021, the consolidated statement of financial position included a fully impaired prepayment balance, of which was made previously to a supplier in the construction business. For the year ended 31 December 2021, an impairment loss of approximately HK\$21,317,000 was recognised.

吾等已完成審核列載於第93至163頁朝威控股有限公司(「貴公司」)及其附屬公司(統稱「貴集團」)之綜合財務報表,此綜合財務報表包括於二零二一年十二月三十一日之綜合財務狀況表與截至該日止年度之綜合損益及其他全面收入表、綜合權益變動表及綜合現金流量表,以及綜合財務報表的附註(包括主要會計政策概要)。

吾等認為,除吾等報告中保留意見的基礎一節所述事項可能產生的影響外,綜合財務報表已根據香港會計師公會(「香港會計師公會」)頒佈之香港財務報告準則(「香港財務報告準則」)真實而公平地反映 貴集團於二零二一年十二月三十一日之綜合財務狀況,及貴集團截至該日止年度之財務表現及現金流量,並按照香港公司條例之披露規定妥為編製。

#### 保留意見的基礎

#### 預付款項

於二零二一年十二月三十一日,綜合財務狀況表包括一項已完全減值的預付款項結餘,該結餘以前是支付予一間建築業務供應商。截至二零二一年十二月三十一日止年度,已確認減值虧損約21,317,000港元。

## INDEPENDENT AUDITOR'S REPORT 獨立核數師報告

The Group and the supplier have entered into a supplemental agreement ("Supplemental Agreement") on 16 March 2021, which stated that (i) The supplier would partially refund RMB7.0 million to the Group by March 2021; (ii) Should the Group be unable to enter into any new business with the supplier before 31 August 2021, the supplier would partially refund another RMB7.0 million to the Group; and (iii) Should the Group be unable to enter into any new business with the supplier before 31 December 2021, the rest amount of RMB12.1 million would be refunded to the Group.

The first partial refund of RMB7.0 million was received by the Group in March 2021 in accordance with the terms as stated in the Supplemental Agreement. Yet, the second partial refund and the final refund totaling RMB19.1 million (equivalent to approximately HK\$21,317,000) were both defaulted. Up to the date of this report, the management is still negotiating with and considering taking any legal action to the supplier on the refunds in arrears. Due to the breach of Supplemental Agreement and recent unfavourable negotiation result with the supplier, the management considered that the impairment loss of approximately HK\$21,317,000 should be recognised for the year ended 31 December 2021.

Due to the above uncertainties, the management is not able to provide further evidences in justifying the sufficiency, adequacy and extent of the impairment loss being recognised. Accordingly, we are not able to obtain sufficient appropriate audit evidences to ascertain the recoverability of the aforesaid balance as at 31 December 2021. More importantly, there is no other satisfactory audit procedures that we could perform to satisfy ourselves whether the aforesaid balance were fairly stated as at 31 December 2021. Consequently, we are not able to obtain sufficient appropriate audit evidences on the impairment losses recognised for the year ended 31 December 2021.

Any adjustments to the figure as described above might have a consequential effect on the Group's financial performance and cash flows for the year ended 31 December 2021 and the financial position of the Group as at 31 December 2021, and the related disclosures thereof in the consolidated financial statements.

貴集團於二零二一年三月根據補充協議所述條款收到第一筆部分退款人民幣7,000,000元。然而,總額為人民幣19,100,000元(相等於約21,317,000港元)的第二筆部分退款及最終退款均被拖欠。截至本報告日期,管理層仍在與供應商協商,並考慮就拖欠的退款向供應商採取任何法律行動。由於供應商違反補充協議,且近期的談判結果並不理想,管理層認為應於截至二零二一年十二月三十一日止年度確認減值虧損約21,317,000港元。

由於上述不確定性,管理層無法提供進一步 證據證明已確認減值虧損的充分性、足夠性 及程度。因此,吾等無法獲取充分及適當 的審計證據,以確定上述結餘於二零二一年 十二月三十一日的可收回性。更重要的以上 吾等並無其他可執行之適當審核程序,以使 吾等信納是否已公平呈列上述於二零二一年 十二月三十一日之結餘。因此,吾等無法就 截至二零二一年十二月三十一日止年度確認 的減值虧損獲取充分及適當的審計證據。

對上述數字的任何調整可能會對 貴集團截至二零二一年十二月三十一日止年度的財務表現及現金流量、 貴集團於二零二一年十二月三十一日的財務狀況以及其在綜合財務報表中的相關披露產生後續影響。

In addition, the Group's recoverability review involves application of judgement and is based on estimates.





#### 1. GENERAL INFORMATION

Glory Flame Holdings Limited (the "Company") was incorporated in the Cayman Islands on 25 April 2014 as an exempted company with limited liability under the Companies Law of the Cayman Islands. The address of its registered office is Windward 3, Regatta Office Park, PO Box 1350, Grand Cayman KY1-1108, Cayman Islands. The address of the Company's principal place of business in Hong Kong is Suite 821, 8th Floor, Ocean Centre, Habour City, 5 Canton Road, Tsim Sha Tsui, Kowloon, Hong Kong. The Company's shares are listed on GEM of The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

The Company is an investment holding company. The principal activities of its subsidiaries are set out in note 31 to the consolidated financial statements.

# 2. ADOPTION OF NEW AND REVISED HONG KONG FINANCIAL REPORTING STANDARDS

In the current year, the Group has adopted all the new and revised Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA") that are relevant to its operations and effective for its accounting year beginning on 1 January 2021. HKFRSs comprise Hong Kong Financial Reporting Standards ("HKFRS"); Hong Kong Accounting Standards ("HKFRS"); and Interpretations. The adoption of these new and revised HKFRSs did not result in significant changes to the Group's accounting policies, presentation of the Group's consolidated financial statements and amounts reported for the current year and prior years.

The Group has not applied the new and revised HKFRSs that have been issued but are not yet effective. The Group has already commenced an assessment of the impact of these new and revised HKFRSs but is not yet in a position to state whether these new and revised HKFRSs would have a material impact on its results of operations and financial position.

#### 1. 一般資料

#### 3. SIGNIFICANT ACCOUNTING POLICIES

These consolidated financial statements have been prepared in accordance with HKFRSs issued by HKICPA, accounting principles generally accepted in Hong Kong and the applicable disclosures required by the Rules Governing the Listing of Securities on GEM of the Stock Exchange and by the Hong Kong Companies Ordinance.

These consolidated financial statements have been prepared under the historical cost convention. These consolidated financial statements are presented in Hong Kong dollars ("**HK\$**") and all values are rounded to the nearest thousand except when otherwise indicated.

The preparation of consolidated financial statements in conformity with HKFRSs requires the use of certain key assumptions and estimates. It also requires the directors to exercise its judgements in the process of applying the accounting policies. The areas involving critical judgements and areas where assumptions and estimates are significant to these consolidated financial statements, are disclosed in note 4 to the consolidated financial statements.

The significant accounting policies applied in the preparation of these consolidated financial statements are set out below.

#### Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 December. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

#### 3. 主要會計政策

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties, to determine whether it has control. A potential voting right is considered only if the holder has the practical ability to exercise that right.

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date the control ceases.

The gain or loss on the disposal of a subsidiary that results in a loss of control represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that subsidiary and (ii) the Company's share of the net assets of that subsidiary plus any remaining goodwill relating to that subsidiary and any related accumulated foreign currency translation reserve.

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

#### **Consolidation (Continued)**

Non-controlling interests represent the equity in subsidiaries not attributable, directly or indirectly, to the Company. Noncontrolling interests are presented in the consolidated statement of financial position and consolidated statement of changes in equity within equity. Non-controlling interests are presented in the consolidated statement of profit or loss and other comprehensive income as an allocation of profit or loss and total comprehensive income for the year between the non-controlling shareholders and owners of the Company.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling shareholders even if this results in the non-controlling interests having a deficit balance.

Changes in the Company's ownership interest in a subsidiary that do not result in a loss of control are accounted for as equity transactions (i.e. transactions with owners in their capacity as owners). The carrying amounts of the controlling and non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiary. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to the owners of the Company.



#### **Business combination and goodwill**

The acquisition method is used to account for the acquisition of a subsidiary in a business combination. The cost of acquisition is measured at the acquisition-date fair value of the assets given, equity instruments issued, liabilities incurred and contingent consideration. Acquisition-related costs are recognised as expenses in the periods in which the costs are incurred and the services are received. Identifiable assets and liabilities of the subsidiary in the acquisition are measured at their acquisition-date fair values.

The excess of the cost of acquisition over the Company's share of the net fair value of the subsidiary's identifiable assets and liabilities is recorded as goodwill. Any excess of the Company's share of the net fair value of the identifiable assets and liabilities over the cost of acquisition is recognised in consolidated profit or loss as a gain on bargain purchase which is attributed to the Company.

Goodwill is tested annually for impairment or more frequently if events or changes in circumstances indicate that it might be impaired. Goodwill is measured at cost less accumulated impairment losses. The method of measuring impairment losses of goodwill is the same as that of other assets as stated in the accounting policy below. Impairment losses of goodwill are recognised in consolidated profit or loss and are not subsequently reversed. Goodwill is allocated to cash-generating units that are expected to benefit from the synergies of the acquisition for the purpose of impairment testing.

The non-controlling interests in the subsidiary are initially measured at the non-controlling shareholders' proportionate share of the net fair value of the subsidiary's identifiable assets and liabilities at the acquisition date.

#### Foreign currency translation

#### (i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in HK\$, which is the Company's functional and presentation currency.

## (ii) Transactions and balances in each entity's financial statements

Transactions in foreign currencies are translated into the functional currency on initial recognition using the exchange rates prevailing on the transaction dates. Monetary assets and liabilities in foreign currencies are translated at the exchange rates at the end of each reporting period. Gains and losses resulting from this translation policy are recognised in profit or loss.



#### (iii) Translation on consolidation

The results and financial position of all the Group entities that have a functional currency different from the Company's presentation currency are translated into the Company's presentation currency as follows:

- Assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that statement of financial position;
- (ii) Income and expenses are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the exchange rates on the transaction dates); and
- (iii) All resulting exchange differences are recognised in the foreign currency translation reserve.

On consolidation, exchange differences arising from the translation of the net investment in foreign entities and of borrowings are recognised in the foreign currency translation reserve. When a foreign operation is sold, such exchange differences are recognised in consolidated profit or loss as part of the gain or loss on disposal.

Goodwill and fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entity and translated at the closing rate.

#### (iii) 綜合換算

功能貨幣與呈列貨幣與本公司不同的所有集團實體的業績及財務 狀況,均按以下方法換算為本公司的呈列貨幣:

#### Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are recognised in profit or loss during the period in which they are incurred.

Depreciation of property, plant and equipment is calculated at rates sufficient to write off their cost less their residual values over the estimated useful lives on a straight-line basis. The principal annual rates are as follows:

Plant and machinery : 25%Furniture and fixtures : 20%

Motor vehicles : 10% - 25%
 Decoration : 20% - 50%
 Office equipment : 20% - 33%

The residual values, useful lives and depreciation method are reviewed and adjusted, if appropriate, at the end of each reporting period.

The gain or loss on disposal of property, plant and equipment is the difference between the net sales proceeds and the carrying amount of the relevant asset, and is recognised in profit or loss.

#### Leases

#### The Group as lessee

Leases are recognised as right-of-use assets and corresponding lease liabilities when the leased assets are available for use by the Group. Right-of-use assets are stated at cost less accumulated depreciation and impairment losses. Depreciation of right-of-use assets is calculated at rates to write off their cost over the shorter of the asset's useful life and the lease term on a straight-line basis. The principal annual rates are as follows:

#### Land and buildings

Offices : 5% - 50%
Warehouse : 50%
Employee accommodation : 20%

Right-of-use assets are measured at cost comprising the amount of the initial measurement of the lease liabilities, lease payments prepaid, initial direct costs and the restoration costs. Lease liabilities include the net present value of the lease payments discounted using the interest rate implicit in the lease if that rate can be determined, or otherwise the Group's incremental borrowing rate. Each lease payment is allocated between the liability and finance cost. The finance cost is charged to profit or loss over the lease term so as to produce a constant periodic rate of interest on the remaining balance of the lease liability.

Payments associated with short-term leases and leases of low-value assets are recognised as expenses in profit or loss on a straight-line basis over the lease terms. Short-term leases are leases with an initial lease term of 12 months or less. Low-value assets are assets of value below US\$5,000.

#### The Group as lessor

## Operating leases

Leases that do not substantially transfer to the lessees all the risks and rewards of ownership of assets are accounted for as operating leases. Rental income from operating leases is recognised on a straight-line basis over the term of the relevant lease.

#### **Inventories**

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the first-in-first-out method. The cost of finished goods comprises raw materials, direct labour and an appropriate proportion of all production overhead expenditure, and where appropriate, subcontracting charges. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale.

# Recognition and derecognition of financial instruments

Financial assets and financial liabilities are recognised in the statement of financial position when the Group becomes a party to the contractual provisions of the instruments.

Financial assets are derecognised when the contractual rights to receive cash flows from the assets expire; the Group transfers substantially all the risks and rewards of ownership of the assets; or the Group neither transfers nor retains substantially all the risks and rewards of ownership of the assets but has not retained control on the assets. On derecognition of a financial asset, the difference between the asset's carrying amount and the sum of the consideration received is recognised in profit or loss.

Financial liabilities are derecognised when the obligation specified in the relevant contract is discharged, cancelled or expires. The difference between the carrying amount of the financial liability derecognised and the consideration paid is recognised in profit or loss.

#### 本集團作為租賃人

#### 經營和賃

並無將資產所有權的絕大部分風險及回 報轉移予承租人的租賃列為經營租賃。 經營租賃的租金收入在相關租賃期內按 直線法確認。

#### 存貨

存貨按成本及可變現淨值兩者之間的較低者列賬。成本使用先進先出法釐定。成品之成本包括原材料、直接勞動力及所有生產間接開支的適當部分及(倘適用)分包費用。可變現淨值為日常業務過程中之估計售價減完工的估計成本與達致銷售所需的估計成本。

#### 確認及終止確認金融工具

#### **Financial assets**

Financial assets are recognised and derecognised on a trade date basis where the purchase or sale of an asset is under a contract whose terms require delivery of the asset within the timeframe established by the market concerned, and are initially recognised at fair value, plus directly attributable transaction costs except in the case of investments at fair value through profit or loss. Transaction costs directly attributable to the acquisition of investments at fair value through profit or loss are recognised immediately in profit or loss.

Financial assets of the Group are classified under financial assets at amortised cost.

Financial assets (including trade and other receivables) are classified under this category if they satisfy both of the following conditions:

- the assets are held within a business model whose objective is to hold assets in order to collect contractual cash flows; and
- the contractual terms of the assets give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

They are subsequently measured at amortised cost using the effective interest method less loss allowance for expected credit losses.

#### Loss allowances for expected credit losses

The Group recognises loss allowances for expected credit losses on financial assets at amortised cost. Expected credit losses are the weighted average of credit losses with the respective risks of a default occurring as the weights.

At the end of each reporting period, the Group measures the loss allowance for a financial instrument at an amount equal to the expected credit losses that result from all possible default events over the expected life of that financial instrument ("**lifetime expected credit losses**") for trade receivables, or if the credit risk on that financial instrument has increased significantly since initial recognition.

If, at the end of the reporting period, the credit risk on a financial instrument (other than trade receivables) has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to the portion of lifetime expected credit losses that represents the expected credit losses that result from default events on that financial instrument that are possible within 12 months after the reporting period.

The amount of expected credit losses or reversal to adjust the loss allowance at the end of the reporting period to the required amount is recognised in profit or loss as an impairment gain or loss.

#### Cash and cash equivalents

For the purpose of the statement of cash flows, cash and cash equivalents represent cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term highly liquid investments which are readily convertible into known amounts of cash and subject to an insignificant risk of change in value. Bank overdrafts which are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents.

#### Financial liabilities and equity instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under HKFRSs. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

#### **Borrowings**

Borrowings are recognised initially at fair value, net of transaction costs incurred, and subsequently measured at amortised cost using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period.

#### Trade and other payables

Trade and other payables are stated initially at their fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

#### **Equity instruments**

Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

Revenue is measured based on the consideration specified in a contract with a customer with reference to the customary business practices and excludes amounts collected on behalf of third parties. For a contract where the period between the payment by the customer and the transfer of the promised product or service exceeds one year, the consideration is adjusted for the effect of a significant financing component.

The Group recognises revenue when it satisfies a performance obligation by transferring control over a product or service to a customer. Depending on the terms of a contract and the laws that apply to that contract, a performance obligation can be satisfied over time or at a point in time. A performance obligation is satisfied over time if:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance;
- the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced; or
- the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If a performance obligation is satisfied over time, revenue is recognised by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the product or service.

#### Other revenue

Interest income is recognised on a time-proportion basis using the effective interest method.

Rental income is recognised on a straight-line basis over the lease term.

#### **Employee benefits**

#### (i) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

#### (ii) Pension obligations

The Group contributes to defined contribution retirement schemes which are available to all employees. Contributions to the schemes by the Group and employees are calculated as a percentage of employees' basic salaries. The retirement benefit scheme cost charged to profit or loss represents contributions payable by the Group to the funds.

#### (iii) Termination benefits

Termination benefits are recognised at the earlier of the dates when the Group can no longer withdraw the offer of those benefits and when the Group recognises restructuring costs and involves the payment of termination benefits.

#### **Share-based payments**

The Group issues equity-settled share-based payments to certain directors.

Equity-settled share-based payments to directors are measured at the fair value (excluding the effect of non market-based vesting conditions) of the equity instruments at the date of grant. The fair value determined at the grant date of the equity-settled share-based payments is expensed on a straight-line basis over the vesting period, based on the Group's estimate of shares that will eventually vest and adjusted for the effect of non market-based vesting conditions.

#### **Borrowing costs**

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

To the extent that funds are borrowed generally and used for the purpose of obtaining a qualifying asset, the amount of borrowing costs eligible for capitalisation is determined by applying a capitalisation rate to the expenditures on that asset. The capitalisation rate is the weighted average of the borrowing costs applicable to the borrowings of the Group that are outstanding during the period, other than borrowings made specifically for the purpose of obtaining a qualifying asset.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

#### **Taxation**

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences, unused tax losses or unused tax credits can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rates that have been enacted or substantively enacted by the end of the reporting period. Deferred tax is recognised in profit or loss, except when it relates to items recognised in other comprehensive income or directly in equity, in which case the deferred tax is also recognised in other comprehensive income or directly in equity.

The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis.

#### **Related parties**

A related party is a person or entity that is related to the Group.

- (A) A person or a close member of that person's family is related to the Group if that person:
  - (i) has control or joint control over the Group;
  - (ii) has significant influence over the Group; or
  - (iii) is a member of the key management personnel of the Company or of a parent of the Company.

#### Segment reporting

Operating segments and the amounts of each segment item reported in the financial statements are identified from the financial information provided regularly to the Group's most senior executive management for the purpose of allocating resources and assessing the performance of the Group's various lines of business.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of productions processes, the type or class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

#### Impairment of assets

Intangible assets that have an indefinite useful life or not yet available for use are reviewed annually for impairment and are reviewed for impairment whenever events or changes in circumstances indicate the carrying amount may not be recoverable.

At the end of each reporting period, the Group reviews the carrying amounts of its tangible and other intangible assets except goodwill, inventories and receivables to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of any impairment loss. Where it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash generating unit to which the asset belongs.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

If the recoverable amount of an asset or cash-generating unit is estimated to be less than its carrying amount, the carrying amount of the asset or cash-generating unit is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the impairment loss is treated as a revaluation decrease.

Where an impairment loss subsequently reverses, the carrying amount of the asset or cash-generating unit is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined (net of amortisation or depreciation) had no impairment loss been recognised for the asset or cash-generating unit in prior years. A reversal of an impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the reversal of the impairment loss is treated as a revaluation increase.

#### **Provisions and contingent liabilities**

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably. the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or nonoccurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

#### **Events after the reporting period**

Events after the reporting period that provide additional information about the Group's position at the end of the reporting period or those that indicate the going concern assumption is not appropriate are adjusting events and are reflected in the financial statements. Events after the reporting period that are not adjusting events are disclosed in the notes to the financial statements when material.



# 4. CRITICAL JUDGEMENTS AND KEY ESTIMATES

#### Key sources of estimation uncertainty

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

#### (a) Impairment loss for bad and doubtful debts

The Group makes impairment loss for bad and doubtful debts based on assessments of the recoverability of the trade and other receivables, including the current creditworthiness and the past collection history of each debtor. Impairments arise where events or changes in circumstances indicate that the balances may not be collectible. The identification of bad and doubtful debts requires the use of judgement and estimates. Where the actual result is different from the original estimate, such difference will impact the carrying value of the trade and other receivables and doubtful debt expenses in the year in which such estimate has been changed. If the financial conditions of the debtors were to deteriorate, resulting in an impairment of their ability to make payments, additional allowances may be required.


The Group determines the estimated useful lives, residual values and related depreciation charges for the Group's property, plant and equipment. This estimate is based on the historical experience of the actual useful lives and residual values of property, plant and equipment of similar nature and functions. The Group will revise the depreciation charge where useful lives and residual values are different to those previously estimated, or it will write-off or write-down technically obsolete or non-strategic assets that have been abandoned or sold. Property, plant and equipment are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount of the assets exceeds its recoverable amount. The recoverable amount is determined with reference to the present value of estimated future cash flows. Where the future cash flows are less than expected or there are unfavourable events and change in facts and circumstance which result in revision of future estimate cash flows, a material impairment loss may arise.

#### 5. FINANCIAL RISK MANAGEMENT

The Group's activities expose it to a variety of financial risks: foreign currency risk, credit risk, liquidity risk and interest rate risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

#### (a) Foreign exchange risk

The Group has minimal exposure to foreign currency risk as most of its business transactions, assets and liabilities are principally denominated in the functional currencies of the Group entities. The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group will monitor its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

#### (b) Credit risk

The carrying amount of the bank and cash balances and trade and other receivables included in the consolidated statement of financial position represents the Group's maximum exposure to credit risk in relation to the Group's financial assets.

The credit risk on bank and cash balances is limited because the counterparties are banks with high creditratings assigned by international credit-rating agencies.

The Group's maximum exposure to credit risk in the event that counterparties fail to perform their obligations at the end of the reporting period in relation to each class of recognised financial assets is the carrying amounts of those assets as stated in the consolidated statement of financial position. The Group's credit risk is primarily attributable to its trade and other receivables. In order to minimise credit risk, the Directors review the recoverable amount of each individual receivable regularly to ensure that adequate impairment losses are recognised for irrecoverable receivable. In this regard, the Directors consider that the Group's credit risk is significantly reduced.

The Group considers whether there has been a significant increase in credit risk of financial assets on an ongoing basis throughout each reporting period by comparing the risk of a default occurring as at the reporting date with the risk of default as at the date of initial recognition. It considers available reasonable and supportive forwarding-looking information. Especially the following information is used:

- internal credit rating;
- external credit rating (if available);
- actual or expected significant adverse changes in business, financial or economic conditions that are expected to cause a significant change to the borrower's ability to meet its obligations;
- actual or expected significant changes in the operating results of the borrower;
- significant increases in credit risk on other financial instruments of the same borrower; and
- significant changes in the expected performance and behaviour of the borrower, including changes in the payment status of borrowers.

Financial assets are written off when there is no reasonable expectation of recovery, such as a debtor failing to engage in a repayment plan with the Group. The Group normally categorises a loan or receivable for write off when a debtor fails to make contractual payments greater than 360 days past due. Where loans or receivables have been written off, the Group, if practicable and economical, continues to engage in enforcement activity to attempt to recover the receivable due.

#### (c) Liquidity risk

The Group's policy is to regularly monitor current and expected liquidity requirements to ensure that it maintains sufficient reserves of cash to meet its liquidity requirements in the short and longer term.



#### Construction service fee income

The Group provides construction service to the customers. When the progress towards complete satisfaction of the performance obligations of a construction contract can be measured reasonably, revenue from the contract and the contract costs are recognised using the percentage of completion method, measured by reference to the percentage of contract costs incurred to date to the estimated total contract costs for the contract. This method provides the most reliable estimate of the percentage of completion.

When the progress towards complete satisfaction of the performance obligations of a construction contract cannot be measured reasonably, revenue is recognised only to the extent of contract costs incurred that is expected to be recoverable.

The customers pay the contract prices to the Group according to the payment schedules as stipulated in the contracts. If the service rendered by the Group exceeds the payments, a contract asset is recognised. If the payments exceed the service rendered, a contract liability is recognised.

The contract price is allocated to the performance obligations based on the relative stand-alone selling prices of the performance obligations. The stand-alone selling prices are determined by applying the expected cost plus a margin approach.



The key assumptions for the discount cash flow method are those regarding the discount rates, growth rates and budgeted gross margin and revenue during the period. The Group estimates discount rates using pre-tax rates that reflect current market assessments of the time value of money and the risks specific to the CGUs. The growth rates are based on long-term average economic growth rate of the geographical area in which the businesses of the CGUs operate. Budgeted gross margin and revenue are based on past practices and expectations on market development.

The Group prepares cash flow forecasts derived from the most recent financial budgets approved by the directors for the next five years with the residual period using the growth rate of 5% (2020: 5%). This rate does not exceed the average long-term growth rate for the relevant markets.

The rate used to discount the forecast cash flows from the Group's manufacturing and trading of prefabricated precast construction components is 18% (2020: 18%).





### 28. SHARE OPTION SCHEME

The Company operates a share option scheme (the "Scheme") for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Eligible participants include the full-time and part-time employees, executives, officers, directors, business consultants, agents, legal and financial advisers of the Company and the Company's subsidiaries. The Scheme became effective on 2 August 2014 and refreshed on 2 June 2017 and 8 June 2018, respectively, unless otherwise cancelled or amended, will remain in force for 10 years from that date.

The maximum number of unexercised share options currently permitted to be granted under the Scheme is an amount equivalent, upon their exercise, to 10% of the shares of the Company in issue at any time. The maximum number of shares issuable under share options to each eligible participant in the Scheme within any 12-month period, is limited to 0.1% of the shares of the Company in issue at any time. Any further grant of shares options in excess of this limit is subject to shareholders' approval in a general meeting.

Share options granted to a director, chief executive or substantial shareholder of the Company, or to any of their associates, are subject to approval in advance by the independent non-executive directors. In addition, any share options granted to a substantial shareholder or an independent non-executive director of the Company, or to any of their associates, in excess of 0.1% of the shares of the Company in issue at any time or with an aggregate value (based on the price of the Company's shares at the date of the grant) in excess of HK\$5 million, within any 12-month period, are subject to shareholders' approval in advance in a general meeting.

Share options do not confer rights on the holder to dividends or to vote at shareholders' meetings.


