**DELAY IN PUBLICATION OF 2021 AUDITED ANNUAL RESULTS AND  
PUBLICATION OF 2021 UNAUDITED ANNUAL RESULTS**

The board of directors of the Company (the “**Board**”) announces that at a meeting of the Board scheduled to be held on Thursday, 31 March 2022 will now be considering and approving the publication of unaudited annual results based on the consolidated management accounts of the Company for the year ended 31 December 2021.

As set out in the Company’s announcement dated 16 March 2022, it was originally planned that the Board would consider and approve the final audited results of the Group for the year ended 31 December 2021 agreed with the Company’s auditors (“**Audited Annual Results**”). However, additional time is required in obtaining information requested by the Company’s auditors regarding the appraised value of the security provided by the Company’s immediate holding company Nan Hai Corporation Limited and its subsidiaries (“**Nan Hai Group**”) to the Group for the loans owing by the Nan Hai Group to the Group.

For the reason mentioned above, the Company is unable to publish an Audited Annual Results announcement by 31 March 2022 in accordance with Rule 13.49 of the Listing Rules.

The Company will publish the Audited Annual Results upon completion of the audit process as soon as practicable after the outstanding information mentioned has been obtained. Further announcement will be made by the Company as and when appropriate.

## **SUSPENSION OF TRADING**

It is expected that trading in the Company's shares on The Stock Exchange of Hong Kong Limited will be suspended with effect from 9:00 a.m. on 1 April 2022 pending the publication of Audited Annual Results.

**Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.**
