Chairman's Statement

Chairman's Statement

面對新時代農資行業發展的 新要求, 本集團唯有加快產品迭代、 技術創新,加強核小競爭力,方能 實現企業長遠持續發展。

感謝大家長期以來對世紀陽光集團控股有限公司(「本公司」,連同其附屬公司,統稱「世紀陽光」或「本集團」)的 信任與支持。本人謹代表本公司董事(「董事」)會(「董事會」),欣然提呈本集團截至2021年12月31日止年度(「年 內1)之全年業績以供各位利益相關者審閱

行業回顧

2021年,全球疫情仍在蔓延,中國本土疫情呈零星散發和局部聚集性疫情交織叠加態勢,防控形勢嚴峻複雜 德爾塔、奧密克戎等變異病毒再次給全球經濟復蘇蒙上陰影,能源危機、極端天氣與自然災害頻發,衝擊著各 行各業,農資行業也未能獨善其身

2021年,能源價格飆漲的同時,也帶動了大宗商品大幅漲價,例如歐洲地區尿素價格同比漲幅超過270%,化肥 價格達到近十年的歷史高位。加之中國政府發布「2021年上半年各地區能耗雙控目標完成情況晴雨表」(「能耗雙 控 | 政策) , 部分地區肥料生產企業受到該政策的影響, 減產、停產、實施設備轉型升級。

在新冠肺炎疫情持續反覆、「能耗雙控」和原材料漲價的多重不利因素之下,肥料行業供應端的生產經營受到影響。 同時,市場需求抵觸高價的心理極為濃厚。 因為肥料價格隨著原料調漲而水漲船高,經銷商和農戶多持觀望態度 市場旺季不旺,購銷氣氛低迷,肥料生產企業備受壓力。

In response to the new demand arising from the development of the agricultural industry in the new era, the Group must accelerate its product upgrade, pursue its technology innovation, and enhance its core competitiveness to achieve sustainable development of the enterprise.

I would like to thank all for the unfailing support and total confidence in Century Sunshine Group Holdings Limited (the "Company" and together with its subsidiaries, "Century Sunshine" or the "Group"). On behalf of the board (the "Board") of directors (the "Directors") of the Company, I am pleased to present the annual results for the year ended 31 December 2021 (the "Year") of the Group for the perusal of our stakeholders.

INDUSTRY REVIEW

In 2021, with the continued spread of the pandemic worldwide, as well as the sporadic outbursts and regional clusters of COVID-19 cases in China, the world was confronted with severe and complex prevention and control challenges. The emergence of new variants such as Delta and Omicron cast a shadow over the recovery of the global economy. The energy crisis, extreme weather, and frequent natural disasters have impacted all industries, among which the agricultural industry was no exception.

In 2021, the surge in energy prices also led to a substantial increase in commodity prices. For example, the price of Urea in Europe recorded a year-on-year increase of over 270%, while the price of chemical fertiliser reached a historical record high for the last ten years. In addition, in light of the "Barometer of Completion of the Dual Control of Total Energy Consumption and Energy Intensity in All regions in H12021" (「2021年上半年各地區能耗 雙控目標完成情況晴雨表」) (the "Dual Control of Total Energy Consumption and Energy Intensity" policy) issued by the Chinese government, fertiliser producers in certain regions reduced output, suspended production, or implemented equipment transformation and upgrade.

Due to several negative factors resulting from the sustained and repeated pandemic, the "Dual Control of Total Energy Consumption and Energy Intensity" policy, and the rising raw material prices, the production and operation of fertiliser suppliers were affected. Meanwhile, the market resists high price. Most of the distributors and farmers adopted a wait-and-see approach due to the sharply increased fertilisers' prices as a result of rising raw material prices. The poor market performance in peak season and the dampened transaction sentiment put fertiliser producers under great pressure.

產品「更新迭代 推陳出新 |



中國經濟發展方式發生了根本性變化,由高速增長向高質量發展轉變。同樣,肥料行業也進入了轉變發展方式、優化經濟結構、轉換增長動力的關鍵期,在「碳達峰。碳中和」的大背景下,推動肥料行業向科技型、高環保的健康方向發展。本集團自2000年成立以來,一直致力於新型綠色肥料的研發和推廣,與中國國家政策「化肥使用量零增長」、「有機肥替代化肥」以及綠色低碳發展戰略相呼應。面對新時代農資行業發展的新要求,本集團唯有加快產品迭代、技術創新,加強核心競爭力,方能實現企業長遠持續發展。於2021年,本集團著重推出海藻肥、腐植酸肥、水溶肥、液體肥等新品類新系列。功能性肥料主要作用於土壤改良、作物提質、肥效提升等,在傳統配方中添加海藻酸、腐植酸、聚谷氨酸等功能性成分,達到提質增效的目的。而水溶肥和液體肥,可採用水肥同施,以水帶肥,實現了水肥一體化,吸收效率顯著提升,肥效快,節水省水,節約人力成本,達到解決土壤問題、適合作物需求、滿足農戶期望的效果。

鎂產品板塊「揚帆起航 蓄力前行」



本集團另一主營板塊鎂產品業務,是由本集團子公司一稀鎂科技集團控股有限公司(「稀鎂科技」)運營。受原材料成本的大幅漲價以及「能耗雙控」政策的實施,鎂價格過山車式的波動行情,使得客戶持觀望態度,謹慎下單,需求走弱。雖然短期內,鎂產業受壓,但是鎂下游應用不斷擴展的大趨勢不會改變。鎂將助力下游產品輕量化,達至節能減排,符合中國政府「碳達峰●碳中和」的大目標。稀鎂科技子公司一新疆騰翔獲認定為國家級「高新技術企業」,擁有22項高性能鎂合金生產工藝和製備方法的技術專利,採用中國政府工信部等部門多次鼓勵推廣的竪罐還原工藝創新技術,取得理想運行效果。

稀鎂科技自2020年7月向百慕達最高法院(「百慕達法院」)申請委任臨時清盤人,經過一年半多的時間,於2022年3月1日,稀鎂科技提出的債權人計劃獲得了法定所需的多數計劃債權人的批准。接下來,稀鎂科技將按照百慕達法院及其他相關法定機構的程序和要求解除臨時清盤狀態,重回健康發展軌道。



PROMOTING PRODUCT UPGRADE AND INNOVATION



The development pattern of the PRC economy has undergone profound changes by shifting from high growth to high-quality development. At the same time, the fertiliser industry has also entered into a critical stage of transformation towards the new development pattern, the optimised economic structure, and the new source of growth. Against the backdrop of achieving "Carbon Peak and Carbon Neutrality", efforts have been made to promote the healthy development of the fertiliser industry through technology empowerment and environmental protection. Since its establishment in 2000, the Group has been committed to developing and promoting new green fertilisers, which was in line with the national policies of "Zero Growth of Chemical Fertilisers Use" and "Replacing Chemical Fertilisers with Organic Fertilisers", as well as the green and low-carbon development strategy. In response to the new demand arising from the development of the agricultural industry in the new era, the Group must accelerate its product upgrade, pursue its technology innovation, and enhance its core competitiveness to achieve sustainable development of the enterprise. In 2021, the Group has launched a number of new products and new series such as seaweed fertilisers, humic acid fertilisers, water-soluble fertilisers, and liquid fertilisers. The functional fertilisers are mainly used to improve soil ecology, boost crop quality and increase the effectiveness of fertilisers. Applying functional elements such as alginic acid, humic acid, and polyalutamic acid to the traditional formula will improve the quality and effectiveness of fertiliser products. In addition, water-soluble fertilisers and liquid fertilisers allow simultaneous application of water and fertilisers. The deep placement of fertilisers with water downward infiltrating achieves the water and fertiliser integration. It significantly improves the efficiency of fertiliser conversion, increases the effectiveness of fertilisers, reduces water consumption, and cuts labour costs. Thereby it addresses the soil issue, meets the needs of crop growth, and satisfies the farmers' expectation for fertiliser effectiveness.

FACILITATING DEVELOPMENT OF MAGNESIUM PRODUCT SEGMENT



The Group's another main segment, the magnesium product business, is operated by the Group's subsidiary, Rare Earth Magnesium Technology Group Holdings Limited ("REMT"). In light of the sharp fluctuations in magnesium price as a result of the substantial increase in raw materials' costs and the implementation of the "Dual Control of Total Energy Consumption and Energy Intensity" policy, the customers adopted a wait-and-see approach and became cautious in placing new orders, leading to the weakened market demand. Although the magnesium industry may be under pressure in the short term, the trend of expanding the application of magnesium-related products in the downstream industries will not be affected. The magnesium will facilitate the lightweight transformation of downstream products to achieve energy conservation and emission reduction, in turn contributing to the goal of "Carbon Peak and Carbon Neutrality" set by the Chinese government. Xinjiang Tengxiang, a subsidiary of REMT, was recognised as a national "High and Advanced Technology Enterprise". It owns 22 technical patents of the production technology and manufacturing methods for high-performance magnesium alloys, and adopts the innovative vertical retorts smelting technology, operating with satisfactory effect. It has been encouraged and promoted repeatedly by the Ministry of Industry and Information Technology and other authorities of the Chinese government.

REMT applied the appointment of the provisional liquidators to the Supreme Court of Bermuda (the "Bermuda Court") in July 2020. After its efforts over the past one and a half years, the creditors' scheme proposed by REMT was approved by the requisite statutory majorities of the scheme creditors on 1 March 2022. Subsequently, REMT will be taken out of provisional liquidation according to the procedures and requirements of the Bermuda Court and other relevant statutory authorities, and returned to a healthy development state.

The Group will stay true to its original aspiration of developing green ecological products, leveraging its technological advantages of soil testing formulae. The Group will further step up its efforts in technology innovation and develop high-efficiency, dedicated and cost-effective fertiliser products, while improving its agricultural-chemical services. Capitalising on its brand influence under the brand "Yanyangtian (豔陽天)" accumulated over the past 30 years, the Group will **create a brighter future**.

業務回顧與分析

截至2021年12月31日 止全年(「年內」),本集團 整體收入達約1,331,858,000港元(2020年:約 2,151,811,000港元)。同比減少約38.1%,整 體毛利率錄得9.9%(2020年:14.1%),稅後虧 損約為1,254,102,000港元,比去年同期虧損約 984,205,000港元增加約27.4%。其中,農業肥 料業務年內收入約為904,013,000港元(2020年: 約1,378,985,000港元),同比減少約34.4%。收 入減少主要由於新冠肺炎疫情持續反復,中國 政府採取最嚴格的防控措施,工廠生產運輸方 面時有受到影響;同時,為貫徹實施「能耗雙控」 政策,工廠生產運營實行減產、停產、設備轉 型升級等方式。本集團毛利減少與肥料生產的 原材料大幅漲價息息相關。原材料的漲價與全 球能源危機以及環球局勢一脈相連。肥料價格 隨著原料調漲而水漲船高,經銷商和農戶多持 觀望態度,市場旺季不旺,購銷氣氛低迷。加 之,本集團正在進行境外債務重組,營運資金 及營運規模皆受阻。因此,由於受到以上多種 內外部因素的叠加影響,中短期內,本集團的 生產運營繼續承壓。

本集團通過「稀鎂科技」持有之鎂產品業務,年內收入為約416,060,000港元(2020年:約744,836,000港元),同比減少約44.1%,平均毛利率約16.5%(2020年:17.5%)。稀鎂科技的銷售收入減少主要由於鎂價格過山車式的波動行情,使得下游加工及應用企業多持觀望態度,謹慎下單,需求走弱。同時,稀鎂科技境外債務重組的影響導致其營運資金持續受制約。

BUSINESS REVIEW AND ANALYSIS

Throughout the year ended 31 December 2021 (the "Year"), the Group recorded an overall revenue of approximately HK\$1,331,858,000 (2020: approximately HK\$2,151,811,000), representing a year-on-year decrease of approximately 38.1%, with an overall gross profit margin of 9.9% (2020: 14.1%). The loss after tax was approximately HK\$1,254,102,000, representing an increase of approximately 27.4% as compared with a loss of approximately HK\$984,205,000 for the same period of last year. Revenue from the fertiliser business during the Year was approximately HK\$904,013,000 (2020: approximately HK\$1,378,985,000), representing a year-on-year decrease of approximately 34.4%. Such decrease in revenue was mainly attributable to the constant impact on the production and transportation at the plants due to the most rigorous pandemic prevention and control measures adopted by the Chinese government as a result of repeated outbursts of the pandemic. Meanwhile, in response to the "Dual Control of Total Energy Consumption and Energy Intensity" policy, the plants implemented a series measures such as production reduction, production suspension and equipment transformation and upgrade. The decrease in gross profit of the Group was closely related to the substantial increase of raw material prices for fertiliser production. The increase in raw material prices was due to the global energy crisis and global environment. Most of the distributors and farmers adopted a wait-and-see approach due to the sharply increased fertilisers' prices as a result of rising raw material prices. Hence, the market performance in peak season was poor, and the transaction sentiment was dampened. In addition, since the Group was undergoing offshore debt restructuring, the Group's working capital liquidity and operating scale has been hampered. Therefore, due to the combined effects of various internal and external factors mentioned above, the production and operation of the Group will continue to be under pressure in the short and medium terms.

Revenue from the magnesium product business held by the Group through REMT was approximately HK\$416,060,000 (2020: approximately HK\$744,836,000) during the Year, representing a year-on-year decrease of approximately 44.1%. Average gross profit margin was approximately 16.5% (2020: 17.5%). For REMT, the decrease in sales revenue was mainly due to the sharp fluctuations in magnesium price, which have led to a wait-and-see approach adopted by most downstream processing and applied companies. They placed orders cautiously, resulting in weaker demand. Meanwhile, the influence of the offshore debt restructuring has led to the lingering constraints to REMT's working capital.

山東紅日「退城入園 |

山東紅日化工股份有限公司(「山東紅日」)響應和配合臨沂市羅莊區政府關於企業「退城入園」(「項目」)的要求,並享受山東省政府「退城入園」相關政策。自項目啟動至今,全部廠房已拆遷,山東紅日正持續與地方政府相關部門商討進一步的操作方案,推進項目盡快實施。

根據山東省政府「退城入園」的相關政策,山東 紅日在按時完成項目後可把原廠址所處的土地, 由工業用地依法報批改變用途,本公司有望受 益於土地變性後的增值收益,實現額外收益, 惟最終變更將視乎中國相關政府部門的批准。

展望

肥料在農業生產中的剛需地位和中國政府的政 策支持、以及本集團深耕二十餘年的差異化優 勢產品綠色生態肥料,都是我們砥礪奮進、迎 難而上的堅實底氣。新冠肺炎疫情的不斷反覆, 導致很多國家出現食品短缺,一些糧食出口國, 開始限制糧食出口。在當前及未來,和糧食相 關的農資市場將面臨著巨大的發展機遇。確保 糧食穩產和高產都離不開肥料,肥料對糧食產 量的貢獻率高達50%以上。本集團自成立以來 研發生產的綠色生態肥料,具有改善土壤狀況 和提高肥料利用率,促進作物增產增收及改良 作物品質等功能。我們相信在後疫情時代,人 們對健康食品需求的不斷增加,也將促進綠色 生態肥料的市場需求,「讓作物更高產,讓土壤 更肥沃」,始終是我們永恆的使命。做大肥料產 業,引領生態肥料行業發展,始終是我們世紀 陽光人不懈的追求。

"RELOCATION OF INDUSTRIES FROM CITY URBAN AREA TO INDUSTRIAL PARKS" BY SHANDONG HONGRI

Shandong Hongri Chemical Joint Stock Company Limited ("Shandong Hongri") has cooperated with Luozhuang District Government of Linyi City to respond to the requirements of "Relocation of Industries from City Urban Area to Industrial Parks" ("the Plan"). Shandong Hongri is benefited from the relevant policies of the Shandong Provincial Government on the Plan. All plants have been demolished since the launch of the Plan. Shandong Hongri is persistently discussing with the local authorities for further instructions to propel the implementation of the Plan as soon as possible.

In accordance with the relevant policies of the Shandong Provincial Government on the Plan, Shandong Hongri can change the industrial use of the land where the plant was originally located according to the law upon obtaining approval after completion of the Plan as scheduled. The Company expects to benefit from the value appreciation after the change of use of the land, and reap additional gains. But the change of land use will eventually hinge upon the approval of relevant authorities in the PRC.

PROSPECT

We have the confidence to forge ahead and overcome difficulties because of the rigid demand of fertilisers in agricultural production, the policy support from the Chinese Government, and the Group's differentiated superior products, the green ecological fertilisers, which we have been exploring for more than 20 years. The repeated outbreak of COVID-19 has caused food shortages in many countries. Some food-exporting countries have begun to restrict food exports. At present and in the future, the market for agricultural materials related to the grain will face great development opportunities. Fertilisers, which have a high contribution rate of over 50% to the grain production, are indispensable for the stable production and high yield of grain. The green ecological fertiliser developed and produced by the Group since its establishment helps improve soil conditions and fertiliser utilisation rate, and enhance crop yield and quality. We believe that in the post-epidemic era, people's increasing demand for healthy food will also promote the market demand for green ecological fertilisers. "Enhancing Crop Productivity and Soil Fertility" is always our eternal mission. To expand the fertiliser industry, leading the development of green fertiliser is the unremitting pursuit of Century Sunshine.

營運收入及毛利

集團兩項主營業務:農業肥料業務及鎂產品業務收入貢獻佔比和去年相若,分別為67.9%及31.2%(2020年:64.1%及34.6%)。

年內,農業肥料業務收入約為904,013,000港元(2020年:約1,378,985,000港元),同比減少約34.4%。收入減少主要由於本集團正在進行境外債務重組,因此本集團的營運資金及營運規模皆受阻。另疫情防控措施、「能耗雙控」政策及原材料價格持續波動上漲,進一步損害了本集團的經營效益。因此肥料總銷量同比下降約47.0%。整體毛利率減少5.1個百分點至7.7%。

年內,鎂產品業務收入約為416,060,000港元 (2020年:約744,836,000港元),同比減少約44.1%;整體毛利率減少1百份點至16.5%。收入減少主要是由於稀鎂科技境外債務重組的影響導致其營運資金持續受制約。自2020年7月稀鎂科技向百慕達最高法院申請以債務重組為目的之臨時清盤以來,由於境外債務重組的影響以及原料成本上升,供應商和客戶對下單更加謹慎。

OPERATING INCOME AND GROSS PROFIT

Contribution of revenue by our Group's dual core businesses: fertiliser business and magnesium product business accounted for similar proportion as last year, representing 67.9% and 31.2% (2020: 64.1% and 34.6%) respectively.

During the Year, the revenue of fertiliser business was approximately HK\$904,013,000 (2020: approximately HK\$1,378,985,000), representing a year-on-year decrease of approximately 34.4%. The decrease in revenue was mainly because that, given the Group is undergoing offshore debt restructuring, the Group's working capital liquidity and operating scale have been hampered. Besides, the pandemic prevention and control measures, "Dual Control of Total Energy Consumption and Energy Intensity" policy together with the continuing fluctuating and increasing raw material prices further impaired the Group's efficiency. As such, the total sales volume of our fertiliser decreased by approximately 47.0% on a year-on-year basis, and the gross profit margin decreased by 5.1 percentage points to 7.7%.

During the Year, the revenue of magnesium product business was approximately HK\$416,060,000 (2020: approximately HK\$744,836,000), representing a year-on-year decrease of approximately 44.1%. The overall gross profit margin decreased by 1 percentage point to 16.5%. The decrease in revenue was mainly due to the lingering constraints to the working capital of REMT as a result of the influence of its offshore debt restructuring. Since REMT applied to the Supreme Court of Bermuda for provisional liquidation for debt restructuring purpose in July 2020, suppliers and customers have been more cautious about placing orders due to the impact of the offshore debt restructuring and the increased costs of raw materials.

銷售及市場推廣費用

銷售及市場推廣費用約為34,377,000港元(2020年:約55,377,000港元),佔收入約2.6%(2020年:2.6%)。主要包括市場業務費用、銷售人員工資及銷售運輸費用。其降幅與收入一致。

行政開支

行政支出主要包括員工薪酬、折舊及攤銷、審核及專業費用等費用。本年度之行政開支約為205,813,000港元(2020年:約237,492,000港元),同比減少約13.3%,本集團正進行境外債務重組,因此致力減省費用。

財務費用

財務費用約為200,301,000港元(2020年:約179,501,000港元),同比增加約11.6%。財務費用增加主要是由於本集團自2020年7月起若干債務發生交叉違約並確認違約利息所致。

OTHER GAINS OR LOSSES, NET

Other net gains or losses were approximately HK\$50,533,000 (2020: approximately HK\$60,309,000), representing a decrease of approximately 16.2% year-on-year, which were mainly resulted from the decrease in government grant. In last year, a discretionary government grant of approximately HK\$19,020,000 for the "Relocation of industries from City Urban Area to Industrial Parks" to Shandong Hongri from the PRC government was recognised by the Group, while there was no such grant for current year.

SELLING AND MARKETING COSTS

Selling and marketing costs were approximately HK\$34,377,000 (2020: approximately HK\$55,377,000), accounting for approximately 2.6% (2020: 2.6%) of revenue, which mainly consisted of market operating expenses, sales staff salaries, and sales and distribution expenses. Its decrease was in line with that of revenue.

ADMINISTRATIVE EXPENSES

Administrative expenses mainly included staff remuneration, depreciation and amortisation, auditing and professional expenses. Administrative expenses for the Year were approximately HK\$205,813,000 (2020: approximately HK\$237,492,000), representing a decrease of approximately 13.3% year-on-year. The Group is undergoing offshore debt restructuring and is therefore striving to reduce expenses.

FINANCE COSTS

Finance costs were approximately HK\$200,301,000 (2020: approximately HK\$179,501,000), representing an increase of approximately 11.6% year-on-year. The increase in finance costs was mainly due to the default interests recognised for the cross default of certain debts of the Group since July 2020.

所得稅抵免/(開支)

INCOME TAX CREDIT/(EXPENSE)

Income tax for the year was a tax credit of approximately HK\$5,605,000 (2020: tax expenses of approximately HK\$56,222,000), which comprised of current tax expenses of approximately HK\$14,965,000 (2020: approximately HK\$35,901,000) and a deferred tax credit of approximately HK\$20,570,000 (deferred tax expenses of approximately HK\$20,321,000). During the year, current tax has decreased by 58.3% year-on-year as a result of decrease in revenue. Besides, certain non-current assets have been impaired for the Year, resulting in a decrease of its related deferred tax liabilities and a deferred tax credit therefore being recognised in the consolidated statement of profit and loss, while in last year, certain properties, plant and equipment have been written-off and its related deferred tax assets was therefore recognised as deferred tax expenses in the consolidated statement of profit and loss.

MATERIAL ITEMS CONTRIBUTED TO LOSS FOR THE YEAR

During the Year, the Group recognised the following write-off, impairment and allowance on assets in aggregate of HK\$1,010,173,000 (2020: HK\$853,464,000):

1. Impairment of non-current assets

During the year ended 31 December 2021, the management of the Group reviewed that two cash-generating unit of the Group, fertiliser business and metallurgical flux business segment ("CGU 1") and magnesium product business segment ("CGU 2") underperformed and incurred losses due to the constraints to working capital and offshore debt restructuring of the Group.

鑒於現金產生單位1及現金產生單位2之經濟表現未如預期,本集團管理層認為存在減值跡象,並對賬面值分別為232,958,000港元、3,408,172,000港元及291,125,000港元之使用權資產、物業、廠房及設備以及無形資產進行減值評估。

當無法個別估計可收回金額時,本集團估計資產所屬現金產生單位1及現金產生單位2之可收回金額,包括於可設定合理一致之基準時分配公司資產。各現金產生單位為本集團於相關地理位置之生產業務營運。現金產生單位1及現金產生單位2資產之賬面值分別為約2,642,500,000港元及1,750,470,000港元。

To cope with the "Dual Control of Total Energy Consumption and Energy Intensity" policy, the plants implemented a series measures such as production reduction, production suspension and equipment transformation and upgrade. In addition, as affected by fluctuations of international commodity prices due to the global energy crisis and global environment, the prices of raw and auxiliary materials for CGU 1 and CGU 2 in China have increased significantly. Most of the customers adopted a wait-and-see approach due to the sharply increased fertilisers' and magnesium's prices as a result of rising raw material prices. The market performance in peak season was poor, and the transaction sentiment was dampened. Subject to the combined effects of both internal and external factors mentioned above, the production and operation of the Group will continue to be under pressure in the short and medium terms.

In view of the economic performance of the CGU 1 and CGU 2 which was not as expected, management of the Group concluded there was an indication for impairment and conducted impairment assessment on right-of-use assets, property, plant and equipment, and intangible assets with carrying amounts of HK\$232,958,000, HK\$3,408,172,000 and HK\$291,125,000 respectively.

The Group estimates the recoverable amount of CGU1 and CGU2, to which the asset belongs when it is not possible to estimate the recoverable amount individually, including allocation of corporate assets when reasonable and consistent basis can be established. Each cash-generating unit represents the Group's manufacturing operation in respective geographical locations. The carrying amounts of assets of CGU1 and CGU 2 were approximately HK\$2,642,500,000 and HK\$1,750,470,000 respectively.

CGU 1

The recoverable amount of CGU1 has been determined based on a value in use calculation. That calculation uses cash flow projections based on financial budgets approved by the management of the Group covering the following 5 years as at 31 December 2021 with an expected pre-tax discount rate of 14.84% and the corporate tax rate of 25%. The cash flows beyond the five-year period are extrapolated using 2% growth rate. This growth rate is based on the relevant industry growth forecasts and does not exceed the average long-term growth rate for the relevant industry. Another key assumption for the value in use calculated is the budgeted gross margin with a range of approximately 11% to 22%, which is determined based on the cash-generating units' past performance and management expectations for the market development.

CGU 2

The recoverable amount of CGU 2 has been determined based on a value in use calculation. That calculation uses cash flow projections based on financial budgets approved by the management of the Group covering the following 5 years as at 31 December 2021 with an expected pre-tax discount rate of 14.71% and the corporate tax rate of 25%. The cash flows beyond the five-year period are extrapolated using 2% growth rate, which is based on the industry growth forecasts and does not exceed the long-term average growth rate for the relevant industry. Another key assumption for the value in use calculated is the budgeted gross margin with a range of approximately 22% to 26%, which is determined based on the cash-generating unit's past performance and management expectations for the market development.

The Group engaged Roma Appraisals Limited, independent valuer, as the valuer to perform the valuations of CGU 1 and CGU 2 of the Group as at 31 December 2021.

The board of directors and audit committee of the Group considered that the basis and assumptions used for preparing the cash flow projection and the valuation methodology, basis and assumptions used for preparing the valuation report were reasonable and appropriate.

Details of the impairment of property, plant and equipment, right-of-use assets and intangible assets are disclosed in Note 22.

2. Allowance for expected credit losses on trade receivables, other receivables and deposits

Under HKFRS 9, companies are required to account for what they expect the loss to be on the day they issue the invoice and revise their estimate of that loss until the date they get paid. The concept of expected credit losses (ECLs) means that companies are required to look at how current and future economic conditions impact the amount of loss. However, it does not mean that such losses had actually occurred nor should happen in coming years. Instead, ECLs reflect information available at the reporting date and it should need to be assessed for each financial year. Independent valuers were engaged by the Group to assess the ECLs for the trade receivables, other receivable and deposits as at 31 December 2021. Affected by the ongoing COVID-19 epidemic, the Group's receivables collection was significantly delayed. Therefore, an allowance of HK\$173,111,000 (2020: HK\$147,212,000) was made for the Year.

For details, please see Notes 26 and 27 to the financial statements.

During the Year, the Group's after-tax loss was approximately HK\$1,254,102,000 (2020: HK\$984,205,000), representing an increase of approximately 27.4% year-on-year. If excluding the above non-recurring and non-cash material items contributed to loss for the year of approximately HK\$1,010,173,000 (2020: HK\$853,464,000) in aggregate, the adjusted after-tax loss from operations for the Year was approximately HK\$243,929,000, while that of last year was approximately HK\$130,741,000. The Group's overall business performance for the Year was hampered due to the pandemic prevention and control measures and the continuing fluctuating and increasing energy and raw material prices.

FINAL DIVIDEND

The Board does not recommend the payment of a final dividend for the year ended 31 December 2021 (2020: Nil).

POSSIBLE DEBT RESTRUCTURING AND THE APPOINTMENT OF JOINT PROVISIONAL LIQUIDATORS FOR RESTRUCTURING PURPOSES

Historically, the Group has enjoyed strong growth and profitability over a number of years in its fertiliser business, metallurgical flux business, and magnesium product business. However, the raging COVID-19 outbreak and the Chinese Government's epidemic prevention and control measures that are considered to be the most rigorous measures in history have led to key businesses either not operating normally or only operating on a limited basis. These conditions had resulted in decrease in orders and longer receivable collection cycles and has led to a material reduction in the Group's profitability and liquidity in the first half of 2020. The spread of the epidemic across the world, and the rising tensions between the United States of America and mainland China have adversely affected the Company's ability to refinance the Notes and other borrowings, leading to the default in the redemption of its subordinated notes in the principal amount of SGD101,750,000 that matured on 3 July 2020.

In order to facilitate a restructuring of its debts with the benefit of a statutory moratorium prohibiting the commencement or continuance of any proceedings against the Company without the leave of court, the Company has filed on 2 July 2020 (Cayman Islands time) to the Grand Court of the Cayman Islands (the "Grand Court") a winding up petition ("Petition") together with the application for the appointment of Mr. Yen Ching Wai David and Ms. So Kit Yee Anita of Ernst & Young Transactions Limited, Mr. Roy Bailey of Ernst & Young Ltd., and Ms. Tammy Karina Fu of EY Cayman Ltd. (collectively, the "JPLs") as the "light-touch" joint provisional liquidators of the Company for restructuring purposes, with the power to act jointly and severally. REMT, a subsidiary of the Company, has also made a similar application to the Supreme Court of Bermuda for the same purpose.

A "light touch" basis is that the Board will retain management of the Company and maintain the operation of the Group, while the JPLs will work alongside the Company's management to monitor, supervise, and oversee the implementation of a group-wide holistic and coordinated restructuring of its debts and liabilities including to maintain the listing of the Company on the Stock Exchange.

The JPLs Application was heard before the Grand Court on 14 July 2020 (Cayman Islands time). The Grand Court granted an order that the JPLs have been appointed with immediate effect.

On 18 August 2020, the Grand Court issued a letter of request ("LOR") to the High Court of Hong Kong for the recognition of the appointment and powers of the JPLs in Hong Kong to, inter alia, develop and propose a restructuring plan to allow the Company to continue as a going concern. The Grand Court also accepted the resignation of one of the JPLs, Mr. Yen Ching Wai David on the same day. The JPLs appointment order remains in force in respect of Mr. Roy Bailey, Ms. Tammy Karina Fu and Ms. So Kit Yee Anita as JPLs. An application has been filed by the JPLs to the High Court of Hong Kong on 26 August 2020 for the recognition of the appointment and powers of the JLPs pursuant to the LOR. On 28 August 2020, the High Court of Hong Kong has approved the said application.

本公司亦正在採取若干措施改善及加強本集團之運營管理。當中包括(i)內部資本及債務重組,以及尋求潛在投資者參與籌資計劃;及/或(ii)對資本投資及運營採取進一步之成本控制措施,以降低本集團之整體運營成本。本公司將繼續致力於爭取債權人的積極反饋,以支持計劃。

重組計劃進程如有重大進展,本公司將另行刊 登公佈。 An application has been filed by the JPLs to the High Court of the Republic of Singapore (the "Singapore High Court") on 28 October 2020 for the recognition of the appointment and powers of the JLPs pursuant to the LOR. On 30 November 2020, the Singapore High Court has approved the said application.

On 23 December 2020, the Singapore Noteholders have established the informal steering committee (the "ISC"). On 7 March 2021, the ISC has appointed an independent financial advisor (the "IFA"), who sits on the creditors' committee, together with the ISC, to proceed the follow-up work.

During the Year, the JPLs have held several creditors' committee meetings to discuss the development of the provisional liquidation and restructuring scheme. Nevertheless, any determination and implementation of such scheme shall be subject to the agreement of the requisite majorities of creditors and the applicable approval(s) of the Grand Court, the High Court of Hong Kong, and/or other relevant jurisdictions, if necessary.

As further ordered by the Grand Court, the hearing of the Petition will be adjourned to be held on Monday, 25 April 2022 (Cayman Islands time).

The Company is also taking various measures to improve and strengthen the operation and management of the Group. These measures include (i) restructuring internal capital and debt, and seeking potential investors to participate in fundraising plans; and/or (ii) taking further cost control measures on capital investment and operation to reduce the overall operating costs of the Group. The Company will continue to seek positive feedbacks from the creditors to support the scheme.

The Company will make further announcements in respect of any substantial development of the restructuring scheme.

為確保稀鎂科技於延長期限選擇權下的還款責任,在本公司建議計劃悉數及最終清償結欠本公司債權人的所有負債後,本公司將以稀鎂科技計劃公司為受益人向稀鎂科技提供一項財務援助,即稀鎂科技之建議計劃潛在還款以及潛在公司擔保。稀鎂科技債權人計劃之進一步詳情已披露於稀鎂科技之公佈。

於2022年3月1日,稀鎂科技召開的計劃會議的 續會上,稀鎂科技債權人計劃已獲得法定所需 的多數計劃債權人的批准。

認可令

根據開曼群島公司法第99章,清盤開始後就本公司財產(包括據法權產)作出的任何產權處置,以及本公司任何股份(「股份」)轉讓,或本公司成員地位的變更均屬無效,除非大法院另行命令。

經審慎考慮本公司的現時情況及事物狀況後, 董事會已尋求法律顧問的意見並認為目前無需 在此階段申請認可令。本公司將不時評估情況, 並根據情況的發展採取必要的措施。

本公司將於適當時候就涉及呈請的任何重大進 展刊發進一步公佈。

REMT CREDITORS' SCHEME

As disclosed in the REMT announcement dated 18 January 2022, REMT proposed to implement the REMT Creditors' Scheme, which comprises (i) the Term Extension Option; (ii) the Convertible Bonds Swap Option; and (iii) a combination of the aforementioned two options. Each REMT Scheme Creditor with REMT Admitted Claims is entitled, to the extent of the total value of his/her/its REMT Admitted Claim(s), to elect among options (i), (ii) and (iii) above.

In order to secure the REMT's payment obligations under the Term Extension Option, a financial assistance, namely the potential repayment under the proposed scheme of REMT and potential corporate guarantee, will be provided to REMT in favour of the REMT Scheme Company by the Company upon the full and final settlement of all liabilities owed to the Company's creditors under the Proposed Scheme of the Company. Further details on the REMT Creditors' Scheme were disclosed in the REMT announcement.

On 1 March 2022, the REMT Creditors' Scheme was approved by the requisite statutory majorities of the scheme creditors at the adjourned scheme meeting convened by REMT.

VALIDATION ORDER

Pursuant to Section 99 of the Cayman Islands Companies Law, any disposition of the property of the Company, including things in action, and any transfer of shares of the Company (the "Shares"), or alteration in the status of the members of the Company, made after the commencement of the winding up, shall, unless the Grand Court otherwise orders, be void.

The Board has sought the legal counsel's advice and after due and careful consideration of Company's current circumstances and state of affairs, it is of the view that there is currently no need to apply for a validation order at this stage. The Company will evaluate the situation from time to time and take such steps as may be required as circumstances evolve.

Further announcement(s) in relation to any material development of the Petition will be made by the Company as and when appropriate.

流動資金、負債及財務資源

本集團於2021年的流動資金主要來自年內經營業務所產生的現金。於2021年12月31日,本集團之銀行及現金結餘合共約為112,528,000港元(2020年:173,654,000港元)。

於2021年12月31日,本集團之總借貸約 為2,146,074,000港元,較2020年之約 2,140,789,000港元增加約0.2%,主要因為人民 幣升值所致。本集團於2021年之負債比率(總借 貸除資產總值)約為36.3%(2020年:30.9%)。

對持續經營不發表意見

在本公司及其附屬公司(統稱「本集團」)截至 2021年12月31日止年度之綜合財務報表中, 本公司核數師就與持續經營基準有關之重意 明朗因素出具不發表意見聲明(「不發表重見 明」),因為彼等未能取得充足適當審核 就管理層以持續經營為基準編製綜合財務報表 之適當性作出結論,這是由於管理層有關 續經營評估之未來行動計劃(「行動計劃」)業 續經營評估之未來 落實,因此彼等就本集團綜合財務報表之 對 出具不發表意見聲明。

管理層正竭盡全力於2021年協定並執行行動計劃。經考慮建議重組之成功及持續實施,管理層及董事均信納本集團將有足夠的營運資金來履行其在可預見的未來到期的財務義務,因此,按持續經營基準編製本集團綜合財務報表乃合宜之舉。根據不發表意見聲明,管理層估計本集團之財務狀況不會受到重大影響,原因是持續經營事宜可透過所制定之行動計劃解決。

LIQUIDITY, LIABILITIES AND FINANCIAL RESOURCES

The Group's liquidity in 2021 was mainly derived from cash generated from business operations during the Year. As at 31 December 2021, total amount of bank and cash balances of the Group was approximately HK\$112,528,000 (2020: HK\$173,654,000).

As at 31 December 2021, the Group's total borrowings was approximately HK\$2,146,074,000, increased by approximately 0.2% as compared to that of 2020 of approximately HK\$2,140,789,000, which was mainly due to the appreciation of CNY. The Group's gearing ratio (calculated by total borrowings over total assets) was approximately 36.3% in 2021 (2020: 30.9%).

DISCLAIMER OPINION RELATING TO GOING CONCERN

In the consolidated financial statements of the Company and its subsidiaries (together as the "Group") for the year ended 31 December 2021, the Company's auditors issued disclaimer of opinion on the material uncertainties relating to the going concern basis ("Disclaimer of Opinion"), in which they were unable to obtain sufficient appropriate audit evidence to conclude on the appropriateness of management to use the going concern basis of accounting in the preparation of the consolidated financial statements because management's plans for future actions (the "Action Plan") in relation to its going concern assessment could not be finalised yet and therefore issued a disclaimer of opinion on the results of the Group's consolidated financial statements.

The management is taking the best efforts to agree on and execute the Action Plan in 2021. Taking into account the successful and continued implementation of the proposed restructuring, the management and also the Directors are satisfied that the Group will have sufficient working capital to meet its financial obligation as and when they fall due in the foreseeable future, and hence it is appropriate to prepare the Group's consolidated financial statements on a going concern basis. The management assessed that there is no material impact on the Group's financial position in light of the Disclaimer of Opinion, as the going concern issue could be resolved by the Action Plan devised.

Management Discussion and Analysis

There was no disagreement between the Board and the Auditors regarding the Disclaimer of Opinion, considering that the consolidated financial statements have been prepared by the management on a going concern basis, the validity of which depends on the outcome of the measures under management's assumptions, which are subject to multiple uncertainties.

The Audit Committee takes the same view as the Board and agreed with the management's position concerning the going concern issue and Disclaimer of Opinion based on the reasons above.

誠如本綜合財務報表附註3所詳述,於2021年 12月31日存在的情況表明存在可能對本集團持 續經營能力產生重大疑慮之重大不明朗因素。 本公司管理層已與共同臨時清盤人及債權人就 以安排計劃的方式進行債務重組積極磋商,涉 及(其中包括)延長還款期限。

此外,本公司將繼續尋求第三方投資者對 本公司的潛在投資,以便本公司籌集現金。 本公司亦就資本投資、生產、行政及營運 實施成本控制措施,以降低本集團的整體 經營成本。

假設成功實施債權人計劃,董事會認為,本集 團於可預見的未來將擁有充足營運資金以履行 其到期的財務義務。因此,綜合財務報表已按 持續經營基準編製。

MANAGEMENT'S POSITION AND BASIS ON THE GOING CONCERN ASSUMPTION

As detailed in Note 3 to this consolidated financial statement, conditions existed as at 31 December 2021 indicating the existence of material uncertainties which may cast significant doubt regarding the Group's ability to continue as a going concern. The management of the Company has been actively negotiated with the JPLs and the creditors on debt restructuring by way of scheme of arrangement involving, among others, extension of repayment period.

In addition, the Company will continue to seek potential investment in the Company from third party investor(s) to facilitate raising of cash for the Company. The Company has also implemented cost control measures on capital investments, production, administrative and operations to reduce overall operating costs of the Group.

Assuming the successful implementation of the creditor's scheme, the Board is of the opinion that the Group will have sufficient working capital to meet its financial obligation as and when they fall due in the foreseeable future. Accordingly, the consolidation financial statements have been prepared on a going concern basis.

PROJECT OVERVIEW

Dolomite Mine

The Group's dolomite mine is situated in Baishan City, Jilin Province, the PRC. The mine is operated by open-pit method, and therefore no additional exploration works are involved or required. Only simple infrastructure works for open-pit mining are involved in the development activities, and no underground exploration or structural works are involved. The dolomite mined is raw material for producing magnesium products of the Group. The transportation cost for raw material is relatively low due to the close proximity of the mine to the production base of the Group.

Management Discussion and Analysis

本集團之白雲石礦乃按中國資源/儲量分類。 截至2021年12月31日的估計資源量和儲量,按 已開採量逐年核減,得出剩餘資源量及儲量。 本集團與以往披露估算假設相比並無重大變更。 該資源量及儲量由本集團之內部地質專家審核。 截至2021年12月31日止年度,本集團並無出產 白雲石。與2020年12月31日相比,白雲石礦於 本年度的估計資源量及礦石儲量並無重大變動。

There is no material change in the assumptions of estimation by the Group as compared with those previously disclosed. The resource and reserve volumes was reviewed by the Group's internal geological experts. For the year ended 31 December 2021, there was no dolomite output. As compared with that as at 31 December 2020, there was no material change in the resource estimate and ore reserve of the dolomite mine during the Year.

蛇紋石礦

本集團之蛇紋石礦,位於中國江蘇省東海縣。 該礦場以露天開採方式操作,不涉及也不需 額外勘探工程,開發活動僅涉及露天開採時的 簡易基建工程,並沒有涉及任何地下勘探以及 結構工程。已開採之蛇紋石直接作為鋼鐵冶煉 的輔助材料出售和作為本集團生產硅鎂肥之原 材料。礦場的位置鄰近本集團生產基地,原料 的運輸成本亦相對很低。

Serpentine Mine

The Group's serpentine mine is situated in Donghai County, Jiangsu Province, the PRC. The mine is operated by open-pit method, and therefore no additional exploration works are involved or required. Only simple infrastructure works for open-pit mining are involved in the development activities, and no underground exploration or structural works are involved. The serpentine mined is sold directly as metallurgical flux for iron and steel smelting and is raw material for producing silicon magnesium fertilisers of the Group. The transportation cost for raw material is relatively low due to the close proximity of the mine to the production base of the Group.

本集團之蛇紋石礦於2010年購入時,乃按JORC 準則資源/儲量分類。截至2021年12月31日的 估計資源量和儲量乃根據購入時的數量,按已 開採量逐年核減,得出剩餘資源量及儲量。本 集團與以往披露估算假設相比並無重大變更。 該資源量及儲量由本集團之內部地質專家審核。 截至2021年12月31日止年度,本集團完成出產 蛇紋石114,587噸。與2020年12月31日相比,蛇 紋石礦的估計資源量及礦石儲量並無重大變動。

The resource/reserve of the serpentine mine of the Group was reported under the JORC system when it was acquired in 2010. As at 31 December 2021, the anticipated resource and reserve volumes were determined based on the volume at the time of acquisition with the yearly reduction of quantity mined to calculate the remaining resource and reserve volumes. There is no material change in the assumptions of estimation by the Group as compared with those previously disclosed. The resource and reserve volumes was reviewed by the Group's internal geological experts. For the year ended 31 December 2021, the Group completed a serpentine output of 114,587 tonnes. As compared with that as at 31 December 2020, there was no material change in the resource estimate and ore reserve of the serpentine mine.

2021年度之開發活動開支主要為礦山深部開拓 工程的資本開支,並已予資本化並計入2021年 度之綜合財務狀況表內。開採活動開支主要用 於直接工資、材料、能源、運輸及折舊攤銷費 用等,並已計入銷售成本於2021年度之綜合損 益及其他全面收益表內扣除。

截至2021年12月31日止年度,蛇紋石礦開發及開採活動產生之支出分別約為10,886,000港元及13,130,000港元,而勘探活動之支出則為零港元。

主要風險及不明朗因素

本集團的財務狀況、營運業績及業務前景可能 受到與本集團業務直接或間接相關的許多風險 及不明朗因素的影響。以下為本集團知悉的主 要風險及不明朗因素。除下文所列者外,或會 存在本集團並未知悉或目前可能不重要但日後 可能變得重要的其他風險及不明朗因素。

市場風險

市場風險乃因市場需求、產品價格、匯率及利率等的變動,而使盈利能力受損或影響達成業務目標的能力的風險。本集團管理層對該等風險持續密切監控,以確保能及時有效採取適當措施以應對。

The expenditures incurred for 2021 in development activities were mainly CAPEX in relation to in-depth development project of the mine. Such expenditures have been capitalised and included in the consolidated statement of financial position for 2021. The expenditures incurred in mining activities were mainly for direct wages, materials, energy, transportation, depreciation and amortisation, etc. Such expenditures have been included in cost of sales and charged to the consolidated statement of profit or loss and other comprehensive income for 2021.

The expenditures incurred in development and mining activities of serpentine for the year ended 31 December 2021 were approximately HK\$10,886,000 and HK\$13,130,000 respectively while the expenditures incurred in exploration activities were HK\$Nil.

KEY RISKS AND UNCERTAINTIES

Our Group's financial condition, results of operations, and business prospects may be affected by a number of risks and uncertainties directly or indirectly pertaining to our Group's businesses. The followings are the key risks and uncertainties identified by our Group. There may be other risks and uncertainties in addition to those shown below which are not known to our Group or which may not be material now but could turn out to be material in the future.

Market risks

Market risk is the risk that deteriorates profitability or affects ability to meet business objectives arising from the movement in market demand, product prices, foreign exchange rates, and interest rates. The management of our Group keeps continually monitoring these exposures closely to ensure appropriate measures are implemented on a timely and effective manner against such risks.

Management Discussion and Analysis

匯率風險

本集團主要在中華人民共和國(「中國」)及香港經營業務,故此承受多種外匯風險,主要涉及人民幣、港元、新加坡元、美元及澳元。外匯風險源於未來商業交易、已確認資產及負債外國經營的投資淨額。本集團現時並與分別匯風險。本集團定期檢討持有除港元以外之貨幣之流動資產及負債以評估外匯風險並於必要時考慮使用對沖工具。

利率風險

對於利息敏感型產品及投資,本集團以動態基準分析其利率風險,並考慮適當時透過各種手段以低成本方式管理該風險。

信貸風險

本集團一直以來十分重視我們客戶的信貸風險。本集團嚴格遵循於2004年建立的「客戶賬戶管理程式」。該程式要求並確保根據每一客戶先前的交易記錄和信貸往績,定期評估及追蹤所有客戶的賬戶。本集團就每名客戶的經營和資信狀況授予一系列信貸措施,例如:信貸比率、信貸期限、信貸評級、信貸條款及擔保。客戶賬戶管理程式可有效控制本集團之信貸風險。

Exchange rate risk

The Group mainly operates in the People's Republic of China (the "PRC") and Hong Kong and is exposed to foreign exchange risk arising from primarily Renminbi, HK\$, Singapore dollars, US\$ and Australian dollars. Foreign exchange risk arises from future commercial transactions, recognised assets and liabilities and net investments in foreign operations. The Group does not presently hedge the foreign exchange risks. The Group periodically reviews current assets and liabilities held in currencies other than HK\$ to evaluate its foreign exchange risk exposure and consider the usage of hedging instruments when necessary.

Interest rate risk

For interest-sensitive products and investments, our Group analyses its interest rate exposure on a dynamic basis and considers managing this risk in a cost-effective manner through variety of means when appropriate.

Credit risk

The Group has always been aware of the credit risk exposure of our customers. The Group strictly followed the "client account management procedures" established in 2004. The procedures required and ensured that all clients were regularly assessed and be kept track of their accounts based on their transaction records and credit history. The Group specified and assigned to each customer, as according to their operation and credit status, a series of credit measures such as credit ratio, credit period, credit rating, credit terms and guarantee. The client account management procedures were effective to control the credit risk of the Group.

營運風險

營運風險指因內部程序、人員或制度不足或缺失,或因外部事件導致之損失風險。管理營運風險之責任基本上由集團及附屬公司的職能部門負責監控和落實。本集團之主要功能是對壓程序、權限及匯報框架作出指引。管理層將會定期評估主要之營運風險及業務發展所帶來的影響,制定相應措施,完善內控制度,以及時有效應對和規避風險。

投資風險

Operational risk

Operational risk is the risk of loss resulting from inadequate or failed internal processes, people and systems or from external events. Responsibility for managing operational risks basically rests with functional departments of the Group and its subsidiaries. Key functions of the Group is to guide their standard operating procedures, limits of authority and reporting framework. Our management will assess key operational exposures and impacts brought by our business development regularly, implement relevant measures and improve the internal control so that risk can be addressed and mitigated on a timely and effective manner.

Investment risk

Investment risk can be defined as the likelihood of extension of its return period relative to the expected return or occurrence of losses on any particular investment attributable to changes of external factors. The Group is well aware of the importance of exploring various business opportunities and territories on a continual basis to the development of our businesses, which shall be implemented as the top agenda of the year. Key concern of investment projects will be balancing risk and return across different investments, and thus risk assessment is a core aspect of the investment decision-making process. Proper investment assessment and due diligence procedures have been set up and detailed analysis will be made before approving investments. Regular updates on the progress of the investments of our Group would be submitted to the Board.

人力供應及留聘人才之風險

環境政策及表現

Manpower and retention risk

Manpower risk means huge demand for talents because of the Group's rapid business development while at the same time facing severe competition over specialists from the industry and turnover of manpower. Our Group may face the risk of not being able to recruit and retain key personnel and talents with appropriate and required skills, experience and competence to cope with the expansion of business which would meet the business objectives of our Group. Our Group will conduct a thorough analysis over its remuneration system, as well as incentive mechanism and optimise the compensation structure so as to ensure remuneration packages can align reasonably with market standard and maintain its competitiveness. Meanwhile, recruitment channels are broadened and the talent pool of senior management are strengthened, so as to further enhance the promotion opportunities and career path of employees. Systematic staff training are also being further enhanced to increase the overall effectiveness of training and the dissemination of good corporate cultures.

ENVIRONMENTAL POLICIES AND PERFORMANCE

Environmental policies and performance mainly means increasing attention of PRC government paid to environmental rules and policies and more strict regulatory requirements. As subsidiaries and newly acquired enterprises have been put into operation for a long while and may lag behind certain environmental and duty requirements promulgated by PRC government. The Group monitors impact on our business development closely arising from changes in environmental policy and external factors. Acting in an environmentally responsible manner and performing social responsibilities, the Group is committed to improving and maintaining the long term sustainability of the communities in which it operates. The Group endeavours to comply with laws and regulations regarding environmental protection and adopt effective measures to achieve efficient use of resources, energy saving and waste reduction. Green initiatives and measures have been adopted in daily operation of the Group. Such initiatives include recycling of resources, energy saving measures and water saving practices.

遵守法律及規則

本集團的業務主要由本公司於中國內地的附屬公司進行,而本公司於聯交所上市。因此,本集團營運須遵守中國內地及香港的有關法律及法規。截至2021年12月31日止年度及直至本報告日期,盡我們所知,本集團已遵守中國內地及香港的所有有關法律及法規。

與員工及主要持份者之關係

於2021年12月31日,本集團所僱用之員工數目約為1,150名(2020年:約1,670名)。本集團根據員工之表現、工作經驗和現時市場情況訂定彼等之薪酬。員工福利包括醫療保險、定額供款公積金計劃、酌情花紅和僱員購股權計劃。本集團並無發生任何導致正常業務運作受影響之勞資糾紛或僱員數目重大改變。董事認為本集團與僱員關係良好。

COMPLIANCE WITH LAWS AND REGULATIONS

The Group's operations are mainly carried out by the Company's subsidiaries in mainland China while the Company is listed on the Stock Exchange. The Group's operations accordingly shall comply with relevant laws and regulations in mainland China and Hong Kong. During the year ended 31 December 2021 and up to the date of this report, to the best of our knowledge, the Group has complied with all the relevant laws and regulations in mainland China and Hong Kong.

RELATIONSHIP WITH EMPLOYEES AND KEY STAKEHOLDERS

The number of employees of the Group was approximately 1,150 (2020: approximately 1,670) as at 31 December 2021. The remuneration of employees was determined by the Group with reference to their performance, work experience and current market conditions. Employee benefits include medical insurance, defined provident fund scheme, discretionary bonus and employee share option scheme. There has been no labour dispute or significant change in the number of employees that affect the normal operations of the Group. The Directors believe that the Group maintains admirable relations with its employees.

Our Group understands that it is important to maintain good relationship with business partners, shareholders, investors and banks to achieve its long-term goals. To keep up with our key stakeholders closely, the Group has formulated corresponding scheme about investor relationship, and also holds tailored activities for various stakeholders from time to time, such as annual/ extraordinary general meetings, on-site visits, seminars and road-shows. Accordingly, our senior management have kept good communication, prompt exchange of ideas and sharing of business latest update about development of the Group with them when appropriate. During the Year, there was no material dispute between our Group and its business partners or banks.

CODE ON CORPORATE GOVERNANCE PRACTICES

Throughout the year of 2021, the Company has complied with the code provision as set out in the Corporate Governance Code (the "CG Code") and Corporate Governance Report under Appendix 14 of the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules") except for the following deviations as explained below with considered reasons:

- (a) Under code provision A.2.1, the roles of chairman and chief executive officer (the "CEO") should be separated and should not be performed by the same individual. However, there is no separation between the roles of chairman and CEO under the current corporate structure of the Company, details of which have been disclosed in the paragraph headed "Chairman and Chief Executive Officer" below.
- (b) Under the code provision E.1.2, the chairman of the Board should attend the annual general meeting. The chairman of the Board was unable to attend the annual general meeting held on 30 June 2021 as he was obliged to be away for a business trip on that date. Mr. Shum Sai Chit, executive Director of the Company, attended the said annual general meeting to answer questions from shareholders.

Following the retirement of Mr. Lau, the Company has two independent non-executive directors and audit committee members, which therefore fell below the minimum requirements of three under Rules 3.10(1) and 3.21 of the Listing Rules respectively.

Pursuant to Rule 3.11 and 3.23 of the Listing Rules, the Company should appoint additional independent non-executive Directors and appropriate members to the Audit Committee within three months after failing to meet the requirements. Despite from the best effort by the Company, the Company failed to identify suitable candidate within the time requirement. The Company has applied to the Stock Exchange for, and the Stock Exchange has on 25 November 2021 granted to the Company, a waiver to extend the grace period to 31 December 2021. Mr. Shen Yi Min has been appointed as an independent non-executive director, a member of audit committee of the board and a member of remuneration committee of the board of the Company on 1 January 2022 to fill the vacancy.

- Approving appointment of Directors
- Setting the Group's remuneration policies

The Board is also responsible for performing the functions set out in code provision D.3.1. The Board will meet to develop, review and monitor the Company's corporate governance policies and practices, to review and monitor training and continuous professional development of Directors and senior management, to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements, to develop, review and monitor the code of conduct and compliance manual applicable to employees and Directors and to review the compliance of the Company with the CG Code and the disclosure in the corporate governance report.

During the year of 2021, in relation to the corporate governance functions, the Board has reviewed the Company's compliance with the CG Code and the regulatory and statutory requirements, and the disclosure in the corporate governance report.

During 2021, the Chairman had met the non-executive Director and the independent non-executive Directors respectively and individually without the presence of other executive Directors.

BOARD COMPOSITION

The Board comprises 6 Directors in which 2 are executive Directors; 1 is non-executive Director and 3 are independent non-executive Directors. The number of independent non-executive Directors constitutes more than one-third of the Board. The composition of the Board as at the date of this report and their profiles are set out on page 38 and page 39 of the annual report respectively.

The Board delegates powers to executive Directors for the day-to-day management of the Group and the implementation of major strategies and initiatives adopted by the Board whereas executive Directors should provide such explanations and information to the Board in a timely manner to enable the Board to monitor the performance of management.

Non-executive Director brings in valuable expertise and experience to the Company and serves important functions as well as provides strategic advices to the management.

Independent non-executive Directors ensure that the Board is accountable for the interest of all shareholders and handles matters in an objective manner. The 3 independent non-executive Directors have brought a wide spectrum of valuable business experience, knowledge and professionalism to the Board for efficient and effective delivery of its functions. The Board has received from each independent non-executive Director an annual confirmation of his independence pursuant to Rule 3.13 of the Listing Rules. The Board considers all of the independent non-executive Directors to be independent.

Mr. Chi Wen Fu and Mr. Chi Jing Chao have a family relationship of uncle and nephew. Mr. Guo Mengyong is a brother-in-law of Mr. Chi Wen Fu. Save as disclosed, there is no other relationship among members of the Board.

Upon reviewing (i) the directorships and major commitments of each Director; and (ii) the attendance rate of each Director at the meetings of the Board and its committees, the Board is satisfied that all Directors have spent sufficient time in performing their responsibilities during 2021.

The Company has arranged appropriate insurance cover in respect of legal action against Directors.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Upon the resignation of Mr. Shum Sai Chit as Chief Executive Officer on 30 July 2021, Mr. Chi Wen Fu, founder of the Group, the chairman and an executive Director, has been appointed as the CEO of the Company.

This structure does not comply with code provision A.2.1. However, the Board is of the view that it is in the best interests of the Group to adopt a single leadership structure, as Mr. Chi possesses extensive experience and knowledge in the PRC market and he is playing a significant role in establishing strategic decisions and overall management of the Group. It enables the Company to make and implement decisions promptly and efficiently. Further, it is difficult for the Board to find a candidate with suitable qualification and expertise in the market to fill the position of CEO at this stage of debts restructuring. With the single leadership structure, sufficient safeguards are established to ensure the management is accountable to the Board. The Chairman/ CEO ensures Board meetings are held regularly and when necessary. The Chairman/ CEO ensures that Board members are provided with complete, adequate, accurate and timely information on a regular basis to enable them to be fully cognizant of the affairs of the Group. The Chairman/CEO ensures all Directors have unrestricted access to document or information kept by the Group and professional advice when necessary.

APPOINTMENT AND RE-ELECTION

Any potential new Directors, being individuals who are suitably qualified and expected to make a positive contribution to the performance of the Board, will be identified by the existing Directors and the Nomination Committee and submitted to the Board for approval.

In accordance with the articles of association of the Company, at each annual general meeting of the Company, one-third of the Directors shall retire from office by rotation and every Director shall be subject to retirement at least once every 3 years. Mr. Guo Mengyong and Mr. Cheung Sound Poon shall retire at the forthcoming annual general meeting of the Company, but being eligible, offer themselves for re-election.

If an independent non-executive Director serves more than 9 years, his further appointment will be subject to a separate resolution to be approved by shareholders.

Each of the non-executive Director and the independent non-executive Directors, namely Mr. Guo Mengyong, Mr. Cheung Sound Poon, Mr. Sheng Hong and Mr. Shen Yi Min, has entered into a letter of appointment with the Company for a fixed term of 2 years commencing from 1 April 2021 and 1 January 2022 respectively, subject to the provisions of retirement and rotation of Directors under the articles of association of the Company and save that either such Director or the Company may terminate the appointment by giving at least 3 months' prior written notice. Annual emoluments payable to independent non-executive Directors and non-executive Director will be reviewed according to their estimated time to be spent on the Company's matters and their working experience with the Company.

All existing executive Directors are entitled to a fixed remuneration per annum respectively. In addition, each executive Director is also entitled to a discretionary management bonus calculated as a percentage of the audited consolidated net profit of the Group attributable to the owners of the Company (after tax and non-controlling interests and the payment of such management bonuses but before extraordinary and exceptional items), which percentage shall be determined by the Board provided that the aggregate amount of the bonuses payable to all executive Directors in respect of each financial year of the Company shall not exceed 5% of such net profit. The remuneration of each executive Director is subject to the annual review of the Board with reference to his/her contribution in terms of time, effort and his/her expertise.

Details of remuneration paid to each of the Directors and senior management during the year are disclosed in Note 13 to the financial statements.

All Directors are entitled to be reimbursed for reasonable expenses incurred during the performance of their duties to the Company and are eligible for share options under the share option scheme of the Company.

BOARD PROCESSES

The Board is accountable to the shareholders and leads the Group in an ethical, responsible and effective manner. The Board meets on a regular basis and arranges ad-hoc meetings for any specific matters that may arise.

董事會的權限

董事會成員多元化政策

於本年度,董事會已實施董事會成員多元化政策,其自2013年9月1日起生效。本公司透過考慮多項因素,包括但不限於性別、年齡、文化及教育背景、種族、專業經驗、技能知識及服務年期,務求達致董事會成員多元化。所有董事會成員委任乃基於用人唯才,而為有效達致董事會成員多元化,將根據客觀準則考慮候選人。

DELEGATION BY THE BOARD

The Board has delegated the authority and responsibility for implementing business strategies and management of the daily operations of the Group to the senior management who is required to report back to the Board. Functions reserved to the Board and the management are reviewed periodically. The Board and each individual Director is empowered to access any Company's information from senior management and the company secretary at all times. The Directors are kept informed on a timely basis of major changes that may affect the Group's businesses, including amendments on relevant rules and regulations. During the year, Directors are provided with monthly updates on the Company's performance, position and prospects to enable the Board as a whole and each Director to discharge their duties. Directors are allowed to seek independent professional advice in performing their duties at the Company's expense, but no request was made by any Director for such independent professional advice in 2021.

The Board monitors and reviews performance of the management based on several key performance indicators such as financial figures, investor relations, corporate governance and internal control. The principal measures include review of management accounts, review of internal or external auditor reports and feedbacks from stakeholders.

BOARD DIVERSITY POLICY

During the year, the Board has implemented a board diversity policy which has been effective since 1 September 2013. The Company seeks to achieve board diversity through the consideration of a number of factors, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. All Board appointments will be based on meritocracy and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the Board.

該等委員會的職權範圍可於本公司及聯交所網站瀏覽。

Selection of candidates will be based on a range of diversity perspectives, including but not limited to gender, age, cultural background and ethnicity, in addition to educational background, professional experience, skills, knowledge and length of service. The ultimate decision will be based on merit and contribution that the selected candidates will bring to the Board.

As at the date of this report, the Board comprises 6 Directors. Among which, one of them is a non-executive Director and three of them are independent non-executive Directors. The Directors are of diverse educational background and possess a wide spectrum of professional qualifications and business experience. The Board is of significant diversity, whether considered in terms of gender, professional and educational background and skills.

CODE OF CONDUCT REGARDING SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers as set out in Appendix 10 of the Listing Rules ("Model Code") as the code of conduct of the Company regarding Directors' securities transactions. The Company made specific enquiries to all Directors and all Directors have confirmed in writing that they have complied with the required standards set out in the Model Code during the year.

BOARD'S COMMITTEES

To assist in the execution of its responsibilities, the Board has established audit committee (the "Audit Committee"), remuneration committee (the "Remuneration Committee"), and nomination committee (the "Nomination Committee"). These committees function within clearly defined terms of reference. Independent non-executive Directors play a significant role in these committees to ensure that independent and objective views are taken.

The terms of reference of these committees are available on the websites of the Company and the Stock Exchange.

AUDIT COMMITTEE

Upon the retirement of Mr. Lau Chi Kit on 30 June 2021, the Audit Committee consists of Mr. Cheung Sound Poon (chairman of the Audit Committee) and Mr. Sheng Hong for the reporting period, who are both independent non-executive Directors. Mr. Shen Yi Min was appointed as independent non-executive Director on 1 January 2022 and also joined the Audit Committee as a member. All committee members possess appropriate qualifications such as accounting and financial management.

The Audit Committee met 5 times in 2021 to review with the senior management and external auditors the Group's significant internal controls and financial matters as set out in the Audit Committee's terms of reference. The functions of the Audit Committee include the following matters:

- Reviewing the Group's financial statements with recommendation to the Board for approval
- Reviewing the Group's compliance of the regulatory and statutory requirements
- Reviewing the Group's internal control and risk management
- Reviewing significant accounting and audit issues
- Reviewing the Group's connected transactions
- Overseeing and managing the relationship with external auditors

The Audit Committee has power to conduct investigations into any matter within the scope of responsibility of the Audit Committee. The Audit Committee is authorised to obtain independent professional advice if it deems necessary for discharging its responsibilities. The Audit Committee has obtained a written confirmation from the auditors on their independence and objectivity as required under the Section 290 (revised) of the Code of Ethics for Professional Accountants issued by Hong Kong Institute of Certified Public Accountants prior to the commencement of the audit of the Company's financial statements for the year ended 31 December 2021.

During the year, the Audit Committee has carried out the above functions in the respective Audit Committee meetings and also has been satisfied with the review of the audit scope, process, effectiveness and independence of the auditors.

In the consolidated financial statements of the Company and its subsidiaries (together as the "Group") for the year ended 31 December 2021, the Company's auditors issued disclaimer of opinion on the material uncertainties relating to the going concern basis ("Disclaimer of Opinion"), in which they were unable to obtain sufficient audit evidence to conclude on the basis of the application of the going concern basis due to the uncertainty on the successful implementation of the debt restructuring of the Company. The Audit Committee has communicated with the Auditors regarding the basis of the Disclaimer of Opinion. Other than the going concern basis, in all other aspect, in the opinion of the Auditors, the consolidated financial statements have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

The Audit Committee has reviewed and recommended to the Board for approval of the interim and annual financial statements for 2021. There was no disagreement between the Board and the Audit Committee on the re-appointment of the auditors.

- monitoring the implementation of the Board diversity policy and to review and to make recommendations on any revisions of such policy

The Nomination Committee met once in 2021 for reviewing the structure, size and composition of the Board, making recommendation to the Board regarding change of roles of board members and re-appointment of retiring Directors at the forthcoming annual general meeting, assessing the independence of independent non-executive Directors.

Such system is designated to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. This responsibility is primarily fulfilled on its behalf by the Audit Committee. In the year under review, the Audit Committee, as delegated by the Board, has reviewed the effectiveness of the internal control systems of the Group, covering all material controls, including financial, operational and compliance controls and risk management functions.

The implementation of risk management of the Group was assisted by the Group's internal audit department so that the Group could ensure new and emerging risks relevant to the Group's operation are promptly identified by management, assess the adequacy of action plans to manage these risks and monitor and evaluate the effectiveness of the action plans. These are on-going processes and our Audit Committee reviews the Group's risk management systems periodically.

Audit committee reported to the Board the implementation of the Group's risk management and internal control policy which, among other things, included the determination of risk factors, evaluation of risk level the Group could endure and effectiveness of risk management measures. Based on the reports from the Group's internal control department and the Audit Committee, the Board considers the Group's risk management and internal control system is adequate and effective and the Group has complied with the provisions on risk management and internal controls as set out in the CG code.

The Group is committed to ensure that information contained in announcements or circulars is not false or misleading as to a material fact, or false or misleading through the omission of a material fact in view of presenting information in a clear and balanced way, which requires equal disclosure of both positive and negative facts.

COMMUNICATION WITH SHAREHOLDERS AND INVESTOR RELATIONS

The Company recognises the importance of open communication and fair disclosure. It is the Company's policy to ensure that all shareholders are equally informed of all major corporate developments.

All shareholders have proper notice of any general meeting of the Company at which the Directors and the committees' members are available to give explanation on any query raised by the shareholders. Major information of the Company could be obtained from the Company's website or financial reports and circulars sent to the shareholders. We were engaged to audit the consolidated financial statements of Century Sunshine Group Holdings Limited (the "Company") and its subsidiaries (collectively referred to as the "Group") set out on pages 81 to 219, which comprise the consolidated statement of financial position as at 31 December 2021, and the consolidated statement of profit or loss, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

We do not express an opinion on the consolidated financial statements of the Group. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these consolidated financial statements. In all other respects, in our opinion, the consolidated financial statements have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

BASIS FOR DISCLAIMER OF OPINION

Material uncertainties relating to the going concern basis

As explained in Note 1 to the consolidated financial statements, on 3 July 2020, the Company announced (i) the Company defaulted on the redemption of the SGD 101.75 million in principal amount of the listed subordinated notes (the "SGD Notes"); (ii) the Company had received demands from two of its bank creditors for the repayment of borrowings of the Company and its subsidiary guaranteed by the Company of approximately HK\$51 million plus interest accrued and believed it was likely to receive further calls from

In 2021, the JPLs have held creditors' committee's meetings to discuss the development of the provisional liquidation and restructuring plan. As of the date of this report, no consensus on any restructuring plan could be reached between the Group and the creditors and the hearing of the winding up petition was adjourned to be heard on Monday, 25 April 2022 (Cayman Islands time) by the Grand Court of Cayman Islands.

Further, as explained in Note 3 to the consolidated financial statements, the Group incurred a net loss of approximately HK\$1,254,102,000 for the year ended 31 December 2021, and, as of that date, the Group's current liabilities exceeded its current assets by approximately HK\$1,881,426,000, its current borrowings amounted to HK\$2,146,074,000 as at 31 December 2021, while its cash and cash equivalents amounted to HK\$101,964,000 only. In addition, the Group could not fulfil certain covenants relating to certain borrowings of the Group amounting to HK\$1,995,673,000 as at 31 December 2021, which have become repayable on demand of the lenders. Further, included in the borrowings of the Group as at 31 December 2021 were borrowings of approximately HK\$637,276,000 and in the trade and other payable for exceeding HK\$1 million in aggregate approximately HK\$43,000,000 of which the creditors have commenced litigations against the Group for repayment of the outstanding balances and to proceed ruling and freezing on certain non-core operating assets.

1. 一般資料

世紀陽光集團控股有限公司(「本公司」)及 其附屬公司(統稱「本集團」)主要從事農業 肥料業務、鎂產品業務及煉鋼熔劑業務。

本公司乃於2003年1月21日根據開曼群島公司法第22章(1961年法律3,經綜合及修訂)在開曼群島註冊成立的獲豁免有限公司。本公司的股份於2004年2月17日於香港聯合交易所有限公司(「聯交所」)GEM(「GEM」)上市,並於2008年7月31日撤銷其於GEM的上市地位。自2008年8月1日起,本公司的股份已於聯交所主板上市。董事認為,本公司之最終控股公司為冠華國際有限公司,該公司為於英屬處女群島註冊成立之公司。

綜合財務報表均以港元(「港元」)為單位, 與本公司的功能貨幣相同。除非另有説明, 否則所有金額均以最接近千位(「千港元」) 計值。

1. GENERAL INFORMATION

Century Sunshine Group Holdings Limited (the "Company") and its subsidiaries (collectively referred to as the "Group") are principally engaged in fertiliser business, magnesium product business and metallurgical flux business.

The Company was incorporated in the Cayman Islands on 21 January 2003 as an exempted company with limited liability under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. On 17 February 2004, the Company's shares were listed on the Growth Enterprise Market ("GEM") of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") and were withdrawn from the GEM on 31 July 2008. Since 1 August 2008, the Company's shares have been listing on the Main Board of the Stock Exchange. In the opinion of the directors, the ultimate holding company of the Company is Alpha Sino International Limited, a company incorporated in the British Virgin Islands.

The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is the same as the functional currency of the Company. All values are rounded to the nearest thousand ("HK\$'000") except when otherwise indicated.

於2020年7月3日,本公司公佈(i)本公司違 約贖回於2020年7月3日到期之本金金額為 101.75百萬新加坡元之上市後償票據(「新 加坡元票據」)(「付款違約」)(附註32iii); (ii)本公司於2020年6月接獲其兩名銀行債 權人要求本公司及其附屬公司償還本公司 擔保之約51百萬港元借款另加應計利息, 並相信其很有可能在付款違約後收到其債 權人之進一步催收;以及(iii)一份清盤呈請 (「呈請」)連同委任共同臨時清盤人(「共同 臨時清盤人」)之申請已代表本公司於2020 年7月2日(開曼群島時間)向開曼群島最高 法院提交,其為[非強制]原則形勢,即本 公司董事會(「董事會」)仍將管理本公司, 而共同臨時清盤人會與本公司管理層一起 致力於(其中包括)監督、督導和監察對整 個集團進行全面及經協調的債務和負債重 組(「建議重組計劃」),包括維持本公司在 香港聯合交易所有限公司的上市。

於2020年7月14日(開曼群島時間),開曼群島大法院(「大法院」)頒佈一項命令,委任安永企業財務服務有限公司的閻正為先生及蘇潔儀女士、Ernst & Young Ltd.的Roy Bailey先生以及EY Cayman Ltd的Tammy Karina Fu女士為本公司共同臨時清盤人,並授予其共同及個別行事之權力。

Winding-up petitions and appointment of provisional liquidators

On 3 July 2020, the Company announced (i) the Company defaulted on the redemption of the SGD 101.75 million in principal amount of the listed subordinated notes (the "SGD Notes") on their maturity on 3 July 2020 (the "Payment Default") (Note 32 iii); (ii) the Company had received in June 2020 demands from two of its bank creditors for the repayment of borrowings of the Company and its subsidiary guaranteed by the Company of approximately HK\$51 million plus interest accrued and believed it was likely to receive further calls from its creditors following the Payment Default; and (iii) a winding-up petition ("Petition") has been filed on 2 July 2020 (Cayman Islands time) to the Supreme Court of the Cayman Islands on behalf of the Company together with an application for the appointment of joint provisional liquidators ("JPLs") on a "light touch" basis that the board of directors of the Company (the "Board") will retain management of the Company while the JPLs will work alongside the Company's management to, amongst other things, monitor, supervise and oversee the implementation of a group-wide holistic and coordinated restructuring of its debts and liabilities (the "Proposed Restructuring Plan") including to maintain the listing of the Company on the Stock Exchange of the Hong Kong Limited.

On 14 July 2020 (Cayman Islands time), an order was granted by the Grand Court of Cayman Islands (the "Grand Court") for the appointment of Mr. Yen Ching Wai David and Ms. So Kit Yee Anita of Ernst & Young Transactions Limited, Mr. Roy Bailey of Ernst & Young Ltd., and Ms. Tammy Karina Fu of EY Cayman Ltd as JPLs of the Company with the power to act jointly and severally.

共同臨時清盤人於2020年10月28日向新加坡共和國高等法院(「新加坡高等法院」)提出申請,要求頒令認可共同臨時清盤人的任命,及獲得根據請求書所給予的共同臨時清盤人權力。於2020年11月30日,新加坡高等法院已批准該申請。

於2020年12月23日,新加坡票據持有人成立了非正式指導委員會(「非正式指導委員會」)。於2021年3月7日,非正式指導委員會委任了一家獨立財務顧問(「獨立財務顧問」),與其共同列席債權人委員會,並推進後續相關工作。建議重組計劃已初步制定,惟須經與債權人磋商。

大法院並進一步命令,呈請將延後至2022 年4月25日(星期一)(開曼群島時間)進行 聆訊。 On 18 August 2020, the Grand Court issued a letter of request ("LOR") to the High Court of Hong Kong for the recognition of the appointment and powers of the JPLs in Hong Kong to, inter alia, develop and propose a restructuring plan to allow the Company to continue as a going concern. The Grand Court also accepted the resignation of one of the JPLs, Mr. Yen Ching Wai David on the same day. The JPLs appointment order remains in force in respect of Mr. Roy Bailey, Ms. Tammy Karina Fu and Ms. So Kit Yee Anita as JPLs. An application has been filed by the JPLs to the High Court of Hong Kong on 26 August 2020 for the recognition of the appointment and powers of the JLPs pursuant to the LOR. On 28 August 2020, the High Court of Hong Kong has approved the said application.

An application has been filed by the JPLs to the High Court of the Republic of Singapore (the "Singapore High Court") on 28 October 2020 for the recognition of the appointment and powers of the JLPs pursuant to the LOR. On 30 November 2020, the Singapore High Court has approved the said application.

On 23 December 2020, the Singapore Noteholders have established the informal steering committee (the "ISC"). On 7 March 2021, the ISC has appointed an independent financial advisor (the "IFA"), who sits on the creditors' committee, together with the ISC, to proceed the follow-up work. The Proposed Restructuring Plan had been initially formulated but subject to be negotiated with the creditors.

During the Year, the JPLs have held several creditors committee's meetings to discuss the development of the provisional liquidation and restructuring scheme. Nevertheless, any determination and implementation of such scheme shall be subject to the agreement of the requisite majorities of creditors and the applicable approval(s) of the Grand Court, the High Court of Hong Kong, and/or other relevant jurisdictions, if necessary.

As further ordered by the Grand Court, the hearing of the Petition will be adjourned to be heard on Monday, 25 April 2022 (Cayman Islands time).

3. 主要會計政策概要

編製綜合財務報表之基準

於編製此等綜合財務報表時應用之主要會 計政策載列如下。除非另有説明,此等政 策已一致應用於所有呈列年度。

綜合財務報表乃按照香港會計師公會頒佈 之香港財務報告準則編製。此外,綜合財 務報表包括香港聯合交易所有限公司證券 上市規則(「上市規則」)及香港公司條例 (「公司條例」)所規定之適用披露資料。

持續經營

截至2021年12月31日 止年度本集團 產生虧損約1,254,102,000港元(2020 年:984,205,000港元),而截至該 日,本集團之流動負債超過其流動 資產約1,881,426,000港元(2020年: 1,082,484,000港元)。此外,於2021年 12月31日,本集團之流動及非流動借款 分別約為2,146,074,000港元(2020年: 2,065,408,000港元)及零港元(2020年: 75,381,000港元),而其現金及等同現 金項目僅約為101,964,000港元(2020 年:157,417,000港元)。誠如綜合財務 報表附註1所述,本公司違約償還其本 金 為101,750,000新 加 坡 元 (相當於約 593,782,000港元)之上市後償票據加 2020年7月3日到期日時到期應計之利 息,並收到其兩家銀行債權人要求償還約 51,000,000港元之本集團借款。截至2021 年12月31日本集團未能履行本集團若干借 款約1,995,673,000港元的若干契諾,有關 金額須按要求償還並在綜合財務狀況表中 呈列為流動負債。

上述狀況表示存在對本集團之持續經營能 力構成疑慮之重大不明朗因素。因此,本 集團可能無法於日常業務過程中變現其資 產及解除債務。

3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of preparation of consolidated financial statements

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

The consolidated financial statements have been prepared in accordance with HKFRSs, issued by the HKICPA. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("Listing Rules") and by the Hong Kong Companies Ordinance ("CO").

Going concern

The Group recorded loss of approximately HK\$1,254,102,000 (2020: HK\$984,205,000) for the year ended 31 December 2021, and, as of that date, the Group's current liabilities exceeded its current assets by approximately HK\$1,881,426,000 (2020: HK\$1,082,484,000). Further, as at 31 December 2021, the Group's current and non-current borrowings amounted to approximately HK\$2,146,074,000 (2020: HK\$2,065,408,000) and HK\$Nil (2020: HK\$75,381,000) respectively, while its cash and cash equivalents only amounted to approximately HK\$101,964,000 (2020: HK\$157,417,000). As stated in note 1 to the consolidated financial statements, the Company had defaulted in repayment of its listed subordinated notes of principal amount of SGD101.75 million (equivalent to approximately HK\$593,782,000) plus interests accrued when they fell due on their maturity date on 3 July 2020 and had received demands from two of its bank creditors for repayment of the borrowings of the Group of approximately HK\$51 million. The Group could not fulfil certain covenants of certain borrowings amounting to approximately HK\$1,995,673,000 as at 31 December 2021, which have become repayable on demand and are presented as current liabilities in the consolidated statement of financial position.

The conditions described above indicate the existence of a material uncertainty that cast significant doubt on the Group's ability to continue as a going concern. Therefore, the Group may be unable to realize its assets and discharge its liabilities in the normal course of business.

此外,本公司計劃對資本投資、生產及行 政運營採取進一步之成本控制措施,以降 低本集團之整體運營成本。 The Company is actively exploring options to restructure the debts of the Group and has commenced implementation of a management led restructuring by taking advantage of the court-supervised provisional liquidation regime in the Cayman Islands, commonly known as a "light touch" provisional liquidation, which gives the Company the benefit of a statutory moratorium prohibiting the commencement or continuance of any proceedings against the Company without the leave of the Grand Court of the Cayman Islands. The Company is seeking to develop a viable proposed restructuring plan, including but not limited to some or all of the followings:

- equity restructuring to facilitate the raising of cash for the Company from third party investors through equity issue;
- 2. a debt restructuring that may involve refinancing and/or a compromise or arrangement of the debts and liabilities of the Group; and
- potential investment in the Company from one or more third party investor(s) to facilitate raising of cash for the Company and potential disposal of non-core business and non-operating fixed assets of the Group.

It is proposed that the Proposed Restructuring Plan will be implemented by way of schemes of arrangement (the "Creditors' Scheme") with the creditors of the companies in provisional liquidation, including the Company. The Schemes are likely subject to the sanction of the Grand Court, the BVI Court (in respect of the subsidiaries in provisional liquidation which are incorporated in the BVI), the Hong Kong Court and the Singapore Court.

In addition, the Company plans to implement further cost control measures on capital investments, production and administrative operations to reduce overall operating costs of the Group.

These consolidated financial statements have been prepared on a going concern basis, the validity of which depends upon the eventual successful outcomes of the events and conditions described above, which are inherently uncertain, including the Group being able to successfully negotiate and agree with the creditors to renew or extend the existing borrowings or complete debt financing to provide funds for the Group to meet its liabilities as they fall due. This in turn is dependent upon (i) the JPLs and the Company being able to finalise the proposed restructuring plan after consultations with the creditors' committee of the general creditors of the Group, the Informal Steering Committee ("ISC") of the noteholders of the SGD Notes and the Independent Financial Adviser engaged to represent the ISC; and (ii) the sanctions of the schemes of arrangement will be successfully obtained from the relevant courts referred to above for the implementation of the finalised Proposed Restructuring Plan.

As at the date of approval for issuance of the consolidated financial statements, the framework of the proposed restructuring plan has been initially formulated but the eventual outcome of the proposed restructuring plan cannot be determined with reasonable certainty. Accordingly, the material uncertainty that cast significant doubt on the Group's ability to continue as a going concern remains in existence as at the date of approval for issuance of the consolidated financial statements. Should the Group be unable to continue as a going concern, adjustments would have to be made to the consolidated financial statements to write down the carrying values of the Group's assets to their recoverable amounts, to provide for further liabilities which might arise and to reclassify non-current assets and non-current liabilities as current assets and current liabilities, respectively. The effects of these adjustments have not been reflected in the consolidated financial statements.

Historical cost basis

The consolidated financial statements have been prepared on the historical cost basis, except for certain financial instruments, which are measured at fair values, as explained in the accounting policies set out below. Historical cost is generally based on the fair value of the consideration given in exchange for assets.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 Share-based Payments, leasing transactions that are within the scope of HKFRS 16, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 Inventories or value in use in HKAS 36 Impairment of Assets.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

For financial instruments which are transacted at fair value and a valuation technique that unobservable inputs is to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that at initial recognition the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

於附屬公司的非控股權益與本集團的權益 分開呈列,其指現有擁有權權益,使其持有人有權於清盤時按比例取得有關附屬公司之資產淨值。

Basis of Consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities (including structured entities) controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Company obtains control over the subsidiary and ceases when the Company loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Company gains control until the date when the Company ceases to control the subsidiary.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to being their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

Subsidiaries

A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e. existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) The contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The results of subsidiaries are included in the Company's profit or loss to the extent of dividends received and receivables. The Company's investments in subsidiaries are stated at cost less any impairment.

Business combinations

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

Except for certain recognition exemptions, the identifiable assets acquired and liabilities assumed must meet the definitions of an asset and a liability in the Framework for the Preparation and Presentation of Financial Statements (replaced by the Conceptual Framework for Financial Reporting issued in October 2010).

- liabilities or equity instruments related to share-based payment arrangements of the acquiree or share-based payment arrangements of the Group entered into to replace share-based payment arrangements of the acquiree are measured in accordance with HKFRS 2 Share-based Payment at the acquisition date (see the accounting policy below);
- assets (or disposal groups) that are classified as held for sale in accordance with HKFRS 5 Non-current Assets Held for Sale and Discontinued Operations are measured in accordance with that standard; and
- lease liabilities are recognised and measured at the present value of the remaining lease payments (as defined in HKFRS 16) as if the acquired leases were new leases at the acquisition date, except for leases for which (a) the lease term ends within 12 months of the acquisition date; or (b) the underlying asset is of low value. Right-of-use assets are recognised and measured at the same amount as the relevant lease liabilities, adjusted to reflect favourable or unfavourable terms of the lease when compared with market terms.

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the net amount of the identifiable assets acquired and the liabilities assumed as at acquisition date. If, after re-assessment, the net amount of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

When the consideration transferred by the Group in a business combination includes a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and included as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively. Measurement period adjustments are adjustments that arise from additional information obtained during the "measurement period" (which cannot exceed one year from the acquisition date) about facts and circumstances that existed at the acquisition date.

The subsequent accounting for the contingent consideration that do not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not remeasured at subsequent reporting dates and its subsequent settlement is accounted for within equity. Contingent consideration that is classified as an asset or a liability is remeasured to fair value at subsequent reporting dates, with the corresponding gain or loss being recognised in profit or loss.

When a business combination is achieved in stages, the Group's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date (i.e. the date when the Group obtains control), and the resulting gain or loss, if any, is recognised in profit or loss or other comprehensive income, as appropriate. Amounts arising from interests in the acquiree prior to the acquisition date that have previously been recognised in other comprehensive income and measured under HKFRS 9 would be accounted for on the same basis as would be required if the Group had disposed directly of the previously held equity interest.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. Those provisional amounts are adjusted retrospectively during the measurement period (see above), and additional assets or liabilities are recognised, to reflect new information obtained about facts and circumstances that existed at the acquisition date that, if known, would have affected the amounts recognised at that date.

Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business (see the accounting policy above) less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units (or group of cash-generating units) that is expected to benefit from the synergies of the combination, which represent the lowest level at which the goodwill is monitored for internal management purposes and not larger than an operating segment.

A cash-generating unit (or group of cash-generating units) to which goodwill has been allocated is tested for impairment annually or more frequently when there is indication that the unit may be impaired. For goodwill arising on an acquisition in a reporting period, the cash-generating unit (or group of cash-generating units) to which goodwill has been allocated is tested for impairment before the end of that reporting period. If the recoverable amount is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit (or group of cash-generating units).

On disposal of the relevant cash-generating unit or any of the cash-generating unit within the group of cashgenerating units, the attributable amount of goodwill is included in the determination of the amount of profit or loss on disposal. When the Group disposes of an operation within the cash-generating unit (or a cashgenerating unit within a group of cash-generating units), the amount of goodwill disposed of is measured on the basis of the relative values of the operation (or the cash-generating unit) disposed of and the portion of the cash-generating unit (or the group of cash-generating units) retained.

控制權會隨時間轉移,而倘滿足以下其中 一項標準,則收益乃參照完全滿足相關履 約責任的進度而隨時間確認:

Revenue from contracts with customers

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- the Group's performance creates and enhances an asset that the customer controls as the Group performs; or
- the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct good or service.

A contract asset represents the Group's right to consideration in exchange for goods or services that the Group has transferred to a customer that is not yet unconditional. It is assessed for impairment in accordance with HKFRS 9. In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

A contract asset and a contract liability relating to a contract are accounted for an presented on a net basis.

Revenue from the processing and sales of fertiliser, magnesium products and metallurgical flux is recognised at a point in time when control of the products has transferred, being at the point the products are delivered to the customer and the customer has accepted the products, and there is no unfulfilled obligation that could affect the customer's acceptance of the products. Delivery occurs when the products have been shipped to the specified location, the risks of obsolescence and loss have been transferred to the customer, and either the customer has accepted the products in accordance with the sales contract, the acceptance provisions have lapsed, or the Group has objective evidence that all criteria for acceptance have been satisfied.

Revenue from these sales is recognised based on the price specified in the contract, net of discounts, returns and value added taxes.

A receivable is recognised when the products are delivered and the customers accept the products, as this is the point in time that the consideration is unconditional because only the passage of time is required before the payment is due.

政府撥款

政府撥款不予確認,直至有合理保證,本 集團將符合政府撥款隨附的條件,以及將 收獲撥款後,方會確認。

倘與收入相關者之政府撥款成為應收款項, 作為已產生的開支或虧損的彌償,或提供 予本集團而沒有相關未來成本即時財務支 持,則於成為應收款項之期間於損益確認。 有關撥備於「其他收益虧損淨額」項下呈列。

物業、廠房及設備

物業、廠房及設備為用作生產或供應貨物 或服務,或行政用途的無形資產(在建工 程除外)按成本減其後累計折舊及累計減 值虧損列賬。

成本包括為使資產達到能夠按照管理層擬 定的方式開展經營所必要的位置及條件而 直接產生的任何成本,及(就合資格資產 而言)根據本集團會計政策資本化的借貸 成本。此等資產以其他物業資產的相同基 準,當資產可供擬定用途時開始計提折舊。

在建工程包括建造以供生產或本身運用的物業、廠房及設備。在建工程乃按成本減任何已確認減值虧損列賬。當在建工程完成及可供擬定用途,則撥入物業、廠房及設備的適當分類。此等資產以其他物業資產的相同基準,當資產可供擬定用途時開始計提折舊。

Government Grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants related to income that become receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable. Such grants are presented under "other gains or losses, net".

Property, Plant and Equipment

Property, plant and equipment, are tangible assets that are held for use in the production or supply of goods or services, or for administrative purposes (other than construction in progress), are stated at cost less subsequent accumulated depreciation and accumulated impairment losses.

Costs include any costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management and, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

Construction in progress includes property, plant and equipment in the course of construction for production or for its own use purposes. Construction in progress is carried at cost less any recognised impairment loss. Construction in progress is classified to the appropriate category of property, plant and equipment when completed and ready for intended use. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

When the Group makes payments for ownership interests of properties which includes both leasehold land and building elements, the entire consideration is allocated between the leasehold land and the building elements in proportion to the relative fair values at initial recognition.

To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land that is accounted for as an operating lease is presented as "right-of-use assets" in the consolidated statement of financial position. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property, plant and equipment.

Depreciation is recognised so as to write off the cost of assets less their residual values over their estimated useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the item) is included in profit or loss in the period in which the item is derecognised.

Investment properties

Investment properties are properties held to earn rentals and for capital appreciation.

Investment proper ties are initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are stated at cost less subsequent accumulated depreciation and any accumulated impairment losses. Depreciation is recognised so as to write off the cost of investment properties over their estimated useful lives and after taking into account of their estimated residual value, using the straight-line method.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposal. A leased property which is recognised as a right-of-use asset is derecognised if the Group as intermediate lessor classifies the sublease as a finance lease. Any gain or loss arising on derecognition of the property (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the period in which the property is derecognised.

就於首次應用日期或之後訂立或修改或由 業務合併產生的合約而言,本集團根據香 港財務報告準則第16號的定義於初始或修 改日期或收購日期(倘適用)評估該合約是 否為租賃或包含租賃。除非合約的條款及 條件其後出現變動,否則有關合約將不予 重新評估。

本集團作為承租人

將代價分配至合約組成部分

就包含租賃組成部分以及一項或多項額外租賃或非租賃組成部分之合約而言,本集團根據租賃組成部分之相對獨立價格及非租賃組成部分之獨立價格總和將合約代價分配至各租賃組成部分,包括收購含有租賃土地及非租賃樓宇組成部分的物業的所有權權益的合約,惟有關分配無法可靠作出則除外。

本集團採用可行權宜方法,不將非租賃組成部分從租賃組成部分區分開來,而是將租賃組成部分及任何相關非租賃組成部分作為一項單獨的租賃組成部分進行入賬。

短期租賃及低價值資產租賃

對於租期自開始日期起計12個月或以內且並無包含購買選擇權的機器及設備租賃,本集團應用短期租賃確認豁免。本集團亦對低價值資產租賃應用確認豁免。短期租赁及低價值資產租賃的租賃付款按直線基準或另一系統基準於租期內確認為開支。

Leases

Definition of a lease

A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

For contracts entered into or modified or arising from business combinations on or after the date of initial application, the Group assesses whether a contract is or contains a lease based on the definition under HKFRS 16 at inception, modification date or acquisition date, as appropriate. Such contract will not be reassessed unless the terms and conditions of the contract are subsequently changed.

The Group as a lessee

Allocation of consideration to components of a contract For a contract that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease component on the basis of the relative standalone price of the lease component and the aggregate stand-alone price of the non-lease components, including contract for acquisition of ownership interests of a property which includes both leasehold land and non-lease building components, unless such allocation cannot be made reliably.

The Group applies practical expedient not to separate non-lease components from lease component, and instead account for the lease component and any associated non-lease components as a single lease component.

Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to leases of machinery and equipment that have a lease term of 12 months or less from the commencement date and do not contain a purchase option. It also applies the recognition exemption for lease of low-value assets. Lease payments on short-term leases and leases of low-value assets are recognised as expense on a straight-line basis or another systematic basis over the lease term.

Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities.

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. Straight-line basis over the shorter of its estimated useful life and the lease term.

The Group presents right-of-use as a separate line item on the consolidated statement of financial position.

Refundable rental deposits

Refundable rental deposits paid are accounted under HKFRS 9 Financial Instruments ("HKFRS 9") and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

Lease liabilities

At the commencement date of a lease, the Group recognises and measures the lease liability at the present value of lease payments that are unpaid at that date. In calculating the present value of lease payments, the Group uses the incremental borrowing rate at the lease commencement date if the interest rate implicit in the lease is not readily determinable.

Lease payments included in the measurement of the lease liability comprise:

- fixed lease payments (including in-substance fixed payments), less any lease incentives receivable;
- variable lease payments that depend on an index or rate, initially measured using the index or rate at the commencement date;
- the amount expected to be payable by the lessee under residual value guarantees;
- the exercise price of purchase options, if the lessee is reasonably certain to exercise the options; and
- payments of penalties for terminating the lease, if the lease term reflects the exercise of an option to terminate the lease.

After the commencement date, lease liabilities are adjusted by interest accretion and lease payments.

- 租期有所變動或行使購買選擇權的 評估發生變化,在此情況下,相關租 賃負債透過使用重新評估日期的經 修訂貼現率貼現經修訂租賃付款而 重新計量。
- 租賃付款因進行市場租金調查後市場租金變動/有擔保剩餘價值下預期付款變動而出現變動,在此情況下,相關租賃負債使用初始貼現率貼現經修訂租賃付款而重新計量。

租賃負債於綜合財務狀況表中呈列為一項 單獨項目。

租賃的修訂

除本集團已應用可行權宜方法的新冠肺炎 疫情相關租金優惠外,倘出現以下情況, 本集團將租賃的修改作為一項單獨的租賃 進行入賬:

- 租賃修訂通過增加了使用一項或以 上相關資產的權利使租賃範圍增大: 及
- 租賃代價增加的金額相當於擴大範圍對應的單獨價格,加上以反映特定合約的實際情況對單獨價格進行的任何適當調整。

就未作為一項單獨租賃入賬的租賃修改而 言,本集團透過使用修改生效日期的經修 訂貼現率貼現經修訂租賃付款,根據經修 訂租賃的租期重新計量租賃負債。

本集團通過對相關使用權資產進行相應調整,以對租賃負債進行重新計量。當經修訂合約包含租賃組成部分以及一項或多項額外租賃或非租賃組成部分時,本集團根據租賃組成部分的相對獨立價格及非租賃組成部分的獨立價格總額,將經修訂合約中的代價分配至各租賃組成部分。

The Group remeasures lease liabilities (and makes a corresponding adjustment to the related right-of-use assets) whenever:

- the lease term has changed or there is a change in the assessment of exercise of a purchase option, in which case the related lease liability is remeasured by discounting the revised lease payments using a revised discount rate at the date of reassessment.
- the lease payments change due to changes in market rental rates following a market rent review/ expected payment under a guaranteed residual value, in which cases the related lease liability is remeasured by discounting the revised lease payments using the initial discount rate.

The lease liability is presented as a separate line in the consolidated statement of financial position.

Lease modifications

Except for Covid-19-related rent concessions in which the Group applied the practical expedient, the Group accounts for a lease modification as a separate lease if:

- the modification increases the scope of the lease by adding the right to use one or more underlying assets; and
- the consideration for the leases increases by an amount commensurate with the stand-alone price for the increase in scope and any appropriate adjustments to that stand-alone price to reflect the circumstances of the particular contract.

For a lease modification that is not accounted for as a separate lease, the Group remeasures the lease liability based on the lease term of the modified lease by discounting the revised lease payments using a revised discount rate at the effective date of the modification.

The Group accounts for the remeasurement of lease liabilities by making corresponding adjustments to the relevant right-of-use asset. When the modified contract contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the modified contract to each lease component on the basis of the relative stand-alone price of the lease component and the aggregate stand-alone price of the non-lease components.

因利率基準改革而變更釐定未來租賃付款 基準

對於因利率基準改革而變更釐定未來租賃 付款基準,本集團應用可行權宜方法以透 過使用未變更貼現率貼現經修訂租賃付款 而重新計量租賃負債,且對相關使用權資 產作出相應調整。當且僅當符合下列兩項 條件時,須就利率基準改革進行租賃修訂:

- 利率基準改革直接導致必須作出變動;及
- 釐定租賃付款的新基準經濟上等同 於過往基準(即緊接修訂前基準)。

新冠肺炎疫情相關租金寬免

就因導致直接產生的與租賃合約有關的租金寬免而言,本集團已選擇在滿足下列所有條件時應用可行權宜方法不評估有關變動是否為一項租賃修改:

- 租賃付款變動導致之租賃之經修訂 代價與緊接變動之前的租賃代價基 本相同或低於該代價;
- 租賃付款之任何減少僅影響原於 2021年6月30日或之前到期的付款: 及
- 租賃的其他條款及條件並無實質性 變動。

應用可行權宜方法將租金寬免導致之租賃付款變動列賬之承租人將以同一方式將應用香港財務報告準則第16號的變動入賬(倘變動並非租賃修訂)。租賃付款之寬免或豁免被入賬列作可變租賃付款。相關租賃負債獲調整以反映寬免或豁免之金額,並於該事件發生的期間內在損益中確認相應調整。

Changes in the basis for determining the future lease payments as a result of interest rate benchmark reform

For changes in the basis for determining the future lease payments as a result of interest rate benchmark reform, the Group applies the practical expedient to remeasure the lease liabilities by discounting the revised lease payments using the unchanged discount rate and makes a corresponding adjustment to the related right-of-use assets. A lease modification is required by interest rate benchmark reform if, and only if, both of these conditions are met:

- the modification is necessary as a direct consequence of interest rate benchmark reform;
 and
- the new basis for determining the lease payments is economically equivalent to the previous basis (i.e. the basis immediately preceding the modification).

Covid-19-related rent concessions

In relation to rent concessions that occurred as a direct consequence of the Covid-19 pandemic, the Group has elected to apply the practical expedient not to assess whether the change is a lease modification if all of the following conditions are met:

- the change in lease payments results in revised consideration for the lease that is substantially the same as, or less than, the consideration for the lease immediately preceding the change;
- any reduction in lease payments affects only payments originally due on or before 30 June 2021; and
- there is no substantive change to other terms and conditions of the lease.

A lessee applying the practical expedient accounts for changes in lease payments resulting from rent concessions the same way it would account for the changes applying HKFRS 16 if the changes are not a lease modification. Forgiveness or waiver of lease payments are accounted for as variable lease payments. The related lease liabilities are adjusted to reflect the amounts forgiven or waived with a corresponding adjustment recognised in the profit or loss in the period in which the event occurs.

無形資產

於業務合併中收購的無形資產

在業務合併中收購的無形資產與商譽分開確認,並按收購日期的公允值(被視為其成本)初始確認。

於首次確認後,具有有限使用年期的無形資產乃按成本減累計攤銷及任何累計減值虧損列賬。具有有限使用年期的無形資產以直線法按其估計可使用年期計提攤銷。或者,擁有無限使用年期的資產可按成本減任何其後累計減值虧損列賬。

無形資產乃於出售時或於預期使用或出售不會產生未來經濟利益時終止確認。於終止確認無形資產所產生的收益及虧損(按資產的出售所得款項淨額與賬面值之間的差額計量)於終止確認資產時在損益中確認。

技術知識

購入技術知識的開支撥作資本,並按自技 術知識可使用日期起計三至五年估計可使 用年期以直線法攤銷。

商標

商標以歷史成本列示。於業務合併收購的 商標按收購日期之公允值確認,由於許可 證可以較低費用續期,可使用年期被評估 為無限期。

專利權

購入專利權之開支將予資本化,並以直線 法按自專利可使用日期起計九至十六年之 估計可使用年期攤銷。

倘無形資產之可使用年期被評定為無限期, 則不會進行攤銷。倘評定無形資產之可使 用年期為無限期,則會每年檢討以釐 否有任何事件或情況繼續支持該項資產的 無限可使用年期。倘並無任何該等事件或 情況,可使用年期評估由無限期轉為有限 期時,則自變動日期起就其預期情況及根 據上文所載攤銷有限期無形資產之政策列 賬。

Intangible Assets

Intangible Assets Acquired in a Business Combination Intangible assets acquired in a business combination are recognised separately from goodwill and are initially recognised at their fair value at the acquisition date (which is regarded as their cost).

Subsequent to initial recognition, intangible assets with finite useful lives are carried at cost less accumulated amortisation and any accumulated impairment losses. Amortisation for intangible assets with finite useful lives is provided on a straight-line basis over their estimated useful lives. Alternatively, assets with indefinite useful lives are carried at cost less any subsequent accumulated impairment losses.

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains and losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, are recognised in profit or loss when the asset is derecognised.

Technical Know-how

Expenditure on acquired technical know-how is capitalised and amortised using the straight-line method over its estimated useful life of 3 to 5 years, from the date when the technical know-how is available for use.

Trademark

Trademarks are shown at historical cost. Trademarks acquired in a business combination are recognised at fair value at the acquisition date and the useful lives are accessed to be indefinite as the license can be renewed at little cost.

Patent

Expenditure on acquired patent is capitalised and amortised using the straight-line method over its estimated useful life of 9 to 16 years, from the date when the patent is available for use.

Intangible assets are not amortised while their useful lives are assessed to be indefinite. Any conclusion that the useful life of an intangible asset is indefinite is reviewed annually to determine whether events and circumstances continue to support the indefinite useful life assessment for that asset. If they do not, the change in the useful life assessment from indefinite to finite is accounted for prospectively from the date of change and in accordance with the policy for amortisation of intangible assets with finite lives as set out above.

會所會籍

會所會籍按歷史成本發列示。業務合併中 收購之會所會籍於收購日期按公允值確認, 且由於其使用年期被評定為無限期,則不 會進行攤銷,且須受年度化減值審閱。

物業、廠房及設備、使用權資產及無 形資產(商譽除外)減值

於各報告期末,本集體審閱其物業、廠房及設備、使用權資產及具有限使用年期實產之賬面值,以釐定是否有任何跡象顯示該等資產已出現減值虧損。倘存在何有關跡象,則會估計有關資產的可在回金額以釐定減值虧損(如有)之程度。無足過後用年期之無形資產及尚未可供使用之無形資產至少每年及於有跡象顯示資產可能出現減值時進行減值測試。

物業、廠房及設備、使用權資產及無形資產之可收回金額予以個別估計。倘無法個別估計可收回金額,則本集團會估計該資產所屬現金產生單位之可收回金額。

在就減值測試現金產生單位時,於可設定合理一致的分配基準時,公司資產會分配至相關現金產生單位,否則有關資產會分配至可設定合理一致分配基準之現金產生單位最小組別。就公司資產所屬現金產生單位或現金產生單位組別釐定可收回金額,並與相關現金產生單位或現金產生單位組別之賬面值進行比較。

Club membership

Club membership are shown at historical cost. Club membership acquired in a business combination are recognised at fair value at the acquisition date and are not amortised as their useful lives are assessed to be indefinite and subject to annualised impairment review.

Impairment on property, plant and equipment, right-of-use assets, and intangible assets other than goodwill

At the end of the reporting period, the Group reviews the carrying amounts of its property, plant and equipment, right-of-use assets, intangible assets with finite useful lives to determine whether there is any indication that these assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss (if any). Intangible assets with indefinite useful lives and intangible assets not yet available for use are tested for impairment at least annually, and whenever there is an indication that they may be impaired.

The recoverable amount of property, plant and equipment, right-of-use assets, and intangible assets are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs.

In testing a cash-generating unit for impairment, corporate assets are allocated to the relevant cash-generating unit when a reasonable and consistent basis of allocation can be established, or otherwise they are allocated to the smallest group of cash generating units for which a reasonable and consistent allocation basis can be established. The recoverable amount is determined for the cash-generating unit or group of cash-generating units to which the corporate asset belongs, and is compared with the carrying amount of the relevant cash-generating unit or group of cash-generating units.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a cash-generating unit) for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. For corporate assets or portion of corporate assets which cannot be allocated on a reasonable and consistent basis to a cash-generating unit, the Group compares the carrying amount of a group of cash-generating units, including the carrying amounts of the corporate assets or portion of corporate assets allocated to that group of cash-generating units, with the recoverable amount of the group of cash-generating units. In allocating the impairment loss, the impairment loss is allocated first to reduce the carrying amount of any goodwill (if applicable) and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit or the group of cash-generating units. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero. The amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro rata to the other assets of the unit or the group of cash-generating units. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or cash-generating unit or a group of cash-generating units) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or a cash-generating unit or a group of cash-generating units) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss.

外幣

編製本集團旗下各個別實體的財務報表時, 以該實體的功能貨幣以外貨幣(外幣)進行 的交易按交易日期的匯率以其功能貨幣(即 該實體經營業務所在主要經濟環境的貨幣) 列賬。

於各報告期末,以外幣結算的貨幣項目按 該日的匯率重新換算。以外幣計值並以公 允值列賬之非現金項目於公允值獲釐定當 日按當前比率重新換算。按過往成本以外 幣結算的非貨幣項目不會重新換算。

結算貨幣項目及換算貨幣項目時產生的匯 兑差額於產生期間在損益確認。重新換算 非貨幣項目產生的匯兑差額按公允值納入 有關期間的損益內。

Mining Rights

Mining rights, including transferred exploration and evaluation assets, are stated at cost less accumulated amortisation and any impairment losses. The mining rights are amortised on the production quantities over the total estimated mineral reserve. Mining rights are written off to the profit or loss if the mining property is abandoned.

Foreign Currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recorded in the functional currency (i.e. the currency of the primary economic environment in which the entity operates) at the rates of exchange prevailing at the dates of the transactions.

At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the translation of monetary items, are recognised in profit or loss in the period in which they arise. Exchange differences arising on the retranslation of non-monetary items carried at fair value, are included in profit or loss for the period.

此外,就並未導致本集團失去附屬公司之 控制權的附屬公司部分出售而言,累計匯 兑差額的相應份額乃重新歸類為非控股權 益,而並不於損益內確認。 For the purposes of presenting consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. HK\$) at the rates of exchange prevailing at the end of the reporting period. Income and expenses are translated at the average exchange rates for the year, unless exchange rates fluctuate significantly during the period, in which case, the exchange rates prevailing at the dates of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity (i.e. the translation reserve) (attributed to non-controlling interests as appropriate).

On the disposal of a foreign operation (i.e. a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, a disposal involving loss of joint control over jointly controlled entity that includes a foreign operation, or a disposal involving loss of significant influence over an associate that includes a foreign operation), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

In addition, in relation to a partial disposal of a subsidiary that does not result in the Group losing control over the subsidiary, the proportionate share of accumulated exchange differences are re-attributed to non-controlling interests and are not recognised in profit or loss.

退休福利費用

退休金計劃

本集團根據強制性公積金計劃條例設立一項界定供款之強制性公積金退休福利計 (「強積金計劃」),為所有僱員參與強積 計劃。供款按僱員基本薪金的若干百分 證定並根據強積金計劃守則於需支付供款 時在損益內扣除。強積金計劃之資產的 集團的其他資產分開處理,由一獨立管理 之基金持有。在向強積金計劃供款時,本 集團僱主供款將全數歸屬於僱員所有。

Borrowing Costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

Retirement Benefit Costs

Pension Schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for all of its employees. Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The Group also operates a defined contribution staff retirement scheme registered under the Occupational Retirement Schemes Ordinance (the "ORSO Scheme") for its employees (including certain directors), the assets of which are held separately from those of the Group in an independently administered fund. Contributions are made based on a percentage of the eligible employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the ORSO Scheme. When an employee leaves the ORSO Scheme prior to his/her interest in the Group's employer contributions vesting fully, the ongoing contributions payable by the Group may be reduced by the relevant amount of forfeited contributions.

現金及等同現金項目

授予僱員的購股權

向僱員及其他提供類似服務者授出的以股 權結算以股份為基礎付款於授出日期按股 權工具公允值計量。

未計及所有非市場歸屬條件的於授出日期 釐定的以股權結算以股份為基礎付款據 允值按直線法於歸屬期間支銷,所依工 準為本集團對於最終將歸屬的股權 估計,當中附帶股權(以股份為基礎付 儲備)的相應增加。於各報告期末, 團根據對所有相關非市場歸屬條件的於集, 修訂對預計將歸屬的股權工具數量的估 認 以致累計開支反映修訂估計,連同以股份 為基礎付款儲備的相應調整。 The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain percentage of their payroll costs to the central pension scheme. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme.

Payments to defined contribution retirement plans are charged as an expense when employees have rendered service entitling them to the contributions.

Cash and Cash Equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprises of cash in hand and demand deposits, and short term highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

Share-based Payment Transactions

Share Options Granted to Employees

Equity-settled share-based payments to employees and others providing similar services are measured at the fair value of the equity instruments at the grant date.

The fair value of the equity-settled share-based payments determined at the grant date without taking into consideration all non-market vesting conditions is expensed on a straight-line basis over the vesting period, based on the Group's estimate of equity instruments that will eventually vest, with a corresponding increase in equity (share-based payments reserve). At the end of each reporting period, the Group revises its estimate of the number of equity instruments expected to vest based on assessment of all relevant non-market vesting conditions. The impact of the revision of the original estimates, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to the share-based payments reserve.

The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that is probable that taxable profit will be available against which those deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which liability is settled or the asset is realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period. The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 Income Taxes requirements to right-of-use assets and lease liabilities separately. Temporary differences on initial recognition of the relevant right-of-use assets and lease liabilities are not recognised due to application of the initial recognition exemption. Temporary differences arising from subsequent revision to the carrying amounts of right-of-use assets and lease liabilities, resulting from remeasurement of lease liabilities and lease modifications, that are not subject to initial recognition exemption are recognised on the date of remeasurement or modification.

Inventories are stated at the lower of cost and net realisable value. In the case of work in progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Cost is calculated using the weighted average method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make sale.

Financial instruments

Financial assets and financial liabilities are recognised when a group entity becomes a party to the contractual provisions of the instrument. All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the market place.

Financial assets and financial liabilities are initially measured at fair value except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss.

For financial assets that have subsequently become credit-impaired, interest income is recognised by applying the effective interest rate to the amortised cost of the financial asset from the next reporting period. If the credit risk on the credit-impaired financial instrument improves so that the financial asset is no longer credit-impaired, interest income is recognised by applying the effective interest rate to the gross carrying amount of the financial asset from the beginning of the reporting period following the determination that the asset is no longer credit impaired.

Financial assets at FVTPL are measured at fair value at the end of each reporting period, with any fair value gains or losses recognised in profit or loss.

Impairment of financial assets subject to impairment assessment under HKFRS 9

The Group recognises a loss allowance for expected credit loss ("ECL") on financial assets which are subject to impairment assessment under HKFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL ("12m ECL") represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessment are done based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group always recognises lifetime ECL for trade receivables.

For all other instruments, the Group measures the loss allowance equal to 12m ECL, unless when there has been a significant increase in credit risk since initial recognition, in which case, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;
- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
- an actual or expected significant deterioration in the operating results of the debtor;
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

(ii) Definition of default

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

(iii) Credit-impaired financial assets

A financial asset is credit-impaired when one or more events of default that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower:
- (b) a breach of contract, such as a default or past due event;
- (c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider;
- (d) it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation; or

The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, for example, when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

(v) Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

For a financial guarantee contract, the Group is required to make payments only in the event of a default by the debtor in accordance with the terms of the instrument that is guaranteed. Accordingly, the ECL is the present value of the expected payments to reimburse the holder for a credit loss that it incurs less any amounts that the Group expects to receive from the holder, the debtor or any other party.

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

On derecognition of a financial asset measured at amortised cost, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

Financial liabilities and equity

Classification as debt or equity

Debt and equity instruments are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument.

Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recognised at the proceeds received, net of direct issue costs.

Financial liabilities

All financial liabilities are subsequently measured at amortised cost using the effective interest method or at FVTPL.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type or class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

4. CRITICAL ACCOUNTING JUDGMENTS AND KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies which are described in Note 3, the directors of the Company are required to make judgments, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Key Sources of Estimation Uncertainty

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

(a) Estimated Impairment of Right-of-use Assets, Property, Plant and Equipment and Intangible Assets

The Group evaluates whether right-of-use assets, property, plant and equipment and intangible assets have suffered any impairment whenever events or changes in circumstances indicate that the carrying amount of the assets may not be recoverable, in accordance with the accounting policy stated in Note 3. The recoverable amounts of CGUs represent the higher of the asset's fair value less costs to sell or its value-in-use. The calculations of fair value less costs to sell or value-in-use require the use of estimates. As at 31 December 2021, the carrying amounts of right-of-use assets, property, plant and equipment and intangible assets subject to impairment assessment were approximately HK\$232,958,000 (2020: HK\$296,330,000), HK\$3,408,172,000 (2020: HK\$3,693,366,000) and HK\$291,125,000 (2020: HK\$366,511,000) respectively after taking into account the impairment losses of approximately HK\$59,215,000 (2020: HK\$Nil), HK\$696,034,000 (2020: HK\$Nil) and HK\$80,362,000 (2020: HK\$Nil) in respect of right-of-use assets, property, plant and equipment and intangible assets that have been recognised respectively.

Details of the impairment of right-of-use assets, property, plant and equipment and intangible assets are disclosed in Notes 22.

(b) Estimated Useful Lives of Right-of-use Assets, Property, Plant and Equipment, Intangible Assets and Mining Rights

The Group's management determines the estimated useful lives and related depreciation/ amortisation charges for its right-of-use assets, property, plant and equipment and intangible assets. This estimate is based on the historical experience of the actual useful lives of right-of-use assets, property, plant and equipment and intangible assets of similar nature and functions and the mineral reserve determined by independent technical adviser. It could change significantly as a result of technical innovations and competitor actions in response to market conditions. Management will increase the depreciation/amortisation charge where useful lives are less than previously estimated lives, or it will write-off or write-down technically obsolete or non-strategic assets that have been abandoned or sold.

During the years ended 31 December 2021 and 2020, the Group did not change the estimated useful lives of right-of-use assets, property, plant and equipment, intangible assets and mining rights.

(c) Income Tax

The Group is subject to income taxes in several jurisdictions. There are certain transactions and calculations for which the ultimate tax determination may be uncertain. The Group recognises liabilities for anticipated tax issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the current and deferred tax provisions in the period in which such determination is made.

(d) Provision for Expected Credit Losses on Trade and Bills Receivables

The Group uses a provision matrix to calculate ECLs for trade receivables. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., by geography, product type, customer type and rating, and coverage by letters of credit and other forms of credit insurance).

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions (i.e., gross domestic products) are expected to deteriorate over the next year which can lead to an increased number of defaults in the manufacturing sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of customer's actual default in the future. The information about the ECLs on the Group's trade receivables is disclosed in notes 5 and 26 to the financial statements.

The Group's major financial instruments include equity instruments on fair value through profit or loss, trade and bills receivables, other receivables, deposits, long-term bank deposits, bank and cash balances, trade and bills payables, accruals and other payables, lease liabilities and borrowings. Details of the financial instruments are disclosed in respective notes. The risks associated with these financial instruments include foreign exchange risk, interest rate risk, other price risk, credit risk and liquidity risk. The policies on how to mitigate these risks are set out below. The Group's overall risk management programme focus on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(i) Foreign Exchange Risk

The Group does not have significant exposures to foreign currency risk as most of its business transactions, assets and liabilities are principally denominated in the functional currencies of the respective subsidiaries. The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group will monitor its significant foreign currency exposure and will consider hedging significant foreign currency exposure should the need arise.

(ii) Interest Rate Risk

The Group is exposed to fair value interest rate risk in relation to pledged bank deposits, bank and cash balances and fixed-rate borrowings (see Notes 28 and 32 respectively for details).

As management considers the Group's exposure to the above fair value interest rate risk is not significant, no interest rate swaps or other hedging activities are undertaken by management during the year.

The Group is also exposed to cash flow interest rate risk in relation to bank balances and variable-rate borrowings carried at prevailing market rate. However, such exposure is minimal to the Group as the bank balances are all short-term in nature.

Sensitivity Analysis

If interest rates on variable-rate borrowings as at 31 December 2021 had been 10 basis points (0.1% per annum) (2020: 10 basis points) higher/lower than the actual effective interest rate, the Group's post-tax loss for the year would increase/decrease by approximately HK\$754,000 (2020: post tax profit for the year would decrease/increase by approximately HK\$744,000).

Sensitivity Analysis

The sensitivity analysis below have been determined based on the exposure to equity price risks at the reporting date.

If the prices of respective instruments has been 10% (2020: 10%) higher/lower, the Group's post-tax loss or other comprehensive income for the year would decrease/increase by approximately HK\$391,000 (2020: post-tax loss or other comprehensive income for the year would decrease/increase by approximately HK\$874,000).

(iv) Credit Risk

The Group trades only with recognised and creditworthy third parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant. For transactions that are not denominated in the functional currency of the relevant operating unit, the Group does not offer credit terms without the specific approval of the Head of Credit Control.

The Group trades only with recognised, creditworthy third parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis.

With respect to credit risk arising from the other financial assets of the Group which comprise cash and cash equivalents, the Group's exposure to credit risk arising from default of the counterparties is limited as the counterparties have good credit standing and the Group does not expect to incur significant loss for unallocated advances/receivable/deposits from these entities.

The Group has no significant concentrations of credit risk. It has policies in place to ensure that sales of goods are made to customers with an appropriate credit history. The Group's deposits with bank and deposits placed with financial institutions are placed in high quality financial institutions without significant exposure to credit risk.

The directors consider that there is no significant credit risk in respect of the Group's deposits with banks and deposits placed with financial institutions and bills receivable as the financial institutions have no record of default payment.

Further quantitative data in respect of the Group's exposure to credit risk arising from trade receivables and other receivable and deposits are disclosed in Notes 26 and 27 respectively to the financial statements.

Financial guarantee contracts

At the end of the reporting period, the management has performed impairment assessment, and concluded that there has been no significant increase in credit risk since initial recognition of the financial guarantee contracts. Accordingly, the loss allowance for financial guarantee contracts issued by the Group is measured at an amount equal to 12-months ECL. The Group recognised allowance of approximately HK\$250,000 in the profit or loss. Details of the financial guarantee contracts are set out in note 30.

(v) Liquidity Risk

The table below analyses the maturity profile of the Group's financial liabilities as the end of the reporting period based on the contractual undiscounted payments. Specially, borrowings with repayment on demand clause and amounts being demanded by the creditors for immediate repayment are included in the earliest time band.

(a) Hong Kong Profits Tax

On 21 March 2018, the Hong Kong Legislative Council passed The Inland Revenue (Amendment) (No. 7) Bill 2017 (the "Bill") which introduces the two-tiered profits tax rate regime. The Bill was signed into law on 28 March 2018 and was gazette on the following day. Under the two-tiered profits tax rate regime, the first HK\$2 million of profits of the qualifying group entity will be taxed at 8.25% and profits tax above HK\$2 million will be taxed at 16.5%. The profits of group entities not qualifying for the two-tiered profits tax rates regime will continue to be taxed at a flat rate of 16.5%.

The directors of the Group considered the amount involved upon implementation of the two-tiered profits tax rate as insignificant to the consolidation financial statement. Hong Kong Profits Tax is calculated at 16.5% for both years. No tax is payable for the year ended 31 December 2021 (2020: HK\$NiI) since there were no assessable profit generated in Hong Kong.

(b) The PRC Enterprise Income Tax

The PRC Enterprise Income Tax is calculated at 25% on the estimated assessable profits arising in the PRC for the years ended 31 December 2021 and 2020.

(c) Overseas Income Tax

The Company was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law of Cayman Islands and, accordingly, is exempted from Cayman Islands income tax. The Company's subsidiaries established in the British Virgin Islands were incorporated under the International Business Companies Act of the British Virgin Islands and, are exempted from British Virgin Islands income tax.

The state sponsored retirement plan is responsible for the entire pension obligations to retired employees.

The Group has arranged for its Hong Kong employees to join the MPF Scheme, a defined contribution scheme managed by an independent trustee. Under the MPF Scheme, each of the Group and its Hong Kong employees make monthly contributions to the scheme at 5% of the employees' earnings as defined under the Mandatory Provident Fund legislation. Since 1 June 2014, both the Group's and the employees' contributions are subject to a cap of HK\$1,500 per month.

During the year ended 31 December 2021, the aggregate amount of the Group's contributions to the aforementioned pension schemes was approximately HK\$2,133,000 (2020: HK\$3,889,000). As at 31 December 2021, the Group was not entitled to any forfeited contributions to reduce the Group's future contributions (2020: HK\$Nil).

In view of the economic performance of the CGU 1 and CGU 2 which was not as expected, management of the Group concluded there was an indication for impairment and conducted impairment assessment on right-of-use assets, property, plant and equipment, and intangible assets with carrying amounts of HK\$232,958,000, HK\$3,408,172,000 and HK\$291,125,000 respectively.

The Group estimates the recoverable amount of CGU1 and CGU2, to which the asset belongs when it is not possible to estimate the recoverable amount individually, including allocation of corporate assets when reasonable and consistent basis can be established. Each cash-generating unit represents the Group's manufacturing operation in respective geographical locations. The carrying amounts of assets of CGU1 and CGU 2 were approximately HK\$2,642,500,000 and HK\$1,750,470,000 respectively.

CGU 1

The recoverable amount of CGU1 has been determined based on a value in use calculation. That calculation uses cash flow projections based on financial budgets approved by the management of the Group covering the following 5 years with a pre-tax discount rate is 14.84% as at 31 December 2021. The cash flows beyond the five-year period are extrapolated using 2% growth rate. This growth rate is based on the relevant industry growth forecasts and does not exceed the average long-term growth rate for the relevant industry. Another key assumption for the value in use calculated is the budgeted gross margin, which is determined based on the cash-generating units' past performance and management expectations for the market development.

(a) Share option scheme of the Company

In order to attract and retain the best quality employees for the development of the Group's businesses and to provide additional incentives or rewards to selected qualifying participants, the Company adopted a share option scheme on 3 December 2008 (the "Old Scheme") and on 26 June 2019 (the "New Scheme" or the "Scheme") respectively. The qualifying participants mainly include employees of the Group, Directors and contractors, suppliers or service providers of the Group who have contribution to the Group. Both schemes, unless otherwise cancelled or amended, will remain in force for 10 years since its establishing date. The Old Scheme was expired on 3 December 2018 while the remaining life of the New Scheme is approximately 7.5 years (expiry on 26 June 2029). Options granted under the Old Scheme before its expiry remain in force.

Options may be granted on such terms and conditions in relation to their vesting, exercise or otherwise as the directors may determine in its absolute discretion, provided that such terms and conditions shall not be inconsistent with any other terms and conditions of the Scheme.

The subscription price is not less than the highest of (i) the closing price of the Shares as stated in the daily quotation sheet of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on the date of offer of the option; (ii) the average closing prices of the Shares as stated in the Stock Exchange's daily quotations sheets for the 5 trading days immediately preceding the date of offer of the option; and (iii) the nominal value of a Share of HK\$0.02. The maximum number of Shares in respect of which options may be granted under the Scheme shall not, in aggregate, exceed 30% of the issued share capital of the Company from time to time. Upon acceptance of the offer for the grant of option, an amount of HK\$1.00 is payable by the grantee to the Company.

42. 訴訟與或然負債

(a) 茲提述本公司日期為2014年10月9日 有關對首智投資有限公司(「首智」) 之民事追討之公佈。截至本報告日 期,據本公司所知悉,有關訴接的自 期令狀尚未送達首智。首智待及就 法律文件後,將就有關追討及就此, 應予採取的必要行動尋求法律意量, 且將就追討極力抗辯。本公司業務, 該追討不會對本集團業務。 營運及財務情況造成重大不利影響。

(b) 茲提述附註3及42中的披露。鑑於付款違約、交叉違約和債務重組,於2021年12月31日本集團借貸中包括借貸約637,276,000港元及本集團之貿易應付和其他應付款項中包括個別超過1百萬港元合共約43,000,000港元的賬款,其債權人已啟動對若干附屬公司提出立即還款的訴訟並對若干非主要營運資產進行查封及凍結。

由於該等訴訟主要涉及未能履行已 在綜合財務報表中確認之相關負債 的義務及相關已抵押資產,本集團 正積極與債權人溝通,爭取通過協 議和解方式解決訴訟。

於年內,若干訴訟已透過調解及協商解決,當中包括(1)約67,089,000港元的借款已同意以經修訂及延長的時間表償還,及(2)債權人提出申請,撤回早前獲頒佈關於一項人民幣124,960,000元(折合約152,426,000港元)貸款的執行書,並已獲法院批准。有關該執行書之詳情,已於以下附註(c)內披露。

42. LITIGATIONS AND CONTINGENT LIABILITIES

- (a) Reference is made to the announcement of the Company dated 9 October 2014 regarding a civil claim against Capital Idea Investments Limited ("Capital Idea"). As of the date of this report, to the best knowledge of the Company, the writ of summons of the litigation has not yet been served on Capital Idea. Upon receiving this legal document, Capital Idea will seek legal advice in relation to the claim and the necessary actions to be taken in this respect and will vigorously defend against the claim. The Board of the Company is of the view that this claim will not have a material adverse impact on the business, operation and financial position of the Group.
- (b) Reference is made to the disclosure in Notes 3 and 42. In view of payment default, cross default and debt restructuring, included in the borrowings of the Group as at 31 December 2021 were borrowings of approximately HK\$637,276,000 and in the trade and other payables of the Group were accounts individually exceeding HK\$1 million and in aggregate to approximately HK\$43,000,000 of which the creditors have commenced litigations against certain subsidiaries for immediate repayments and to proceed ruling and freezing on certain non-core operating assets.

For such litigations, which were mainly in relation to failure to perform the obligation of the related liabilities already recognised in the consolidated financial statements and related assets pledged, the Group is proactively communicating with the creditors, striving to solve the litigations through settlement by agreement.

During the year, certain litigations were resolved by mediations and negotiations which included (1) borrowings of approximately HK\$67,089,000 were agreed to be repaid by revised and extended schedules; and, (2) an application was made by a creditor to withdraw an enforcement granted before in respect of borrowings RMB124,960,000 (equivalent to approximate HK\$152,426,000) and was approved by court. Details of this enforcement was disclosed in below note (c).

As such, in the view of the directors of the Company, the above ruling and freezing being sought by the creditors in the outstanding litigations as at 31 December 2021 will not affect the Group's continued operations, in the absence of unforeseen circumstances, and is not expected to have a material adverse effect on the Group's financial position or its business operations.

Nevertheless, the Company will seek legal advices on the litigations and will take necessary actions based on such legal advices for the entire interests of the Group. Further announcements will be made by the Company to update the shareholders and investors of the Company in relation to any material development on the proposed debt restructuring and litigations.

(c) As disclosed in the announcement of the Company dated 1 August 2021, the Company received a written ruling (the "Ruling") from Linyi Intermediate People's Court ("Linyi Court") regarding a PRC bank's application to enforce guarantees of loans amounting to RMB124.96 million granted to Shandong Hongri (an indirect non-wholly owned subsidiary of the Group) by the bank that have been provided by certain subsidiaries of the Group and Ms. Chi Bi Fen, the former legal representative of Shandong Hongri.

The Ruling stated that bank deposits of the certain subsidiaries of the Group and Ms. Chi Bi Fen in total sum of approximately RMB125 million or assets of equivalent value may be frozen for periods of up to one year (if cash), two years (if moveable assets) and three years (if immovable property or other types of assets). The Bank applied for 13 plots of land owned by Shandong Hongri to be frozen pursuant to the Ruling. On 26 July 2021, Shandong Hongri received a copy of a notice for assistance for enforcement (協助執 行通知書) dated 21 July 2021 from Linyi Court to Linyi Immovable Assets Registration Centre (the "Registry") requiring the assistance of the Registry in order to enforce the ruling by "freezing" three plots of land owned by Shandong Hongri (the "Frozen Assets") for the period between 21 July 2021 and 20 July 2024.

As advised by PRC counsels of the Company that, in deciding whether or not to grant any such order and the scope of such order, the Lingvi Court is required to have regard to the following requirements: (i) the value of the relevant asset that is to be "frozen" must not be excessive in the context of the payment obligations to which the ruling relates, unless the asset is indivisible and there are no alternative assets of sufficient value to satisfy such payment obligations; and (ii) if multiple assets are available for "freezing", the order should apply to those assets which if frozen would least impact the production activities of the party concerned. Having considered, (i) to the best knowledge of the Company, the aggregate value of the Frozen Assets (after taking account the value of the Land after its change of use and other liabilities that were secured by the Frozen Assets) is not less than RMB125 million; and (ii) the Linyi Court has ordered the freezing of 3 plots of land, instead of 13 plots of land that were the subject of the bank's application, the Company believes that there is low risk of further freezing orders at this stage. In view of the foregoing and the fact that the Frozen Assets belong to Shandong Hongri which has no operations and absent unforeseen circumstances, the Company did not expect the ruling to have a material adverse impact on the business operations of the Group that are subject to the Ruling.

On 25 November 2021, the PRC bank had submitted an application to Linyi Court to withdraw the enforcement. Pursuant to the written ruling from Linyi Court dated 1 December 2021, such application was approved and the enforcement was withdrawn.

(the "Petitioner") on 22 February 2021 against REMT in the Court for an order that REMT be wound up by the Court. The Petition was filed against REMT for its failure to repay the Petitioner an outstanding principal of the Notes (as defined below) together with the unpaid interest and default interest in an aggregate amount of US\$20,707,777.78, which was pursuant to a subscription agreement of 7% unsubordinated and unsecured notes due 2020 in a principal amount of US\$20,000,000 entered into between the Petitioner as subscriber and REMT as the issuer dated 7 August 2017.

On 1 March 2022, the REMT Creditors' Scheme was approved by the requisite statutory majorities of the scheme creditors. The hearing of the Petition has been adjourned that together with sanction hearing will be heard on 27 May 2022. For details, please refer to the announcements made by REMT on 23 February 2022 and 1 March 2022.

Save as disclosed above, the Directors consider that up to report date there were no significant litigations would have material adverse impact on the business and operation of the Group.

As disclosed in the Company's announcement dated 18 January 2022, the Company proposed to implement the restructuring plan and three assets would be transferred to settle the claims of the creditors of the Company, which included (i) 20% of the issued shares capital of REMT; (ii) the entitlement to receive net sale proceeds (after deduction of all relevant tax, costs and expenses incidental to remittance) from the sale of land in Zhangzhou, the PRC owned by Century Sunshine (Zhangzhou) Ecological Technology Limited, a wholly-owned subsidiary of the Company; (iii) the entitlement to the dividend payments (after deduction of all relevant tax, costs and expenses incidental to remittance) receivable by Acronagrotrans Ltd (an immediate holding company of Shandong Hongri) from Shandong Hongri after the realisation of the land registered under the name of Shandong Hongri located in Shandong, the PRC.

On 18 January 2022, REMT, an indirect non-wholly owned subsidiary of the Company, proposed to implement, subject to the approvals by creditors of REMT and the Hong Kong High Court, the proposed scheme of arrangement for REMT to be made between REMT and the creditors who had made a claim (the "REMT Creditors' Scheme").

The REMT Creditors' Scheme comprises (i) the term extension option; (ii) the convertible bonds swap option; and (iii) a combination of the aforementioned two options. Each scheme creditor with admitted claims is entitled, to the extent of the total value of his/her/its admitted claim(s), to elect between options (i), (ii) and (iii) above.
