# Corporate Overview

## 公司概況

Founded in Chongqing in 2004, Hanhua Financial Holding Co., Ltd. (“**Hanhua Financial**”, “**Hanhua**” or the “**Company**”, together with its subsidiaries named as the “**Group**”, “**we**”, “**our**” or “**us**”) (Stock Code: 3903) was listed on The Stock Exchange of Hong Kong Limited (“**Hong Kong Stock Exchange**”) via issue of H shares in 2014, and has now expanded its business portfolio to include financing guarantee, commercial banking, financial asset management and equity investment. As at the end of 2021, the Company had a registered capital of RMB4.6 billion, total assets of RMB12.4 billion and net assets of RMB8 billion. Since its establishment, the Company has recorded cumulative business turnover of over RMB300 billion, providing services to more than 200,000 small and medium-sized enterprises (“**SMEs**”) and more than 2,000,000 individual customers.

**Credit guarantee.** Hanhua Financing Guarantee Co., Ltd. (“**Hanhua Guarantee**”), established in 2009 with a registered capital of RMB3.5 billion, has established 26 branches across the country and gained a long-term corporate credit rating of AA+. As at the end of 2021, Hanhua Guarantee had net assets of RMB4 billion, and outstanding guarantee balance of RMB32.5 billion. Hanhua Guarantee has provided services to a total of 50,000 SMEs.

瀚華金控股份有限公司（「**瀚華金控**」、**「瀚華**」、**「公司**」或**「本公司**」，連同其附屬公司**「本集團**」或**「我們**」）（股份代號：3903）2004年創立於重慶，2014年在香港聯合交易所有限公司（**「香港聯交所**」）發行H股上市，目前已形成了融資擔保、民營銀行、金融資產管理及股權投資等業態。截至2021年末，公司註冊資本46億元，總資產124億元，淨資產80億元。成立至今，累計業務發生額超過3000億元，服務中小企業客戶20餘萬家，個人客戶200餘萬戶。

**信用擔保。**瀚華融資擔保股份有限公司（**「瀚華擔保**」）成立於2009年，註冊資本35億元，在全國設有26家分支機構，長期主體信用評級AA+。截至2021年末，淨資產40億元，在保餘額325億元。累計服務中小企業5萬家。

# Corporate Overview

## 公司概況

**Commercial banking.** Chongqing Fumin Bank Co., Ltd. (“**Fumin Bank**”), a private bank established in 2016 with Hanhua Financial as the lead promoter, is owned as to 30% by Hanhua Financial, its largest shareholder. Fumin Bank is the first private bank normally approved by the government. In line with its mission of “supporting micro businesses & helping startups and enriching the people & prospering the country”, Fumin Bank is committed to better serving micro and small-sized enterprises, agricultural industry, rural areas and farmers as well as innovative startups by innovating the service methods and business models of digital inclusive finance. Since its establishment, Fumin Bank has developed a series of digital featured products such as Fumin Bao, Fuyi Loan and E-Bills Quick Discounting to cater to the needs of SMEs, which was recognized by the People’s Bank of China and well-received among customers. As at the end of 2021, Fumin Bank had total assets of RMB54.1 billion, total loans of RMB37.7 billion, total liabilities of RMB50.2 billion and total deposits of RMB28.6 billion, with its financial services benefiting more than 10 million customers.

**Financial asset management.** Liaoning Fu’an Financial Asset Management Co., Ltd. (“**Fu’an Asset**”) was established in 2017 jointly by Hanhua Financial (as the lead promoter) and a local state-owned enterprise, with a registered capital of RMB1 billion. Fu’an Asset is the second local asset management company in Liaoning Province. Based in Liaoning and radiating across the country, Fu’an Asset provides financial institutions and enterprises with services such as transfer and disposal of non-performing assets, debt restructuring, investment management, financing innovation.

**民營銀行。**2016年，瀚華金控主發起設立民營銀行—重慶富民銀行股份有限公司（「**富民銀行**」），瀚華金控持股30%，為第一大股東。富民銀行是常態化審批的第一家民營銀行。富民銀行以「扶微助創、富民興邦」為使命，緊密圍繞服務小微、三農和創新創業，開展數字普惠金融的服務方式和業務模式創新。成立以來富民銀行圍繞中小企業客戶需求，開發出富民寶、富易貸、電子票據極速貼現等數字化特色產品，受到央行肯定和客戶認可。截至2021年末，資產總額541億元，各項貸款377億元，負債總額502億元，各項存款286億元，累計服務客戶超1000萬。

**金融資產管理。**2017年，瀚華金控聯合地方國企主發起成立註冊資本10億元的遼寧省第一家地方資產管理公司—遼寧富安金融資產管理有限公司（「**富安資產**」）。富安資產立足遼寧，輻射全國，為金融機構及企業提供不良資產轉讓處置、債務重組、投資管理、融通創新等服務。

# Chairman's Report

## 董事長報告

As a Chinese proverb says, everything goes through ups and downs as seasons change. Looking back on 2021, the persistent COVID-19 pandemic severely impacted every aspect of economic, social and financial activities, leaving SMEs struggling to sustain their operations. In the face of the complex and changing market environment, the Company managed to cope with the adverse factors by proactively adapting to new changes and requirements of customers and business partners and enhancing its digital capability while maintaining stable operations, which has achieved considerable results.

**New business grew steadily.** In 2021, the transaction amount of non-financing guarantee business amounted to RMB38.6 billion, representing an increase of 131.7% as compared to that of 2020. In particular, electronic bid guarantee business grew rapidly and registered transaction amount of RMB34.2 billion (2020: RMB9.3 billion), taking a leading position in the industry. By leveraging Hanhua Cloud Chain platform, Hanhua's electronic guarantee business has been officially put into operation in more than 230 urban public resources trading centres in 28 provinces across the country, including Sichuan, Shandong, Zhejiang, Jiangsu, Anhui, Guangdong, Hunan and Shaanxi. In 2021, the average outstanding balance per customer of non-financing guarantee business was RMB800,000. Our non-financing guarantee business segment has provided services to tens of thousands of customers, effectively reducing the financial burden of SMEs and improving transaction efficiency.

四時更替，萬物循生。回首2021年，新冠疫情仍未消散，經濟、社會、金融各方面受到全方位衝擊，中小企業生存環境依然嚴峻。面對複雜多變的市場環境，公司在堅持穩健經營的基礎上，努力克服不利因素，主動適應客戶、合作夥伴的新變化、新需求，加大數字化能力建設，取得明顯成效。

**新型業務穩步增長。**2021年非融資擔保業務發生額386億元，較2020年增幅131.7%，其中，電子投標保函業務快速增長，業務發生額達到342億元（2020年：人民幣93億元），並居於行業領先地位。目前通過瀚華雲鏈平台，瀚華電子保函已在四川、山東、浙江、江蘇、安徽、廣東、湖南、陝西等全國28個省份、230餘個城市公共資源交易中心正式上線，2021年非融資擔保業務單戶平均在保餘額80萬元，累計服務客戶數萬戶，有力減輕了中小企業資金負擔，提升了交易效率。

# Chairman's Report

**Structural adjustment has achieved initial success.** Upholding the principles of “staying close to the livelihood of people, staying close to the industry and serving SMEs”, the Company developed its guarantee business in a prudent, steady and moderate manner. In response to the changes in the market environment, the Company promoted digital transformation and adjusted business structure, and proactively shifted its focus to non-financing guarantee business in 2021. As at the end of 2021, the balance of non-financing guarantee business was RMB16.3 billion, representing a year-on-year increase of 34.0%; while the balance of financing guarantee business was RMB16.1 billion, representing a year-on-year decrease of 26.7%. With Hanhua Guarantee as the mainstay, the Company has concentrated its efforts on developing towards digital finance, proactively connected industry scenarios and enhanced scenario building to actualize comprehensive digital operations. Fu'an Asset has established cooperation with more than 40 banks, including state-owned banks, joint-stock banks, city commercial banks, rural commercial banks and rural credit cooperatives, and has acquired RMB27.3 billion of non-performing assets since its establishment. At the end of 2021, the debt assets under management of Fu'an Asset amounted to RMB7.25 billion. Fumin Bank has been striving to innovate the service modes and business models of digital inclusive finance to better serve SMEs, agriculture industry, rural areas and farmers and innovative startups, and recorded total comprehensive income of RMB360 million in 2021. The digital featured products developed by Fumin Bank, such as Fumin Bao, Fuyi Loan and E-Bills Quick Discounting, were recognized by the People's Bank of China and well-received in the market.

**Asset quality improved significantly.** In 2021, we further worked towards “safety first, customer base upgrade, comprehensive income and compliant credit extension”, and implemented whole-process risk management and control at all levels through “product management”. As a result, the quality of our assets continued to improve, while core risk management indicators such as default payment and default rate continued to decline. In 2021, the default rate was 0.4%, representing a decrease of 0.2 percentage point as compared to that of 2020. As at the end of 2021, the collateral coverage rate of traditional financing guarantee business was 66.0%. The collateral coverage rate of bond guarantee business was over 80%, and over 90% of the bonds guaranteed had an “AA” or higher issuer credit rating.

**結構調整初見成效。**公司圍繞「貼近民生、貼近實業、服務中小企業」理念，審慎、穩健、適度的發展擔保業務。根據市場環境變化，主動進行數字化轉型和業務結構調整，2021年度主動向非融資擔保業務傾斜，2021年末非融資擔保業務餘額163億元，同比增幅34.0%；融資擔保業務餘額161億元，降幅26.7%。以瀚華擔保為主體，聚焦數字化金融發展方向，主動鏈接產業場景，強化場景建設，全面開展數字化運營。富安資產與40餘家國有銀行、股份制銀行、城商行、農商行、農信社達成合作，自開業以來，累計收購不良資產債權273億元。2021年末，在管理債權規模72.5億元。富民銀行緊密圍繞服務小微、三農、和創新創業，開展數字普惠金融的服務方式和業務模式創新，2021年實現綜合收益總額3.6億元，其開發的富民寶、富易貸、電子票據極速貼現等數字化特色產品，受到央行肯定和市場認可。

**資產質量明顯改善。**2021年繼續堅持「安全第一、客群上移、綜合收益、授信規範」的風險管控邏輯，堅持以「產品管理」為載體，實行全流程全員風險管控。資產質量持續提升，核心風險管理指標如代償金額、代償率均呈持續下降態勢。2021年代償率0.4%，較2020年下降0.2個百分點。2021年末，傳統融資擔保業務整體抵押覆蓋率為66.0%。債券擔保業務中有抵質押物的佔比超過80%，在保債券中，發行人主體評級在AA及以上佔比超過90%。

Looking ahead, technologies such as the Internet, big data, cloud computing, artificial intelligence and blockchain have profoundly changed all industries, and the digitalization of the financial industry is picking up pace. Hanhua will always keep in mind its original aspiration to provide financial services to the development of SMEs, and take the initiative to innovate and reform to benefit from the development of digital economy in the new era.

**With digital transformation as the core strategy.** With the increasing sophistication of technologies, the financial industry is well-positioned to reform its service mode, marketing model and risk control model through technological means and thereby upgrade its growth model. After 17 years of development, the Company has successfully established a professional, standardized and inclusive market brand, and accumulated rich resources in terms of business licenses, management teams, technologies and market networks. The Company will build on its success to start a new chapter by promoting comprehensive digital transformation, and move towards digital finance by applying new technologies and techniques to its products, services and operations, thereby enhancing its capability in an all-round way to better serve SMEs and reconstructing its own development model.

**With building fintech capabilities as the core mission.** The financial sector has a vocation to serve the real economy and support industrial development, and the digitisation of finance must be premised on in-depth collaboration and connection with industry scenarios. In this regard, we will have in-depth cooperation with industry scenarios that meet needs of national strategies and social development and have sufficient customer base and potential for expansion, a complete industrial chain and a stable competitive landscape, so as to create accurate customer profiling and labeling and digitalize operations. We will further enhance our risk management capability by creating a digital risk control model, developing a more professional and efficient approval mechanism, optimizing our forward-looking risk prevention and control system and building a strong risk management system and team.

展望未來，互聯網、大數據、雲計算、人工智能、區塊鏈等技術已深刻改變各行各業，金融業的數字化正在加速推進。瀚華將始終牢記服務中小企業發展的初心，主動創新變革，搶抓新時代下數字經濟發展紅利。

**以數字化轉型作為核心戰略。**隨著技術手段的日趨成熟，金融業利用科技改變服務模式、營銷模式、風控模式，從而改變自身增長模式，已經具備條件並得到驗證。公司歷經17年發展，已成功樹立專業、規範、普惠的市場品牌，沉澱了牌照、團隊、科技和市場資源，在此基礎上，以全面數字化轉型作為新一輪佈局的起點，堅定數字金融發展方向，將新科技、新技術運用到產品、服務、運營各方面，全方位提升中小微企業服務能力，重構發展模式。

**以打造金融科技能力作為核心任務。**金融以服務實體經濟、支持產業發展為天職，金融數字化須以深度協同和鏈接產業場景為前提。與契合國家戰略和社會發展需要，有足夠客群和延展空間，有完整產業鏈條，穩定競爭格局的行業場景進行深度合作，精準畫像，構建標籤，數字化運營。持續提升風險管理能力，打造數字化風控模式，構建更加專業、高效的審批機制，完善前瞻式風險防控體系，建設強大風險系統與團隊。

### **With digital organizational capability as the bedrock.**

Digitisation requires innovative, agile and efficient organizational capabilities. Therefore, we will streamline our governance structure and strengthen value growth and sustainable development. In particular, we will build a streamlined and efficient organizational system by delegating more authority to lower-level management and shorten decision-making process, thereby improving organizational efficiency. We will design an innovative talent management system to adjust personnel structure, improve per capita efficiency, and stimulate organizational vitality. We will also build a robust long-acting evaluation and incentive mechanism to promote stable and sustainable development.

The Group pursued a “customer-oriented” strategy in business expansion. Externally, “single customer access and unified credit standards” have been implemented through “customer expansion and risk management” to improve the quality of customer service; internally, with the objectives of “integration of functions and efficiency enhancement”, it strengthened the integration of functions, especially the mid-and-back office, for higher operating efficiency and lower operating cost. In 2021, the Group continued to operate through four major business segments, namely the partnership finance business segment, the micro and small loan business segment, the capital investment and management business segment and other segment.

### Partnership finance business segment:

Partnership finance business segment mainly engages in the provision of integrated financing services for SME clients covered by the national operating network of the Group, which primarily include credit guarantee, capital business (capital business mainly includes receivables for factoring business, bill discount, entrusted loans), financial assets management and other services.

### Micro and small loan business segment:

Micro and small loan business segment consists of eight small loan companies in Chongqing, Chengdu, Tianjin, Shenyang, Nanning, Guiyang, Nanjing and Shenzhen, as well as institutions with functions such as information consulting, asset management and credit services, with focus on offering “small-amount and diversified” integrated financial services to various micro and small enterprises, individual business proprietors and individuals.

### Capital investment and management business segment:

This segment provides capital investment services to certain SMEs that have growth potential and value, by utilization of its own funds and raising funds through cooperation with external institutions.

本集團圍繞「以客戶為中心」的策略拓展業務。對外，以「客戶拓展、風險管理」為手段，實施「單一客戶入口、統一授信標準」，以提升客戶服務質量；對內，以「職能整合、提升效率」為目標，加強職能部門尤其是中後台職能部門的整合，以提升運營效率，降低運營成本。2021年，本集團經營仍以四大業務分部開展，分別是夥伴金融業務集群分部、小微信貸業務分部、資本投資及管理業務分部及其他分部。

### 夥伴金融業務集群分部：

以本集團位於全國的經營網絡，主要面向廣大中小企業客戶提供綜合性金融服務解決方案，主要包括信用擔保、資金業務（資金業務主要包括應收賬款保理、票據貼現、委託貸款）、金融資產管理、以及其他服務。

### 小微信貸業務分部：

小微信貸業務分部由註冊於重慶、成都、天津、瀋陽、南寧、貴陽、南京及深圳的八家小額貸款公司以及具備信息諮詢、資產管理、信用服務等功能的機構組成，專注於為廣大小微企業、個體工商戶及個人提供「小額、分散」的綜合性金融服務解決方案。

### 資本投資及管理業務分部：

利用自有資金，以及通過與外部機構合作募集資金，向具有成長空間和增長價值的特定中小企業提供資本投資服務。

Other segment:

This segment represents the aggregation of other business lines and the operational results that undertake management functions of the headquarters and cannot be completely divided into any of the above segments.

The Group has continued to adjust the business structure and customer structure, and provide integrated financial services to micro, small and medium-sized enterprises (“MSMEs”) and individuals based on the “customer-oriented” strategy. At the same time, “performance management” has been used as a means to enhance the risk control awareness of all staff. Assets quality of new businesses improved significantly as admission criteria for new customers was strengthened and management on collaterals was stepped up. Meanwhile, the recovery of historical non-performing assets was strengthened and achieved good progress.

In 2021, the net profit of the Group amounted to RMB112.3 million, representing a decrease of RMB95.7 million or 46.0% as compared to the net profit of RMB208.0 million in 2020, the analysis of which is as follows:

- **Remarkable results have been achieved effectively in the transformation of credit guarantee business, the electronic bid guarantee products continued to maintain a rapid growth trend and took a leading position in the industry, gradually becoming a new profit growth point for the Group’s guarantee business.**

其他分部：

指承擔總部管理職能以及無法完全劃分為上述任一分部的其他業務條線及經營業績。

本集團始終圍繞「以客戶為中心」的戰略，不斷調整業務結構和客戶結構，向廣大中小微企業和個人提供綜合性金融服務；同時，以「績效管理」為手段，強化全員風險管控意識，在提升新客戶准入標準和強化抵質押物管理的同時，新發生業務的資產質量得到明顯改善；與此同時，加強歷史不良資產清收，且取得良好的績效。

2021年，本集團淨利潤為人民幣112.3百萬元，與2020年淨利潤人民幣208.0百萬元相比，減少人民幣95.7百萬元，降幅46.0%。相關分析如下：

- 信用擔保業務轉型成效顯著，電子投標保函產品持續保持高速增長態勢，處於行業領先地位，逐漸成為本集團擔保業務新的利潤增長點。

In order to effectively reduce the transaction costs of market entities, reduce the burden of SMEs, simplify the transaction process, improve the transaction efficiency and improve the service function of the electronic bidding and procurement platform, the Group took a forward-looking approach and developed the electronic guarantee platform for bidding and procurement at the end of 2018. Since the issuance of the first electronic bid guarantee at the Dazhou Public Resources Trading Centre, Sichuan Province in December 2018, the electronic bid guarantee has been officially put into operation in more than 230 urban public resources trading centres in 28 provinces across the country, including Sichuan, Shandong, Zhejiang, Jiangsu, Anhui, Guangdong, Hunan and Shaanxi, with rapid development.

The electronic bid guarantee business continued to maintain a rapid growth trend and registered transaction amount of RMB34,216.7 million in 2021 (2020: RMB9,338.1 million), taking a leading position in the industry and gradually becoming a new profit growth point for the Group's guarantee business.

Due to the delay of the contribution of new electronic bid guarantee business to operating income, and the reduced scale of traditional financing guarantee business and bond guarantee business, the Group's net guarantee and consulting fee income generated from credit guarantee business in 2021 decreased by RMB51.0 million or 9.7% as compared to that of 2020.

- **In view of the default in payment of some commercial acceptance bills held under receivables for factoring business, the Group has made adequate provision for impairment losses to cope with the potential risk of loss.**

為切實降低市場主體交易成本，減輕中小企業負擔，簡化交易環節，提高交易效率，完善電子招標採購平台服務功能，本集團於2018年底前瞻性的開發了招投標採購電子保函平台。自2018年12月在四川省達州市公共資源交易中心成功簽發首單電子投標保函以來，電子投標保函現已在四川、山東、浙江、江蘇、安徽、廣東、湖南、陝西等全國28個省份的230餘個城市公共資源交易中心正式上線運行。

2021年，電子投標保函業務發生額達到人民幣34,216.7百萬元（2020年：人民幣9,338.1百萬元），繼續保持高速增長態勢，並處於行業領先地位，已逐漸成為本集團擔保業務新的利潤增長點。

由於新型電子投標保函業務對營業收入的貢獻存在一定的時間延遲，而傳統融資擔保業務和債券擔保業務因其業務規模下滑，使得本集團2021年信用擔保業務產生的擔保及諮詢費淨收入較2020年下降人民幣51.0百萬元，降幅9.7%。

- 針對應收賬款保理業務下持有的部分商業承兌匯票出現逾期兌付的現象，本集團已計提充足的減值準備以應對潛在的損失風險。

### 財務概要

In 2021, the default in payment of commercial acceptance bills issued by certain enterprises led to an increase in the default rate of receivables for factoring business of the Group with the collection of commercial acceptance bills as the main repayment source. As at 31 December 2020 and 31 December 2021, the balance of overdue receivables for factoring business was RMB58.3 million and RMB376.0 million, respectively, representing a year-on-year increase of RMB317.7 million or 544.9%. As a result, the interest and handling fee income from the receivables for factoring business decreased to RMB130.9 million in 2021, representing a decrease of RMB79.1 million or 37.7% as compared with RMB210.0 million in 2020.

The Group established a special working group to take stock of overdue bills, actively communicated with bill acceptors, bill holders and bill endorsers, and implemented specific collection plans according to the specific conditions of each business. At present, significant progress has been made and the ultimate risk of loss is manageable. Nevertheless, the Group has adopted a prudent assessment system and made adequate provision for impairment of overdue receivables for factoring business to enhance its anti-risk capacity. In 2021, the provision for impairment losses of receivables for factoring business of the Group was RMB138.3 million, representing an increase of RMB126.8 million or 1,102.6% as compared with the provision for impairment losses of RMB11.5 million in 2020. As at 31 December 2021, the provision rate of the receivables for factoring business was 14.3% (31 December 2020: 3.2%), representing a significant year-on-year increase.

2021年，市場上個別企業開具的商業承兌匯票出現逾期兌付現象，導致本集團以商業承兌匯票托收款為主要還款來源的應收賬款保理業務逾期率上升。截至2020年12月31日及2021年12月31日，已逾期應收賬款保理業務餘額分別為人民幣58.3百萬元和人民幣376.0百萬元，增加人民幣317.7百萬元，增幅544.9%。受此影響，2021年，應收賬款保理業務產生的利息及手續費收入降至人民幣130.9百萬元，較2020年應收賬款保理業務利息及手續費收入人民幣210.0百萬元，下降人民幣79.1百萬元，降幅37.7%。

本集團成立了專門工作組對逾期票據進行了盤點，積極與票據承兌企業、持票人、票據背書人等進行溝通，根據每筆業務的具體情況實施特定的清收方案，目前已取得了重大進展，終極損失風險可控。儘管如此，本集團仍採取審慎的評估體系，對逾期應收賬款保理業務計提了充足的減值準備來增強其抗風險能力。2021年，本集團對應收保理款計提的資產減值損失為人民幣138.3百萬元，與2020年應收保理款提取的資產減值損失人民幣11.5百萬元相比，增加人民幣126.8百萬元，增幅1,102.6%。截至2021年12月31日，應收賬款保理業務撥備率為14.3%（2020年12月31日：3.2%），撥備率水平大幅提高。

- **The scale of credit lending business of the micro and small loan business segment funded by its own working capital was reduced for the purpose of business transformation and upgrading with effectiveness; while the scale of credit consulting business relating to credit service output capability remained stable.**

In order to achieve the purpose of business transformation and upgrading with effectiveness, the micro and small loan business segment proactively adjusted its business structure and gradually reduced the credit lending business funded by its own working capital. As a result, the balance of credit lending business of the micro and small loan business segment was RMB679.9 million as at 31 December 2021, representing a decrease of RMB976.3 million or 58.9% as compared with RMB1,656.2 million as at 31 December 2020.

Since 2018, the micro and small loan business segment has leveraged the Group's accumulated experience, capabilities and strengths in micro and small loan services to provide credit consulting business to financial institutions such as external partner banks, including assistance in obtaining clients, standardized risk assessment services and post-loan management service, and charged certain service fee based on services provided. As at 31 December 2020 and 31 December 2021, the balance of credit consulting business was RMB4,195.8 million and RMB4,134.1 million, respectively, representing a year-on-year decrease of 1.5%, remaining relatively stable.

- 為有效實現業務轉型升級，小微信貸業務分部以自有運營資金開展的信貸服務業務規模下降；同時，與信用能力輸出相關的信用服務業務規模保持穩定。

為有效實現業務轉型升級，小微信貸業務分部主動調整業務結構，逐步壓縮以自有運營資金開展的信貸服務業務，受此影響，截至2021年12月31日，小微信貸業務分部信貸服務業務餘額為人民幣679.9百萬元，與2020年12月31日信貸服務業務餘額人民幣1,656.2百萬元相比，減少人民幣976.3百萬元，降幅58.9%。

自2018年開始，小微信貸業務分部利用本集團在小微金融服務領域積累的經驗、能力和優勢，為外部合作銀行等金融機構提供信用類服務，包括協助獲取客戶、協助標準化風險評估服務、貸後協助管理服務等，並依據提供服務的內​​容收取一定的服務費。截至2020年12月31日及2021年12月31日，信用服務業務餘額分別為人民幣4,195.8百萬元和人民幣4,134.1百萬元，降幅1.5%，呈相對穩定態勢。

- **The assets quality of credit guarantee business enhanced continuously, with core risk management indicators such as default payments and default rate on a downward trend.**

In 2021, the total default payments of the Group for defaulting clients was RMB165.8 million, representing a decrease of RMB6.0 million or 3.5% as compared with RMB171.8 million in 2020. Meanwhile, in 2021, the default rate of the Group's credit guarantee business (default rate = current default payment amount/current guarantee amount released) was 0.4% only, representing a significant decline as compared with 0.6% in 2020.

- **With the continued enhancement in cost management, the refined management system was gradually formed, which resulted in the continuous decline in operating expenses.**

In 2021, the Group reported operating expenses of RMB633.4 million, representing a decrease of RMB40.7 million or 6.0% as compared with the operating expenses of RMB674.1 million in 2020. The decrease was mainly due to: (1) the continuous enhancement of human resources management by the Group and the continuous improvement of operational efficiency through "process reconstruction and performance adjustment" resulted in a further decrease in the number of employees. As at 31 December 2021, the total number of employees of the Group was 1,125, representing a significant decrease as compared with 1,377 employees as at 31 December 2020; (2) the Group commenced to purchase commercial properties as its own office premises to gradually phase out the original leasing of offices in certain cities with business since 2017. With more commercial properties purchased being gradually put into use, the operating expenses relating to office leasing have been declining; and (3) the Group continued to adopt cost optimization management measures and actively reduced various non-essential expenses. As a result of the combined impact above, the operation and administrative expenses showed a declining trend.

- 信用擔保業務資產質量持續提升，其核心風險管理指標如代償金額、代償率均呈持續下降態勢。

2021年，本集團為違約客戶支付的代償款項總額為人民幣165.8百萬元，與2020年支付的代償款項人民幣171.8百萬元相比，減少人民幣6.0百萬元，降幅3.5%。同時，2021年本集團信用擔保業務代償率（代償率=當期代償金額/當期解除擔保金額）僅為0.4%，與2020年代償率0.6%相比，有較大程度的下降。

- 持續加強成本管理，成本精細化管理體系逐步形成，營運支出呈下降趨勢。

2021年，本集團營運支出為人民幣633.4百萬元，較2020年營運支出人民幣674.1百萬元，減少人民幣40.7百萬元，降幅6.0%。其下降主要源於：(1)本集團持續加強人力資源管理，通過「流程再造、績效調整」等方式持續提升運營效率，使得員工人數持續下降。截至2021年12月31日，本集團在崗員工總數1,125人，較截至2020年12月31日在崗員工總數1,377人明顯減少；(2)本集團自2017年開始在部分業務拓展城市購買商業房產作為辦公場所，並逐步替換原有租賃模式。隨著商業房產逐步購買並投入使用，與辦公場地租賃相關的運營成本呈下降態勢；(3)本集團持續採取成本優化管理措施，主動縮減各類非必要的開支。上述措施綜合影響，使得業務及管理費呈下降態勢。

In 2021, the Group continued to adopt cost optimization management measures to control various expenses. As a result, the percentage of such expenses in respect of the total operating expenses remained stable without drastic fluctuations.

- **The commercial bank initiated by the Company developed rapidly with steady operation.**

The Company and six other domestic institutions jointly established Chongqing Fumin Bank Co., Ltd. in 2016. The Company invested RMB900.0 million in Fumin Bank for its 30% equity interest and became its largest shareholder. In accordance with the requirements of the accounting standards, this investment is accounted for using the equity method by the Company.

Fumin Bank adhered to its position in the inclusive financial market and focused on the digital development. With products as its means and business as its bridge, Fumin Bank actively initiated digital financial service business and service innovation. By adhering to the path of exploring differentiated characteristics, Fumin Bank achieved better results and social benefits. Its assets and liabilities maintained a balanced growth trend in the past several years. As at 31 December 2021, Fumin Bank had total assets of RMB54,131.2 million (31 December 2020: RMB53,177.2 million) and total liabilities of RMB50,247.7 million (31 December 2020: RMB49,652.2 million). Meanwhile, its profitability remained stable. In 2021, Fumin Bank achieved the total comprehensive income of RMB358.5 million (2020: RMB227.5 million). Accordingly, the Group recorded gains of RMB107.6 million in “share of profits of associates” in respect of its investment in Fumin Bank in 2021.

2021年，本集團持續採取成本優化管理措施，嚴控各項費用開支，各項費用項目佔營運支出總額的比例保持相對穩定狀態，並無劇烈波動。

- 公司發起設立的民營銀行發展迅速，經營穩健。

於2016年，本公司與境內六家機構共同發起設立重慶富民銀行股份有限公司，本公司以人民幣900.0百萬元對富民銀行進行出資並持有富民銀行30.0%的權益，完成出資後本公司為富民銀行的第一大股東。按照會計準則的要求，本公司採用權益法核算此筆投資。

富民銀行堅守普惠金融市場定位，聚焦數字化發展方向，以產品為抓手，以業務為橋樑，積極開展數字金融服務的業務及服務模式創新，堅定探索差異化特色發展道路，取得較好的經營成效和社會效益，資產規模和負債規模在過去幾年處於均衡增長態勢。截至2021年12月31日，富民銀行資產總額為人民幣54,131.2百萬元（2020年12月31日：人民幣53,177.2百萬元），負債總額為人民幣50,247.7百萬元（2020年12月31日：人民幣49,652.2百萬元）。同時，其盈利能力保持穩定，2021年，富民銀行共計實現綜合收益總額人民幣358.5百萬元（2020年：人民幣227.5百萬元）。據此，2021年本集團記錄於「聯營企業投資收益」中與此相關的收益為人民幣107.6百萬元。

### BUSINESS AND FINANCIAL REVIEW

#### Credit guarantee

##### Business expansion and products

The Group kept improving its product portfolio based on the macroeconomic environment and market conditions, in combination with needs of business development in the future, to provide more diversified product support for business marketing. At the same time, the Group revised and optimized some of its existing products to meet market changes, and continuously improved product popularity and competitiveness. In addition, the Group will continue its product innovation. Such strategies will promote the constant improvement of the Group's business product portfolio. The Group's guarantee products primarily include guarantee for direct financing and sale under repurchase agreement transactions through bank and other fund channels; guarantees for bonds issued on the stock exchange market, inter-bank markets and other channels; and other forms of non-financing guarantees such as electronic bid guarantee and pledge and performance guarantee for construction projects.

The Group adhered to the principles of compliant operations and "encouragements and discouragements", and effectively integrated the macroeconomic control policies and industry policies of the government to develop the guarantee business in a prudent, steady and appropriate manner. As at 31 December 2021, the Group's outstanding guarantee balance of the credit guarantee business was RMB32,452.1 million, representing a decrease of RMB1,709.9 million or 5.0% as compared with RMB34,162.0 million as at 31 December 2020. Remarkable results have been achieved effectively in the transformation of credit guarantee business, the rapid development of the electronic bid guarantee business, which has been a key focus of the Company in recent years, has led to a significant increase in the balance of non-financing guarantee business. As at 31 December 2020 and 31 December 2021, the balance of non-financing guarantee business was RMB12,195.0 million and RMB16,340.7 million, respectively, representing a year-on-year increase of 34.0%. On the other hand, the balance of financing guarantee business further declined. As at 31 December 2020 and 31 December 2021, the balance of financing guarantee business was RMB21,967.0 million and RMB16,111.4 million, respectively, representing a year-on-year decrease of 26.7%.

#### 業務及財務回顧

#### 信用擔保

##### 業務拓展及產品

本集團根據宏觀經濟環境和市場狀況，結合未來業務發展需要，不斷完善產品體系，為業務營銷提供更加多元化的產品支撐。同時，本集團根據市場變化修改完善部份已有產品，不斷提高產品使用度和競爭力。此外，本集團還將持續進行產品創新，這一系列工作將促進本集團業務產品體系的持續完善。本集團擔保業務產品主要包括：為客戶通過銀行以及其他資金渠道的直接融資、賣出回購交易提供擔保；為客戶通過交易所市場、銀行間市場以及其他渠道發行債券提供擔保；以及其他形式的電子投標保函、工程保證及履約擔保等非融資擔保業務。

本集團堅持依法合規經營，堅持「有保有壓」的原則，有效結合國家宏觀調控政策和產業政策，審慎、穩健、適度的發展擔保業務。截至2021年12月31日，本集團信用擔保業務在保餘額為人民幣32,452.1百萬元，較2020年12月31日在保餘額人民幣34,162.0百萬元，減少人民幣1,709.9百萬元，降幅5.0%。信用擔保業務轉型成效顯著，公司近年來重點發展的電子投標保函業務發展迅速，使得非融資擔保業務餘額大幅上升。於2020年12月31日及2021年12月31日，非融資擔保業務餘額分別為人民幣12,195.0百萬元和人民幣16,340.7百萬元，增長34.0%。與此同時，融資擔保業務餘額進一步下滑。於2020年12月31日及2021年12月31日，融資擔保業務餘額分別為人民幣21,967.0百萬元和人民幣16,111.4百萬元，下降26.7%。

### Traditional financing guarantee business

Traditional financing guarantee business mainly includes bank financing guarantee and other non-bank financing guarantee. In 2021, the transaction amount of traditional financing guarantee business was RMB4,332.9 million, representing a decrease of RMB3,532.3 million or 44.9% as compared with RMB7,865.2 million in 2020. As at 31 December 2021, the Group's outstanding balance of traditional financing guarantee business was RMB4,152.4 million, representing a decrease of RMB2,585.6 million or 38.4% as compared with RMB6,738.0 million as at 31 December 2020.

The decrease was due to the successful release of certain bond guarantees upon maturity of relevant bonds. Most issuers of the bonds guaranteed by the Group started to repay the principal in installments in the third year from the issuance year to reduce their pressure to repay the principal and the interest in one lump sum at maturity; In addition, the Group provided guarantee for newly issued bonds worth of RMB1,500 million in 2021 (2020: Nil).

The maximum period of the bonds guaranteed by the Company is seven years, and issuers of most bonds begin to repay the principal gradually from the third year, in order to relieve the pressure for repayment of the principal due on one-off basis. In terms of the balance of a single bond, the outstanding bond guarantee balance will show a declining trend year by year. As at the date of approval of this report, the principal and interest of all the City Investment Bonds guaranteed by the Group have been normally repaid, without any exception.

### Non-financing guarantee

The Group also offers non-financing guarantee services whereby the Group acts as the guarantor and undertakes to pay one party (i.e. the creditor) a certain amount if another party (i.e. the principal) fails to meet certain obligations (such as fulfilling the terms of a contract). To reduce the Group's credit risks, the Group requires business owners or controlling persons of the principal to provide counter-guarantees, which make them jointly and severally liable together with the principal when the Group incurs a loss. The non-financing guarantee products mainly comprise electronic bid guarantee and project performance guarantee (collectively, the “**non-financing guarantee business**”).

To meet the demands for “project performance guarantee” by the construction industry, the Group designed specific products by taking into account the operating features of the construction industry, and assisted a number of construction and engineering construction enterprises which met certain qualifications in their business expansion by issuing “bid guarantee, performance guarantee and prepayment guarantee”.

In order to effectively reduce the transaction costs of market entities, reduce the burden of SMEs, simplify the transaction process, improve the transaction efficiency and improve the service function of the electronic bidding and procurement platform, the Group took a forward-looking approach and developed the electronic guarantee platform for bidding and procurement at the end of 2018. Since the issuance of the first electronic bid guarantee at the Dazhou Public Resources Trading Centre, Sichuan Province in December 2018, the electronic bid guarantee has been officially put into operation in more than 230 urban public resources trading centres in 28 provinces across the country, including Sichuan, Shandong, Zhejiang, Jiangsu, Anhui, Guangdong, Hunan and Shaanxi, with rapid development.

### 非融資擔保

本集團也提供非融資擔保服務，據此本集團擔任擔保人，並承諾倘若其中一方（即委托人）無法履行若干責任（例如滿足合約條款），則向另一方（即債權人）支付若干金額。為降低本集團信用風險，本集團要求經營者或委托人的控制人士提供反擔保，他們於本集團蒙受損失時須與委托人共同及各自承擔連帶責任，非融資擔保產品主要是電子投標保函及工程履約擔保（以下合稱「**非融資擔保業務**」）。

基於建築施工行業對於「工程履約保函」業務的需求，本集團結合建築施工行業的運營特徵，設計特定的產品，為符合一定資質要求的建築、工程施工企業開立「投標保函、履約保函、預付款保函」，協助其業務拓展。

為切實降低市場主體交易成本，減輕中小企業負擔，簡化交易環節，提高交易效率，完善電子招標採購平台服務功能，本集團於2018年底前瞻性的開發了招投標採購電子保函平台。自2018年12月在四川省達州市公共資源交易中心成功簽發首單電子投標保函以來，電子投標保函現已在四川、山東、浙江、江蘇、安徽、廣東、湖南、陝西等全國28個省份230餘個城市公共資源交易中心正式上線運行，業務發展迅速。

In 2021, the transaction amount of the non-financing guarantee business was RMB38,609.0 million, representing an increase of RMB21,943.4 million or 131.7% as compared with RMB16,665.6 million in 2020, which was mainly due to the rapid growth of electronic bid guarantee business. Although the transaction amount of the non-financing guarantee business increased significantly in 2021, the balance of non-financing guarantee business did not increase proportionally due to the small amount and short term of single electronic bid guarantee business. As at 31 December 2021, the balance of non-financing guarantee business was RMB16,340.7 million, representing an increase of RMB4,145.7 million or 34.0% as compared with RMB12,195.0 million as at 31 December 2020.

Due to the small amount and short term of single electronic bid guarantee business, as at 31 December 2020 and 31 December 2021, the balance of non-financing guarantee business with guarantee amount of each transaction less than RMB3 million was RMB5,221.9 million and RMB11,848.5 million, respectively, accounting for 42.8% and 72.5% of the total balance of non-financing guarantee business, respectively. As at 31 December 2020 and 31 December 2021, the balance of non-financing guarantee business due within six months amounted to RMB7,268.0 million and RMB12,245.5 million, respectively, accounting for 59.6% and 74.9% of the total balance of non-financing guarantee business, respectively.

The Group did not include the default payment for the principal and interest of a targeted debt financing instrument when calculating relevant indicators of the Group's credit guarantee business such as the default payment amount, default rate, etc. in 2020. After the default payment for the targeted debt financing instrument was made, the Group made corresponding provision for impairment losses based on the controlled collateral and prudent consideration of future cash recovery. The Group believes that this default payment is only an isolated and exceptional event.

- (2) Provision for impairment losses of receivables for default payments divided by guarantee released.
- (3) Recovered amount divided by default payments made on behalf of defaulting clients.
- (4) Provisions for guarantee losses divided by the balance of the outstanding guarantees. Provision rate indicates the level of reserve which the Group set aside for the guarantee portfolio.

After years of development, the partnership finance business segment has developed an independent risk culture and risk management system. The Group applied the general principles of risk management that aim to “focus on quality and seek progress while maintaining stability; adjust the structure and enhance quality and efficiency; manage by classification and engage in bottom-line thinking; and optimize models and carry out transformation and upgrading”, and further worked towards “safety first, customer base upgrade, comprehensive income and compliant credit extension” in 2021.

**Safety first:** The Group adheres to the principles of unified customer access and single debtor, small amount dispersion and reasonable installments. For new customers, in the market survey phase, the Group strengthened customer admission standards and efforts in on-site investigation and management of uncertain risks. While focusing on the primary repayment source, the Group also developed the secondary repayment source by strengthening acquisition and management of collaterals, so as to reduce the ultimate risk. As at 31 December 2021, the collateral coverage of traditional financing guarantee business was 66.0% (31 December 2020: 72.7%). Furthermore, the Group raised all staff's awareness of risk management by fully implementing the administrative rules for distribution of performance-based bonus after the “discharge of guarantee liabilities” among the members of all business units and teams.

經過多年的發展，夥伴金融業務集群分部已經形成獨立的風險文化和風險管理體系。在堅持「質量為本、穩中求進；調整結構、提質增效；分類管理、底線思維；模式優化、轉型升級」的風險管理總體原則基礎之上，2021年繼續堅持「安全第一、客群上移、綜合收益、授信規範」的風險管控邏輯。

**安全第一：**堅持客戶入口統一和一個債務人原則，堅持小額分散、合理分期原則。對於增量客戶，在市場調研階段，提高客戶的准入標準，加強對客戶不確定性風險的現場調研和管理力度。堅持第一還款來源的同時，通過加強抵質押物的獲取及管理形成第二還款來源，以降低終極風險。截至2021年12月31日，傳統融資擔保業務整體抵押覆蓋率為66.0%（2020年12月31日：72.7%）。同時，堅持全員風險管理，在所有業務機構及團隊成員中，全面推行「擔保責任解除」後發放績效獎金的管理辦法。

**Customer base upgrade:** We preferred to select the consumer industry that has growth potential and manufacturing industry with room for development in the emerging markets. Meanwhile, the Group firmly withdrew from surplus industries with relatively high inventory pressure as well as the industries with low efficiency of resource allocation, and gradually developed “partnership finance, supply chain finance, capital market” as its three major customer bases and business direction.

**Comprehensive income:** While granting business units with the risk pricing power for a single business, the Group set the principles on minimum comprehensive pricing guidelines to achieve the balance between risk and return. Moreover, the Group achieved overall upgrade of comprehensive income by utilizing the partnership finance business segment, the sound financial instruments of Hanhua Financial and by offering customers with integrated financial service solutions.

**Compliant credit extension:** The Group published policies on credit extension periodically and adjusted the same from time to time through “product management” on the basis of research and studies. Meanwhile, it strengthened the standardization of operational procedures to achieve comprehensive management of the entire process of “pre-loan, in loan and post-loan stages, and the disposal and recovery of non-performing assets” so as to reduce operational risk.

In 2021, the total default payments of the Group paid on behalf of defaulting clients amounted to RMB165.8 million, representing a decrease of RMB6.0 million or 3.5% as compared with RMB171.8 million in 2020. The overall default rate of the Group shows the quality of the Group’s guarantee portfolio. In 2021, the Group’s default rate was 0.4%, representing a decrease of 0.2 percentage point as compared with 0.6% in 2020. The decrease in the amount of default payments and default rate in 2021 indicate that the asset quality of the Group’s guarantee business has significantly improved. This was mainly due to the Group’s continued efforts in adjusting customer structure and business structure and vigorously developing electronic bid guarantee business nationwide that features short guarantee term, small amount of each transaction and low risk, which has diversified business risks while increasing business turnover rate.

**客群上移：**優先選擇具備一定成長性的消費產業以及具有明確新興市場空間的製造業，同時本集團堅決退出去庫存壓力比較大的過剩行業以及資源分配效率低下的行業，逐步確立「夥伴金融、供應鏈金融、資本市場」三大客群及業務方向。

**綜合收益：**在賦予業務機構對單筆業務的風險定價權的基礎之上，設定最低綜合價格指導原則，實現風險與收益的對等。同時，利用夥伴金融業務集群甚至瀚華金控完善的金融工具，通過向客戶提供綜合金融服務解決方案，實現綜合收益的整體提升。

**授信規範：**以「產品管理」為載體，在充分調研和研究的基礎上，定期發佈並動態調整授信政策；與此同時，加強操作流程的標準化建設，實現「貸前、貸中、貸後、不良資產處置及清收」的全流程管理，降低操作風險。

2021年本集團為違約客戶支付的代償款項總額為人民幣165.8百萬元，與2020年代償款項人民幣171.8百萬元相比，下降人民幣6.0百萬元，降幅3.5%。本集團整體代償率顯示本集團擔保組合質量，2021年本集團代償率為0.4%，與2020年本集團代償率0.6%相比，下降0.2個百分點。2021年代償金額和代償率的下降，顯示本集團擔保業務資產質量明顯提升，主要源於本集團不斷調整客戶結構和業務結構，在全國範圍內大力推廣週期短、單筆金額小、風險低的電子投標保函業務，在業務周轉率提高的同時，分散了業務風險。

The Group assessed the recoverability, recovery amount and recovery time of receivables for default payments on an item-by-item basis, mainly based on the collaterals and counter-guarantee provided by clients, compared the present value of potentially recoverable amount and default amount and recognized the difference as impairment losses of receivables for default payments. As most of the Group's collaterals are assets related to commercial real estate and land, the prices of which are relatively stable in recent years and the Group expects that such assets can be disposed of with discount in the future to recover cash quickly, the Group made provision for impairment losses of RMB51.4 million for existing receivables for default payments in 2021. As at 31 December 2021, the Group's provision rate of receivables for default payments (provision rate = provision for impairment of receivables for default payments/original value of receivables for default payments) was 35.6%, representing an increase of 1.7 percentage points as compared with 33.9% as at 31 December 2020.

For defaulting clients, the Group stepped up management on collateral and disposal of non-performing assets so as to rapidly recover funds. In 2021, the Group recovered cumulative default payments of RMB113.8 million from defaulting clients (2020: RMB118.2 million) with recovery ratio (recovery ratio = current recovery amount/current default payments) of 68.6% for 2021 (2020 : 68.8%).

Provision rate of the credit guarantee business represents the level of reserve which the Group set aside for the potential guarantee losses. As at 31 December 2021, the Group's balance of provisions for guarantee losses was RMB322.1 million (31 December 2020: RMB358.6 million). As at 31 December 2021, the provision rate of our credit guarantee business was 1.0% (31 December 2020: 1.0%), remaining stable. As at 31 December 2021, the proportion of provisions for guarantee losses in terms of all types of guarantee products was basically equivalent to that as at 31 December 2020.

本集團主要依據客戶提供的抵押物情況、反擔保情況對應收代償款潛在的回收可能性、回收金額、回收時間點等進行逐筆評估，並將可能回收金額的現值與代償款金額進行比較，將差額確認為應收代償款資產減值損失。由於本集團絕大部分的抵質押物為商業房地產、土地等相關資產，鑒於該類資產近年來價格保持相對穩定以及本集團預期未來通過折扣等方式快速處置此類資產以期快速回籠現金，本集團2021年針對存量應收代償款計提資產減值損失人民幣51.4百萬元。截至2021年12月31日，本集團應收代償款撥備率（撥備率=應收代償款減值準備/應收代償款原值）為35.6%，與2020年12月31日撥備率33.9%相比，增加1.7個百分點。

對於違約客戶，本集團加強抵質押物管理和不良資產處置力度，以期快速回籠資金。2021年，本集團從違約客戶處累計回收現金人民幣113.8百萬元（2020年：人民幣118.2百萬元），2021年回收比率（回收比率=當期回收金額/當期代償金額）為68.6%（2020年：68.8%）。

信用擔保業務的撥備率，代表本集團就潛在賠付所作出的儲備水平。截至2021年12月31日，本集團針對信用擔保業務計提的擔保賠償準備金餘額為人民幣322.1百萬元（2020年12月31日：人民幣358.6百萬元）。截至2021年12月31日，我們信用擔保業務的撥備率為1.0%（2020年12月31日：1.0%），撥備率水平保持穩定。截至2021年12月31日，我們針對各類擔保產品所承擔的擔保餘額計提的擔保賠償準備金比例與2020年12月31日相比基本相當。

**Substandard:** *The solvency of the borrower is obviously undermined. The borrower is unable to pay the principal and interest in full with his or her normal income. A loss might be incurred even if the guarantee is executed.*

**Doubtful:** *The borrower fails to pay the principal and interest in full. A material loss will be incurred definitely even if the guarantee is executed.*

**Loss:** *The principal and interest are unrecoverable in full or at all after all possible actions are taken or all necessary legal procedures are implemented.*

The partnership finance business segment satisfied customers' demand for funding of different maturities, costs and trading structure through entrusted loans and receivables for factoring. As at 31 December 2020 and 31 December 2021, the balance of capital business of the partnership finance business segment amounted to RMB1,653.8 million and RMB1,625.5 million, respectively, representing a year-on-year decrease of RMB28.3 million or 1.7%. In 2021, the default in payment of commercial acceptance bills issued by certain enterprises led to an increase in the default rate of receivables for factoring business of the Group with the collection of commercial acceptance bills as the main repayment source. As at 31 December 2020 and 31 December 2021, the balance of overdue receivables for factoring business was RMB58.3 million and RMB376.0 million, respectively, representing a year-on-year increase of RMB317.7 million or 544.9%. As a result, the net interest income generated from the capital business showed a downward trend. In 2020 and 2021, net interest and handling fee income from the partnership finance business segment was RMB214.8 million and RMB152.7 million, respectively, representing a year-on-year decrease of RMB62.1 million or 28.9%.

**關注類:** 儘管借款人目前有能力償還貸款本息，但存在一些可能對償還產生不利影響的因素。

**次級類:** 借款人的還款能力出現明顯問題，完全依靠其正常收入無法足額償還貸款本息，即使執行擔保，也可能會造成一定損失。

**可疑類:** 借款人無法足額償還貸款本息，即使執行擔保，也肯定要造成較大損失。

**損失類:** 在採取所有可能措施或一切必要的法律程序之後，本息仍然無法收回，或只能收回極少部份。

夥伴金融業務集群分部利用委托貸款、應收賬款保理的方式，以滿足客戶不同期限、不同成本、不同交易結構的資金需求。截至2020年12月31日及2021年12月31日，本集團夥伴金融業務集群資金業務餘額分別為人民幣1,653.8百萬元和人民幣1,625.5百萬元，下降人民幣28.3百萬元，降幅1.7%。2021年，市場上個別企業開具的商業承兌匯票出現逾期兌付現象，導致本集團以商業承兌匯票托收款為主要還款來源的應收賬款保理業務逾期率上升。截至2020年12月31日及2021年12月31日，已逾期應收賬款保理業務餘額分別為人民幣58.3百萬元和人民幣376.0百萬元，增加人民幣317.7百萬元，增幅544.9%。受此影響，資金業務產生的淨利息收入呈下滑態勢。2020年及2021年，夥伴金融業務集群分部產生的利息及手續費淨收入分別為人民幣214.8百萬元和人民幣152.7百萬元，下降人民幣62.1百萬元，降幅28.9%。

### Risk management and assets quality

The Group satisfied customers' financing demand through the credit guarantee business and direct financing. In each case, it adhered to the principle of "unified customer access and single debtor", so as to set a universal credit standard and credit line. For details on the risk management policy of the capital business of the partnership finance business segment, please refer to the section headed "Risk management and assets quality" of the credit guarantee business.

As at 31 December 2021, the balance of overdue capital business of the partnership finance business segment was RMB445.2 million, representing an increase of RMB270.9 million or 155.4% as compared with RMB174.3 million as at 31 December 2020, which was mainly due to the increase in overdue receivables for factoring business. As a result, the balance of impaired capital business of the partnership finance business segment increased to RMB207.9 million as at 31 December 2021, representing an increase of RMB174.8 million or 528.1% as compared with RMB33.1 million as at 31 December 2020.

As at 31 December 2021, the balance of provision for impairment losses of capital business in the partnership finance business segment was RMB193.8 million (31 December 2020: RMB83.7 million), with provision rate of 11.9% (31 December 2020: 5.1%). After occurrence of past due events relating to receivables for factoring business with the collection of commercial acceptance bill as the main repayment source, the Group established a special working group to take stock of overdue bills, actively communicated with bill acceptors, bill holders and bill endorsers, and implemented specific collection plans according to the specific conditions of each business. At present, significant progress has been made and the ultimate risk of loss is manageable. Nevertheless, the Group has adopted a prudent assessment system and made adequate provision for impairment of overdue receivables for factoring business to enhance its anti-risk capacity.

無論向客戶提供信用擔保業務還是直接提供資金，以滿足客戶的資金需求，本集團始終堅持「客戶入口統一及一個債務人原則」，以統一授信標準和授信額度。有關夥伴金融業務集群分部資金業務的風險管理政策，請參閱信用擔保業務「風險管理及資產質量」部份。

截至2021年12月31日，夥伴金融業務集群分部已逾期資金業務餘額為人民幣445.2百萬元，較2020年12月31日餘額人民幣174.3百萬元，上升人民幣270.9百萬元，增幅155.4%，主要源於逾期應收賬款保理業務上升所致。受此影響，截至2021年12月31日，夥伴金融業務集群分部已減值資金業務餘額亦增至人民幣207.9百萬元，較2020年12月31日餘額人民幣33.1百萬元，增加人民幣174.8百萬元，增幅528.1%。

截至2021年12月31日，夥伴金融業務集群分部資金業務資產減值準備餘額為人民幣193.8百萬元（2020年12月31日：人民幣83.7百萬元），資金業務撥備率為11.9%（2020年12月31日：5.1%）。本集團在以商業承兌匯票托收款為主要還款來源的應收賬款保理業務發生逾期後，成立了專門工作組對逾期票據進行了盤點，積極與票據承兌企業、持票人、票據背書人等進行溝通，根據每筆業務的具體情況實施特定的清收方案，目前已取得了重大進展，終極損失風險可控。儘管如此，本集團仍採取審慎的評估體系，對逾期應收賬款保理業務計提充足的減值準備來增強其抗風險能力。

### Financial assets management

In April 2017, the Group, as the promoter, jointly established Liaoning Fu'an Financial Asset Management Co., Ltd. with three other companies in the People's Republic of China ("PRC"). Fu'an Asset has a registered capital of RMB1,000.0 million, and all shareholders of Fu'an Asset had made contribution in cash in accordance with the relevant requirements under the investors' agreement. On 4 July 2017, Fu'an Asset obtained the approval of operation from the regulators, and the filing with China Banking Regulatory Commission ("CBRC") has been completed on 2 January 2018. As at 31 December 2021, the Group holds 60.0% equity interest of Fu'an Asset.

Pursuant to the business license obtained by Fu'an Asset, its business scope includes acquisition; entrusted operation and management of non-performing assets of financial institutions and non-financial institutions; management of, investment in and disposal of non-performing assets; debt restructuring and corporate restructuring; debt-to-equity swap business, management of, investment in and disposal of equity assets; external investment and management; financial, investment, legal, and risk management advisory and consulting business.

As a leading comprehensive and inclusive financial service group in the PRC, the Group strives to pursue new development opportunities in the financial services industry through equity investment and integration of platform resources, so as to provide comprehensive financial services to MSMEs and fulfill their diversified financing and business needs.

### 金融資產管理

於2017年4月，本集團作為發起人，與境內其他三家公司合資設立遼寧富安金融資產管理有限公司。富安資產的註冊資本為人民幣1,000.0百萬元，各股東已按照出資人協議的相關要求，完成貨幣資金出資。富安資產已於2017年7月4日獲得監管機構批覆，獲准開業，並於2018年1月2日完成在中國銀行業監督管理委員會（「中國銀監會」）備案。截至2021年12月31日，本集團持有富安資產60.0%的權益。

根據富安資產所獲取的營業執照，其業務範圍包括收購、受托經營金融機構和非金融機構不良資產，對不良資產進行管理、投資和處置；債務重組及企業重組；債權轉股權，對股權資產進行管理、投資和處置對外投資及管理；財務、投資、法律及風險管理諮詢和顧問業務。

本集團作為中國領先的綜合性普惠金融服務集團，一直致力於通過股權投資和平台資源整合，把握金融服務業之發展新機遇，為中小微企業提供全面的金融服務以滿足其多樣化的融資及業務需求。

In order to regulate the batch transfer, acquisition and disposal business of non-performing assets of financial enterprises, and effectively prevent and eliminate financial risks, according to the Administrative Measures on the Batch Transfer of Nonperforming Assets of Financial Enterprises, Notice on Relevant Issues Concerning Conditions for Qualification Licensing of Local Asset Management Companies to Carry out the Batch Purchase and Disposal of Non-performing Assets of Financial Enterprises, and the Letter of the General Office of CBRC in relation to the Appropriate Adjustment of Relevant Policies on Local Asset Management Company, provincial people's governments may establish an additional local asset management company, the disposal of the non-performing assets is permitted by way of debt restructuring, external transfer, etc., and the transferee of the external transfer is free from regional restrictions. These provide market opportunities for social capital, especially private capital to participate in mitigating and stimulating the non-performing assets of local financial institutions.

The establishment of Fu'an Asset is an important part of the overall strategic layout of building an inclusive finance ecosystem of the Group, which will enrich and extend its layout of the integrated finance ecosystem. As an integral part of the partnership finance business segment, Fu'an Asset will leverage the existing business team and institutional layout in actively seizing opportunities in the development of asset management market in the "New Normal" economic environment of the PRC. Coordinating existing financial business resources, it will provide comprehensive integrated financial services to MSMEs in their entire life cycle and further enhance the integrated business strength of the Group.

為規範金融企業不良資產批量轉讓、收購和處置業務，切實防範和化解金融風險，根據《金融企業不良資產批量轉讓管理辦法》、《關於地方資產管理公司開展金融企業不良資產批量收購處置業務資質認可條件等有關問題的通知》及《中國銀監會辦公廳關於適當調整地方資產管理公司有關政策的函》，各省級人民政府允許增設一家地方資產管理公司，允許以債務重組、對外轉讓等方式處置不良資產，對外轉讓的受讓主體不受地域限制。這為社會資本特別是民營資本參與地方金融機構不良資產的化解盤活，提供了市場機會。

富安資產是本集團構建普惠金融生態圈整體戰略佈局的重要組成部份，將進一步豐富和延伸本集團綜合金融生態佈局。富安資產作為夥伴金融業務集群分部的重要組成部份，將依托現有業務團隊及機構佈局，積極把握中國經濟新常態下金融資產管理市場發展機遇，協同現有金融業務資源為中小微企業全生命週期提供全要素綜合金融服務，進一步提升本集團的綜合經營實力。

### MICRO AND SMALL LOAN BUSINESS SEGMENT

Micro and small loan business segment, which consists of eight small loan companies in Chongqing, Chengdu, Tianjin, Shenyang, Nanning, Guiyang, Nanjing and Shenzhen, as well as institutions with functions such as information consulting, asset management and credit services, has mainly focused on offering small-amount and diversified integrated financial services to various micro and small enterprises, individual business proprietors and individuals (hereinafter collectively referred to as “**small and micro customers**”). Among them, small loan companies in Chongqing, Sichuan, Shenyang and Shenzhen have obtained the qualification for “lending loan on the internet”.

The micro and small loan business segment has gradually developed “credit lending business based on self-loan” and “credit consulting business based on market development and credit assessment”, by virtue of its years of experience in serving small and micro clients, and its own capabilities and strengths as well as combining relevant regulatory policies and industry characteristics. These two business models have formed a variety of service portfolios around the small and micro customer market, and rationalized and adjusted business structure through business portfolios with “different risk levels and different profit levels”, thus improving service capabilities for small and micro customers.

### 小微信貸業務分部

小微信貸業務分部由註冊於重慶、成都、天津、瀋陽、南寧、貴陽、南京及深圳的八家小額貸款公司以及具備信息諮詢、資產管理、信用服務等功能的機構組成，主要為廣大小微企業、個體工商戶及個人（以下合稱「**小微客戶**」）提供「小額、分散」的綜合性金融服務解決方案。其中，位於重慶、四川、瀋陽、深圳的小額貸款公司已經獲得「互聯網放貸」的資格。

小微信貸業務分部借助多年服務小微客戶的經驗，根據自身能力和優勢，並結合相關的監管政策和行業特點，逐步發展出「以自營貸款為主的信貸服務」和「以市場開發及信用評估為主的信用服務」兩大業務模式。兩大業務模式形成了圍繞小微客戶市場的多種服務組合，通過「不同風險程度、不同收益程度」的業務組合，實現業務結構的合理化調整，並提升了對小微客戶的服務能力。

### Credit Lending Business:

It mainly refers to small loan companies with granting qualification leading the issuance of loans to small and micro customers with their own working capital (including registered capital and external financing funds), while the Group is responsible for marketing to customers, due diligence, risk review and post-loan management, and the Group is entitled to the income and assumes the risks related thereto.

### Credit Consulting Business:

It mainly refers to the Group's provision of credit consulting business to financial institutions such as external partner banks by leveraging its accumulated experience, capabilities and strengths in micro and small loan services, including assistance in obtaining clients, standardized risk assessment services and post-loan management service, while external partner financial institutions conduct independent evaluation on small and micro customers based on their own understanding of small and micro customers and risk tolerance, and make independent decision about whether to provide services.

In the course of cooperation with various financial institutions, both parties share information, exchange resources, and give full play to their resource and technological advantages, with a view to jointly provide credit lending business to small and micro customers. The Group's strengths lie in its risk awareness and experience built on serving customer groups over the years in the small and micro customer sector, as well as special risk control capacities, nationwide network and team, and sound credit service output capability.

### 信貸服務：

主要指具有放款資格的小額貸款公司完全主導並以自有運營資金（包括註冊資本金及外部融入資金）向小微客戶發放貸款，其客戶營銷、盡職調查、風險審查、貸後管理等工作以及與此相關的收入和風險都由本集團自行享有和承擔。

### 信用服務：

主要指利用本集團在小微金融服務領域積累的經驗、能力和優勢，為外部合作銀行等金融機構提供信用類服務，包括協助獲取客戶、協助標準化風險評估服務、貸後協助管理服務等；外部合作金融機構在此基礎上，結合自身對小微客戶的理解和風險承受能力，對小微客戶開展獨立評估，並自行作出提供或拒絕資金服務的決定。

在與各類金融機構開展合作的過程中，雙方共享信息、互換資源，充分發揮雙方的資源優勢、技術優勢，共同為小微客戶提供信貸類服務。本集團的優勢在於，多年來持續在小微客戶領域所積累的對該類客戶群體的風險認識和服務經驗、所建立的特色風控能力、全國性網絡與團隊以及良好的信用服務輸出能力。

As at 31 December 2021, the balance of assets under management of the micro and small loan business segment was RMB4,814.0 million, representing a decrease of RMB1,038.0 million or 17.7% as compared with RMB5,852.0 million as at 31 December 2020. The decrease was mainly due to a further reduction in assets under management of the credit lending business.

截至2021年12月31日，小微信貸業務分部管理的資產規模為人民幣4,814.0百萬元，與2020年12月31日管理的資產規模人民幣5,852.0百萬元相比，減少人民幣1,038.0百萬元，降幅17.7%。主要源於信貸服務業務規模的進一步下降。

In order to achieve the purpose of business transformation and upgrading with effectiveness, the micro and small loan business segment proactively adjusted its business structure and gradually reduced the credit lending business funded by its own working capital. As a result, the balance of assets under management of credit lending business of the micro and small loan business segment was RMB679.9 million as at 31 December 2021, representing a decrease of RMB976.3 million or 58.9% as compared with RMB1,656.2 million as at 31 December 2020.

為有效實現業務轉型升級，小微信貸業務分部主動調整業務結構，逐步壓縮以自有運營資金開展的信貸服務業務，受此影響，截至2021年12月31日，小微信貸業務分部信貸服務管理的資產規模為人民幣679.9百萬元，與2020年12月31日管理的資產規模人民幣1,656.2百萬元相比，減少人民幣976.3百萬元，降幅58.9%。

Leveraging the Group's accumulated experience, capabilities and strengths in micro and small loan services, the micro and small loan business segment provided credit consulting business to financial institutions such as external partner banks, including assistance in obtaining clients, standardized risk assessment services and post-loan management service, and charged certain service fee based on services provided. As at 31 December 2020 and 31 December 2021, the balance of credit consulting business was RMB4,195.8 million and RMB4,134.1 million, respectively, representing a year-on-year decrease of 1.5%.

The table below sets out key assets quality indicators of credit lending business in the Group's micro and small loan business segment as at the dates indicated:

In 2021, in accordance with the overdue and impairment characteristics of products, the Group made reversal for impairment losses of RMB6.6 million, representing a decrease of RMB46.1 million or 87.5% as compared with the reversal for impairment losses of RMB52.7 million in 2020. In 2021, the amount of impairment losses charged to the current statement of profit or loss was reversed, mainly due to the decreased balance of credit lending business as at 31 December 2021 which resulted in a decrease in the balance of provision for impairment losses for the loan asset portfolio as at 31 December 2021.

Provision rate indicates the level of the Group's reserves for potential future risks in respect of the small and micro credit business. As at 31 December 2021, the balance of provisions for impairment losses of micro and small loan business segment was RMB84.4 million (31 December 2020: RMB94.6 million), with a provision rate of 12.4% (31 December 2020: 5.7%).

2021年，本集團結合產品逾期及減值特徵，轉回資產減值損失人民幣6.6百萬元，與2020年轉回的資產減值損失人民幣52.7百萬元相比，減少人民幣46.1百萬元，降幅87.5%。2021年計入當前損益表的資產減值損失金額呈轉回狀態，主要是因為截至2021年12月31日信貸服務的貸款餘額減少，使得截至2021年12月31日的信貸資產組合需要計提的資產減值準備金餘額下降所致。

撥備率反映了本集團就小微信貸業務未來潛在風險的儲備水平。截至2021年12月31日，小微信貸業務分部資產減值準備餘額為人民幣84.4百萬元（2020年12月31日：人民幣94.6百萬元），撥備率為12.4%（2020年12月31日：5.7%）。

As at 31 December 2021, the overdue balance of micro and small loan business segment was RMB276.5 million, representing an increase of RMB59.4 million or 27.4% as compared with RMB217.1 million as at 31 December 2020. The proportion of overdue loan business increased to 40.7% as at 31 December 2021 (31 December 2020: 13.1%) due to the decline in loan balance of credit lending business. Overdue loans are mainly from the “Jiaye Loan” business. Jiaye Loan is a product with sufficient collaterals and its primary repayment source requirement is more relaxed than that of small and micro financial products. Although the amount and proportion of overdue loans increased, there was no fundamental change in the overall risk level. As at 31 December 2021, the balance of overdue Jiaye Loan business was RMB193.9 million, accounting for 70.1% of the balance of overdue loan business.

As at 31 December 2021, the balance of impaired loans of the micro and small loan business segment was RMB33.6 million, basically unchanged as compared with RMB33.3 million as at 31 December 2020. However, due to the decrease in the balance of credit lending business, the proportion of impaired loans in the loan balance of credit lending business increased from 2.0% as at 31 December 2020 to 4.9% as at 31 December 2021.

### CAPITAL INVESTMENT AND MANAGEMENT BUSINESS SEGMENT

The capital investment and management business segment uses capital owned by the Group and aligns with other institutions in fund raising to provide capital investment services to specific SMEs demonstrating growth potential and value.

In early 2015, the Group started to engage in capital investment and management business. In terms of fund raising, the Group worked together with external organizations that aim to serve SMEs to raise capital by way of funds, with a special focus on industry funds established by government authorities at any levels and listed companies. As at 31 December 2021, the Group successfully established 8 funds with external investors (31 December 2020: 8), raising gross proceeds of RMB684.1 million (31 December 2020: RMB881.5 million).

截至2021年12月31日，小微信貸業務分部已逾期金額為人民幣276.5百萬元，較2020年12月31日逾期金額人民幣217.1百萬元，增加人民幣59.4百萬元，增幅27.4%。由於信貸服務貸款餘額下降，截至2021年12月31日，已逾期貸款業務佔比上升至40.7%（2020年12月31日：13.1%）。已逾期貸款主要來自於「佳業貸」業務，佳業貸是有足值抵押物的產品，對借款人的第一還款來源要求相較小微金融產品更寬鬆，雖然已逾期貸款業務金額和佔比增加，但整體風險水平無根本性變化。截至2021年12月31日，已逾期佳業貸業務餘額為人民幣193.9百萬元，佔已逾期貸款業務餘額的比例為70.1%。

截至2021年12月31日，小微信貸業務分部已減值貸款餘額為人民幣33.6百萬元，與2020年12月31日的人民幣33.3百萬元相比基本持平。但由於信貸服務的貸款餘額下降，已減值貸款佔信貸服務資產餘額的比例從2020年12月31日的2.0%上升至2021年12月31日的4.9%。

### 資本投資及管理業務分部

資本投資及管理業務分部指本集團利用自有資金，以及通過與外部機構合作募集資金，向具有成長空間和增長價值的特定中小企業提供資本投資服務。

2015年初，本集團開始涉足資本投資及管理業務。在資金募集方面，本集團與有志於服務中小企業的外部機構尤其是各級政府、上市公司設立的產業基金合作，以基金的形式募集資金，截至2021年12月31日，本集團已成功與外部投資者合作成立了8只基金（2020年12月31日：8只），合計從外部募集資金共計人民幣684.1百萬元（2020年12月31日：人民幣881.5百萬元）。

In terms of the use of proceeds, we provide small capital investment services to leading SMEs in their respective industries with stable operating and management teams and positive growth prospect in the existing clientele. As at 31 December 2021, RMB1,064.8 million (31 December 2020: RMB999.4 million) had been used for equity investment for long term returns from capital appreciation, and RMB140.9 million (31 December 2020: RMB162.2 million) for debt investment for stable return with the aim of effectively utilizing idle funds to enhance capital earning.

In 2021, the capital investment and management business segment derived total income of RMB10.8 million (2020: RMB11.9 million) from interest on debts invested. In addition, the Group recorded net gains of RMB23.8 million (2020: RMB9.8 million) from dividends from invested business and disposal of some equity interest in invested entities. Benefiting from the continuous development of the invested entities, the capital investment and management business segment achieved gains from fair value change of RMB8.1 million in 2021 (2020: RMB31.3 million).

Meanwhile, the Group makes provision for asset impairment associated with these creditor's rights by referring to the rules of risk management of capital business in the partnership finance business segment. In 2021, the Group made provision for asset impairment losses of RMB6.4 million (2020: reversal of impairment losses of RMB6.8 million). In respect of the Group's equity investment in specific SMEs, as at the date of approval of this report, the invested entities are running soundly and there is no indication of impairment.

在資金投向方面，一方面向現有客戶群體中那些在自身所處行業中處於前茅、具有穩定的經營管理團隊、行業及自身成長性較好的中小企業提供小額的資本投資服務；截至2021年12月31日，人民幣1,064.8百萬元資金用於股權投資（2020年12月31日：人民幣999.4百萬元），以獲得長期資本增值回報；另一方面為有效利用閒置資金以提升資金收益，人民幣140.9百萬元資金用於債權投資（2020年12月31日：人民幣162.2百萬元），以獲取穩定回報。

2021年，資本投資及管理業務分部共實現收入人民幣10.8百萬元（2020年：人民幣11.9百萬元），主要來自於債權投資獲取的利息收入。此外，本集團獲得被投資業務的股利分紅及處置被投資企業部份股權，獲得淨收益人民幣23.8百萬元（2020年：人民幣9.8百萬元）。得益於被投資企業的持續發展，2021年資本投資及管理業務分部實現公允價值變動收益人民幣8.1百萬元（2020年：人民幣31.3百萬元）。

與此同時，本集團參照夥伴金融業務集團分部對於資金業務風險管理的相關規定，對該類債權提取資產減值準備。2021年，共計提資產減值損失人民幣6.4百萬元（2020年：轉回資產減值損失人民幣6.8百萬元）。本集團對於特定中小企業所進行的股權投資，截至本報告批准刊發之日，被投資方經營狀況良好，未見其減值跡象。

In 2021, the Group's net income from interest and handling fee was RMB231.1 million, representing a decrease of RMB197.0 million or 46.0% as compared with the net income from interest and handling fee of RMB428.1 million in 2020. The decrease was mainly attributable to the decrease of interest and handling fee income.

In 2021, the Group's interest and handling fee income was RMB585.7 million, representing a decrease of RMB337.5 million or 36.6% as compared with RMB923.2 million in 2020. This decrease was mainly due to the decrease in interest and handling fee income generated from both micro and small loan business and receivables for factoring business as a result of the decreasing scale of the micro and small loan business and the increase in the overdue rate of receivables for factoring business.

In 2021, the Group's interest and commission expenses was RMB354.6 million, representing a decrease of RMB140.5 million or 28.4% as compared with the interest and commission expenses of RMB495.1 million in 2020, which was mainly due to the decrease of the interest-bearing liabilities of the Group. As at 31 December 2020 and 31 December 2021, the balance of interest-bearing liabilities of the Group amounted to RMB5,263.9 million and RMB3,204.7 million, respectively, representing a year-on-year decrease of 39.1%

Should any of our credit guarantee subsidiaries fail to pay any contingent liability under outstanding guarantee, the Group's liability under such outstanding guarantee will not have negative impact on the business and performance of other entities of the Group.

As at 31 December 2021, the outstanding balance of guarantees provided by our credit guarantee subsidiaries for certain small loans extended by our micro-credit subsidiaries was RMB155.6 million (31 December 2020: RMB311.6 million). Such small loans have been included in the loans and advances to customers in the Group's consolidated financial statements, and the aforesaid amount was not included in the balance of credit guarantee of the Group to avoid duplicate computation and overestimation of credit risk assumed by the Group. Should any of such credit guarantee subsidiaries be liquidated or bankrupt, these loans will not be guaranteed and our relevant micro-credit subsidiaries would be exposed to higher credit risk. As loans guaranteed by credit guarantee subsidiaries are individually insignificant and widely distributed, the Group believes any of these small loans ceasing to be guaranteed by credit guarantee subsidiaries will not have material impact on the business and performance of other subsidiaries.

### CAPITAL STRUCTURE, LIQUIDITY AND FINANCIAL RESOURCES

#### Capital structure

As at 31 December 2021, our share capital was RMB4,600.0 million comprising 3,430,000,000 domestic shares and 1,170,000,000 H shares, each with a face value of RMB1.00.

#### Liquidity and capital resources

We have funded our working capital and other capital requirements principally with capital contributions from shareholders, bank borrowings, bond issue, cash inflow from operating activities and proceeds from IPO. Our liquidity and other capital requirements are primarily related to micro and small loans and entrusted loans, default payments, restricted bank deposits, and other working capital needs.

As at 31 December 2021, we had cash and cash equivalents of RMB795.0 million (31 December 2020: RMB1,505.2 million). For the year ended 31 December 2021, the Group did not use any financial instrument for hedging purpose.

### INFORMATION TECHNOLOGY

Upholding the principle of integrating information technology with business strategies, the Company continued to formulate the informatization plan of the Group, optimize its information technology governance structure, and promote the construction of information technology infrastructure and important information systems based on the Company's business strategies, thereby ensuring the stable operation of its information systems and providing strong support for strengthening the management and business innovation of the Group.

#### Information Technology Governance

An information construction leading group has been set up at the management level with the president as the core member to play the role of major decision-making, important project establishment, coordination and supervision, thus forming a regular decision-making mechanism for information construction.

#### Information Planning

Focusing on its strategic goal of creating a Chinese sample of inclusive finance and on the basis of the existing information planning, the Company pushed forward the dynamic formulation of an information plan, and made clear that the priority for 2021–2022 is to optimize and upgrade business systems and manage data assets, so as to support the implementation of the Company's strategies and enhance its management and operating efficiency.

The Company effectively defined system boundaries and positioning by creating an integrated operation and maintenance process and improving relevant functions, and introduced new technologies to gradually realize automatic replacement of the whole process of core business system products, while leveraging modularization and cloud services to meet the market demand for rapid iteration of products, with a view to building an integrated business platform based on financial technology (fintech).

On the basis of the existing data warehouse, data mart and in-memory BI analysis tools, the Company built capabilities in internal and external data collection, unstructured data analysis and data tag creation. The Company acquired a full range of data assets, created complete connections among business objects, further protected and improved the value of data assets, in an effort to avoid the sinking of data assets.

### Information System Construction

According to the Group's management, business development and innovation needs, the Company accelerated the construction of various information systems.

In order to optimize human resources management and services, the Company improved the recording of organizational and personnel information in all aspects to form a complete set of personal data on employees, while providing mobile self-service functions to serve employees, setting annual performance targets and conducting performance appraisal through performance management functions, and improving employees' self-learning results through an online learning platform. The Company provided an approval process platform and mobile modeling platform with flexible configuration, and established and adjusted online approval procedures processes that can change rapidly in tandem with business development. A mature financial system is in place to handle all revenues and expenses and accounting procedures of the Company and provide employees with an online reimbursement mechanism. A stable knowledge management platform has been set up to manage and store various electronic files of the Company in a centralized manner and enhance the security of digital assets through encryption and watermarking functions. A number of communication and collaboration mechanisms including an email system, an instant messaging platform, a video conferencing platform, and an online conferencing platform, are employed to facilitate efficient collaboration among employees.

In respect of partnership finance, the Company insisted on “embracing the opportunities from industrial Internet, developing the supply chain finance and leveraging on financial technology”, identified industry pain points and bridged industrial scenarios by going deep in the industrial chain, and focused on target customers, thereby continuously improving its digital operation and service capability. The management firmly promoted the digital transformation of the Company, vigorously implemented the “customer centric” concept, developed a series of digital systems based on the objectives such as customer perceptions, contacts, transactions and services, and carried out continuous and iterative upgrade for such systems. Meanwhile, through continually optimizing the online service platform “Hanhua Cloud Chain”, the Company provided a unified customer-oriented portal, offering customers with comprehensive consultation, products, care and services. With iterative optimization of e-bonding system, the Company fully upgraded the micro-service system architecture to enhance system resilience and business support flexibility while safeguarding its business need. Through continually building up the system’s middle-office capabilities, and upgrading the membership center, clearing and settlement center, cashier and other subsystems, the Company improved the construction of sharing capabilities and promoted access to upper-level applications. The customer relationship management system (CRM) was upgraded to further improve and enhance the standardization during the sales process, build all-around profiles of customers, and enable the account managers to make precision marketing and services. In an effort to improve the standardization and efficiency of internal management, the Company promoted the iterative upgrade of core business systems, optimized its electronic seal management system, performance accounting system, data warehouse and BI analysis platform, and incorporated the value chain of business management into the information system to fully realize digital management, thus strengthening the standardization of business procedures, improving the risk control capabilities and enhancing the efficiency of internal collaboration.

In response to the Company's comprehensive digital transformation, the credit business optimized the structure of its former information construction team and made an adjustment to the department while maintaining its stable operation. The new team, while ensuring the continuation of traditional credit business, optimized and reinforced the credit-related business systems, continuously included new channels and funding providers into the systems in line with the business development, enhancing the flexibility of business channels. A new partner management system was developed to provide new tools for the front-end business partners, effectively improving the communication efficiency among the front, middle and back office and enhancing the Company's ability to manage its partners. In order to strengthen risk control decisions, the Company established a new risk control index platform to improve the automatic approval capability and reduce the failure risk of the existing system. In addition to supporting traditional business lines, the Company also initiated the construction of "Smart" series products, built a new procurement, sales and storage cloud system, and enabled access to payment channel services, thus achieving the integrated management of procurement, sales and finance for customers in the fast-moving consumer goods industry chain. Meanwhile, it broke the boundaries between the "Smart" series and traditional credit business, provided one-stop financial services to customers and effectively served the industry, laying a foundation for the Company to pursue higher business goals.

The Company advanced the construction of API gateways based on its enterprise data bus (EDB) to ensure the standardization and security of internal system APIs and save costs. The Company optimized and upgraded the existing communication and collaboration platform to eliminate the incompatibility problems at the user end, allowing employees to use it more smoothly and improving their office efficiency.

### Construction of Information Technology Infrastructure

Hanhua's private cloud was extended in depth. On the basis of the previous compression and integration of physical servers of the data center into a virtualization platform and with an aim to reduce costs and improve backup efficiency, the Company completed the design and implementation of a construction project of a disaster recovery platform based on its IT construction needs, thus realizing the shift from a decentralized manual backup model to a centralized and automatic backup platform that supports remote disaster recovery. Through the construction of a new unified monitoring platform, the Company conducted sampling analysis on all kinds of equipment and applications (e.g. hosts, network equipment, databases, and applications) and monitoring and processing of the massive data generated by the managed objects in a centralized manner, enabling rapid locating, analysis and handling of faults and risks. Based on the previous upgrade of the data center host to virtualization architecture, the Company deployed an anti-virus system in a virtualized environment by incorporating all server security functions into an integrated flexible platform which is integrated with the virtualization platform, so as to protect the virtual machine from viruses, spyware, Trojans and other malicious software attacks. The Company has completed the deployment of a vulnerability scanning platform which can scan vulnerabilities in the entire network and collect and analyze relevant information, so that the operation and maintenance personnel can keep track of the overall network security and timely secure equipment or systems with potential security risks.

瀚華私有雲的建設向縱深方向擴展。在前期數據中心實現物理服務器向虛擬化平台的壓縮整合基礎上，從降低投入成本、提高備份效率出發，結合自身信息化項目建設需求，完成了數據中心的災備平台建設項目方案設計及實施，實現了從過去分散式、手工的備份向集中式、自動化、支持異地容災的統一備份平台轉變。通過搭建新的統一監控平台，對各類設備和應用（主機、網絡設備、數據庫、應用）進行集中化的採集分析，對各類被管對象產生的大量數據進行集中監測處理，實現對各類故障、風險的快速定位和分析處理。在前期數據中心主機升級為虛擬化架構的基礎上，部署虛擬化環境防病毒系統，將所有服務器安全功能整合到一個全面的集成式靈活平台中，與虛擬化平台相集成，保護虛擬機免受病毒、間諜軟件、木馬和其他惡意軟件的攻擊。完成漏洞掃描平台的部署，對整個網絡中的漏洞進行掃描，並能夠進行集中管理，收集信息，匯總分析，讓運維人員掌握整體網絡安全狀況，並及時對存在安全隱患的設備或系統進行安全加固。

The Company strengthened the standardization of edge network system in branches. Through a unified management platform, the Company performs equipment and network security monitoring, centralized management and strategic management on all firewalls of branches nationwide to realize rapid distribution of strategies and unified early warning, and regularly submits and analyzes HSM management reports, so as to prevent network security incidents, protect its data assets and ensure the security of employees' working environment. The security control of the intranet has been strengthened and a Group-wide network access system has been implemented. Accordingly, non-intranet users' private connections to the intranet can be detected, pinpointed and effectively blocked.

### Information Technology Management Capabilities

In order to further standardize the management process of IT projects and improve the inter-departmental collaboration in information system development, the Company established an effective process supervision system, adjusted and optimized its demand management measures, test management measures, launch process and version management methods, ensuring the integrity and traceability of demands while improving the progress and quality of information system development projects. In an effort to strengthen user account management, enhance the compliance of production-related operations, prevent unauthorized operations, and improve the security of the production environment, the Company conducted an overhaul of account security in the production environment, strictly separated read and write permissions based on the operation requirements, cleaned up some non-compliant accounts, and traced and rectified illegal operations in the production environment through bastion host and video surveillance, thereby ensuring the safe and stable operation of the information system and preventing and reducing system or data access risks caused by illegal or improper operations.

加強了分支機構邊緣網絡體系的標準化建設。統一管理平台對全國分支機構所有防火牆進行設備及網絡安全監控、集中管理及策略管理，實現策略快速分發和統一告警，定期進行HSM管理平台報告提交分析，有效防範網絡安全事件發生，保障公司數據財產及員工辦公環境安全。加強了內網安全管控，全集團推行網絡准入系統，能夠對非內部用戶私自連接到內部網絡的行為進行檢查，準確定出位置，並對其進行有效阻斷。

### 信息科技管理能力

為了進一步規範信息項目管理流程，提升各部門在信息系統開發的整體協同能力，建立起有效的流程監管體系，相繼調整、優化了需求管理規範，測試管理規範，上線流程及版本管理辦法，保證了需求的完整性與可追溯性，同時也進一步提升了信息系統研發項目執行的進度與質量。為了強化用戶賬號管理，增強生產環境操作的合規性，杜絕未授權操作，提高生產環境的安全性，開展了生產環境賬號安全大檢查，根據操作需求嚴格區分生產環境的讀寫權限，清理與整治了一些不合規賬戶，並通過堡壘機與視頻監控對生產環境的違規操作進行了溯源與整改，有效地保障了信息系統的安全、穩定運行，切實防範和降低了因非法或不當操作對系統或數據訪問帶來的風險。

### HUMAN RESOURCES

“Talents” represent one of the most valuable assets of Hanhua Financial and are carefully nurtured. The Company has always been committed to building a high-standard professional team with “kindness, diligence, integrity, self-discipline and responsibility”. As at 31 December 2021, the total number of employees of the Group was 1,125, all of whom served in Mainland China and Hong Kong.

The Company attaches great importance to organizational culture building and employee care, promotes cultural cohesion through employee care, and incorporates corporate values and social responsibility into organizational culture. In 2021, the Company implemented and demonstrated employee care activities in many aspects: sending employees’ “Joining Anniversary” blessings through the Company’s online platform; launching a special event “Love in Chongyang” in conjunction with the labor union to thank employees’ families; building an internal communication platform, in which themed columns were launched to deepen the emotional connection between employees and their families, employees and employees, and employees and the Company during festivals such as the Double Ninth Festival and the Spring Festival, through communication and sharing activities, and enhanced employees’ sense of identity and belonging to the Company.

In terms of the construction of the honor system, the Company continues to carry out the five-year and tenth-anniversary recognition of employee service, and issue honorary certificates, thank-you letters and customized exclusive souvenirs to award-winning employees every year, in recognition of employees’ dedication and inheritance of corporate culture. In addition, the Company also recognizes outstanding employees, outstanding teams, and outstanding work cases of the year through the annual evaluation work, establishes a model of behavior, and stimulates a sense of honor and enthusiasm for work.

「人才」始終是瀚華最為重要且精心培育的資源之一，公司致力於打造「善良、勤奮、學習、自律、擔當」的高標準、專業化人才團隊。截至2021年12月31日，本集團在崗員工總數為1,125人，於中國內地及香港任職。

本公司高度重視組織文化建設與員工關懷，以員工關懷促文化凝聚，寓企業責任於組織文化。2021年，公司在多個方面貫徹和彰顯員工關懷活動：通過公司線上平台推送員工「入司紀念日」祝福；聯合工會發起「愛在重陽」特別活動，感恩員工家屬；搭建內部交流平台，在重陽節、春節等節慶時期推出主題專欄，通過交流、分享活動加深了員工與家人、員工與員工、員工與公司的情感鏈接，增強了員工對公司的認同感和歸屬感。

在榮譽體系建設方面，公司持續開展員工服務五周年、十周年表彰，每年為獲獎員工頒發榮譽證書、感謝信和定制的專屬紀念品，表彰員工奉獻，傳承企業文化。此外，公司還通過年度評優工作，表彰年度優秀員工、優秀團隊、優秀工作案例，樹立行為典範，激發榮譽感和工作熱情。

In terms of organizational management, in the fourth quarter of 2021, with the comprehensive advancement of the Company's digital transformation, in order to realize the focus on digital business strategy, the Company quickly restructured the organizational form, successively completed the organizational structure adjustment and personnel optimization, and started to sort the system of job positions and match the salaries of the job positions. So far, the Company has gradually transformed into an investment management platform, delegating more authority to lower-level management, shortening the decision-making chain, breaking information barriers, and at the same time improving the operational autonomy and flexibility of business units.

In terms of employee development, the Company has realized the continuous and stable operation of the digital management function, and the Company's training data has also been effectively controlled. The Company organizes a variety of learning activities, such as financial literacy competitions, time and listening online learning activities, etc. The Company's digital learning platform breaks the time and space constraints and efficiently meets the needs of localized learning development.

In terms of the remuneration and incentive system, the Company has formulated targeted remuneration, assessment and incentive measures based on business development diversity and individualized trends, and actively explored market-based distribution and incentive mechanisms such as business partnership and project partnership to create value together and the concept of benefit sharing and risk sharing to promote the continuous improvement of organizational efficiency. At the same time, the Company has optimized its welfare system, managed and cared about the general health of employees, and adopted multiple measures in social insurance, health examination, commercial insurance and other aspects to provide employees with comprehensive and practical protection. Using digital platform construction to create cross-functional and cross-system information transmission channels, implement automatic connection and calculation of multiple links such as report statistics, performance assessment and salary issuance, and greatly improve data accuracy and operational efficiency. In addition, in combination with organizational operations and employee needs, the Company initiated discussions on flexible welfare plans, mid-and long-term incentive systems and other individual plans to boost business development with the upgrade of the compensation and welfare system.

在組織管理方面，2021年四季度，伴隨公司數字化轉型的全面推進，為實現聚焦數字業務策略，公司快速重構組織形態，陸續完成了組織架構調整和人員優化，並著手開展崗位體系梳理與人崗薪匹配。至此，金控公司逐步轉型為投資管理型平台，下沉管理職能，縮短決策鏈條，打破信息壁壘，同時提高業務單位經營自主性和靈活性。

在員工發展方面，實現數字化管理功能持續穩定運營，公司培訓數據有效管控。組織豐富多樣的學習活動，如金融知識大賽、時光輕聽在線學習活動等。數字化學習平台打破時間和空間限制，高效滿足屬地化學習開展需求。

在薪酬與激勵體系方面，結合業務發展多樣性、個性化趨勢，針對性制定薪酬、考核與激勵辦法，並積極探索事業合夥制、項目合夥制等市場化分配和激勵機制，以價值共創、利益共享、風險共擔的理念，促進組織效能持續提升。同時優化公司福利體系，關注員工大健康管理與關懷，在社會保險、健康體檢、商業保險等方面多措並舉，給予員工全面、切實的保障。利用數字化平台建設，打通跨職能、跨系統的信息傳輸通道，實現報表統計、業績考核和薪資核發等多環節的自動化對接與運算，大幅提升數據準確性和運行效率。此外，結合組織運營與員工需求，啟動研討彈性福利方案、中長期激勵體系等個性方案，以薪酬福利體系升級助推業務發展。

In terms of human resources digitization, the development blueprint is systematically drawn and the implementation is actively promoted. The introduction of RPA (Robot Process Automation) has realized the centralized and automated operation of human resources transactional work. It has been successfully operated in salary calculation and individual tax declaration links, which has reduced costs and increased efficiency in human resources management. The internal social collaboration platform has achieved initial results, and the employee communication and service Q&A robot “Hanhua Xiao H” has been launched to answer common questions such as salary, social insurance, housing provident fund, personal income tax, and attendance for employees. Since its launch, Hanhua Xiao H has been used on an average of tens of thousands times per month, gradually covering various human resources service scenarios and becoming a good assistant for serving employees; human resources electronic signatures have made groundbreaking progress, and it has been successfully used in the recruitment groundbreaking investigation, salary confirmation and other scenarios, which has greatly improved the convenience and work efficiency of users. In 2021, Hanhua’s “My HR” human resources digitization case participated in the “2021 China Digital Transformation and Innovation Selection” and won the “Digital Service Model” case award.

在人力資源數字化建設方面，系統性描繪發展藍圖，積極推動落地。引進RPA（機器人流程自動化），實現人力資源事務性工作集中、自動化運作，目前已在薪資計算、個稅申報環節成功運行，促進了人力資源管理降本增效。內部社交協同平台初見成效，上線員工交流與服務問答機器人「瀚華小H」，為員工解答薪資、社會保險、住房公積金、個人所得稅、考勤等常見問題，自上線以來，月均使用人次上萬條，逐漸覆蓋各個人力資源服務場景，成為服務員工的好助手；人力資源電子簽章取得突破性進展，現已在招聘背景調查、薪資確認等環節成功投用，極大地提高了使用者的便捷性和工作效率。在2021年，瀚華「我的HR」人力資源數字化案例，參評「2021中國數字化轉型與創新評選」，榮膺「數字化服務典範」案例獎。

There was no breach of the laws and regulations during the Reporting Period.

### SHAREHOLDERS' RIGHTS

To safeguard shareholders' interests and rights, according to the Articles of Association, when an extraordinary general meeting is requested in writing by a shareholder individually or shareholders collectively holding at least 10% (inclusive of 10%) of the outstanding shares with voting rights of the Company, the Board shall convene an extraordinary general meeting within two months; when the Company is to hold an annual general meeting, shareholder(s) holding at least 3% (inclusive of 3%) of the shares of the Company with voting rights shall have the right to put forward temporary proposals in writing to the Company, and the Company shall list the issues in the temporary proposal that fall within the scope of responsibility of the general meeting in the meeting agenda.

All resolutions put forward at general meetings will be voted on by poll pursuant to the Listing Rules and poll results will be posted on the websites of the Company and the Hong Kong Stock Exchange in a timely manner after each general meeting.

### THE BOARD

#### Responsibilities

The Board is responsible for the overall leadership of the Group, overseeing the Group's strategic decisions, business and performance. The Board has delegated the authority and responsibility for day-to-day management and operation of the Group to the senior management of the Group. To oversee particular aspects of the Company's affairs, the second session of the Board has established four Board committees, including the audit committee (the "**Audit Committee**"), the nomination and remuneration committee (the "**Nomination and Remuneration Committee**"), the strategic investment committee (the "**Strategic Investment Committee**") and the risk management committee (the "**Risk Management Committee**") (collectively referred to as the "**Third Session of the Board Committees**"). The Board has delegated to the Board Committees responsibilities as set out in their respective terms of reference.

### Chairman and Chief Executive Officer

Code Provision A.2.1 stipulates that the roles of chairman and chief executive should be separate and should not be performed by the same individual. During the year ended 31 December 2021, Mr. Zhang Guoxiang has been the chairman of the third session of the Board and Mr. Cui Weilan has been the president of the Company. Mr. Zhang and Mr. Cui lead by example, perform their duties, commit to maintain the high standards of corporate governance for the Company.

### Appointment, Change and Re-Election of Directors

In accordance with the Articles of Association, the Directors shall be elected at the general meetings for a term of no more than three years, and may be re-elected and re-appointed upon the expiry of such term. The Company has implemented an effective mechanism regarding the appointment of a new Director. The Nomination and Remuneration Committee will first discuss the matters in relation to the appointment of new Director, and then present proposals to the Board, which will be subject to the approval at the general meeting.

### Director Nomination Policy

This Director Nomination Policy (the “Policy”) aims to: set out the criteria and process in the nomination and appointment of directors of the Company; ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate for the Company’s business needs; and ensure continuity of the Board and appropriate leadership at Board level.

In evaluating and selecting any candidate for directorship, the following criteria should be considered by the Nomination and Remuneration Committee and/or the Board: character and integrity, qualifications including professional qualifications, skills, knowledge and experience that are relevant to the Company's business and strategy, and the potential contribution to the Board from the diversity aspects under the Board Diversity Policy, any measurable objectives adopted for achieving diversity on the Board, willingness and ability to devote adequate time to discharge duties as a member of the Board and Board committee(s) of the Company. Meanwhile, in order to meet the Board Diversity Policy, the Nomination and Remuneration Committee and/or the Board may also conduct a wide search for candidates who are in the interests of the Company.

### Nomination Process of the Appointment of New Director

1. The Nomination and Remuneration Committee and/or the Board should, upon receipt of the proposal on appointment of new director and the biographical information (or relevant details) of the candidate, evaluate such candidate based on the criteria as set out above to determine whether such candidate is qualified for directorship.
2. If the process yields one or more desirable candidates, the Nomination and Remuneration Committee and/or the Board should rank them by order of preference based on the needs of the Company and reference check of each candidate (where applicable).
3. The Nomination and Remuneration Committee should then recommend to the Board to appoint the appropriate candidate for directorship (where applicable).
4. ### CHANGES OF MEMBERS OF SENIOR MANAGEMENT

Mr. Li Xuan has been a vice-president of the Company since June 2017, He Has resigned as a vice-president of the Company on 10 December 2021.

Mr. Cheng Xiaoqin has been a vice president of the Company since March 2018. The Company removed Mr. Cheng Xiaoqin from the position of Vice president, which took effect on 5 January 2022.

As at the date of this report, details of the Senior Management are set out under the section headed “Directors, Supervisors and Senior Management” of this report.

### RISK MANAGEMENT AND INTERNAL CONTROL

The Board recognizes its responsibilities in relation to monitoring the risk management and internal control system of the Company. It also performs supervision and inspection on the effectiveness of the risk management and internal control system through the Risk Management Committee and the Audit Committee on an annual basis. Risk management and internal control system are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Board has set up the Risk Management Committee, which is responsible for providing professional advice on risk management to the Board and making decisions on professional matters in relation to risk management under the authorization of the Board. The Risk Management Committee categorizes and streamlines the strategic risks, financial risks, operational risks and legal risks which potentially arise from operation of the Company, and assigns the duties of monitoring, initial assessment, formulating risk response strategy, implementation of strategy and alert of risk to different functions and departments. These functions and departments will then carry out initial risk information collection and risk assessment, while the internal control and audit department and the senior management of the Company will supervise and improve the risk management, and report to the Risk Management Committee as necessary.

### 風險管理及內部監控

Based on the business nature of the Company, the Company established the risk management special committee at its subsidiary level, which focused on the management of business risks such as operational risks under the supervision of the Risk Management Committee of the Board. The risk management special committee has three tiers and six regional risk review centres, which substantially optimize and reform the control procedures of credit risks, operational risks and legal compliance risks according to the principles of separation of front, middle and back offices and effective supervision and control. The risk management special committee also formulates regulatory documents such as the standard operating procedure and measures for managing operational risks, with a view to establishing an internal control and risk management system covering our whole business process. The business department collects raw information on risk and conducts risk assessment; the risk management department formulates business risk strategy and raise business risk resolutions; and the internal control and audit department and the senior management of the Company are responsible for relevant supervision and improvement work, and, where necessary, report to the Risk Management Committee.

The Group carries out communication in a timely manner regarding the identified major internal control flaws and prudently assesses potential risks. The responsible department shall propose relevant corrective actions and obtain approval from the senior management prior to the implementation. The senior management and the internal control and audit department monitor the implementation status and ensure timely and proper remediation of relevant monitoring flaws.

The Group has formulated the policies and procedures for handling and disclosing inside information, which are set out in the section headed "Management of Inside Information and Insiders of the Administrative Rules for Information Disclosure of Hanhua Financial Holding Co., Ltd." (《瀚華金控股份有限公司信息披露管理辦法》). The information and date to be disclosed shall be properly reviewed and approved by the Board to ensure its timeliness, accuracy, sufficiency and effectiveness, and shall be closely monitored after disclosure.

根據本公司業務特點，本公司下屬層面設風險管理專業委員會在董事會風險管理委員會領導下工作，重點針對運營、操作等業務風險進行管理。風險管理專業委員會分三個層級和六個區域風險審批中心，按照前中後台分離，有效監督制約的原則，對信用風險、操作風險、法律合規風險控制流程進行較大的優化改革，並制定業務操作規範、操作風險管理辦法等規範性文件，構建起覆蓋全業務流程的內部監控及風險管理體系。由業務部門收集風險初始信息、進行風險評估、由風險管理部門制定業務風險策略，提出業務風險解決方案，由內控審計部門與公司領導層對風險管理進行監督與改進，並在必要時匯報至風險管理委員會。

### RELATIONSHIP WITH SHAREHOLDERS AND STAKEHOLDERS

The Company considers that effective communication with shareholders and stakeholders are essential for enhancing investor relations and understanding of the Group's business, performance and strategies. The general meeting of shareholders provides an opportunity for shareholders to communicate directly with Directors and senior management of the Company. The chairman of the Board, chairman of the Board committees and certain senior management of the Company will attend the general meetings to answer shareholders' questions. The Company has also issued notices, announcements, circulars, interim and annual reports to keep shareholders informed of the latest development of the Company.

The Company has formulated the Shareholder Communication Policy to maintain close contact with the investors. During the reporting period, the Company strengthened the communication between investors and potential investors by holding Shareholders' meetings, accepting investors' visits and research, telephone conference exchanges by one-to-one or one-to-many, accepting inquiries or email replies to improve investors' understanding and recognition of the Company and improve corporate governance to maximize the Company's overall interests and protect the legitimate rights and interests of investors. The Company has maintained continuous close relationship with stakeholders, including customers, employees, suppliers, regulatory authorities and the public. The Company devoted to balance the opinions and interests of the stakeholders through constructive communication, so as to set the long-term development direction for the Company and the regions where our business operates.

Taking Haier Electronics, the major strategic cooperation customer of the Company's supply chain financial business, as an example. Established in 1984, Haier Group is one of the world's largest manufactures of household electronic appliances and has a large number of distributors in China. Since 2012, Haier Finance Co., Ltd. has established business relationship with Hanhua Guarantee, a subsidiary of the Company, for the provision of supply chain financial services to distributors of the distribution channel of Haier Group, and has maintained such business cooperation for over nine years. Despite the close relationship with Haier Group, Shell Oil and other major customers, the Company holds a firm position on adopting the same credit requirements as other customers and makes provision according to industry regulations. The Company is aware that the risks in cooperating with major customers mainly arise from their operating risks, hence it does not fully rely on the credit of the major customers, rather, it applies strict screening on SME borrowers through credit rating system so as to diversify the operating risks of its major clients.

The latest version of the Company's Articles of Association has been published on our Company's website ([www.hanhua.com](http://www.hanhua.com)) and the Hong Kong Stock Exchange website, respectively.

### A. ENVIRONMENTAL PROTECTION

In compliance with the provisions under the Environmental Protection Law of the PRC, the Securities and Futures and Companies Legislation (Uncertificated Securities Market Amendment) Ordinance 2015 and other applicable laws and regulations, the Company actively adopts measures to improve environmental management and encourages staff to reduce pollution and waste during work to minimize the environmental impact of the Company's business as well as its products and services, with a view to protecting and improving the environment, reducing pollutant emissions and promoting ecological civilization.

As most of the Company's operation is office-based, the Company is committed to minimizing the impact of office impact on the environment by means of green office initiatives, including:

For the construction of weak current systems in branch offices, the Company widely adopted environmentally-friendly materials to maximize the utilization of materials and reduce material waste and loss. We adopted low-energy and information-based office devices, and ensured compliance with operational specifications to extend their service life. New integrated computer rooms, smart office platforms and other new products are used to achieve energy saving and emission reduction in the office area.

We further increased office automation and established collaborative office platforms and various office systems such as business management system, human resources management system, financial management system, capital management system, reimbursement system and knowledge management system, with a focus on improving the credit and standard finance business platform, partnership finance business platform, data analysis and management platform and private cloud infrastructure platform, so as to establish standard management procedures to boost operational efficiency.

We encourage double-sided printing to reduce paper consumption and the use of durable items and recyclable and reusable items instead of disposable office items, and recommend our employees to use video and telephone conferencing for offsite meetings to reduce accommodation and travel resulting from employees' participation in the meetings. The cooling and heating systems at the our offices are required to be set at a minimum of 26 degree Celsius and maximum of 22 degree Celsius for different seasons. We promote environmentally-friendly habits such as turning off lightings when not in use, saving water, and turning off air conditioners after meetings or office hours. We call for promoting thrift and stopping food waste, and ban the supply of luxurious dishes and the consumption of protected wild animals, thereby encouraging our employees to cherish food and develop good dining habits.

### 1. Employment and Labor Practices:

#### (1) Employment:

As at 31 December 2021, the Company had a total of 1,125 employees (Full-time) in Mainland China and Hong Kong. In terms of education background, 930 employees (83%) have bachelor's degree or above, and 195 employees (17%) have received post-secondary education and below. In terms of lines of work, 513 employees (46%) are front-office staff, and 612 employees (54%) are middle-office and back-office supporting staff. In terms of age, 122 employees (11%) are aged 20-30; 694 employees (62%) are aged 31-40; 158 employees (20%) are aged 41-50; and 87 employees (7%) are aged 51 and above.

In strict compliance with applicable laws and regulations including the Labor Law of the PRC, the Labor Contract Law of the PRC, the Implementation Regulation of the Labor Contract Law of the PRC, the Law on Safeguarding Women's Interests and Rights of the PRC and the Hong Kong Employment Ordinance, the Company upholds the principle of gender equality. As at 31 December 2021, the Company had 574 male employees and 551 female employees, with a gender ratio of 5:5.

### 1. 僱傭及勞動常規：

In the course of recruitment, the Company treats job applicants equally and does not discriminate them on the grounds of national origin, race, nationality, gender, religion, age, sexual orientation, political affiliation, marital status and other social identity. It establishes employment relations based on legal, fair and equal negotiation. In the course of day-to-day management, the Company does not take into consideration their national origin, race, nationality, religion, age, sexual orientation, political affiliation, marital status and other social identity in their welfare, treatment and promotion.

In 2021, the employee dismissal/resignation rate was 28%, covering employees who resigned themselves and those dismissed by the Company based on performance and competence. By gender, the dismissal/resignation rates are 30% for male employees and 26% for female employees.

By age group, the dismissal/resignation rates are 41% for employees aged 20-30, 30% for employees aged 31-40, 16% for employees aged 41-50 and 15% for employees aged 51 and above.

The Company maintains strict compliance with relevant national and regional requirements for termination of employment relations. As to employees' voluntary resignation, the Company negotiates with employees on an equal footing and respects their decisions. Termination of labor contracts, termination negotiation, dismissal and other procedures are conducted in accordance with laws. For dismissal due to employees' violation of laws, regulations and rules, the Company will proceed as permitted by laws and regulations and with reference to the Company's "Employee Manual".

### (2) Health and Safety:

The Company has always attached importance to employees' occupational health and safety. It complies with applicable laws and regulations, including the Labor Law of the PRC, the Labor Contract Law of the PRC and the Implementation Regulations of the Labor Contract Law of the PRC in establishing and maintaining a safe, healthy and people-oriented office environment to guarantee employees' interests and rights. From 2019 to 2021, there was no case of work-related death or serious injury.

According to the legal requirements of national and regional governments, the Company practices a working hour system of no more than 8 working hours a day and no more than 40 hours a week. Meanwhile, in the interest of staff's work-life balance, we safeguard their rights to reasonable leave and provide them with various kinds of leave, e.g., public holiday leave, statutory holidays, annual leave, marital leave, maternity leave and paternity leave, nursing leave, funeral leave, sick leave, absence leave and work-related injury leave.

The Company attaches great importance to organizational culture building and employee care, promotes cultural cohesion through employee care, and incorporates corporate values and social responsibility into organizational culture. In 2021, the Company enhanced employees' wellbeing through various ways and optimized channels of communication with employees, including work anniversary wishes for employees; the "Love for the Elderly" event at Chongyang Festival to pay tribute to parents of our employees, activated our internal communication platform and set up a "Super Topics" space on "My HR" employee service platform, on which "Taste of Spring Festival" and other thematic columns were launched for employees to share their work and life stories and insights, thereby deepening the emotional connections between our employees and their families and between our employees and the Company, and enhancing our employees' sense of identity and belonging.

### (2) 健康與安全：

本公司一貫重視員工職業健康及安全，遵守《中華人民共和國勞動法》、《中華人民共和國勞動合同法》、《中華人民共和國勞動合同法實施條例》等法律法規，建立並維持安全、健康、人性化的辦公環境，確保員工權益。自2019年至2021年，未發生因公受傷、死亡的案例。

本公司按照國家、地區政府的法規要求，實行每日工作時間不超過8小時、平均每週工作時間不超過40小時的工時制度。同時基於員工工作與生活平衡的原則，保障員工合理的休假權益，向員工提供各類假期，如公休日、法定節假日、年休假、婚假、產假及陪产假、哺乳假、喪假、病假、事假、工傷假等。

本公司高度重視組織文化建設與員工關懷，以員工關懷促文化凝聚，寓企業價值觀與社會責任於組織文化。2021年，公司通過多種方式提升員工關懷，優化溝通渠道：員工入司紀念日問候與祝福；在傳統敬老佳節策劃「愛在重陽」專題活動，慰問感恩員工父母；激活內部溝通平台，在員工服務平台「我的HR」開闢「超話空間」，陸續推出「樂享年味」等主題專欄，讓員工們分享工作、生活故事與感悟，加深員工與家人、員工與公司的情感鏈接，增強員工對公司的認同感和歸屬感。

In terms of honors and commendations, the Company held the “Employee Service Awards” event and presented honorary certificates, letters of appreciation and gifts to award-winning employees, as a way of thanking employees for their dedication and promoting our corporate culture. Besides, the Company also held the “Employee of the Year” and “Team of the Year” award event to reward and commend teams and individuals with outstanding performance, thereby setting up role model to stimulate employees’ sense of honor and their enthusiasm for work.

### (3) Organizational Development and Training:

In the fourth quarter of 2021, along with its ongoing comprehensive digital transformation, the Company swiftly reconstructed its organizational structure through organizational restructuring and personnel optimization and proceeded to improve its staffing system and job-based pay system so as to implement its strategy of focusing on digitally-enabled operations. Since then, Hanhua Financial has been gradually transforming into an investment management platform, with more authority delegated to lower-level management and decision-making process streamlined to break down information barriers while increasing the operational autonomy and flexibility of each business units. On the other hand, the operation teams at all levels gave full play to their localized advantages, customized and promoted the localization model of talents fostering system in line with local actual conditions, reflecting the flexibility and innovation of the overall system. In addition, the Company continued to deepen the previous programs, focused on the continuity and consistency of talents development, and ensured talents development to effectively serve business development, thereby further building Hanhua’s elite team.

### (3) 組織發展與培訓：

2021年四季度，伴隨公司數字化轉型的全面推進，為實現聚焦數字業務策略，公司快速重構組織形態，陸續完成了組織架構調整和人員優化，並著手開展崗位體系梳理與人崗薪匹配。至此，金控公司逐步轉型為投資管理型平台，下沉管理職能，縮短決策鏈條，打破信息壁壘，同時提高業務單位經營自主性和靈活性。另一方面，各級運營團隊充分發揮屬地化優勢，定制並推動契合當地實際情況的人才培養體系落地模式，體現了整體體系的靈活性與創新性。此外，公司持續推動前期專案深化，注重人才發展的延續性與連貫性，確保人才發展切實服務業務發展，進一步打造瀚華人力資源核心精品。

In terms of staff development, the digitalized management functions operated steadily. The training data of the Company is kept under effective control and management, and the training records and training agreements are regularly updated to ensure the training data is complete and effective. The digital learning platform, E-Learning School, has been in operation, organizing rich and diverse learning activities, such as financial knowledge competitions and e-Lectures. The digital learning platform allows users to learn anytime and anywhere, efficiently satisfying the training needs of each enterprise wherever it locates. As at 31 December 2021, our employees completed a total of 13,700.4 hours of learning, with 12.66 hours per capita.

The percentage of employees received trainings in 2021 by gender: 50% male and 50% female; by employee category: 71.1% general staff/supervisors, 19.4% department heads, and 69.5% general managers or above.

The average training hours per employee by gender: 12.86 hours for male and 12.45 hours for female; by employee category: 14.06 hours for general staff/supervisors, 12.07 hours for department heads and 6.39 hours for general managers or above.

### (4) Performance and remuneration and benefits:

In terms of performance incentives, we cleared transmission barriers among our business units through developing a digital platform and thus effectuated the automatic alignment in respect of data statistics, performance assessment and bonus determination and payment, which has greatly improved data accuracy and management efficiency. In addition, each business segment has formulated targeted evaluation and incentive schemes based on its own characteristics and development status and with reference to internal and external management practices, and actively explored market-based distribution and incentive mechanisms such as partnerships to maximize value co-creation and benefit and risk sharing, thereby driving the continuous improvement of organizational efficiency.

In terms of remuneration and benefits, we reasonably applied the principle of cost-effectiveness and maintained effective payroll control. We optimized our welfare system through flexible item settings and concrete services, prioritized employees' health management and provided such benefits as social insurance, health checks and commercial insurance to give our employees more comprehensive and practical protection. In addition, we proceeded to outsource the administration and management of our employee benefits in respect of social insurance and housing provident fund contributions ("SI&HPF"), and have formulated a step-by-step implementation strategy after careful research on local policies and operational methods of the places where our operations are located. Currently, we have completed the connection with the SI&HPF service provider's system and the SI&HPF transfer procedures for employees at our headquarters and some of our local business units, and will step by step complete the outsourcing of SI&HPF administration and management of all our employee SI&HPF in the future.

### (5) Labor Standards:

The Company strictly complies with the Labor Law of the PRC, the Labor Contract Law of the PRC, the Law on Safeguarding Women's Interests and Rights of the PRC, the Law on the Protection of Minors of the PRC, the Special Rules on Labor Protection of Female Employees of the PRC, the Employment Promotion Law of the PRC and other applicable laws and regulations, as well as the local labor standards where employees are located. In terms of personnel recruitment, the Group complies with national and local regulations and treats all employees equally and fairly without discriminatory policies. In terms of employee management, working hours and salary and benefits are implemented in accordance with relevant laws and regulations, and relevant reward and punishment and daily management policies and systems are clearly defined and communicated to the employees. Employees are encouraged to have friendly communication with the Company. Prior to the establishment of employment relations, it carries out strict identity screening and has never hired minors. The relationship between the Company and employees is fair and equal. The employment of the Company's staff is subject to laws and their consent.

## 2. OPERATION PRACTICES:

### (1) Supply Chain Management:

The Company is committed to building a responsible supply chain, based on the principles of "seeking truth from facts, supervising according to law", "openness, fairness and justice", and "combining supervision with work effectiveness" to build mutual trust and win-win cooperation relationship with suppliers.

### (5) 勞工準則：

本公司致力於構建負責任的供應鏈，本著「實事求是、依法監督」、「公開、公平、公正」、「監督檢查與工作實效相結合」的原則，與供應商構建相互信賴、合作共贏的關係。

In the process of evaluating suppliers, the Company adheres to the combination of offline and online methods, strictly controls the process, adopts multiple comparison principles, and selects the best suppliers. At the same time, the Company attaches great importance to the social and environmental responsibilities assumed by suppliers and their performances. Under the same conditions, priority is given to purchasing energy-saving and environmentally-friendly products that have passed environmental labeling product certification, energy-saving product certification, or other certifications recognized by the state.

In terms of banking, the Company has cooperated with more than 50 banks to obtain credit lines for credit guarantee business of more than RMB40 billion. The five largest cooperative banks of the Group each provided 32% of the bank financing guaranteed by us, and the largest cooperative bank provided 14% of the total financing guaranteed by the Group.

In 2021, the Company is not aware of any major actual and potential negative impacts caused by any suppliers due to business ethics, environmental protection and improper labor measures.

For office network, we selected China Unicom as service provider. China Unicom has established a “three-in-one” green management system, including green concept, green practice and green performance. It continued to implement the Special Plan for Energy Conservation and Emission Reduction for 2017-2020, and formulated and implemented the “Special Action for Cost Reduction and Efficiency Reduction” and the “Special Implementation Plan for Pollution Prevention and Control”. Meanwhile, it strived to improve environmental management capabilities, reduce greenhouse gas emissions, improve refined management level, and established a long-term mechanism for green development, contributing to the prevention and control of pollution.

For office stationery, we selected Deli brand. As the largest conglomerate specializing in office and school supplies in China, Deli has engaged environmental management experts as its environmental protection consultants to inspect and rectify the environmental protection treatment equipment, production process, operation process, production materials and emission standards at each business unit, after that the aforesaid aspects will be monitored and tested by its environmental officers all the time; the Group's production safety management office conducts environmental hygiene supervision and inspection on all units and records relevant information in the standing books.

In 2021, the Company was not aware of any actual or potential significant negative influence due to misconduct of suppliers in business ethnics, environmental protection and labor measures.

### (2) Product Responsibility:

The Company is committed to providing outstanding customer experience and ensuring that the provision of products and services is legal, effective and safe.

The Company possesses a substantial amount of information of corporate and individual customers due to its business nature. Thus, it attaches great importance to protecting customer information in compliance with the Anti-Unfair Competition Law of the PRC and other applicable laws and regulations relating to health and safety, advertising, labelling and privacy matters of products and services and the redress method. It also adopted the following protective measures:

Enhance customers' self-protection awareness and avoid information leakage from the source. In the course of business promotion and processing, we properly conduct warning of information security so that customers are able to develop clear understanding of the danger of information security breach, learn how to strengthen information protection and identify the authenticity of suggestive information, and know about information theft and how to deal with information leakage, etc.

Strengthen internal management to formulate a long-lasting mechanism. On one hand, the Company has optimized customer information management mechanism, formulated standards for collection, utilization and storage management of customers' information and set limitation on operators' access to information and contents according to authorization and roles in the business system. The Company keeps customers' personal data properly and forbids access by unrelated personnel. For the personal credit system in particular, it also sets up special position of credit search for designated personnel. It keeps borrowing records with regard to the borrowing authorization and scope strictly in compliance with file access requirements.

Enhance position management. We strictly identify positions handling customer information and confidential materials and forbid unrelated personnel to have access to confidential information. We strictly regulate resigned staff's hand-over of files involving customer information and request them to sign the "Resigned Staff Confidentiality Undertaking".

Enhance monitoring and accountability. We conduct irregular review on the standardization of customer file keeping and access as well as detect and rectify hazards and loopholes in customer information management work in a timely manner. We effectively eliminate the non-compliance with regulations and misconduct so as to block loopholes of leakage of confidential information by means of establishing supervisory and accountability.

加強崗位管理。嚴格界定涉及客戶信息秘密的工作崗位，不讓無關人員接觸秘密信息。對離職員工涉及客戶信息的數據移交要嚴格規範，並要求離職員工簽訂《離崗人員保密承諾書》。

強化監督問責。我們對客戶數據保管和調閱是否規範進行不定期檢查，及時發現和糾正客戶信息管理工作中的隱患和漏洞。設立監督問責機制，切實杜絕有章不循、有禁不止的現象，堵塞洩密漏洞。

Strengthen customer information security and confidentiality management with technological approach. We have established the internal network, external network and non-military region segregation on the business system network level by means of security devices so as to realize secured and controllable visit of the Internet. We have also set up intrusion inspection, loophole screening and log auditing on the application level to ensure stable operation of each system and avoid the loss and tampering of customer information, while establishing the comprehensive information security system to ensure that daily customer behavior is secured and compliant. We have established the data warehouse for data centralization, as well as data analysis and presentation through BI, which prevents data leakage.

### (3) Anti-corruption:

In line with the attitude of being responsible to shareholders, investors and employees, the Company attaches great importance to anti-corruption and governance. The Company has an internal control and audit department to conduct regular compliance reviews on its business and management.

The Company adopts a zero-tolerance principle in the fight against corruption and related non-compliances. Upholding business ethics, it formulated the “Employee Manual” and other relevant rules. The manual clearly states that employees should work with high professional ethics, conduct with integrity, act with good faith, and that any employee who is found to be involved in any act of corruption, bribery or embezzlement will be considered as having committed a serious violation of discipline and will be dismissed by the Company according to laws and regulations and without any economic compensation. All employees have signed the “Integrity Building Undertaking Letter”, undertaking that they will not engage in any act in violation of Company’s rules or regulations, work ethics and the requirements set out in the letter during their employment, otherwise they shall bear all responsibilities and consequences (including but not limited to civil compensation and criminal responsibility).

公司對貪污及有關違紀行為採取零容忍原則，重視職業道德建設，制定了《員工手冊》等相關規範，《員工手冊》明確規定：員工應當以高標準職業道德規範行事，品行正直，恪守誠實信用，貪污、收受賄賂、行賄或挪用公款等行為屬於嚴重違紀行為，公司有權根據法律法規予以辭退，並不予支付任何經濟補償。全體員工均簽署有《廉政建設承諾書》，承諾在職期間絕不從事任何違反公司規章制度、道德底線以及承諾書的行為，否則將承擔全部責任（包括但不限於民事賠償責任、刑事責任）。

In addition, the Company carries out educational campaigns on anti-corruption on a regular basis, using real cases to raise employees' awareness against corruption.

During the Reporting Period, the Company was not involved in any corruption litigation against the Company or its staff.

The senior management of the Company is committed to social responsibility. In 2021, due to the continued impact of the COVID-19 epidemic, most industry associations and summit forums suspended and reduced their offline events or switched to online events. Following the requirements of epidemic prevention and control, the management of the Company adopted diversified ways to participate in public activities to spread the concept of inclusive finance and fulfilled and social responsibility of the Company as an inclusive financial service provider.

In October 2021, Mr. Zhang Guo Xiang, Chairman of the Board, attended the 2nd Summit on Cooperation of the Chambers of Commerce of the Chengdu-Chongqing Economic Circle jointly organized by the United Front Work Department of Sichuan Provincial Party Committee, the United Front Work Department of Chongqing Municipal Party Committee, Sichuan Federation of Industry and Commerce and Chongqing Federation of Industry and Commerce, and delivered a speech on opportunities and challenges arising from jointly developing the Chengdu-Chongqing Economic Circle at the summit. On 27 May 2015, the 2014 annual general meeting of the Company considered and approved the proposal on the grant of bonus in the form of shares in open market to the senior and middle to senior management of the Company under the share incentive scheme (the "**Scheme**"), a medium and long-term incentive scheme to increase in share by the senior and middle to senior management with incentive fund base of the portion of year-end performance-related remuneration of the participants. In 2015, the Scheme was gradually implemented in accordance with the relevant procedures. 5,738,623 H shares of the Company were acquired from the open market. As of the date of this report, all of the above 5,738,623 H shares were unlocked and vested to individuals. There were currently H Shares remaining due to the factors such as resignation of the members of senior management.

### RISK MANAGEMENT

Our risk management committee is the highest decision-making organisation on risk management, fully responsible for risk management of the Group. Our internal control departments including risk management and internal control and audit as well as other departments and business department form a system of pre-, during and post-incident risk management and internal control.

For the year ended 31 December 2021, the Company has identified our actual risks including credit risk, market risk, operational risk, liquidity risk, of which credit risk is our major risk. Besides, this report does not constitute a recommendation or an advice for anyone to invest in the securities of the Company and investors are advised to make their own judgment or consult their own investment advisors before making any investment in the securities of the Company.

#### Credit Risk Management

In the light of the characteristics of credit risk, the Company shifted gradually the way of risk assessment from single business project to that on product and business model, and formulated admission criteria, investigation standard, credit standard, operation procedure, post-loan management and method of payment call for each product. The Company made amendment and improvement to policies and operation standard on admission and investigation of guarantee, loan, factoring and leasing, specific operation requirements and management requirement of post-guarantee and loan to ensure the suitability and feasibility of the policies during the year.

### 風險管理

本公司董事會及董事會風險管理委員會作為風險管理的最高決策機構，全面負責本集團的風險管理。本公司風險管理、內控審計等內部控制部門與其他職能部門、業務部門一起形成了覆蓋事前、事中和事後的風險管理與內部控制體系。

截至2021年12月31日止年度期間，公司已識別出所面臨的實質性風險包括信用風險、市場風險、操作風險、流動性風險，其中信用風險是公司面對的主要風險。此外，本報告不對任何人就投資本公司證券作出任何建議或意見。投資者在投資本公司證券之前，應自行判斷或諮詢投資顧問的意見。

#### 信用風險管理

本公司針對信用風險的特點，從對單個業務項目的風險評估逐步向對產品、對業務模式的風險評估轉型，對每個產品制定了准入標準、調查標準、授信標準、操作流程、貸後管理和催收辦法，並在本年度對擔保、信貸、保理、租賃等業務的准入及調查方面、具體操作要求及保貸後的管理要求等方面的政策和操作標準進行修改和完善，以確保其適用性和可操作性。

### Market Risk Management

Based on its exposure to the specific market risks, the Company established stringent industrial and regional credit policy. In respect of the industrial credit policy, it conformed to the national industrial policies and industry development trends, selected the best sectors and made dynamic adjustment. In respect of the regional credit policy, it has taken into account of the local credit market conditions, regional risk level, competition level to control the scale and use of the credit facility. Coupled with differentiated pricing administrative measures based on customer classification, scale of single transaction, and income-to-cost ratio, this enabled “better than average management, preventive system and revenue covering cost”.

### Operational Risk Management

The Company prevented the operational risk from the origin through strict management of authorization and implementation of installation of two persons, dual position and double duties for key positions, and established a system of normalized check and reporting and feedback and improvement mechanism of risk incident, which effectively prevented the operational risk.

### Liquidity Risk Management

“Liquidity safety” is the first management objective for our Planned Finance Department, which is responsible for overall management of our liquidity risk. Each subsidiary is required to compile a daily sheet of monetary liquidity to submit to the Planned Finance Department. Our Planned Finance Department flexibly adjusts the size and structure of the balance sheet by monitoring various liquidity risk limits and cash flow. This is to ensure to maintain sufficient cash reserve to meet liquidity needs in the short and long term and guarantee our liquidity safety.

### REPORT OF THE BOARD OF SUPERVISORS

In 2021, pursuant to the requirements set out in the Company Law of the PRC and the Articles of Association, the Board of Supervisors of the Company has attentively performed its duties and proactively carried out supervision on the financial activities, internal control, risk management, lawful operation as well as the performance of duties by the Board and senior management of the Company, thus effectively contributing to the optimization of governance of the Company and to the healthy and sustainable development of the Company.

# Notes to the Consolidated Financial Statements

## 財務報表附註

### 1 SIGNIFICANT ACCOUNTING POLICIES

#### (a) Statement of compliance

These financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (**HKFRSs**), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (**HKASs**) and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (**HKICPA**), accounting principles generally accepted in Hong Kong and the requirements of the Hong Kong Companies Ordinance. *These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.* Significant accounting policies adopted by the Group are disclosed below.

The HKICPA has issued certain amendments to HKFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 1(c) provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current accounting periods reflected in these financial statements.

#### (b) Basis of preparation of the financial statements

The consolidated financial statements for the year ended 31 December 2021 comprise the Company and its subsidiaries (together referred to as the “**Group**”) and the Group’s interest in associates and a joint venture.

The financial statements are presented in RMB, rounded to the nearest thousand. It is prepared on the historical cost basis except for financial instrument classified as fair value through profit or loss (see Note 1(k)(i)) that are stated at their fair value and liabilities from guarantees (see Note 1(r)(i)).

### 1 重大會計政策

#### (a) 合規聲明

該等財務報表已根據所有適用香港財務報告準則（「**香港財務報告準則**」）編製，其條款包括香港會計師公會（「**香港會計師公會**」）頒佈的所有適用的個別香港財務報告準則、香港會計準則（「**香港會計準則**」）及詮釋、香港公認會計原則和香港公司條例的披露規定。本財務報表亦符合香港聯合交易所有限公司證券上市規則的適用披露條文。本集團所採納的重大會計政策載於下文。

香港會計師公會已頒布多項於本財務報表期間生效或可以提前採用的新增及修訂的香港財務報告準則。附註1(c)提供了關於因首次適用這些準則而導致本集團財務報表中本期和前期會計期間的會計政策任何變化的資訊。

#### (b) 財務報表的編制基準

截至2021年12月31日止年度的合併財務報表包括本公司及其附屬公司（合稱「**本集團**」）以及本集團投資的聯營企業和合營企業。

財務報表以人民幣列值，並湊整至最近千位。除以公允價值呈列的以公允價值計量且其變動計入當期損益的金融資產（見附註1(k)(i)）及擔保性負債（見附註1(r)(i)）外，財務報表以歷史成本法為編製基準。

#### (b) Basis of preparation of the financial statements (Continued)

The preparation of financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of HKFRSs that have significant effect on the financial statements and major sources of estimation uncertainty are discussed in Note 39.

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealized profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealized losses resulting from intra-group transactions are eliminated in the same way as unrealized gains but only to the extent that there is no evidence of impairment.

Non-controlling interests represent the equity in a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at the non-controlling interests' proportionate share of the subsidiary's net identifiable assets.

Non-controlling interests are presented in the consolidated statements of financial position within equity, separately from equity attributable to the equity holders/shareholders of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of profit or loss and the consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the equity shareholders of the Company. Loans from holders of non-controlling interests and other contractual obligations towards these holders are presented as financial liabilities in the consolidated statements of financial position in accordance with Note 1(k) depending on the nature of the liability.

非控制性權益指非直接或間接歸屬於本公司的附屬公司權益，且本集團就此並無與該等權益持有人協定任何額外條款，致使本集團整體須就該等符合金融負債定義的權益承擔合約責任。就各業務合併而言，本集團可選擇按公允價值或按佔附屬公司可識別淨資產的非控股權益比例而計量任何非控制性權益。

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognized.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognized in profit or loss. Any interest retained in that former subsidiary at the date when control is lost is recognized at fair value and this amount is regarded as the fair value on initial recognition of a financial asset (see Note 1(k)) or, when appropriate, the cost on initial recognition of an investment in an associate or joint venture (see Note 1(e)).

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment losses (see Note 1(n)(i)), unless the investment is classified as held for sale (or included in a disposal group that is classified as held for sale).

#### (e) Associates and joint ventures

An associate is an entity in which the Company has significant influence, but not control or joint control, over its management, including participation in the financial and operating policy decisions.

A joint venture is an arrangement whereby the Company and other parties contractually agree to share control of the arrangement, and have rights to the net assets of the arrangement.

An investment in an associate or a joint venture is accounted for in the financial statements under the equity method, unless it is classified as held for sale (or included in a disposal group that is classified as held for sale). Under the equity method, the investment is initially recorded at cost, adjusted for any excess of the Group's share of the acquisition-date fair values of the investee's identifiable net assets over the cost of the investment (if any). Thereafter, the investment is adjusted for the post acquisition change in the Group's share of the investee's net assets and any impairment loss relating to the investment (see Notes 1(f) and 1(n)(i)). At each reporting date, the Group assesses whether there is any objective evidence that the investment is impaired. Any acquisition-date excess over cost, the Group's share of the post-acquisition, post-tax results of the investees and any impairment losses for the year are recognized in the consolidated statement of profit or loss, whereas the Group's share of the post-acquisition post-tax items of the investees' other comprehensive income is recognized in the consolidated statement of profit or loss and other comprehensive income.

When the Group's share of losses exceeds its interest in the associate or the joint venture, the Group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the investee. For this purpose, the Group's interest is the carrying amount of the investment under the equity method together with the Group's long-term interests that in substance form part of the Group's net investment in the associate or the joint venture.

Unrealized profits and losses resulting from transactions between the Group and its associates and joint venture are eliminated to the extent of the Group's interest in the investee, except where unrealized losses provide evidence of an impairment of the asset transferred, in which case they are recognized immediately in profit or loss.

If an investment in an associate becomes an investment in a joint venture or vice versa, retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method.

In all other cases, when the Group ceases to have significant influence over an associate or joint control over a joint venture, it is accounted for as a disposal of the entire interest in that investee, with a resulting gain or loss being recognized in statement of profit or loss. Any interest retained in that former investee at the date when significant influence or joint control is lost is recognized at fair value and this amount is regarded as the fair value on initial recognition of a financial asset (see Note 1(k)).

#### (f) Goodwill

**Goodwill represents the excess of**

- (i) the aggregate of the fair value of the consideration transferred, the amount of any noncontrolling interest in the acquiree and the fair value of the Group's previously held equity interest in the acquiree; over
- (ii) the net fair value of the acquiree's identifiable assets and liabilities measured as at the acquisition date.

##### Goodwill represents the excess of (Continued)

When (ii) is greater than (i), then this excess is recognized immediately in profit or loss as a gain on a bargain purchase.

Goodwill is stated at cost less accumulated impairment losses. Goodwill arising on a business combination is allocated to each cash-generating unit, or groups of cash generating units, that is expected to benefit from the synergies of the combination and is tested annually for impairment (see Note 1(n) (ii)).

On disposal of a cash generating unit during the year, any attributable amount of purchased goodwill is included in the calculation of the profit or loss on disposal.

#### (g) Investment property

Investment properties are land and/or buildings which are owned or held under a leasehold interest (see Note 1(j)) to earn rental income and/or for capital appreciation. These include land held for a currently undetermined future use and property that is being constructed or developed for future use as investment property.

Investment properties are stated at cost less accumulated depreciation and any impairment losses. Depreciation is calculated on the straight-line basis to write off the cost of investment properties to its residual value over its estimated useful life, i.e. 26 years. Rental income from investment properties is accounted for as described in Note 1(s)(iii).

商譽以成本減累計減值準備列示。集團依據現金流產生單元或者現金流產生單元組能夠從企業合併的協同效應中的受益情況分攤商譽賬面價值，並在此基礎上進行商譽減值測試(附註1(n)(ii))。

在處置資產組時，任何屬於購置商譽的金額均在計算處置損益時考慮。

#### (g) 投資性房地產

Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses (see Note 1(n)(ii)).

The cost of self-constructed items of property, plant and equipment includes the cost of materials, direct labor and borrowing costs.

Gains or losses arising from the retirement or disposal of an item of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognized in the statement of profit or loss on the date of retirement or disposal.

Depreciation is calculated to write off the cost of items of property, plant and equipment, less their estimated residual value, if any, using the straight-line method over their estimated useful lives as follows:

#### (i) Intangible assets (other than goodwill)

Intangible assets that are acquired by the Group are stated at cost less accumulated amortization (where the estimated useful life is finite) and impairment losses (see Note 1(n)(iii)). Expenditure on internally generated goodwill and brands is recognized as an expense in the period in which it is incurred.

Amortization of intangible assets with finite useful lives is charged to the statement of profit or loss on a straight-line basis over the assets' estimated useful lives. The following intangible assets with finite useful lives are amortized from the date they are available for use and their estimated useful lives are as follows:

#### (j) Leased assets

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

Where the contract contains lease components and non-lease components, the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

At the lease commencement date, the Group recognizes a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognized as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognized at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

當合約包含租賃組成部分及非租賃組成部分，本集團選擇不拆分非租賃部分，而是將租賃部分和非租賃部分作為一項單一的租賃進行會計處理。

在租賃開始日，本集團確認使用權資產和負債，但租賃期不超過12個月的短期租賃和低價值租賃的資產除外。當集團就一項低價值的資產簽訂租賃協議時，本集團決定是否對其進行資本化，與未資本化的租賃相關的付款在租賃期內系統的確認為費用。

如果租賃資本化，則租賃負債初始按租賃期內應付的租賃付款的現值確認，使用租賃中隱含的利率貼現，如果無法輕易確定該利率，則使用相關的增量借款利率進行貼現。初始確認後，租賃負債按攤餘成本計量，利息費用採用實際利率法計算。不依賴於指數或利率的可變租賃付款不包括在租賃負債的計量中，因此在其發生的會計期間計入損益。

The right-of-use asset recognized when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-of-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses (see Notes 1(h) and 1(n)(ii)).

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

In this case the lease liability is remeasured based on the revised lease payments and lease term using a revised discount rate at the effective date of the modification. The only exceptions are rent concessions that occurred as a direct consequence of the COVID-19 pandemic and met the conditions set out in paragraph 46B of HKFRS 16 Leases. In such cases, the Group has taken advantage of the practical expedient not to assess whether the rent concessions are lease modifications, and recognized the change in consideration as negative variable lease payments in profit or loss in the period in which the event or condition that triggers the rent concessions occurred.

In the consolidated statement of financial position, the current portion of long-term lease liabilities is determined as the present value of contractual payments that are due to be settled within twelve months after the reporting period.

當租賃範圍或租賃對價發生變化時，如果租賃合同中最初未規定（「租賃變更」），且未作為單獨租賃入帳，則租賃負債也應重新計量。在這種情況下，根據修改後的租賃付款和租賃期限，使用修改生效日的修改後貼現率重新計量租賃負債。唯一的例外是，任何由於新冠疫情直接引起，並滿足香港財務報告準則第16條租賃第46B段所述條件的租金優惠。在該情況下，本集團利用簡便實務操作方法，不評估該租金減讓是否為租賃修改，並在觸發該租金減讓的事件或情況發生的期間作為負可變租賃付款額計入損益。

在合併報表中，長期租賃負債的當前部分被確定為應在報告期後十二個月內結算的合同付款的現值。

When the Group acts as a lessor, it determines at lease inception whether each lease is a finance lease or an operating lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to the ownership of an underlying assets to the lessee. If this is not the case, the lease is classified as an operating lease.

When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. The rental income from operating leases is recognized in accordance with Note 1(s)(iii).

When the Group is an intermediate lessor, the sub-leases are classified as a finance lease or as an operating lease with reference to the right-of-use asset arising from the head lease. If the head lease is a short-term lease to which the Group applies the exemption described in Note 1(j)(i), then the Group classifies the sub-lease as an operating lease.

當合同包含租賃和非租賃組成部分時，本集團將合同中的對價以相對獨立的銷售價格分配到每個組成部分。經營租賃的租金收入根據附註1(s)(iii)確認。

當本集團作為中間出租人時，根據主租賃產生的使用權資產，將轉租分為融資租賃或經營租賃。如果主租賃是短期租賃，本集團對其適用附註1(j)(i)所述的豁免，則本集團將轉租歸類為經營租賃。

For an explanation of how the Group determines fair value of financial instruments, see Note 35. These investments are subsequently accounted for as follows, depending on their classification.

##### *Investments other than equity investments*

Non-equity investments held by the Group are classified into one of the following measurement categories:

- amortised cost, if the investment is held for the collection of contractual cash flows which represent solely payments of principal and interest. Interest income from the investment is calculated using the effective interest method (see Note 1(s)(ii)).

Such elections are made on an instrument-by-instrument basis, but may only be made if the investment meets the definition of equity from the issuer's perspective. Where such an election is made, the amount accumulated in other comprehensive income remains in the fair value reserve (non-recycling) until the investment is disposed of. At the time of disposal, the amount accumulated in the fair value reserve (non-recycling) is transferred to retained earnings. It is not recycled through profit or loss. Dividends from an investment in equity securities, irrespective of whether classified as at FVTPL or FVOCI, are recognized in profit or loss.

ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the present value of all expected cash shortfalls (i.e. the difference between the cash flows due to the Group in accordance with the contract and the cash flows that the Group expects to receive).

The maximum period considered when estimating ECLs is the maximum contractual period over which the Group is exposed to credit risk.

In measuring ECLs, the Group takes into account reasonable and supportable information that is available without undue cost or effort. This includes information about past events, current conditions and forecasts of future economic conditions.

估計預期信用損失時所考慮的最長期限是本集團面臨信用風險的最長合約期。

ECLs are measured on either of the following bases:

- 12-month ECLs: these are losses that are expected to result from possible default events within the 12 months after the reporting date; and
- lifetime ECLs: these are losses that are expected to result from all possible default events over the expected lives of the items to which the ECL model applies.

Loss allowances for trade receivables, lease receivables and contract assets are always measured at an amount equal to lifetime ECLs. ECLs on these financial assets are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors and an assessment of both the current and forecast general economic conditions at the reporting date.

For all other financial instruments, the Group recognizes a loss allowance equal to 12-month ECLs unless there has been a significant increase in credit risk of the financial instrument since initial recognition, in which case the loss allowance is measured at an amount equal to lifetime ECLs.

###### *Significant increases in credit risk*

In assessing whether the credit risk of a financial instrument (including a loan commitment) has increased significantly since initial recognition, the Group compares the risk of default occurring on the financial instrument assessed at the reporting date with that assessed at the date of initial recognition. In making this reassessment, the Group considers that a default event occurs when (i) the borrower is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held); or (ii) the financial asset is 90 days past due. The Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- failure to make payments of principal or interest on their contractually due dates;
- an actual or expected significant deterioration in a financial instrument's external or internal credit rating (if available);

###### *信貸風險的顯著增加*

在評估自初始確認後金融工具的信用風險(包括貸款承諾)是否顯著增加時，本集團將報告日期評估的金融工具違約風險與初始確認日評估的風險進行比較。在進行重新評估時，本集團認為，當(i)借款人不可能全額支付其對本集團的信貸責任，且本集團無需追究實現擔保(如有任何保證)等行動時，就會發生違約事件；或(ii)該金融資產是逾期90天。本集團考慮合理且可支援的定量和定性資訊，包括歷史經驗和前瞻性資訊，無需過多的成本或努力即可獲得。

特別是，在評估自初始確認後信用風險是否顯著增加時，會考慮以下資訊：

Depending on the nature of the financial instruments, the assessment of a significant increase in credit risk is performed on either an individual basis or a collective basis. When the assessment is performed on a collective basis, the financial instruments are grouped based on shared credit risk characteristics, such as past due status and credit risk ratings.

ECLs are remeasured at each reporting date to reflect changes in the financial instrument's credit risk since initial recognition. Any change in the ECL amount is recognized as an impairment gain or loss in profit or loss. The Group recognizes an impairment gain or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account, except for investments in debt securities that are measured at FVOCI (recycling), for which the loss allowance is recognized in other comprehensive income and accumulated in the fair value reserve (recycling).

Interest income recognized in accordance with Note 1(s)(ii) is calculated based on the gross carrying amount of the financial asset unless the financial asset is credit-impaired, in which case interest income is calculated based on the amortised cost (i.e. the gross carrying amount less loss allowance) of the financial asset.

At each reporting date, the Group assesses whether a financial asset is credit-impaired. A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of the financial asset have occurred.

Evidence that a financial asset is credit-impaired includes the following observable events:

- significant financial difficulties of the debtor;
- a breach of contract, such as a default or delinquency in interest or principal payments;
- it becoming probable that the borrower will enter into bankruptcy or other financial reorganisation;

根據附註1(s)(ii)確認的利息收入乃根據金融資產的帳面總值計算，除非該金融資產為信貸減值，在此情況下，利息收入乃根據攤銷成本計算（即金融資產的帳面總額減去損失準備金額。

於各報告日期，本集團會評估金融資產是否為信貸減值。當一項或多項事件對金融資產的估計未來現金流量產生不利影響時，金融資產即為信用減值。

金融資產信用減值的證據包括以下可觀察事件：

###### *Write-off policy*

The gross carrying amount of a financial asset is written off (either partially or in full) to the extent that there is no realistic prospect of recovery. This is generally the case when the Group determines that the debtor does not have assets or sources of income that could generate sufficient cash flows to repay the amounts subject to the write-off.

Subsequent recoveries of an asset that was previously written off are recognized as a reversal of impairment in profit or loss in the period in which the recovery occurs.

###### *核銷政策*

在沒有實際復蘇前景的情況下，核銷（部分或全部）金融資產的賬面總額。當本集團確定債務人沒有可產生足夠現金流量以償還註銷金額的資產或收入來源時，通常就是這種情況。

已減記的金融資產以後又收回的，作為減值損失的轉回計入收回當期的損益。

Financial guarantees are contracts that require the issuer (i.e. the guarantor) to make specified payments to reimburse the beneficiary of the guarantee (the "holder") for a loss the holder incurs because a specified debtor fails to make payment when due in accordance with the terms of a debt instrument.

Financial guarantees issued are initially recognized at fair value, which is determined by reference to fees charged in an arm's length transaction for similar services, when such information is obtainable, or to interest rate differentials, by comparing the actual rates charged by lenders when the guarantee is made available with the estimated rates that lenders would have charged, had the guarantees not been available, where reliable estimates of such information can be made. Where consideration is received or receivable for the issuance of the guarantee, the consideration is recognized in accordance with the Group's policies applicable to that category of asset. Where no such consideration is received or receivable, an immediate expense is recognized in profit or loss.

Subsequent to initial recognition, the amount initially recognized as deferred income is amortized in profit or loss over the term of the guarantee as income from financial guarantees issued (see Note 1(s)(i)).

財務擔保是指要求發行人(即擔保人)支付特定款項以償還擔保人(「持有人」)造成的損失的合同,該損失是由指定的債務人未能按照債務工具的條款還款造成的。

已發行的財務擔保初始按公允價值在「遞延收益」內確認,並在類似服務的公平交易中收取的費用可得時,參考該資訊;或在沒有可用來參考的類似擔保交易時,參考利率差異,通過比較實際收取的費率確定貸款人提供擔保時貸款人可能會收取的估計費率,可以對這些資訊作出可靠的估計。倘就發行擔保而收取或應收對價,則對價將根據本集團適用於該類資產的政策確認。倘未收取或應收該等對價,則直接確認於損益中。

初始確認後,初始確認為遞延收入的金額在擔保期內在損益中攤銷,作為已發出財務擔保的收入(見附註1(s)(i))。

The Group monitors the risk that the specified debtor will default on the contract and recognizes a provision when ECLs on the financial guarantees are determined to be higher than the carrying amount in respect of the guarantees (i.e. the amount initially recognized, less accumulated amortisation).

To determine ECLs, the Group considers changes in the risk of default of the specified debtor since the issuance of the guarantee. A 12-month ECL is measured unless the risk that the specified debtor will default has increased significantly since the guarantee is issued, in which case a lifetime ECL is measured. The same definition of default and the same assessment of significant increase in credit risk as described in Note 1(k)(ii) apply.

As the Group is required to make payments only in the event of a default by the specified debtor in accordance with the terms of the instrument that is guaranteed, an ECL is estimated based on the expected payments to reimburse the holder for a credit loss that it incurs less any amount that the Group expects to receive from the holder of the guarantee, the specified debtor or any other party. The amount is then discounted using the current risk-free rate adjusted for risks specific to the cash flows.

本集團監察指定債務人違約的風險，並當財務擔保的預期信用損失高於擔保的「遞延收益」所載金額時（即初始確認的金額，減累計攤銷）確認減值準備。

為確定預期信用損失，本集團考慮自擔保發行以來指定債務人違約風險的變化。除非自發行擔保以來指定債務人違約的風險顯著增加，否則將計量未來12個月內預期信用損失，在指定債務人違約的風險顯著增加的情況下，將衡量整個存續期內預期信用損失。附註1(k)(ii)中描述了相同的違約定義和對信用風險顯著增加的相同評估。

If there is an active market for a financial asset or financial liability, the quoted price in the active market without adjusting for transaction costs that may be incurred upon future disposal or settlement is used to establish the fair value of the financial asset or financial liability. For a financial asset held or a financial liability to be assumed, the quoted price is the current bid price. For a financial asset to be acquired or a financial liability assumed, it is the current asking price. The quoted prices from an active market are prices that are readily and regularly available from an exchange, broker, industry group or pricing service agency, and represent actual and regularly occurring market transactions on an arm's length basis.

If no active market exists for a financial instrument, a valuation technique is used to establish the fair value. Valuation techniques include using recent arm's length market transactions between knowledgeable, willing parties; reference to the current fair value of another instrument that is substantially the same; discounted cash flow analysis and option pricing models. Where discounted cash flow technique is used, future cash flows are estimated based on management's best estimates and the discount rate used is the prevailing market rate applicable for instrument with similar terms and conditions at the end of each reporting period. Where other pricing models are used, inputs are based on market data at the end of each reporting period.

對存在活躍市場的金融資產或金融負債，用活躍市場中的報價確定其公允價值，且不扣除將來出售或處置該金融資產或金融負債時可能發生的交易費用。對於已持有的金融資產或將發生的金融負債，報價為當前競標價。對於將取得的金融資產或已發生的金融負債，報價為當前報價。活躍市場中的報價是可容易且經常從交易所、代理人、行業集團或定價服務機構獲取的，並且代表實際和經常發生的正常市場交易。

對不存在活躍市場的金融工具，採用估值技術確定其公允價值。所採用的估值技巧包括參考熟悉情況並自願交易的各方最近進行的市場交易的成交價、參照實質上相同的其他金融工具的當前公允價值、現金流量折現分析及期權定價模式。當使用現金流量折現法時，估計未來現金流量乃根據管理層的最佳估計，所使用的折現率乃具有相若條款及條件的工具所適用之各報告期末之市場利率。當使用其他定價模式時，輸入的數據乃根據報告期末的市場數據計算。

The Group obtains market data from the same market where the financial instrument was originated or purchased.

##### (v) Interim financial reporting and impairment

Under the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited, the Group is required to prepare an interim financial report in compliance with HKAS 34, Interim financial reporting, in respect of the first six months of the financial year. At the end of the interim period, the Group applies the same impairment testing, recognition, and reversal criteria as it would at the end of the financial year (see Notes 1(k)(ii) and (iii) and 1(n)(i) and (ii)).

Impairment losses recognized in an interim period in respect of goodwill are not reversed in a subsequent period. This is the case even if no loss, or a smaller loss, would have been recognized had the impairment been assessed only at the end of the financial year to which the interim period relates.

本集團獲得的市場數據來自產生或購買該金融工具的另一市場。

##### (v) 中期財務報告和減值

根據香港聯合交易所有限公司證券上市規則，本集團須就本財政年度首六個月編制符合香港會計準則第34號中期財務報告的中期財務報告。於中期期末，本集團採用與財政年度末相同的減值測試，確認及轉回準則（見附註1(k)(ii)以及(iii)，1(n)(i)以及(ii)）。

Interest-bearing borrowings are measured initially at fair value less transaction costs. Subsequent to initial recognition, interest-bearing borrowings are stated at amortized cost using the effective interest method. Interest expense is recognized in accordance with the Group's accounting policy for borrowing costs (see Note 1(t)).

#### (m) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Cash and cash equivalents are assessed for ECL in accordance with the policy set out in Note 1(k)(ii).

#### (n) Impairment of non-financial assets

##### (i) Impairment of investments in subsidiaries, associates and joint venture

Investments in subsidiaries, associates and joint venture are reviewed at the end of each reporting period to determine whether there is objective evidence of impairment. Objective evidence of impairment includes observable data that comes to the attention of the Group about one or more of the loss events in Note 1(k)(ii). When any such evidence exists, the impairment loss is measured by comparing the recoverable amount of the investment with its carrying amount in accordance with Note 1(d) and Note 1(e). The impairment loss is reversed if there has been a favorable change in the estimates used to determine the recoverable amount in accordance with Note 1(n)(ii).

貨幣資金包括銀行存款及現金、存放於銀行及其他金融機構的活期存款，以及可隨時兌換為已知數額現金、價值變動風險不大，並在認購後三個月內到期的短期高流動性投資。現金和現金等價物根據附註1(k)(ii)中規定的政策評估預期信用損失。

If any such indication exists, the asset's recoverable amount is estimated. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a cash-generating unit). A portion of the carrying amount of a corporate asset (for example, head office building) is allocated to an individual cash-generating unit if the allocation can be done on a reasonable and consistent basis, or to the smallest group of cash-generating units if otherwise.

Salaries, annual bonuses, paid annual leave and defined contribution the Group makes pursuant to the relevant laws and regulations of the PRC are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

Pursuant to the relevant laws and regulations of the PRC, the Group's subsidiaries in the PRC have joined defined contributions for the employees, such as basic pension scheme, housing fund, basic medical insurance, unemployment insurance, injury insurance and maternity insurance. The Group makes contributions to the above mentioned schemes at the applicable rates based on the amounts stipulated by the government organization. The contributions are charged to the statement of profit or loss on an accrual basis.

薪金、年終獎金、帶薪年假及本集團根據中國相關法律及條例作出的指定供款於僱員提供相關服務的年度內計算。如延遲付款或結算並構成重大影響，則此等金額會以現值列賬。

根據相關中國法律和條例，本集團位於中國的附屬公司為員工加入了指定供款，例如基本養老金計劃、住房公積金、基本醫療保險、失業保險、意外傷害保險及產險。本集團根據政府組織規定金額按適用比例向上述計劃供款。供款按應計基準計入當期損益。

The fair value is measured at grant date using the Cox-Ross-Rubinstein Binomial Pricing model, taking into account the terms and conditions upon which the awards were granted. Where the employees have to meet vesting conditions before becoming unconditionally entitled to the awards, the total estimated fair value of the awards is spread over the vesting period, taking into account the probability that the awards will vest.

During the vesting period, the number of share awards that is expected to vest is reviewed. Any resulting adjustment to the cumulative fair value recognized in prior years is charged/credited to the profit or loss for the year of the review, unless the original employee expenses qualify for recognition as an asset, with a corresponding adjustment to the capital reserve. On vesting date, the amount recognized as an expense is adjusted to reflect the actual number of awards that vest (with a corresponding adjustment to the capital reserve) except where forfeiture is only due to not achieving vesting conditions that relate to the market price of the Company's shares. The equity amount is recognized in the capital reserve until either the option is exercised (when it is included in the amount recognized in share capital for the shares issued) or the option expires (when it is released directly to retained profits).

Termination benefits are recognized at the earlier of when the Group can no longer withdraw the offer of those benefits and when it recognizes restructuring costs involving the payment of termination benefits.

#### (p) Income tax

Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognized in the statement of profit or loss except to the extent that they relate to items recognized in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognized in other comprehensive income or directly in equity, respectively.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the end of reporting period, and any adjustment to tax payable in respect of previous years.

Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purposes and their tax bases. Deferred tax assets also arise from unused tax losses and unused tax credits.

辭退福利產生的負債以·本集團在不能單方面撤回因解除勞動關係計劃或裁減建議所提供的辭退福利和已經制定正式的解除勞動關係計劃或提出自願裁減建議並即將實施·兩者孰早確認。

#### (p) 所得稅

年度所得稅包括當期所得稅及遞延所得稅資產和負債的變動。當期所得稅及遞延所得稅資產和負債的變動均於當期損益確認，但與其他綜合收益表或直接於權益內確認的項目有關者，則相關稅額分別於其他綜合收益表或直接於權益內確認。

Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary difference or in periods into which a tax loss arising from the deferred tax asset can be carried back or forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credit, that is, those differences are taken into account if they relate to the same taxation authority and the same taxable entity, and are expected to reverse in a period, or periods, in which the tax loss or credit can be utilized.

The limited exceptions to recognition of deferred tax assets and liabilities are those temporary differences arising from goodwill not deductible for tax purposes, the initial recognition of assets or liabilities that affect neither accounting nor taxable profit (provided they are not part of a business combination), and temporary differences relating to investments in subsidiaries to the extent that, in the case of taxable differences, the Group controls the timing of the reversal and it is probable that the differences will not reverse in the foreseeable future, or in the case of deductible differences, unless it is probable that they will reverse in the future.

Additional income taxes that arise from the distribution of dividends are recognized when the liability to pay the related dividends is recognized.

Current tax balances and deferred tax balances, and movements therein, are presented separately from each other and are not offset. Current tax assets are offset against current tax liabilities, and deferred tax assets against deferred tax liabilities, if the Group has the legally enforceable right to set off current tax assets against current tax liabilities and the following additional conditions are met:

- in the case of current tax assets and liabilities, the Group intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously; or

When determining the amounts to be recognized in respect of liabilities arising from the guarantee business, management estimates the provisions based on prior experience and default history of the business (see Note 1(k)(iii)). It is possible that the prior experience and default history is not indicative of future loss on the guarantees issued. Any increase or decrease in the provisions would affect the statement of profit or loss in future years.

##### (ii) Provisions and contingent liabilities

Provisions are recognized for other liabilities of uncertain timing or amount when the Group has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Income is classified by the Group as revenue when it arises from the sale of goods, the provision of services or the use by others of the Group's assets under leases in the ordinary course of the Group's business.

Revenue is recognized when control over a product or service is transferred to the customer, or the lessee has the right to use the asset, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Where the contract contains a financing component which provides a significant financing benefit to the Group, revenue recognized under that contract includes the interest expense accreted on the contract liability under the effective interest method. The Group takes advantage of the practical expedient in paragraph 63 of HKFRS 15 and does not adjust the consideration for any effects of a significant financing component if the period of financing is 12 months or less.

Further details of the Group's revenue and other income recognition policies are as follows:

#### (i) Guarantee and consulting fee income

Guarantee income is recognized when guarantee contracts have been made whereby the related guarantee obligation has been accepted, the economic benefits associated with the guarantee contracts will probably flow in, and the amount of revenue associated with guarantee contracts can be measured reliably. Guarantee income is determined based on the total agreed fee in the guarantee contracts and is recognized in the statement of profit or loss over the period of guarantee. The Group receives consulting fee income in relation to guarantee services in full at inception and records it as unearned income before amortizing it throughout the period of guarantee.

Rental income receivable under operating leases is recognized in profit or loss in equal instalments over the periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the use of the leased asset. Lease incentives granted are recognized in profit or loss as an integral part of the aggregate net lease payments receivable. Variable lease payments that do not depend on an index or a rate are recognized as income in the accounting period in which they are earned.

##### (iv) Insurance broker related service

Commission income from insurance brokerage is recognized in profit or loss on the transaction dates when the relevant contract notes are exchanged.

##### (v) Dividends

- Dividend income from unlisted investments is recognized when the shareholder's right to receive payment is established.
- Dividend income from listed investments is recognized when the share price of the investment goes ex-dividend.

While subsidiaries engaged in providing a range of loan and services to the small sized and micro enterprises (“SME enterprises”) are required to set aside a general reserve through appropriations of profit after tax according to a certain provision ratio of the ending balance of gross risk-bearing assets to cover potential losses against their assets. In principal, the general reserve balance should not be lower than 1.0% of the ending balance of gross risk-bearing assets.

The total appropriation to general reserve of the Group was RMB22.1 million for the year ended 31 December 2021 (2020: RMB45.5 million).

##### (v) Exchange reserve

Foreign exchange differences arising from activities of Huiwei Hong Kong Holding Limited and Hanhua Hong Kong Holdings Limited (accounted in HK dollars) are recognized as “exchange reserve” in the shareholder’s equity in the consolidated statement of financial position.

#### (e) Capital management

The Group’s primary objectives when managing capital are to safeguard the Group’s ability to continue as a going concern, so that it can continue to provide returns for equity shareholders and benefits for other stakeholders, by pricing products and services commensurate with the level of risk and by securing access to finance at a reasonable cost.

而從事中小企業貸款業務的附屬公司需從稅後利潤中提取作為一般風險準備，金額為風險資產總額期末結餘的若干百分比，以彌補其資產可能出現的虧損。原則上，一般風險準備結餘不得少於風險資產總額期末結餘的1.0%。

於截至2021年12月31日止年度，本集團提取一般風險準備總計人民幣22.1百萬元（2020年度：人民幣45.5百萬元）。

#### (e) 資本管理

The Group actively and regularly reviews and manages its capital structure to maintain a balance between the higher equity holder/shareholders returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

There were no changes in the Group's approach to capital management during the years ended 31 December 2021 and 2020.

Particularly for guarantee and credit loan operation, the Group monitors regularly the residual balance of outstanding guarantees or/and credit loans for single customers and multiples of the total outstanding guarantees or/and credit loans in relation to paid-in/share capital of companies in the Group engaging guarantee or/and credit loan business respectively, so as to keep the capital risk within an acceptable limit. The decision to manage the share capital of companies in the Group to meet the needs of developing guarantee or/and credit loans business rests with the directors.

#### Capital investment and management

This segment provides capital investment services to a range of SME enterprises that have growth potential and value, by utilization of fund under their ownership and raising funds through cooperation with external institutions.

#### Others

This segment represents the aggregation of other business lines and the operational results that undertake management functions of the headquarters and cannot be completely divided into any of the above segments.

For the purposes of assessing segment performance and allocating resources between segments, the Group's senior executive management monitors the results, assets and liabilities attributable to each reportable segment on the following bases:

Segment assets include all tangible, intangible assets and current assets with the exception of deferred tax assets. Segment liabilities include all liabilities managed directly by the segments.

Exposure to credit, interest rate and liquidity risks arises in the normal course of the Group's business.

The Group's exposure to these risks and the financial risk management policies and practice used by the Group to manage these risks are described below.

#### (a) Credit risk

Credit risk refers to the risk that a customer will default on its contractual obligations resulting in a financial loss to the Group. Credit risk is primarily attributable to unexpired guarantee issued by the Group and financial assets measured at amortized cost.

The maximum exposure to credit risk is represented by the net carrying amount of each type of financial assets as at the end of the reporting periods. Except for the guarantee as disclosed below, the Group has no credit risk arising from any other guarantee.

#### Credit risk arising from guarantee business

The Group has taken measures to identify credit risks arising from guarantee business. The Group manages credit risk at every stage of the risk management system, including pre-approval, review and credit approval and post-transaction monitoring processes. The Group conducts customer acceptance and due diligence by business department and risk management department during the pre-approval process. A transaction may be subject to the review and approval of credit approval officer, regional risk committee, deputy chairman and chairman depending on the transaction size.

#### (a) 信用風險

信用風險是指因客戶違反合約責任而導致本集團出現財務虧損的風險。信用風險主要來自本集團發行的未到期擔保及按攤餘成本計量的金融資產。

所面對的最大信用風險指於報告期末各種金融資產的淨賬面值。除下列所披露的擔保外，本集團概無產生信用風險的任何其他擔保。

#### 擔保業務產生的信用風險

本集團已採取措施識別擔保業務產生的信用風險。本集團通過風險管理系統管理每個階段的信用風險，包括盡職審查、審查、信用審批及擔保後回訪。於審批前，本集團委派業務部及風險管理部進行客戶接納及盡職審查。根據交易的規模而定，交易可能交由信用審批人、地區風險委員會、副主席及主席審查及審批。

##### Credit risk arising from guarantee business (Continued)

During the post-transaction monitoring process, the Group conducts on-site inspection and ongoing post-transaction reviews focusing on various aspects, including but not limited to customers' product markets, operating income, assets and liabilities, cash flows from operating activities to detect potential risks. The Group takes proactive preventive actions based on the risk analysis and design contingency plans accordingly.

When a certain number of clients undertake the same business activities, stay in the same geographical locations, or bear similar economic features for their industries, their ability to fulfill contracts will be affected by the same economic changes. Concentration of credit risk reflects the sensitivity of the Group's operating results to specific industries or geographical locations. As the Group mainly operates its businesses in the PRC, there exists a certain level of geographical concentration risk for its guarantee and loan portfolios in that it might be affected by changes in the PRC economic conditions.

擔保後回訪，本集團就（包括但不限於）客戶產品市場、經營收入、資產負債情況、經營活動的現金流量等多個方面進行實地檢查及持續回訪，以偵測潛在風險。本集團根據風險分析作出積極的防範措施並設計相應的應變計劃。

當若干數量的客戶進行相同的業務活動，處於相同的地理位置或其行業具有相似的經濟特性，他們的履約能力將受到同一經濟變化的影響。信用風險的集中程度反映了本集團業績對某一特定行業或地理位置的敏感程度。由於本集團主要在中國經營業務，其擔保及貸款組合因此承擔一定的地理集中風險，並可能因中國經濟狀況的變化而受到影響。

##### Credit risk arising from financial assets measured at amortized cost

The Group adopts the same pre-approval, review and credit approval risk management system for credit risk arising from financial assets measured at amortized cost. During the post-transaction monitoring process, the Group conducts a visit of customers within one month after disbursement of loans and receivables, and conducts on-site inspection on a semi-annual basis. The review focuses on the use of loans and receivables, the financial and operational conditions of the borrowers or the progress of projects and status of the collateral.

The Group classifies financial assets measured at amortized cost into three stages and makes provisions for expected credit losses accordingly, depending on whether credit risk on that financial instrument has increased significantly since initial recognition.

The three stages are defined as follows:

Stage 1: A financial asset of which the credit risk has not significantly increase since initial recognition. The amount equal to 12-month expected credit losses is recognized as loss allowance.

Stage 2: A financial asset with a significant increase in credit risk since initial recognition but is not considered to be credit-impaired. The amount equal to lifetime expected credit losses is recognized as loss allowance.

本集團就以攤餘成本計量的金融資產的信用風險採取相同的盡職調查、審查及信用審批。貸後回訪，本集團於發放貸款後一個月內回訪客戶，並每半年一次進行實地檢查。審查主要集中於貸款用途、借款人的財務及經營狀況、項目進度及抵押品的狀況。

本集團將以攤餘成本計量的金融資產劃分為三個階段，並據此計提預期信用損失，預期信用損失取決於該金融工具的信用風險自初始確認後是否出現大幅提高。

三階段定義如下：

階段一：自初始確認後信用風險未顯著增加的金融資產，將未來12個月預期信用損失確認為減值準備。

階段二：自初始確認以來信用風險顯著增加，但未被視為出現信用減值的金融資產，將未來全部預期信用損失確認為減值準備。

Stage 3: A financial asset is considered to be credit-impaired as at statement of financial position date. The amount equal to lifetime expected credit losses is recognized as loss allowance. Refer to Note 1(k)(ii) for the definition of credit-impaired financial assets.

##### Significant increase in credit risk

The assessment of significant increase since initial recognition in the credit risk is performed at least on a quarterly basis for financial assets held by the Group. The Group takes into consideration all reasonable and supportable information (including forward-looking information) that reflects significantly change in credit risk for the purposes of classifying financial assets. The main considerations are regulatory and operating environment, internal and external credit risk gradings, debt-servicing capacity, operating capabilities, contractual terms, and repayment records. The Group compares the risk of default of a single financial asset or a portfolio of financial assets with similar credit risk characteristics as at statement of financial position date and its risk of default at the date of initial application to determine changes in the risk of default during the lifetime of a financial asset or a portfolio of financial assets. In determining whether credit risk of a financial asset has increased significantly since initial recognition, the Group considers factors indicating whether the probability of default has risen sharply, whether the financial asset has been past due for more than 30 days (except micro-lending business, which is 7 days), whether the market price has been falling to assess deterioration.

##### 信用風險顯著增加

自信用風險初步確認後，至少每季度對本集團持有的金融資產進行信用風險是否顯著增加的評估。本集團考慮所有合理以及可支援性的資料（包括前瞻性資料），以反映信用風險的重大變動，並據此分類金融資產。主要考慮因素包括監管和運營環境，內部和外部信用風險評級，償債能力，運營能力，合同條款和還款記錄。在一項金融資產或金融資產組合的存續期內，本集團將該項金融資產或遇有類似信用風險特徵的金融資產組合的違約風險與財務報告日及初始確認日的違約風險進行比較，以確定違約風險的變化。在確定金融資產的信用風險自初始確認後是否顯著增加時，本集團考慮的因素包括違約概率是否大幅上升，金融資產是否逾期30天以上（小額貸款業務為7天），市場價格是否下降到評估惡化的程度。

##### Impairment assessment

Generally, a financial asset is considered to be credit-impaired if:

- It has been overdue for more than 90 days;
- In light of economic, legal or other factors, the Group has made concessions to a customer in financial difficulties, which would otherwise have been impossible under normal circumstances;
- The customer is probable to be insolvent or carry out other financial restructurings;
- Due to serious financial difficulties, the financial asset cannot continue to be traded in an active market;
- There are other objective evidences that the financial asset is impaired.

##### Description of parameters, assumptions, and estimation techniques

Expect for the credit-impaired financial assets, expected credit losses (“ECL”) is measured at an amount equal to 12-month ECL or lifetime ECL depending on whether a significant increase in credit risk has occurred since initial recognition or whether an asset is considered to be credit-impaired. ECL is the product of the Probability of Default (“PD”), Loss Given Default (“LGD”), and Exposure at Default (“EAD”), considering the time value of money. Related definitions are as follows:

PD is the possibility that a customer will default on its obligation within a certain period of time in light of forward-looking information.

LGD is the magnitude of the likely loss if there is a default in light of forward-looking information.

EAD refers to the total amount of on- and off-balance sheet exposures in the event of default and is determined based on the historical repayment records.

The assumptions underlying the ECL calculation, such as how the PDs and LGDs of different maturity profiles change are monitored and reviewed on a quarterly basis by the Group.

There have been no significant changes in estimation techniques or significant assumptions made during the year.

The impairment loss on credit-impaired assets applied cash flow discount method, if there is objective evidence that an impairment loss has incurred, the amount of the loss is measured as the difference between the asset's gross carrying amount and the present value of estimated future cash flows discounted at the asset's original effective interest rate. The allowance for impairment loss is deducted in the carrying amount. The impairment loss is recognized in the statement of profit or loss. In determining allowances on an individual basis, the following factors are considered:

- The sustainability of the customer's business plan;
- The customer's ability to improve performance once a financial difficulty has arisen;

LGD是指在前瞻性資訊出現違約時，可能出現損失的幅度。

EAD是指違約時資產負債表表內和表外風險敞口的總額，其根據歷史還款記錄決定。

ECL計算的基本假設，例如不同期限下PD和LGD如何變化，均由本集團按季度進行監控和審核。

本年估計技術和重大假設沒有顯著變化。

信用減值的資產減值損失採用現金流量折現法，如果有客觀證據表明已發生減值損失，則按照資產總賬面價值與預計未來現金流量現值之間的差額計量。未來現金流量按照實際利率貼現。減值損失在賬面金額中扣除，減值虧損與損益表確認。在確認個別減值時，要考慮如下因素：

It may not be possible to identify a single, or discrete events that result in the impairment, but it may be possible to identify impairment through the combined effect of several events. The impairment losses are evaluated at the end of each reporting period, unless unforeseen circumstances require more careful attention.

##### Forward-looking information contained in ECL

The calculation of ECL incorporates forward-looking information. The Group has performed historical analysis and identified the key economic variables, including GDP, CPI, PMI, M2, Industrial Added Value and Real Estate Climate Index, impacting ECL for each portfolio. The impact of these economic variables on the PD and LGD has been determined by performing statistical regression analysis to understand the correlations among the historical changes of the economic variables, PD and LGD. Forecasts of these economic variables are provided by the Group at least once per year and provide the best estimate view of the economy over the next year.

When calculating the weighted average ECL, the optimism, neutral and pessimism scenarios and its weightings determined by a combination of macro-statistical analysis and expert judgment are taken into account by the Group.

##### Write-off policy

The Group writes off financial assets when it has exhausted practical recovery efforts and has concluded there is no reasonable expectation of recovery.

#### (b) Interest rate risk

The Group is principally engaged in the provision of credit guarantee, lending, factoring, finance lease and related consulting services to SME enterprises in the PRC. Its interest rate risk arises primarily from deposits with banks, loans and advances to customers and interest-bearing borrowings.

At 31 December 2021, it is estimated that a general increase of 50 basis points in interest rates, with all other variables held constant, would have increased the Group's profit before taxation for the next 12 months by approximately RMB3.6 million (2020: RMB8.0 million).

Note 35 contains information about the assumptions and their risk factors relating to fair value of financial instruments. Other key sources of estimation uncertainty are as follows:

#### (a) Impairment of financial assets measured at amortised cost

The Group reviews portfolios of financial assets measured at amortized cost to assess whether any impairment losses exist and the amount of impairment losses if there is any indication of impairment. Objective evidence for impairment includes observable data indicating that there is a measurable decrease in the estimated future cash flows for financial assets measured at amortized cost. It also includes observable data indicating adverse changes in the repayment status of the debtors, or change in national or local economic conditions that causes the default in payment.

The impairment loss for financial assets measured at amortized cost using the expected credit loss model is subjected to a number of key parameters and assumptions, including the identification of loss stages, estimates of probability of default, loss given default, exposures at default and discount rate, adjustments for forward-looking information and other adjustment factors. The expected credit losses for financial assets measured at amortized cost are derived from estimates whereby management takes into consideration historical data, the historical loss experience and other adjustment factors. Historical loss experience is adjusted on the basis of the relevant observable data that reflect current economic conditions and the judgment based on management's historical experience. Management reviews the selection of those parameters and the application of the assumptions regularly to reduce any difference between loss estimates and actual loss.

#### (a) 以攤餘成本計量的金融資產減值

本集團定期覆核以攤餘成本計量的金融資產，以評估是否出現任何資產減值損失，以及若出現任何減值跡象，則評估有關資產減值損失金額。減值客觀證據包括可觀察資料顯示以攤餘成本計量的金融資產的預計未來現金流出現可衡量的減幅。此外，亦包括可觀察資料顯示債務人的還款狀況出現不利變動、或國家或地方經濟狀況出現變動而導致拖欠還款。

以攤餘成本計量的金融資產在使用預期信用損失模型評估資產減值損失時，受若干關鍵參數和假設的影響，包括損失階段的確定，違約概率的估計，違約損失率，違約風險敞口，貼現率，調整前瞻性資訊和其他調整因素。在評估以攤餘成本計量的金融資產的預期信用損失時，要考慮管理層對於歷史數據，歷史損失經驗和其他調整因素的估計。歷史損失經驗根據當前經濟狀況的相關可觀察數據和管理層歷史經營的盤坐做出調整。管理層定期考慮這些參數的選擇及假設的應用，以降低損失估計與實際損失之間的差異。

#### (b) Impairment of long-lived assets

If circumstances indicate that the carrying amount of a long-lived asset may not be recoverable, the asset may be considered "impaired", and an impairment loss may be recognized in accordance with accounting policy for impairment of long-lived assets as described in Note 1(n) (ii). The carrying amounts of long-lived assets are reviewed periodically in order to assess whether the recoverable amounts have declined below the carrying amounts. When such a decline has occurred, the carrying amount is reduced to recoverable amount. The recoverable amount is the greater of the fair value less costs to sell and the value in use. In determining the value in use, expected future cash flows generated by the asset are discounted to their present value, which requires significant judgment relating to the level of revenue and amount of operating costs. The Group uses all readily available information in determining an amount that is a reasonable approximation of the recoverable amount, including estimates based on reasonable and supportable assumptions and projections of the level of revenue and amount of operating costs. Changes in these estimates could have a significant impact on the carrying value of the assets and could result in additional impairment charge or reversal of impairment in future periods.

#### (c) Depreciation and amortisation

Property, plant and equipment and intangible assets are depreciated and amortized using the straight-line method over their useful lives after taking into account estimated residual value. The useful lives and residual value are regularly reviewed to determine the depreciation and amortization costs charged in each reporting period. The useful lives are determined based on historical experience of similar assets and the estimated technical changes. If there is an indication that there has been a change in the factors used to determine the depreciation, the rate of depreciation is revised.

#### (d) Provisions for guarantee losses

The Group makes reasonable estimate on costs required to fulfil the relevant obligation of guarantee contracts when the Group computes the provisions of guarantee losses. Such estimation is made based on the available information as at the balance sheet date and is determined by the Group's practical experience, taking into consideration of industry information and market data.

#### (e) Tax

Determining income tax provisions involves judgment on the future tax treatment of certain transactions. The Group carefully evaluates the tax implications of transactions and tax provisions are set up accordingly. The tax treatment of such transactions is reconsidered periodically to take into account all changes in tax legislation. Deferred tax assets are recognized for tax losses not yet used and temporary deductible differences. As those deferred tax assets can only be recognized to the extent that it is probable that future taxable profits will be available against which the unused tax credits can be utilized, management's judgment is required to assess the probability of future taxable profits. Management's assessment is constantly reviewed and additional deferred tax assets are recognized if it becomes probable that future taxable profits will allow the deferred tax assets to be recovered.

確定所得稅涉及對某些交易未來稅務處理的判斷。本集團慎重評估各項交易的稅務影響，並計提相應的所得稅準備。本集團定期根據更新的稅收法規重新評估這些交易的稅務影響。遞延所得稅資產按可抵扣稅務虧損及可抵扣暫時性差異確認。遞延所得稅資產只會在未來期間很有可能足夠應納稅所得用作抵扣暫時差異時確認，所以需要管理層判斷以評估未來應納稅所得的可能性。管理層持續審閱對遞延所得稅的判斷，如果預計未來很有可能獲得能利用遞延所得稅資產的未來應納稅所得，將確認相應的遞延所得稅資產。

The Group is in the process of making an assessment of what the impact of these developments is expected to be in the period of initial application. So far it has concluded that the adoption of them is unlikely to have a significant impact on the consolidated financial statements.

### 41 CONSOLIDATED STRUCTURED ENTITY

The Group has consolidated structured entities which issued trust plans of RMB114.7 million at 31 December 2021 (31 December 2020: RMB534.1 million). The Group acquired all the interests of the subordinated tranches of the trust plans and the Group provided financial guarantee against the investors that required the senior tranches.

The Group has consolidated structured entities which initiated partnerships of RMB1,657.8 million at 31 December 2021 (31 December 2020: RMB1,595.4 million). The Group has the right to variable returns from its involvement and has the ability to affect its returns through its power over the entity and the Group provided financial guarantee against the limited liabilities partners that required the fixed returns.

As at 31 December 2021, the above structured entities consolidated by the Group amounted to RMB1,772.5 million (31 December 2020: RMB2,129.5 million).

The relevant activities of the structured entities are directed by means of contractual arrangement and the entity has been designed so that voting or similar rights are not the dominant factor in deciding who has control. These structured entities are consolidated as the Group is exposed or has the right to variable returns from its involvement with these entities and has the ability to affect its returns through its power over the entity.

### 40 於截至2021年12月31日止年度已頒布但尚未生效的修訂、新準則及解釋的潛在影響(續)

本集團正著手評估此等修訂預計對香港財務報告準則於初步應用期間的影響。至今，本集團認為採用此等修訂不會對合併財務報表造成重大影響。

### 41 結構化主體

本集團已合併列示於2021年12月31日發行的人民幣114.7百萬元(2020年12月31日：人民幣534.1百萬元)信託計劃的結構化主體。本集團取得信託計劃次級部分的全部權益，對優先級部分的投資者提供財務擔保。

納入本集團合併財務報表範圍的結構化主體包括設立的合夥企業。截至2021年12月31日已發起的合夥業務規模為人民幣1,657.8百萬元(2020年12月31日：人民幣1,595.4百萬元)。本集團因參與該等主體的營運而有權享有其可變回報，並能夠運用其對該等主體的權利影響上述回報，且本集團向獲取固定回報的有限責任合夥人提供財務擔保。

於2021年12月31日，納入本集團合併財務報表範圍的結構化主體餘額為人民幣1,772.5百萬元(2020年12月31日：人民幣2,129.5百萬元)。

由於該等結構化主體的相關活動是直接按照合同安排進行的，所以表決權不是決定是否控制該等結構化主體的主要因素。本集團因參與該等主體的營運而獲得或有權享有其可變回報，並能夠運用其對該等主體的權利影響上述回報。因此，本集團將該等結構化主體納入合併範圍。

On 10 January 2022, the Company and Chengdu Metallic Materials Co., Ltd. (成都市金屬材料有限公司) entered into an equity transfer agreement pursuant to which the Company has agreed to acquire, at the total consideration of RMB116,000,000, an aggregate of approximately 14.29% equity interest in Sichuan Micro-credit from Chengdu Metallic Materials Co., Ltd. Upon completion of the equity transfer, Sichuan Micro-credit will become a direct wholly-owned subsidiary of the Company.
