Such increase was primarily attributable to (i) a fair value gains arising from revaluations of the investment properties of the Group and its associated companies for the YR 2022 as compared to a fair value losses for the YR 2021 and (ii) the Group's share of profits from the sale of properties of an associated company for the YR 2022 (whereas no realized profit from the sale of properties was recorded for the YR 2021), nothwithstanding that there were declines in the exchange gain arising from the appreciation of Renminbi as well as the rental income and the interest income.
