主席報告書

Chairman's Statement

本人謹代表麗年國際控股有限公司(「本公司」,連同其附屬公司統稱「本集團」)董事(「董事」)於然向本公司股東(「股東」)提呈本集團截至2021年12月31日止年度(「2021財政年度」)或「報告期間」)的年度業績及綜合財務報表連同截至2020年12月31日止年度(「2020財政年度」)的比較數字。

COVID-19危機已臨近第三個年頭,儘管全球經濟環境仍然艱難且充滿挑戰,但我們2021年仍然取得了振奮人心的成績。

美國(「美國」)與中華人民共和國(「中國」)兩國 的緊張貿易局勢以及烏克蘭戰爭繼續影響我們 產品的市場需求及供應穩定性。誠如本公司 2021年中期報告所述,2021財政年度上半年 本集團收益增長遭受期內全球供應鏈及物流中 斷以及半導體及其他電子原件的短缺加劇的不 利影響。此外,期內中國的電力短缺以及馬來 西亞實施的封鎖及其他安全措施已擾亂我們的 生產並影響我們於2021財政年度上半年訂單的 履行。該等綜合因素對本集團2021財政年度 上半年的財務業績產生不利影響,其中,本集 團於2021財政年度上半年僅錄得收益421.3百 萬港元因本集團亦蒙受虧損7.9百萬港元。面 對重重挑戰及艱難的經營環境,我們繼續努力 開拓新的客戶群,受惠於全球經濟逐步回暖, 致使本集團於2021財政年度下半年收到來自 部分主要客戶及新客戶的銷售訂單顯著增加。 憑藉我們靈活的製造能力及克服挑戰的努力, 我們於2021財政年度下半年錄得收益626.0百 萬港元及溢利28.0百萬港元。因此,儘管受 COVID-19流行病的不利影響,本集團於2021 財政年度錄得總收益1,047.3百萬港元及溢利 20.1百萬港元,較2020財政年度的收益819.5 百萬港元增加227.8百萬港元或27.8%及純利 1.5百萬港元增加18.7百萬港元或1,286.6%。

2021財政年度本公司權益持有人應佔年內溢利為20.1百萬港元(2020財政年度:1.5百萬港元)。溢利增加主要是由於全球經濟逐步復甦,2021年本集團現有主要客戶及新客戶訂單大幅增加,導致截至2021年12月31日止年度收益大幅增加。

全球經濟初步反彈和COVID-19疫情逐步好轉可能對本集團情況扭轉有所貢獻,然而,我們確信,本公司員工的堅韌不拔及樂於奉獻的精神更是功不可沒。

董事建議及宣派截至2021年12月31日止年度末期股息每股0.0025港元。

On behalf of the board (the "Board") of directors (the "Directors" and each a "Director") of Wise Ally International Holdings Limited (the "Company", together with its subsidiaries, the "Group"), I am pleased to present to the shareholders of the Company (the "Shareholders") the annual results and consolidated financial statements of the Group for the year ended 31 December 2021 ("FY2021" or the "reporting period") together with the comparative figures for the year ended 31 December 2020 ("FY2020").

Approaching the third year of the COVID-19 crisis, though the economic environment is still tough and challenging, we completed the year of 2021 with a very encouraging result.

The enormous trade tensions between the United States (the "U.S.") and the People's Republic of China (the "PRC") together with the Ukraine War have continued to affect the market demand for our products as well as supply stability. As mentioned in the Company's 2021 interim report, the growth of the Group's revenue in the first half of FY2021 was adversely affected by the global supply chain and logistic disruptions and intensified shortages of semiconductors and other electronic components during the period. In addition, the power shortage in the PRC and the lockdown and other safety measures implemented in Malaysia had disrupted our production and affected our orders fulfilment during the first half of FY2021. The combined impact of these factors adversely affected the Group's financial performance in the first half of FY2021, by which the Group's revenue only hit HK\$421.3 million suffering from a loss of HK\$7.9 million for the first half of FY2021. In response to the challenges and difficult operating conditions, by putting more efforts in developing and exploring the new customer base, we have been benefited from gradual rebound of the global economy leading to a significant increase in sales orders received by our Group from some of our major customers and the new customers in the second half of FY2021. With our resilient manufacturing capabilities and our efforts in overcoming the challenges, we achieved a revenue of HK\$626.0 million with a profit of HK\$28.0 million in the second half of FY2021. As a result, the Group recorded a total revenue of HK\$1,047.3 million and profit of HK\$20.1 million for FY2021, reflecting an increase of HK\$227.8 million or 27.8% as compared to the revenue of HK\$819.5 million and an increase of HK\$18.7 million or 1,286.6% as compared to net profit of HK\$1.5 million for FY2020, despite the adverse impacts from the COVID-19 pandemic.

Profit for the year attributable to equity holders of the Company for FY2021 amounted to HK\$20.1 million (FY2020: HK\$1.5 million). The increase in profit was mainly attributable to the substantial increase in revenue for the year ended 31 December 2021 mainly due to the gradual recovery of the global economy which resulted in a significant increase in orders from the existing major and new customers of the Group during 2021.

A tentative rebound of the global economy and gradual easing of COVID-19 pandemic might have contributed, but, with certitude and pride, it is the resiliency and dedication of our staff that underwrite this significant upswing.

The Directors recommended a final dividend of HK\$0.0025 per share for the year ended 31 December 2021.

Chairman's Statement

前景

儘管COVID-19奧密克戎變種病毒已經開始消退,但由於俄烏戰爭的爆發,世界發展仍未能恢復「常態」,該戰爭無可爭辯是繼第二次世界大戰後最嚴峻、最危險的軍事衝突,人類遭受巨大創傷。該戰爭的後果可能極其宏大深遠,現階段無法衡量和理解。面對眾多不明朗因素,唯一可確定的是未來仍將受戰亂新起、通脹激增以及利率飆升等困擾。

作為回應,未來我們將引進新的管道產品以拓 展新客戶,而開發自主品牌產品將成為企業發 展的潮流與方向。

最重要的是,我們已與Talentone Technology Limited達成合作,該公司已獲得財富榜百強 公司(「許可方」)的許可,可於其日常業務過程 中作為批發分銷商在某些產品中使用許可商標 (「許可商標」),通過時間歷練及不斷努力,我 們將在地板護理產品領域獲得絕佳增長機會。

許可方在超過70多個國家的1,200多個地點分銷帶有其許可商標的產品。可想而知,憑藉此等聯繫,本集團的能力和業務版圖可實現極大擴展。

縱使諸多變數,前途難測,仍篤信不疑,鉛華 盡,意尤盛。

PROSPECTS

Even as the Omicron variant of COVID-19 has begun to recede, the world has not yet been able to return to 'normalcy' when the Russo-Ukrainian War erupted in what is arguably the greatest, most dangerous military conflict since after World War Two. On top of the above, our collaboration with Talentone Technology Limited, which has been licensed by a Fortune 100 company (the "Licensor") to use the licensed trademark (the "Licensed Trademark") in certain products in its ordinary course of business as a wholesale distributor, has been consummated which should, with time and effort, open up exciting growth opportunities in the area of floor care products.

The Licensor distributes products with their Licensed Trademark in over 1,200 locations across over 70 countries. It is envisioned that by leveraging this linkage, our Group's capabilities and footprints can be much expanded.

Despite all these current uncertainties, we are confident that the Company will emerge fresher, stronger and worthier.

管理層討論與分析

Management Discussion and Analysis

財務回顧

儘管受到本年報的主席報告書所述COVID-19 流行病的不利影響,本集團於2021財政年度錄 得收益1,047.3百萬港元(2020財政年度:819.5 百萬港元),較截至2020財政年度的收益819.5 百萬港元增加227.8百萬港元或27.8%,有關增 加乃主要由於2021年第四季度業務復甦所致。

2021財政年度,我們的產品運往逾25個(2020財政年度:24個)國家和地區。美國仍然是我們最大的市場,其貢獻430.9百萬港元(2020財政年度:439.7百萬港元)或我們總收益41.1%(2020財政年度:53.7%)。由於美國銷售額非常穩定,向美國的銷售額較去年同期僅出現小幅下降。美國銷售下降12.6%,乃由於2021財政年度在其他國家(如菲律賓及愛爾蘭)的銷售額顯著增加所致。銷往世界其他主要國家的銷售組合變動,主要受COVID-19疫情和部分國家之間的主要客戶分銷策略改變所綜合影響。

毛利為194.3百萬港元(2020財政年度:156.9 百萬港元),相當於增加37.4百萬港元或23.8%,而毛利率由2020財政年度的19.1%減少至2021財政年度的18.5%。毛利的增加乃主要由於新客戶帶來收入增加,而毛利率下降乃為2021財政年度關鍵零部件短缺及供應鏈中斷導致材料成本上升的直接結果。

銷售及分銷與行政開支為145.9百萬港元(2020 財政年度:135.7百萬港元),相當於增加10.2 百萬港元或7.5%。開支增加乃主要由於2021 財政年度全球運費急劇上升所致。

淨融資成本由2020財政年度的11.2百萬港元減少3.7百萬港元或33.0%至2021財政年度的7.5百萬港元。減少主要歸因於2021財政年度內償還若干循環貸款及定期貸款所致。

鑒於上文所述,2021財政年度本公司權益持有人應佔年內溢利為20.1百萬港元(2020財政年度:1.5百萬港元)。2021財政年度溢利增加主要是由於2021財政年度下半年因全球經濟逐步適應流行病狀況而獲得溢利,惟被2021財政年度上半年蒙受虧損所輕微抵銷。

FINANCIAL REVIEW

The Group recorded revenue of HK\$1,047.3 million for FY2021 (FY2020: HK\$819.5 million), reflecting an increase of HK\$227.8 million or 27.8% as compared to revenue of HK\$819.5 million for FY2020, mainly due to the recovery of business in the last quarter in 2021 despite the adverse impacts from the COVID-19 pandemic as mentioned in the Chairman's Statement of this annual report.

For FY2021, our products were shipped to over 25 (FY2020: 24) countries and regions. The U.S. continued to be our largest market, which contributed to HK\$430.9 million (FY2020: HK\$439.7 million), or 41.1% (FY2020: 53.7%) of our total revenue. Sales to the U.S. showed a minute drop in comparison with that of last year, as sales in the U.S. were fairly stable. The percentage of U.S. sales displayed a fall of 12.6%, which was attributed to remarkably expanded sales in other countries, such as the Philippines and Ireland, in FY2021. The changes in sales mix to other major countries of the world were mainly the combined impact of the COVID-19 pandemic and change of distribution strategy from some of our major customers between countries.

Gross profit amounted to HK\$194.3 million (FY2020: HK\$156.9 million), representing an increase of HK\$37.4 million, or 23.8%, while the gross profit margin decreased from 19.1% for FY2020 to 18.5% for FY2021. The increase in gross profit was mainly due to the increase in revenue brought by new customers, whilst the decrease in gross profit margin was a direct result of higher material costs driven by key components shortage and supply chain disruption in FY2021.

The selling and distribution and administrative expenses amounted to HK\$145.9 million (FY2020: HK\$135.7 million), reflecting an increase of HK\$10.2 million or 7.5%. The increase in expenses was primarily due to an especially steep increase in global freight rates in FY2021.

Net finance costs decreased by HK\$3.7 million, or 33.0% from HK\$11.2 million for FY2020 to HK\$7.5 million for FY2021. The decrease was mainly due to the fact that some revolving loans and term loans were repaid during FY2021.

As a result of the foregoing, profit for the year attributable to equity holders of the Company for FY2021 amounted to HK\$20.1 million (FY2020: HK\$1.5 million). The increase in profit for FY2021 was mainly attributable to the profit attained in the second half of FY2021, which was slightly offset by the loss suffered in the first half of FY2021 as the global economy had been gradually adapting to the conditions of the pandemic.

Management Discussion and Analysis

股息

董事會建議派發截至2021年12月31日止年度的末期股息5.0百萬港元(2020年:10.0百萬港元),相當於每股普通股0.0025港元(2020年:0.0050港元)。待本公司股東於2022年6月1日(星期三)舉行的本公司應屆股東週年大會(「2022年股東週年大會」)上批准後,建議末期股息預計於2022年6月23日(星期四)或之前派付予於2022年6月9日(星期四)名列本公司股東名冊的本公司股東。

本公司並無訂立任何安排以致股東須據此放棄或同意放棄任何股息。

流動資金及財務資源

本集團主要透過結合經營活動產生的內部資金 及銀行借款為流動資金及資本需求提供資金。 於2021年12月31日,本集團銀行借款為249.9 百萬港元(2020年12月31日:261.5百萬港元),而本集團現金及現金等價物為207.3百萬港元(2020年12月31日:234.4百萬港元)。

於2021年12月31日,本集團總借款淨額為42.6百萬港元(2020年12月31日:27.1百萬港元),而其總權益為152.7百萬港元(2020年12月31日:137.7百萬港元),淨資本負債比率為27.9%(2020年12月31日:19.7%)。淨資本負債比率乃按總借款扣除現金及現金等價物除以總權益再乘以100%計算。

本集團具備充足的流動資金應付其目前及日後 的營運資金需求。

資本開支及承擔

於2021財政年度,本集團產生總資本開支16.9 百萬港元(2020財政年度:19.4百萬港元),用 於添置物業、廠房及設備以及無形資產。

於2021年12月31日,本集團擁有已訂約但尚未 撥備有關購買廠房及機器之資本承擔1.8百萬港 元(2020年12月31日:4.9百萬港元)。

DIVIDEND

The Board recommends the payment of a final dividend of HK\$5.0 million (2020: HK\$10.0 million), representing HK\$0.0025 (2020: HK\$0.0050) per ordinary share for the year ended 31 December 2021. Subject to the approval by the shareholders of the Company at the forthcoming annual general meeting of the Company to be held on Wednesday, 1 June 2022 (the "2022 AGM"), the proposed final dividend is expected to be paid on or before Thursday, 23 June 2022 to the shareholders of the Company whose names appear on the register of members of the Company on Thursday, 9 June 2022.

There is no arrangement under which a shareholder has waived or agreed to waive any dividends.

LIQUIDITY AND FINANCIAL RESOURCES

The Group funded its liquidity and capital requirements primarily through a combination of internally generated funds from its operating activities and bank borrowings. As at 31 December 2021, the Group's bank borrowings were HK\$249.9 million (31 December 2020: HK\$261.5 million) while the Group's cash and cash equivalents were HK\$207.3 million (31 December 2020: HK\$234.4 million).

As at 31 December 2021, the Group's total net borrowings amounted to HK\$42.6 million (31 December 2020: HK\$27.1 million) while its total equity amounted to HK\$152.7 million (31 December 2020: HK\$137.7 million), resulting in a net gearing ratio of 27.9% (31 December 2020: 19.7%). The net gearing ratio is calculated as total borrowings net of cash and cash equivalents divided by total equity and multiplied by 100%.

The Group has adequate liquidity to meet its current and future working capital requirements.

CAPITAL EXPENDITURES AND COMMITMENTS

The Group incurred total capital expenditures of HK\$16.9 million during FY2021 (FY2020: HK\$19.4 million) for additions of properties, plant and equipment and intangible assets.

As at 31 December 2021, the Group had capital commitments in relation to the purchase of plant and machinery contracted but not provided for in the amount of HK\$1.8 million (31 December 2020: HK\$4.9 million).

As at 31 December 2021, to the best knowledge of the Board, the Group was not involved in any legal proceedings pending or threatened against our Group which could have a material adverse effect on our business or operations. Besides, the Group did not have any significant contingent liabilities as at 31 December 2021.

CHARGES ON ASSETS

As at 31 December 2021 and 2020, there were no charges over the assets of the Group.

MATERIAL ACQUISITION AND DISPOSAL OF SUBSIDIARIES, ASSOCIATES AND JOINT VENTURES

The Group did not have any material acquisition and disposal of subsidiaries, associates and joint ventures during the year ended 31 December 2021.

SIGNIFICANT INVESTMENTS

As at 31 December 2021, there were no significant investments held by the Group.

FOREIGN EXCHANGE AND RISK MANAGEMENT

The Group operates in Hong Kong and the PRC and is exposed to foreign exchange risk arising primarily with respect to the United States dollars ("USD") and Chinese Renminbi ("RMB"). Most of the Group's sales proceeds are received in USD and some of the Group's purchases and operating expenses are denominated in RMB. The Group closely monitors its overall foreign exchange exposure from time to time and will adopt a proactive but prudent approach to minimize the relevant exposures.

The Group did not enter into any derivative instruments to hedge against its foreign exchange exposure during the year ended 31 December 2021.

Management Discussion and Analysis

資本結構

本公司股份(「**股份**」)自2020年1月10日起在聯 交所主板上市。自股份於上市日期發行以來, 本公司已發行股本概無任何變動。

於2021年12月31日,本集團資本結構包括銀行借款及本公司權益持有人應佔權益(包括已發行股本及儲備)。於2021財政年度,本集團資本結構概無任何重大變動。

僱員

於2021年12月31日,本集團於香港及中國聘用約1,300名(2020年12月31日:1,500名)僱員。2021財政年度的總員工成本為191.4百萬港元(2020財政年度:160.8百萬港元)。本集團所採納的薪酬政策乃按僱員的工作性質、資歷及經驗釐定薪酬。除提供年終花紅及僱員相關保險福利外,本集團亦會基於僱員的個人表現發放酌情花紅。本集團定期檢討薪酬待遇及政策。本集團亦向其僱員提供內部及外部培訓計劃。董事酬金由董事會及本公司薪酬委員會考慮本集團經營業績、個人表現及可資比較市場統計資料後決定。

本集團於2019年12月10日亦已採納一項購股權計劃,以向計劃的合資格參與者(包括本集團的董事、全職僱員、顧問及諮詢師)提供獎勵。於2021財政年度,概無授出任何購股權及於2021年12月31日,計劃項下概無已授出的發行在外購股權。

CAPITAL STRUCTURE

The shares of the Company (the "Shares") have been listed on the Main Board of the Stock Exchange since 10 January 2020. Since the issue of the Shares on the Listing Date, there has been no change in the issued share capital of the Company.

As at 31 December 2021, the Group's capital structure consisted of bank borrowings and equity attributable to equity holders of the Company, comprising issued share capital and reserves. There was no material change in capital structure of the Group during FY2021.

EMPLOYEES

As at 31 December 2021, the Group employed approximately 1,300 (31 December 2020: 1,500) employees in Hong Kong and the PRC. Total staff costs for FY2021 amounted to HK\$191.4 million (FY2020: HK\$160.8 million). The Group adopts a remuneration policy which is commensurate with job nature, qualification and experience of employees. In addition to the provision of annual bonuses and employee related insurance benefits, discretionary bonuses are also rewarded to employees based on individual performance. The remuneration packages and policies are reviewed periodically. The Group also provides in-house and external training programs to its employees. The emoluments of the Directors are decided by the Board and the remuneration committee of the Company having regard to the Group's operating results, individual performance and comparable market statistics.

The Group has also adopted a share option scheme on 10 December 2019 for the purpose of providing incentives to eligible participants of the scheme, including Directors, full-time employees of and advisers and consultants to the Group. No option was granted during FY2021 and as at 31 December 2021, there was no outstanding option granted under the scheme.

報告期結束後的重大事項

(a) 於2022年1月28日,本公司全資附屬公司 麗年控股有限公司(「認購人」)與本公司獨 立 第 三 方 Talentone Technology Limited (「目標公司」)訂立股份認購協議及可換股 債券認購協議,據此,認購人有條件同意分別認購,而目標公司有條件同意分別發行認購股份(「認購股份」),代價為 2,000,000港元(「股份認購」),及可換股債 券,代價合計為44,000,000港元(「可換股債券認購」)。茲提述本公司日期為2022年 1月28日、2022年2月8日及2022年3月22 日之公告,內容有關股份認購及可換股債 券認購詳情之須予披露交易。

目標公司主要從事開發及銷售高科技地板 護理產品(其中包括真空吸塵器)並獲授權 作為批發分銷商可在正常商業進程中在若 干產品上使用許可商標。

FUTURE PLANS FOR MATERIAL INVESTMENTS AND CAPITAL ASSETS

The Group has set out its future plans in the prospectus of the Company dated 27 December 2019 (the "Prospectus"). As part of its future plans, the Group plans to establish production facilities in South East Asia region and expand manufacturing platform in the PRC by acquiring new surface mount technology ("SMT") lines, upgrading the production facility at the existing plant and strengthening the research and development capability for the development and provision of IoT related solutions. The future plans will be funded by a balanced mix of internal resources, borrowings and proceeds from the Global Offering (as defined in the Prospectus).

SIGNIFICANT EVENTS AFTER THE END OF THE REPORTING PERIOD

(a) On 28 January 2022, Wise Ally Holdings Limited ("the Subscriber"), a wholly-owned subsidiary of the Company, entered into the share subscription agreement and the convertible bonds subscription agreement with Talentone Technology Limited ("the Target Company"), an independent third party of the Company, pursuant to which the Subscriber conditionally agreed to subscribe for, and the Target Company conditionally agreed to issue, the subscription Shares (the "Subscription Shares") at a consideration of HK\$2,000,000 (the "Share Subscription") and the convertible bonds at an aggregate consideration of HK\$44,000,000 (the "CB Subscription") respectively. Reference is made to the announcements of the Company dated 28 January 2022, 8 February 2022 and 22 March 2022 in relation to a discloseable transaction regarding the Share Subscription and the CB Subscription in details.

The Target Company is principally engaged in the development and sales of the high technology floor care products including, among others, vacuum cleaners and has been granted the right to use the licensed trademarks in certain products in its ordinary course of business as a wholesale distributor.

待股份認購及可換股債券認購完成後,本 集團可利用目標公司的經驗及銷售網絡並 開始建立自有網絡,同時拓寬本集團的收 入來源。

股份認購及第一批可換股債券認購(認購本金總額為22,000,000港元的可換股債券)已於2022年3月22日完成。

(b) 由於新型冠狀病毒疫情的爆發,中國多個 省市已採取緊急公共衛生措施及多種行動 防止新型冠狀病毒的傳播。

本集團將繼續評估新型冠狀病毒疫情的爆發對本集團財務表現及本集團於東莞的生產工廠運營的影響,以及本集團就此面臨的相關風險及不確定性。本集團將於必要時採取適當措施。

Upon the completion of the Share Subscription and the CB Subscription, the Group can leverage on the Target Company's experience and sales network and start establishing its own network while also expanding the Group's revenue sources.

The Share Subscription and the first tranche CB Subscription of the convertible bonds in a principal amount of HK\$22,000,000 were completed on 22 March 2022.

(b) Due to the outbreak of the novel coronavirus pandemic, a number of provinces and municipalities in the PRC have taken emergency public health measures and various actions to prevent the spread of the novel coronavirus.

The Group will continue to assess the impact of the outbreak of the novel coronavirus pandemic on the financial performance of the Group and operation of the Group's production plant in Dongguan and the Group's exposure to the risks and uncertainties in this connection. The Group will take appropriate measures as necessary.

朱慧恒先生為本公司多家附屬公司之董事。 於本集團在2010年7月成立前,朱慧恒先生 自1990年6月起於德豐控股(香港)有限公司 及其附屬公司擔任主席,負責電子製造服務 (「EMS」)分部的技術、資訊科技及研發職能, 其後則負責該分部的管理及營運。自1977年5 月至20世紀90年代初,朱慧恒先生於一家主要 從事提供機電驅動系統及解決方案的公司擔任 工程師。

朱慧恒先生於1977年3月畢業於美國加州大學 伯克利分校,取得機械工程理學士學位。

朱慧恒先生為執行董事及原創品牌開發董事總經理朱文彥先生的父親,且為本公司控股及主要股東朱惠璋先生的哥哥。彼亦為本公司控股及主要股東及Smart Union Global Group Limited 及 Smartview Investments Limited 各自的董事及股東,上述公司各自於本公司股份中擁有根據香港法例第571章證券及期貨條例(「證券及期貨條例」)第XV部第2及3分部條文須向本公司予以披露的權益。

朱文彥先生(「朱文彥先生」),39歲,於2021年7月2日獲委任為執行董事。彼於2021年1月加入本集團擔任原創品牌開發的董事總經理,負責本集團新品牌分部的整體營運。其職責包括制定自主研發產品的營銷策略及開發新銷售機遇及與內外部合作夥伴保持長期合作關係。

Executive Directors

Mr. Chu Wai Hang Raymond ("Mr. Raymond Chu"), aged 69, is our Chairman, an executive Director and one of the founders of our Group and has been the Chief Executive Officer of the Company since 30 September 2021. He is also a member of the Nomination Committee and Remuneration Committee and an authorized representative of the Company. He is responsible for the leadership of the Board, corporate governance promotion, strategic planning, and major decision-making of our Group.

Mr. Raymond Chu is a director of various subsidiaries of the Company. Prior to the establishment of our Group in July 2010, Mr. Raymond Chu worked for Defond Holdings (H.K.) Co. Limited and its subsidiaries since June 1990 as the chairman responsible for technical, information technology and research and development functions and later for the management and operation of the electronics manufacturing services ("EMS") division. From May 1977 to early 1990s, Mr. Raymond Chu worked as an engineer for a company principally engaged in the supply of electromechanical motion systems and solutions.

Mr. Raymond Chu graduated from the University of California, Berkeley in the U.S. with a bachelor of science in mechanical engineering in March 1977.

Mr. Raymond Chu is the father of Mr. Chu Man Yin Arthur Newton, an executive Director and the managing director of original brand development, and the elder brother of Mr. Chu Wai Cheong Wilson (a controlling and substantial shareholder of the Company). He is also a controlling and substantial shareholder of the Company and a director and shareholder of each of Smart Union Global Group Limited and Smartview Investments Limited, each of which has an interest in the shares of the Company which would fall to be disclosed to the Company under the provisions of Divisions 2 and 3 of Part XV of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong) (the "SFO").

Mr. Chu Man Yin Arthur Newton ("Mr. Arthur Chu"), aged 39, was appointed as an executive Director on 2 July 2021. He joined the Group in January 2021 with the position as the managing director of original brand development responsible for overall operation of the New Branded Division of the Group. His duties include the formulation of the marketing strategy of self-developed products, identification and development of new sales opportunities, and maintaining long-term relationships with internal and external partners.

He was later promoted to senior program manager in February 2013, responsible for overseeing the new projects launching, budget control, coordination and implementation of products, and handling commercial issues with customers. Mr. Arthur Chu's last position in DEIL was research and development senior manager from April 2015 to November 2015, responsible for research, planning and implementing new programs development into the organization.

Mr. Arthur Chu graduated from the University of Southern California with a Bachelor Degree of Science in Mechanical Engineering in 2006.

Mr. Arthur Chu is the son of Mr. Raymond Chu, the Chairman, the Chief Executive Officer, an executive Director and a controlling and substantial shareholder of the Company. Mr. Arthur Chu is also the nephew of Mr. Chu Wai Cheong Wilson, a controlling and substantial shareholder of the Company.

Mr. Lau Shui Fung ("Mr. Lau"), aged 55, was appointed as Chief Financial Officer of the Company and an executive Director on 31 October and on 1 December 2021, respectively. He is responsible for the financial and accounting management of the Group. Prior to joining the Group, Mr. Lau has been the chief financial officer of Defond Holdings (H.K.) Co Ltd., and held various positions, including vice president of finance and company secretary in Defond Holdings (H.K.) Co Ltd. from April 2016 to October 2021. From September 2013 to March 2016, he was the vice president of finance of Computime Group Limited, a company listed on the Main Board of the Stock Exchange (stock code: 320). He had served as an independent non-executive director of Kaisa Health Group Holdings Limited, a company listed on the Main Board of the Stock Exchange (stock code: 0876) for the period from August 2019 to March 2020. He had also served as an independent nonexecutive director of Nam Tai Property Inc. (formerly known as Nam Tai Electronics, Inc.), a company listed on the New York Stock Exchange (stock code: NTP), from June 2018 to June 2019. He held various positions, such as group financial controller, vice president of finance and corporate secretary of Nam Tai Property Inc. from November 2001 to September 2013.

She has also been appointed as an independent non-executive director of Arta TechFin Corporation Limited, a company listed on the Main Board of the Stock Exchange (stock code: 0279), on 29 October 2021. Ms. Ling was an independent non-executive director of Digital Hollywood Interactive Limited, a company listed on the Main Board of the Stock Exchange (stock code: 2022), from November 2017 to June 2021.

Mr. Lee is an executive director of Da Yu Financial Holdings Limited, which is principally engaged in the provision of corporate finance advisory services and asset management services and listed on the Main Board of the Stock Exchange (stock code: 1073), since July 2019. Mr. Lee was an executive director and the chairman of the board of SHK Hong Kong Industries Limited which was listed on the Main Board of the Stock Exchange (stock code: 666) in December 1990 but was delisted on 23 April 2021 subsequent to its successful privatization. Mr. Lee first joined SHK Hong Kong Industries Limited as a manager in July 1992 and became an executive director in September 2004. Mr. Raymond Chu, executive Director, has entered into a director service agreement with the Company for a term of three years commencing from the Listing Date while each of Mr. Arthur Chu and Mr. Lau Shui Fung, executive Directors, has entered into a director service agreement with the Company for a term of three years commencing from 2 July 2021 and 1 December 2021 respectively (all are subject to termination in certain circumstances as stipulated in the relevant director service agreement).

Each of the independent non-executive Directors has entered into a letter of appointment with the Company for an initial term of three years commencing from the Listing Date (subject to termination in certain circumstances as stipulated in the relevant letter of appointment).

None of the Directors being proposed for re-election at the 2022 AGM has a service agreement or letter of appointment with the Company which is not determinable by the Company within one year without payment of compensation, other than statutory compensation.

本集團自2010年起一直向德豐電業集團購買該等產品。有鑑於(i)本集團與德豐電業集團購買及即時交付;及(ii)德豐電業集團向本集團所受的條款屬正常商業條款或不遜於向獨立無事認為,與德豐電業集團的長期業務關係,董事認為,與德豐電業集團的長期業務與德豐電業集團的長期工作關係達致專的人人,實過數數,與德豐電業集團的長期工作關係達致專人之之,與一個人工。

Continuing Connected Transactions – Master Purchase Agreement

On 19 December 2019, Wise Ally Holdings Limited ("HK Wise Ally"), an indirect wholly-owned subsidiary of the Company, and DEIL, which is a company incorporated under the laws of Hong Kong with limited liability and beneficially held as to 50% by Mr. Raymond Chu and as to 50% by Mr. Chu Wai Cheong Wilson (younger brother of Mr. Raymond Chu), each being a controlling Shareholder and a connected person of the Company, entered into a master purchase agreement (the "Master Purchase Agreement"), pursuant to which HK Wise Ally and its subsidiary agreed to purchase, and DEIL and its subsidiaries ("DEIL Group") agreed to supply and/or manufacture a variety of switches (the "Products") to the Group for a term commencing on the Listing Date until 31 December 2022. As such, DEIL is an associate of the connected persons of the Company pursuant to Rule 14A.12(1)(c) of the Listing Rules and the transactions contemplated under the Master Purchase Agreement constitute continuing connected transactions for the Company under Chapter 14A of the Listing Rules.

Pursuant to the Master Purchase Agreement, DEIL Group agreed to supply the Products to the Group at a price which shall be determined on arm's length negotiations based on the prevailing market prices for the supply of similar Products. The parties agreed that each purchase order ("Order") placed by the Group with DEIL Group for the purchase of the Products shall constitute a separate legally binding contract between DEIL Group and the Group upon acceptance by DEIL Group. The terms and conditions of the Master Purchase Agreement shall be deemed to be incorporated into each Order and form part thereof. The parties further agreed that prevailing market price of Products shall be (i) the lower of the quoted prices for such Products of comparable quality ordered in similar quantities obtained by the Group from no less than two independent third parties; or (ii) in the event that the Group is not able to obtain at least two quotes from independent third parties, determined on terms no less favourable than terms available to independent third parties for the purchase of such Products of comparable quality in similar quantities from DEIL Group.

The Group has been purchasing the Products from DEIL Group since 2010. Given (i) the long-term business relationship of the Group with DEIL Group, (ii) that the Group is satisfied with the quality and timely delivery of the Products and (iii) the terms offered by DEIL Group to the Group are of normal commercial terms and no less favourable than those provided by independent third parties, the Directors are of the view that it will be in the interests of the Group and the Shareholders as a whole to continue such transactions with DEIL Group. Furthermore, given the long-term business relationship with DEIL Group, DEIL Group understands the quality, standards, and specifications that the Group requires in relation to the Products, and the Directors believe that the Group would be able to achieve better business and operation efficiencies through the long-term working relationship with DEIL Group. Thus, the Directors believe that the entering into of the Master Purchase Agreement with DEIL Group will bring synergies to the Group's business and operations.

本公司獨立非執行董事已審閱上文持續關連交易並確認訂立該交易乃:

- 按正常商業條款或更佳條款;及

本公司確認其於截至2021年12月31日止年度已 遵守上市規則第十四A章項下有關持續關連交 易的披露規定。 The annual caps for each of the financial years ended/ending 31 December 2020, 2021 and 2022 in respect of the maximum purchase price payable by our Group to DEIL Group in respect of the purchase of the Products are HK\$4.0 million, HK\$4.0 million and HK\$4.0 million, respectively.

During the year ended 31 December 2021, the Group purchased the Products from DEIL Group in an amount of HK\$3.2 million. Details of the transactions with DEIL Group are set out in note 30(b)(ii) to the consolidated financial statements.

The transactions contemplated under the Master Purchase Agreement constitute non-fully exempt continuing connected transactions which are exempt from the circular and independent shareholders' approval requirements but subject to reporting, annual review and announcement requirements under Chapter 14A of the Listing Rules. The Stock Exchange has granted to the Company a waiver from strict compliance with the announcement requirements of the Listing Rules in respect of the nonfully exempt continuing connected transactions.

Annual Review of the Continuing Connected Transactions

The independent non-executive Directors of the Company have reviewed the above continuing connected transactions and confirmed that the transactions were entered into:

- in the ordinary and usual course of business of the Group;
- on normal commercial terms or better; and
- according to the agreement governing the terms that are fair and reasonable in the interests of the Company and Shareholders as a whole.

The Company's auditor was engaged to report on the above continuing connected transactions of the Group in accordance with Hong Kong Standard on Assurance Engagements 3000 (Revised) "Assurance Engagements Other Than Audits or Reviews of Historical Financial Information", and with reference to Practice Note 740 "Auditor's Letter on Continuing Connected Transactions under the Hong Kong Listing Rules" issued by the Hong Kong Institute of Certified Public Accountants. The Company's auditor has issued its unqualified report containing its findings and conclusions in respect of the continuing connected transactions disclosed on pages 30 to 31 of this annual report in accordance with Rule 14A.56 of the Listing Rules. The following is a summary of the principal terms of the Share Option Scheme.

(a) Purpose

The purpose of the Share Option Scheme is to recognise and acknowledge the Eligible Participants (as defined in paragraph (b) below) who have contributed and will contribute to the Group. The Share Option Scheme will provide the Eligible Participants an opportunity to have a personal stake in the Company with the view to achieving the following objectives:

- (i) motivating the Eligible Participants to optimize their performance efficiency for the benefit of the Group; and
- (ii) attracting and retaining or otherwise maintaining on-going business relationships with the Eligible Participants whose contributions are or will be beneficial to the long-term growth of the Group.

(b) Participants

The "Eligible Participants" are:

- (i) any full-time or part-time employees, executives or officers of the Company or any of its subsidiaries;
- (ii) any directors (including non-executive directors and independent non-executive directors) of the Company or any of its subsidiaries;
- (iii) any advisers, consultants, suppliers, customers and agents to the Company or any of its subsidiaries; and

The maximum number of Shares issuable upon exercise of all options to be granted under the Share Option Scheme and any other share option schemes of the Company must not in aggregate exceed 10% of all the Shares in issue as at the Listing Date, being 200,000,000 Shares (the "Limit") (representing 10% of the total number of Shares in issue as at the date of this annual report). The Board may renew the Limit subject to approval of the Shareholders and/or other requirements prescribed under the Listing Rules and the Share Option Scheme but the Limit must not exceed 30% of the issued Shares from time to time.

(d) Maximum number of options to any one individual

The total number of Shares issued and to be issued upon exercise of the options granted to each Eligible Participant (including both exercised and outstanding options and Shares which were the subject of options which have been granted and accepted under the Share Option Scheme and any other share option schemes of the Company but subsequently canceled) under the Share Option Scheme and any other share option schemes of the Company in any 12-month period up to the date of grant shall not exceed 1% of the Shares in issue as of the date of grant. Any further grant of options in excess of this 1% of the issued shares of the Company should be subject to approval of the Shareholders and/or other requirements prescribed under the Listing Rules and the Share Option Scheme.

The Board may at its absolute discretion determine any minimum period for which an option must be held before it can be exercised and/or any performance targets which must be achieved before the option can be exercised, except that no option may be exercised more than ten years after it has been granted.

(f) Amount payable on acceptance of the option and the payment period

To accept the grant of an option, HK\$1.0 as consideration for the grant of an option must be paid by the grantee to the Company on or before the relevant acceptance date, as defined in the Share Option Scheme, which is a date not later than 30 days after the date of grant.

(g) Basis of determining the exercise price

The exercise price shall be such price determined by the Board in its absolute discretion but in any event shall not be less than the highest of:

- the closing price of the Shares as stated in the Stock Exchange's daily quotation sheets on the date of grant, which must be a day on which the Stock Exchange is open for the business of dealing in securities ("Business Day");
- (ii) the average of the closing prices of the Shares as stated in the Stock Exchange's daily quotation sheets for the five Business Days immediately preceding the date of grant; and
- (iii) the nominal value of a Share.

CORPORATE GOVERNANCE PRACTICES

The Board is committed to achieving high corporate governance standards.

The Board believes that high corporate governance standards are essential in providing a framework for the Group to safeguard the interests of Shareholders, enhance corporate value, formulate its business strategies and policies, and enhance its transparency and accountability.

The Company has in place a corporate governance framework and has adopted a set of policies and procedures based on the Corporate Governance Code (the "CG Code") contained in Appendix 14 to the Listing Rules. Such policies and procedures provide the infrastructure for enhancing the Board's ability to implement governance and exercise proper oversight on business conduct and affairs of the Company.

In the opinion of the Directors, during the year ended 31 December 2021, the Company has complied with all the code provisions as set out in the CG Code except as disclosed in this Corporate Governance Report.

The Company has also put in place certain recommended best practices as set out in the CG Code.

The Company has deviated from this code provision as Mr. Raymond Chu has acted as both the Chairman and Chief Executive Officer of the Company since 30 September 2021.

董事會亦認為,董事會目前包括三名可提供不同獨立觀點的獨立非執行董事,足以確保其職權均衡。同時,本公司所有重大決策均在經諮詢董事會成員以及高級管理層後制定。因此,董事會認為本公司當前的組織架構符合股東的整體利益,且已具備足夠的權力平衡及保障。然而,董事會仍將根據現況不時檢討本公司的高組織架構及董事會的組成,以保持本公司的高水平企業管治常規。

獨立非執行董事

本公司已取得各獨立非執行董事獨立性之年度確認書,確認彼等符合上市規則第3.13條所載的獨立性指引。本公司認為所有獨立非執行董事均屬獨立人士。

Considering that Mr. Raymond Chu is the founder of the Group possessing the expertise and extensive experience in the EMS industry conducive to the Company's development, coupled with his responsibility in major decision-making concerning the Group's daily management and business, the Board believes that the roles of Chairman and Chief Executive Officer being assumed solely by Mr. Raymond Chu can provide the Group with strong and consistent leadership and allow for effective development of long-term business strategies and efficient execution of business decisions and plans.

The Board also believes that the balance of authority is adequately ensured as the Board currently comprises three independent non-executive Directors who offer different independent perspectives. At the same time, all major decisions of the Company are made in consultation with members of the Board as well as the senior management. Therefore, the Board is of the view that the current organizational structure of the Company is in the interests of the Shareholders as a whole, and there is adequate balance of power and safeguards in place. The Board will nevertheless review the organizational structure of the Company and composition of the Board from time to time in light of prevailing circumstances in order to maintain a high standard of corporate governance practices of the Company.

Independent non-executive Directors

During the year ended 31 December 2021, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive Directors representing at least one-third of the Board with one of whom possessing appropriate professional qualifications or accounting or related financial management expertise.

The Company has received written annual confirmation from each of the independent non-executive Directors in respect of his/her independence in accordance with the independence guidelines set out in Rule 3.13 of the Listing Rules. The Company is of the view that all independent non-executive Directors are independent.

執行董事朱慧恒先生已與本公司訂立董事服務協議,自上市日期起為期三年。執行董事朱文彦先生及劉士峰先生已與本公司訂立董事服務協議,分別自2021年7月2日及2021年12月1日起為期三年。任何一方均可隨時通過向另一方發出三個月的書面通知或支付代通知款項以終止董事服務協議。

各獨立非執行董事(凌潔心女士、李華倫先生及司徒毓廷先生)已與本公司訂立委任函,自 上市日期起為期三年,可由任何一方向另一方 發出不少於三個月的書面通知予以終止。

Appointment and Re-election of Directors

Code provision A.4.1 of the CG Code stipulated that non-executive directors shall be appointed for a specific term, subject to re-election, whereas code provision A.4.2 stated that all directors appointed to fill a casual vacancy shall be subject to election by shareholders at the first general meeting after appointment and that every director, including those appointed for a specific term, shall be subject to retirement by rotation at least once every three years.

Under the Articles of Association of the Company, at each annual general meeting, one-third of the Directors for the time being, or if their number is not three or a multiple of three, then the number nearest to but not less than one-third, shall retire from office by rotation, provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation and re-election at least once every three years. The Company's Articles of Association also provides that any Director appointed by the Board to fill a casual vacancy shall hold office only until the first general meeting of the Company after his/her appointment and be subject to re-election at such meeting whereas any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election.

Mr. Raymond Chu, executive Director, has entered into a director service agreement with the Company for a term of three years commencing from the Listing Date. Each of Mr. Arthur Chu and Mr. Lau Shui Fung, executive Directors, has entered into a director service agreement with the Company for a term of three years commencing from 2 July 2021 and 1 December 2021 respectively. Either party may at any time terminate the director service agreement by giving to the other party three months' written notice or payment in lieu of notice.

Each of the independent non-executive Directors, Ms. Ling Imma Kit Sum, Mr. Lee Wa Lun Warren and Mr. Szeto Yuk Ting, has entered into a letter of appointment with the Company for a term of three years commencing from the Listing Date, which may be terminated by not less than three months' notice in writing served by either party on the other.

All Directors, including independent non-executive Directors, have brought a wide spectrum of valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning. The independent non-executive Directors are responsible for ensuring a high standard of regulatory reporting of the Company and providing a balance in the Board for bringing effective independent judgement on corporate actions and operations.

All Directors have full and timely access to all the information of the Company and may, upon request, seek independent professional advice in appropriate circumstances, at the Company's expenses, for discharging their duties to the Company.

The Directors shall disclose to the Company details of other offices held by them.

The principal functions of the Board are to supervise the Group's business and affairs; to review the Group's financial performance; to review the Group's systems of risk management and internal control; to approve the strategic plans; and to appoint directors of the Company.

Responsibilities relating to implementing decisions of the Board, directing and co-ordinating the daily operation and management of the Company are delegated to the management.

提名委員會

提名委員會由四名成員組成,即獨立非執行董 事李華倫先生、凌潔心女士及司徒毓廷先生以 及執行董事朱慧恒先生。李華倫先生為提名委 員會主席。

提名委員會的職權範圍與企業管治守則所載者 同等嚴謹。提名委員會的主要職責包括檢討董 事會的架構、規模和組成、開展和制定提名及 委任董事的相關程序,就董事的委任、重新委 任及繼任計劃向董事會提出建議,以及評估獨 立非執行董事的獨立性。

在評估董事會組成時,提名委員會將考慮各個方面及本公司董事會多元化政策所載的董事會多元化相關因素。提名委員會將在必要時討論和商定達致董事會多元化的可衡量目標,並建議董事會採納。

在物色及甄選合適董事候選人時,提名委員會會在推薦予董事會前,考慮本公司提名政策所載候選人就配合公司策略和達致董事會多元化(如適用)所必需的相關標準。

Nomination Committee

The Nomination Committee consists of four members, namely Mr. Lee Wa Lun Warren, Ms. Ling Imma Kit Sum and Mr. Szeto Yuk Ting, independent non-executive Directors, and Mr. Raymond Chu, executive Director. Mr. Lee Wa Lun Warren is the chairman of the Nomination Committee.

The terms of reference of the Nomination Committee are of no less exacting terms than those set out in the CG Code. The principal duties of the Nomination Committee include reviewing the structure, size and composition of the Board, developing and formulating relevant procedures for the nomination and appointment of Directors, making recommendations to the Board on the appointment, re-appointment and succession planning of Directors, and assessing the independence of independent non-executive Directors.

In assessing the Board composition, the Nomination Committee would take into account various aspects as well as factors concerning Board diversity as set out in the Company's Board Diversity Policy. The Nomination Committee would discuss and agree on measurable objectives for achieving diversity on the Board, where necessary, and recommend them to the Board for adoption.

In identifying and selecting suitable candidates for directorships, the Nomination Committee would consider the candidate's relevant criteria as set out in the Company's Nomination Policy that are necessary to complement the corporate strategy and achieve Board diversity, where appropriate, before making recommendations to the Board.

The Nomination Committee held three meetings to review the structure, size and composition of the Board, the independence of the independent non-executive Directors, the Nomination Policy and Board Diversity Policy of the Company and to consider and recommend to the Board on the Directors standing for re-election at the annual general meeting of the Company. The Nomination Committee also made recommendations to the Board on the appointment of new executive Directors and new Chief Executive Officer of the Company.

The Nomination Policy also sets out the procedures for the selection and appointment of new Directors and re-election of Directors at general meetings.

The Nomination Committee will review the Nomination Policy, as appropriate, to ensure its effectiveness. The Nomination Committee will also review at least annually the structure, size and composition (including skills, knowledge and experience) of the Board and diversity of the Board to ensure that it has a balance of expertise, skills, experience and diversity of perspectives appropriate to complement the Company's corporate strategy.

Corporate Governance Functions

The Board is responsible for performing the functions set out in the code provision D.3.1 (now A.2.1) of the CG Code.

The Board reviewed the Company's corporate governance policies and practices, training and continuous professional development of Directors and senior management, the Company's policies and practices on compliance with legal and regulatory requirements, the compliance of the Model Code, and the Company's compliance with the CG Code and disclosure in this Corporate Governance Report. A manual setting out various corporate governance policies and procedures has been adopted by the Company, which applies to assist the Board and the top management to better perform their corporate governance duties to the Group and delegate the responsibilities to the Board committees.

RISK MANAGEMENT AND INTERNAL CONTROLS

The Board acknowledges its responsibility for the risk management and internal control systems and reviewing their effectiveness. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Board has the overall responsibility for evaluating and determining the nature and extent of the risks it is willing to take in achieving the Company's strategic objectives, and establishing and maintaining appropriate and effective risk management and internal control systems.

The Audit Committee assists the Board in leading the management and overseeing their design, implementation and monitoring of the risk management and internal control systems.

The Company has developed and adopted various risk management procedures and guidelines with defined authority for implementation by key business processes and office functions, including sales and receivables, procurements and payments, financial reporting, human resources and information technology.

The Company's risk management and internal control systems include a defined management structure with limits of authority. Appropriate policies and control procedures have been designed, implemented and reviewed to ensure that assets are safeguarded against improper use or disposal; established system, relevant rules and regulations are adhered to and complied with; reliable financial and accounting records are maintained in accordance with relevant accounting standards and regulatory reporting requirements; and key risks that may impact the Company's performance are appropriately identified and managed. Such procedures are designed to manage the risk of failure to achieve business objectives.

The management, in coordination with department heads, assesses the likelihood of risk occurrence, provide treatment plans, and monitor the risk management progress, and reports to the Audit Committee and the Board on all findings and the effectiveness of the systems. Any significant internal audit issues identified and associated remedial actions are followed up for proper implementation, and the progress is reported to the Audit Committee periodically.

本公司已制定內幕資料政策,就處理機密資料、監察信息披露及回應查詢為董事、本集團高級職員及有關僱員提供全面指引。內幕資料政策確保了可能存在的股價敏感或內幕資料可被及時發現、評估及引起董事會垂注,以決定是否需為確保符合證券及期貨條例第XIVA部而作出及時披露。

The management has confirmed to the Board and the Audit Committee on the effectiveness of the risk management and internal control systems for the year ended 31 December 2021.

During the year under review, the Company engaged its external auditor, PricewaterhouseCoopers, to conduct an internal control review on certain operational processes of the Group. A report on the result of assessment and recommendations was provided by PricewaterhouseCoopers to the Audit Committee. The Group will take measures to implement the recommendations made by PricewaterhouseCoopers on the internal control system.

The Board, as supported by the Audit Committee as well as the management report and the internal audit findings, reviewed the risk management and internal control systems, including the financial, operational and compliance controls, for the year ended 31 December 2021, and considered that such systems are effective and adequate. The annual review also covered the financial reporting and internal audit function and staff qualifications, experiences and relevant resources.

The Company has adopted a Whistle-blowing Policy to facilitate employees of the Group to raise, in confidence, concerns about possible improprieties in the practices and procedures, including financial reporting, internal control and other matters, in their workplace. It enables employees to report matters that may constitute (i) noncompliance to laws or regulations; (ii) malpractice, impropriety or fraud relating to internal controls, accounting, auditing and financial matters; (iii) endangerment of the health and safety of an individual; (iv) damage caused to the environment; (v) improper conduct or unethical behaviour likely to prejudice the standing of the Company; and (vi) deliberate concealment of any of the above.

The Company has developed its Inside Information Policy which provides a general guide to the Directors, officers and relevant employees of the Group in handling confidential information, monitoring information disclosure and responding to enquiries. The Inside Information Policy ensures that potentially price sensitive or inside information can be promptly identified, assessed and escalated for the attention of the Board to decide the need for timely disclosure in order to ensure compliance with Part XIVA of the SFO.

Such requisition shall be made in writing to the Board or the Company's company secretary for the purpose of requiring an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition. Such meeting shall be held within two months after the deposit of such requisition. If within 21 days of such deposit, the Board fails to proceed to convene such meeting, the requisitionist(s) himself/ herself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.



環境

概覽

ENVIRONMENTAL

Overview

The Group is an established EMS provider offering full turnkey solutions to customers, with particular focus in consumer electronic products that covers a broad spectrum of product applications, including vapour products, appliances, commercial controls and heating, ventilation and air-conditionings.

The Group acknowledge the importance of environmental protection and follows the principle of sustainable development in our day to day operations in an attempt to improve the environmental awareness of employees and build a more sustainable environment. The Group has formulated an ESG policy to guide the ESG practices, and our Dongguan production plant has also established an environmental management system with relevant policies and procedures for each business process that met the international industry-specific environmental standards and obtained ISO 14001:2015 certification. Some of these policies and procedures include, but are not limited to, the Environmental Management Handbook, the Procedure for Environmental Factors/ Hazard Source Identification, Evaluation and Updating, the Procedure of Monitoring and Measurement of Environmental Performance, and the Management Procedures for Electricity and Water Usage.

The Group strictly abides by the relevant environmental laws and regulations in the PRC, including but not limited to:

- "Environmental Protection Law"

本集團的溫室氣體直接排放主要來源於發電機 及車輛的燃料燃燒以及製冷劑的使用,溫室氣 體間接排放主要來源於外購電力、丢棄的廢紙 以及僱員公事出差乘坐的航班。 The Group's direct emissions of greenhouse gases result principally from the burning of fuels in the generators and vehicles, as well as consuming of refrigerants, while the indirect emissions of greenhouse gases are mainly from the purchased electricity, discarded waste paper and the flights that employees took for business trips.

As the operations in our Dongguan production plant gradually resumed to normal this year, the amount of greenhouse gas emissions have increased compared to the previous Reporting Period. To uphold the principles of sustainable development, the Group is committed to reducing carbon footprint, and aims to maintain greenhouse gas emissions intensity below 380 tonnes CO<sub>2</sub>e per every million units of production by pieces through adopting the following mitigating measures.

#### 減排措施

本集團已採納多項措施減少產生排放物。在車隊管理方面,本集團已禁止僱員將車輛作業務以外的用途,且僱員的長途出行用車申請僅在十分必要的情況下才批准。本集團亦對其車輛進行每週檢查及定期維護,以確保車輛以最高的燃燒效率運行。

對於生產廠房中的柴油發電機,本集團定期安排脱硫、除塵及淨化作業,以達到減少排放的目的。本集團亦安裝排氣通風系統以控制焊接過程中產生的排放物,該等排氣設施由行政部(「行政部」)專責人員負責管理及維護。

通過上述措施,本集團一直保持穩定的排放水平,且該排放水平達到法律規定的排放標準,從而維持ISO 14001:2015認證。

#### 廢棄物管理

本集團倡導綠色及可持續工作環境理念,並堅持「環保4R」原則(減少使用、廢物重用、循環再造及替代使用)。本集團亦鼓勵數字通訊,以減少紙張的使用。此外,本集團實行廢棄物管理程序,該程序將廢棄物分類為有害廢棄物及無害廢棄物。

#### Measures to Reduce Emissions

The Group has adopted a wide range of measures to reduce the emissions that we generate. In relation to our fleet of vehicles, the Group has prohibited the use of vehicles by our employees other than for business purposes, whereas the use of vehicles for long-distance travelling by employees would only be approved if it is strictly necessary. The Group also conducts weekly inspections and regular maintenance of the vehicles to ensure that they are operating at maximum fuel efficiency.

Desulphurization, dust removal and purification are scheduled on a regular basis to reduce the emissions from the diesel generators in the Group's production plants. The Group also installed exhaust ventilation systems to control emissions generated from the soldering process, and such exhaust facilities are managed and maintained by responsible personnel from the Administrative Department ("ADM").

Due to the above measures, the Group has been maintaining a stable emission level that meets the emission standards set out by law in order to maintain ISO 14001:2015 certification.

#### **Waste Management**

The Group advocates the idea of a green and sustainable working environment, and adheres to the principle of the 4'R's' in environmental protection (Reduce, Reuse, Recycle and Replace). The Group also encourages digital communication to reduce the use of paper. Besides, the Group also implemented the Waste Management Procedures that categorises waste into hazardous waste and non-hazardous waste.

#### **Environmental, Social and Governance Report**

有害廢棄物主要來自於化學廢棄物,如廢棄礦物油、使用過的含汞燈具及塗料等。本集團已委聘持有害廢棄物業務牌照的環境服務提供商每年收集處理有害廢棄物,亦將持續加強舉措將有害廢棄物密度維持在0.10噸/按件計的每百萬產量單位以下。

無害廢棄物主要來自於紙張耗用及其他各種類型的一般商業廢棄物,如辦公用品及塑料製品。本集團將無害廢棄物進一步分類為可回收廢棄物及不可回收廢棄物。可回收廢棄物分類存放,並由回收公司在集中存儲區域回收處理。同時,我們要求僱員雙面打印或影印、重用已用過一面的紙張影印或打印文件初稿,且在紙張未包含機密信息的情況下回收利用紙張。本集團將持續加強舉措將紙張耗用密度維持在0.30噸/按件計的每百萬產量單位以下。

#### 資源使用及能源效益

就節約用電而言,本集團已制定用電管理程序,以確保工業安全及鼓勵在工作場所節約能源。具體的節能措施包括:要求僱員在離開工作場所以及不使用設備之時關閉電子設備及電源;禁止僱員在未經行政部事先批准的情況下鋪設電線:每月監察用電情況並追蹤超過用電標準的部門。

For hazardous waste, the generation of hazardous waste results principally from chemical waste, such as waste mineral oil, used mercury containing lamps and paints. The Group has engaged an environmental service provider with Hazardous Waste Business License to collect hazardous waste on an annual basis. The Group will make continuous efforts to keep the intensity of hazardous waste produced below 0.10 tonnes per million units of production by pieces.

For non-hazardous waste, the generation of non-hazardous waste results principally from paper consumption and other various types of general commercial wastes, such as office supplies and plastics. The Group further categories non-hazardous waste into recyclable and non-recyclable waste. The recyclable waste is sorted out and collected by the recycling companies at the centralised location. Meanwhile, we also require our employees to use both sides of paper when printing or photocopying, and reuse single-sided paper for photocopying or printing draft documents, and recycle them as long as there is no confidential information. The Group will make continuous efforts to keep the intensity of paper consumption below 0.30 tonnes per every million units of production by pieces.

#### **Use of Resources and Energy Efficiency**

In terms of electricity saving, the Group has established the Management Procedures for Electricity Usage to ensure industrial safety and encourage energy conservation at workplace. Specific measures have been implemented to conserve energy, such as requiring employees to turn off electrical equipment and power supply before leaving the premises and when not using such equipment; prohibiting employees from laying cables without permission from the Admin Department; monitoring the monthly electricity usage and following up with relevant departments that exceed the electricity usage standards.

本集團致力於推廣低碳文化,並竭力將能源消耗總量密度維持在0.50千瓦時/按件計的總產量單位以下。本年度的能源消耗密度略微高於既定的目標,原因為東莞生產廠房在下半年經歷持續的城市電力短缺,因而需要大幅增加柴油消耗以維持營運。考慮到這一事件的暫時性,本集團認為能源消耗密度將於下一年度恢復至正常水平。

#### Note:

 The significant increase in the total emission of greenhouse gases in 2021 is due to the continuous city power shortage problem during May 2021 to October 2021, resulting in greater reliance on fuel burning to support the operations in our Dongguan production plant.

The Group endeavours to promote a low-carbon culture and strives to maintain the total energy consumption intensity below 0.50 kWh per total production units by pieces. This year, our energy consumption intensity has slightly exceeded our target because our Dongguan production plant encountered continuous city power shortage in the second half of the year, which resulted in a significant increase in the consumption of diesel to support our operation. In view of the temporary nature of this incident, the Group believes the energy consumption intensity will resume to a normal level next year.

#### 用水

The Group strives to conserve water by implementing a series of measures, such as: adopting circulating water system, performing regular checks on faucets to avoid unnecessary leakage and to enable prompt reporting of any damages. In order to raise our employees' awareness on water conservation, water-saving signs were placed inside the toilets and next to every faucet. The Group will make continuous efforts to maintain the intensity of total water consumption at or below 0.03 per total production units by pieces.

在保證合規的同時,本集團致力於構建多元化及包容的工作環境,以保證僱員於招聘及晉升過程中不因其性別、種族、宗教信仰、膚色、性取向、年齡、婚姻狀況或家庭狀況而遭受歧視或被剝奪平等機會。本集團特別制定女性僱員勞動保護規定以及反歧視及反性騷擾程序,以保護所有僱員的權益,從而保證僱員的才能得到公平的反映、評估及獎勵。

本集團對童工及強制勞工持零容忍態度且嚴明 禁止任何形式的童工及強制勞工。為避免強制 勞工及童工,人力資源部對各候選人執行詳細 的面試篩選程序。通過核查申請人的身份證原 件、進行詳盡的查詢,執行徹底的背景調查, 以核實申請表所述個人資料的真實性,進而保 證未僱用任何童工。

#### **SOCIAL**

#### **Employment and Labour Standards**

The Group believes that employees are one of the most valuable assets of an enterprise and we see human resource management as an integral part of our overall business strategy. The Group strictly abides by all applicable laws and regulations related to employment, including but not limited to:

#### In Hong Kong:

- "Employment Ordinance", the "Minimum Wage Ordinance", and
- "Employees' Compensation Ordinance"

#### In PRC:

- "Labour Contract Law",
- "Labour Law",
- "Regulations on Paid Annual Leave of Employees",
- · "Law on the Protection of Women's Rights and Interests", and
- "Law on the Protection of Disabled Persons" and "Social Insurance Law"

Going beyond compliance, the Group is committed to building a diversified and inclusive working environment to ensure that no employees are discriminated against or deprived of opportunities due to their gender, ethnic background, religious belief, colour, sexual orientation, age, marital status or family status in relation to recruitment and promotion. The Group has specially formulated the Rules on the Labour Protection of Female Employees and Anti-discrimination and Harassment Procedures to protect the rights of all employees, so that the employees' talents can be reflected on, assessed and rewarded fairly.

The Group has zero tolerance on child labour and forced labour and strictly prohibits any form of child and forced labour at work. To avoid such practices, the Human Resources Department performs detailed interview screening procedures on each candidate. A thorough background check is carried out to verify the authenticity of personal data stated on application forms by examining the applicants' original identity cards and making detailed inquiries to ensure that no child labour is employed.

#### **Environmental, Social and Governance Report**

倘發現任何童工或強制勞工,本集團即刻終止 僱傭關係並調查該事件的根本原因。對於任何 須對僱用童工及強制勞工承擔責任的僱員,我 們保留採取紀律行動的權利。於報告期間,本 集團並無任何童工或強制勞工的事件。

本集團亦制定人力資源政策,以管理僱員招 聘、離職、晉升及其他程序,從而標準化本集 團工作流程、提高工作效率。根據需求,本集 團通過簡歷篩選、背景調查及工作面試等層層 甄選程序選擇合適的候選人。有意辭職的僱員 須事先向相關部門的主管及負責的經理提交書 面通知。於離職僱員在本集團任職的最後一 天,人力資源部與離職員工進行離職面談,以 了解離職原因、收集進一步的反饋或投訴,以 確定工作環境是否有任何提升空間。僱員試用 期評估及年度考核為獎勵及懲罰、薪資調整及 晉升、年終花紅等事項的重要基礎。現行的薪 酬政策乃根據工作性質、僱員的資質及經驗制 定,且該政策每年進行檢討。除了提供年度花 紅及僱員相關保險福利,亦根據僱員的個人表 現獎勵其酌情花紅。

為了招募高素質人才及激勵現有僱員,本集團為僱員提供具有競爭力的薪酬、附加福利及福利津貼,如醫療及社會保險、差旅及電話津貼。本集團僱員每天標準工作時數為8小時,每週平均工作時數為40小時,每週休息至少1天。為了增強團隊凝聚力及營造和諧的工作氛圍,本集團定期組織各類團體活動。

Should any child labour or forced labour be discovered, the Group would immediately terminate his or her employment and investigate the root cause of such incident. We will reserve our rights to take disciplinary actions against any employees who are accountable for the employment of child labour or forced labour. During the Reporting Period, the Group was not aware of any cases regarding the practice of child labour or forced labour.

The Group has also established a Human Resources Policy to manage our employee recruitment, resignation, promotion and other processes, so as to standardize the workflow and improve the working efficiency of the Group. In accordance with our needs, the Group hires suitable candidates through a series of selection processes, including resumescreening, background check and job interview. Employees who intend to resign shall inform his or her Department Head or Manager-in-Charge in advance notice in writing. On the last day of employment of the staff who is leaving the Group, the Human Resources Department performs an exit interview with the leaving staff to understand the reason of their resignations, and collect further feedback or complaints to ascertain if there is any rooms for improvement in the workplace environment. Employee probation assessments and annual appraisals, serve as an important basis for rewards and punishments, salary adjustment and promotion, year-end bonus, etc. Our remuneration policy is commensurate with the job nature, qualifications and experience of our employees, and such policy is subjected to annual review. In addition to the provision of annual bonuses and employee related insurance benefits, discretionary bonuses are also rewarded to employees based on their individual performance.

To attract high-calibre talents and motivate existing employees, the Group offers competitive remuneration packages, fringe benefits, and welfare allowances for our employees, such as the medical and social insurances, travel and phone call allowances. The standard working hours of the Group's employees are 8 hours per day and 40 hours per week on average with at least 1 rest day per week. In order to strengthen team cohesion and create a harmonious working atmosphere, the Group organizes various group activities on a regular basis.

#### 健康與安全

僱員的健康與安全對於本集團而言尤為重要。 本集團遵守所有相關的安全法規,如香港的 《職業安全及健康條例》以及中國的《安全生產 法》及《消防法》。本集團已制定僱員安全政 策:該政策識別各類潛在危害,並就本集團生 產活動的各個方面訂明安全程序。本集團亦在 員工手冊中制定應急措施,訂明颱風、暴雨及 重大傳染病等危難時期的工作安排。

在本集團的東莞生產廠房,環境健康與安全 (「EHS」)僱員負責處理所有健康與安全的相關 事務。所有僱員於檢查工作環境後須簽署相關 的確認書。本集團亦要求所有新僱員在開始工 作之前完成「三級安全培訓」。培訓包括操作及 防範指南,提升僱員的安全生產意識,指導僱 員以準確及安全的方式操作設備,增強僱員面 對緊急事件迅速反應的能力。

此外,本集團制定一系列一般安全措施,其中包括禁止在無煙區(如倉庫、易燃易爆區及其他生產區域)吸煙;根據適用法律法規制定消防安全管理計劃及預警程序,並定期開展消防演練,以增強所有僱員的安全意識、幫助僱員應對火災事故。

#### **Health and Safety**

Employee's health and safety is of utmost importance to the Group. The Group complies with all relevant safety regulations such as the "Occupational Safety and Health Ordinance" in Hong Kong and the "Production Safety law" and "Fire Protection Law" in the PRC. An Employee Safety Policy has been formulated to identify different potential hazards and outline the safety procedures for different aspects of our production activities. The Group also established contingency measures in the Employee Handbook, which outlines the special work arrangements in times of typhoons, rainstorms, serious communicable diseases, etc.

As for our Dongguan production plant, the Environmental Health and Safety ("EHS") employee is responsible for handling all health and safety related issues. All employees have to sign a confirmation notice after inspecting their working environment. The Group also requires all new employees to complete a "3-Level Safety Training" before commencing work. This training provides both operational and preventative guidelines to raise the employees' awareness on work safety and guide employees to operate equipment in an accurate and safe manner, and encourage employees to respond swiftly in case of emergencies.

In addition, the Group has formulated a series of general safety measures, which includes prohibit smoking in non-smoking zones (e.g. warehouse, flammable and explosive areas, and other production areas); formulate fire safety management plan and precaution procedures in accordance with applicable laws and regulations, and carry out regular fire drills to strengthen the safety awareness of all employees and help them to get prepare when fire accidents occur.

在新冠疫情期間,本集團成立新冠疫情應急小 組,制定應急方案確保所有切實有效的防疫及 保護措施貫徹實施,以最大程度地降低新冠病 毒在工作環境中蔓延的風險。具體的措施包 括:要求僱員及來訪者申報健康信息、每日社 測體溫、在任何時候都須佩戴口罩及保持社 距離。我們亦為僱員提供口罩及消毒液,允管理 在家辦公。本集團亦制定特別方案指導及 進入東莞生產廠房的跨境司機。本集團密切關 注新冠疫情的最新發展,並定期檢討及優化應 急方案確保其充足性及適用性。

In the midst of COVID-19 pandemic, the Group established a COVID-19 emergency recovery team and developed contingency plans to ensure that all practicable preventive and protective measures are in place to minimise the risk of spreading COVID-19 at workplace. For instance, we require employees and visitors to fill in health declaration forms, perform daily temperature checks, wear masks at all time and keep social distancing. We also provide employees with masks and sanitizers, and allow work from home arrangements. The Group also formulated a special plan to guide and manage cross-border drivers entering our Dongguan production plant. The Group pays close attention to latest developments regarding the COVID-19 pandemic and regularly reviews and enhances our contingency plans to ensure its adequacy and suitability.

僱員的技能與經驗對於本集團的長期發展至關重要。因此,我們為僱員的成長投資,以提升僱員的知識及技能。我們的培訓涵蓋廣泛的領域,從電子元件及焊接等技術知識到溝通技能及關係建立,促進僱員更高效地履行職責,同時亦幫助僱員實現其個人目標。本集團一直為所有級別的僱員提供內部及外部培訓,以支持僱員的職業發展及個人成長。

#### **Development and Training**

The skills and experience of our employees are critical to the long-term development of the Group. Therefore, we invest in the growth of our employees to enhance their knowledge and skills. Our training covers a myriad of topics, ranging from technical knowledge, such as electronic components and welding, to communication skills and relationship building, which would in turn allow them to discharge their duties more effectively while helping them to achieve their personal goals. The Group is committed to providing our employees across all levels with both in-house and external trainings to support their career development and personal growth.

#### 供應鏈管理

本集團深刻認識到審慎供應鏈管理為可持續發展不可或缺的一部分;鑒於此,本集團致力於與供應商建立長期及和諧的合作關係。本集團希望供應商遵循誠信與務實的原則,嚴格按照適用法律法規的規定提供產品及服務。本集團要求供應商遵守包括歐洲聯盟(歐盟)的相關指令及法規在內的適用法律法規,例如《有害物質限用指令2002/95/EC》(「RoHS」)及《化學品註冊、評估、授權及限制法規(EC) No 1907/2009》(「REACH」)。

為標準化採購程序及強化供應商的監督與管理,本集團制定供應管理(「**SBM**」)標準操作程序,當中載明一系列關鍵措施,如在接納供應商為認可供應商之前進行評估,持續評估及定期審查認可供應商。

於選擇新供應商的過程中,SBM團隊及供應質量保證團隊評估潛在供應商的能力,且工程師可要求供應商提供樣品進行檢測。SBM團隊將獲得新供應商提供的已簽署並加蓋公司印單時機應商信息表以及RoHS及REACH合規聲明章的機應商信息表以及RoHS及REACH合規聲明章的表框。經評估及SBM經理及副總裁評估後,新供應商方可加入認可供應商名單。超過一個大大學學、人權管理等方面。若潛在供應商涉及各種管理等方面。若潛在供應商涉及任何重大環境不合規事件,我們亦會開展調查每年對供應商進行績效考核,未達到本集團標準的供應商可能會終止合作。

#### **Supply Chain Management**

The Group understands that prudent supply chain management is integral to sustainable development and therefore, we are committed to establishing long-term and harmonious cooperation relationships with our suppliers. The Group expects our suppliers to uphold the principles of integrity and pragmatism, and provide products and services in strict compliance with the requirements of applicable laws and regulations. The Group requires suppliers to comply with applicable laws and regulations in relation to relevant European Union (EU) directives and regulation, such as the Restriction of Hazardous Substances Directive 2002/95/EC ("RoHS") and the Registration, Evaluation, Authorisation and Restriction of Chemicals Regulation (EC) No 1907/2009 ("REACH").

In order to standardise the procurement procedures and strengthen the monitoring and management of suppliers, the Group has established the Supply Base Management ("SBM") Standard Operating Procedure, which includes key measures such as assessments prior to accepting a supplier as an approved supplier, and on-going assessments and regular inspections of approved suppliers.

When sourcing new suppliers, the SBM team and the supply quality assurance team would evaluate the capability of the potential supplier, while our engineers may request the supplier to submit samples for testing. The SBM team would obtain relevant documents such as signed supplier information forms with company chops and compliance declaration forms in relation to RoHS and REACH from a new supplier. New suppliers can only be added to the approved vendor list upon passing the assessment and getting approval of the manager and vice president of SBM. Our assessments include the new supplier's background information, product and service quality, reputation, human rights management, etc. We would also investigate if the potential suppliers were involved in any significant environmental non-compliance incidents. Supplier performance appraisal is conducted on an annual basis and those suppliers that fail to meet the Group's standards may result in termination of the cooperation.

#### 產品及服務責任

為客戶提供安全、優質及可靠的產品及服務是本集團的核心價值觀之一,本集團始終堅持於製造過程中保持卓越的品質。本集團採納全面品質管理(TQM)原則,為僱員提供有關質量保證方面的持續培訓,並遵守所有相關法規,如中國的《產品質量法》,歐盟指令2006/122/EC、2005/69/EC及2011/65/EU,以及歐盟理事會第1907/2006號法規。

本集團實行嚴格的質量保證及檢驗,範圍覆蓋 從材料採購到開展材料來料質量保證,再到生 產過程中的工序間檢驗及電子製成品的出廠質 量保證的整個製造流程。質量保證人員執行定 期抽查,包括目視檢查、功能測試、自動化光 學檢查(AOI)及/或X光檢查,以保證所有產品 在交付予客戶之前符合規範及標準。

為方便檢索生產數據,本集團在生產線中建立 追蹤系統,據此所有產品在生產過程中均貼上 編碼。倘本集團產品出現質量問題,本集團通 過該系統能夠立刻查明生產流程中的缺陷源 頭,確定不良產品批次及採取適當的補救措 施,以糾正有關問題及防止未來再次發生。

此外,本集團的生產廠房設有100K級潔淨生產樓層,建築面積約為2,700平方米,其中包括一個10K級的潔淨實驗室,用於生產醫療及保健產品等衛生要求較高的產品。

憑藉嚴格的質量保證,本集團已取得(其中包括)有關製造印刷電路板組件(PCBA)及設計家用控件模組的質量管理體系ISO 9001:2015認證、有關製造心電圖監測貼片(PCBA)的質量管理體系ISO 13485:2016認證、有關美國食品藥品監督管理局醫療器械質量體系規定的脈搏血氧計QSR 820認證、國際電工委員會(IEC)及美國安全檢測實驗室公司(UL)有關食品的良好生產規範(GMP)認證。為獲得上述認證,本集團的生產及質量管理系統須通過年度審查。

#### **Product and Service Responsibility**

Providing a safe, quality and reliable product and service to customers is one of the core values of the Group, and we are committed to maintaining high quality in our manufacturing process. The Group adopted the principles of total quality management (TQM) and provides our employees with ongoing trainings on quality assurance. We also comply with all relevant regulations such as the "Product Quality Law" in the PRC, the EU Directive 2006/122/EC, 2005/69/EC and 2011/65/EU, and the Regulation (EC) No. 1907/2006.

The Group maintains stringent quality assurance and carries out indepth inspections throughout the manufacturing process, from the incoming quality assurance of materials procured to performing inprocess inspections during production and outgoing quality assurance of finished electronic products. The quality assurance officers will perform periodic sample checks, including visual checks, functionality tests, automated optical inspection (AOI) and/or x-ray inspections to ensure that all products meet the specifications and standards before delivering to customers.

To allow easy retrieval of production data, the Group has implemented a traceability record system in the production line. All our products are labelled with barcodes during the production process. Should there be any quality issues with the Group's products, the system enables the Group to promptly ascertain the source of the defect throughout the production process, identify the defective lot of products and take appropriate remedial measures to rectify the issues and to prevent future reoccurrence.

In addition, the Group has a Class 100K cleanroom production floor with a gross floor area of approximately 2,700 square meters in our production facility, which includes a Class 10K cleanroom laboratory facility for the production of products with higher sanitary requirements, such as medical and healthcare products.

With the stringent quality assurance in place, the Group has obtained, among others, ISO 9001:2015 for quality management system in respect of manufacture of printed circuit board assembly (PCBA) and design of household control modules; ISO 13485:2016 for quality management system for manufacture of electrocardiogram monitor patch; and pulse oximeter QSR 820 for the United States Food and Drug Administration Medical Device Quality System Regulation; and Good Manufacturing Practice (GMP) certifications for food from both International Electrotechnical Commission (IEC) and Underwriters Laboratories Inc. (UL). In order to achieve the above certifications, the Group's production and quality management systems are subject to annual review and inspection.

#### 知識產權

本集團深刻認識到保護及行使知識產權(「知識產權(「知識產權」)的重要性,並嚴格遵守對自身有重大影響的所有相關法律法規,包括但不限於香港的《商標條例》及《版權條例》以及中國的《商標法》及《專利法》。本集團已採納慣例避免知識產權被侵犯,如與分包製造商及僱員訂立保密協議(保密協議)或不披露協議(不披露協議);並註冊對業務營運至關重要的知識產權。

截至2021年12月31日,本集團已註冊9個商標、1項專利及2個域名,此等項目對本集團的業務至關重要。

#### 私隱保護

在業務營運過程中,本集團收集及保存客戶、 供應商及僱員的基本資料;為保障相關持份者 的權益,嚴明禁止以正常業務用途以外的其他 目的發出或使用該等數據。經參考香港的《個 人資料(私隱)條例》及中國的《網絡安全法》的 規定,本集團建立規章制度並制定個人信息政 策,以處理機密信息及禁止任何向任何外部人 士洩露與本集團、供應商及客戶有關的資料的 行為。

於報告期間,東莞生產廠房定期組織信息系統安全培訓,提升僱員的信息及私隱保護意識。

#### 投訴與回應

客戶的反饋對於本集團的成功具有重要意義。本集團嚴肅對待客戶的所有反饋與投訴,確保在收到投訴後立即採取跟進措施。本集團已建立客戶投訴處理程序,倘收到投訴,質量保證部的質量工程師將調查該事件並出具報告,當中載明須承擔責任的部門、問題的根源以及應採取的整改行動。

於報告期間,本集團收到33項投訴,經本集團 採取跟進行動後,所有投訴均已妥善解決。概 無產品因安全及健康原因被召回。

#### **Intellectual Property**

The Group recognises the importance of protecting and enforcing our intellectual property ("IP") rights, and strictly complies with all relevant laws and regulations that have a significant impact on us. These regulations include but not limited to the "Trade Marks Ordinance" and "Copyright Ordinance" in Hong Kong, and "Trademark Law" and "Patent Law" in the PRC. The Group has adopted practices to avoid infringements of intellectual property rights, such as entering into Confidentiality Agreement (CA) or Non-Disclosure Agreement (NDA) with our subcontracted manufacturer and employees; and registering IP rights that are material to our business operations.

As of 31 December 2021, the Group has registered a total of 9 trademarks, 1 patent and 2 domain names that are material to our business.

#### **Privacy Protection**

In the course of the Group's business operations, we collect and maintain basic information of our customers, suppliers and employees. To protect the interest of respective stakeholders, any dispatch or use of such data for purposes other than conducting normal business is strictly prohibited. With reference to the requirements set out in the Personal Data (Privacy) Ordinance in Hong Kong and the Cybersecurity Law in PRC, the Group has established rules and formulated Personal Data Policy to handle confidential information and prohibit any leakage of information relating to the Group, our suppliers, customers, as well as any other external parties.

During the Reporting Period, our Dongguan production plant has organised regular Information System Safety trainings to employees to raise their awareness on data protection and privacy matters.

#### **Complaints and Responses**

Customers feedbacks are important to the Group's success, we take all feedback and complaints from customers seriously and ensure that immediate follow-up actions are taken upon receipt of complaints. The Group has established a customer complaint handling procedure. In cases where complaints are received, the quality engineers from the Quality Assurance Department will investigate the incidents and issue a report outlining the responsible department, the root cause of the problem, and the corrective actions implemented.

During the Reporting Period, the Group received 33 complaints and all have been resolved after proper follow-up actions were taken by the Group. No products were subject to recalls due to safety and health reasons.

#### 反貪污

本集團嚴格遵守所有與反貪污相關的法律法規,包括香港的《防止賄賂條例》及中國的《刑法》。

員工手冊明確列出本集團僱員須遵守的商業行為準則及職業道德。結合企業管治政策與程序以及內幕消息政策,本集團以堅定的立場向所有僱員傳遞明確的信息,即嚴明禁止任何形式的賄賂、貪污、勒索及欺詐。於報告期間,我們向東莞生產廠房的僱員提供超過240期的反貪污培訓,向本集團香港辦事處的所有僱員及董事提供超過30期的線上反貪污培訓。

本集團亦建立舉報政策,僱員可根據此政策舉報任何可疑的不法行為或不當行為。倘發現任何可疑的不法行為或不當行為,僱員可通過電郵向其直屬上司或舉報委員會舉報。隨後將展開全面的調查,如確認存在不法行為,將對涉事僱員施予紀律行動,亦可根據各個案件的性質及具體情況進一步採取法律措施。

於報告期間,並無針對本集團或其僱員的貪污 法律案件,本集團亦不知悉任何賄賂、勒索、 欺詐或其他違法事件。

#### 社區投資

本集團切實履行社會責任,積極開展社會公益 活動,並將社會公益視為企業文化的重要方 面。

於2021年,本集團參與救世軍主辦的企業義工計劃,分享我們利用創新思維開發新產品幫助長者克服日常生活中的主要困難的經驗。此外,我們亦參與救世軍主辦的耆才創科導航計劃,提升3D打印在多功能坐立支持工具、飲食輔助工具等面向長者的產品的技術及應用。藉助社區活動與分享,我們呼籲大眾更重視長者照護、希望激發長者的創意思維及想法。

未來,待新冠疫情形勢緩和及社交距離限制取 消後,本集團將繼續發展及主辦更多公益與社 區活動。

#### **Anti-corruption**

The Group strictly complies with all relevant laws and regulations over anti-corruption, including the "Prevention of Bribery Ordinance" in Hong Kong and the "Criminal Law" in the PRC.

The Employee Handbook clearly outlines the expected business conduct and professional ethics of our employees. Coupled with the Corporate Governance Policies and Procedures and the Policy on Inside Information, the Group is determined to convey a clear message to all employees that any forms of bribery, corruption, extortion and fraud are strictly prohibited. During the Report Period, more than 240 anti-corruption training sessions were provided to our employees in the Dongguan production plant, while more than 30 online anti-corruption training sessions were provided to all employees and directors of the Group's Hong Kong office.

The Group has also established the Whistleblowing Policy for employees to report any concerns about malpractices or improprieties. Should employees have any concerns about malpractices or improprieties, they can report to their supervisors or to the Whistleblowing Committee via email. A full investigation will then be conducted, and disciplinary action will be applied to the employees involved upon confirmation of the allegation, and further legal action may be taken depending on the nature and circumstances of each case.

During the Reporting Period, no legal cases regarding corruption were brought against the Group or our employees, and the Group is not aware of any incidents of bribery, extortion, fraud or other violations.

#### **Community Investment**

The Group earnestly fulfills our social responsibilities, actively carries out public welfare activities, and regards public welfare as an important aspect of our corporate culture.

In 2021, the Group participated in a Corporate Volunteer Program and organised by the Salvation Army share our experience on how innovative mindsets enable us to develop new products that can help the elderly people surmount their major obstacles in their daily lives. Moreover, we also participated in Smart Age Innovation Adventure Project organised by the Salvation Army to improve the technology and application of 3D printing on elderly products, ranging from multi-function sit-up stand to eating aids. Through these community events and sharing, we hope to emphasize the importance of elderly care and provoke their innovative thinking and ideas.

The Group will continue to explore and host more public welfare and community activities in the future when the COVID-19 situation improves and the social distancing restrictions are lifted.

All statutory reserves are created for specific purposes. A PRC company is required to appropriate an amount of not less than 10% of statutory profits after income tax to statutory surplus reserves, prior to distribution of its post-tax profits of the current year. A company may discontinue the contribution when the aggregate sum of the statutory surplus reserve is more than 50% of its registered capital. The statutory surplus reserves shall only be used to make up losses of the company, to expand the company's operations, or to increase the capital of the company. In addition, a company may make further contribution to the discretional surplus reserve using its post-tax profits in accordance with resolutions of the board of directors.
- (b) Other reserve represents the accumulated actuarial gains on the Group's long service payment scheme for its Hong Kong employees and the excess of the combined share capital of the companies comprising the Group, after considering the intra-group elimination, over the consideration given in relation to the reorganisation.

#### 1 一般資料及重組

#### 1.1 一般資料

本公司為一家根據開曼群島法例第22章公司法(1961年法例三)(經綜合及修訂)於2019年1月15日在開曼群島註冊成立的獲豁免有限公司。其註冊辦事處地址為4th Floor, Harbour Place, 103 South Church Street, P.O. Box 10240, Grand Cayman KY1-1002, Cayman Islands。

本公司為一家投資控股公司及其附屬公司(「本集團」)主要從事電子產品的製造及銷售。最終控股股東為朱慧恒先生(「朱慧恒先生」)及朱惠璋先生(「朱惠璋先生」)(統稱「控股股東」),彼等自集團公司註冊成立以來一直控制有關公司。

本公司股份自2020年1月10日起在香港聯合交易所有限公司主板上市。

除另有説明外,綜合財務報表以千港 元(「**千港元**」)為單位呈列。

#### 1 GENERAL INFORMATION AND REORGANISATION

#### 1.1 General information

The Company was incorporated in the Cayman Islands on 15 January 2019 as an exempted company with limited liability under the Companies Law (Cap. 22, Law 3 of 1961 as consolidated and revised) of the Cayman Islands. The address of its registered office is 4th Floor, Harbour Place, 103 South Church Street, P.O. Box 10240, Grand Cayman KY1-1002, Cayman Islands.

The Company is an investment holding company and its subsidiaries (the "Group") are principally engaged in the manufacturing and sales of electronic products. The ultimate controlling shareholders are Mr. Raymond Chu ("Mr. Raymond Chu") and Mr. Chu Wai Cheong Wilson ("Mr. Wilson Chu") (collectively, the "Controlling Shareholders") who have been controlling the group companies since their incorporation.

The shares of the Company have been listed on the Main Board of The Stock Exchange of Hong Kong Limited since 10 January 2020.

The consolidated financial statements are presented in thousands of Hong Kong Dollar ("HK\$'000"), unless otherwise stated.

The consolidated financial statements of the Group have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and the disclosure requirements of the Hong Kong Companies Ordinance Cap. 622. The consolidated financial statements have been prepared under the historical cost convention.

The preparation of consolidated financial statements in conformity with HKFRSs requires the use of certain critical accounting estimates. It also requires the directors of the Company to exercise their judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements, are disclosed in Note 4.

#### 2.2.1 綜合賬目

#### 2.2 Subsidiaries

#### 2.2.1 Consolidation

Subsidiaries are all entities over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. Subsidiaries are consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

#### (a) Business combination

Except for the reorganisation upon listing, the Group applies the acquisition method to account for business combinations. The consideration transferred for the acquisition of a subsidiary is the fair values of the assets transferred, the liabilities incurred and the equity interests issued by the Group. The consideration transferred includes the fair value of any asset or liability resulting from a contingent consideration arrangement. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are measured initially at their fair values at the acquisition date. The Group recognises any noncontrolling interest in the acquiree on an acquisitionby-acquisition basis, either at fair value or at the non-controlling interest's proportionate share of the recognised amounts of acquiree's identifiable net assets.

Acquisition-related costs are expensed as incurred.

If the business combination is achieved in stages, the acquisition date carrying value of the acquirer's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date; any gains or losses arising from such re-measurement are recognised in profit or loss.

Any contingent consideration to be transferred by the Group is recognised at fair value at the acquisition date. Subsequent changes to the fair value of the contingent consideration that is deemed to be an asset or liability are recognised in accordance with HKFRS 9 in profit or loss. Contingent consideration that is classified as equity is not remeasured, and its subsequent settlement is accounted for within equity.

The excess of the consideration transferred, the amounts of any non-controlling interest in the acquiree and the acquisition-date fair value of any previous equity interest in the acquiree over the fair value of the identifiable net assets acquired is recorded as goodwill. If the total of consideration transferred, non-controlling interest recognised and previously held interest measured is less than the fair value of the net assets of the subsidiary acquired in the case of a bargain purchase, the difference is recognised directly in the profit or loss.

Inter-company transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

## (b) Changes in ownership interests in subsidiaries without change of control

Transactions with non-controlling interests that do not result in a loss of control are accounted for as equity transactions – that is, as transactions with the owners of the subsidiary in their capacity as owners. The difference between fair value of any consideration paid and the relevant share acquired of the carrying amounts of net assets of the subsidiary is recorded in equity. Gains or losses on disposal to non-controlling interests are also recorded in equity.

#### (c) Disposal of subsidiaries

When the Group ceases to have control, any retained interest in the entity is re-measured to its fair value at the date when control is lost, with the change in carrying amounts recognised in profit or loss. The fair value is the initial carrying amounts for the purposes of subsequently accounting for the retained interest as an associate, or financial asset. In addition, any amounts previously recognised in other comprehensive income in respect of that entity are accounted for as if the Group had directly disposed of the related assets or liabilities. This may mean that amounts previously recognised in other comprehensive income are reclassified to profit or loss.

#### 2.2.2 Separate financial statements

Investments in subsidiaries are accounted for by the Company at cost less impairment. Cost includes direct attributable costs of investment. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

Impairment testing of the investments in subsidiaries is required upon receiving dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

#### 2.3 Segment reporting

Operating segment is reported in a manner consistent with the internal reporting provided to the chief operating decision-maker ("CODM"). The CODM, who is responsible for allocating resources and assessing performance of the operating segment, has been identified as the Chief Executive Officer (the "CEO") who makes strategic decisions.

#### 2.4 Foreign currency translation

#### 2.4.1 Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in HK\$, which is the Company's functional and the Group's presentation currency.

#### 2.4.2 Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transaction. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are generally recognised in profit or loss.

Foreign exchange gains and losses that relate to borrowings are presented in the consolidated statement of comprehensive income, within finance costs. All other foreign exchange gains and losses are presented in the consolidated statement of comprehensive income on a net basis within "other losses, net".

Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. Translation differences on assets and liabilities carried at fair value are reported as part of the fair value gain or loss. For example, translation differences on non-monetary assets and liabilities such as equities held at fair value through profit or loss are recognised in profit or loss as part of the fair value gain or loss and translation differences on non-monetary assets such as equities held at fair value through other comprehensive income are recognised in other comprehensive income.

#### 2.4.3 集團公司

功能貨幣有別於呈列貨幣的所有 集團實體(該等集團實體概無擁有 嚴重通貨膨脹經濟體的貨幣)的業 績及財務狀況,均按以下方式換 算為呈列貨幣:

#### 2.4.3 Group companies

The results and financial positions of all the group entities (none of which has the currency of a hyperinflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that consolidated statement of financial positions;
- income and expenses for each income statement and statement of comprehensive income are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the rate on the dates of the transactions); and
- all resulting exchange differences are recognised in other comprehensive income.

On consolidation, exchange differences arising from the translation of any net investment in foreign operations are taken to other comprehensive income. When a foreign operation is sold or any borrowings forming part of the net investment are repaid, the associated exchange differences are reclassified to profit or loss, as part of the gain or loss on sale.

Goodwill and fair value adjustments arising on the acquisition of a foreign operation are treated as assets and liabilities of the foreign entity and translated at the closing rate.

#### 2.5 Properties, plant and equipment

Properties, plant and equipment are stated at historical cost less accumulated depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the assets' carrying amounts or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the asset will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged to profit or loss during the reporting period in which they are incurred.

Depreciation of properties, plant and equipment is calculated using the straight-line method to allocate their costs, net of their residual value, over their estimated useful lives, as follows:

Furniture and fixtures 5 years

Office equipment 3 to 5 years

Plant and machineries 3 to 10 years

Motor vehicles 3 to 5 years

Leasehold improvements Over the shorter of lease term and useful life of 5 years

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gain or loss on disposals are determined by comparing proceeds with carrying amount and are recognised in profit or loss.

#### 2.6 Intangible assets

#### **System software**

Acquired system software licences are capitalised on the basis of the costs incurred to acquire and bring to use the specific software. These costs are amortised using straight-line method over the shorter of licence period and their estimated useful lives of three years.

#### 2.7 Impairment of non-financial assets

Assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows (cash generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

#### 2.8 Financial assets

#### 2.8.1 Classification

The Group classifies its financial assets as assets to be measured at amortised cost.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

#### 2.8.2 Recognition and measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at fair value through profit or loss are expensed in profit or loss.

Financial assets with embedded derivatives are considered in their entirety when determining whether their cash flows are solely payment of principal and interest.

#### 債務工具

#### 2.8.3 終止確認

#### Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. The Group classifies its debt instruments to be measured at amortised costs.

Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. A gain or loss on a debt investment that is subsequently measured at amortised cost and is not part of a hedging relationship is recognised in profit or loss when the asset is derecognised or impaired. Interest income from these financial assets is included in finance income using the effective interest rate method.

#### 2.8.3 Derecognition

Financial assets are derecognised when the rights to receive cash flows from the investments have expired or have been transferred and the Group has transferred substantially all risks and reward of ownership.

#### 2.9 Offsetting financial instruments

Financial assets and liabilities are offset and the net amounts reported in the consolidated statement of financial position when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously.

#### 2.10 金融資產減值

本集團按攤銷成本計量的金融資產須依據香港財務報告準則第9號的預期信貸虧損模式。本集團按前瞻基準評估與按攤銷成本入賬的資產有關之預期信貸虧損。所用的減值方法取決於信貸風險有否大幅增加。

就來自第三方及關聯方的貿易應收款項而言,本集團採用香港財務報告準則第9號允許的簡化方法,該方法規定預期存續期虧損須於初始確認來自第三方及關聯方的貿易應收款項時確認。本集團已透過考慮過往違約機率、現行市場狀況及前瞻性資料,評估預期信貸虧損。

就其他應收款項而言,視乎信貸風險 自初步確認後有否大幅上升,本集團 計量減值為12個月預期信貸虧損或 使用年期預期信貸虧損。倘其他應收 款項的信貸風險自初步確認後大幅上 升,減值計量為年期預期信貸虧損。

#### 2.11 貿易應收款項及其他應收款項

貿易應收款項乃於日常業務過程中向客戶銷售貨品或提供服務而應收的款項。倘貿易應收款項預期將在一年或以內收回(若更長則在業務正常經營週期內),則歸類為流動資產,否則呈列為非流動資產。

貿易應收款項及其他應收款項初步按 公平值確認,其後以實際利率法按攤 銷成本計量,並扣減減值撥備。

#### 2.10 Impairment of financial assets

The Group's financial assets measured at amortised cost are subject to HKFRS 9's expected credit loss model. The Group assesses on a forward-looking basis the expected credit losses associated with its assets carried at amortised cost. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables from third parties and related parties, the Group applies the simplified approach permitted by HKFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the trade receivables from third parties and related parties. The Group has assessed the expected credit loss by considering historical default rates, existing market conditions and forward-looking information.

For other receivables, the Group measures the impairment as either twelve months expected credit losses or life-time expected credit losses, depending on whether there has been a significant increase in credit risk since initial recognition. If a significant increase in credit risk of the other receivables has occurred since initial recognition, then impairment is measured as lifetime expected credit losses.

#### 2.11 Trade and other receivables

Trade receivables are amounts due from customers for goods sold or services performed in the ordinary course of business. If collection of trade receivables is expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. If not, they are presented as non-current assets.

Trade and other receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less allowance for impairment.

存貨按成本與淨可變現值較低者列 賬。成本乃採用加權平均法釐定。製 成品及在製品成本包括原材料、直接 人工、其他直接成本及相關生產間接 成本(根據一般經營能力計算),其不 包括借款成本。淨可變現值按日常業 務過程中的估計售價減完成產品估計 成本及進行銷售所需的估計成本計算。

#### 2.13 現金及現金等價物

#### 2.14 股本

普通股分類為權益。

發行新股份或購股權直接應佔的新增成本於權益中列作所得款項的減項(扣除稅項)。

#### 2.15 貿易應付款項、應付票據及其 他應付款項

貿易應付款項及應付票據指就於日常 業務過程中自供應商購得貨品或服務 付款的責任。倘款項於一年或以內(若 更長則在業務正常經營週期內)到期, 則貿易應付款項及應付票據分類為流 動負債。否則,貿易應付款項及應付 票據呈列為非流動負債。

貿易應付款項、應付票據及其他應付 款項初步按公平值確認,其後以實際 利率法按攤銷成本計量。

#### 2.12 Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the weighted-average method. The cost of finished goods and work in progress comprises raw material, direct labour, other direct costs and related production overheads (based on normal operating capacity). It excludes borrowing costs. Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

#### 2.13 Cash and cash equivalents

For the purpose of presentation in the consolidated statement of cash flows, cash and cash equivalents include cash at banks and cash on hand.

#### 2.14 Share capital

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

#### 2.15 Trade, bills and other payables

Trade and bills payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Trade and bills payables are classified as current liabilities if payment is due within one year or less (or in the normal operating cycle of the business if longer). If not, they are presented as non-current liabilities.

Trade, bills and other payables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

#### 2.16 借款

借款最初按公平值(扣除已產生交易成本)確認。借款其後按攤銷成本列賬: 所得款項(扣除交易成本)與贖回價值 的任何差額,於借款期採用實際利率 法於利息開支確認。

除非本集團有權無條件延遲償還負債 至報告期末後至少12個月,否則借款 分類為流動負債。

#### 2.17 借款成本

收購、建造或生產合資格資產(即需相當時間方可作擬定用途或出售的資產) 直接應佔的一般及特定借款成本會計入該等資產的成本,直至該等資產大致可作擬定用途或出售為止。

特定借款用於合資格資產之前作為臨 時投資所賺取的投資收入,於合資格 資本化的借款成本中扣除。

所有其他借款成本在產生期間於損益 確認。

#### 2.18 撥備

當本集團因過往事件須承擔現行法律 或推定責任,而履行責任可能需要有 資源流出,且能夠可靠地估計有關金額,則會確認撥備。日後經營虧損不 會確認撥備。

倘出現多項類似責任,履行責任需要 資源流出的可能性乃經整體考慮責任 類別後釐定。即使同類責任中就任何 一項流出資源的可能性可能偏低,仍 會確認撥備。

#### 2.16 Borrowings

Borrowings are recognised initially at fair value, net of transaction costs incurred. Borrowings are subsequently carried at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in interest expense over the period of the borrowings using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least twelve months after the end of the reporting period.

#### 2.17 Borrowing costs

General and specific borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

#### 2.18 Provisions

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation; and the amounts can be reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

#### 2.18 撥備(續)

撥備採用税前利率按照履行有關責任 預期所需支出的現值計量,有關利率 反映當時市場對貨幣的時間價值及該 責任特有風險的評估。因時間推移而 增加的撥備確認為利息開支。

#### 2.19 即期及遞延所得税

期內所得税開支或抵免按當期應課税 收入與按各司法權區的適用所得税税 率計算,並就由於暫時性差額及未抵 扣税務虧損而導致的遞延税項資產及 負債作出調整。

#### (a) 即期所得税

即期所得税支出乃根據本公司的附屬公司營運及產生應課税收入的國家於報告期末已頒佈或實頒佈的稅務法例計算。管理層就適用稅務規例受詮釋所規限的情況定期評估報稅表的狀況,並在適當情況下根據預期須向稅務機關支付的金額設定撥備。

#### (b) 遞延所得税

遞延所得税利用負債法按資產及 負債的税基與資產及負債在綜合 財務報表的賬面值之間產生的暫 時性差額悉數撥備。然而,倘遞 延税項負債來自對商譽的初步確 認,則不會確認遞延税項負債。 倘遞延所得税來自在交易(不包 括業務合併)中對資產或負債的初 步確認,而在交易時不影響會計 或應課稅溢利或虧損,則亦不會 將遞延所得税列賬。遞延所得税 採用於報告期末或之前已頒佈或 實質上已頒佈,並在有關遞延所 得税資產變現或遞延所得税負債 結算時預期將會適用的税率(及法 例)而釐定。

#### 2.18 Provisions (continued)

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

#### 2.19 Current and deferred income tax

The income tax expense or credit for the period is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

#### (a) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of the reporting period in the countries where the Company's subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

#### (b) Deferred income tax

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill. Deferred income tax is also not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

#### (b) 遞延所得税(續)

遞延税項資產僅於可能有未來應 課税款項用作抵銷暫時性差額及 虧損時確認。

倘本公司有能力控制撥回暫時性 差額的時間及該等差額很可能不 會於可見將來撥回,則不會就海 外業務投資的賬面值及税基之間 的暫時性差額確認遞延税項負債 及資產。

#### (c) 抵銷

倘有法定可執行權力將即期稅項 資產與負債相互抵銷而遞延稅頭項 結餘涉及同一稅務機關,則遞延 稅項資產及負債可予相互抵銷。 倘有關實體有法定可執行權力 抵銷及有意按淨值基準結算,可 有意同時變現資產及稅項負債可相 互抵銷。

即期及遞延所得税於損益確認,惟有關於其他全面收益或直接於權益確認的項目除外。在此情況下,税項亦分別於其他全面收益或直接於權益確認。

#### (b) Deferred income tax (Continued)

Deferred tax assets are recognised only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Deferred tax liabilities and assets are not recognised for temporary differences between the carrying amounts and tax bases of investments in foreign operations where the Company is able to control the timing of the reversal of the temporary differences and it is probable that the differences will not reverse in the foreseeable future.

#### (c) Offsetting

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Current and deferred income tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

#### 2.20 Employee benefits

#### (a) Short-term obligations

Liabilities for wages and salaries, including non-monetary benefits that are expected to be settled wholly within twelve months after the end of the period in which the employees render the related service are recognised in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled. The liabilities are presented as current employee benefit obligations in the consolidated statement of financial position.

#### 2.20 僱員福利(續)

#### (b) 其他長期僱員福利債務

倘實體沒有無條件權利延遲償還 至於報告期間後最少12個月,而 不論預期何時會實際償還,負債 會將於綜合財務狀況表中呈列為 流動負債。

#### (c) 界定供款計劃

本集團向由國家管理的退休金保險計劃支付強制、合約或自願性 供款。本集團在支付供款後即無 進一步付款責任。供款於到期時 確認為僱員福利開支。倘若有現 金退款或未來供款額出現下調, 預付供款可確認為資產。

#### (d) 花紅計劃

本集團按照計及本公司股東應佔 溢利的公式在作出若干調整後確 認花紅負債及開支。本集團於有 合約責任或過往慣例已產生推定 責任時確認撥備。

#### (e) 長期服務金

根據香港僱傭條例,本集團須就 在若干情況下終止僱用香港僱員 承擔支付長期服務金淨額的離職 後福利責任,數額為僱員本期及 過往期間提供服務而可賺取的未 來福利金額。

#### 2.20 Employee benefits (continued)

#### (b) Other long-term employee benefit obligations

The obligations are presented as current liabilities in the consolidated statement of financial position if the entity does not have an unconditional right to defer settlement for at least twelve months after the reporting period, regardless of when the actual settlement is expected to occur.

#### (c) Defined contribution plans

The Group pays contributions to state-managed pension insurance plans on a mandatory, contractual or voluntary basis. The Group has no further payment obligations once the contributions have been paid. The contributions are recognised as employee benefit expense when they are due. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

#### (d) Bonus plans

The Group recognises a liability and an expense for bonuses based on a formula that takes into consideration the profit attributable to the Company's shareholders after certain adjustments. The Group recognises a provision where contractually obliged or where there is a past practice that has created a constructive obligation.

#### (e) Long service payments

The Group's net post-employment benefit obligation in respect of long service payments to its employees in Hong Kong upon cessation of their employment in certain circumstances under the Hong Kong Employment Ordinance is the amount of future benefits that the employees have earned in return for their services in the current and prior periods.

#### (e) 長期服務金(續)

該責任乃採用預計單位信貸成本 法計算,貼現至其現值並扣減根 據本集團退休計劃累計的權益(屬 於本集團作出的供款)。貼現率為 香港政府外匯基金債券(其到期日 與有關責任之到期日相若)於各個 結算日之孳息率。該等福利之預 期成本乃於僱用期間使用與界定 福利計劃相同之會計方法累算。

#### (f) 終止福利

終止福利是指本集團在正常退休日期前終止僱傭或員工自願接受裁員以換取此等福利的應付福利。本集團在明確承諾:根據已式計劃終止現職員工的僱用且不可能撤回;或作出鼓勵自願裁員的要約提供終止福利時確認終止福利。於報告期末後12個月以上到期的福利折現至現值。

#### (e) Long service payments (continued)

The obligation is calculated using the projected unit credit cost method, discounted to its present value and reduced by entitlements accrued under the Group's retirement schemes that are attributed to contributions made by the Group. The discount rate is the yield at each balance sheet date of Hong Kong Government's Exchange Fund Notes which have terms to maturity approximating the terms of the related liability. The expected costs of these benefits are accrued over the period of employment using the same accounting methodology as used for defined benefit plans.

The current service cost of the long service payment scheme, recognised in the consolidated statement of comprehensive income reflects the increase in the long service payment's obligation as a result of employee service in the current year, benefit changes, curtailments and settlements. Past-service costs are recognised immediately in the consolidated statement of comprehensive income. The interest cost is calculated by applying the discount rate to the balance of the long service payment's obligation. Actuarial gains and losses arising from experience adjustment and changes in actuarial assumptions are charged or credited to equity in other comprehensive income in the period in which they arise.

#### (f) Termination benefits

Termination benefits are payable when employment is terminated by the Group before the normal retirement date, or whenever an employee accepts voluntary redundancy in exchange for these benefits. The Group recognises termination benefits when it is demonstrably committed to either: terminating the employment of current employees according to a detailed formal plan without possibility of withdrawal; or providing termination benefits as a result of an offer made to encourage voluntary redundancy. Benefits falling due more than 12 months after the end of the reporting period are discounted to present value.

#### 2.21 收益確認

收益按已收或應收代價的公平值計量,即於本集團一般業務過程中就出售貨品已收及應收的代價。收益經扣除退貨並與本集團內的銷售額對銷後 呈列。

本集團預期不存在任何轉讓承諾貨品 予客戶與客戶付款之間間隔超過一年 的合約。因此,本集團並未就資金的 時間價值調整任何交易價格。

當合約任何一方已履約,本集團於綜合財務狀況表呈列合約為合約資產或合約負債,視乎本集團履約與客戶付款的關係。合約資產指本集團轉讓商品予客戶後收取代價的權利。為取得合約產生的增支成本(如可收回)將資本化並呈列為資產,並於隨後確認有關收益時攤銷。

當合約任何一方已履約,本集團於綜合財務狀況表呈列合約為合約資產或合約負債,視乎本集團履約與客戶付款的關係。合約資產指本集團轉讓商品予客戶後收取代價的權利。為取得合約產生的增支成本(如可收回)將資本化並呈列為資產,並於隨後確認有關收益時攤銷。

應收款項於本集團對代價擁有無條件權利時入賬。倘支付代價僅須待時間流逝而到期,收取代價的權利即為無條件。

當收益金額符合下述本集團業務的特 定準則時,便會確認收益:

#### 銷售貨品

所轉讓貨品銷售於貨品控制權已經轉 讓後於某一個時間確認,為本集團已 將產品交付予客戶,而客戶已經接收 產品的時間。有關客戶就產品全權控 制,並概無可影響客戶接受產品而尚 未履行的責任。

#### 2.21 Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable, and represents amounts for the sale of goods in the ordinary course of the Group's activity. Revenue is shown net of returns and after eliminating sales within the Group.

The Group does not expect to have any contracts where the period between the transfer of the promised goods to the customers and the payment by the customers exceeds one year. As a consequence, the Group does not adjust any of the transaction prices for the time value of money.

When either party to a contract has performed, the Group presents the contract in the consolidated statement of financial position as a contract asset or a contract liability, depending on the relationship between the Group's performance and the customer's payment. A contract asset is the Group's right to consideration in exchange for goods that the Group has transferred to a customer. Incremental costs incurred to obtain a contract, if recoverable, are capitalised and presented as assets and subsequently amortised when the related revenue is recognised.

If a customer pays consideration or the Group has a right to an amount of consideration that is unconditional, before the Group transfers the promised goods to the customer, the Group presents the contract as a contract liability when the payment is received or a receivable is recorded (whichever is earlier). A contract liability is the Group's obligation to transfer the promised goods to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

A receivable is recorded when the Group has an unconditional right to consideration. A right to consideration is unconditional if only the passage of time is required before payment of that consideration is due.

Revenue is recognised when specific criteria have been met for the Group's activity as described below:

#### Sales of goods

Sales of goods transferred at a point in time are recognised when control of the goods has transferred, being when the Group has delivered the products to the customers and the customers have accepted the products, the customers have full discretion over the products, and there is no unfulfilled obligation that could affect the customers' acceptance of the products.

#### 2.22 利息收入

利息收入採用實際利率法按時間比例 基準確認。

#### 2.23 租賃

本集團租賃若干物業及廠房以及機器。租賃合約通常訂有三個月至五年的固定期限。租賃條款按個別基準進行磋商,包含各種條款及條件。租賃協議並無施加任何契諾,惟租賃資產不得用作借款的抵押品。

租賃確認為使用權資產(計入物業、廠房及設備),並在有關租賃資產可供本集團使用之日確認相應負債。每筆租賃付款乃分配至負債及融資成本。融資成本於租期內自損益扣除,以計算出各期間負債餘下結餘的固定週期利率。

租賃產生的資產及負債初步以現值基 準進行計量。租賃負債包括以下租賃 付款的淨現值:

- 固定付款(包括實質固定付款)減 任何應收租賃獎勵;
- 基於指數或利率的可變租賃付款;
- 剩餘價值擔保下的承租人預期應 付款項:
- 購買權的行使價(倘承租人合理地 確定行使該選擇權);及
- 支付終止租賃的罰款(倘租賃條款 反映承租人行使該選擇權)。

租賃付款採用租賃所隱含的利率(倘該 利率可被釐定)或實體的增量借款利率 予以貼現。

#### 2.22 Interest income

Interest income is recognised on a time-proportion basis using the effective interest method.

#### 2.23 Leases

The Group leases various properties and plant and machinery. Rental contracts are typically made for fixed periods of three months to five years. Lease terms are negotiated on an individual basis and contain various terms and conditions. The lease agreements do not impose any covenants, but leased assets may not be used as security for borrowing purposes.

Leases are recognised as right-of-use assets (included in properties, plant and equipment) and the corresponding liabilities at the date of which the respective leased asset is available for use by the Group. Each lease payment is allocated between the liability and finance cost. The finance cost is charged to profit or loss over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period.

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives receivable;
- variable lease payment that are based on an index or a rate;
- amounts expected to be payable by the lessee under residual value guarantees;
- the exercise price of a purchase option if the lessee is reasonably certain to exercise that option; and
- payments of penalties for terminating the lease, if the lease term reflects the lessee exercising that option.

The lease payments are discounted using the interest rate implicit in the lease, if that rate can be determined, or the entity's incremental borrowing rate.

#### 2.23 租賃(續)

使用權資產乃按成本計量,包括以下 各項:

- 租賃負債的初始計量金額;
- 於開始日期或之前作出的任何租 賃付款減任何已收租賃獎勵;
- 任何初始直接成本;及
- 修復成本。

使用權資產通常按資產的可使用年期 或租期中的較短者以直線法折舊。倘 本集團合理確定將會行使購買權,則 使用權資產於相關資產的可使用年期 內折舊。用於資產折舊的可使用年期 目的為:

#### 物業於租賃期內

與短期租賃及低價值資產租賃相關的支付以直線法於損益中確認為開支。短期租賃指租期為少於12個月的物業、廠房及機器租賃。低價值資產包括價值低於5,000港元的機器。

#### 2.24 股息分派

向股東分派的股息在本公司股東或董事(如適用)批准有關股息的年度內確認為負債。

#### 2.23 Leases (Continued)

Right-of-use assets are measured at costs comprising the following:

- the amount of the initial measurement of lease liabilities;
- any lease payments made at or before the commencement date less any lease incentives received;
- · any initial direct costs; and
- restoration costs.

Right-of-use assets are generally depreciated over the shorter of the asset's useful life and the lease term on a straight-line basis. If the Group is reasonably certain to exercise a purchase option, the right-of-use asset is depreciated over the underlying asset's useful life. The useful life used for the assets' depreciation purpose is:

#### **Properties**

Over the lease term

Payments associated with short-term leases and leases of low-value assets are recognised on a straight-line basis as an expense in profit or loss. Short-term leases are leases for properties, plant and machinery with a lease term of less than 12 months. Low-value assets comprise machinery with value below HK\$5,000.

#### 2.24 Dividend distribution

Dividend distribution to the shareholders is recognised as a liability in the years in which the dividend is approved by the Company's shareholders or directors, where appropriate.

#### 2.25 財務擔保合約

在擔保簽發的同時,財務擔保合約確認為一項金融負債。該負債按公平值初步計量及其後按下列較高者計量:

- 按香港財務報告準則第9號的預期 信貸虧損模式釐定的金額;及
- 初步確認的金額減去(倘適用)按 香港財務報告準則第15號的原則 確認的累計收入金額。

財務擔保的公平值由基於債務工具下 要求的合約付款與無需擔保的付款之 間的現金流量差額的現值,或就承擔 責任可能支付予第三方的估計金額釐 定。

#### 2.26 政府補助

當能夠合理地保證將可收取政府補助,而本集團將會遵守所有附帶條件時,政府補助會按其公平值確認。

與開支有關的政府補助遞延入賬,並 按該等補助與其擬補償的開支配合所 需期間在綜合全面收益表內確認。

與購買物業、廠房及設備有關的政府 補助列入非流動負債作為遞延收益, 並按有關資產的預計年期以直線法計 入損益。

用於補償已產生的費用或虧損或用於 向本集團提供即時財政支持的政府補 助,不再發生未來相關成本時,在其 變為可收到的期間於損益確認。

#### 2.25 Financial guarantee contracts

Financial guarantee contracts are recognised as a financial liability at the time the guarantee is issued. The liability is initially measured at fair value and subsequently at the higher of:

- the amount determined in accordance with the expected credit loss model under HKFRS 9; and
- the amount initially recognised less, where appropriate, the cumulative amount of income recognised in accordance with the principles of HKFRS 15.

The fair value of financial guarantees is determined based on the present value of the difference in cash flows between the contractual payments required under the debt instrument and the payments that would be required without the guarantee, or the estimated amount that would be payable to a third party for assuming the obligations.

#### 2.26 Government grants

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the Group will comply with all attached conditions.

Government grants relating to expenses are deferred and recognised in the consolidated statement of comprehensive income over the period necessary to match them with the expenses that they are intended to compensate.

Government grants relating to the purchase of properties, plant and equipment are included in non-current liabilities as deferred income and are credited to profit or loss on a straight-line basis over the expected lives of the related assets.

Government grants that become receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

#### 2.27 或然負債

或然負債乃因過往事項可能產生的責任,而其存在與否僅能透過發生或未有發生一宗或多宗本集團不能完全控制的不明朗未來事項確定。或然負債亦可為因不大可能須流出經濟資源或未能可靠計量有關責任金額而不予確認的過往事項所產生的現時責任。

儘管或然負債不予確認,惟須在財務報表中披露。當流出資源的可能性有變,致使可能流出資源,則或然負債將被確認為撥備。

#### 3 財務風險管理

本集團業務承受多種財務風險:市場風險(包括外匯風險及利率風險)、信貸風險及流動資金風險。本集團的整體風險管理計劃重點關注金融市場的不可預測性,並尋求盡量減低對本集團財務表現的潛在不利影響。

#### 3.1 市場風險

#### 3.1.1 外匯風險

本集團於香港及中國營運,面對 多種貨幣風險產生的外匯風險, 主要有關美元及人民幣。外匯風 險產生自以此等貨幣計值的未來 商業交易、已確認資產及負債以 及海外業務的淨投資。

截至2021年及2020年12月31日止年度,本集團並無訂立任何衍生工具對沖其外匯風險。

# 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### 2.27 Contingent liabilities

A contingent liability is a possible obligation that arises from past events and whose existence will only be confirmed by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Group. It can also be a present obligation arising from past events that is not recognised because it is not probable that outflow of economic resources will be required or the amounts of obligation cannot be measured reliably.

A contingent liability is not recognised but is disclosed in the financial statements. When a change in the probability of an outflow occurs so that outflow is probable, it will then be recognised as a provision.

#### 3 FINANCIAL RISK MANAGEMENT

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk and interest rate risk), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

#### 3.1 Market risk

#### 3.1.1 Foreign exchange risk

The Group operates in Hong Kong and the PRC and is exposed to foreign exchange risk arising from various currency exposures, primarily with respect to the USD and RMB. Foreign exchange risk arises from future commercial transactions, recognised assets and liabilities and net investments in foreign operations, which are denominated in these currencies.

During the years ended 31 December 2021 and 2020, the Group has not entered into any derivative instruments to hedge its foreign exchange exposures.

#### 3.1.2 利率風險

本集團的利率風險主要來自其銀行現金及浮動利率銀行借款。本集團現金及現金等價物及銀行借款的詳情分別於綜合財務報表附註17及25披露。

除銀行現金及銀行借款外,本集 團並無重大計息資產或負債。

於2021年及2020年12月31日, 倘銀行現金及銀行借款的利率增加/減少50個基點而所有其他 變量保持不變,截至有關日期止 年度的除所得税前溢利會減少/ 增加約213,000港元(2020年: 135,000港元),主要由於銀行借 款利息開支(經扣除銀行現金的利 息收入)增加/減少所致。

#### 3.1.2 Interest rate risk

The Group's interest rate risk is mainly attributable to its cash at banks and bank borrowings with floating interest rates. Details of the Group's cash and cash equivalents and bank borrowings have been disclosed in Notes 17 and 25 to the consolidated financial statements respectively.

Other than cash at banks and bank borrowings, the Group does not have significant interest-bearing assets or liabilities.

As at 31 December 2021 and 2020, if interest rates on cash at banks and bank borrowings had been 50 basis points higher/lower with all variables held constant, profit before income tax for the years ended would have been approximately HK\$213,000 (2020: HK\$135,000) lower/higher, mainly as a result of higher/lower interest expenses on the bank borrowings netted with interest income on the cash at banks.

#### 3.2 信貸風險

本集團的信貸風險主要來自銀行現金 及貿易應收款項及其他應收款項以及 應收關聯公司款項。各項金融資產的 賬面值為本集團面臨的與金融資產相 關的最大信貸風險。

#### 風險管理

本集團設有政策確保向具備適當信貸 記錄的客戶授出信貸期,且本集團對 客戶進行定期信貸評估。

本集團銀行現金已存入優質財務機構。因此,本集團預期不會出現因該 等對手方不履約而招致的任何虧損。

截至2021年12月31日止年度,本集團收益的53%(2020年:63%)來自其五大客戶。於2021年12月31日,本集團五大客戶合共結欠貿易應收款項總額的61%(2020年:68%)。

銀行現金的信貸風險有限,因為該等存款均存放於具良好信貸評級的銀行。

#### (a) 金融資產減值

本集團擁有兩類金融資產受預期 信貸虧損模式規限:

- 來自第三方貿易應收款項
- 按攤銷成本計量的其他金融 資產

#### 貿易應收款項

本集團採用香港財務報告準則第9 號簡化方法計量預期信貸虧損, 該方法就所有貿易應收款項計提 存續期預期虧損撥備。

為計量預期信貸虧損,貿易應收 款項已根據共享信貸風險特款項 逾期天數分類。各組別應收款項 的未來現金流量乃根據過往違約 機率估計,並經調整以反映現有 形況的影響以及影響客戶結清應 收款項能力的宏觀經濟因素的前 瞻性資料。

#### 3.2 Credit risk

The credit risk of the Group mainly arises from cash at banks and trade and other receivables. The carrying amounts of each financial asset represent the Group's maximum exposure to credit risk in relation to financial assets.

#### Risk management

The Group has policies in place to ensure that credit terms are made to customers with an appropriate credit history and the Group performs periodic credit evaluations of its customers.

The Group's cash at banks were deposited with high quality financial institutions. Therefore, the Group does not expect any losses arising from non-performance by these counterparties.

For the year ended 31 December 2021, 53% (2020: 63%) of the Group's revenue was derived from its top five customers. As at 31 December 2021, 61% (2020: 68%) of the total trade receivables were due from the Group's top five customers.

The credit risk on cash at banks are limited because deposits are in banks with sound credit ratings.

#### (a) Impairment of financial assets

The Group has two types of financial assets that are subject to the expected credit loss models:

- trade receivables from third parties
- other financial assets carried at amortised cost

#### Trade receivables

The Group applies the HKFRS 9 simplified approach to measure expected credit losses which use a lifetime expected loss allowance for all trade receivables.

To measure the expected credit losses, trade receivables have been grouped based on shared credit risk characteristics and the days past due. Future cash flows for each group of receivables are estimated on the basis of historical default rates, adjusted to reflect the effects of existing market conditions as well as forward looking information on macroeconomic factors affecting the ability of the customers to settle the receivable.

#### 按個別基準計量預期信貸虧損

倘無合理預期可收回,則已知無力償還之貿易應收款項就減值撥備作個別評估且予以撇銷。無方償還的跡象包括(其中包括)債務人無法與本集團訂立還款計劃及無法作出合約付款。於2021年12月31日,若干與其他債務人並無相同信貸風險特徵的客戶屬拖欠項結餘約1,555,000港元(2020年:1,304,000港元)因而全面減值。

#### 按共同基準計量預期信貸虧損

並無已知無力償還之餘下貿易應 收款項就收回可能性進行共同評估,當中乃計及客戶性質及其賬 齡組別並應用預期信貸虧損率於 相關應收款項的賬面總額。

預期信貸虧損率乃根據歷史信貸 虧損經驗估計得出,經調整以反 映現有市況的影響以及影響客戶 清算應收貸款能力的宏觀經濟因 素的前瞻性資料。

於2021年12月31日,有關該等共同評估應收款項的虧損撥備結餘根據適用於不同組別的預期信貸虧損率計算為約287,000港元(2020年:152,000港元)。

貿易應收款項的減值虧損於經營 溢利內呈列為淨減值虧損。其後 收回先前已撇銷的金額則計入同 一項目。

Measurement of expected credit loss on individual basis

Trade receivables with known insolvencies are assessed individually for impairment allowances and are written off when there is no reasonable expectation of recovery. Indicators of insolvencies include, amongst others, the failure of a debtor to engage in a repayment plan with the Group and a failure to make contractual payments. As at 31 December 2021, certain customers who did not share the same credit risk characteristics as the rest of the debtors were in delinquency of payments and their respective trade receivable balances amounting to approximately HK\$1,555,000 (2020: HK\$1,304,000) were therefore fully impaired.

Measurement of expected credit loss on collective basis

Remaining trade receivables without known insolvencies are collectively assessed for likelihood of recovery, taking into account the nature of the customer and its ageing category, and applying the expected credit loss rates to the respective gross carrying amounts of the receivables.

The expected credit loss rates are estimated on the basis of historical credit losses experienced, adjusted to reflect the effects of existing market conditions as well as forward looking information on macroeconomic factors affecting the ability of the customers to settle the receivable.

As at 31 December 2021, the balance of loss allowance in respect of these collectively assessed receivables was approximately HK\$287,000 (2020: HK\$152,000) based on expected credit loss rates applied on different groupings.

Impairment losses on trade receivables are presented as net impairment losses within operating profit. Subsequent recoveries of amounts previously written off are credited against the same line item.

#### 按攤銷成本計量的其他金融資產

於2021年及2020年12月31日,管理層認為其他應收款項的信貸風險較低,原因為交易對手在短期內具備履行合約現金流量責任的雄厚實力。本集團已按12個月預期信貸虧損法評估其他應收款項的預期信貸虧損並不重大。因此,該等結餘的虧損撥備接近於零,且並未確認任何撥備。

Other financial assets carried at amortised cost

The Group's other financial assets carried at amortised cost include other receivables in the consolidated statement of financial position. The impairment loss of other financial assets carried at amortised cost is measured based on the twelve months expected credit loss. The twelve months expected credit loss is the portion of lifetime expected credit loss that results from default events on a financial instrument that are possible within twelve months after the reporting date. However, when there has been a significant increase in credit risk since origination, the allowance will be based on the lifetime expected credit loss.

As at 31 December 2021 and 2020, management considered the credit risk of other receivables to be low as counterparties have a strong capacity to meet their contractual cash flow obligations in the near term. The Group has assessed that the expected credit losses for the other receivables were immaterial under 12 months expected losses method. Therefore, the loss allowance provision for these balances was close to zero and no provision was recognised.

# 3.3 流動資金風險

本集團的政策為定期監察現時及預期 的流動資金需求,以確保維持足夠的 現金儲備以應付短期及長期流動資金 需求。

於2021年12月31日,本集團持有的現金及現金等價物約為207,272,000港元(2020年:234,376,000港元),預期可產生現金流入以管理流動資金風險。

本集團透過多種來源維持流動資金, 包括有序變現短期金融資產、應收, 項及本集團認為適當的若干資產, 本集團在其資本建構過程中亦會考慮 長期借款等長期融資。本集團旨在透 過維持充足的銀行結餘、已承諾可用 信貸額及計息借款來維持資金的靈活 性,以便本集團於可見將來繼續其業 務。

於2021年12月31日,本集團未提取的總銀行融資約為260,920,000港元(2020年:165,716,000港元),而本集團已提取的總銀行融資約為265,580,000港元(2020年:281,784,000港元)。

下表列示本集團非衍生金融負債按照 相關到期組別,根據由報告期末至合 約到期日的剩餘期間進行分析。

表內披露的金額為合約未貼現現金流量及本集團須按要求支付的最早日期。由於貼現的影響並不重大,故在12個月內到期的餘額相等於其賬面值。

# 3.3 Liquidity risk

The Group's policy is to regularly monitor current and expected liquidity requirements to ensure that it maintains sufficient reserves of cash to meet its liquidity requirements in the shorter and longer term.

As at 31 December 2021, the Group held cash and cash equivalents of approximately HK\$207,272,000 (2020: HK\$234,376,000), that are expected to be readily available to generate cash inflows for managing liquidity risk.

The Group maintains liquidity by a number of sources including orderly realisation of short-term financial assets, receivables and certain assets that the Group considers appropriate. Long term financing including long-term borrowings are also considered by the Group in its capital structuring. The Group aims to maintain flexibility in funding by keeping sufficient bank balances, committed credit lines available and interest bearing borrowings which enable the Group to continue its business for the foreseeable future.

As at 31 December 2021, the Group's total undrawn banking facilities amounted to approximately HK\$260,920,000 (2020: HK\$165,716,000) and the Group's total drawn banking facilities amounted to approximately HK\$265,580,000 (2020: HK\$281,784,000).

The table below analyses the non-derivative financial liabilities of the Group into relevant maturity groupings based on the remaining period at the end of the reporting period to the contractual maturity date.

The amounts disclosed in the table were the contractual undiscounted cash flows and the earliest date the Group can be required to pay. Balances within twelve months equal their carrying balances as impact from discounting is not significant.

為維持或調整資本結構,本集團或會 調整向股東派付的股息金額,向股東 退回資本或出售資產以減低債務。

# 3.4 Capital management

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the amounts of dividend paid to shareholders, return capital to shareholders or sell assets to reduce debt.

總負債對總資本比率由2020年12月31日的1.9倍減少至2021年12月31日的1.6倍,主要由於償還銀行貸款淨額及總權益因年內盈利而增加所致。

本集團流動金融資產及流動金融負債 的賬面值因其於短期內到期而與其公 平值相若。非流動金融資產及非流動 金融負債的賬面值根據貼現現金流量 計算與其公平值相若。 The decrease in total debt to total capital ratio from 1.9 times as at 31 December 2020 to 1.6 times as at 31 December 2021 was mainly due to the net repayment of bank borrowings and an increase in total equity as a result of profit for the year.

#### 3.5 Fair value estimation

As at 31 December 2021 and 2020, the Group did not have any financial assets or financial liabilities in the consolidated statement of financial position which were measured at fair value.

The carrying amounts of the Group's current financial assets and current financial liabilities, approximated their fair values due to their short maturities. The carrying amounts of non-current financial assets and non-current financial liabilities approximate their fair values which are estimated based on the discounted cash flows.

# 4 關鍵會計估計及假設

估計及判斷乃根據過往經驗及其他因素(包括在相關情況下認為屬合理的未來事件預期)持續評估。

本集團對未來作出多項估計及假設。根據 定義,就此產生的會計估計很少會與有關 實際結果相符。有重大風險導致須於下一 個財政年度對資產及負債賬面值作出重大 調整的估計及假設論並如下。

#### 4.1 存貨的淨可變現值

存貨按成本及淨可變現值兩者的較低 者列賬。存貨的淨可變現值指日常業 務過程中的估計售價減去估計完工成 本及銷售開支。該等估計乃基於現時 市況以及製造及銷售類似性質產品的 過往經驗作出。管理層於各報告期末 重新評估該估計。

#### 4.2 所得税

本集團主要在香港及中國繳納所得 税。在釐定所得税撥備時須作出重大 判斷。在日常業務過程中,多項交易 及計算的最終税項釐定並不明確。倘 該等事宜的最終税務結果與最初入賬 的金額不同,該等差額將會影響作出 有關釐定期間的所得税及遞延所得税 撥備。

由於管理層認為可能有未來應課稅溢 利用作抵銷暫時性差額或稅項虧損, 故確認有關若干暫時性差額及稅項虧 損的遞延所得稅資產。倘預期與原本 估計存在差額,該等差額將會影響有 關估計變動期間的遞延所得稅資產及 稅項開支確認。

# 4 CRITICAL ACCOUNTING ESTIMATES AND ASSUMPTIONS

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are addressed below.

#### 4.1 Net realisable value of inventories

Inventories are stated at the lower of cost and net realisable value. Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated cost to completion and selling expenses. These estimates are based on the current market condition and the historical experience of manufacturing and selling products of similar nature. Management reassesses the estimation at the end of each reporting period.

#### 4.2 Income taxes

The Group is subject to income taxes mainly in Hong Kong and the PRC. Significant judgement is required in determining provision for income taxes. There are transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred income tax provisions in the periods in which such determination is made.

Deferred income tax assets relating to certain temporary differences and tax losses are recognised as management considers it is probable that future taxable profit will be available against which the temporary differences or tax losses can be utilised. Where the expectation is different from the original estimate, such differences will impact the recognition of deferred income tax assets and tax expense in the periods in which such estimate is changed.

# 4.3 Impairment of receivables

The Group makes provision for impairment of receivables based on assumptions about risk of default and expected loss rates. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's historical default rates, existing market conditions as well as forward looking estimates at the end of each reporting period. The identification of impairment of receivables requires the use of judgment and estimates. Where the expectations are different from the original estimates, such differences will impact the carrying value of receivables and loss for the impairment of receivables recognised in the periods in which such estimates have been changed.

#### 5 REVENUE AND SEGMENT INFORMATION

The Company is an investment holding company and the Group is principally engaged in the manufacturing and sales of electronic products.

The CODM has been identified as the CEO of the Company. The CEO reviews the Group's internal reporting in order to assess performance and allocate resources. The CEO has determined the operating segment based on these reports.

The CEO considers the Group's operation from a business perspective and determines that the Group has one reportable operating segment being the manufacturing and sales of electronic products.

The CEO assesses the performance of the operating segment based on a measure of revenue and gross profit.

During the years ended 31 December 2021 and 2020, all of the Group's revenues were from contracts with customers and were recognised at a point in time. Please refer to Note 2.21 for details of accounting policies on revenue recognition.

Retirement benefit costs - defined contribution schemes

The Group has arranged for its Hong Kong employees to join the Mandatory Provident Fund Scheme (the "MPF Scheme"), a defined contribution scheme managed by an independent trustee. Under the MPF Scheme, the Group and its employees make monthly contributions to the scheme at 5% of the employees' earnings as defined under the Mandatory Provident Fund legislation. Both the Group's and the employees' mandatory contributions were subject to a cap of HK\$1,500 per month.

No forfeited contribution is available to reduce the contribution payable in future year.

#### The PRC

As stipulated under the relevant rules and regulations in the PRC, the Group's subsidiary operating in the PRC contributes to state-sponsored retirement plans for its employees. Depending on the provinces of the employees' registered residences and their current region of work, the subsidiary contributes certain percentages of the basic salaries of its employees and has no further obligations for the actual payment of pensions or post retirement benefits beyond the contributions. The state-sponsored retirement plans are responsible for the entire pension obligations payable to the retired employees.

During the year ended 31 December 2020, the Human Resources and Social Security Bureau of Dongguan Municipality has announced that all micro, small and medium size enterprises in Dongguan were exempt from 50% of employer contributions to pension, unemployment and work-related injury insurance schemes from the period between February and June 2020.

#### (b) Manpower service expenses

During the year ended 31 December 2020, the Group entered into certain manpower service arrangements with several external manpower service organisations in the PRC. Under these arrangements, certain of the Group's manpower requirements were fulfilled by these organisations at agreed service fees whereas the human resources provided were directly employed by the relevant service organisations. The individuals providing services to the Group did not have any employment relationship with the Group.

# **Compliance with bank covenants**

During the year ended 31 December 2021, the Group was in compliance with the financial covenants of its bank facilities save as the facilities described below. As at 31 December 2021, the Group was in breach of certain financial covenants in respect of the Group's facilities with a bank with the total facilities granted amounting to approximately HK\$326,500,000, of which approximately HK\$230,263,000 was utilised by the Group as bank borrowings and bills payables as of 31 December 2021.

After the end of the reporting period, notwithstanding the breach of financial covenants under the bank facilities with the relevant bank, upon the mutual agreement of the relevant bank and the Group, and having settled part of the drawn down amount and the breach of covenant penalty imposed by the relevant bank, the Group renewed the bank facilities with the relevant bank and with facilities limit reduced to HK\$220,000,000.

With the consideration of the cash and cash equivalents amounting to approximately HK\$207,272,000, the financial position and operating activities of the Group and the undrawn bank facilities with other banks amounting to approximately HK\$164,684,000 as at 31 December 2021, the management considers that the breach of financial covenants under the bank facilities described above did not have any material adverse impact to the Group.

The excess of net assets value of Brilliant Holdings in aggregate as at 13 December 2019 over the par value of 1,000,000 ordinary shares at HK\$0.01 per share was credited to the capital reserve account with the amount of HK\$67.898,000.

#### **33 SUBSEQUENT EVENTS**

(a) On 28 January 2022, Wise Ally Holdings Limited ("the Subscriber"), a wholly-owned subsidiary of the Company entered into the share subscription agreement and the convertible bonds subscription agreement with Talentone Technology Limited ("the Target Company"), an independent third party of the Company, pursuant to which the Subscriber conditionally agreed to subscribe for, and the Target Company conditionally agreed to issue the subscription shares at a consideration of HK\$2,000,000 (the "Share Subscription") and the convertible bonds at an aggregate consideration of HK\$44,000,000 (the "CB Subscription") respectively. Reference is made to the announcements of the Company dated 28 January 2022, 8 February 2022 and 22 March 2022 in relation to a disclosable transaction regarding the Share Subscription and the CB Subscription in details.

The Target Company is principally engaged in the development and sales of the high technology floor care products including, among others, vacuum cleaners and has been granted the right to use the licensed trademarks in certain products in its ordinary course of business as a wholesale distributor.

Upon the completion of the Share Subscription and the CB Subscription, the Group can leverage on the Target Company's experience and sales network and start establishing its own network while also expanding the Group's revenue sources.

The Share Subscription and the first tranche CB Subscription of the convertible bonds in a principal amount of HK\$22,000,000 were completed on 22 March 2022.
