### NOTES TO THE UNAUDITED CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

For the three months ended 31 March 2022

#### 1. GENERAL INFORMATION

The Company was incorporated as an exempted company and registered in the Cayman Islands with limited liability under the Companies Act of the Cayman Islands on 20 January 2017. The registered office of the Company is located at Windward 3, Regatta Office Park, PO Box 1350, Grand Cayman KY1-1108, Cayman Islands. The shares of the Company (the "Shares") are listed on GEM of the Stock Exchange since 8 December 2017 (the "Listing Date") by way of share offer of 120,000,000 new Shares ("Share Offer") offered by the Company at an offer price of HK\$0.55 per Share. The Company's principal place of business is located at Unit B, 9th Floor, Safety Godown Industrial Building, 56 Ka Yip Street, Chai Wan, Hong Kong.

The Company is an investment holding company. The principal activities of the Group are provision of marketing production services, e-commerce and retail business, operation of a café and content media business.

#### 2. BASIS OF PREPARATION AND PRESENTATION

The Unaudited Condensed Consolidated Financial Statements have been prepared in accordance with the applicable disclosure requirements of Chapter 18 of the GEM Listing Rules and all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual HKFRSs, Hong Kong Accounting Standards and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"). The Unaudited Condensed Consolidated Financial Statements should be read in conjunction with the Group's annual financial statements for the year ended 31 December 2021.

The accounting policies adopted in the preparation of the Unaudited Condensed Consolidated Financial Statements are same as those applied in the preparation of the Group's annual financial statements for the year ended 31 December 2021, except for the new and revised HKFRSs and interpretations issued by HKICPA that are first effective for the current accounting period of the Group. There has been no significant change to the accounting policy applied in these Unaudited Condensed Consolidated Financial Statements for the period presented as a result of adoption of these amendments.

The preparation of the Unaudited Condensed Consolidated Financial Statements in conformity with the HKFRSs requires the use of certain critical accounting estimates. It also requires management to exercise their judgements in the process of applying the Group's accounting policies. Actual results may differ from these estimates. The significant judgements made by the management in applying the Group's accounting policies and the key sources of estimation uncertainty were the same as those that applied to the Group's annual financial statements for the year ended 31 December 2021.

The Unaudited Condensed Consolidated Financial Statements have been prepared on historical cost basis, except for financial asset at fair value through profit or loss that are measured at fair value at the end of each reporting period. The Unaudited Condensed Consolidated Financial Statements are presented in Hong Kong dollar ("HK\$"), which is also the functional currency of the Company. All values are rounded to the nearest thousand except when otherwise indicated.

The Unaudited Condensed Consolidated Financial Statements have not been audited by the Company's independent auditor, but have been reviewed by the Company's Audit Committee (the "Audit Committee").

#### 3. REVENUE AND OTHER INCOME AND GAINS

#### 4. INCOME TAX EXPENSE

The Group is subject to income tax on an entity basis on profits arising in or derived from the jurisdictions in which members of the Group are domiciled and operated.

Pursuant to the rules and regulations of the Cayman Islands and the British Virgin Islands ("BVI"), the Group is not subject to any income tax under these jurisdictions during the period (2021: Nil).

Under the two-tiered profits tax rates regime of the Hong Kong Profits Tax, the first HK\$2,000,000 of profits of the qualifying group entity will be taxed at 8.25% (2021: 8.25%) during the period, and profits above HK\$2,000,000 will be taxed at 16.5% (2021: 16.5%). The profits of group entities not qualifying for the two-tiered profit tax rates regime will continue to be taxed at a flat rate of 16.5% (2021: 16.5%) during the period.

Accordingly, the Hong Kong Profits Tax of the qualifying group entity is calculated at 8.25% of the first HK\$2,000,000 of the estimated assessable profits and at 16.5% on the estimated profits above HK\$2,000,000, taking into account the tax concession granted by the Hong Kong Special Administrative Region Government during the period.

No provision for Hong Kong Profits Tax has been made as the Group did not generate any assessable profits during the three months ended 31 March 2021.

Under the Enterprise Income Tax ("EIT") Law and the Implementation Regulation of the EIT Law, the subsidiary in the People's Republic of China (the "PRC") is subject to the tax rate of 25% on the estimated assessable profits during the period.

No provision for EIT has been made for the subsidiary established in the PRC as the subsidiary did not have any assessable profits subject to EIT in the PRC during the three months ended 31 March 2021.

Pursuant to the EIT Law, 5% withholding tax is levied on the foreign investor in respect of dividend distributions arising from a foreign investment enterprise's profits earned after 1 January 2008. As at 31 March 2022, temporary withholding tax differences relating to the undistributed profits of the PRC subsidiary amounted to approximately HK\$3,334,000 (2021: HK\$2,517,000). Deferred tax liabilities of approximately HK\$167,000 (2021: HK\$126,000) have not been recognised in respect of the tax that would be payable on the distribution of these retained profits as the Company is in a position to control the dividend policy of the PRC subsidiary and it has been determined that it is probable that undistributed profits of the PRC subsidiary will not be distributed in the foreseeable future.

#### 5. DIVIDENDS

The Board does not recommend the payment of any dividend for the three months ended 31 March 2022 (2021: Nil).

#### 6. LOSS PER SHARE

The calculations of basic loss per Share are based on the loss of approximately HK\$559,000 (2021: HK\$2,379,000) for the period attributable to the owners of the Company and the weighted average number of 480,000,000 (2021: 480,000,000) Shares in issue during the period.

Diluted loss per Share were same as the basic loss per Share as there were no dilutive potential ordinary Shares in existence during the periods.

#### MANAGEMENT DISCUSSION AND ANALYSIS

#### **BUSINESS REVIEW AND OUTLOOK**

The 5th wave of COVID in Hong Kong has set back the gradual recovery of market economy in 2021. Our marketing production services have been badly affected resulting from the significant reduction in marketing spend of our key clients from retail, luxury brands, hospitality and insurance business sectors. Basically, other than those minimum regular items, there was no marketing campaign or ad hoc project at all from our clients. Revenue from marketing production services for the three months ended 31 March 2022 decreased by 35% as compared with the same period last year.

The Group's expanded content media business via a licensing deal with US-based entertainment company, focused on popular and emerging trends in style, sneakers, food, music, sports and pop culture, continued to develop with few more projects secured in this first quarter of 2022. Revenue from content media business for the three months ended 31 March 2022 was HK\$2.8 million.

The Group's e-commerce start-up business supplemented by operation of a café in Hong Kong has been suspended due to high operating costs and continued COVID-related challenges.

The Group's revenue for the three months ended 31 March 2022 decreased by 18% as compared with the same period last year. The impact of decrease in revenue from marketing production services and ecommerce and operation of cafe was mitigated by revenue generated from the content media business. Despite the decrease in revenue, the Group's loss for the three months ended 31 March 2022 decreased by 87% as compared with the same period last year that was benefited from cost control on operating costs.

Looking ahead, although the 5th wave of COVID in Hong Kong has reached its peak, there are still uncertainties in the market recovery on our marketing production business. Regarding the content media business, the COVID in Hong Kong and mainland China has delayed discussion for new projects and execution and delivery of secured projects. While the Group is diligently evaluating opportunities striving for the growth of the Group, we would continue imposing stringent cost control.

#### FINANCIAL REVIEW

#### Revenue

The Group's revenue is principally generated from the provision of marketing production services, ecommerce and retail business, operation of a café and content media business which are categorised into (i) physical marketing production; (ii) digital marketing production; (iii) e-commerce and retail; (iv) income from operation of a café and (v) income from content media business. During the three months ended 31 March 2022, the Group's revenue decreased by approximately HK\$2.3 million, representing 18.1%, to approximately HK\$10.4 million (2021: HK\$12.7 million).

During the three months ended 31 March 2022, the revenue from physical marketing production services decreased by approximately 31.9% to approximately HK\$7.2 million (2021: HK\$10.6 million). The revenue from digital marketing production services decreased by approximately 65.2% to approximately HK\$0.4 million (2021: HK\$1.1 million). The decrease in revenue from physical marketing production and digital marketing production was mainly due to decrease in number of projects during the period.

During the three months ended 31 March 2022, the revenue from e-commerce and retail was approximately HK\$9,000 and no income from operation of a café was generated. The significant decrease in revenue was due to the suspension of this business during the period.

During the period, the income from content media business was approximately HK\$2.8 million. The revenue mainly represented brand income on our original content. The content media business was not yet commenced during the three months ended 31 March 2021.

# **Outsourced project costs**

Outsourced project costs consist of printing costs and other outsourced project costs and costs for content media business. During the three months ended 31 March 2022, the Group's outsourced project costs decreased by approximately HK\$1.0 million, representing 25.7%, to approximately HK\$2.9 million (2021: HK\$3.9 million). The decrease was in line with the decrease in revenue from marketing production services.

#### Materials and consumables

Materials and consumables are costs on papers and other materials sourced by the Group for the marketing production and materials used for operation of a café and the cost of goods for retail sales. During the three months ended 31 March 2022, the Group's materials and consumables decreased by approximately HK\$0.8 million, representing 49.3%, to approximately HK\$0.9 million (2021: HK\$1.7 million). The decrease was directly attributable to the suspension of the e-commerce and café business during the period.

# **Employee benefits expenses**

Employee benefits expenses primarily consist of salaries, allowances and benefits in kind, discretionary bonus and retirement benefit scheme contributions. During the three months ended 31 March 2022, the Group's employee benefits expenses increased by approximately HK\$0.1 million, representing 3.2%, to approximately HK\$3.8 million (2021: HK\$3.7 million). The increase was directly attributable to the expansion of business of content media business and offsetting by the decrease effect from suspension of the e-commerce and cafe business.

# Rental expenses

Rental expenses primarily represent the rental expenses for short-term leases for office premises and staff quarter and the variable lease payment for the printing machines for confidential data printing services. During the three months ended 31 March 2022, the Group's rental expenses increased by approximately HK\$0.2 million, representing 59.5%, to approximately HK\$0.5 million (2021: HK\$0.3 million). The increase was primarily attributable to the new short term lease for office premise in the PRC for the content media business.

# Transportation fee

Transportation fee consists of fees paid to logistic service providers for (i) delivery of products from merchants and to clients; and (ii) postage incurred in respect of the direct mailing services. During the three months ended 31 March 2022, the Group's transportation fee decreased by approximately HK\$0.3 million, representing 17.5%, to approximately HK\$1.4 million (2021: HK\$1.7 million). The decrease was directly attributable to the decrease in revenue from marketing production services.

# Other operating expenses

Other operating expenses primarily consist of consultancy fee, professional fee, rates and building management fee, utilities and office expenses. During the three months ended 31 March 2022, the Group's other operating expenses decreased by approximately HK\$1.1 million, representing 45.0%, to approximately HK\$1.4 million (2021: HK\$2.5 million). The decrease was primarily attributable to the removal and reinstatement costs for the office premise relocation incurred during the period ended 31 March 2021 and no such expenses recognised during the period.

#### Finance cost

Finance cost primarily represents the interest on lease liabilities. During the three months ended 31 March 2022, the Group's finance cost decreased by approximately HK\$38,000, representing 34.5%, to approximately HK\$72,000 (2021: HK\$110,000). The decrease was mainly due to the early termination of the lease for the shop in Sham Shui Po.

## Loss for the period

During the three months ended 31 March 2022, the Group recorded loss of approximately HK\$0.4 million (2021: HK\$2.9 million). The decrease in loss was mainly benefited from cost control on operating costs during the period.

## LIQUIDITY, FINANCIAL RESOURCES, GEARING RATIO AND CAPITAL STRUCTURE

As at 31 March 2022, the Group had net current assets of approximately HK\$57.4 million (31 December 2021: HK\$58.1 million), including time deposits and cash and bank balances of approximately HK\$57.3 million (31 December 2021: HK\$56.2 million) mainly denominated in Hong Kong dollars, with approximately HK\$4.3 million (31 December 2021: HK\$5.0 million) denominated in renminbi which is not freely convertible into other currencies and the remittance of funds out of the PRC is subject to exchange restrictions imposed by the PRC government.

The gearing ratio of the Group as at 31 March 2022 was 8.2% (31 December 2021: 11.0%). The gearing ratio is calculated as total debt divided by total equity as at the respective period end.

There has been no change in the capital structure of the Company during the three months ended 31 March 2022. The equity attributable to owners of the Company amounted to approximately HK\$69.1 million as at 31 March 2022 (31 December 2021: HK\$69.7 million).

#### FOREIGN EXCHANGE EXPOSURE AND TREASURY POLICY

The majority of the Group's business operations were conducted in Hong Kong. The transactions, monetary assets and liabilities of the Group were mainly denominated in Hong Kong dollars. During the period, there was no material impact to the Group arising from the fluctuation in the foreign exchange rates. The Group did not engage in any derivatives agreement and did not commit to any financial instruments to hedge its foreign exchange exposure during the period. The Group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy liquidity position throughout the period. The Group strives to reduce exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and other commitments can meet its funding requirements from time to time.

#### PLEDGE OF ASSETS

As at 31 March 2022, the Group did not have any pledged assets (31 December 2021: Nil).

#### CAPITAL COMMITMENTS AND CONTINGENT LIABILITIES

During the year ended 31 December 2020, the Group obtained an exclusive distribution right to produce and distribute marketing media programme in the PRC through internet under the brandname of a famous marketing media producer (the "Media Producer"), which stationed in the USA. According to the term sheet entered between the Group and the Media Producer, the Group is committed to invest in the co-operative project with the Media Producer with mutually approved budget of US\$1,800,000 (equivalent to HK\$13,953,000). On 28 April 2021, Shanghai Qixian Culture Communication Co., Ltd was incorporated in the PRC to commence the operation of such project. During the period ended 31 March 2022, project costs of HK\$1,738,000 (equivalent to US\$223,000) (31 December 2021: HK\$1,236,000 (equivalent to US\$167,000)) was incurred by the Group for project. As at 31 March

2022, the other commitment in relation to the mutually approved budget is US\$1,410,000 (equivalent to HK\$10,979,000) (31 December 2021: US\$1,633,000 (equivalent to HK\$12,717,000)). Also, according to the term sheet between the Group and the Media Producer, subject to further negotiation and to enter into an agreement, the Group is committed to pay further license fee of US\$63,000 (equivalent to HK\$488,000) to the Media Producer and to invest in the cooperative project with the Media Producer with mutually approved budget of US\$1,200,000 (equivalent to approximately HK\$9,302,000).

As at 31 March 2022, the Group did not have any material contingent liability (31 December 2021: Nil).

#### EMPLOYEES AND REMUNERATION POLICIES

As at 31 March 2022, the Group had 40 (31 December 2021: 40) full-time (including executive Director) employees. The Group offers a comprehensive and competitive remuneration and benefits package to all its employees. The Group has adopted a share option scheme and approved by the then shareholders of the Company (the "Shareholders") on 16 November 2017 (the "Share Option Scheme") for the purpose of providing incentives and rewards to eligible persons who contribute to the success of the Group's operations. The Group has also adopted other employee benefits including a mandatory provident fund retirement benefit scheme for its employees in Hong Kong, as required under the Mandatory Provident Fund Schemes Ordinance, and has participated in central pension scheme organised and governed by the relevant local governments for its employees in the PRC. In addition, discretionary bonus is offered to eligible employees by reference to the Group's results and individual performance. To ensure that the Group is able to attract and retain staff capable of attaining the best performance levels, remuneration packages are reviewed on a regular basis.

# LOAN AGREEMENTS WITH COVENANTS RELATING TO SPECIFIC PERFORMANCE OF THE CONTROLLING SHAREHOLDER

On 20 August 2018, Icicle Production Company Limited ("Icicle Production"), an indirect wholly-owned subsidiary of the Company, as the borrower, entered into a bank facility letter (the "Facility Letter") with DBS Bank (Hong Kong) Limited as the lender (the "Lender"), pursuant to which the Lender agreed to make available a bank overdraft facility, with a maximum facility of HK\$10,000,000, which has been made available and will continue to be made available by Lender to Icicle Production on the terms and conditions therein contained. Pursuant to the Facility Letter, a specific performance covenant is imposed on Ms. Bonnie Chan Woo, the controlling Shareholder, to hold not less than 51% beneficial interest of the Company and Icicle Production.

In 2020, the Facility Limit has been adjusted to HK\$9,500,000 after the regular review by the Lender. Other than that, all terms and conditions under the Facility Letter remain unchanged.

#### CORPORATE GOVERNANCE PRACTICES

The Company is committed to maintaining a high standard of corporate governance in emphasising a quality board of directors, sound internal control, transparency and accountability with a view to safeguard the interests of all the Shareholders. The Board has adopted the principles and the code provisions of Corporate Governance Code (the "CG Code") contained in Appendix 15 to the GEM Listing Rules. In accordance with the requirements of the GEM Listing Rules, the Company has established the Audit Committee, a nomination committee and a remuneration committee with specific written terms of reference. During the three months ended 31 March 2022 and up to the date of this announcement, the Company has complied with all the code provisions of the CG Code as set out in Appendix 15 to the GEM Listing Rules except for the deviation from code provision C.2.1 as detailed below.

Code provision C.2.1 of the CG Code stipulates that the roles of chairman and chief executive should be separate and should not be performed by the same individual. Under the current structure of the Company, Ms. Bonnie Chan Woo is the Chairperson and the chief executive officer of the Company ("CEO"). In view that Ms. Bonnie Chan Woo has been managing the Group's business and overall strategic planning since August 2002, the Board believes that the vesting of the roles of the Chairperson of the Board and CEO in Ms. Bonnie Chan Woo is beneficial to the business operations and management of the Group as it provides a strong and consistent leadership to the Group, and the current management has been effective in the development of the Group and implementation of business strategies under the leadership of Ms. Bonnie Chan Woo. In allowing the two roles to be vested in the same person, the Board believes both positions require in-depth knowledge and considerable experience in the Group's business, and Ms. Bonnie Chan Woo is the most suitable person to take up both positions for effective management of the Group.

Therefore, the Board considers that the deviation from code provision C.2.1 of the CG Code is appropriate in such circumstances. Notwithstanding the above, the Board believes that the balance of power and authority is adequately ensured by the operation of the Board which comprises experienced and high-caliber individuals, with three of them being independent non-executive Directors.

#### Audit Committee and Review of Unaudited Condensed Consolidated Financial Statements

The Audit Committee was established with written terms of reference in compliance with Rule 5.28 of the GEM Listing Rules and paragraph D.3 of the CG Code as set out in Appendix 15 to the GEM Listing Rules. The Audit Committee comprises three independent non-executive Directors, namely Mr. Ip Arnold Tin Chee, Mr. Hung Alan Hing Lun and Mr. Man Ka Ho Donald and Mr. Ip Arnold Tin Chee is the chairman of the Audit Committee. The primary duties of the Audit Committee include reviewing and supervising the Group's financial reporting system, monitoring the internal control procedures and risk management, reviewing the Group's financial information and the relationship with the external auditor of the Company, ensuring compliance with the relevant laws and regulations. In addition, the Audit Committee is responsible for the initial establishment and the maintenance of a framework of internal controls and ethical standards for the Group's management.

The Unaudited Condensed Consolidated Financial Statements have not been audited. The Audit Committee has reviewed with the management of the Group the Unaudited Condensed Consolidated Financial Statements, this quarterly report, the accounting principles and policies adopted by the Group, and other financial reporting matters. The Audit Committee is satisfied that the Unaudited Condensed Consolidated Financial Statements complied with the applicable accounting standards, the requirements under the GEM Listing Rules and other applicable legal requirements, and that adequate disclosures have been made.
