As at the date of the AGM, the total number of issued Shares was 701,774,350 Shares, which was the total number of Shares entitling the holders to attend and vote for or against the resolutions proposed at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of any of the resolutions proposed at the AGM as set out in Rule 13.40 of the Listing Rules. No Shareholder was required to abstain from voting at the AGM under the Listing Rules. No Shareholder had indicated in the AGM Circular that they intended to vote against or to abstain from voting on any resolutions proposed at the AGM.

Dr. Xu Yao-Chang, chairman of the Board, presided at the AGM. The executive Directors of the Company, Dr. Xu Yao-Chang, Dr. Yu Hongping and Dr. Chen Zhui, the non-executive Directors of the Company, Dr. Xia Gavin Guoyao and Ms. Tang Yanmin and the independent non-executive Directors of the Company, Dr. Sun Piaoyang, Mr. Sun Hongbin and Mr. Wang Lei attended the AGM.

The Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.
