POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 30 JUNE 2022

SUMMARY

The Board is pleased to announce that all the Resolutions proposed at the AGM were duly passed by the Shareholders at the AGM held on 30 June 2022 by way of poll.

Reference is made to the circular (the “**Circular**”) of Furniweb Holdings Limited (the “**Company**”) and notice of annual general meeting (the “**AGM Notice**”) dated 30 March 2022 to its shareholders (the “**Shareholders**”) regarding, among others, the resolutions (each a “**Resolution**” and collectively, the “**Resolutions**”) proposed to be considered and passed at the annual general meeting (the “**AGM**”) of the Company held on 30 June 2022.

Unless the context requires otherwise, capitalised terms used in this announcement have the same meanings as those defined in the Circular.

POLL RESULTS OF THE AGM

The board of directors of the Company (the “**Board**”) is pleased to announce that all the Resolutions were duly passed by the Shareholders at the AGM held on 30 June 2022 by way of poll.

Tricor Investor Services Limited, the Company’s branch share registrar and transfer office in Hong Kong, was appointed as the scrutineer for vote-taking at the AGM.

As at the date of the AGM:

- (1) the total number of issued shares was 560,000,000 (“**Shares**”), which was the total number of Shares entitling the holders to attend and vote for or against any of the Resolutions at the AGM;
- (2) there was no Share entitling the holder to attend and vote only against any of the Resolutions at the AGM;
- (3) no Shareholders are required under the GEM Listing Rules to abstain from voting at the AGM; and
- (4) no Shareholders have stated their intention in the Circular to vote against the Resolutions or to abstain from voting at the AGM.

Dato’ Lim Heen Peok, Mr. Cheah Eng Chuan, Dato’ Lua Choon Hann and Mr. Cheah Hannon attended the AGM in person. Mr. Ho Ming Hon, Dato’ Sri Dr. Hou Kok Chung and Dato’ Lee Chee Leong attended the AGM by electronic means.
