CHANGE OF COMPANY NAME

The Board is pleased to announce that the English name of the Company has been changed from “Vinco Financial Group Limited” to “Zijing International Financial Holdings Limited”, and its dual foreign name in Chinese has been changed from “域高金融集團有限公司” to “紫荊國際金融控股有限公司”, both with effect from 25 May 2022.

CHANGE OF STOCK SHORT NAME

The stock short name of the Company for trading in the Shares on GEM will be changed from “VINCO FINANCIAL” to “ZIJING INTL FIN” in English and from “域高金融” to “紫荊國際金融” in Chinese, with effect from 9:00 a.m. on 13 July 2022. The stock code of the Company on GEM will remain unchanged as “8340”.

Reference is made to the announcement of Zijing International Financial Holdings Limited (formerly known as Vinco Financial Group Limited) (the “**Company**”) dated 19 April 2022 and the circular of the Company dated 26 April 2022 (the “**Circular**”) and the announcement of the Company dated 20 May 2022 relating to the poll results of the EGM held on 20 May 2022, in relation to the Change of Company Name. Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

CHANGE OF COMPANY NAME

The Board is pleased to announce that the English name of the Company has been changed from “Vinco Financial Group Limited” to “Zijing International Financial Holdings Limited”, and its dual foreign name in Chinese has been changed from “域高金融集團有限公司” to “紫荊國際金融控股有限公司”, both with effect from 25 May

2022.

Subsequent to the passing of a special resolution to approve the Change of Company Name at the EGM held on 20 May 2022, the Certificate of Incorporation on Change of Name has been issued by the Registrar of Companies in the Cayman Islands, certifying the change of the English name of the Company and the dual foreign name in Chinese of the Company to “Zijing International Financial Holdings Limited” and “紫荊國際金融控股有限公司”, respectively, with effect from 25 May 2022. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 4 July 2022 confirming the registration of the new names of the Company in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

EFFECTS OF THE CHANGE OF COMPANY NAME

The Change of Company Name will not affect any rights of the holders of securities of the Company or the Company’s daily business operation and its financial position.

All share certificates in issue bearing the former name of the Company shall continue to be evidence of title to such Shares and the share certificates will continue to be valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for exchange of the share certificates of the Company under its former name for new share certificates under the new name of the Company. New share certificates of the Company will be issued under the new name of the Company with effect from 13 July 2022.
