Whether or not you intend to attend the AGM, you are requested to complete the form of proxy and return the same to the Company's Hong Kong branch share registrar and transfer office, Tricor Investor Services Limited at: Level 54 Hopewell Centre, 183 Queen's Road East, Hong Kong in accordance with the instructions printed thereon not less than 48 hours before the time appointed for the holding of the AGM (or any adjourned meeting). Completion and delivery of the form of proxy will not preclude you from attending and voting at the AGM (or any adjourned meeting) if you so wish.

**PRECAUTIONARY MEASURES FOR THE AGM**

The Company will implement the following precautionary measures at the AGM against the coronavirus disease to protect the Shareholders or proxies from the risk of infection, including but not limited to: compulsory body temperature check; mandatory use of surgical face masks; and no distribution of gifts and no refreshments will be served. Any attendee who does not comply with the precautionary measures or is subject to quarantine, with any flu-like symptoms, who has had close contact with any person under quarantine, or has travelled overseas within 14 days immediately before the AGM shall not be permitted to enter the venue. To the extent permitted under law, the Company reserves the right to deny entry into the AGM venue or require any person to leave the AGM venue so as to ensure the health and safety of the attendees at the AGM. The Company strongly recommends the Shareholders to exercise their voting rights by appointing the Chairman of the AGM as their proxy to vote on the relevant resolutions at the AGM as an alternative to attending the AGM in person.

**INTRODUCTION**

The purpose of this circular is to provide you with information relating to (i) the general mandates to issue and repurchase Shares, (ii) the re-election of the retiring Directors, (iii) the proposed adoption of the New M&A and (iv) the notice of the AGM.

## **LETTER FROM THE BOARD**

### **GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES**

#### **Issue Mandate**

At the AGM, an ordinary resolution will be proposed to grant to the Directors a general and unconditional mandate to allot and issue further new Shares representing up to 20% of the aggregate number of the Shares of the Company in issue as at the date of passing the resolution.

The Company had an aggregate of 357,815,052 Shares in issue as at the Latest Practicable Date. Assuming that there is no change in the issued share capital of the Company between the Latest Practicable Date and the date of passing the resolution approving the Issue Mandate, the maximum number of Shares which may be issued pursuant to the Issue Mandate will be 71,563,010 Shares.

#### **Repurchase Mandate**

At the AGM, an ordinary resolution will be proposed to grant to the Directors a general and unconditional mandate to exercise all powers of the Company to repurchase Shares subject to the criteria set out in this circular. Under the Repurchase Mandate, the maximum number of Shares that the Company may repurchase shall not exceed such number representing 10% of the share capital of the Company in issue as at the date of the passing of the resolution.

Assuming that there is no change in the issued share capital of the Company between the Latest Practicable Date and the date of passing the resolution approving the Repurchase Mandate, the maximum number of Shares which may be repurchased pursuant to the Repurchase Mandate will be 35,781,505 Shares.

An explanatory statement, as required by the GEM Listing Rules to provide the requisite information in connection with the Repurchase Mandate, is set out in Appendix I to this circular.

#### **Extension of the Issue Mandate**

An ordinary resolution will also be proposed at the AGM to authorize the Directors to extend the Issue Mandate by an amount representing the aggregate number of the Shares repurchased pursuant to the Repurchase Mandate.

### **RE-ELECTION OF RETIRING DIRECTORS**

Pursuant to Article 83(3) of the Articles of Association, any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election.

Pursuant to Article 84(1) of the Articles of Association, at each annual general meeting one-third of the Directors for the time being (or, if their number is not a multiple of three, the number nearest to but not less than one-third) shall retire from office by rotation. Pursuant to Article 84(2) of the Articles of Association, a retiring Director shall be eligible for re-election

and shall continue to act as a Director throughout the meeting at which he retires. Any Director appointed by the Board pursuant to Article 83(3) shall not be taken into account in determining which particular Directors or the number of Directors who are to retire by rotation.

In accordance with Article 83(3), Mr. Lam Kwok Leung Roy (“**Mr. Lam**”) shall hold office until the AGM and shall be eligible for re-election. In accordance with Articles 84(1) and 84(2), Ms. Cheng Yeuk Hung (“**Ms. Cheng**”), Ms. Chan Wan Shan Sandra (“**Ms. Chan**”) and Mr. Leung Yu Tung Stanley (“**Mr. Leung**”) shall retire from their offices as Directors and shall be eligible for re-election. Ms. Cheng and Ms. Chan will offer themselves for re-election as executive Directors, Mr. Lam and Mr. Leung will offer themselves for re-election as independent non-executive Directors.

Particulars relating to the above named Directors are set out in Appendix II to this circular.

### **PROPOSED ADOPTION OF THE NEW M&A**

The Board has resolved to put forward to the Shareholders for approval a special resolution to amend the M&A by adopting the New M&A, with the Proposed Amendments incorporated therein, in substitution for, and to the exclusion of, the M&A for the purposes of, among others, (i) bringing the M&A in line with the amendments made to Appendix 3 to the GEM Listing Rules which became effective on 1 January 2022 and the applicable laws of the Cayman Islands; (ii) providing flexibility to the Company in relation to the conduct of general meetings; and (iii) incorporating certain housekeeping amendments.

The proposed adoption of the New M&A is subject to approval by the Shareholders by way of passing a special resolution at the AGM. In this regard, a special resolution numbered 8 as set out in the notice of the AGM will be proposed at the AGM. Details of the Proposed Amendments to the existing M&A brought about by the New M&A (marked-up against the existing M&A) are set out in Appendix III to this circular. The M&A is written in English, and there is no official Chinese translation in respect thereof. The Chinese translation of the New M&A is therefore for reference only. In case of any discrepancy or inconsistency between the English version and its Chinese translation, the English version shall prevail.

The legal advisers to the Company as to Hong Kong laws and Cayman Islands laws have respectively confirmed that the Proposed Amendments conform with the applicable requirements under the GEM Listing Rules and do not contravene the applicable laws of the Cayman Islands. The Company confirms that there is nothing unusual about the Proposed Amendments for a Cayman Islands company listed in Hong Kong.

### **THE AGM**

A notice convening the AGM is set out on pages 67 to 71 of this circular. The AGM will be convened and held at Room 3207A, 32/F, Cable TV Tower, 9 Hoi Shing Road, Tsuen Wan, New Territories, Hong Kong on Thursday, 11 August 2022 at 11:00 a.m. for the purpose of considering and, if thought fit, passing the ordinary resolutions to approve, among others, the general mandates to issue and repurchase Shares, and the re-election of retiring Directors.

A form of proxy for use at the AGM is enclosed with this circular. Whether or not you intend to attend the AGM, you are requested to complete the form of proxy and return the same to the Company's Hong Kong branch share registrar and transfer office, Tricor Investor Services Limited at: Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong, in accordance with the instructions printed thereon not less than 48 hours before the time appointed for the holding of the AGM (or any adjourned meeting). Completion and delivery of the form of proxy will not preclude you from attending and voting at the AGM (or any adjourned meeting) if you so wish.

None of the Shareholders are required to abstain from voting at the AGM on any resolutions as set out in the notice of the AGM.

Pursuant to Rule 17.47(4) of the GEM Listing Rules, any vote of the Shareholders at a general meeting must be taken by a poll. Therefore, all resolutions proposed at the AGM shall be voted by poll.

### RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the GEM Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

### RECOMMENDATIONS

The Directors believe that all the resolutions to be proposed at the AGM are in the best interests of the Company and the Shareholders as a whole and recommend the Shareholders to vote in favour of the relevant resolutions to be proposed at the AGM.

*The following is the explanatory statement required to be sent to Shareholders pursuant to Rule 13.08 of the GEM Listing Rules in connection with the proposed Repurchase Mandate which, if approved, would authorize the Directors to repurchase the Shares.*

## **1. SHARE CAPITAL**

As at the Latest Practicable Date, there were 357,815,052 Shares in issue. Subject to the passing of the resolution granting the Repurchase Mandate and on the basis that no further Shares are issued or repurchased before the AGM, the Company will be allowed to repurchase a maximum of 35,781,505 Shares (representing 10% of the issued share capital of the Company as at the date of the AGM) during the period from the date of the AGM up to (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association or any applicable laws of the Cayman Islands to be held; or (iii) the revocation, variation or renewal of the Repurchase Mandate by ordinary resolution of the Shareholders in a general meeting, whichever occurs first.

## **2. REASONS FOR REPURCHASES**

Although the Directors have no present intention of repurchasing the Shares, they believe that it is in the interests of the Company and the Shareholders for the Directors to have a general authority from the Shareholders to enable the Company to repurchase Shares on the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and/or its earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders.

## **3. FUNDING OF REPURCHASE**

In repurchasing the Shares, the Company may only apply funds legally available for such purpose in accordance with the Articles of Association, the GEM Listing Rules and the applicable laws and regulations of the Cayman Islands. Under the Cayman Islands law, a share repurchase by the Company may only be made out of profits of the Company or out of the proceeds of a fresh issue of shares made for the purpose of the repurchase or, if so authorized by the Articles of Association and subject to the provisions of the Companies Law (Chapter 22 of the Laws of the Cayman Islands), out of capital.

## **4. IMPACT ON REPURCHASES**

Whilst the Repurchase Mandate, if exercised in full, may have a material adverse impact on the working capital or gearing position of the Company, as compared with the position disclosed in the audited consolidated financial statements contained in the Company's annual report for the year ended 31 March 2022, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital of the Company or the gearing levels which, in the opinion of the Directors, are from time to time appropriate for the Company.

## 6. GENERAL INFORMATION AND UNDERTAKINGS

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, any of their close associates (as defined in the GEM Listing Rules), has any present intention to sell any Shares to the Company or any of its subsidiaries, if the Repurchase Mandate is approved by the Shareholders.

No core connected persons (as defined in the GEM Listing Rules) of the Company have notified the Company that they have any present intention to sell any Shares to the Company, or have undertaken not to do so, if the Repurchase Mandate is approved by the Shareholders.

The Directors have undertaken to the Stock Exchange that they will exercise the Repurchase Mandate in accordance with the GEM Listing Rules, the applicable laws of the Cayman Islands and the Articles of Association.

## 7. TAKEOVERS CODE

If a Shareholder's proportionate interest in the voting rights of the Company increases as a result of a repurchase of Shares, such increase will be treated as an acquisition for the purposes of the Takeovers Code.

Accordingly, a Shareholder, or a group of Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase of the Shareholders' interest, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, (a) Ms. Siu Hiu Ki Jamie was interested in 37,354,504 Shares, representing approximately 10.44% of all issued Shares; (b) ECGO International Limited ("ECGO"), which is wholly owned by Industronics Berhad a company listed on Bursa Malaysia Securities Berhad (the stock exchange of Malaysia) (stock code: 9393), was interested in 76,008,474 Shares, representing approximately 21.24% of all issued Shares; and (c) Lissington Limited ("**Lissington**"), which is legally, beneficially and wholly owned by Ms. Zheng Zeli, was interested in 79,791,486, representing approximately 22.30% of all issued Shares.

In the event that the Repurchase Mandate is exercised in full, assuming that the present shareholdings and capital structure of the Company remains the same, the interest in the Company held by Ms. Siu Hiu Ki Jamie, ECGO and Lissington would be increased to approximately 11.60%, 23.60% and 24.78% of the issued share capital of the Company, respectively and such increase would not give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code. Except as disclosed above, the Directors are not aware of any consequence which will arise under the Takeovers Code as a result of any repurchase of Shares under the proposed Repurchase Mandate.

An exercise of the Repurchase Mandate whether in whole or in part will not result in less than the relevant prescribed minimum percentage of the Shares being held by the public as required by the Stock Exchange. The Directors have no intention to repurchase Shares to such an extent which will result in the amount of the Shares held by the public being reduced to less than 25%.

## **8. SHARE REPURCHASE MADE BY THE COMPANY**

No repurchases of Shares have been made by the Company (whether on GEM or otherwise) during the six months immediately prior to the Latest Practicable Date.

The details of the Directors who will offer themselves for re-election at the AGM, are set out below:

**A. EXECUTIVE DIRECTORS**

**1. Ms. Cheng Yeuk Hung**

*Experience*

Ms. Cheng Yeuk Hung (鄭若雄), aged 65, is an executive Director, the chief executive officer and the founder of the Group; she is also a member of remuneration committee of the Board. Ms. Cheng finished her secondary education in 1975 and has approximately 43 years of experience in the electronics industry of which she has spent over 31 years in managing her own business. Prior to establishing Echo Co in 1989, Ms. Cheng had worked in EDAX Industrial Company Limited from 1979 to 1988 as an operation manager whereby she became skilled at business promotion, procurement of raw materials, and resource management in the electronics industry. Save as disclosed, Ms. Cheng did not hold any directorship in the past 3 years in any companies the securities of which are listed on any securities market in Hong Kong or overseas.

*Length of Service*

The Company has entered into a service contract with Ms. Cheng on 27 September 2013. The fixed term of service of Ms. Cheng is one year commencing from the date of the listing of the Shares on the GEM (i.e. 11 October 2013) and shall be automatically renewed for successive terms of one year until terminated by Ms. Cheng or the Company giving not less than three months' written notice to the other party. Either the Company or Ms. Cheng has the right to give not less than three months' written notice to terminate the respective service agreement. Her appointment is subject to retirement by rotation and re-election and other related provision as stipulated in the articles of association of the Company and the GEM Listing Rules.

*Relationships*

Ms. Cheng is the spouse of Mr. Lo Yan Yee (“**Mr. Lo**”), an executive Director, and the mother of Mr. Lo Ding To, the general manager of the Group. Save as disclosed, Ms. Cheng has no relationship with any other Director, senior management, substantial shareholder (as defined in the GEM Listing Rules) or controlling shareholder of the Company. Ms. Cheng also serves as director of certain subsidiaries of the Company as at the Latest Practicable Date.

*Interest in Shares*

So far as the Directors are aware as at the Latest Practicable Date, Ms. Cheng is a shareholder of the Company holding 4,878,000 Shares and 1,140,000 Options with rights to subscribe for up to 1,140,000 Shares at an exercise price of HK\$0.15 per Share. She is also taken to be interested in 1,140,000 Options (carrying the right to subscribe for up to

1,140,000 Shares) held by her spouse, Mr. Lo. Save as disclosed, Ms. Cheng does not have any other interest in the shares of the Company within the meaning of Part XV of the SFO.

*Directors' emoluments*

Ms. Cheng is entitled to receive a total yearly emoluments of HK\$750,000 and a discretionary bonus which has been determined by the Board with reference to her background, qualifications, experience, level of responsibilities undertaken with the Group and prevailing market conditions.

*Matters that need to be brought to the attention of the Shareholders*

There is no information that is required to be disclosed in respect of such details set out paragraph (h) to (v) of Rule 17.50(2) of the GEM Listing Rules and there are no other matters concerning the re-appointment of Ms. Cheng as an executive Director that need to be brought to the attention of the Shareholders.

**2. Ms. Chan Wan Shan Sandra**

*Experience*

Ms. Chan Wan Shan Sandra (陳韻珊) aged 48, joined our Group in August 2017 and was appointed as an executive Director on 31 March 2020. She is also responsible for supervising and managing the business development of Echo Asia (Hong Kong). Ms. Chan has been an independent non-executive director of Industronics Berhad, the issued shares of which are listed on the main market of Bursa Malaysia Securities Berhad (stock code: 9393 and stock name: ITRONIC), since November 2019. Save as disclosed, Ms. Chan did not hold any directorship in the past 3 years in any companies the securities of which are listed on any securities market in Hong Kong or overseas.

*Length of Service*

If, after the sending of Notice of a general meeting but before the meeting is held, or after the adjournment of a meeting but before the adjourned meeting is held (whether or not Notice of the adjourned meeting is required), the Directors, in their absolute discretion, consider that it is inappropriate, impracticable, unreasonable or undesirable for any reason to hold the general meeting on the date or at the time or place or by means of electronic facilities specified in the Notice calling the meeting, they may change or postpone the meeting to another date, time and/or place and/or change the electronic facilities and/or change the form of the meeting (a physical meeting, an electronic meeting or a hybrid meeting) without approval from the Members. Without prejudice to the generality of the foregoing, the Directors shall have the power to provide in every Notice calling a general meeting the circumstances in which a postponement of the relevant general meeting may occur automatically without further notice, including without limitation where a number 8 or higher typhoon

signal, black rainstorm warning or other similar event is in force at any time on the day of the meeting. This Article shall be subject to the following:

- (a) when a meeting is so postponed, the Company shall endeavour to post a Notice of such postponement on the Company's website as soon as practicable (provided that failure to post such a Notice shall not affect the automatic postponement of a meeting);
- (b) when only the form of the meeting or electronic facilities specified in the Notice are changed, the Board shall notify the Members of details of such change in such manner as the Board may determine;
- (c) when a meeting is postponed or changed in accordance with this Article, subject to and without prejudice to Article 64, unless already specified in the original Notice of the meeting, the Board shall fix the date, time, place (if applicable) and electronic facilities (if applicable) for the postponed or changed meeting and shall notify the Members of such details in such manner as the Board may determine; further all proxy forms shall be valid (unless revoked or replaced by a new proxy) if they are received as required by these Articles not less than 48 hours before the time of the postponed meeting; and

64F. All persons seeking to attend and participate in an electronic meeting or a hybrid meeting shall be responsible for maintaining adequate facilities to enable them to do so. Subject to Article 64C, any inability of a person or persons to attend or participate in a general meeting by way of electronic facilities shall not invalidate the proceedings of and/or resolutions passed at that meeting.

64G. Without prejudice to other provisions in Article 64, a physical meeting may also be held by means of such telephone, electronic or other communication facilities as permit all persons participating in the meeting to communicate with each other simultaneously and instantaneously, and participation in such a meeting shall constitute presence in person at such meeting.

For purposes of this Article, procedural and administrative matters are those that (i) are not on the agenda of the general meeting or in any supplementary circular that may be issued by the Company to its Members; and (ii) relate to the chairman's duties to maintain the orderly conduct of the meeting and/or allow the business of the meeting to be properly and effectively dealt with, whilst allowing all Members a reasonable opportunity to express their views. - (2) In the case of a physical meeting, where ~~Where~~ a show of hands is allowed, before or on the declaration of the result of the show of hands, a poll may be demanded:

Where a resolution is voted on by a show of hands, a declaration by the chairman that a resolution has been carried, or carried unanimously, or by a particular majority, or not carried by a particular majority, or lost, and an entry to that effect made in the minute book of the Company, shall be conclusive evidence of the facts without proof of the number or proportion of the votes recorded for or against the resolution.
